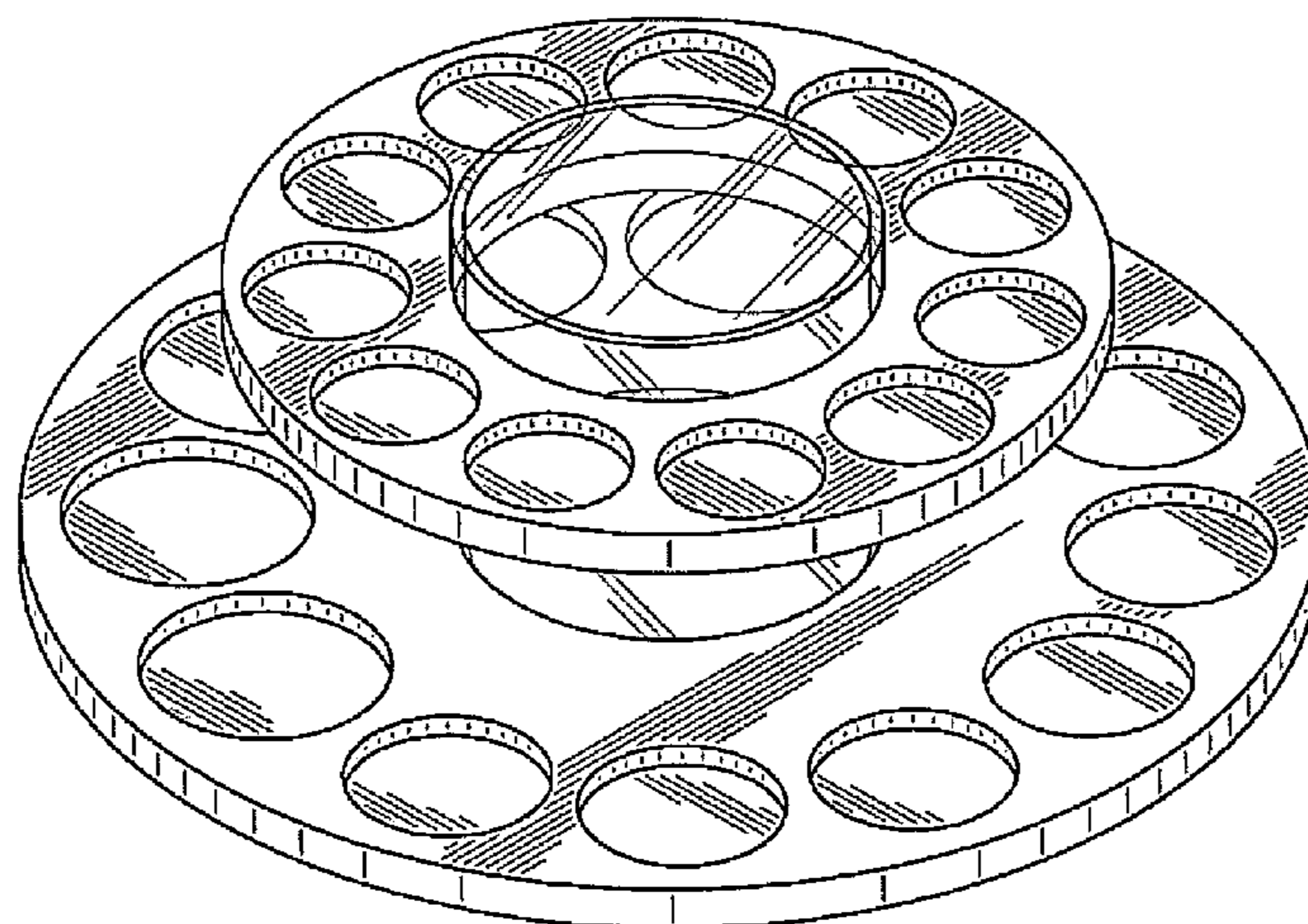

(57) **CLAIM**
The ornamental design for a cosmetic carousel, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a cosmetic carousel embodying my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a side view thereof, the opposite side being a mirror image thereof; and,
FIG. 4 is a bottom view thereof.
The broken lines shown in the drawings illustrate portions of the article and form no part of the claimed design.

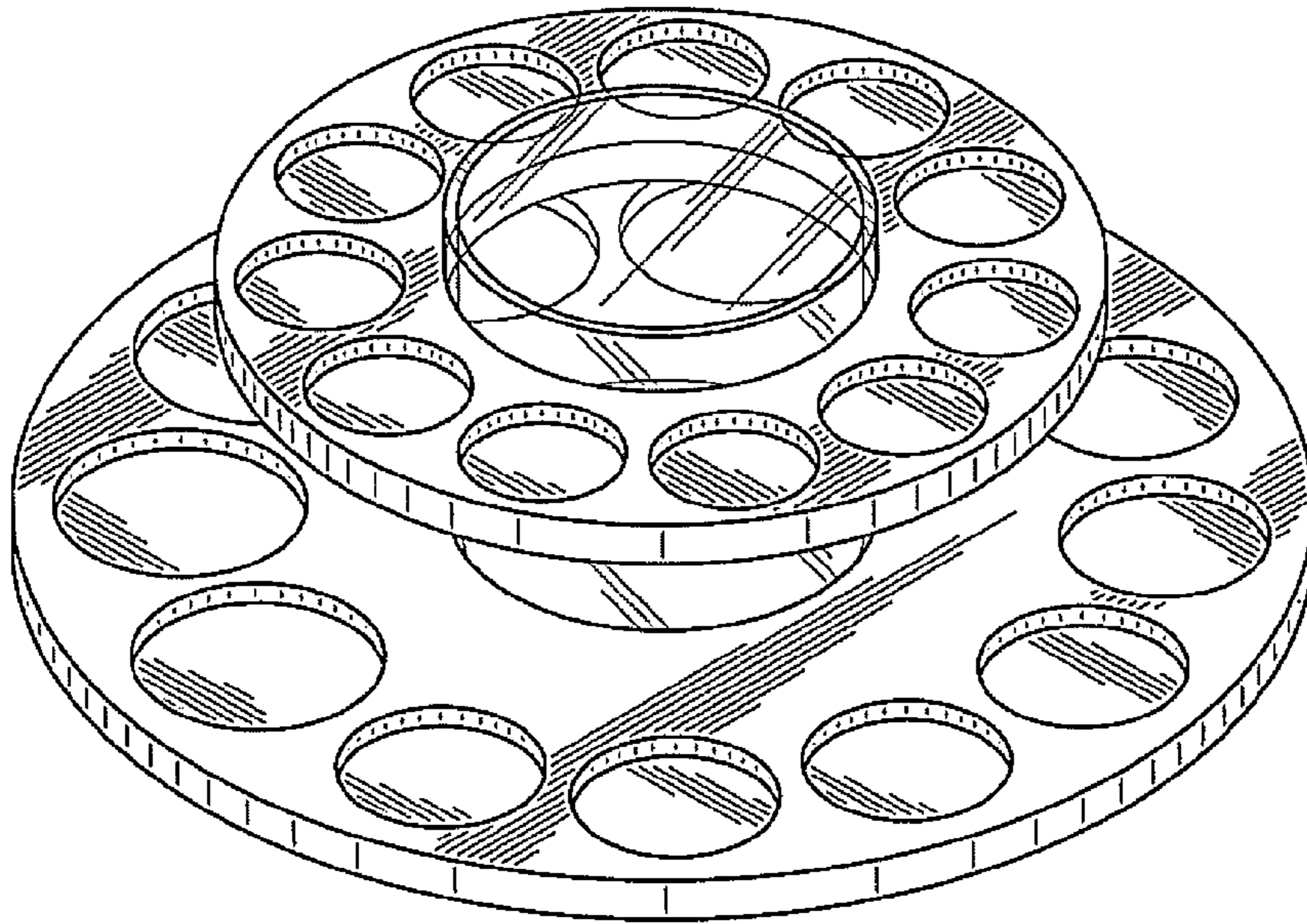

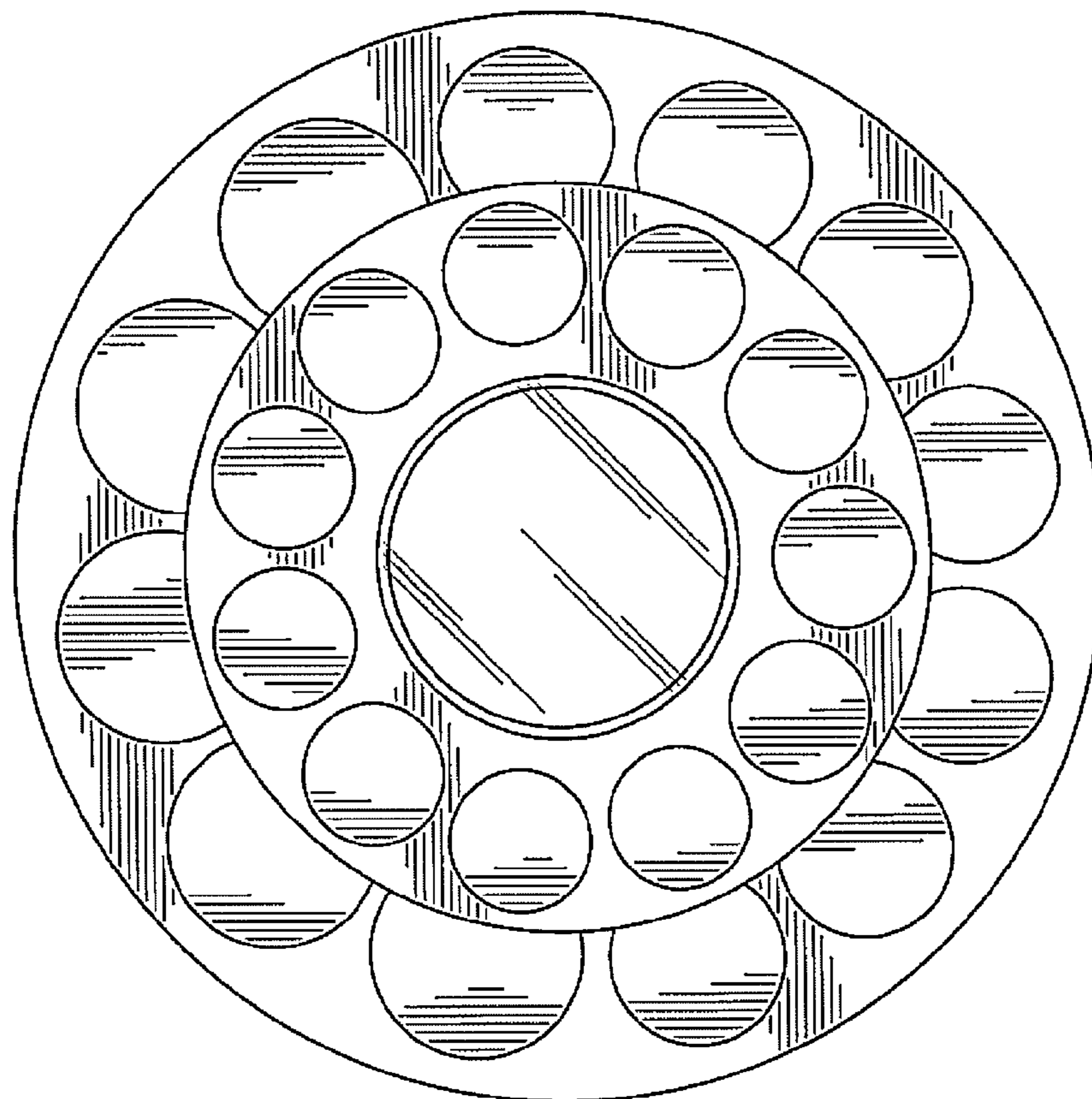

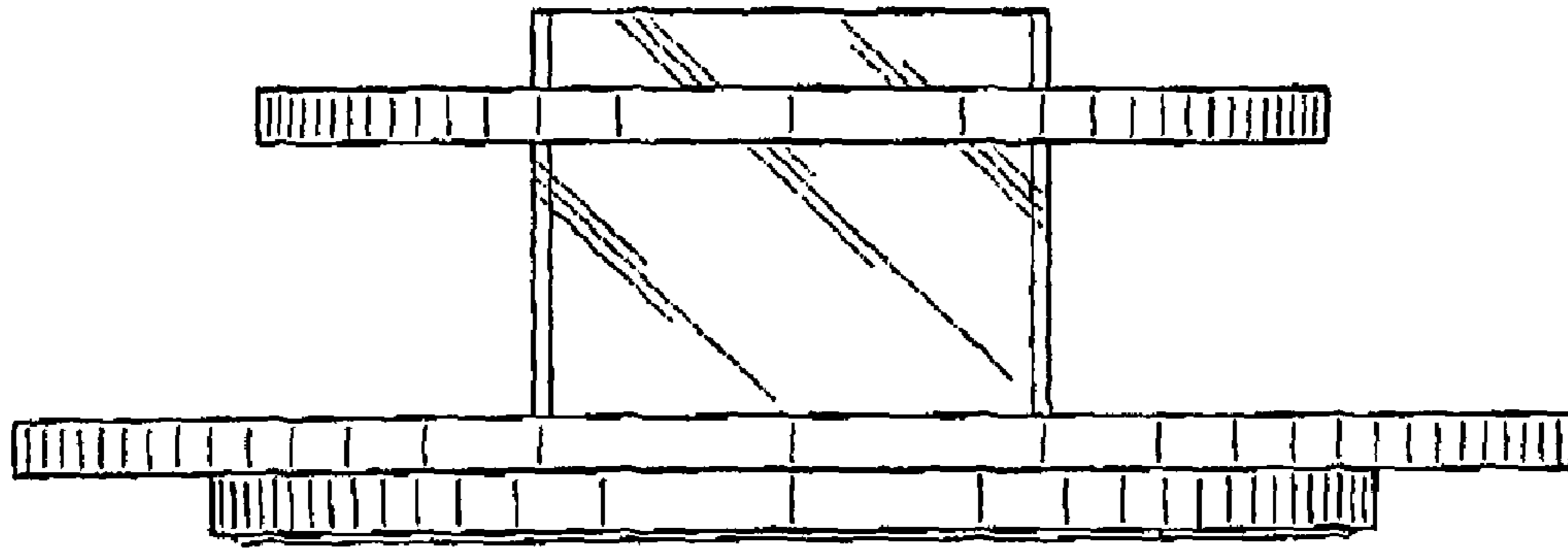

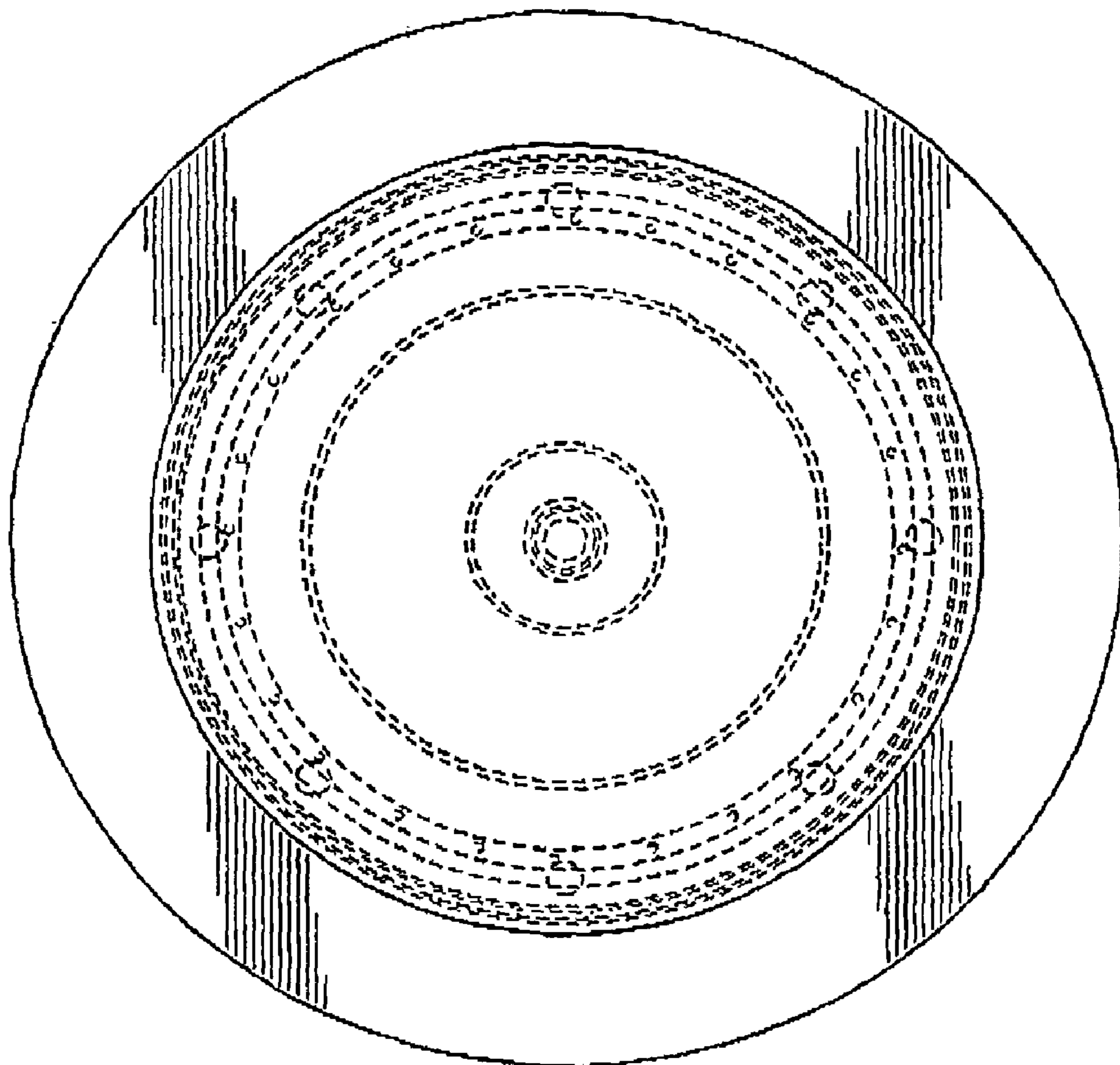
