(57) **CLAIM**

I claim the ornamental design for luggage with shoe compartments, as shown and described.

FIG. 1 is a perspective view of the luggage with shoe compartments;

FIG. 2 is a top plan view of the luggage with shoe compartments;

FIG. 3 is a bottom plan view of the luggage with shoe compartments;

FIG. 4 is a side elevation view of the luggage with shoe compartments;

FIG. 5 is a side elevation view of the opposite side of the luggage with shoe compartments;

FIG. 6 is a rear view of the luggage with shoe compartments showing the handle in an extended position;

FIG. 7 is a front view of the luggage with shoe compartments showing the handle in an extended position;

FIG. 8 is a front view of the luggage with shoe compartments, showing the shoe compartments open;

FIG. 9 is a perspective view of the luggage with shoe compartments showing the interior of the luggage; and,

FIG. 10 is a perspective view of the luggage with shoe compartments, showing the upper portion of the luggage in an expanded position and with the shoe compartments open.

The broken line showing of environment in FIG. 8 and FIG. 10 is included for the purpose of illustration only and forms no part of the claimed design.

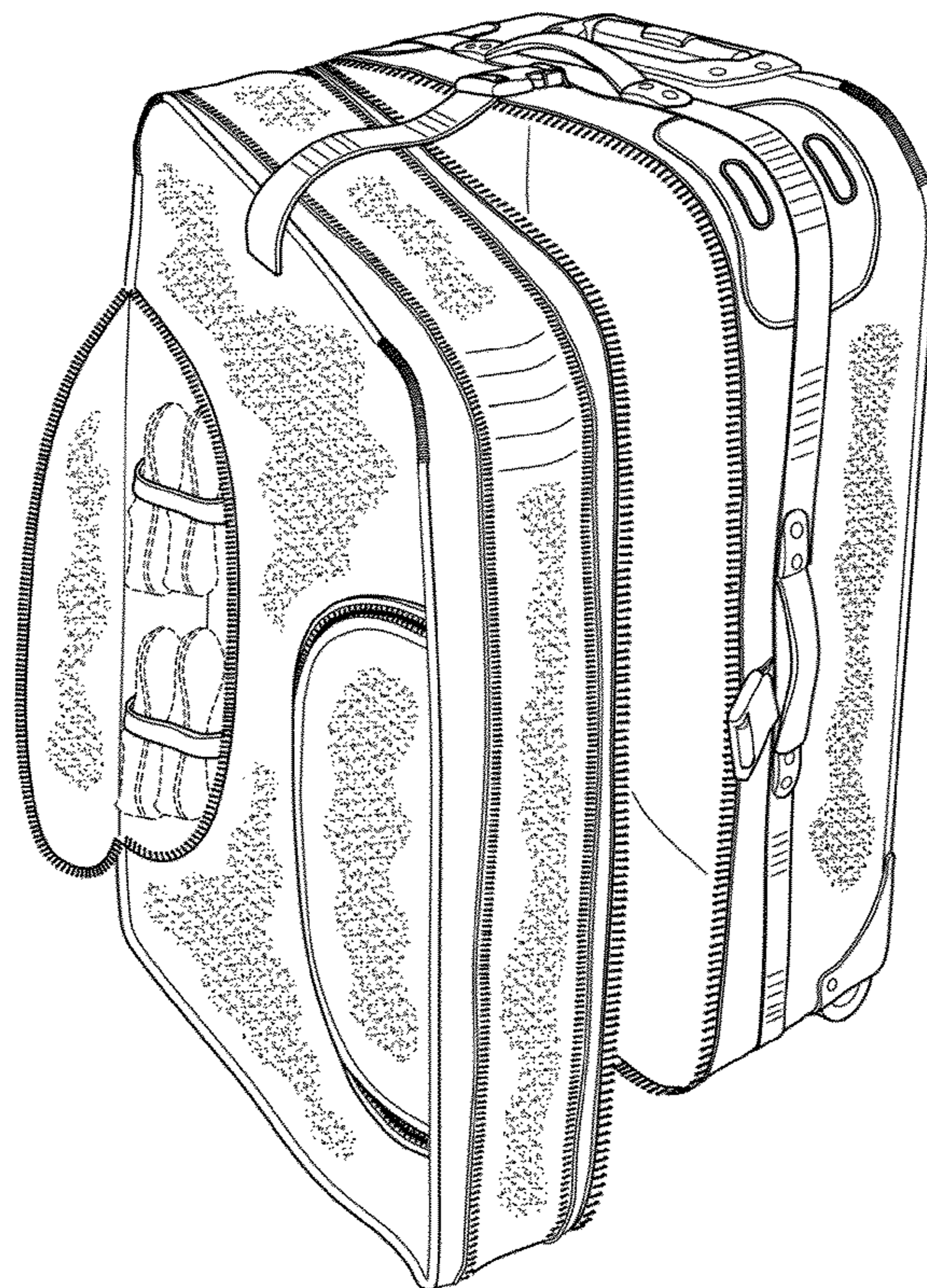

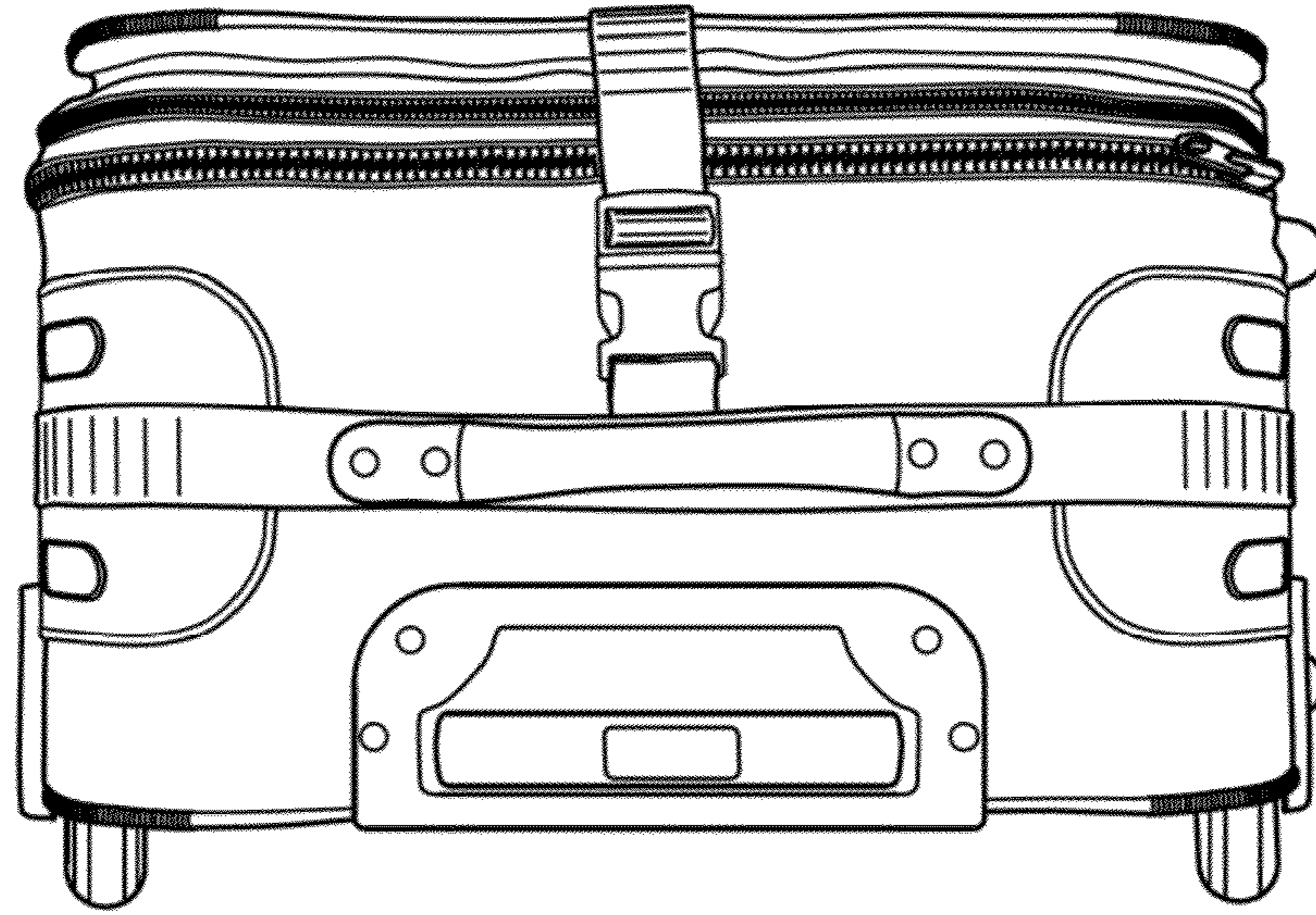

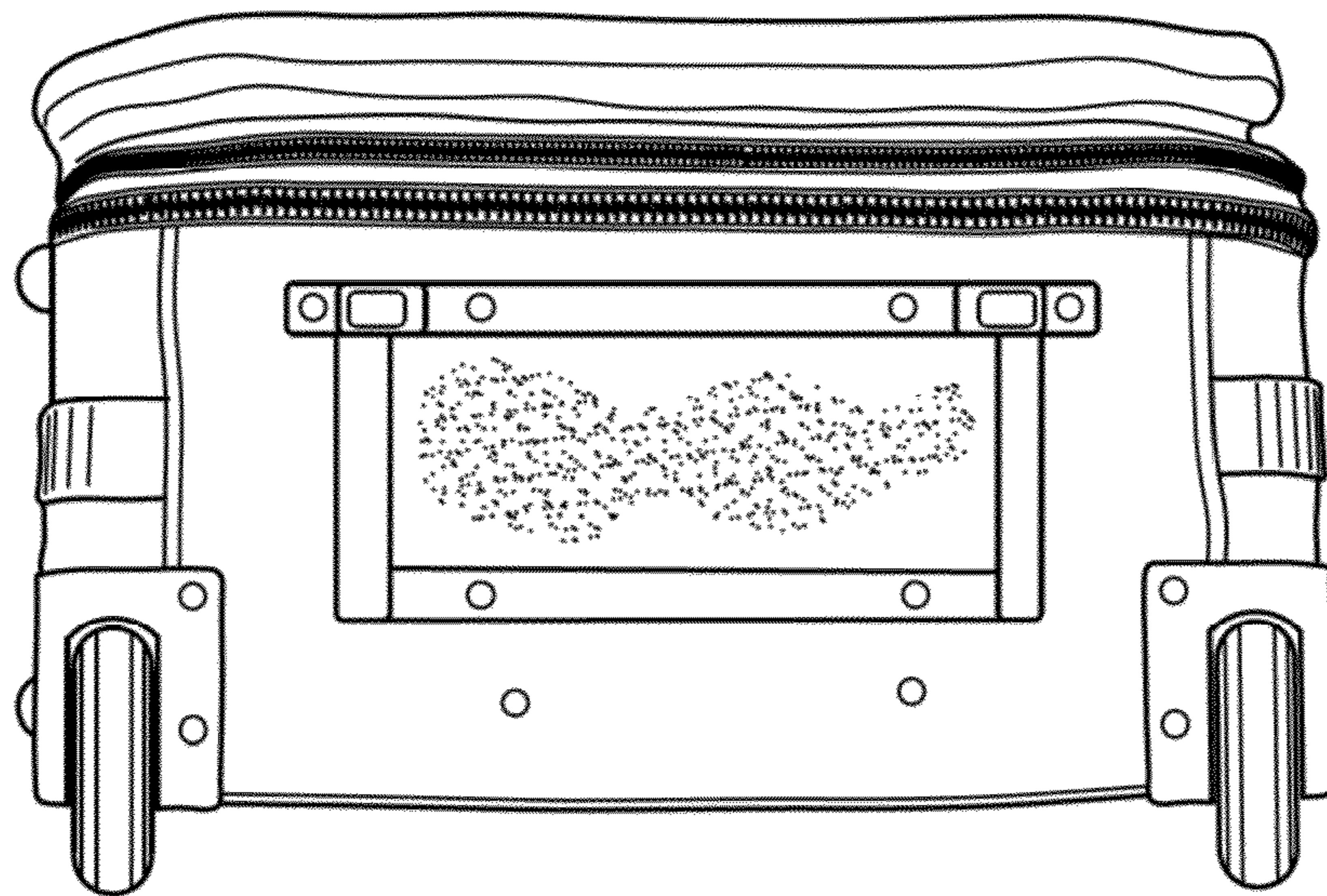

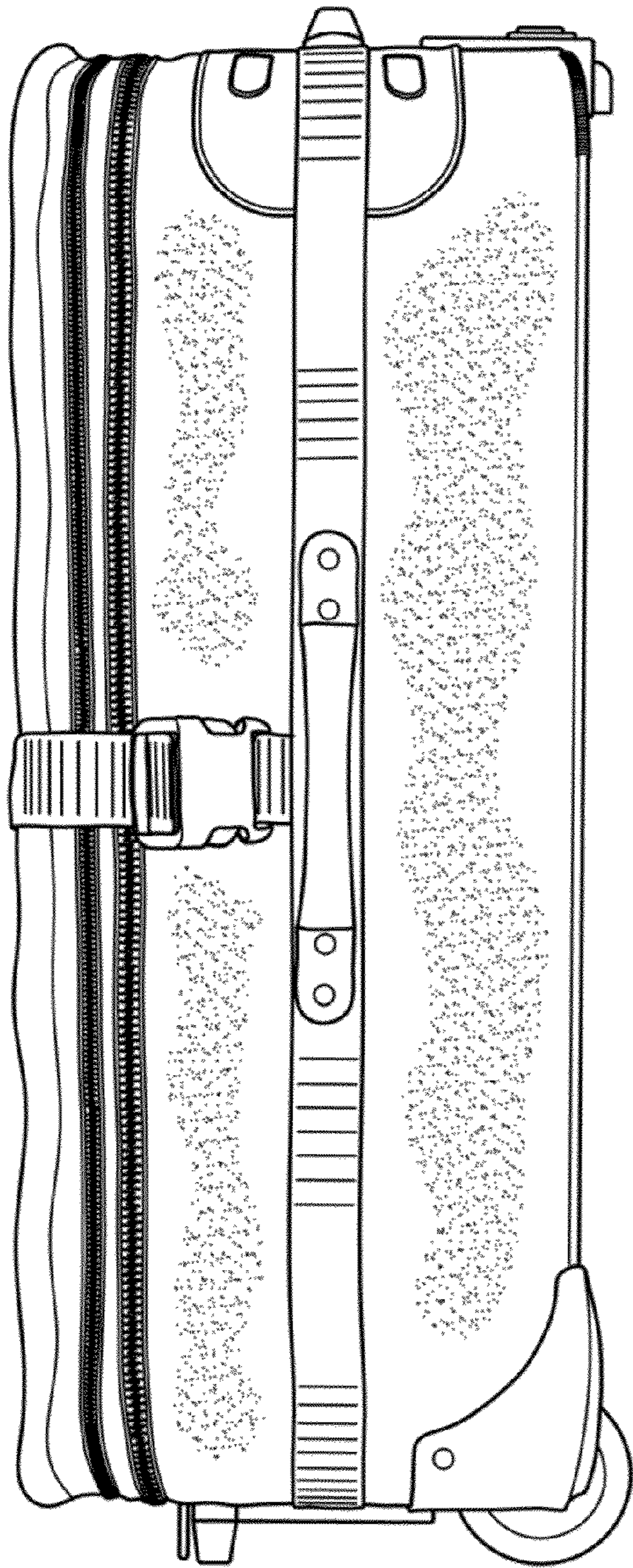

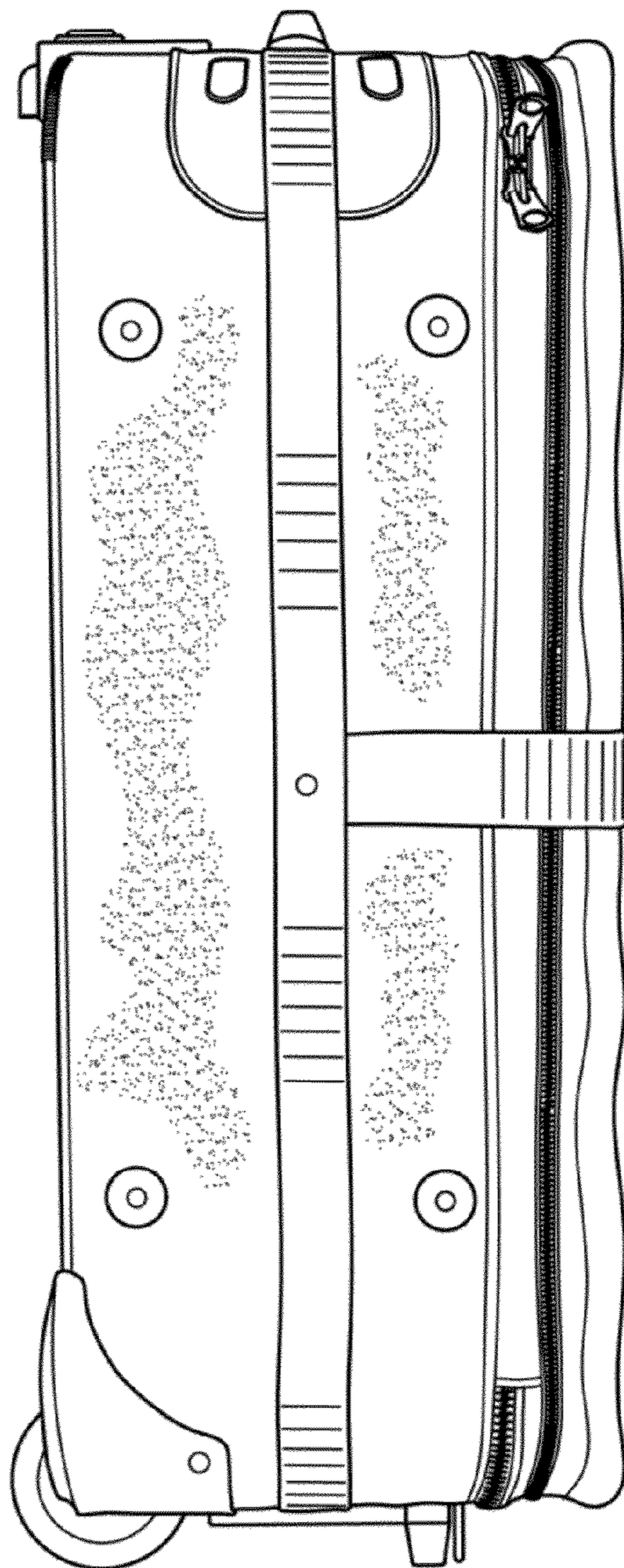

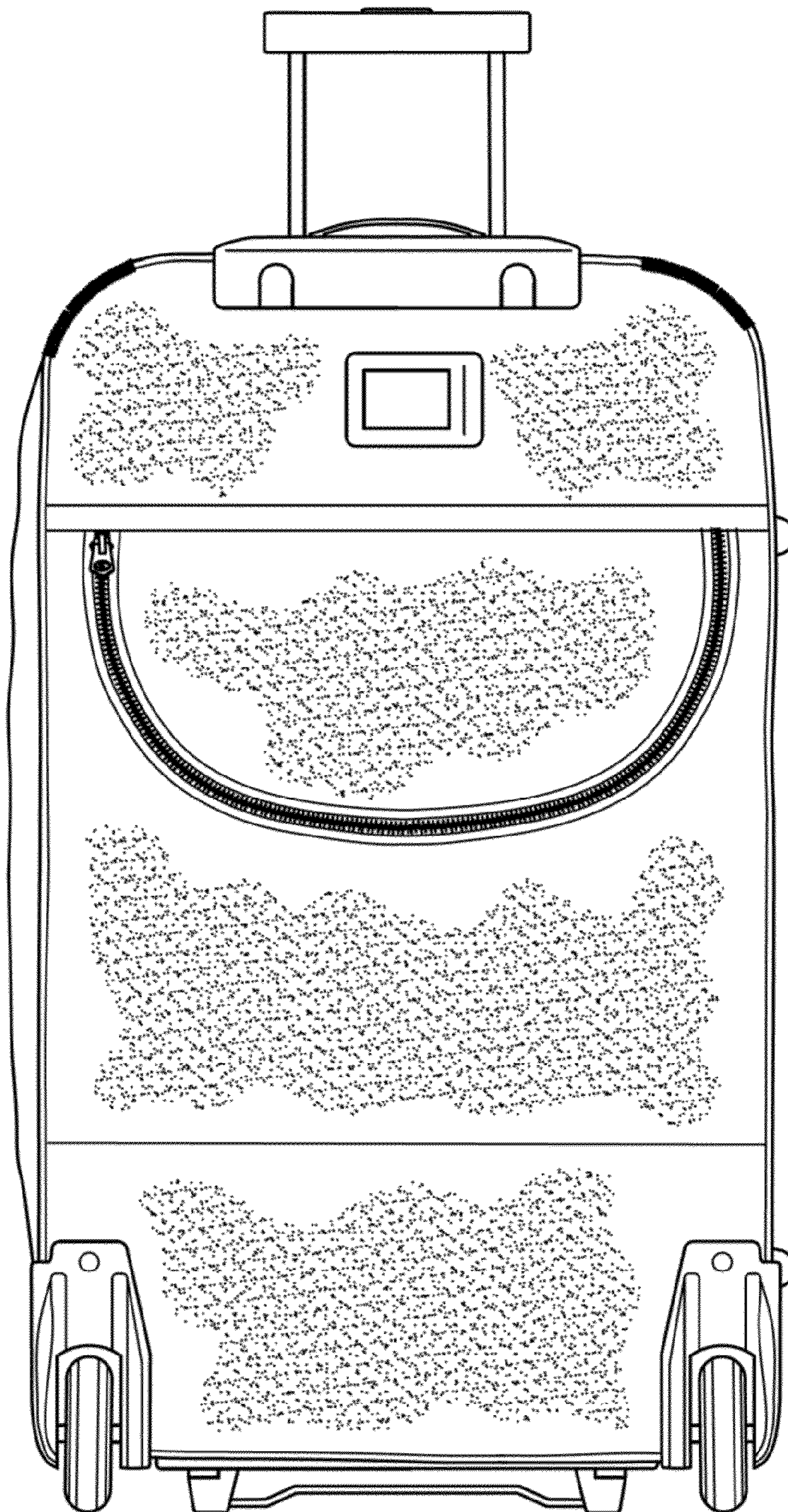

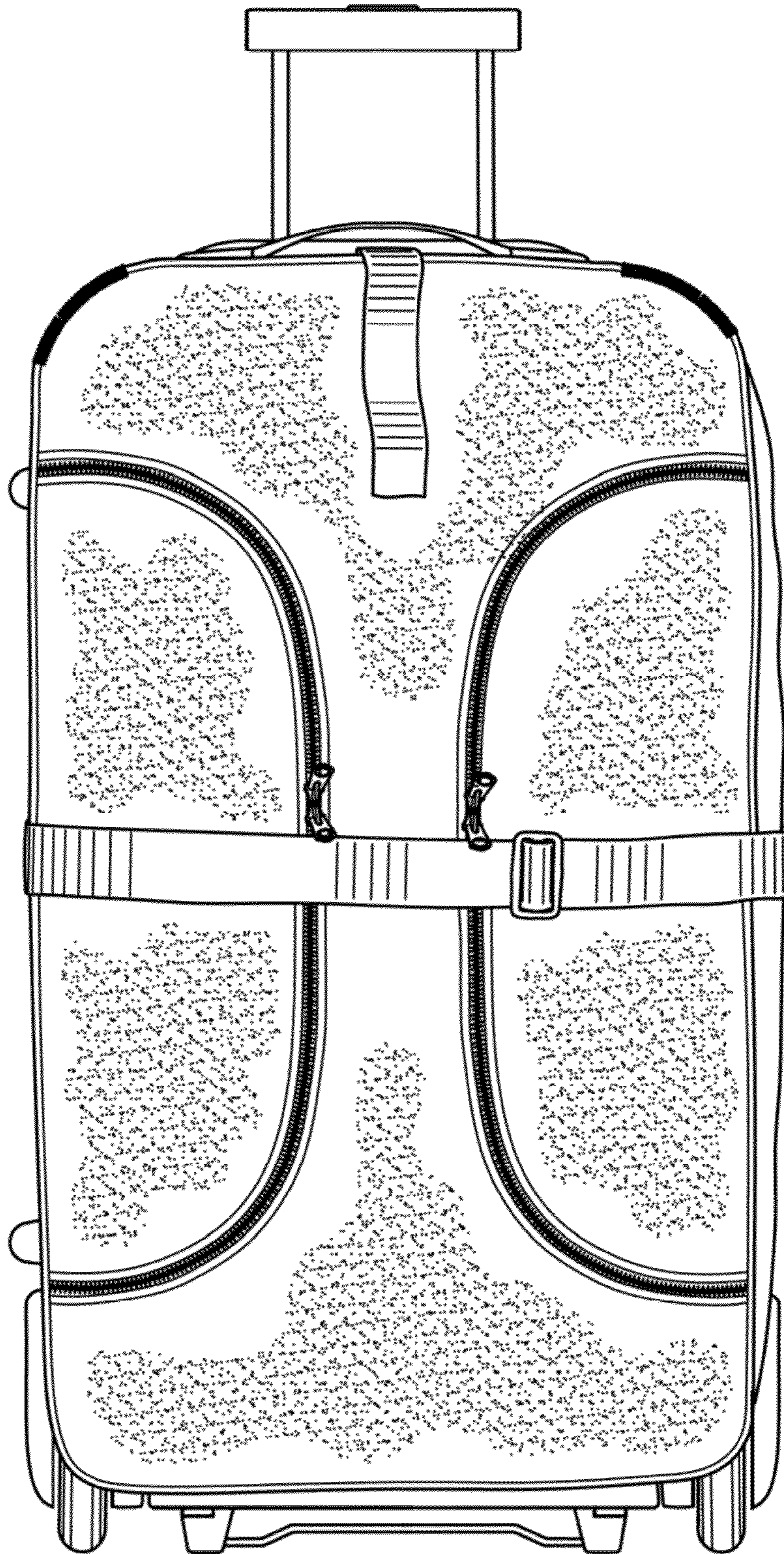

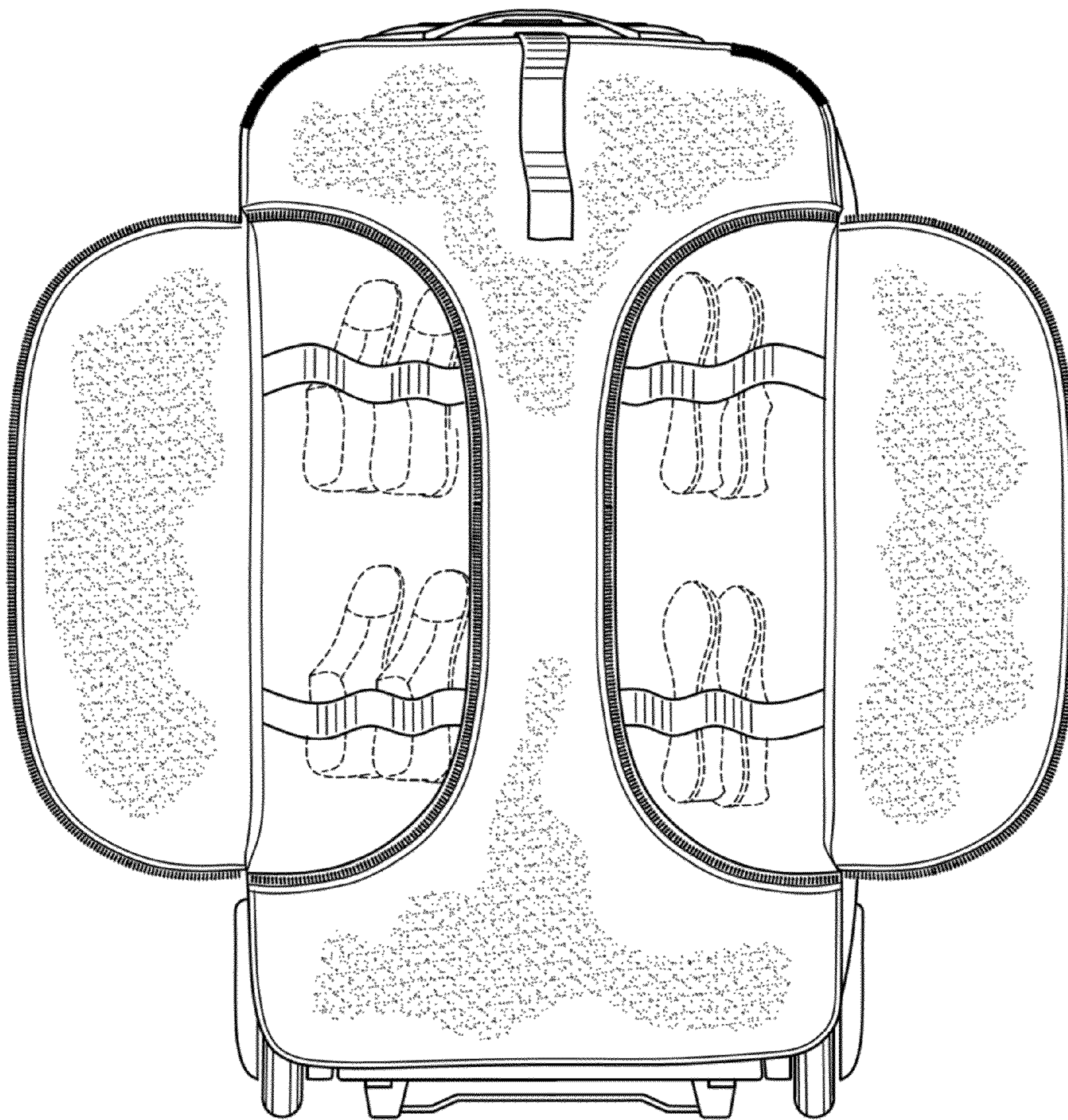

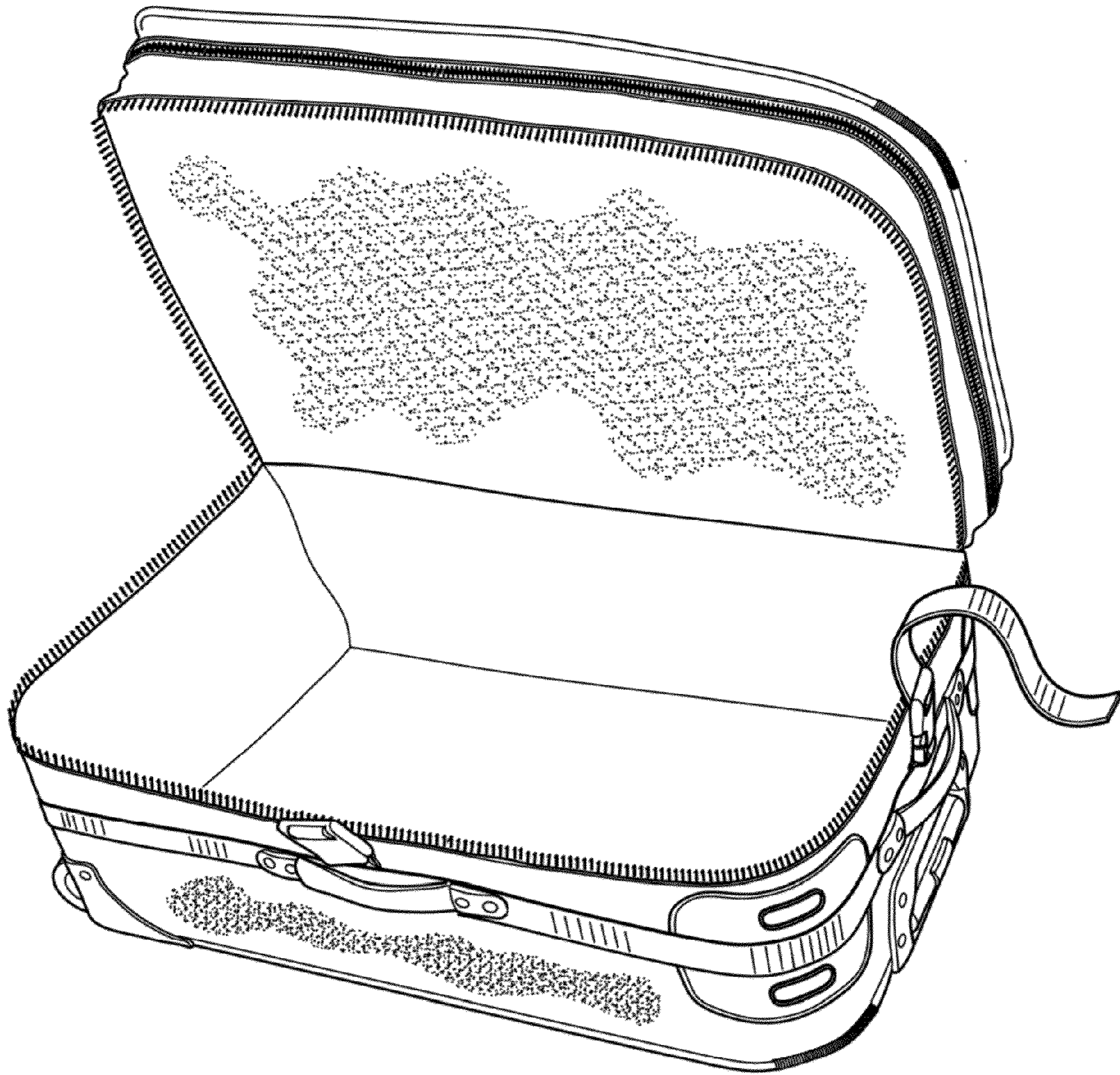

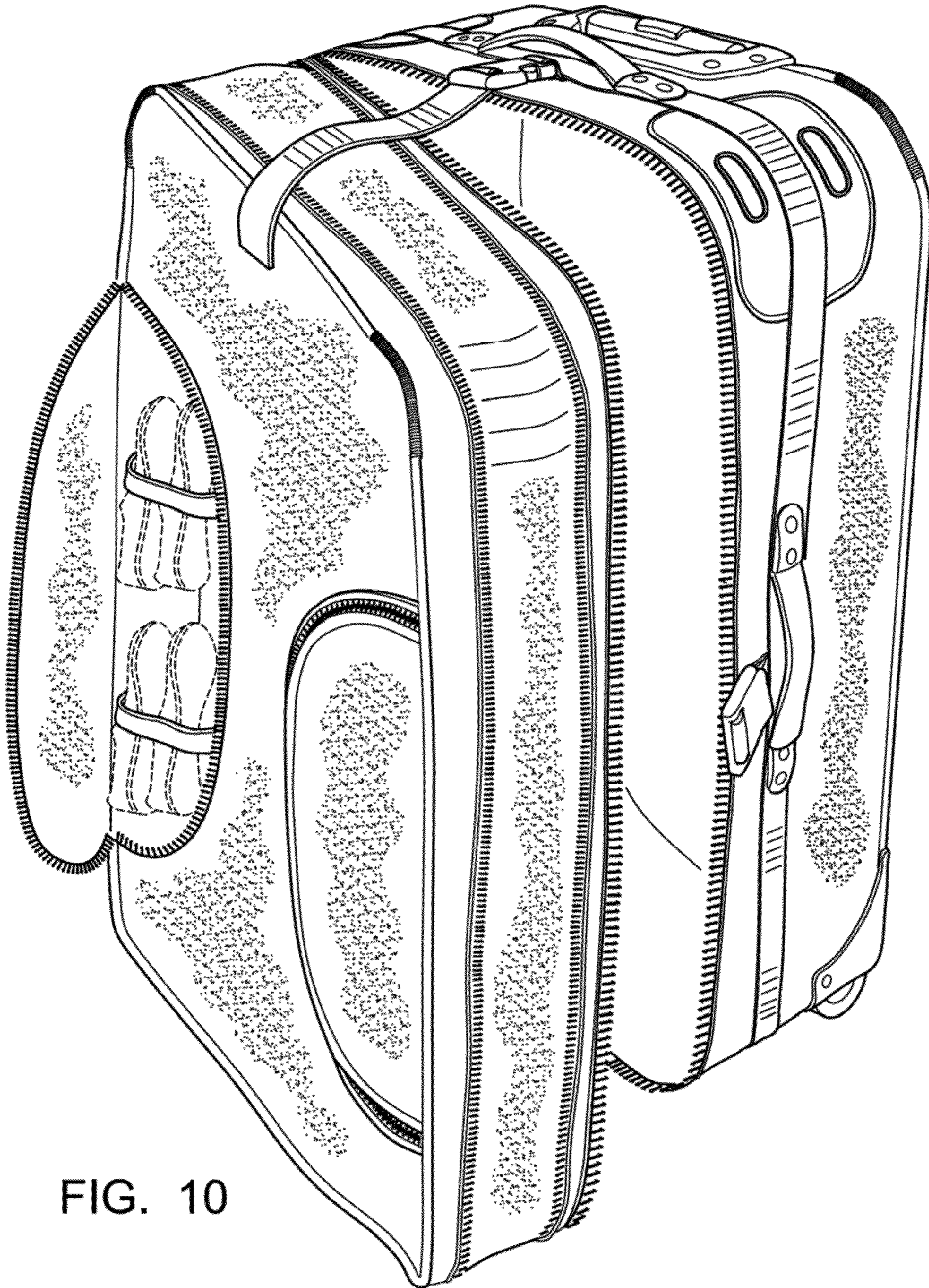
