(57) **CLAIM**

The ornamental design for a bag bundle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a bag bundle embodying the present invention.

FIG. 2 is a rear view of the bag bundle.

FIG. 3 is a left side view of the bag bundle.

FIG. 4 is a right side view of the bag bundle.

FIG. 5 is a top view of the bag bundle.

FIG. 6 is a bottom view of the bag bundle.

FIG. 7 is a front/side isometric view of bag bundle with contents on three strip backing; and,

FIG. 8 is a front/side view of a bag bundle with contents pulled forward from three strip backing.

The broken lines illustrate the environment of the article and form no part of the claimed design.

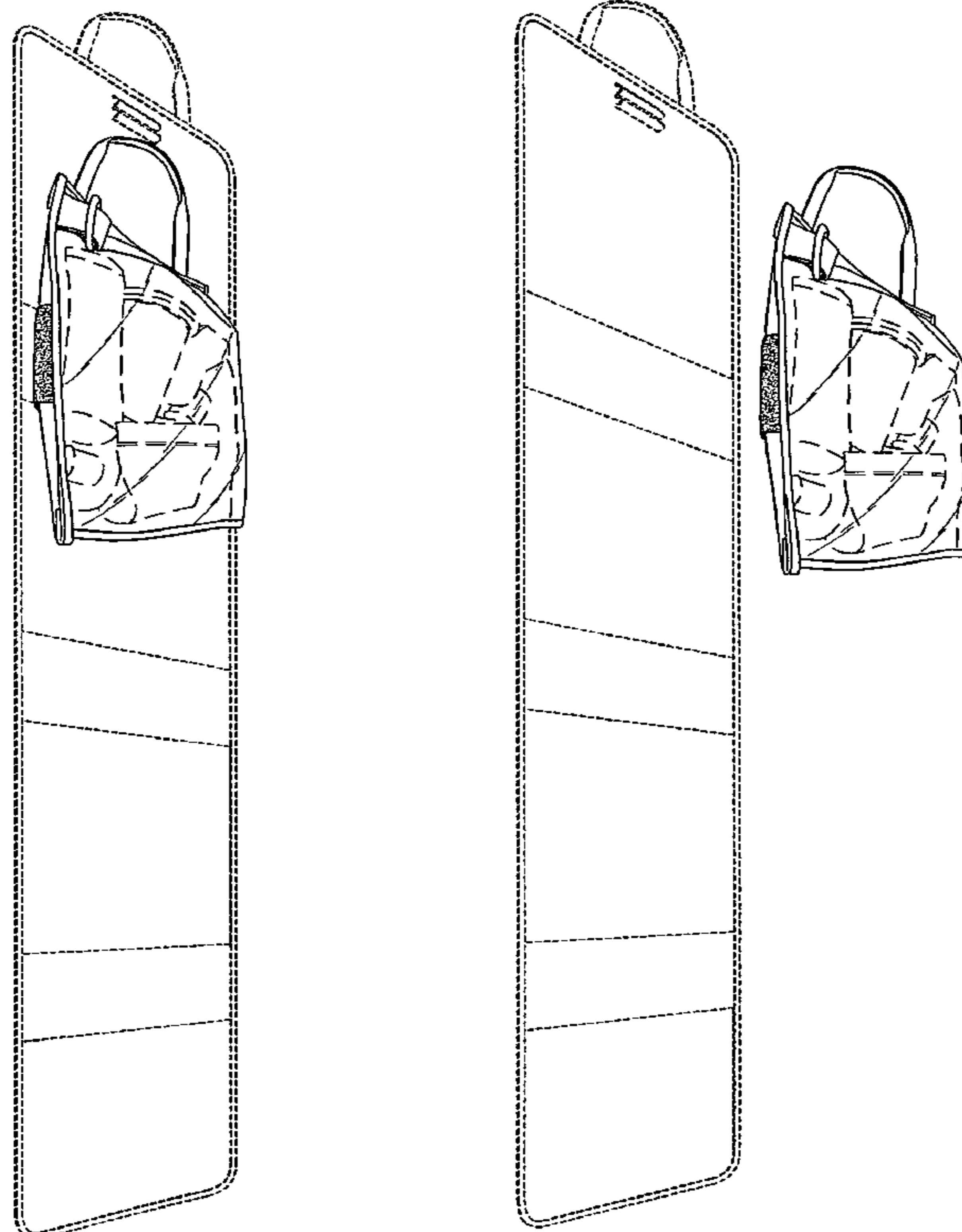

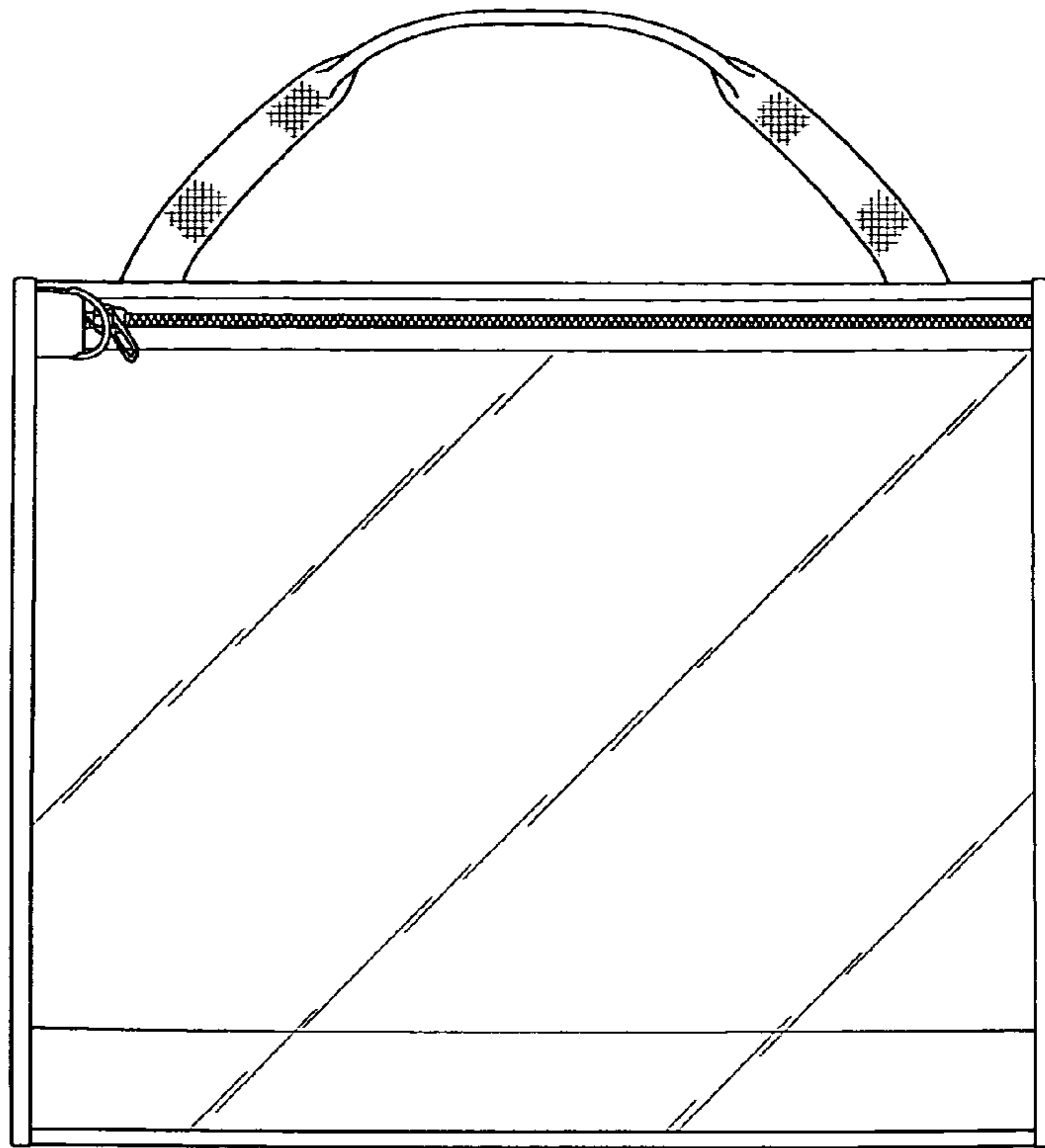
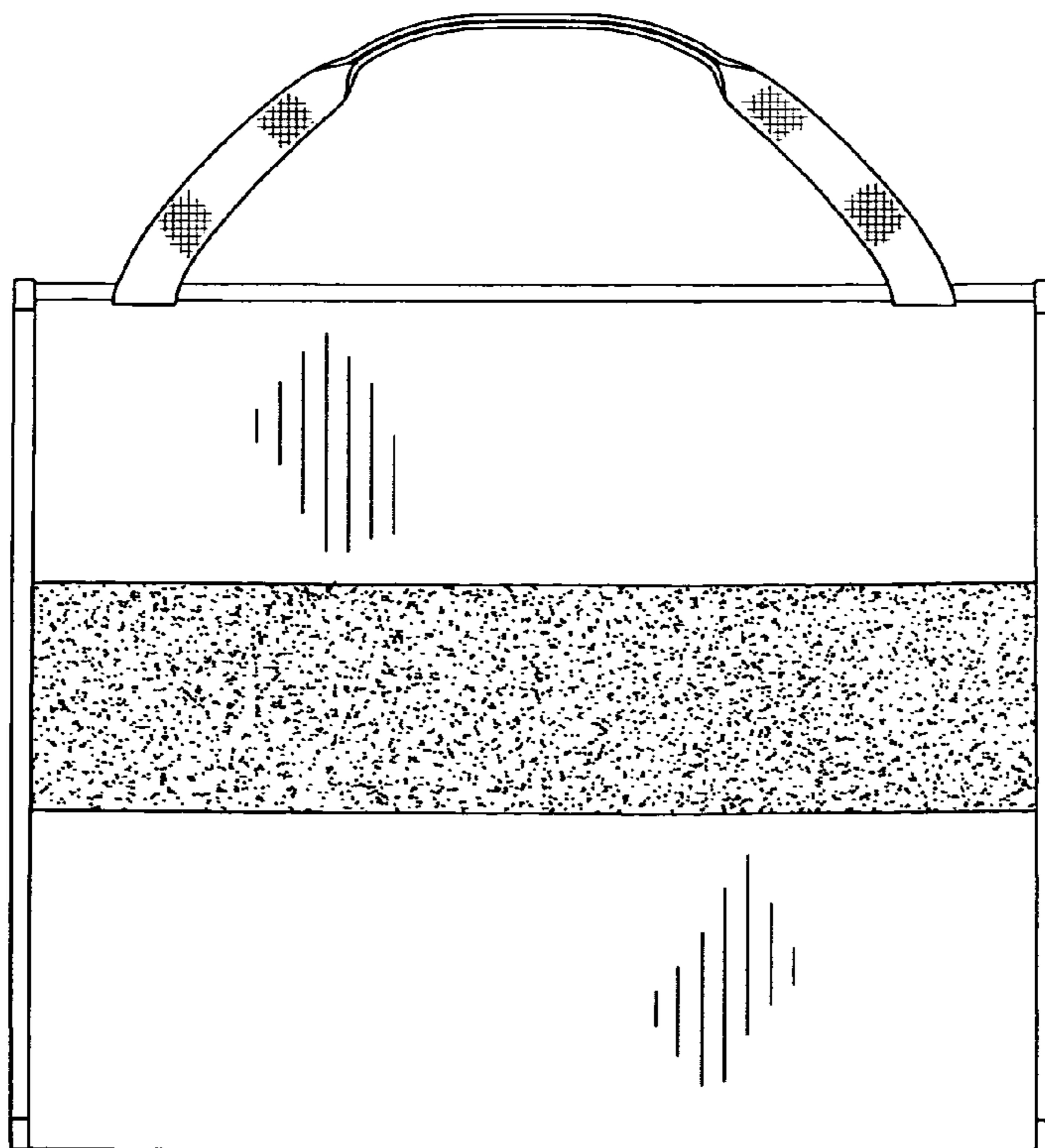

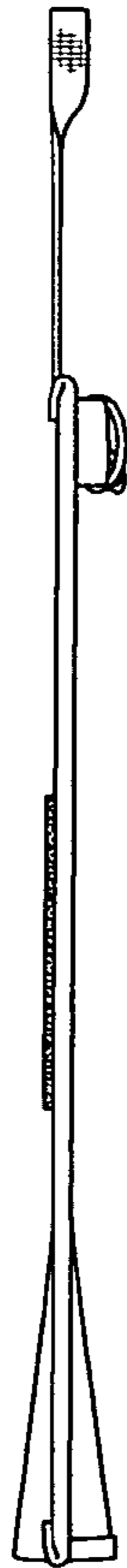

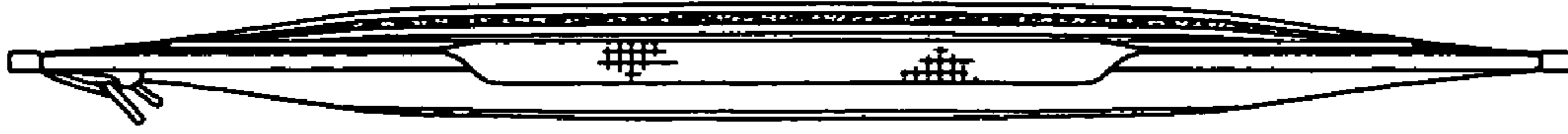

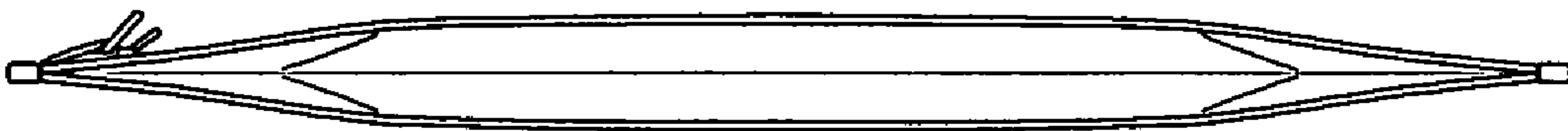

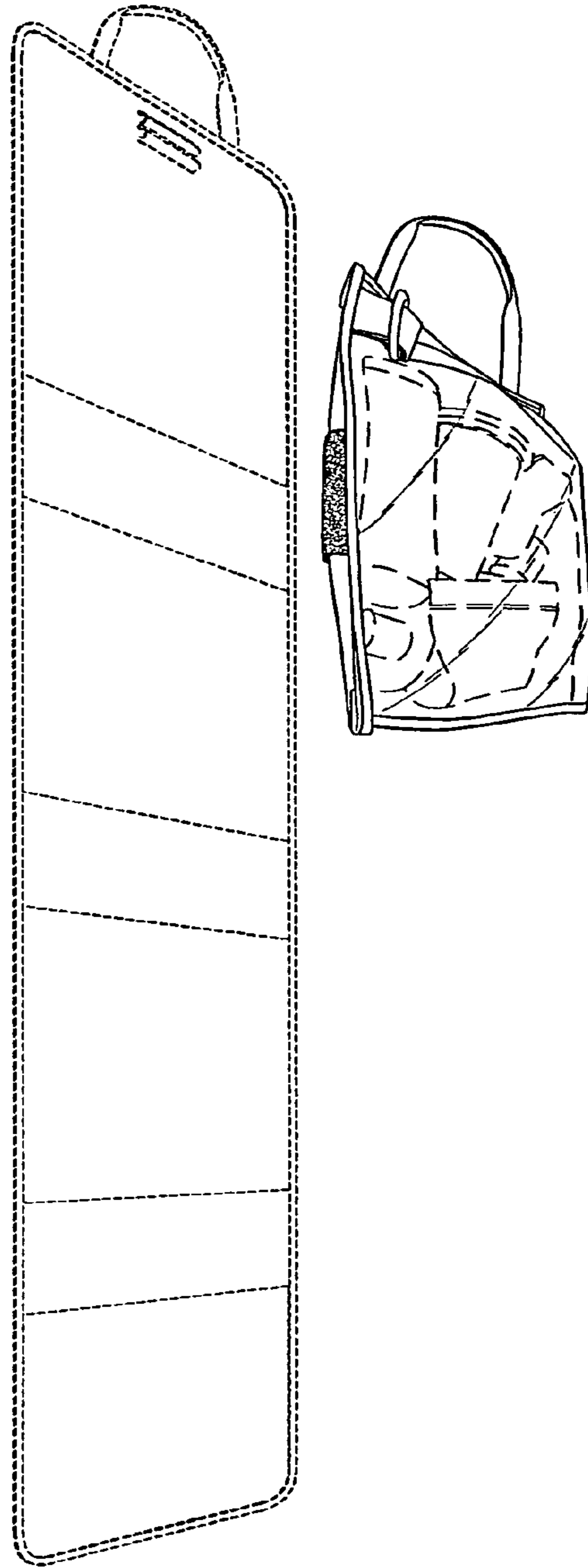
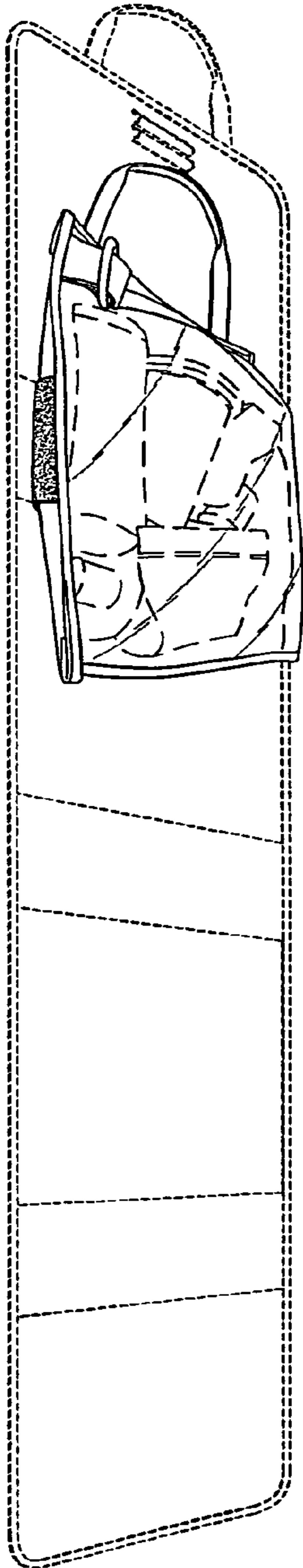
