I claim the ornamental design for a modular storage unit set, as shown and described.

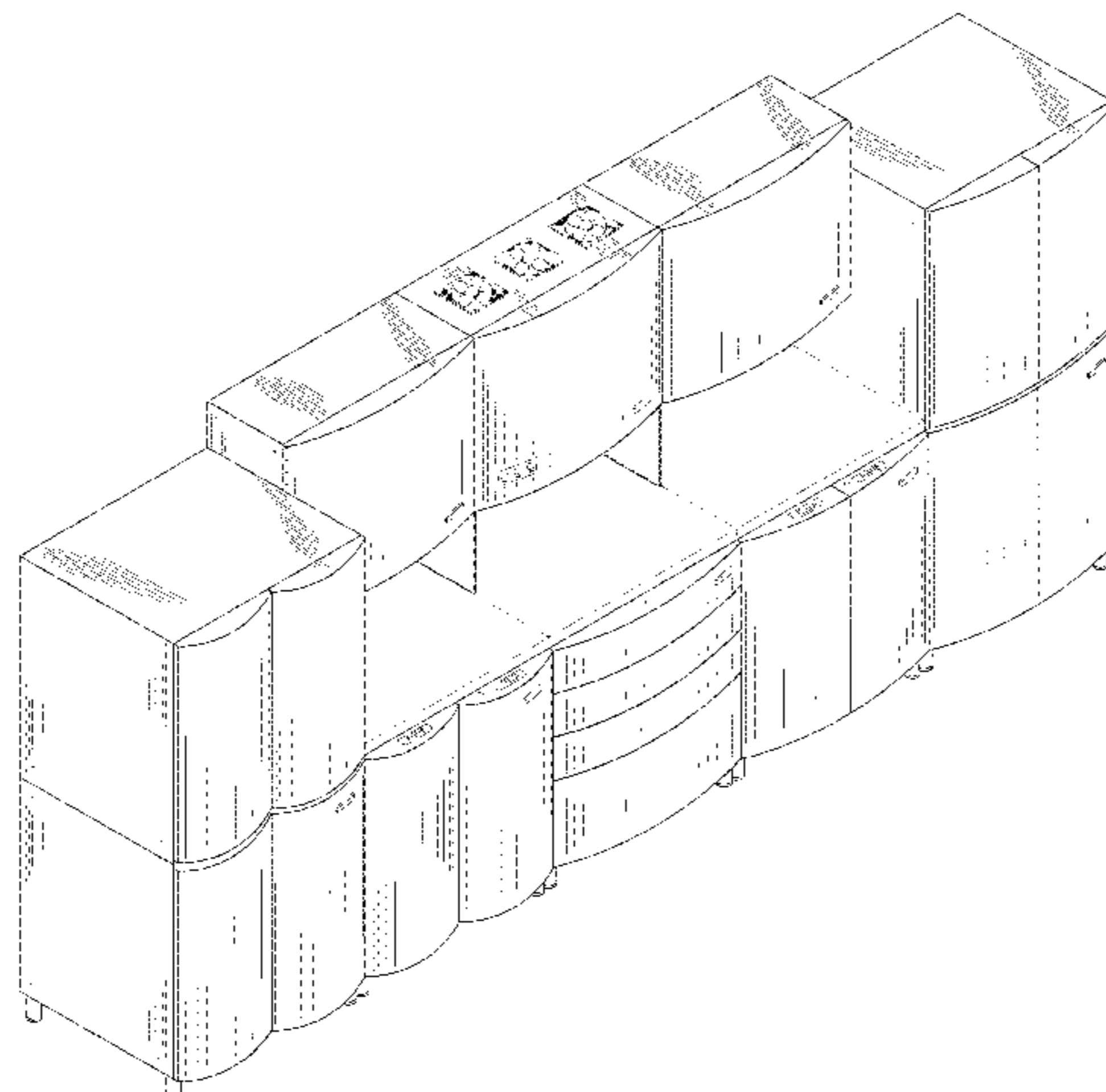
DESCRIPTION

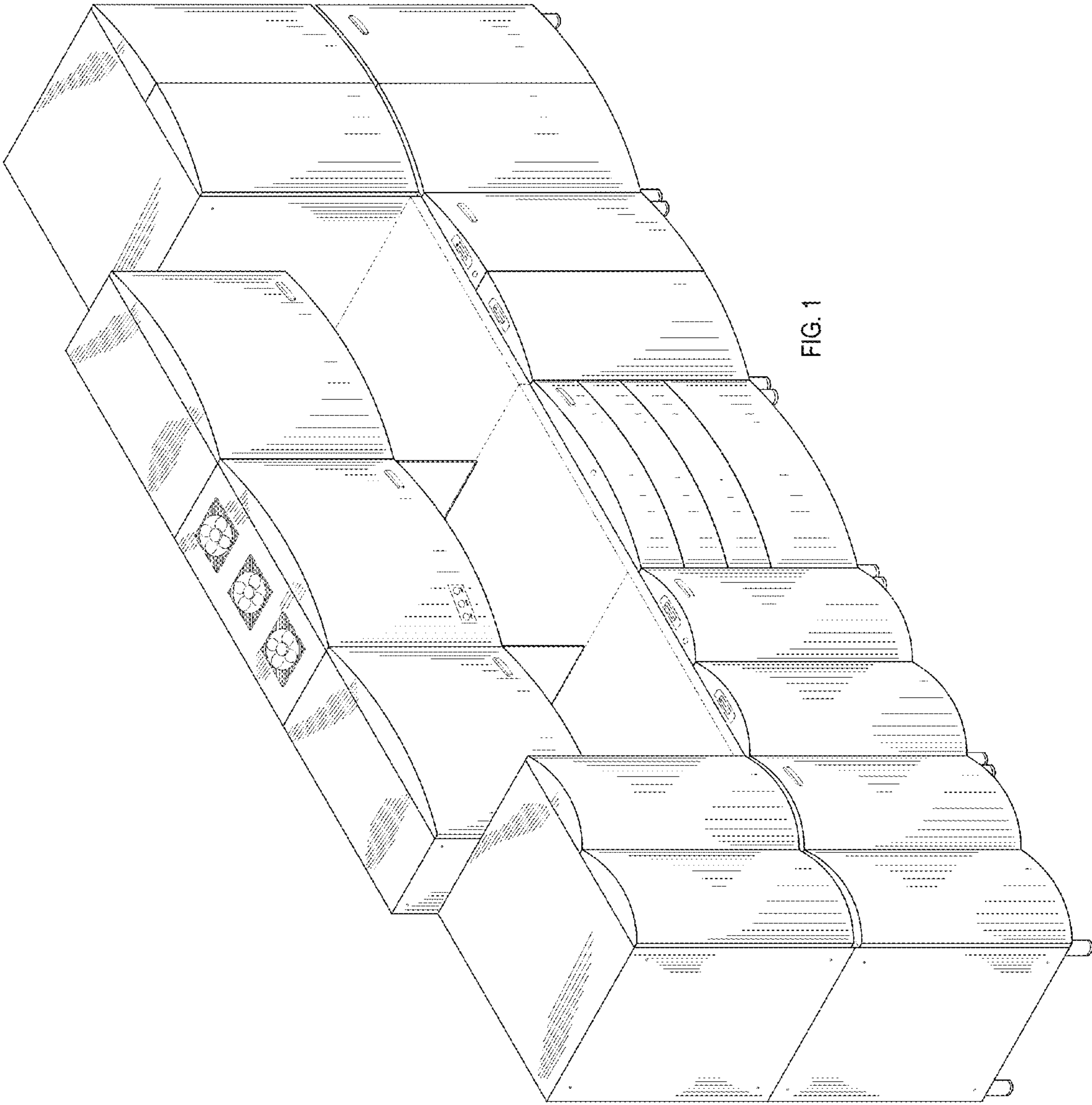

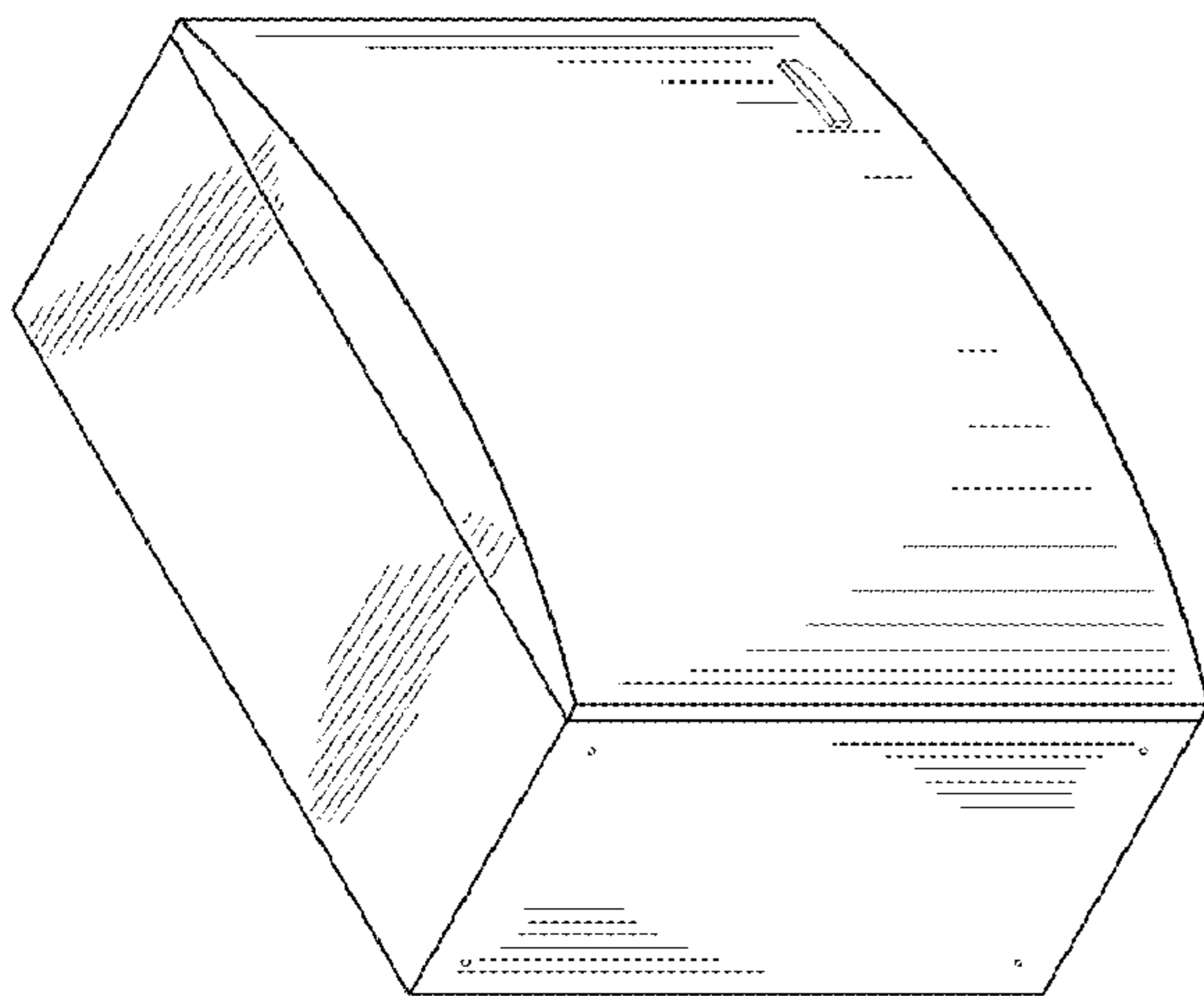

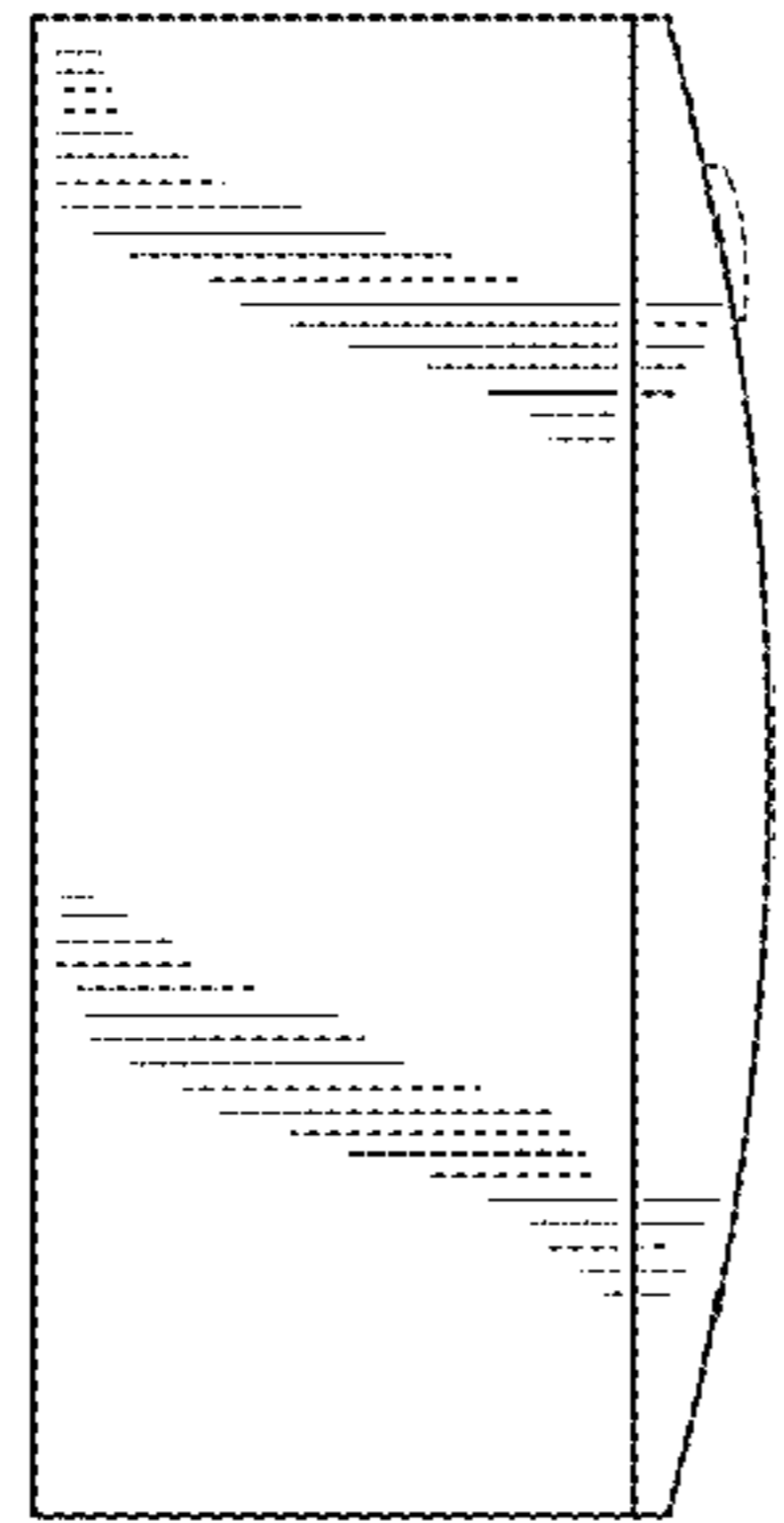

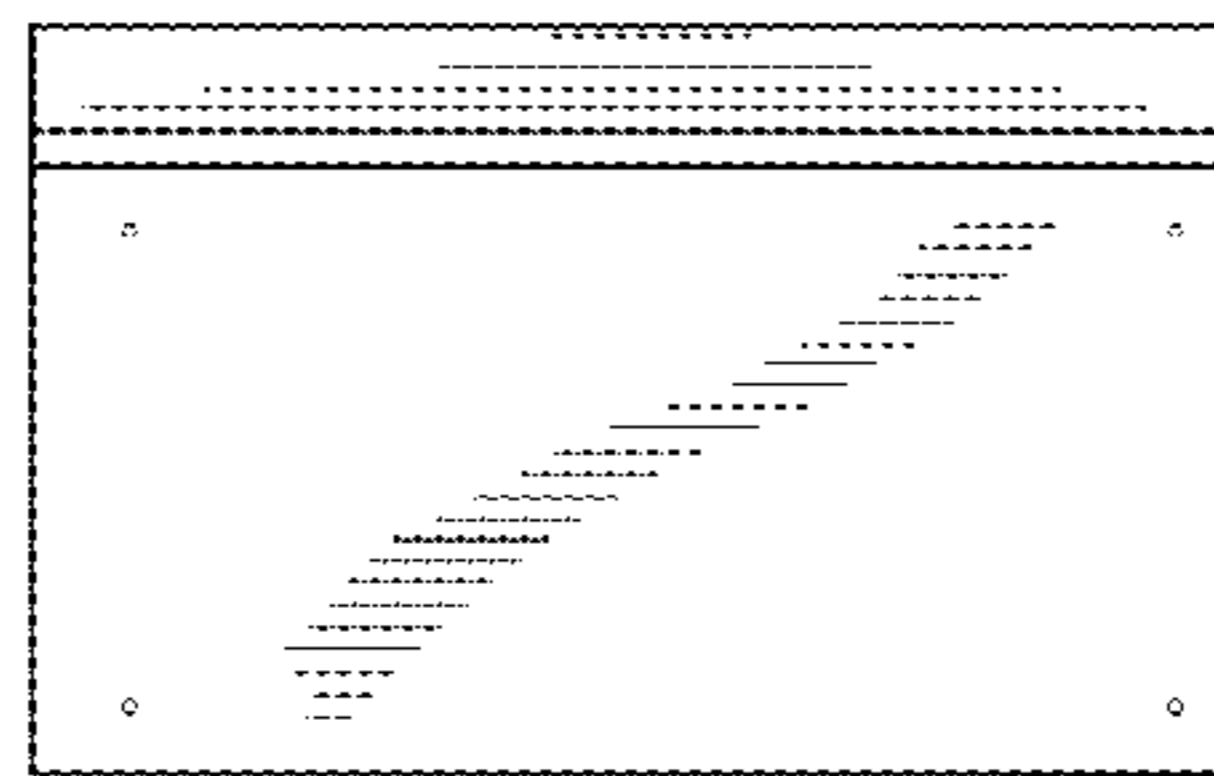

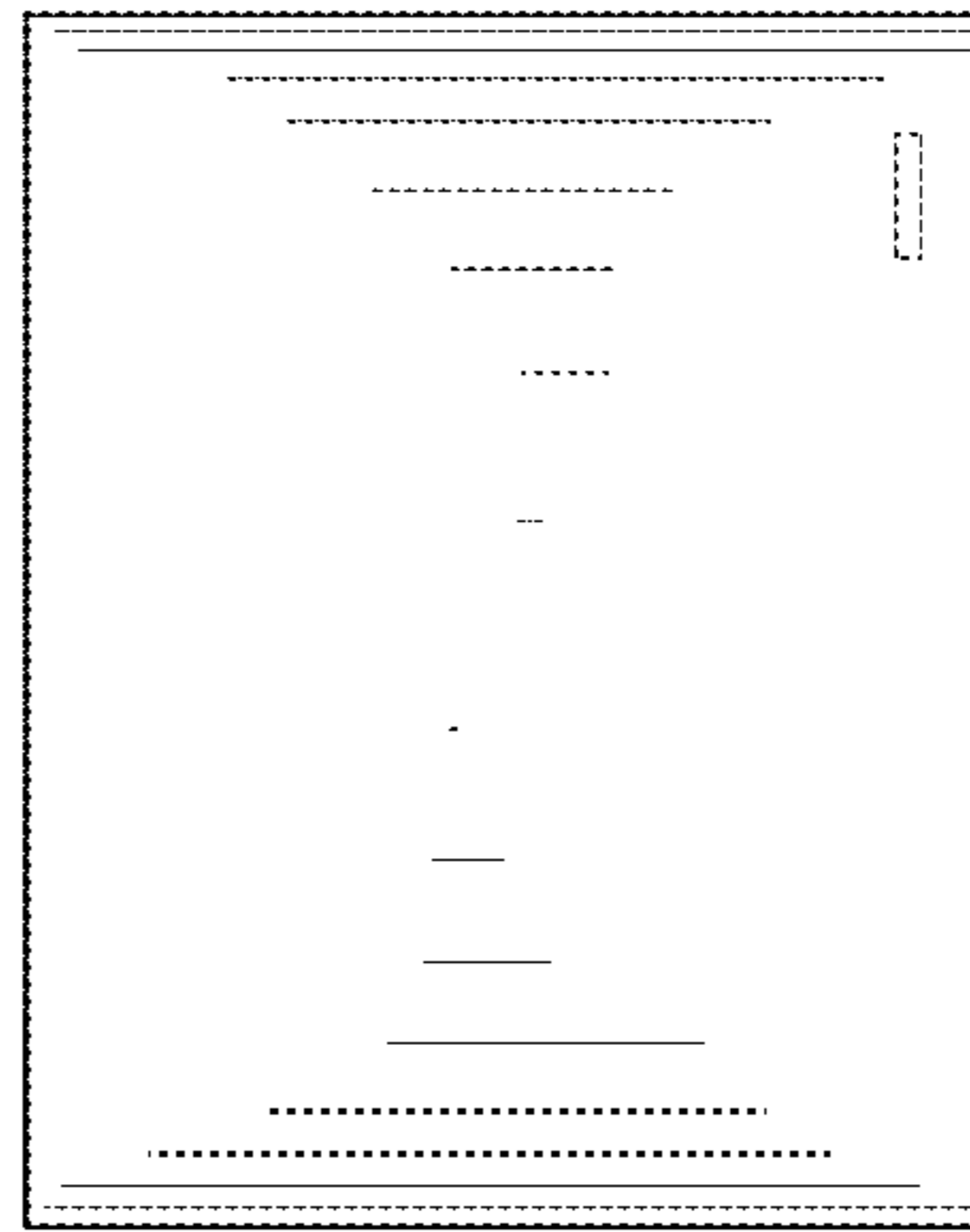

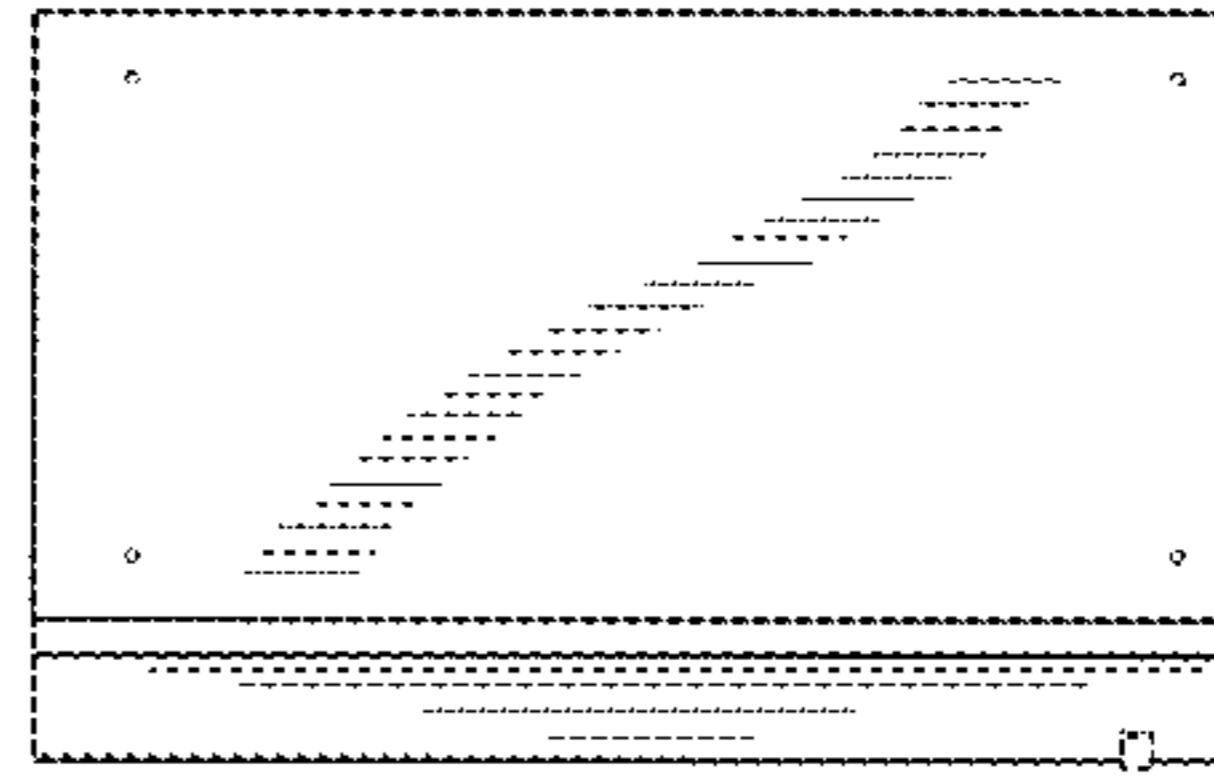
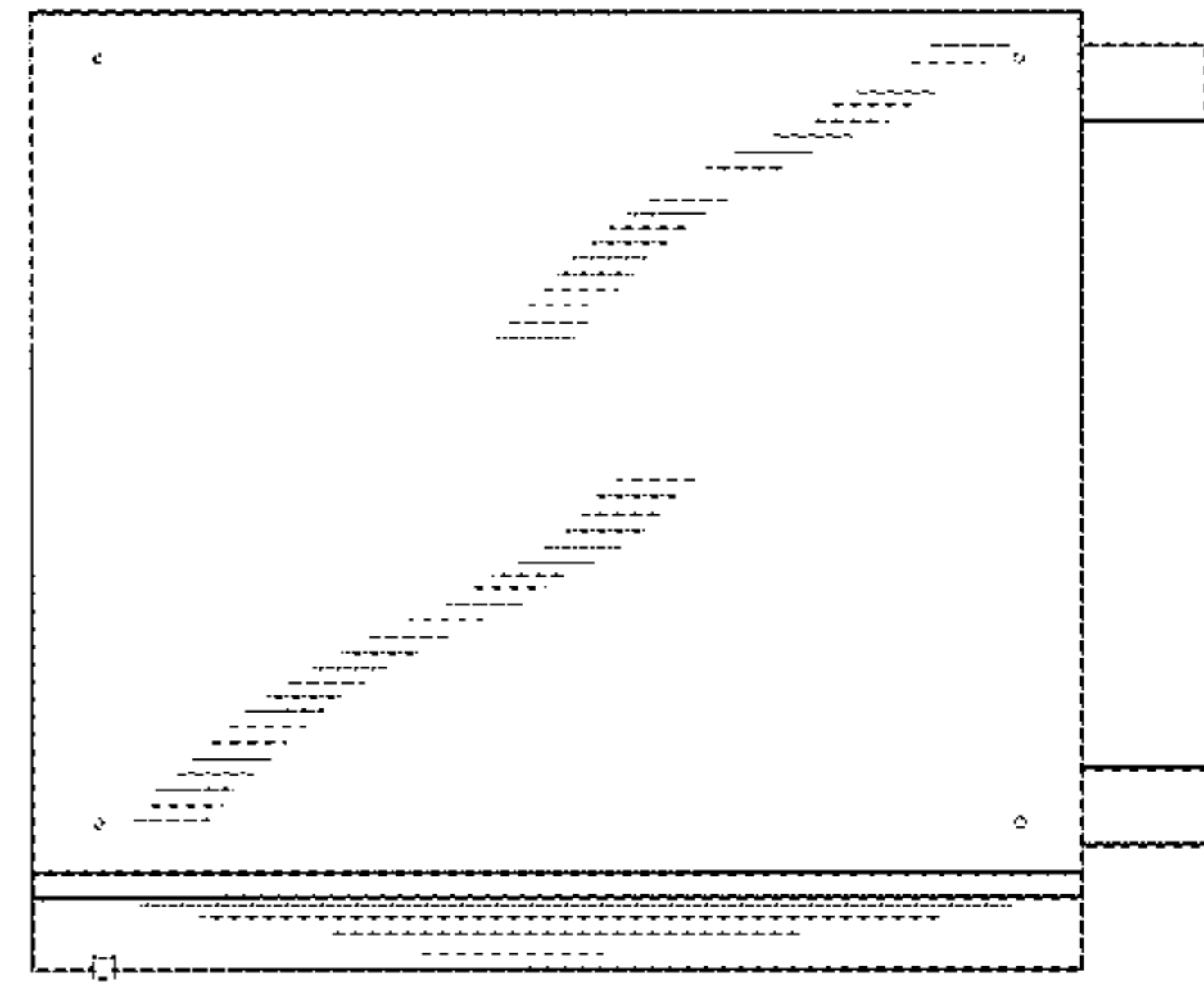
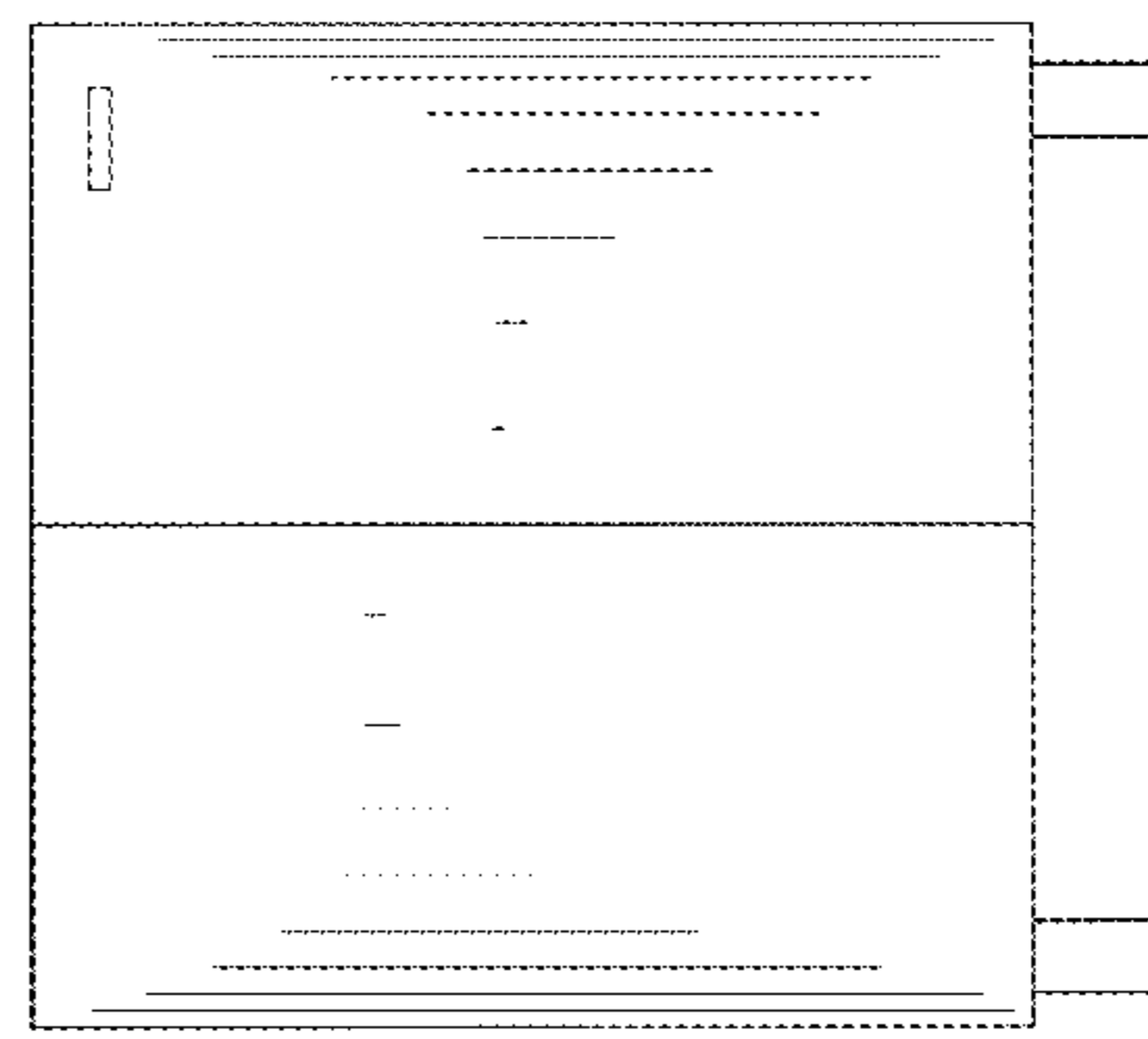
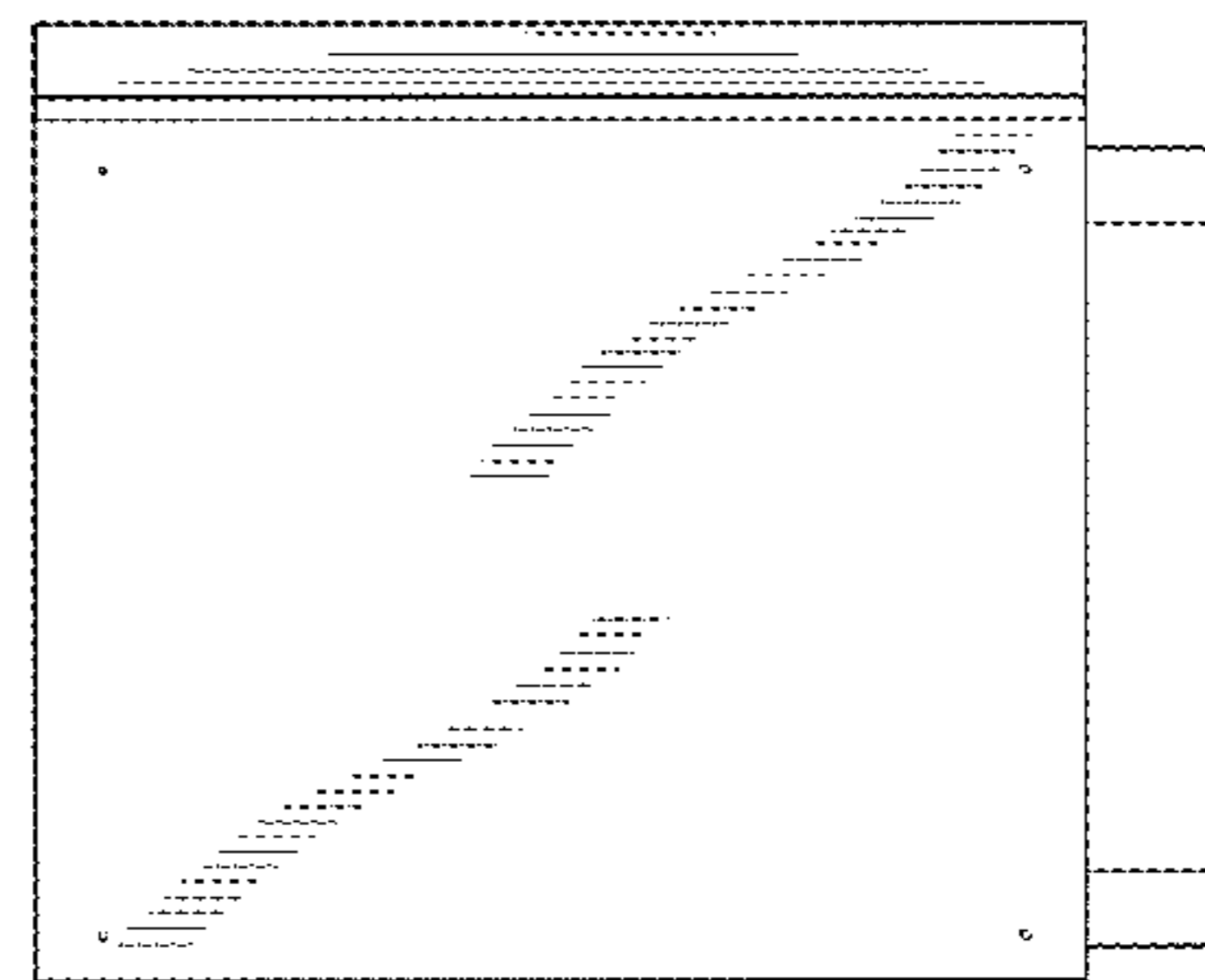
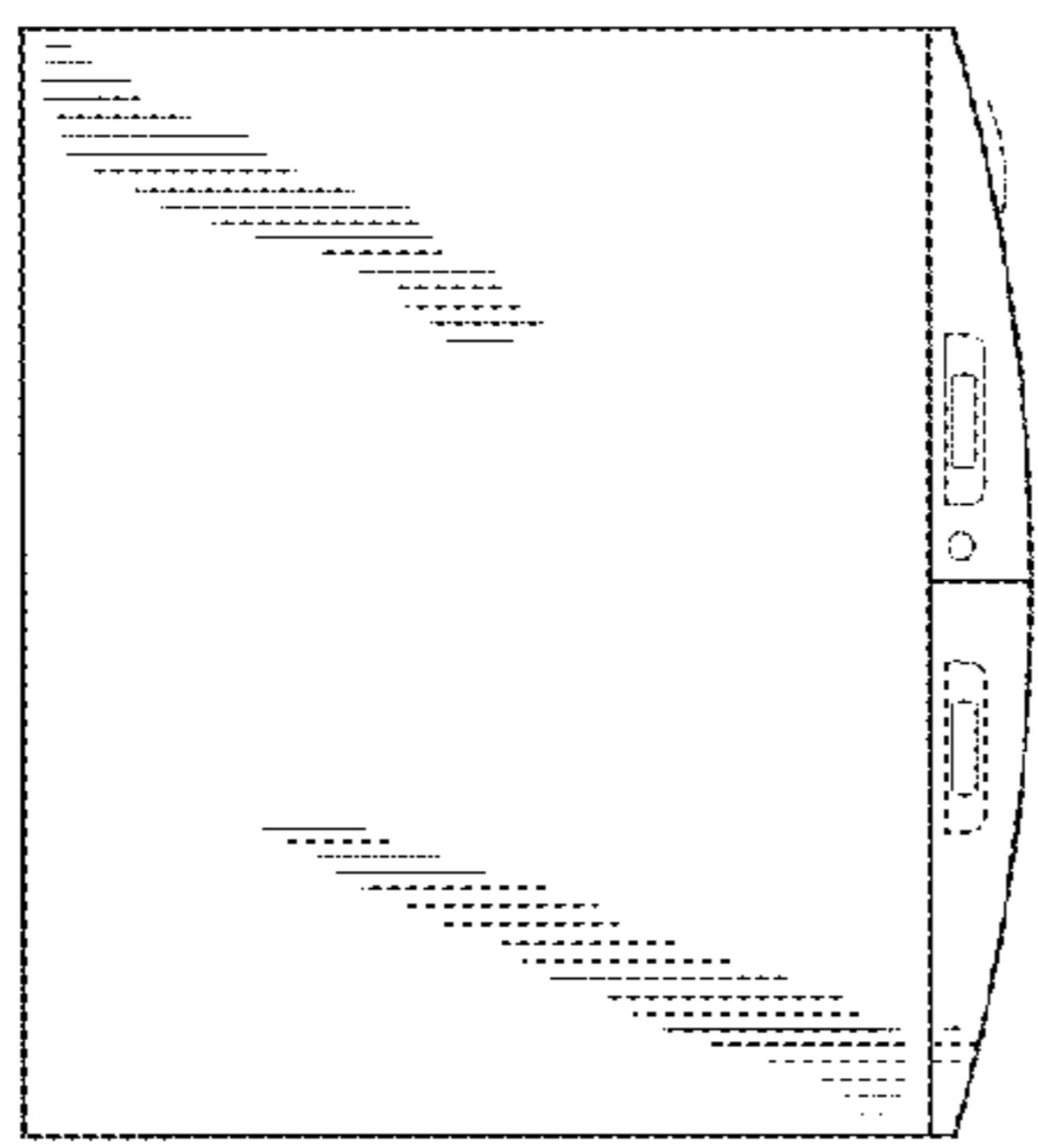
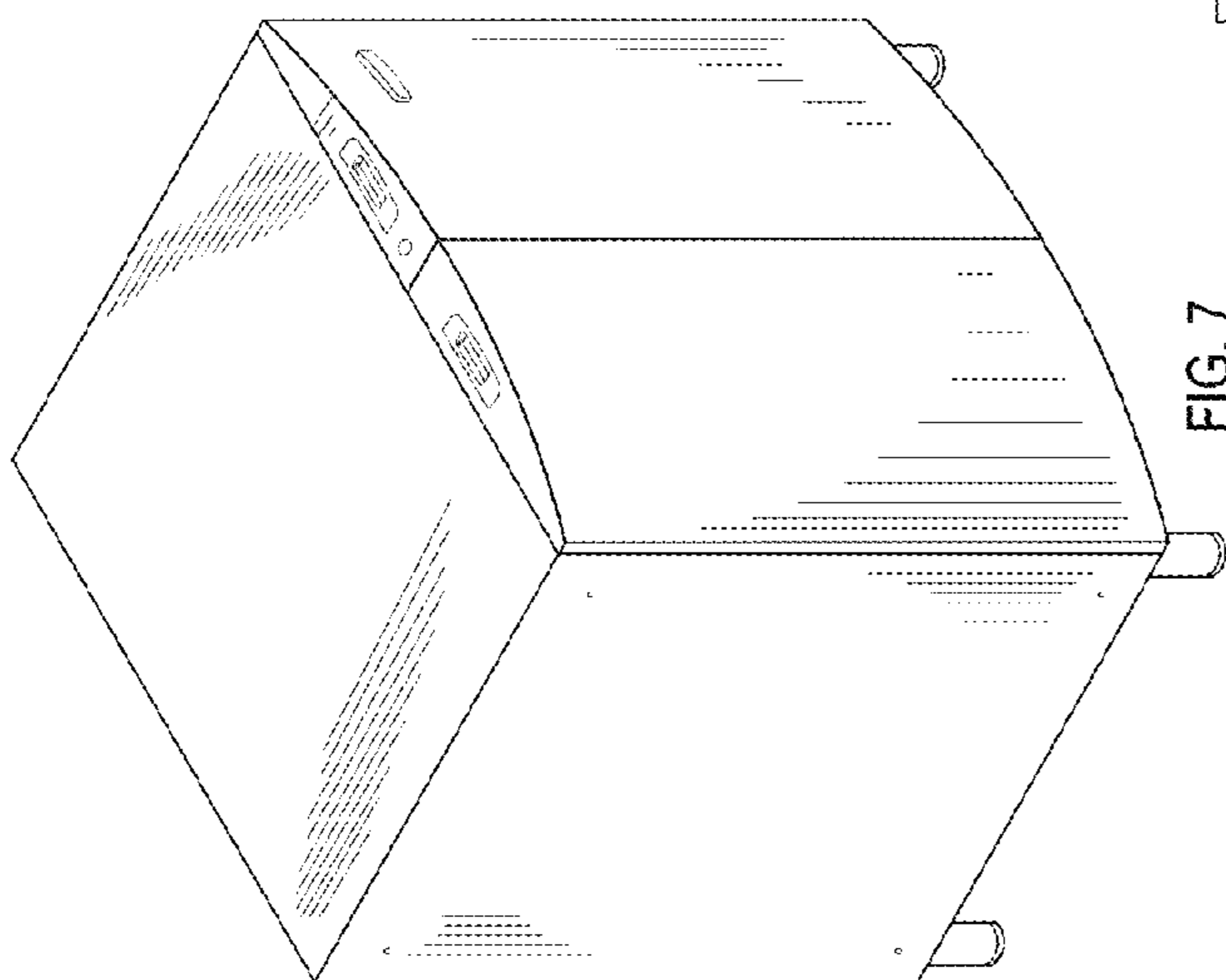

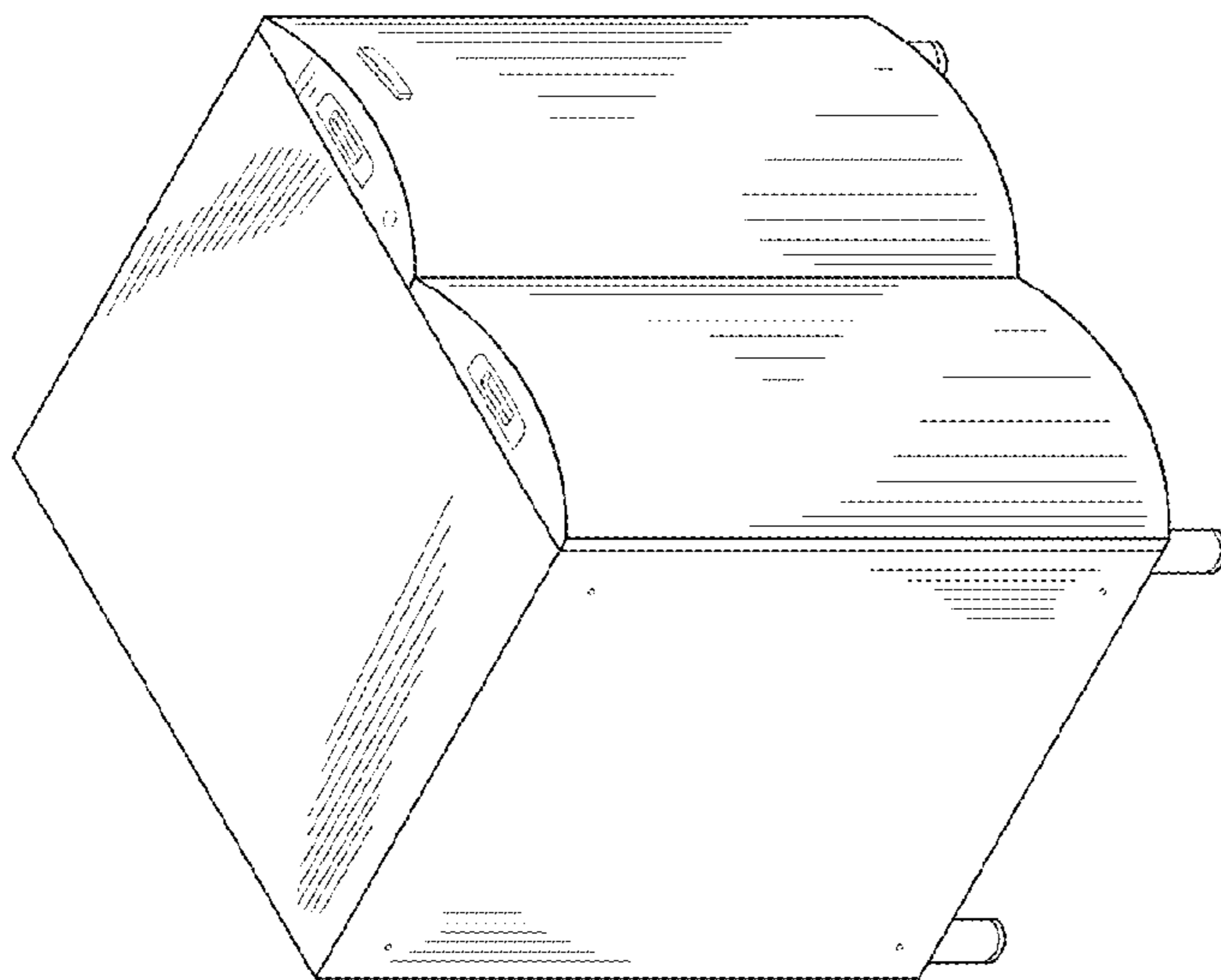

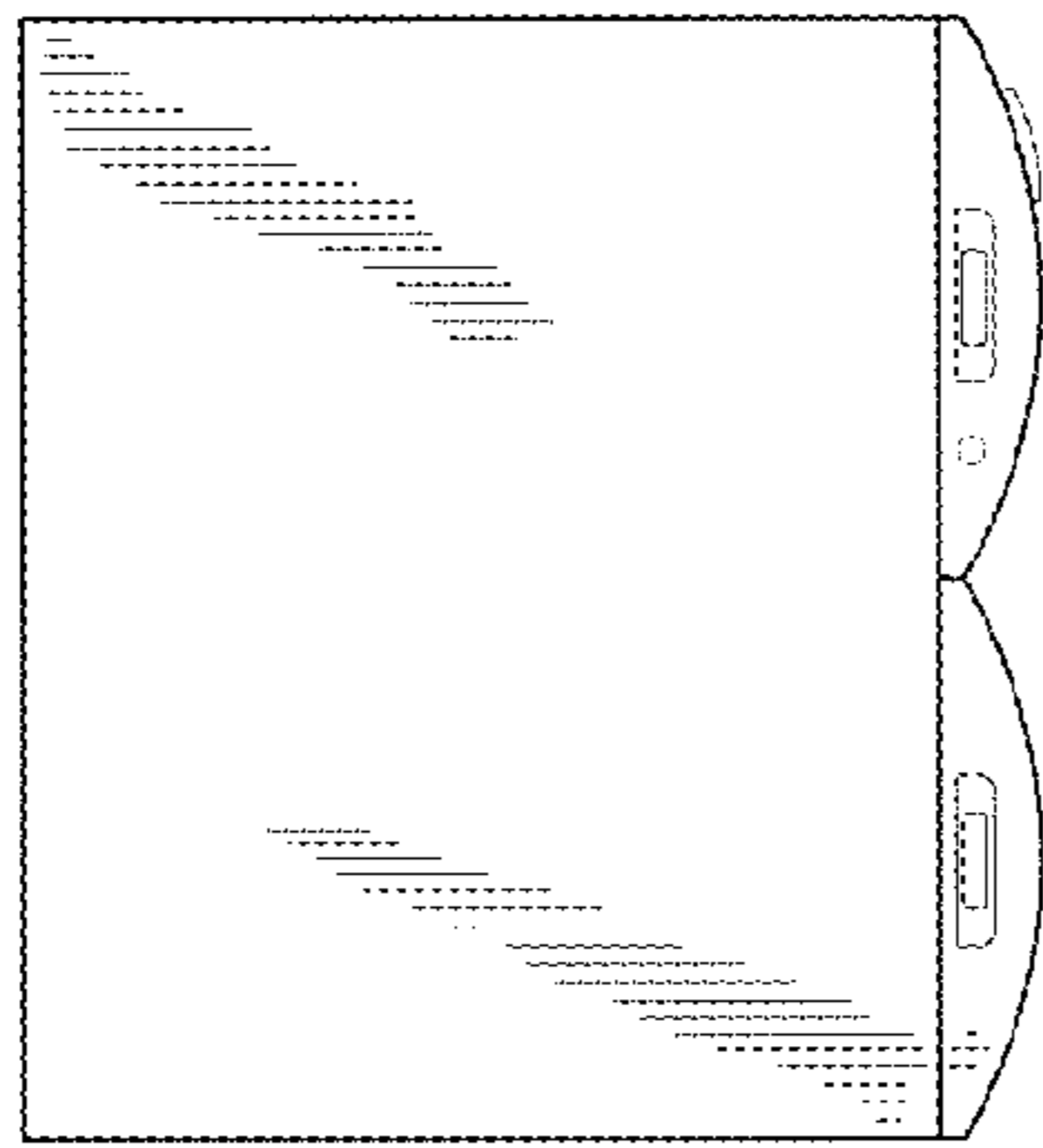

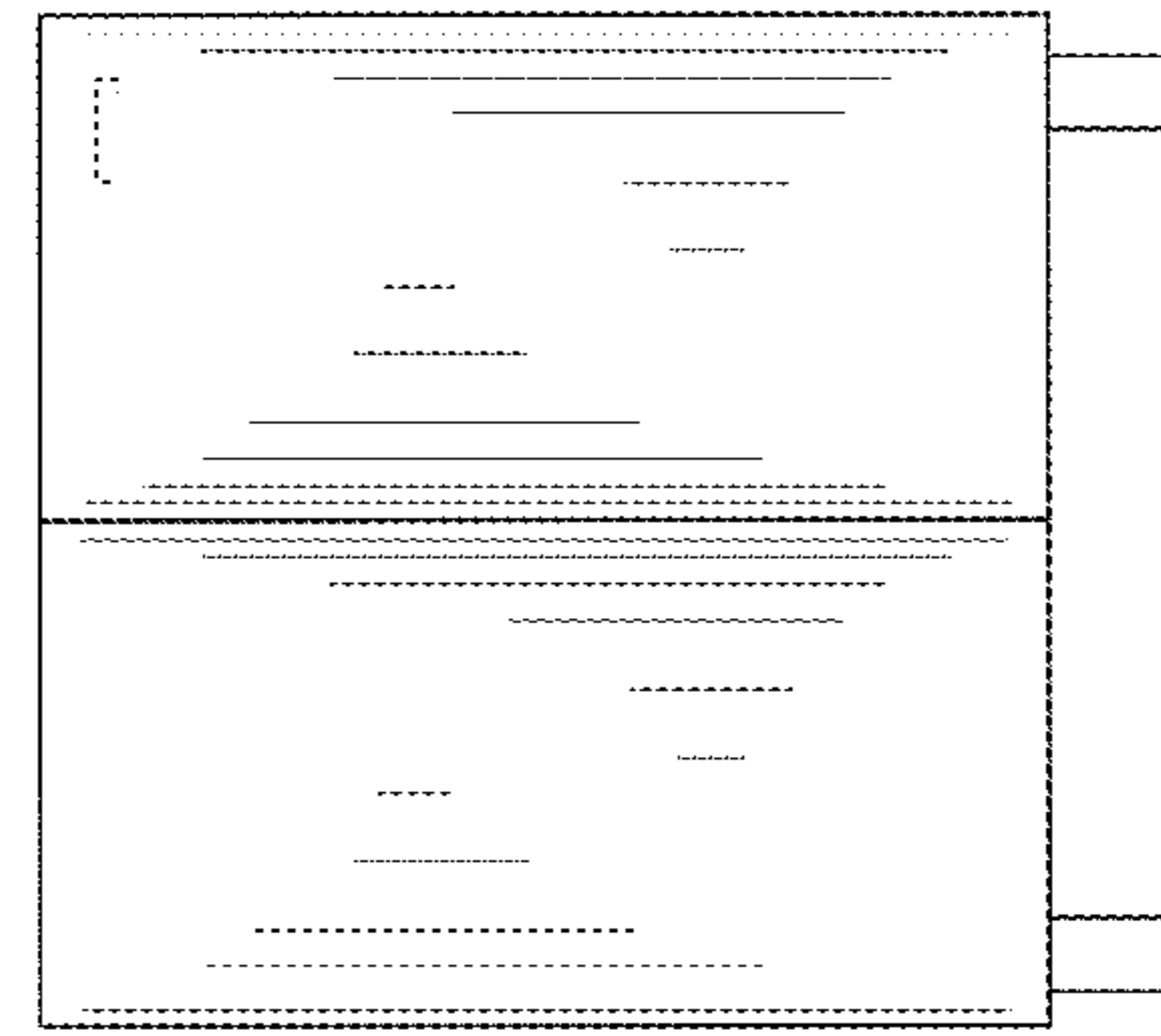

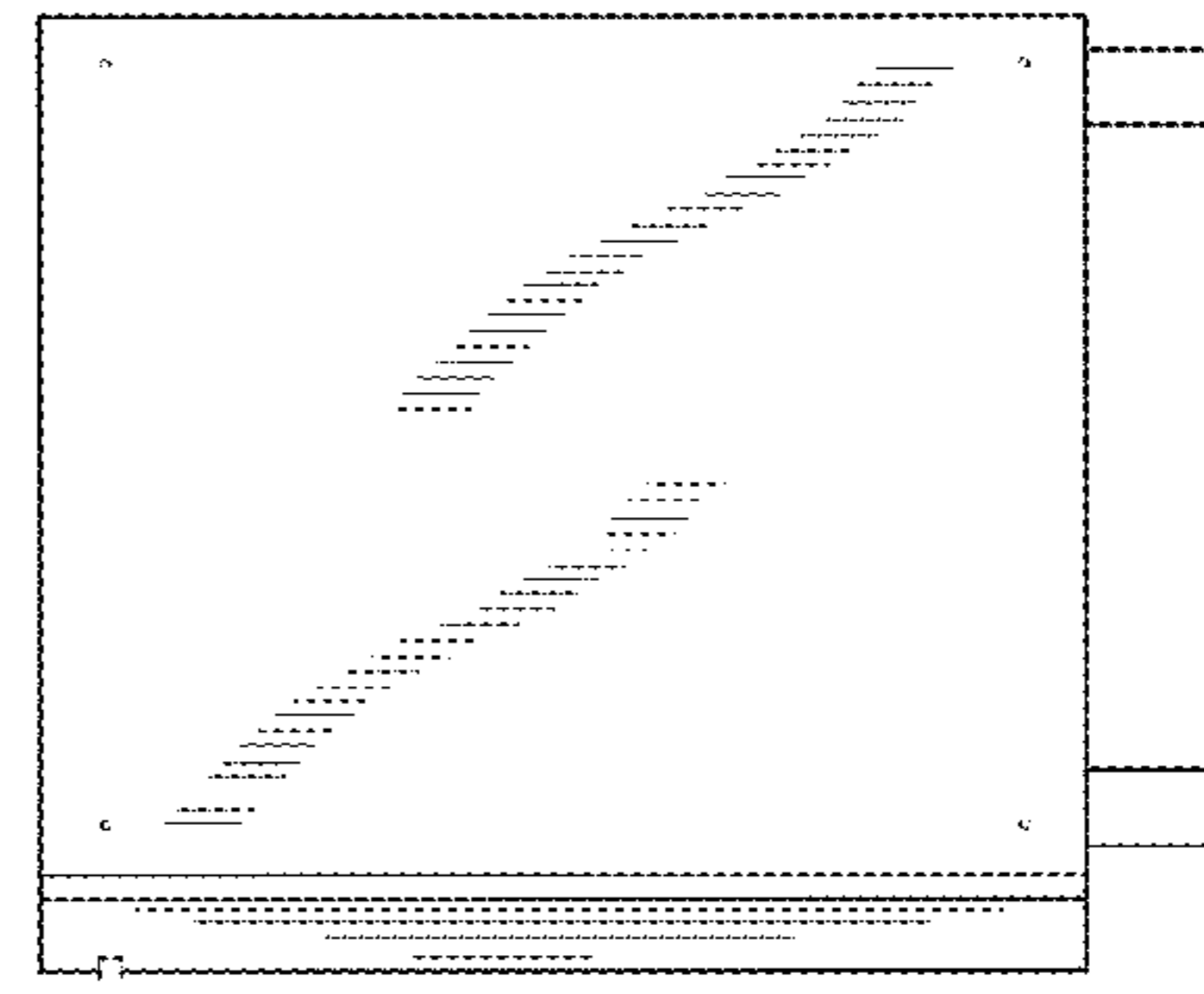

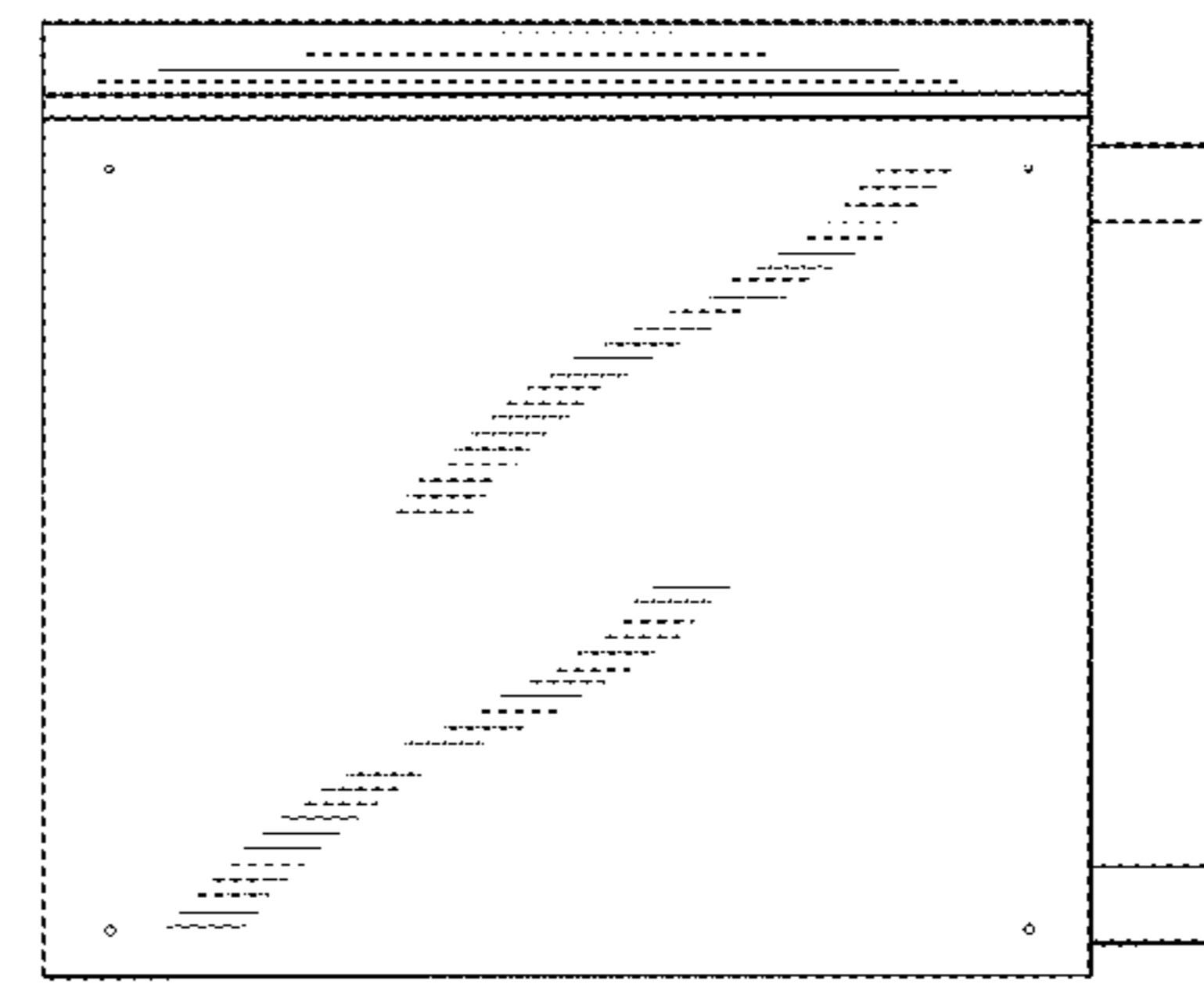

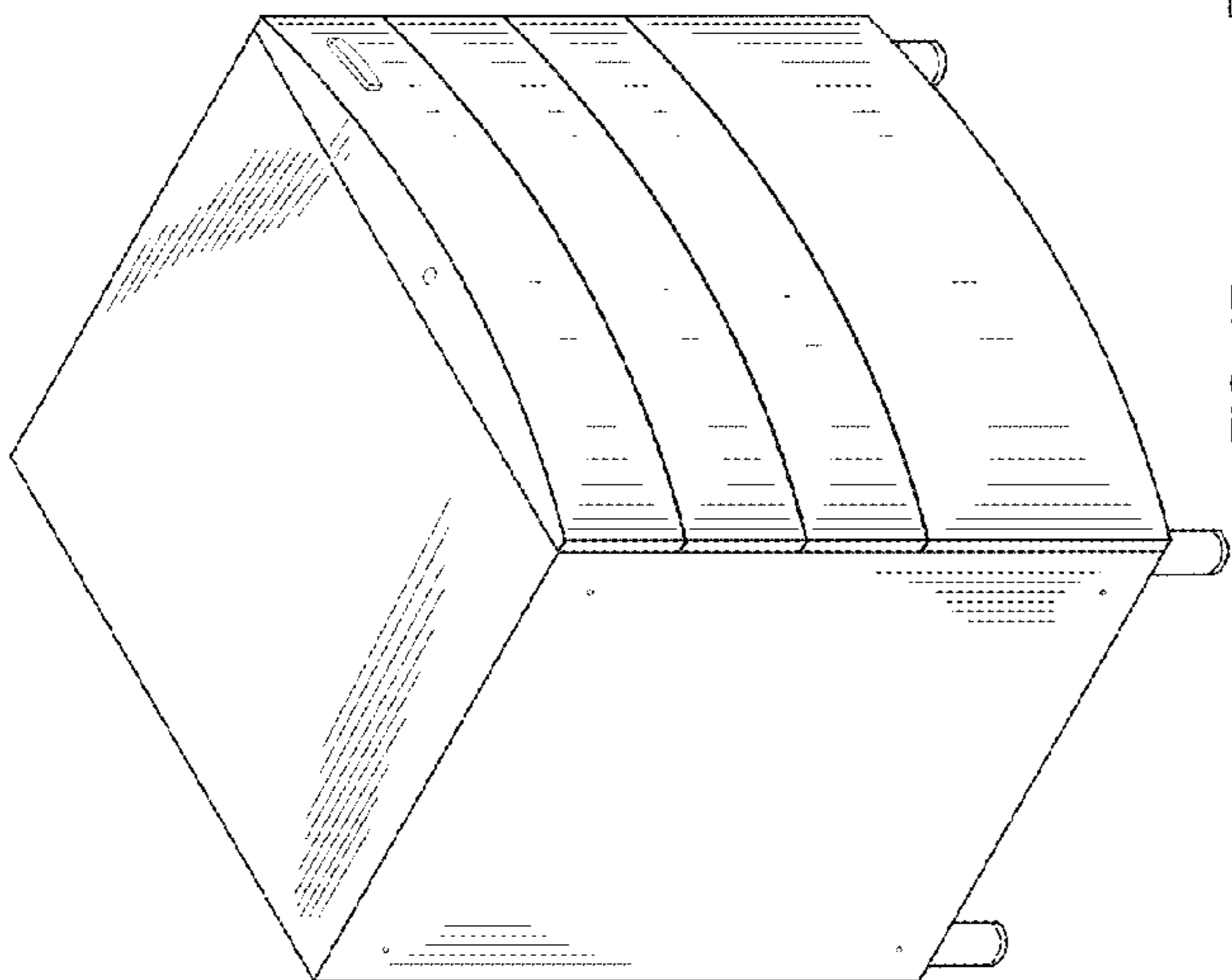

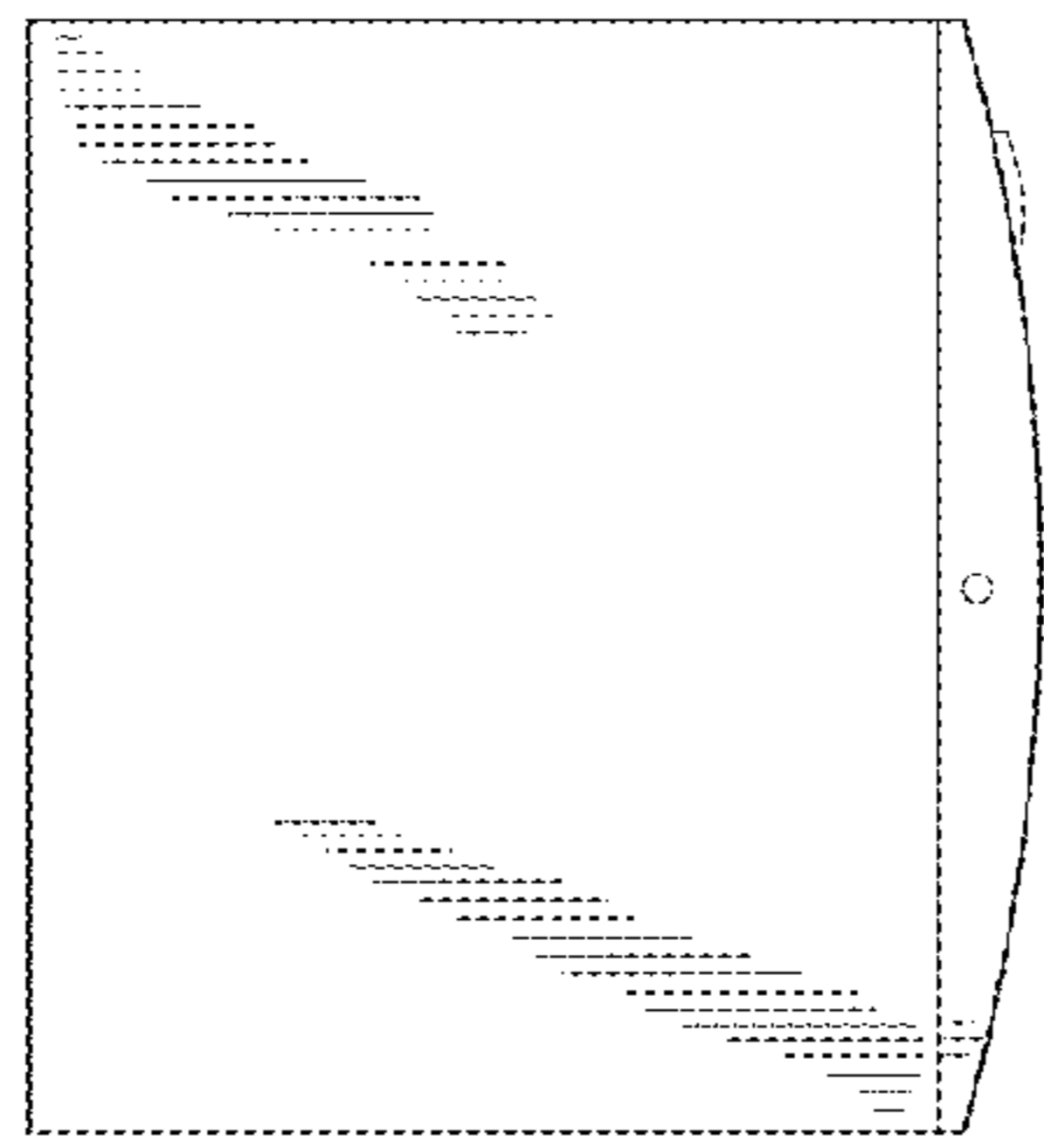

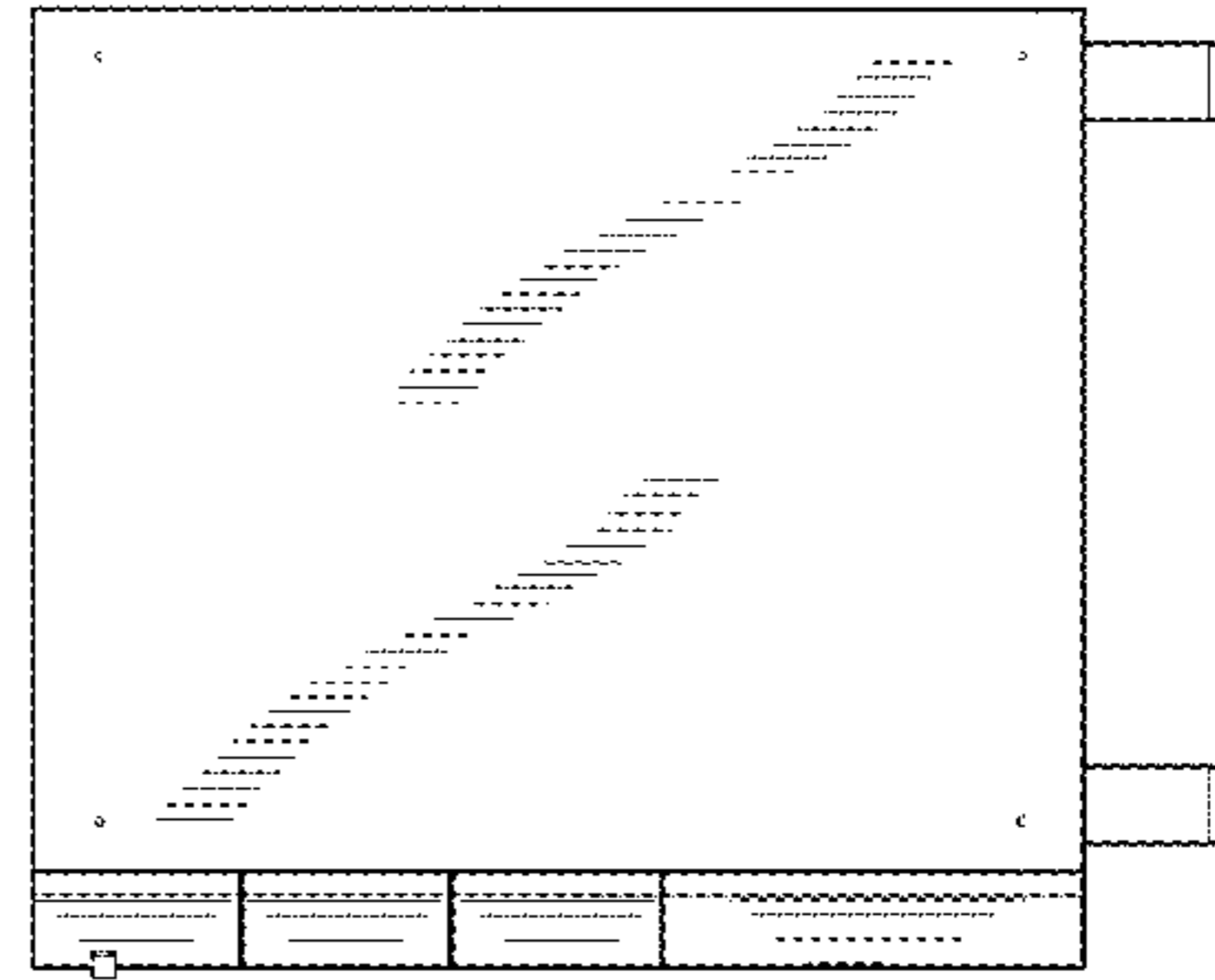

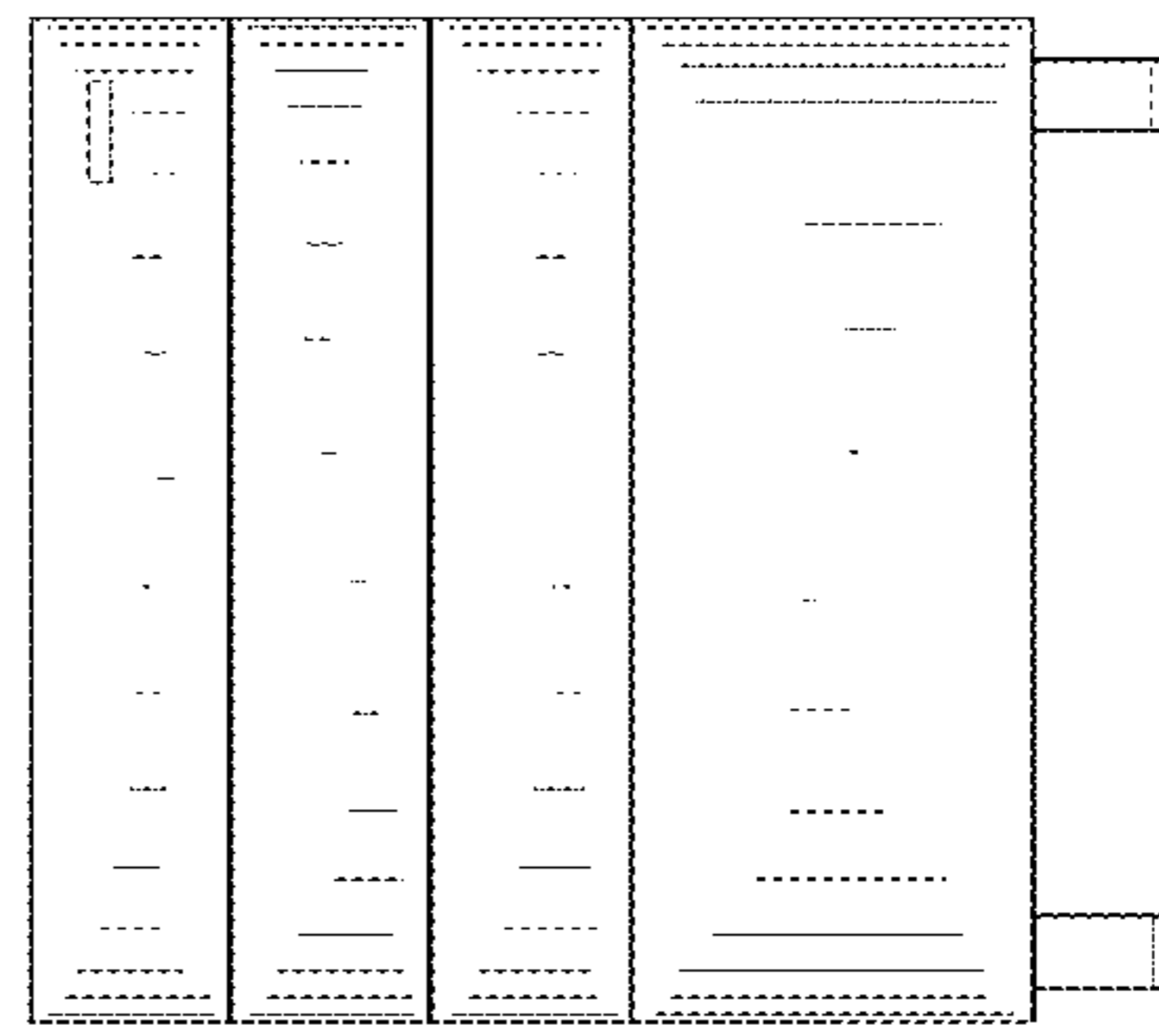

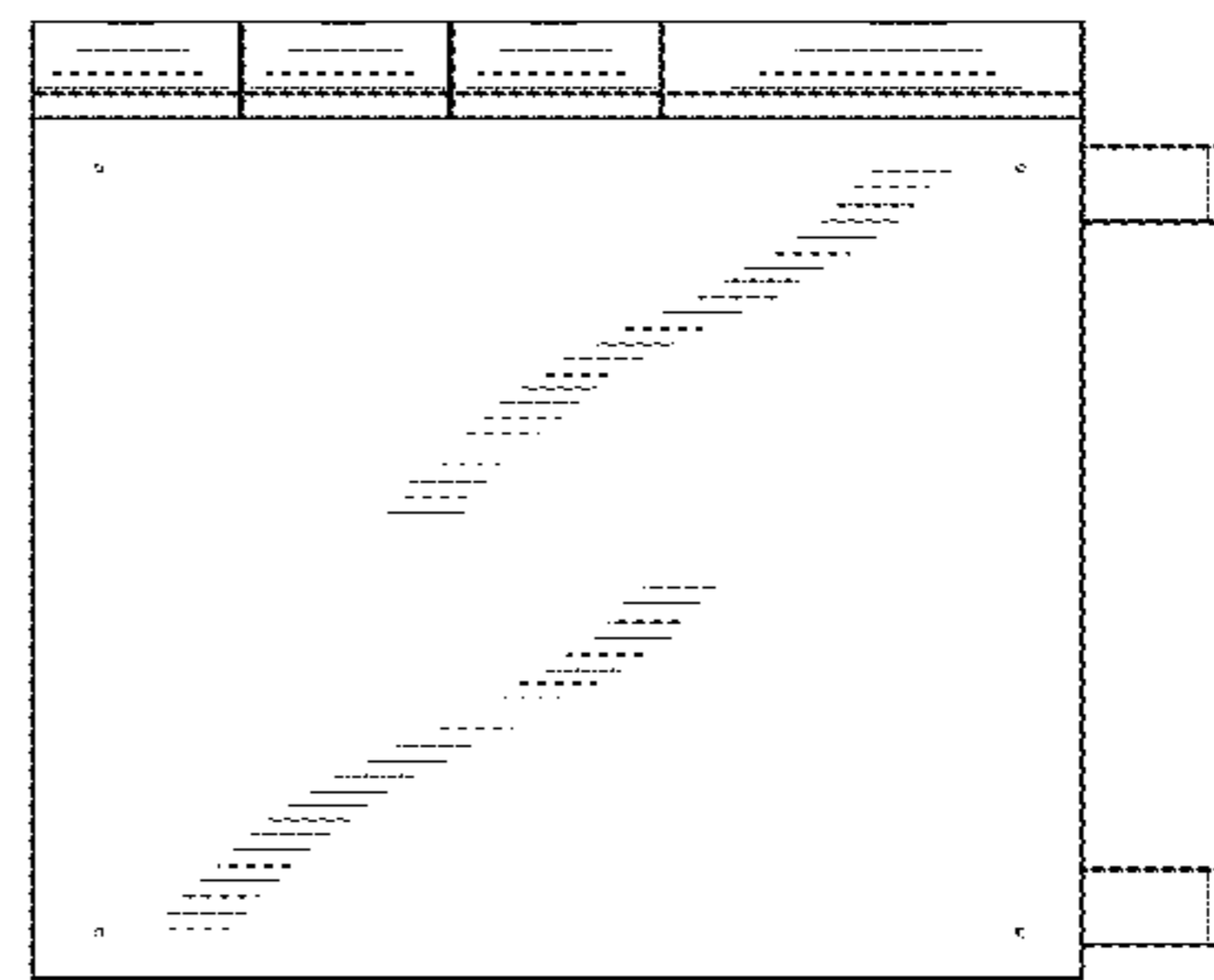
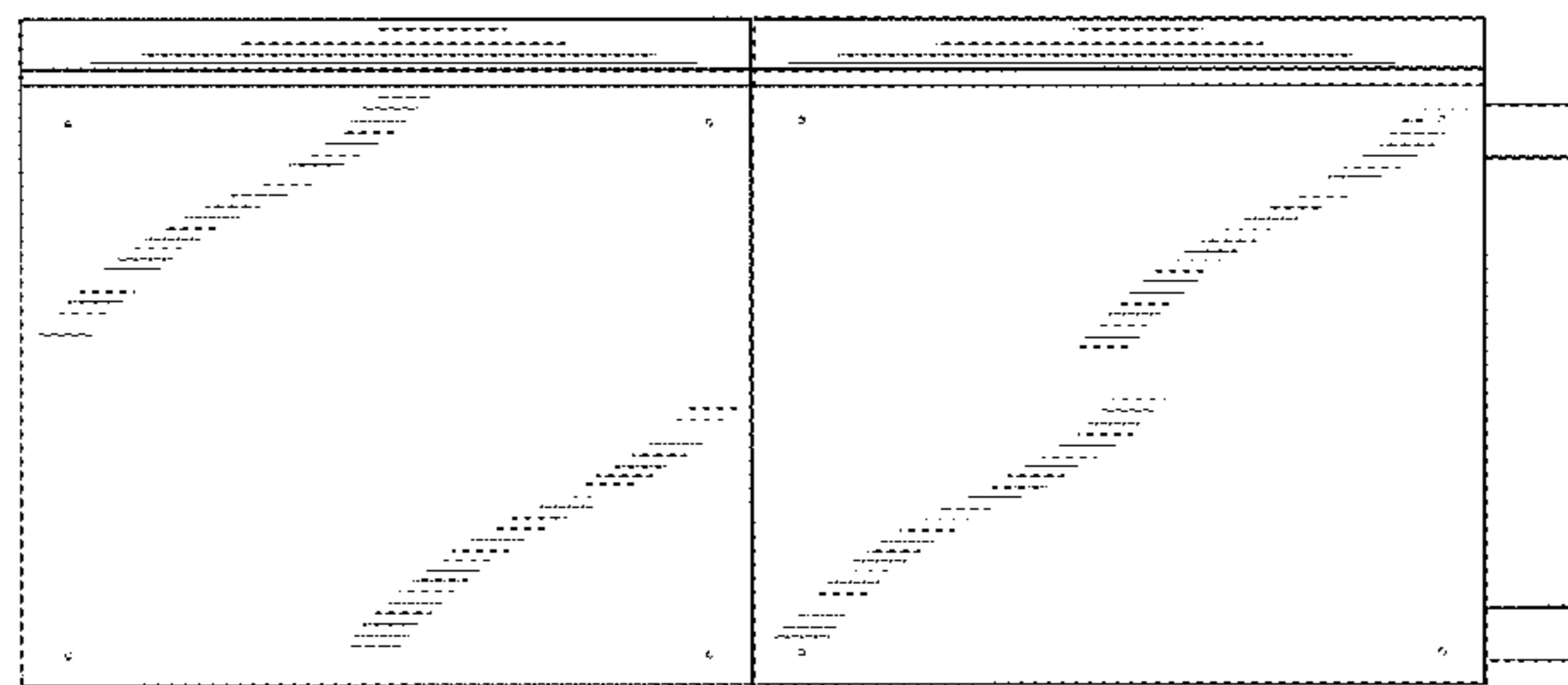
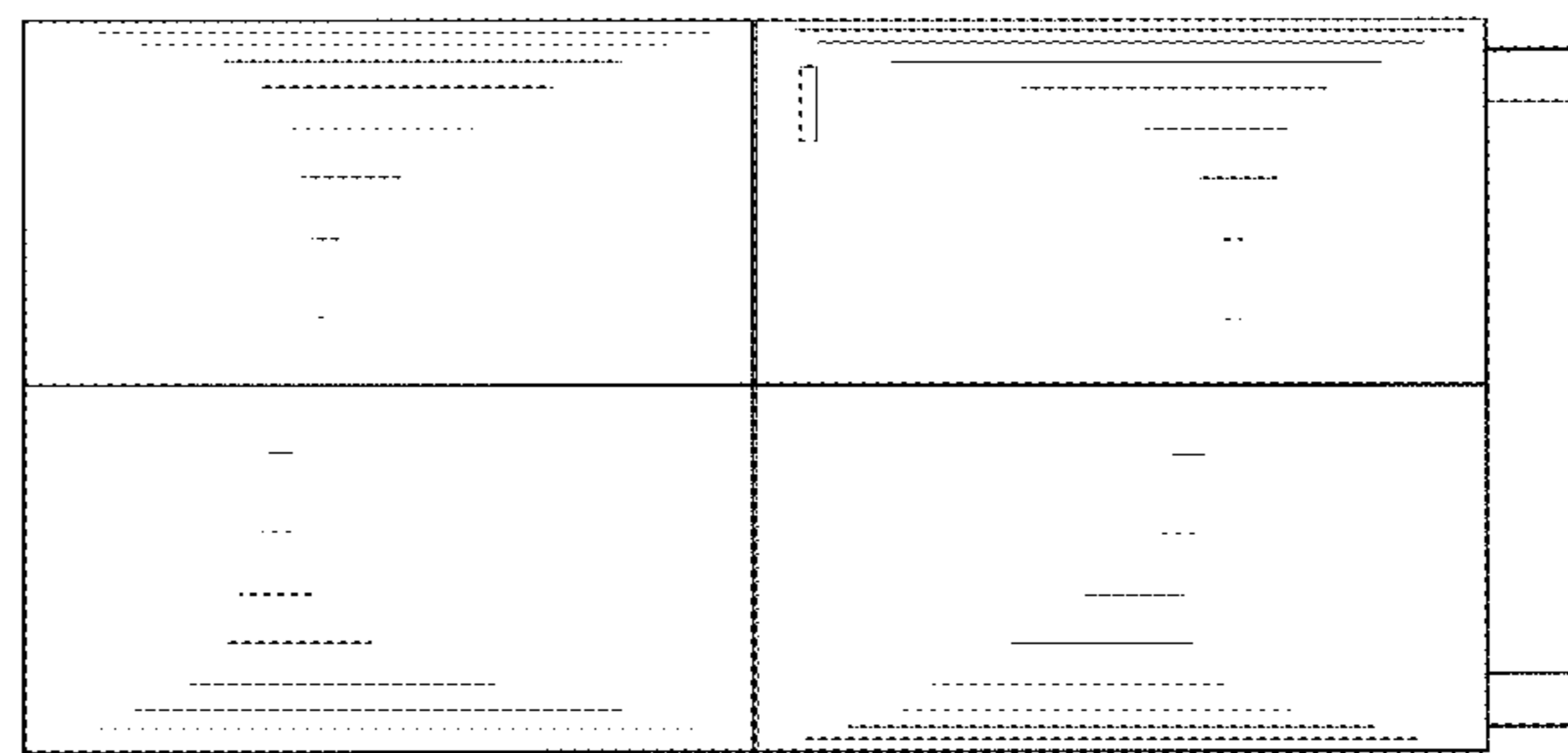
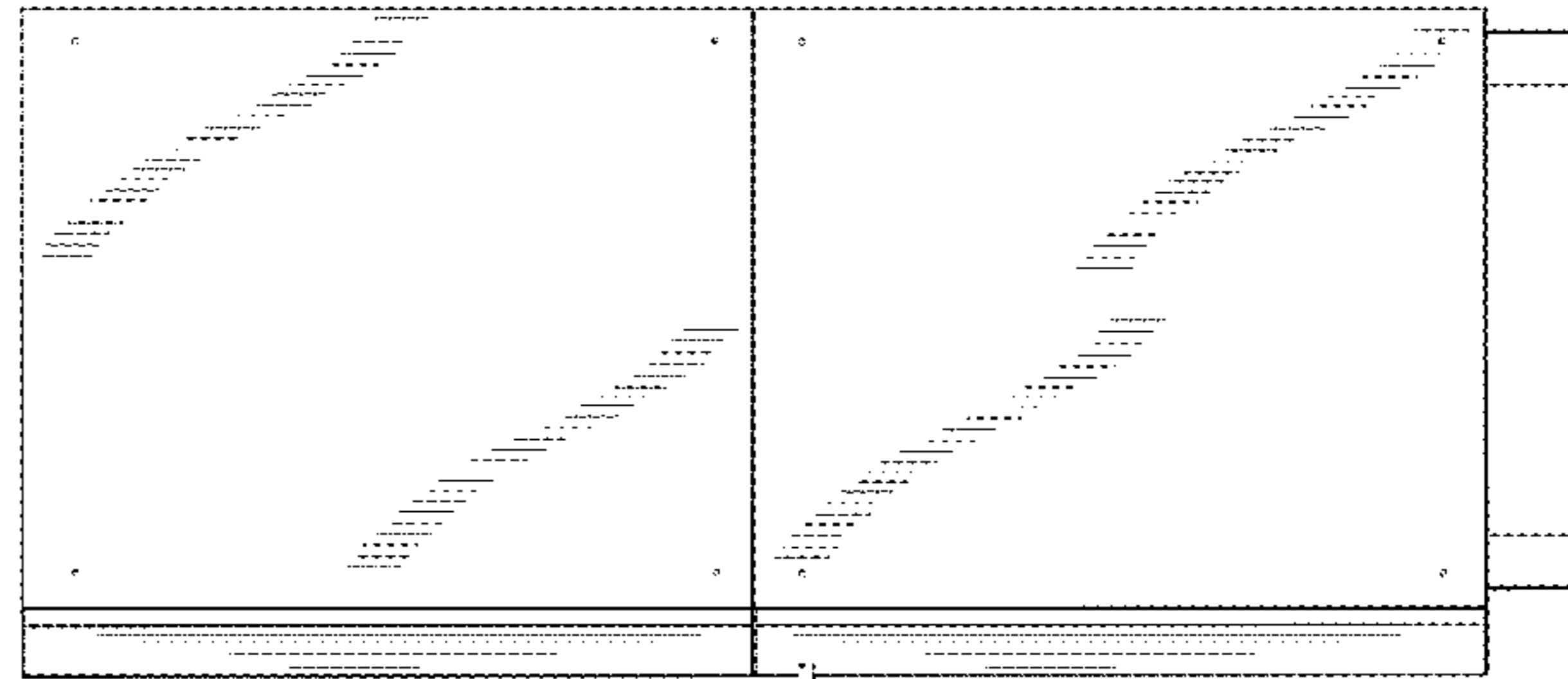
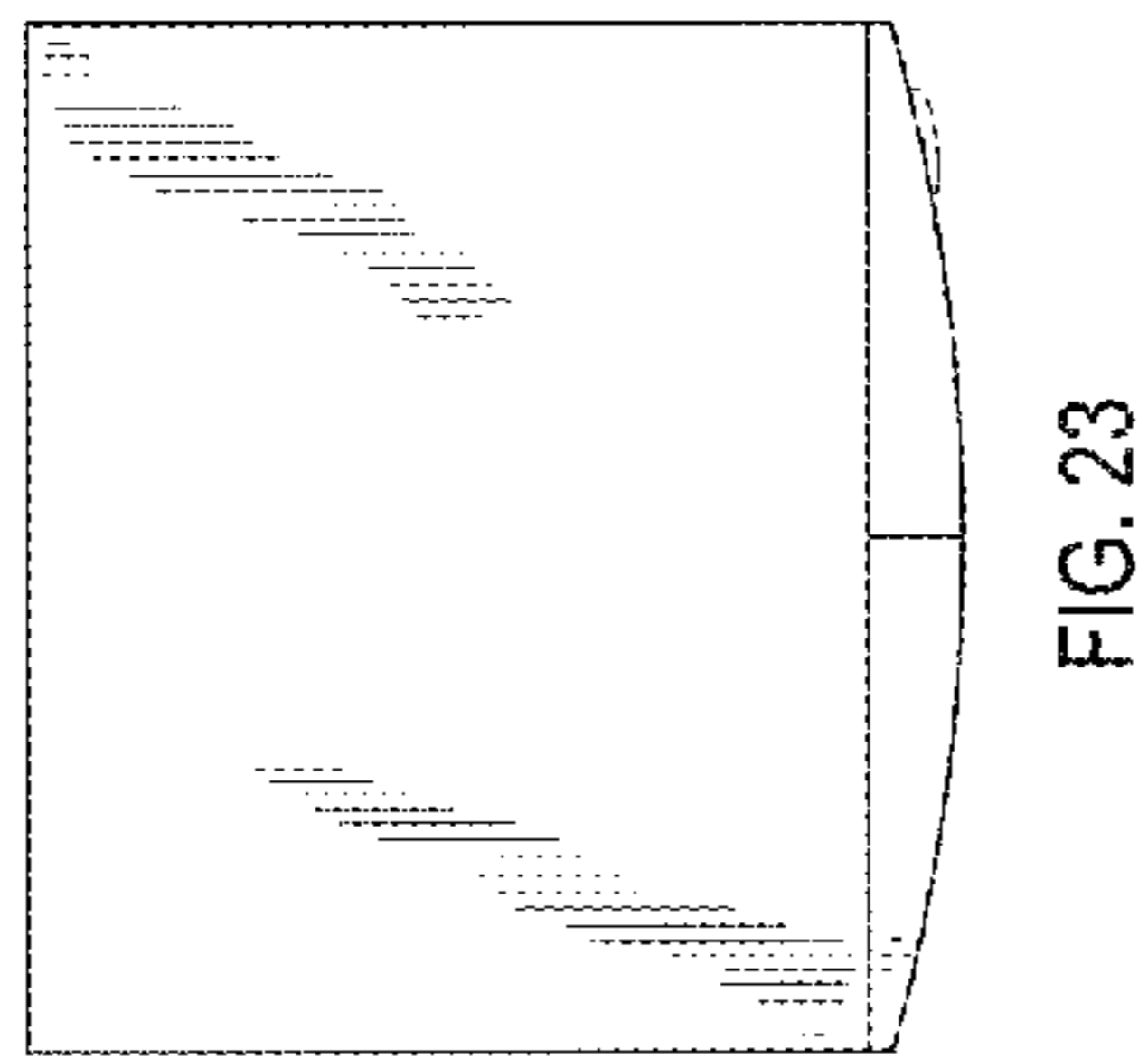
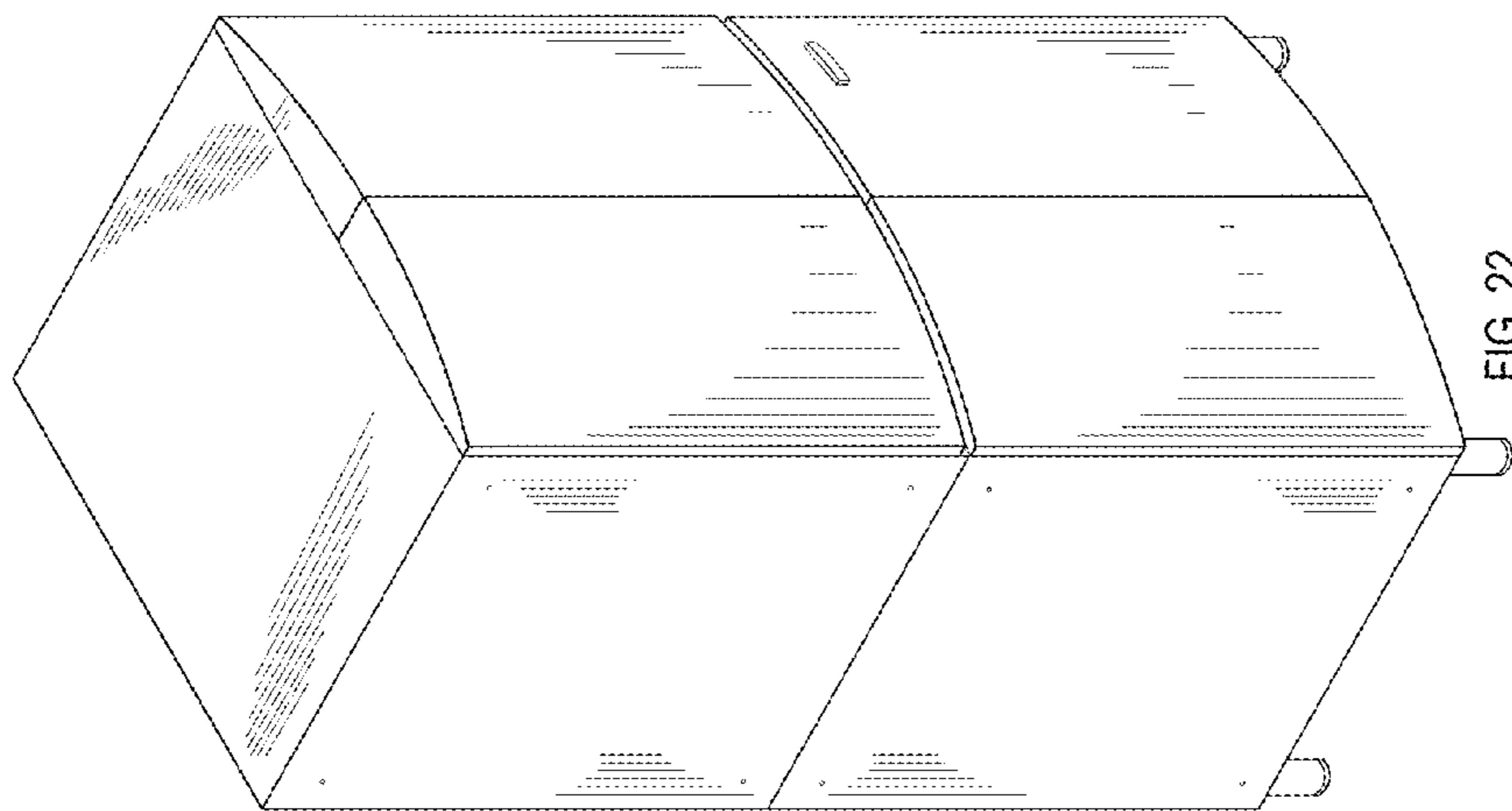

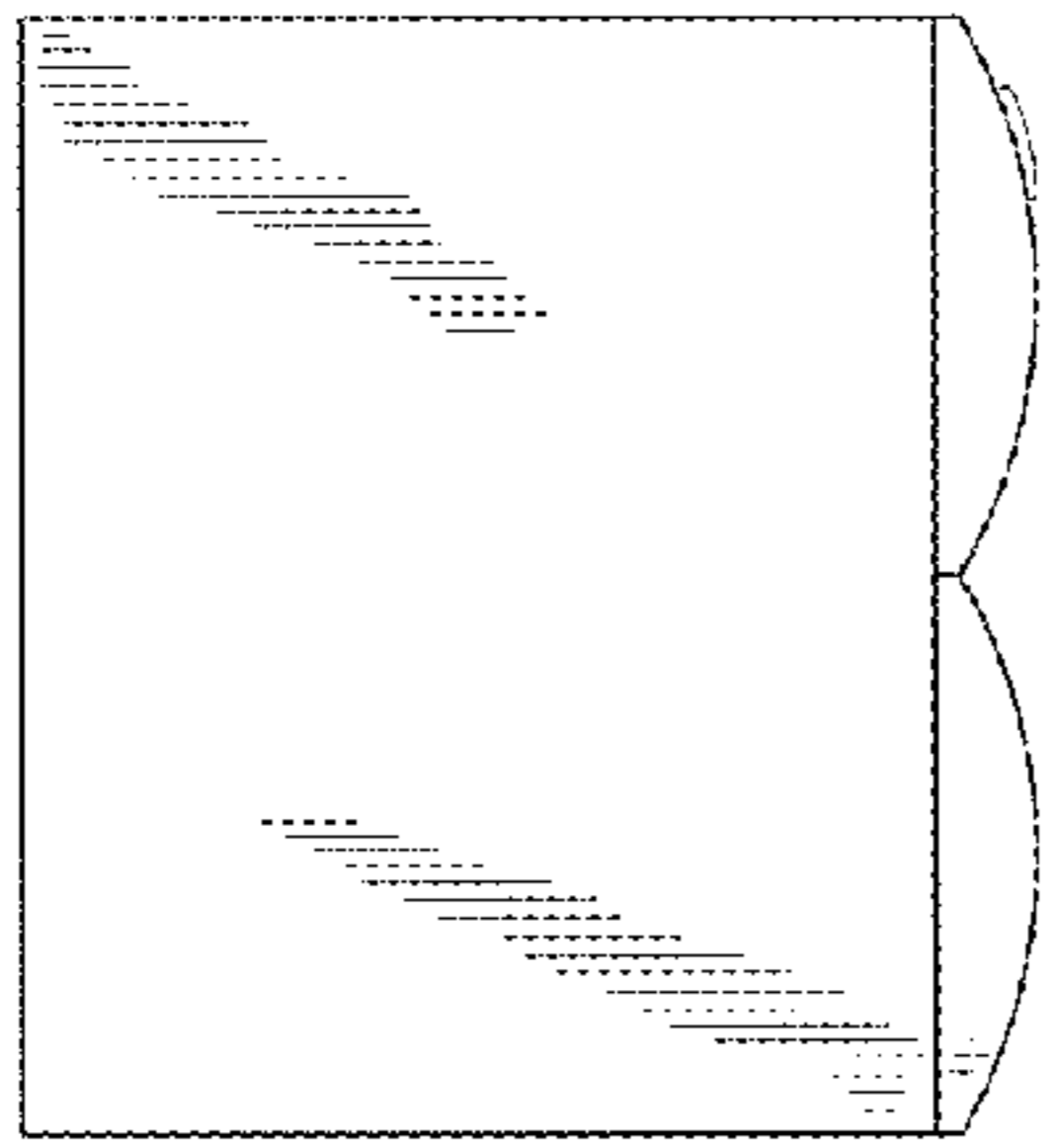
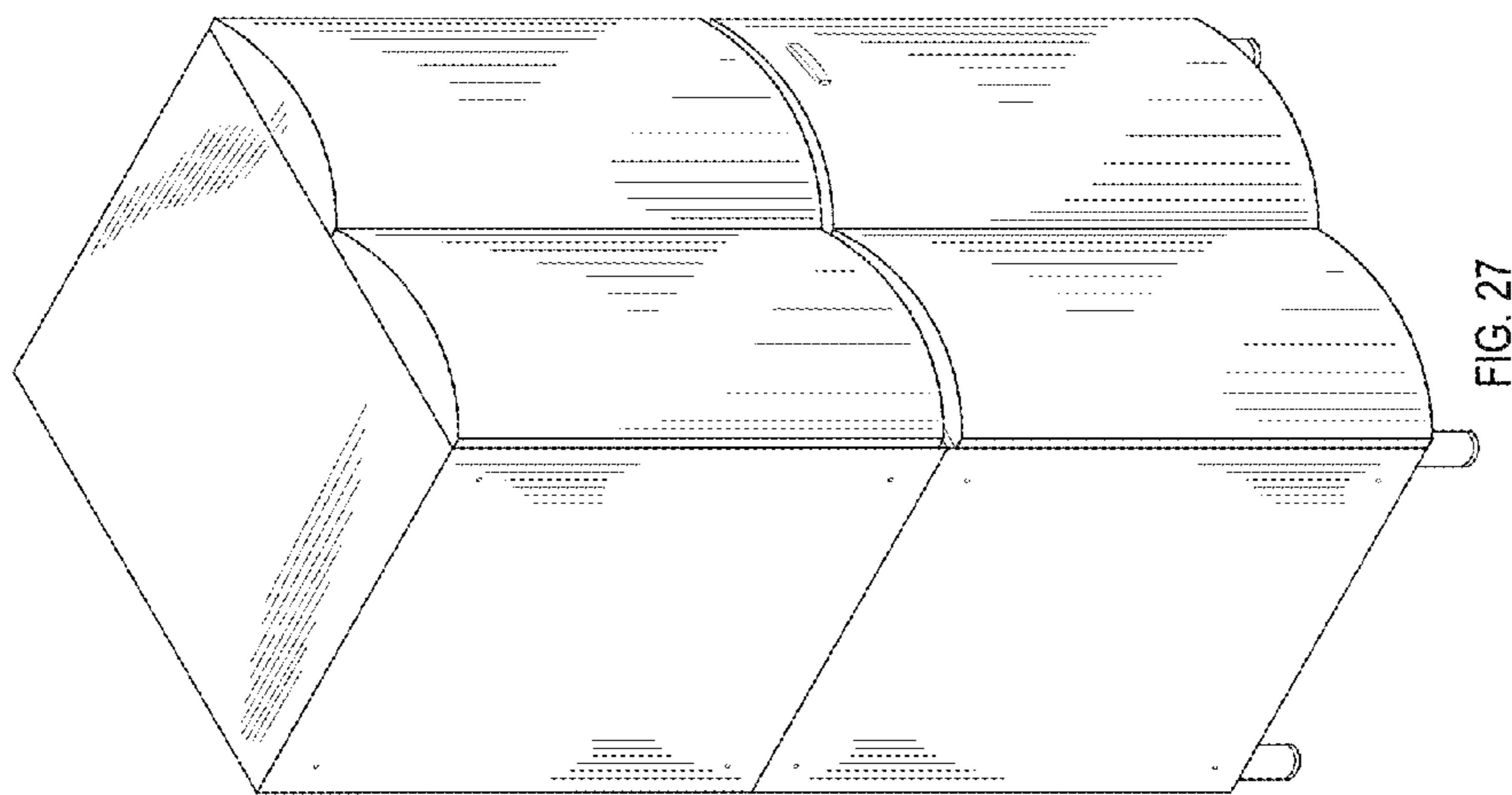

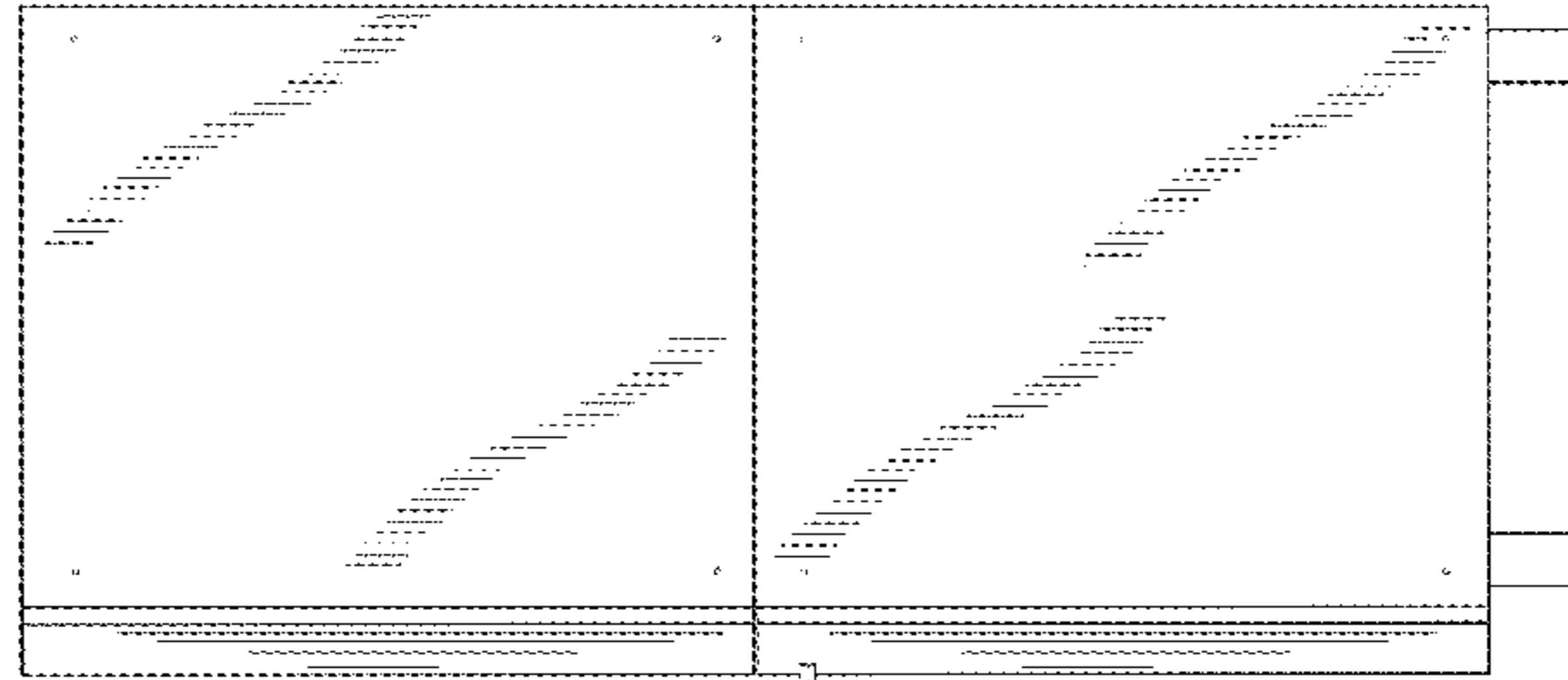

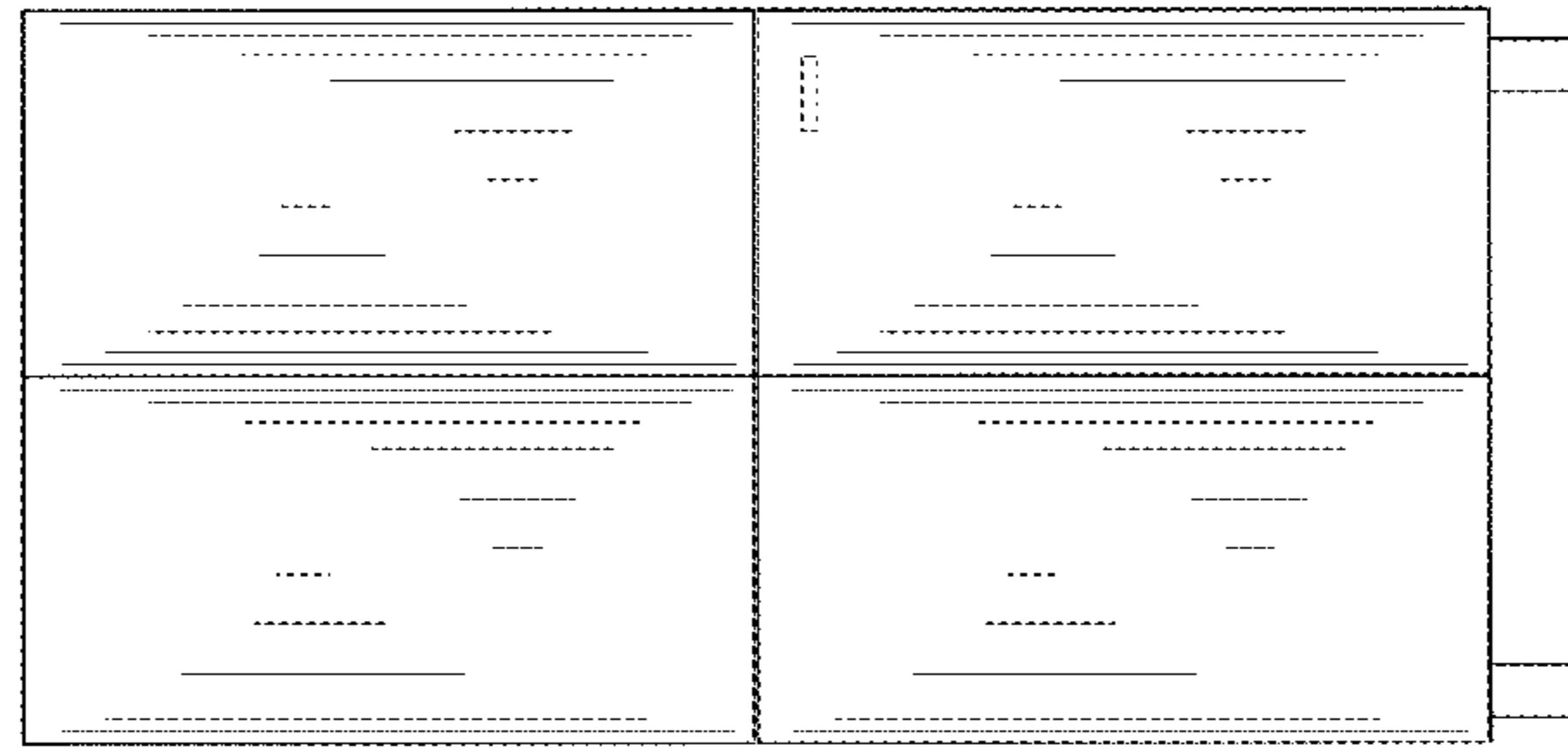

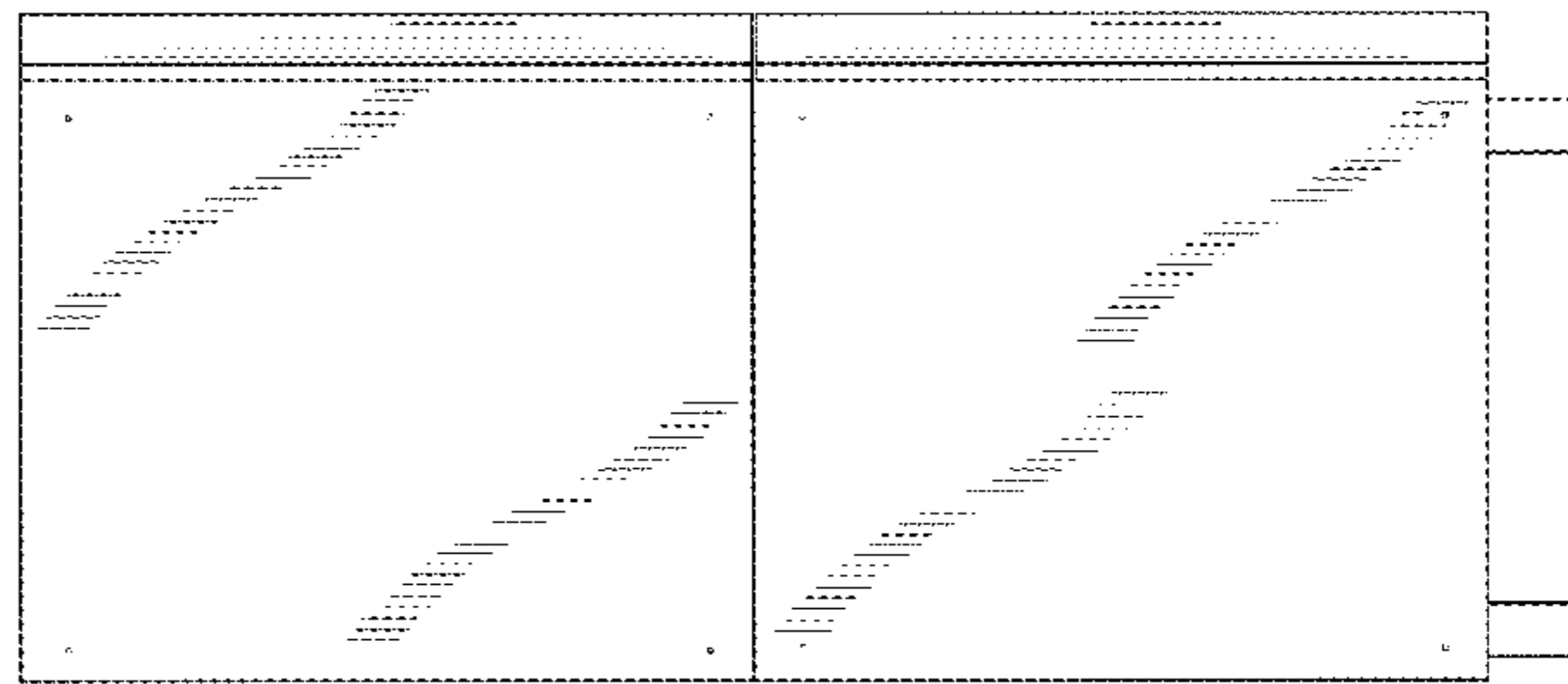

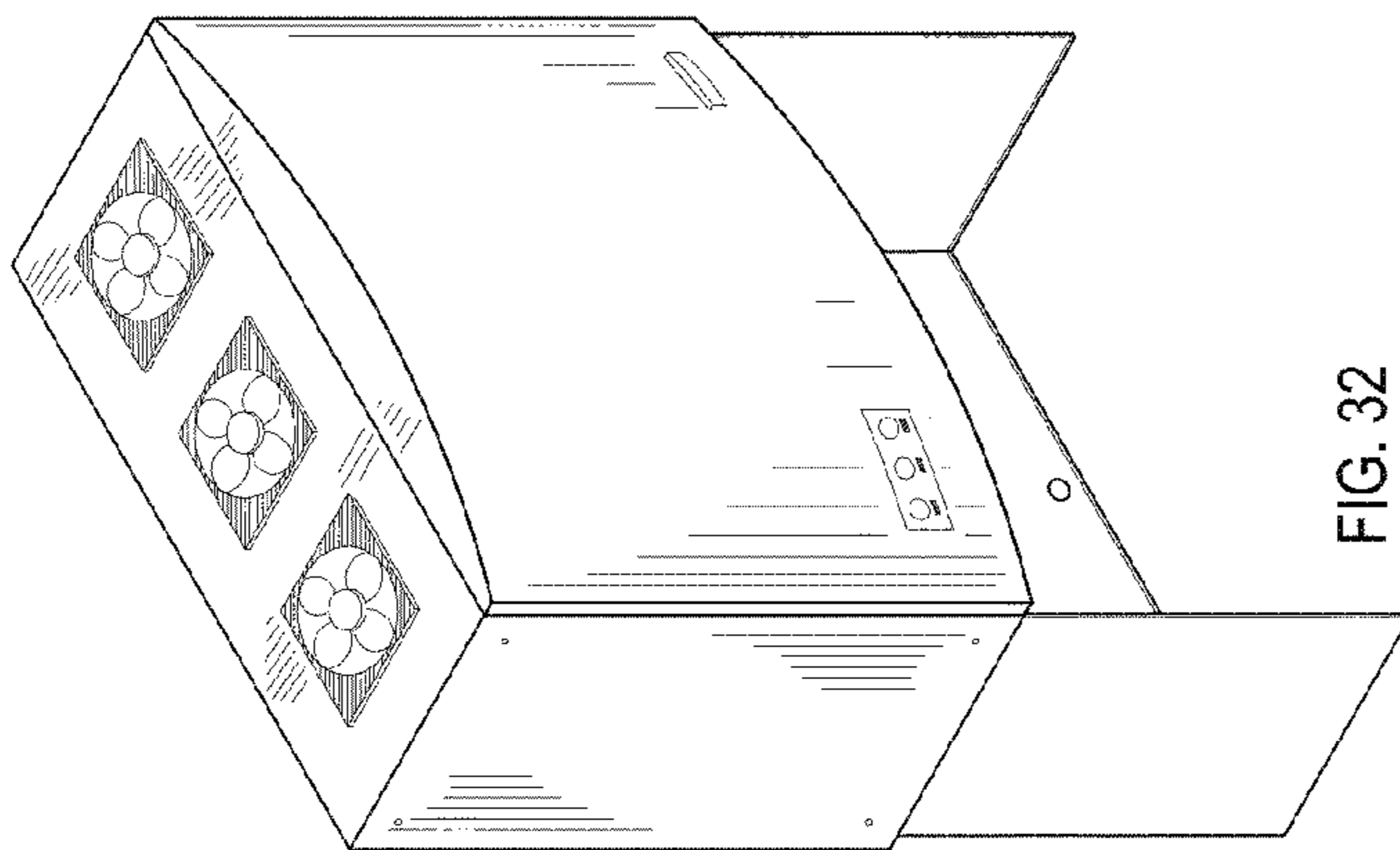

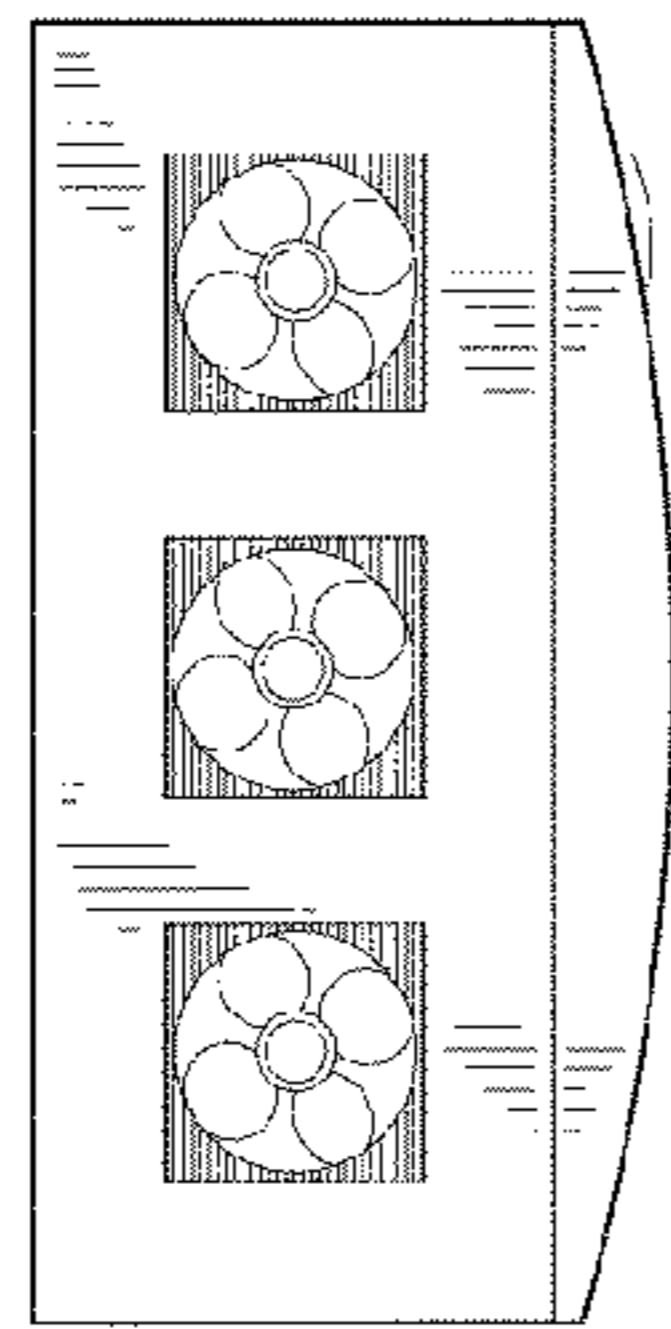

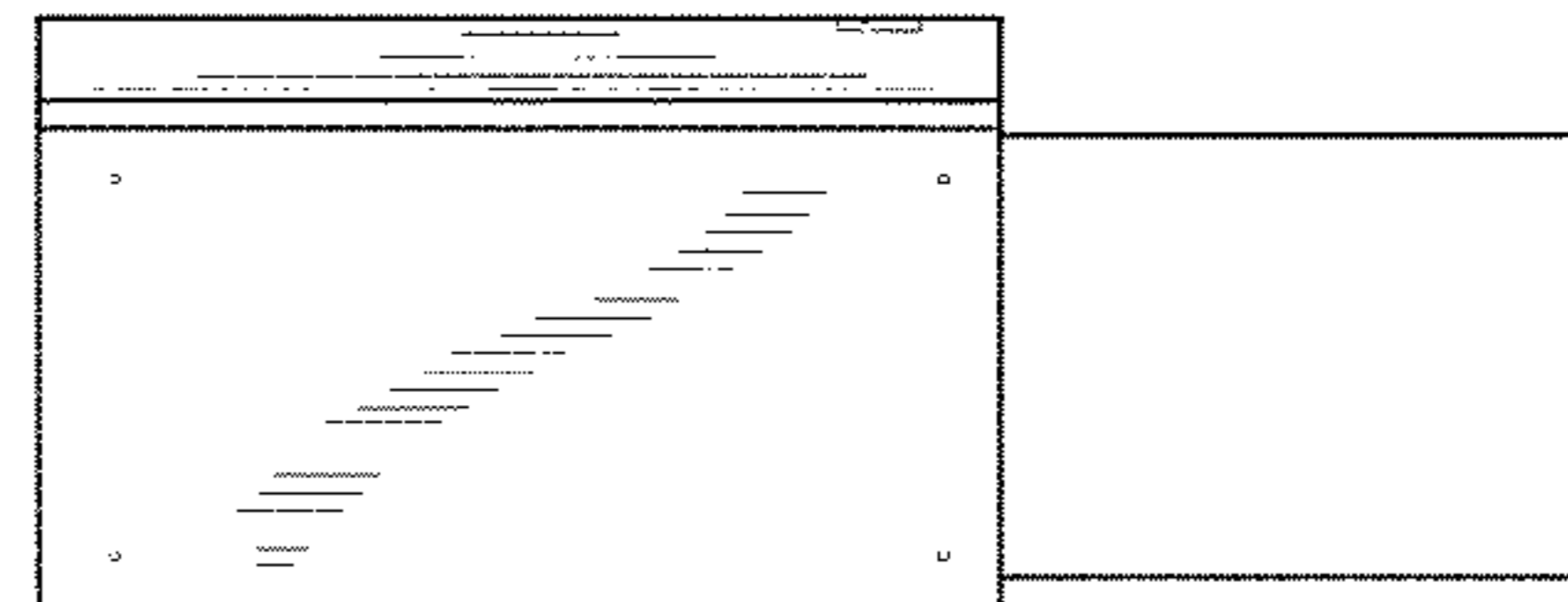

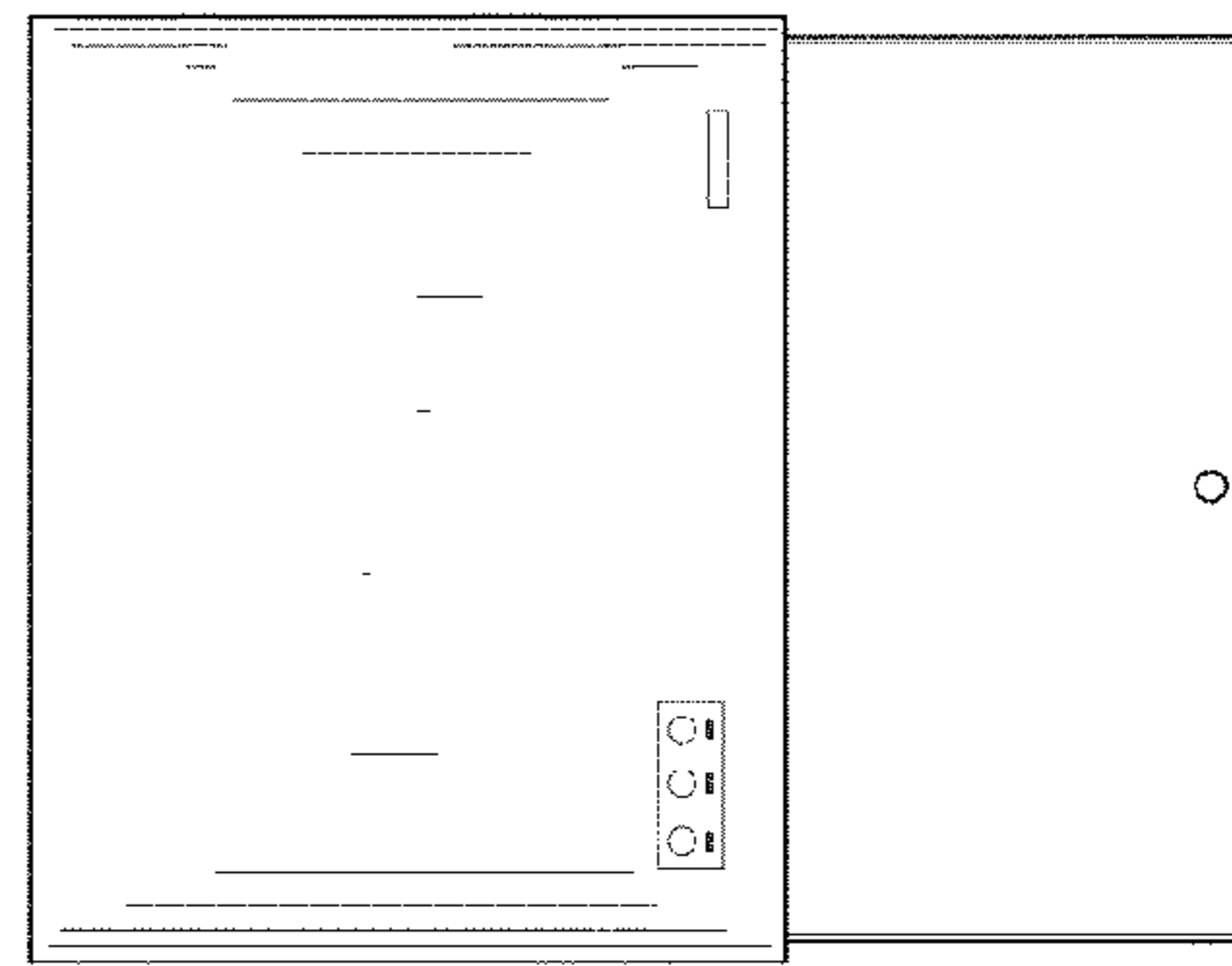

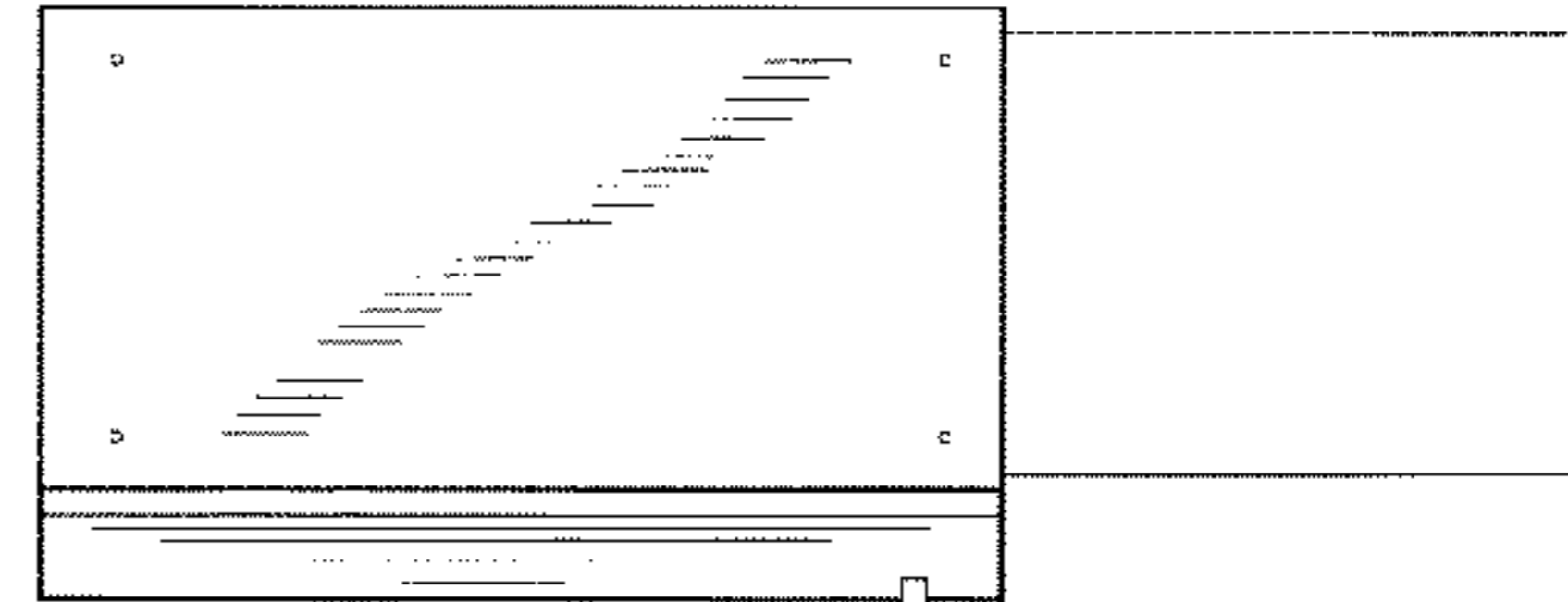
