The ornamental design for a mat with variety of embedded numbers, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a mat with variety of embedded numbers showing my new design. The bottom of the design forms no part of the claim;

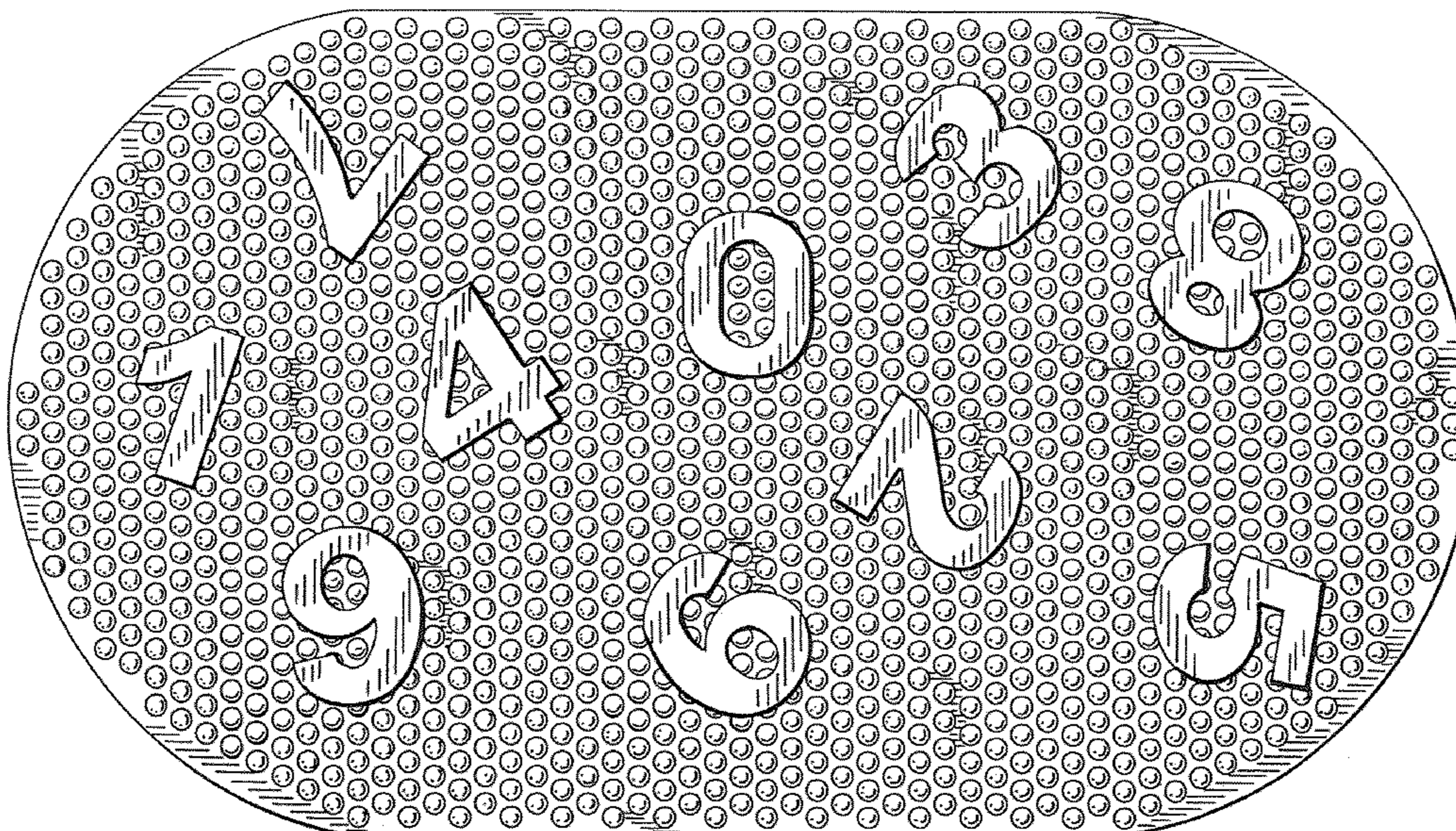
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; and,

FIG. 4 is a partial exploded view thereof showing an enlarged number from FIG. 1.

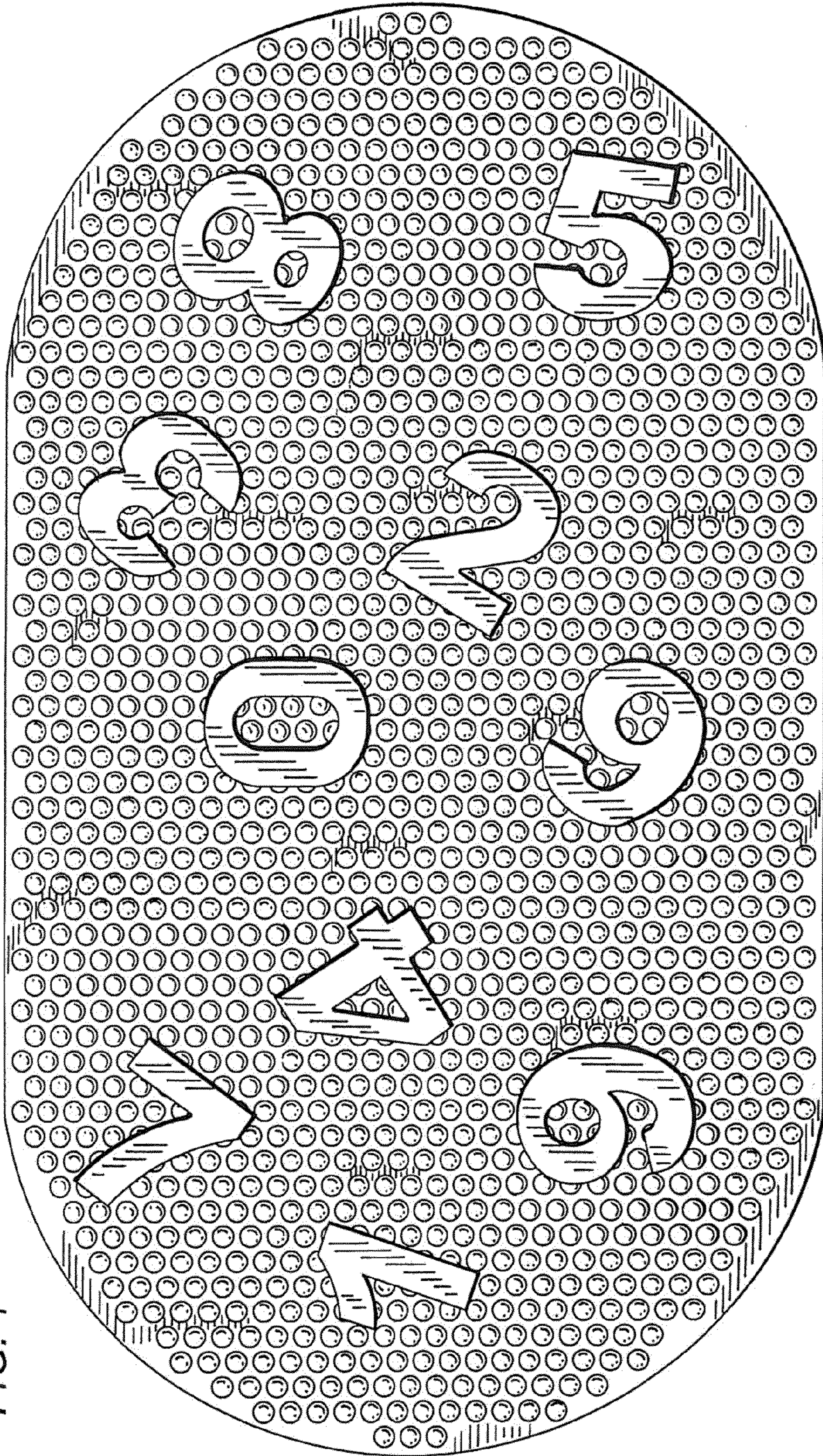
