The ornamental design for a plate apparatus for an empanada making device, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the plate apparatus for an empanada making device, showing the new design;

FIG. 2 is a right side view thereof;

FIG. 4 is a front view thereof;

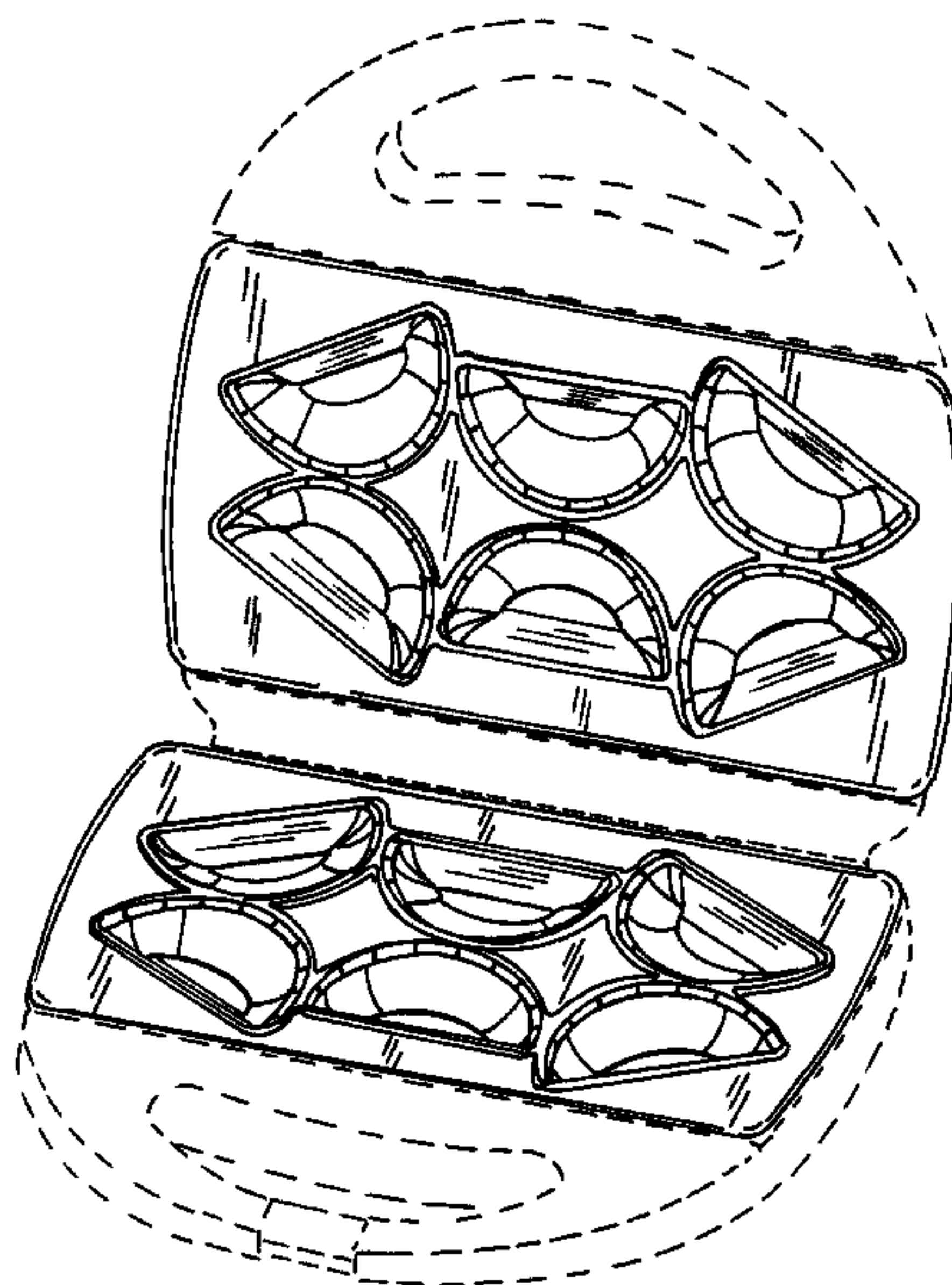
FIG. 5 is a rear view thereof;

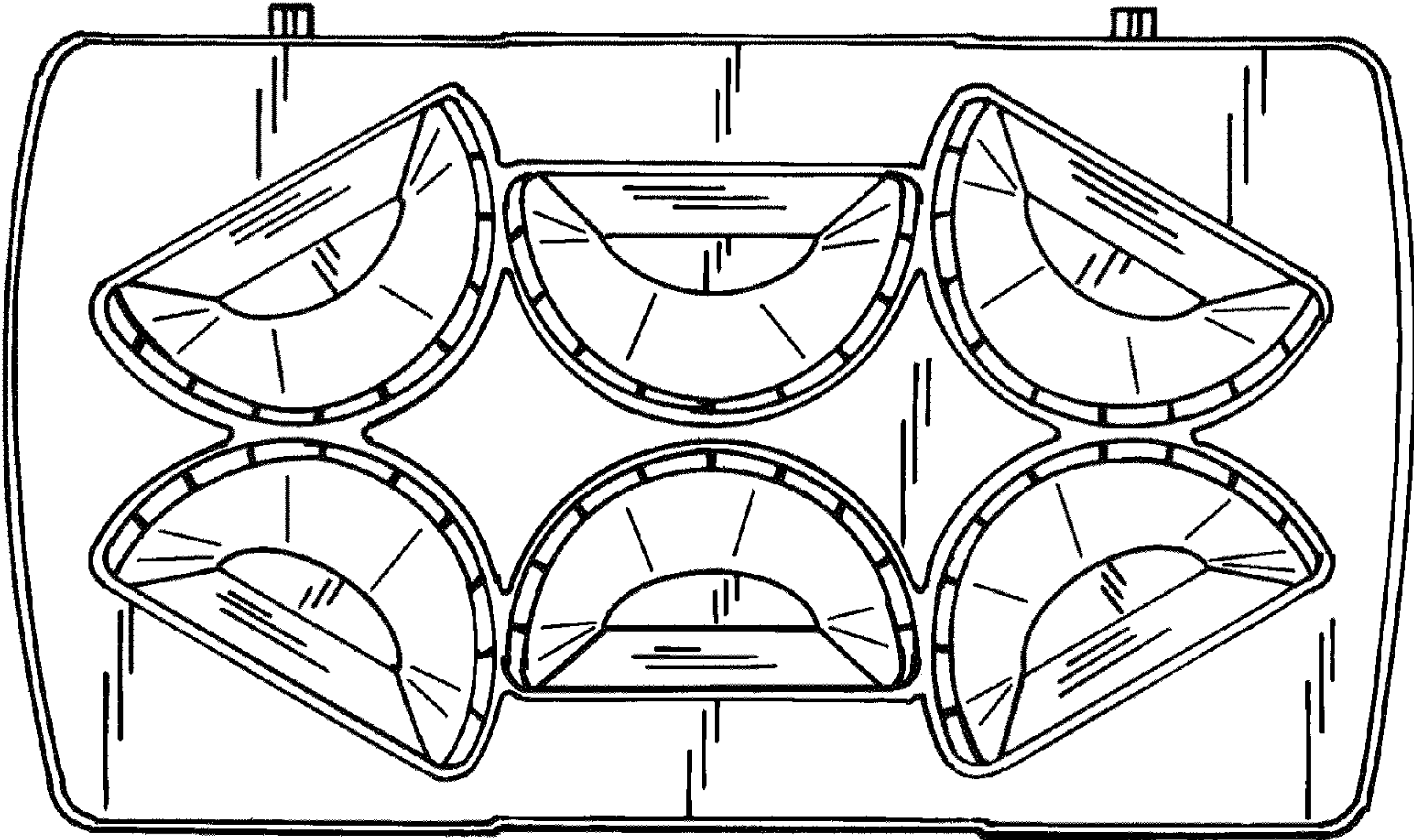

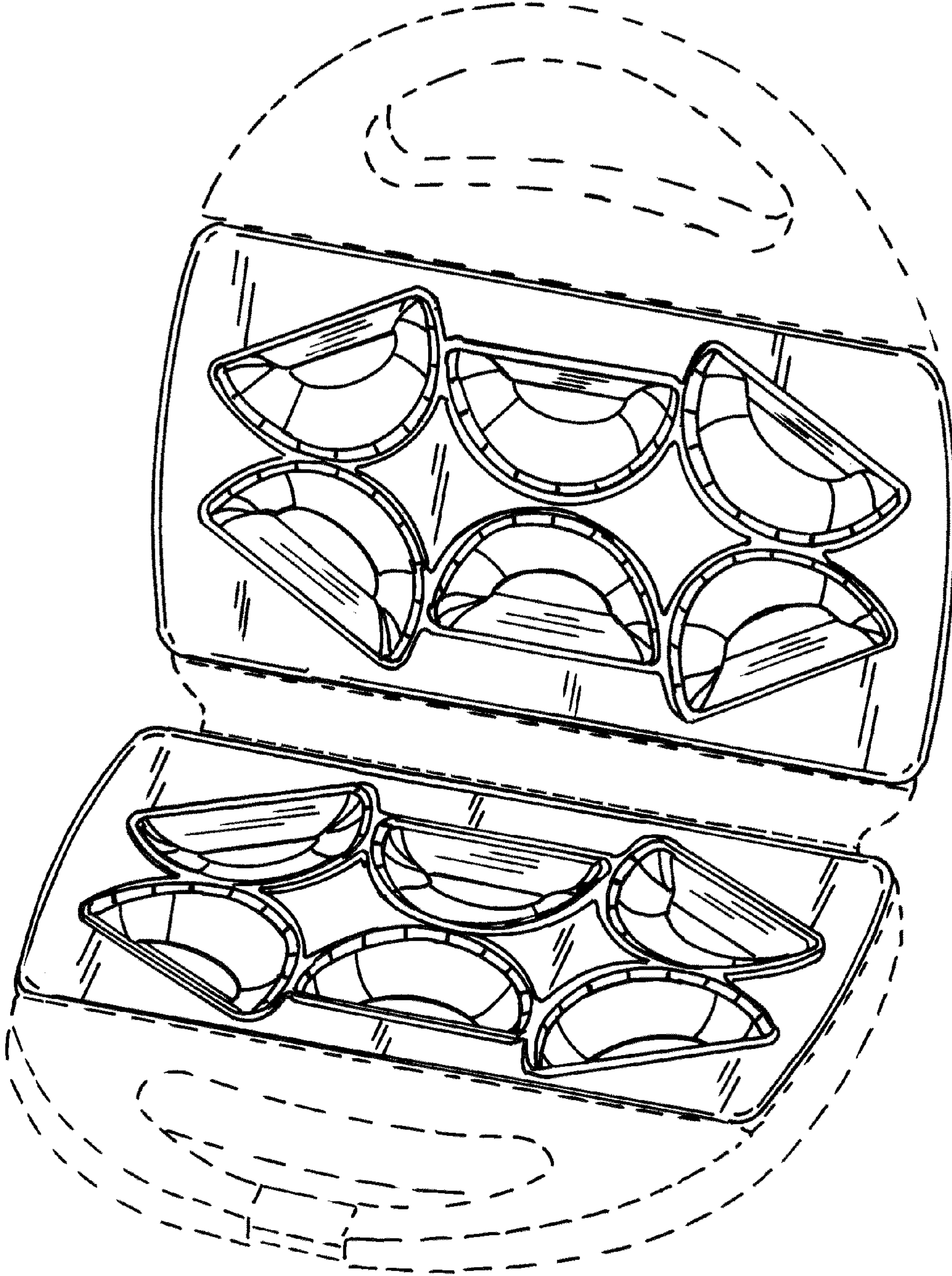

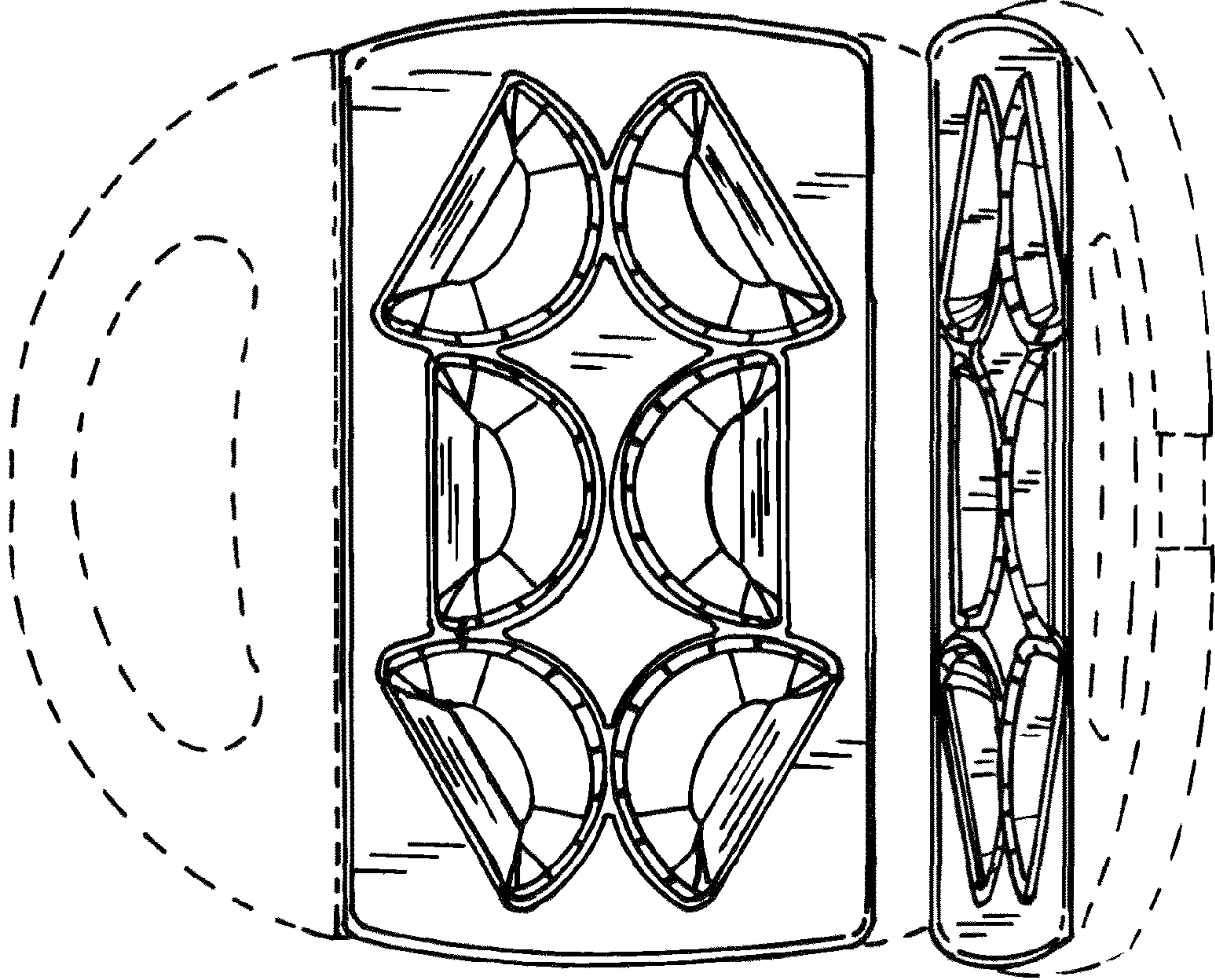
