(57) **CLAIM**

The ornamental design for a grip tray, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the grip tray.
FIG. 2 is a side view of the grip tray.
FIG. 3 is a bottom view of the grip tray; and,
FIG. 4 is a front view of the grip tray.
The broken lines shown in the drawing views of FIG. 1 and FIG. 3 represent portions of the grip tray that form no part of the claimed design.

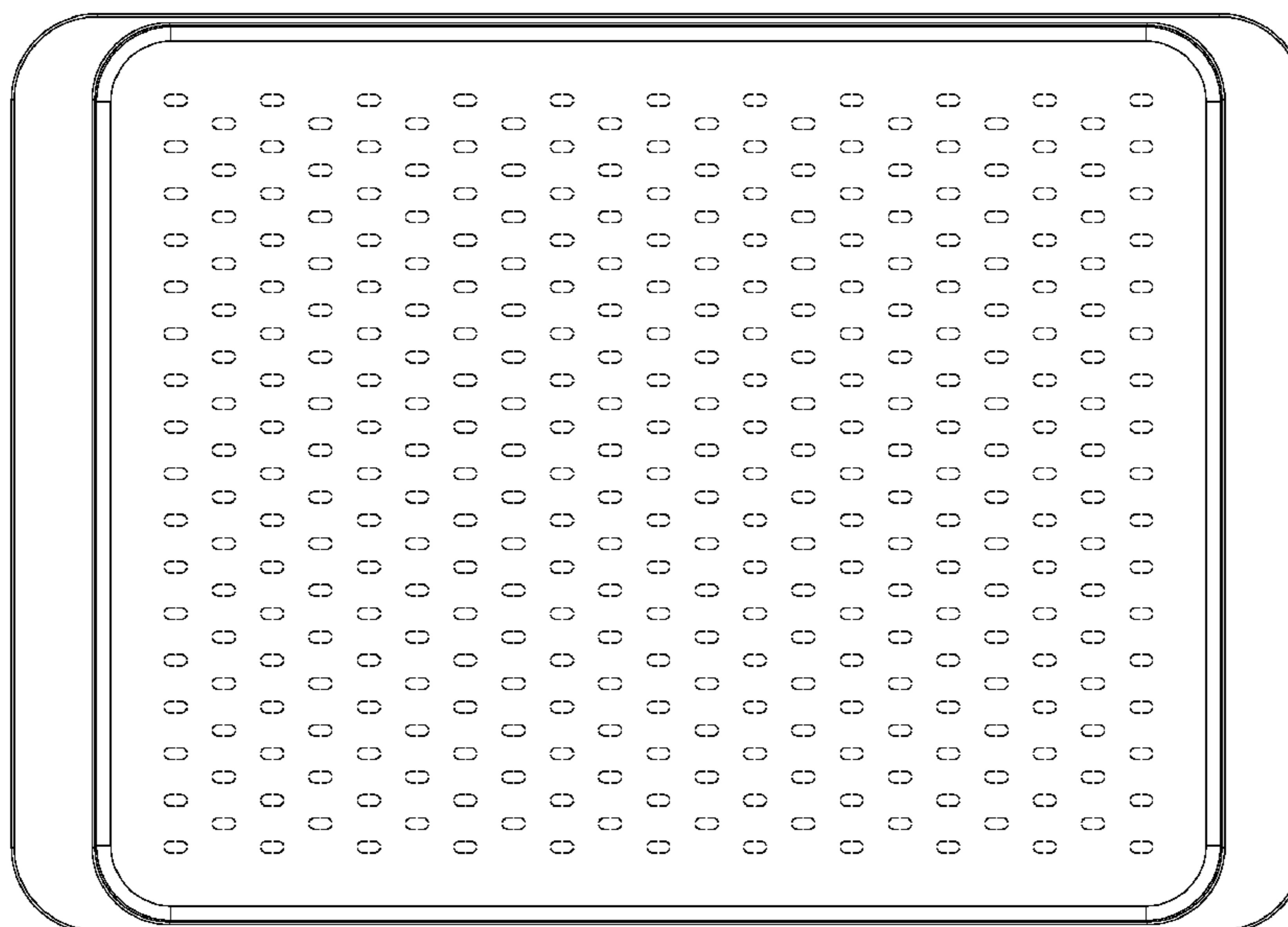
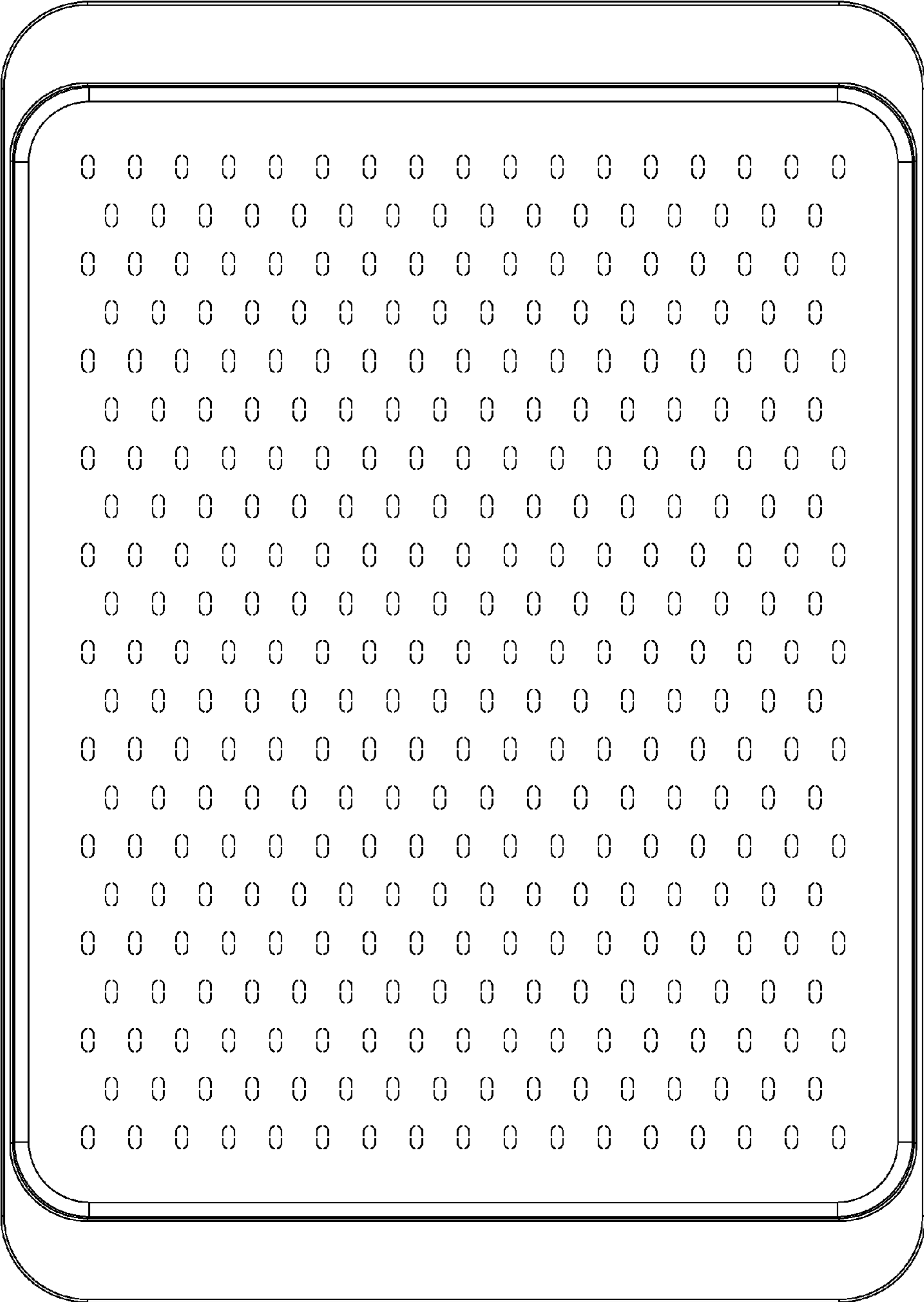

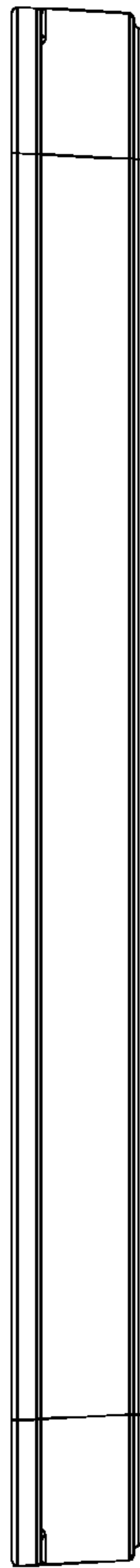
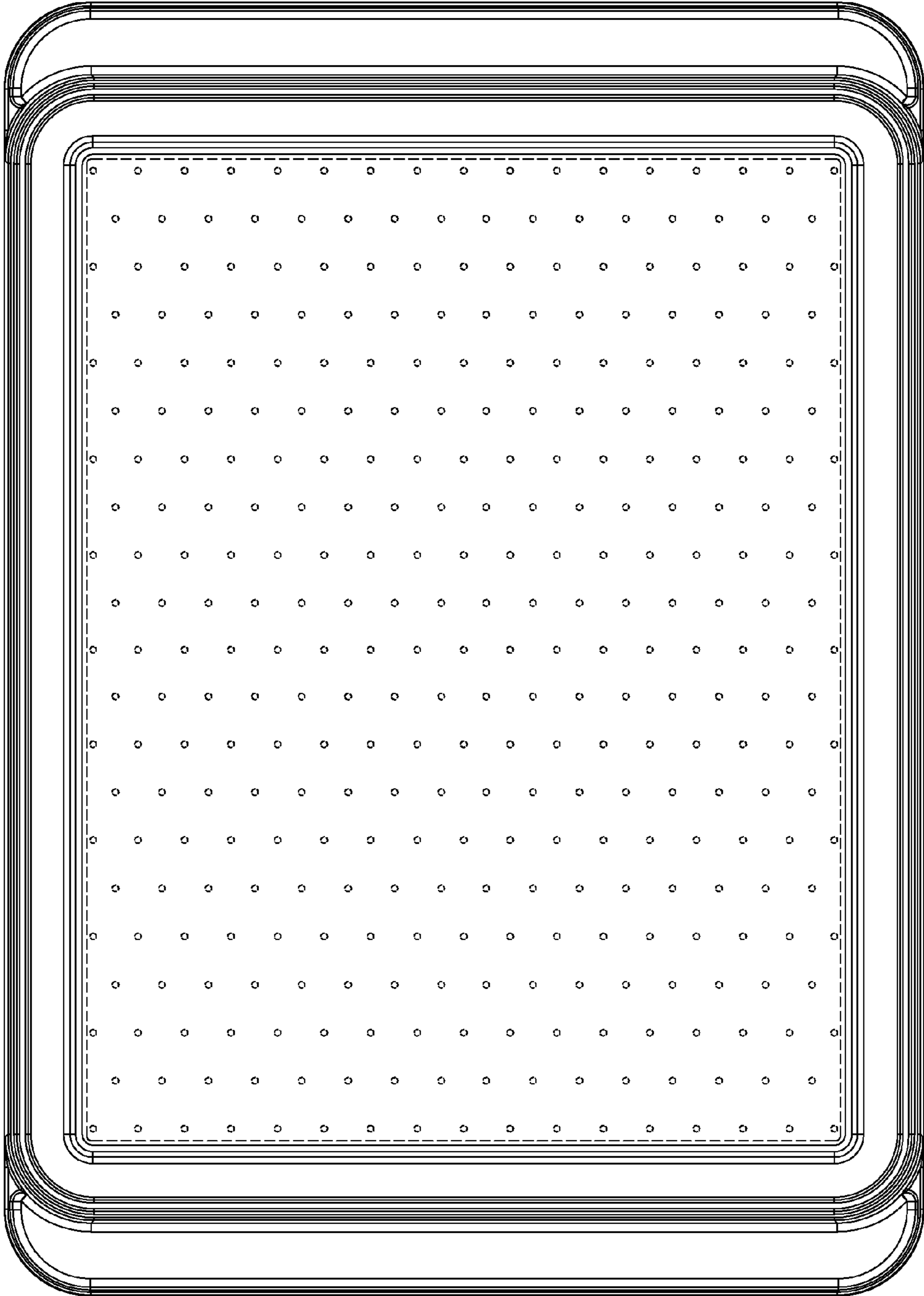

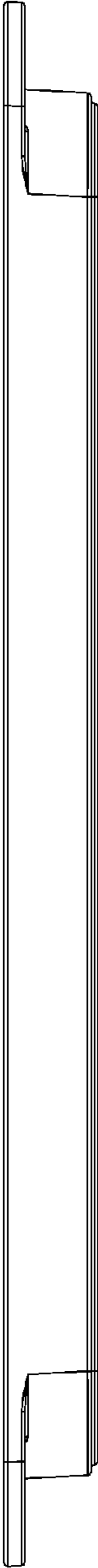
