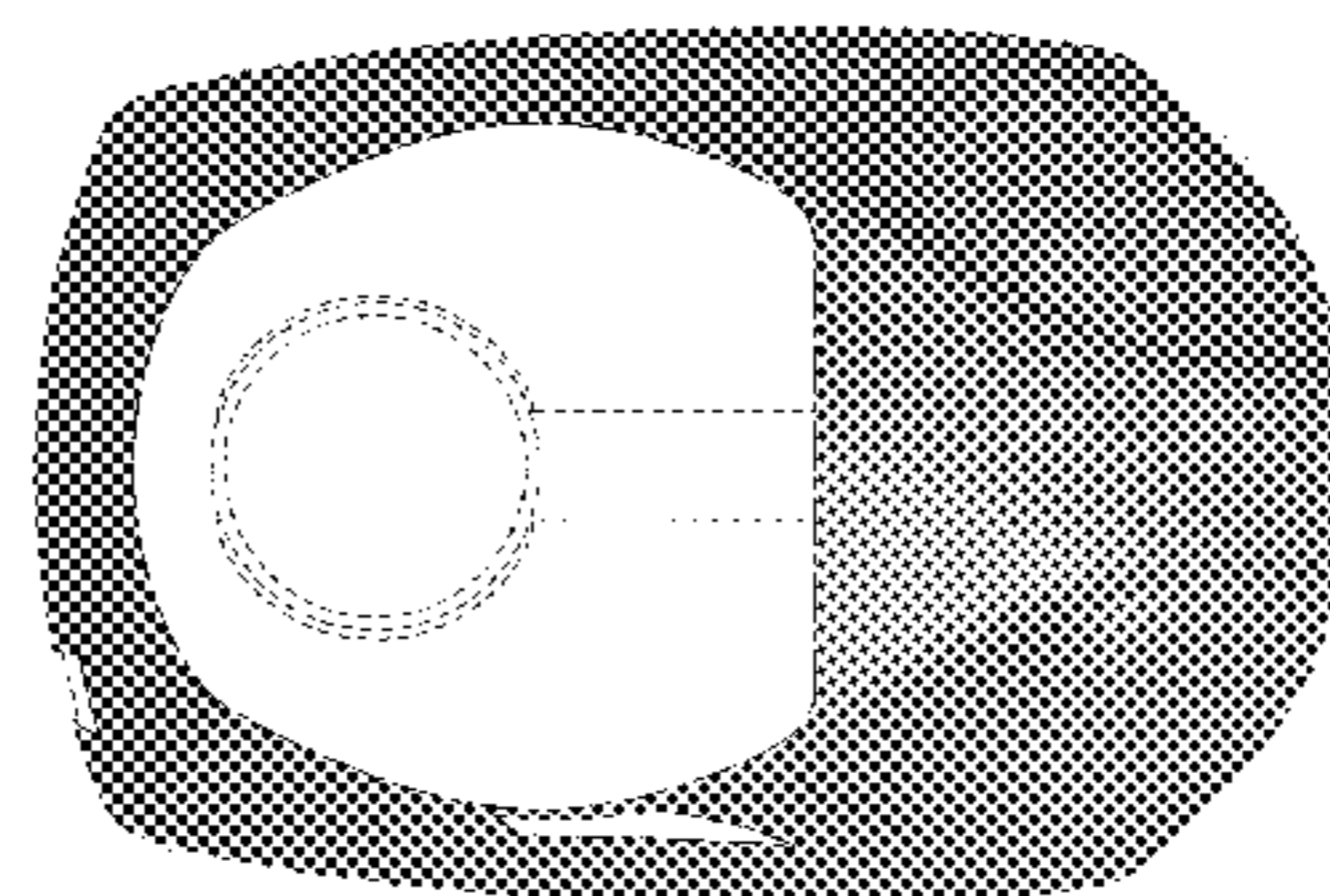
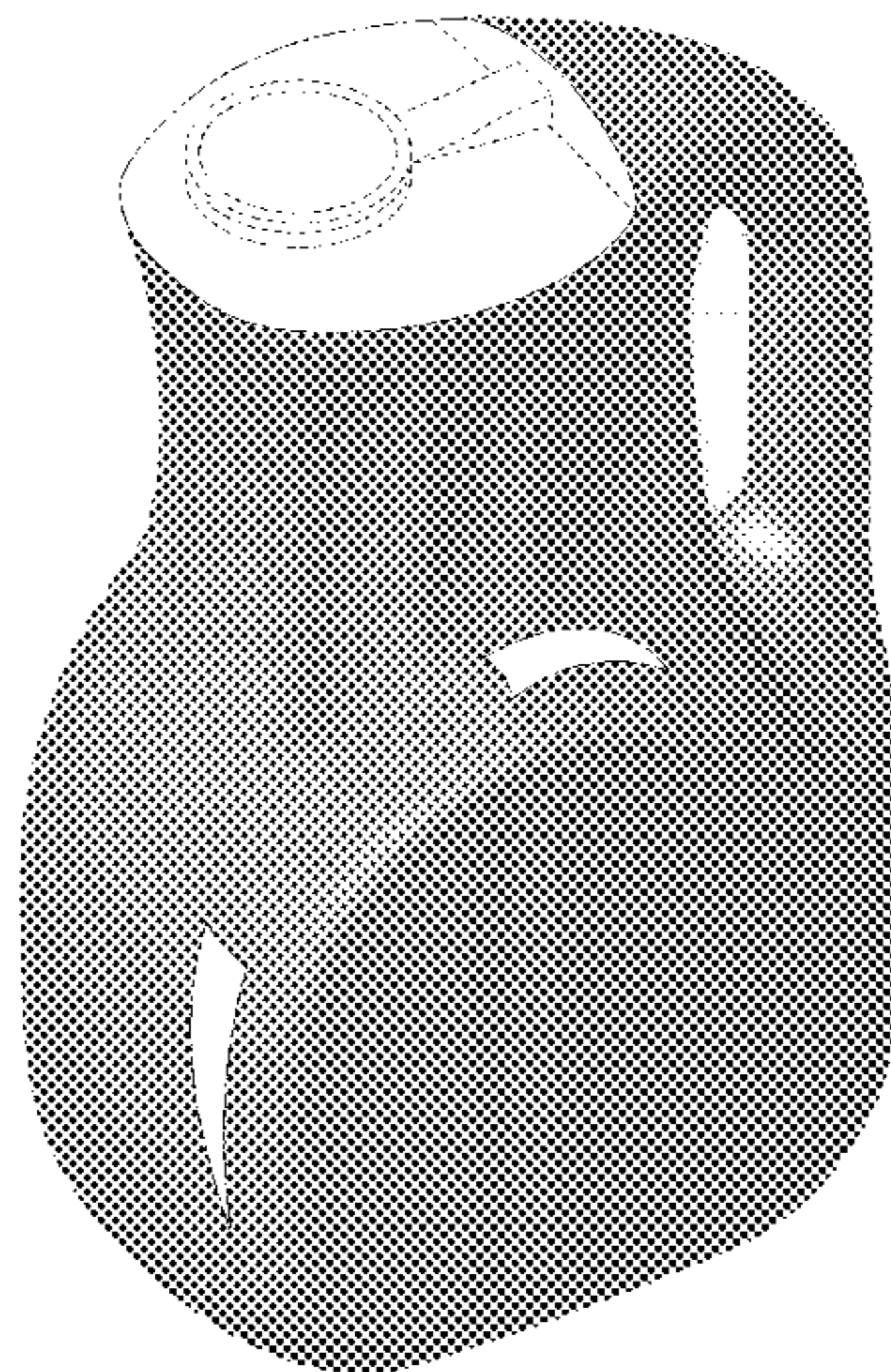
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a bottle showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; and, FIG. 6 is a top view thereof. The uneven-length broken lines represent unclaimed boundaries of the claimed design. The even-length broken lines showing the remainder of the bottle are for environmental purposes only and form no part of the claimed design.

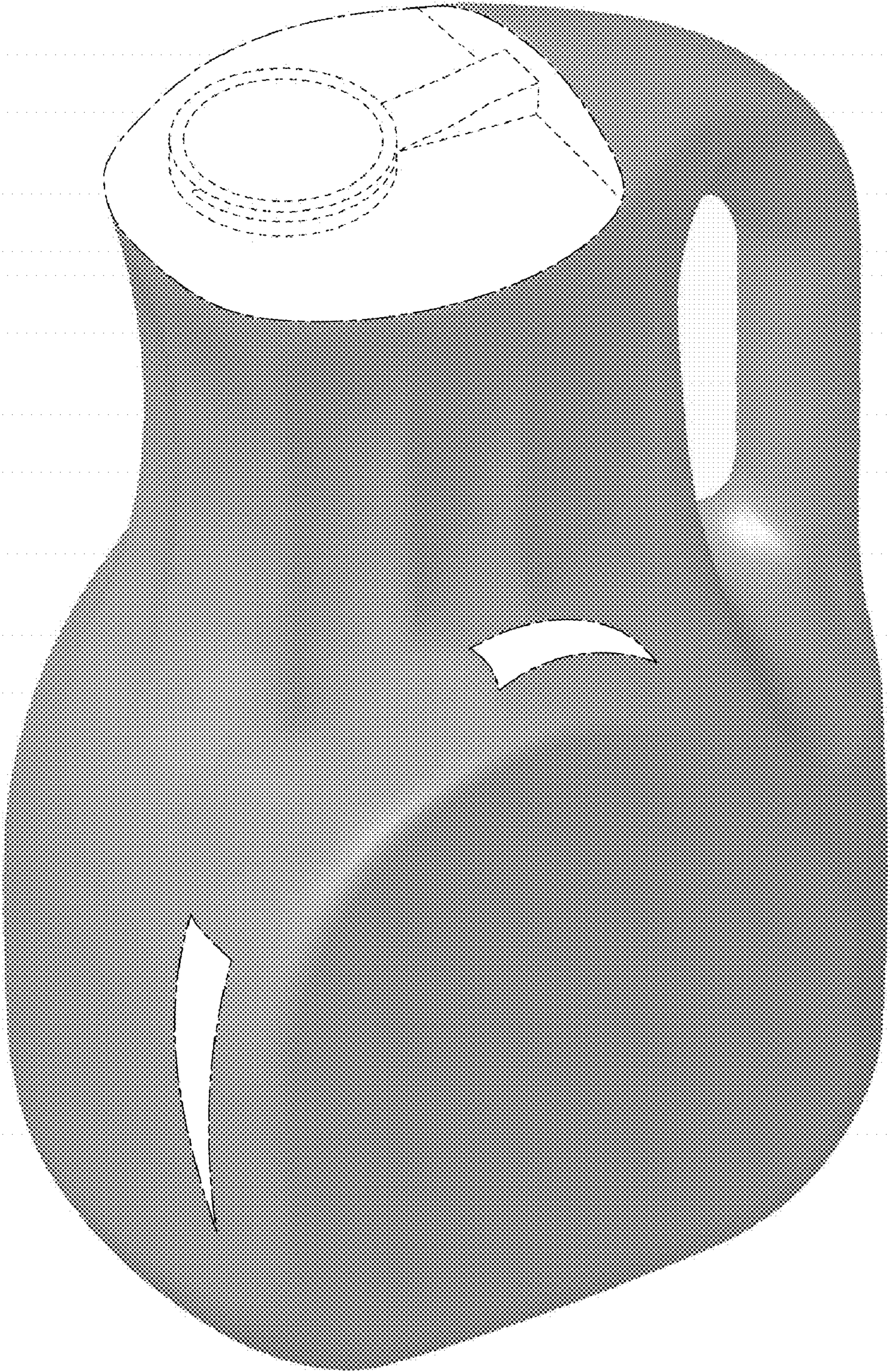

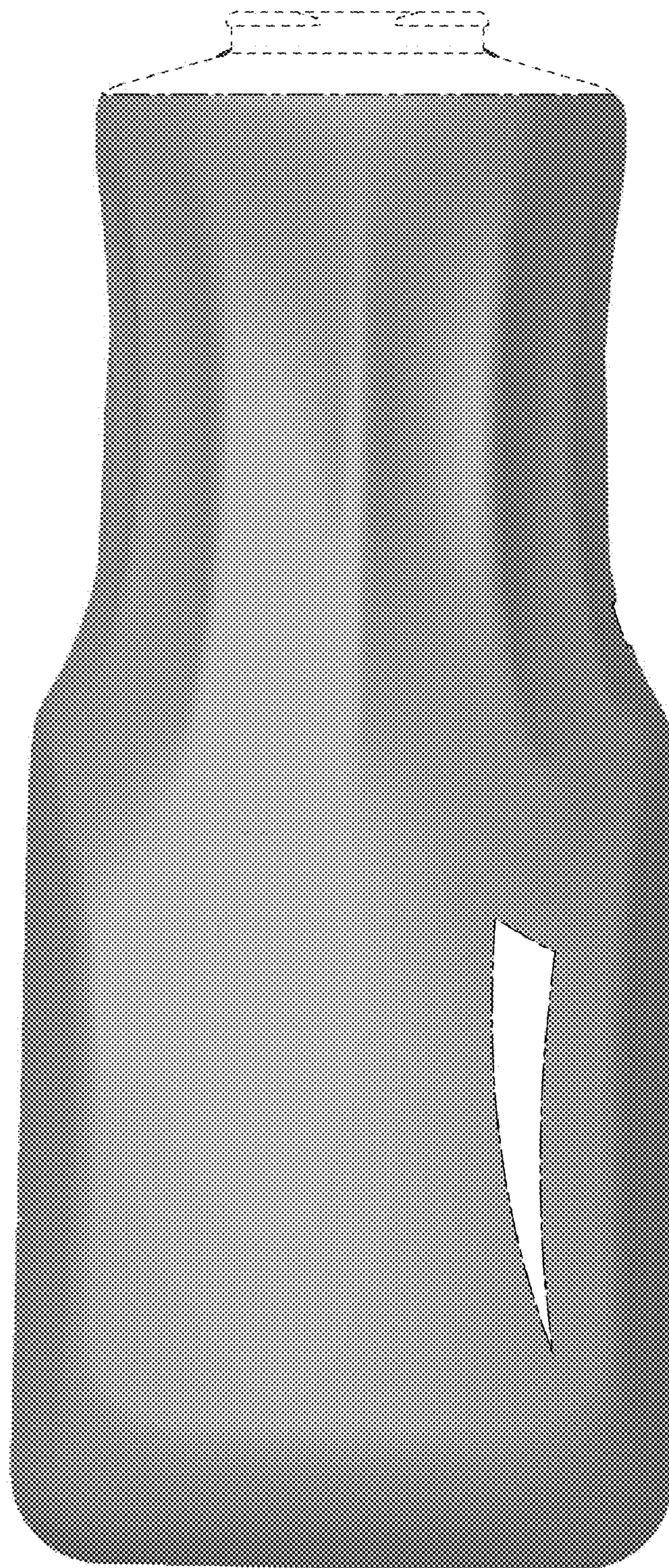

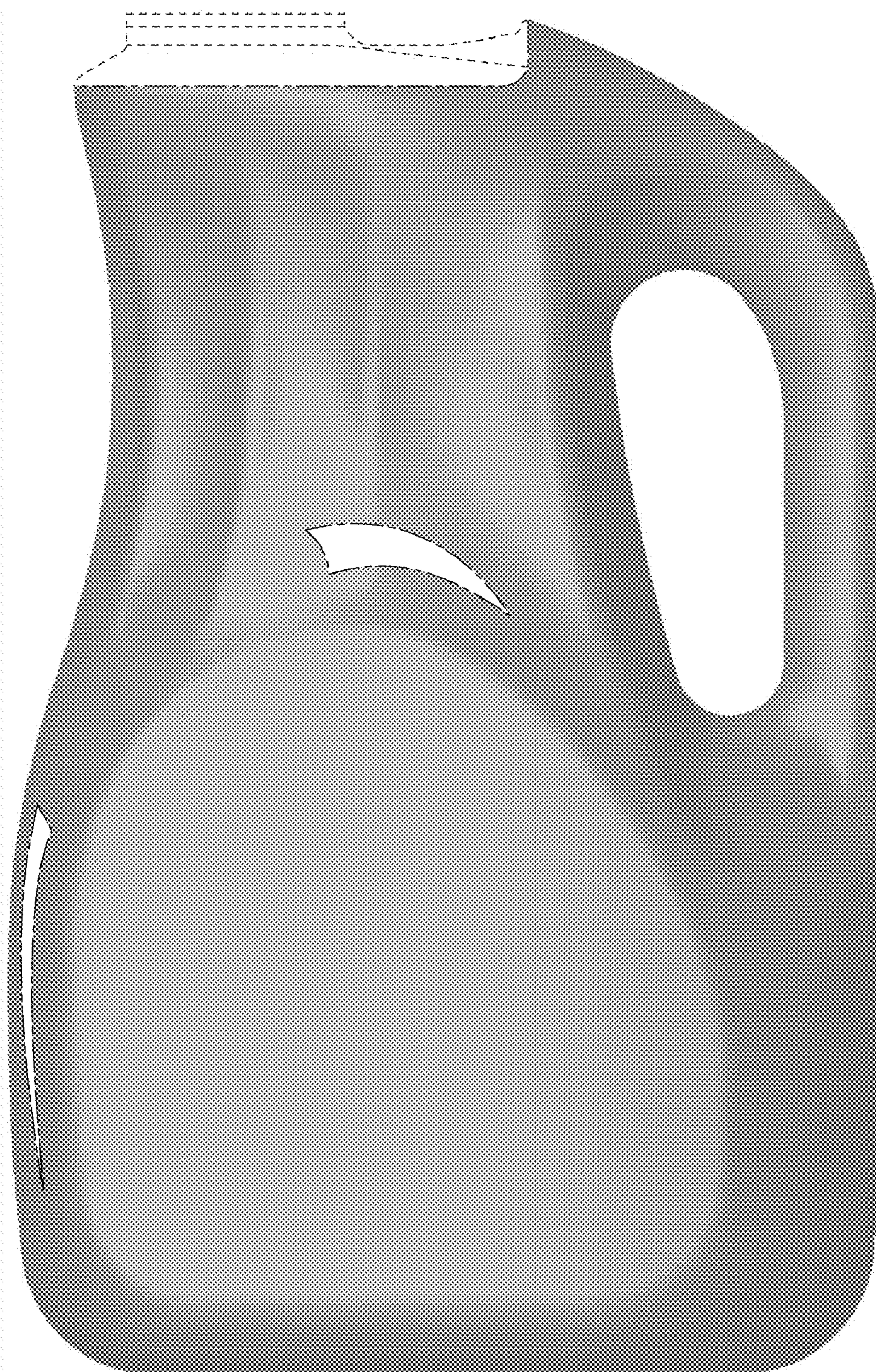

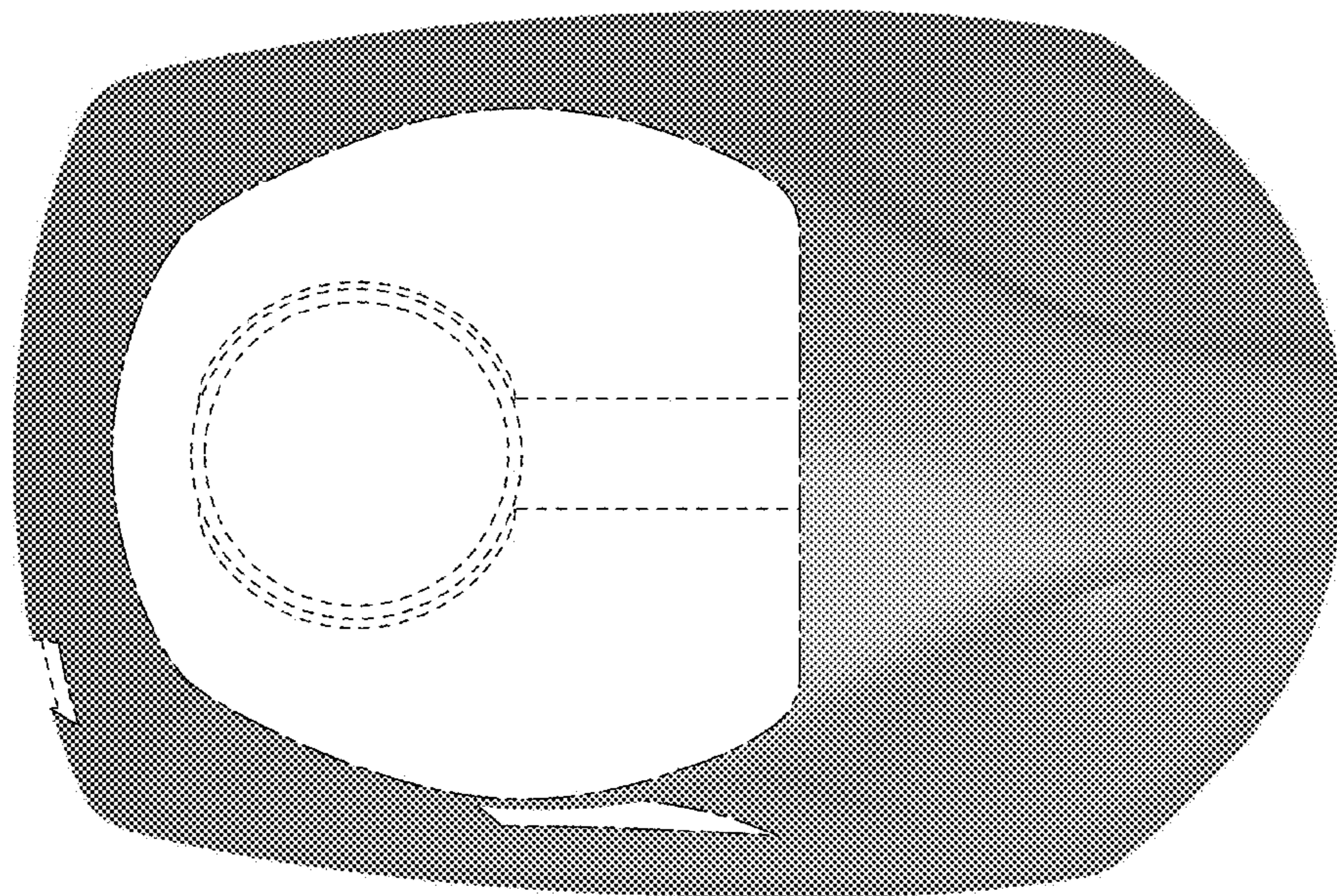
