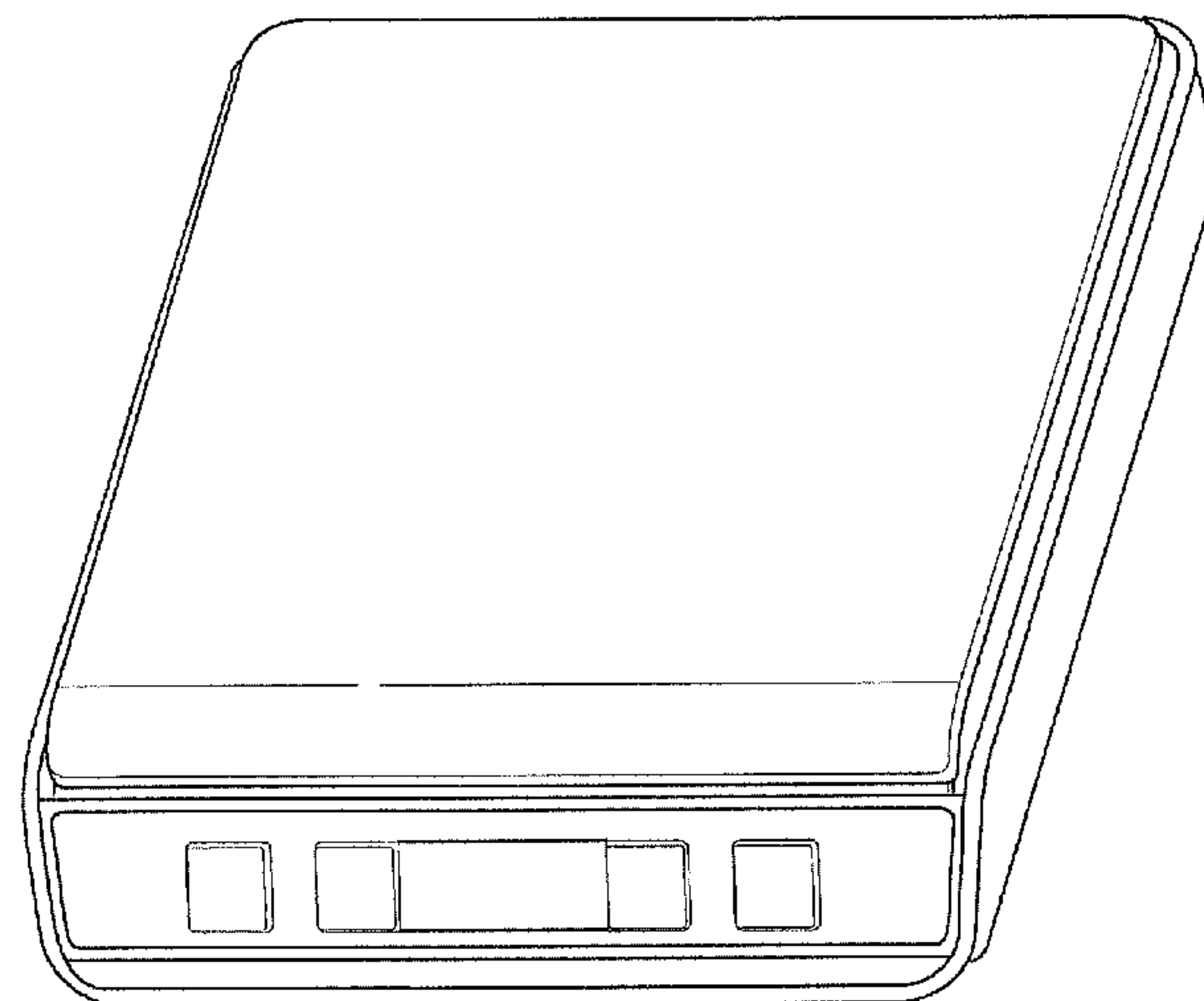
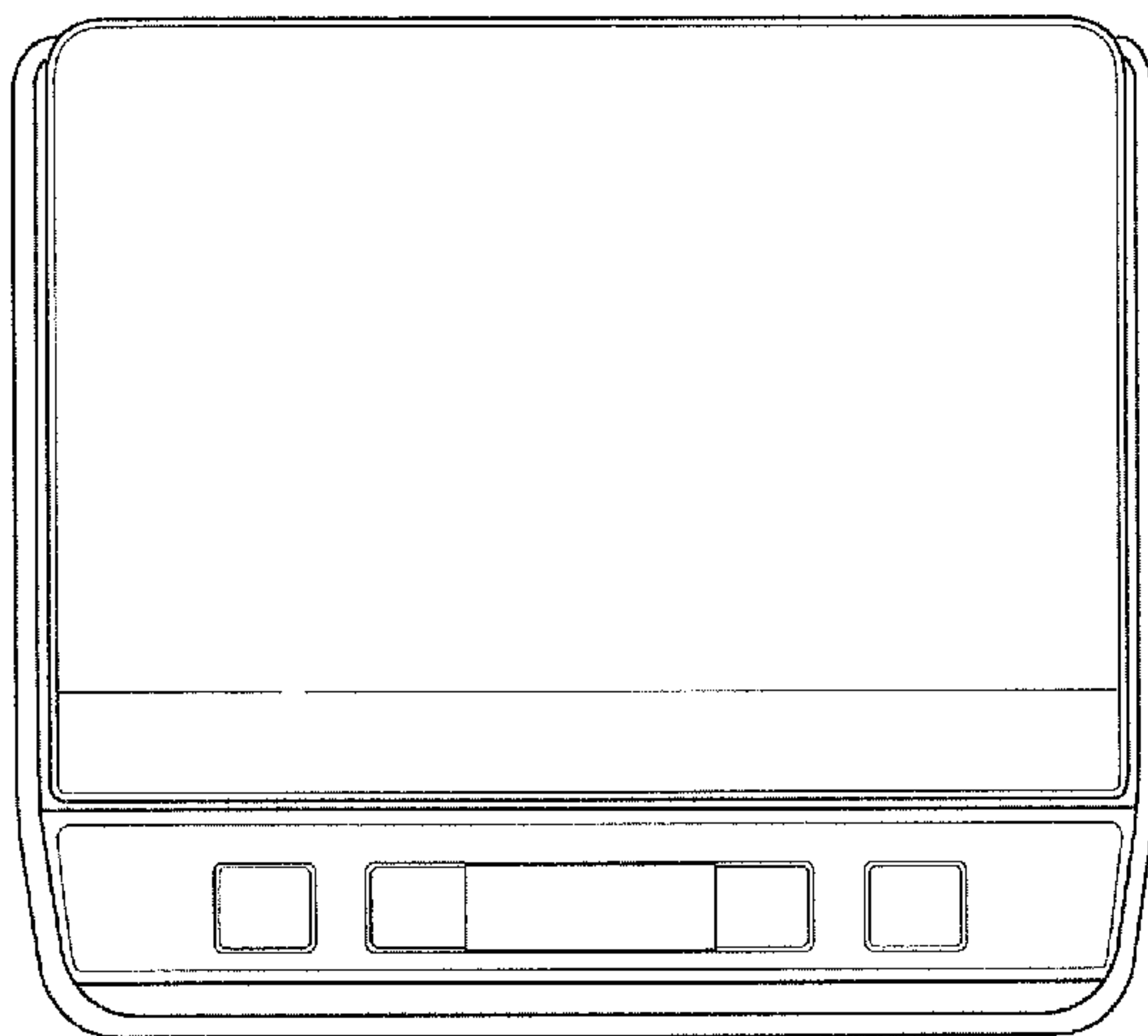

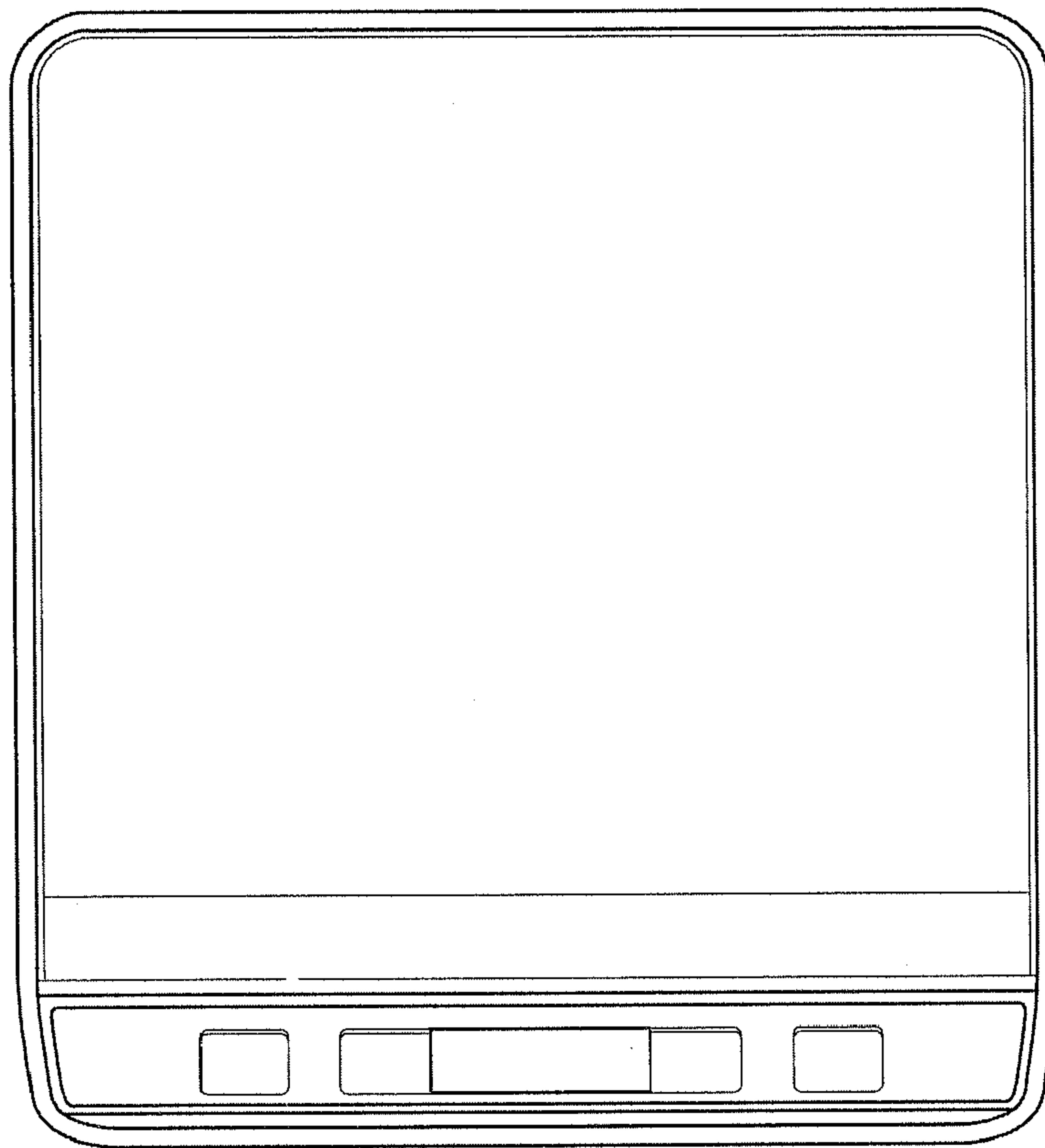
The ornamental design for a scale, as shown and described.

**DESCRIPTION**

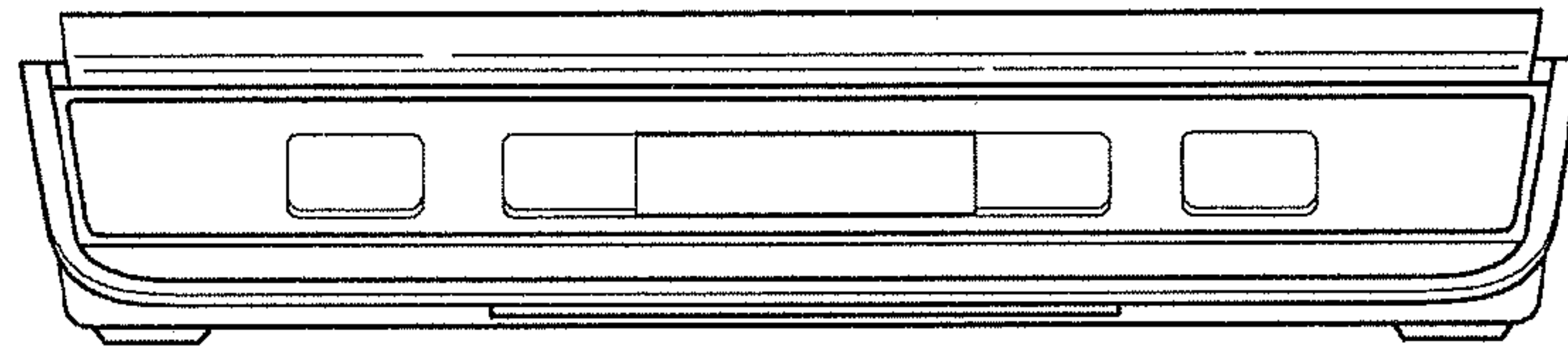

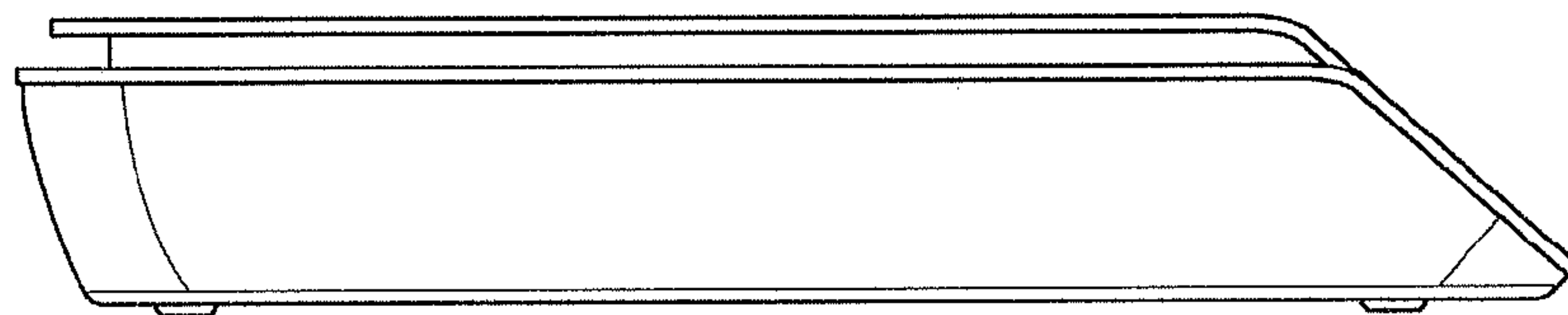




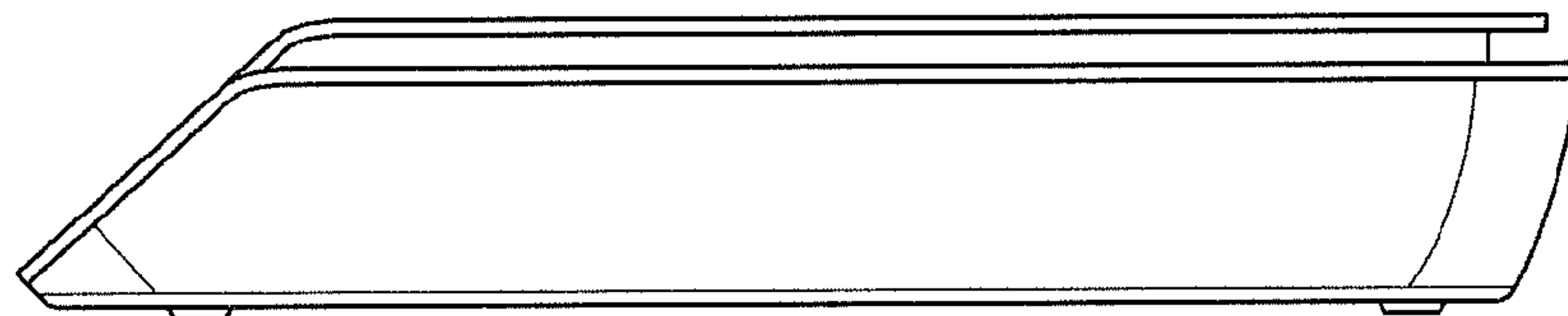

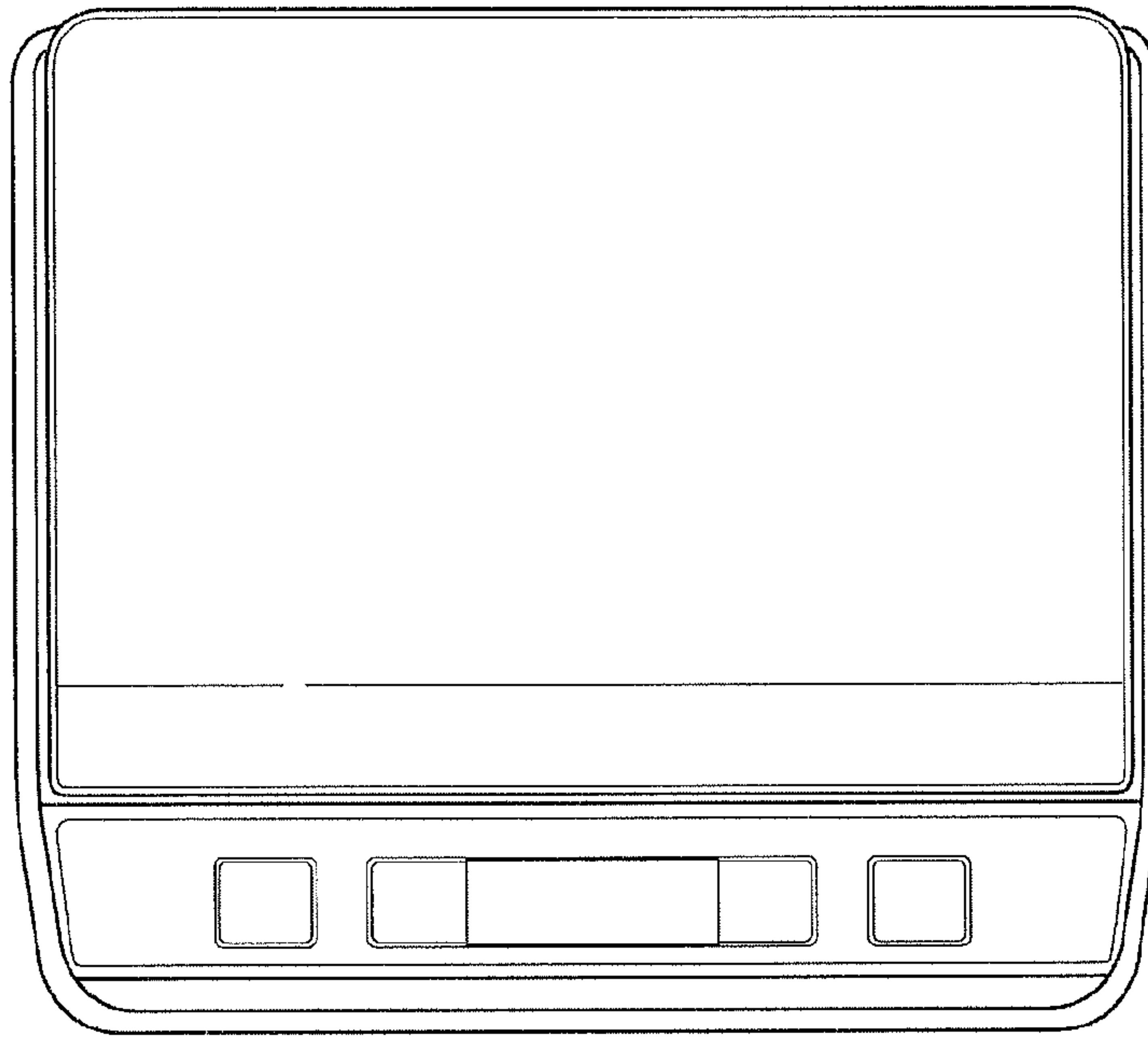

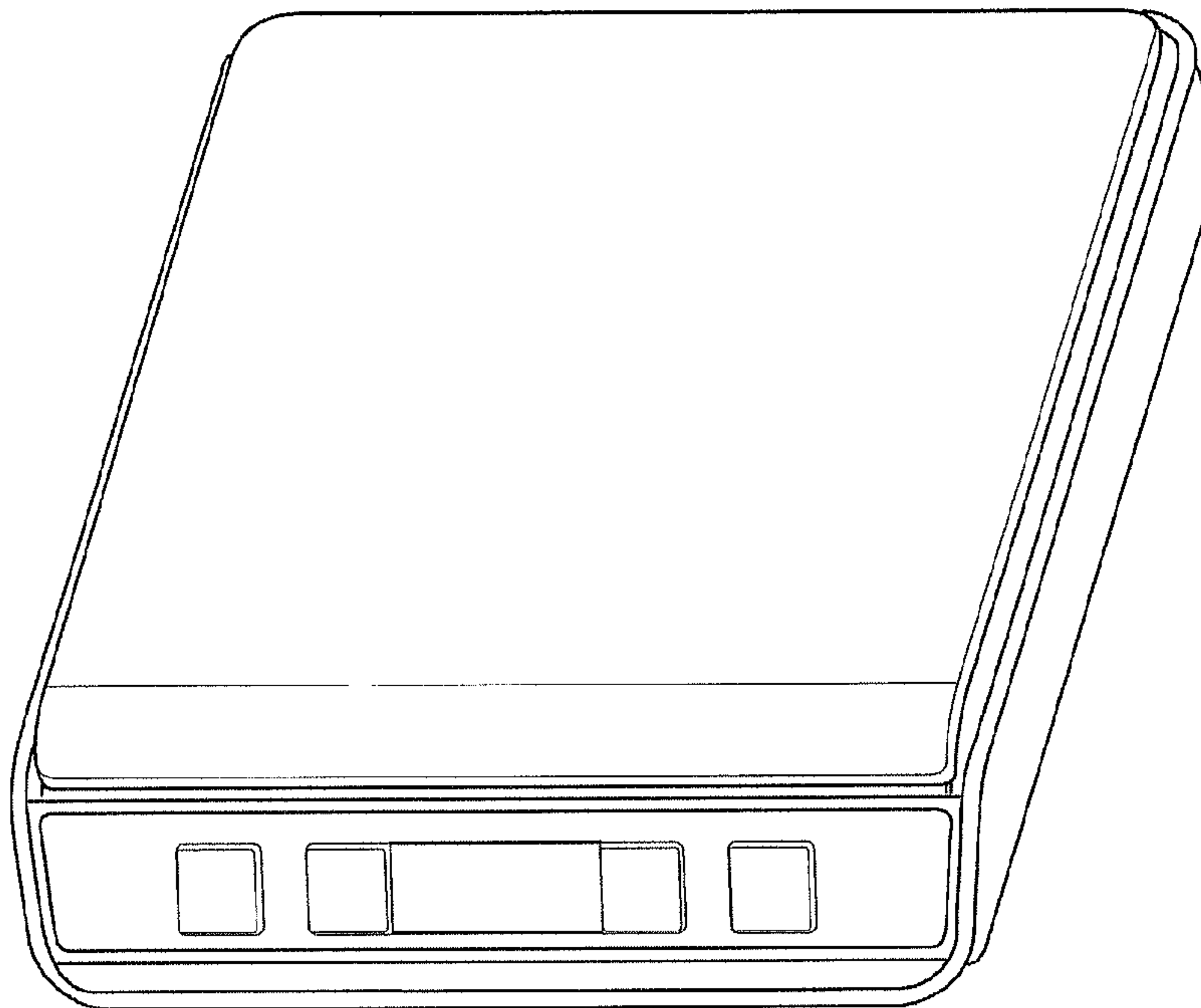

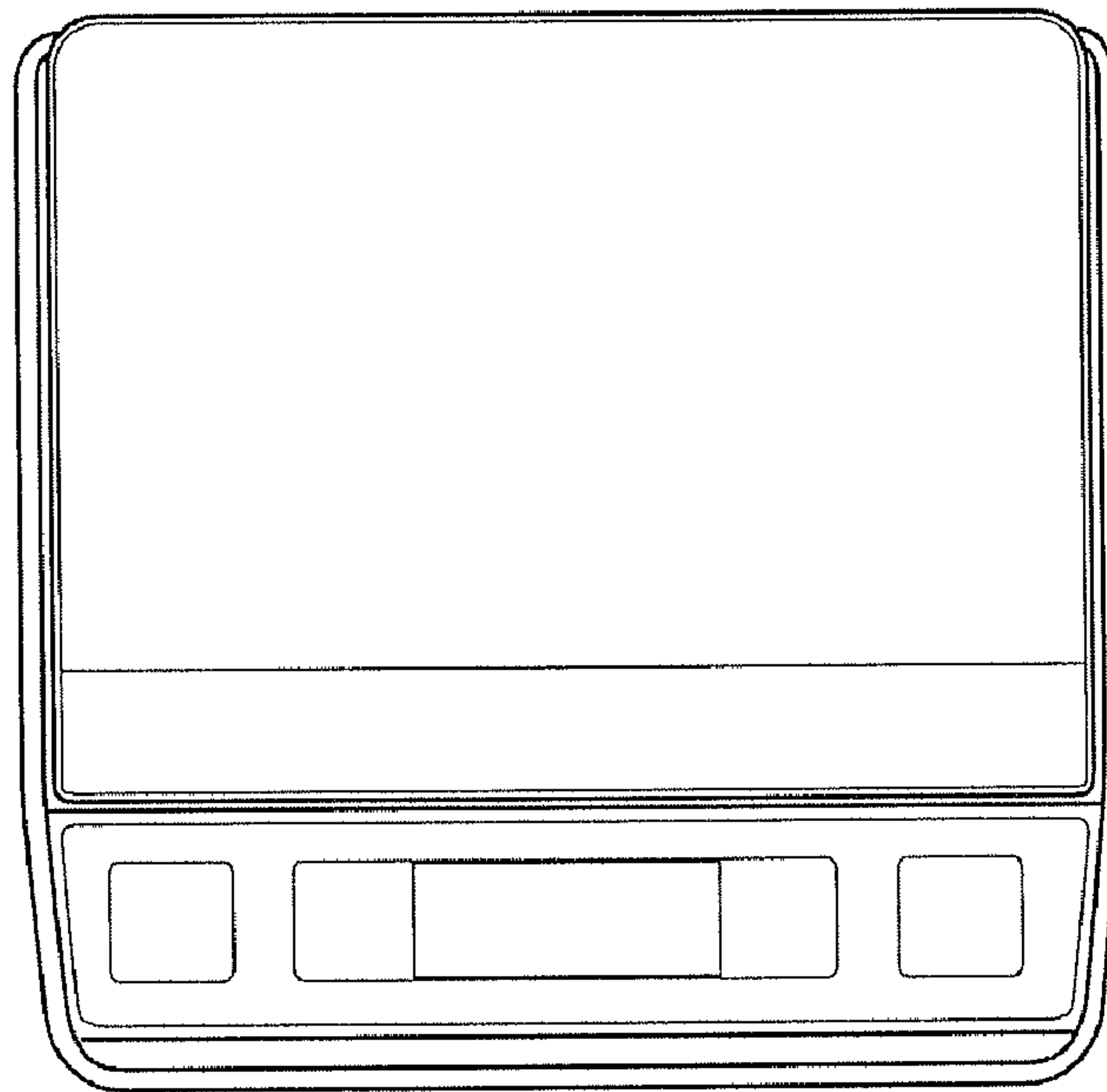

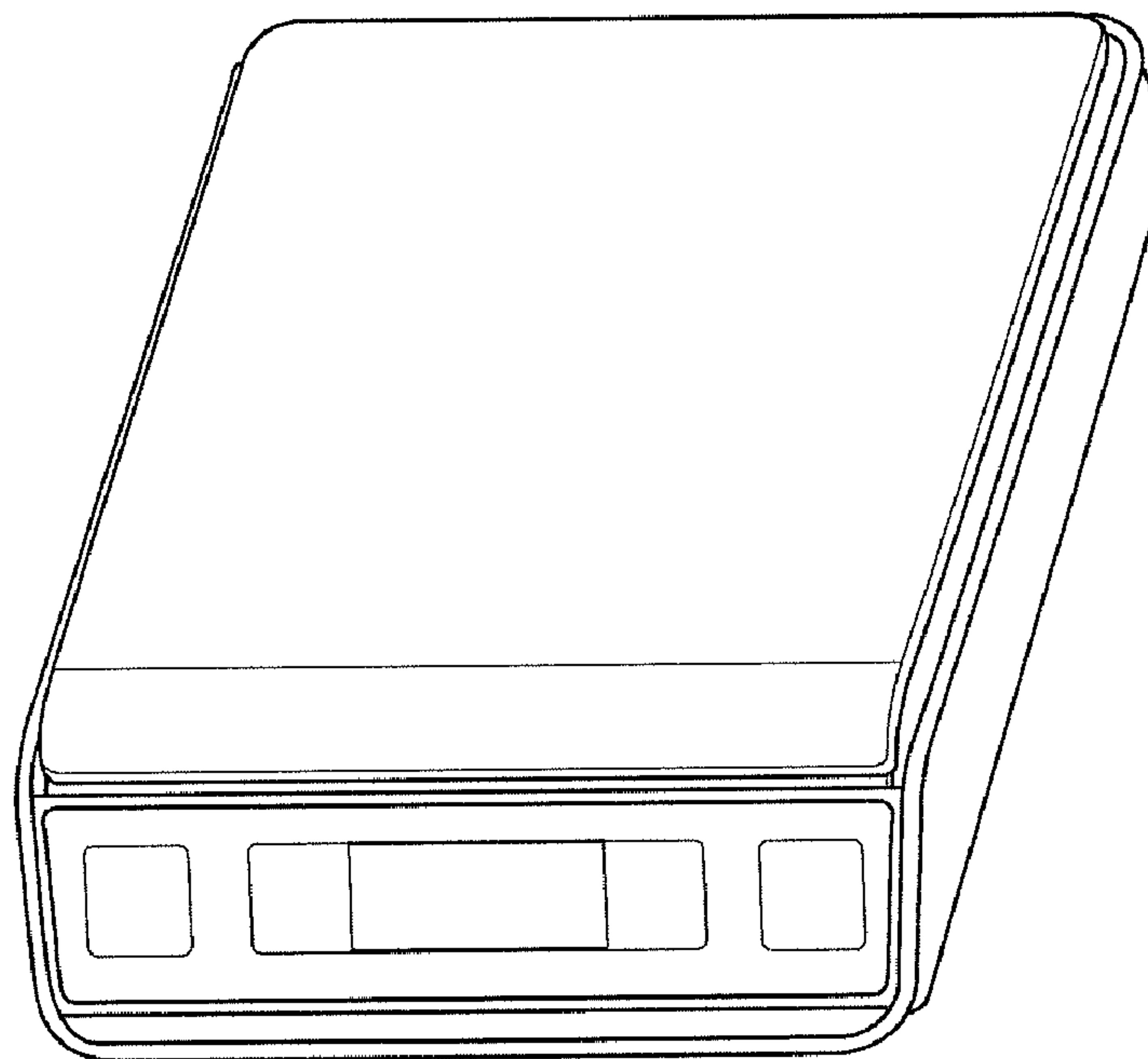

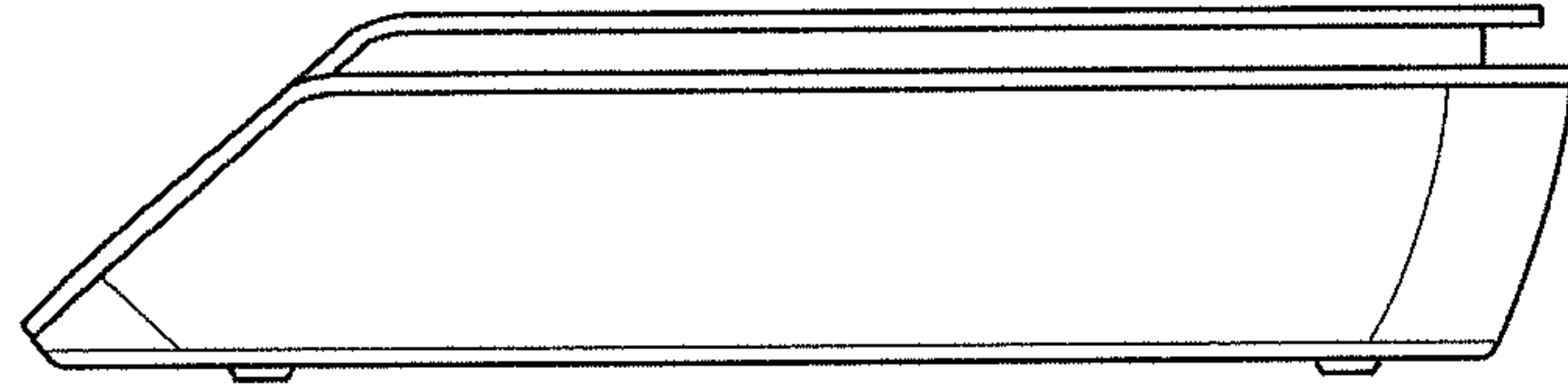

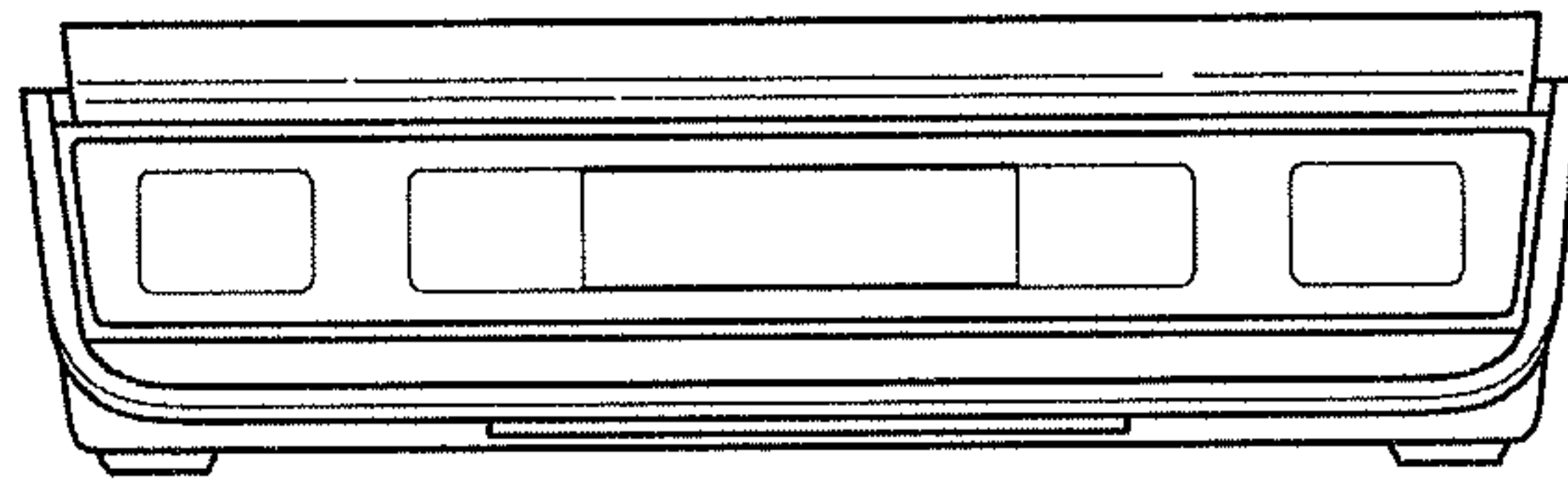

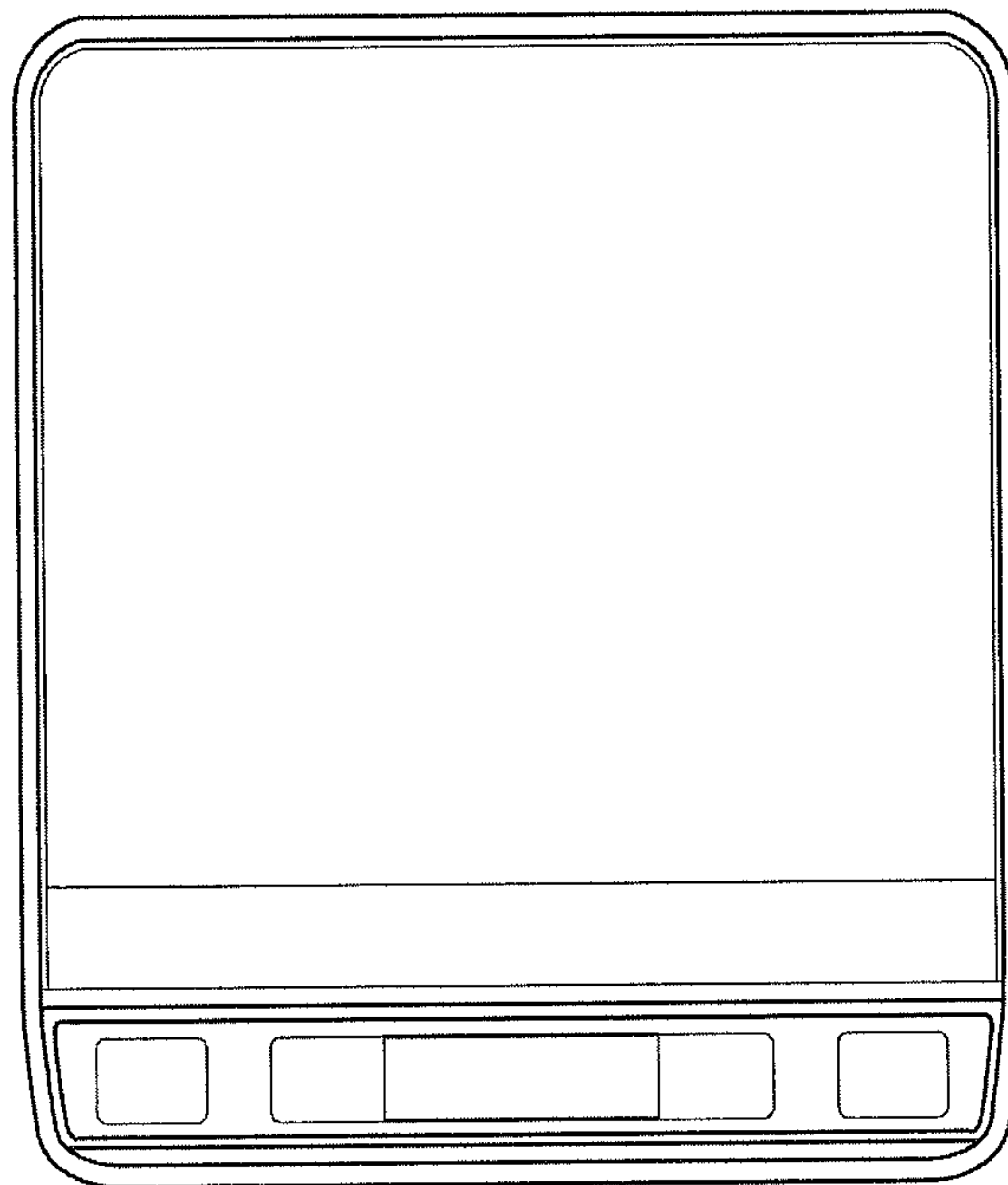

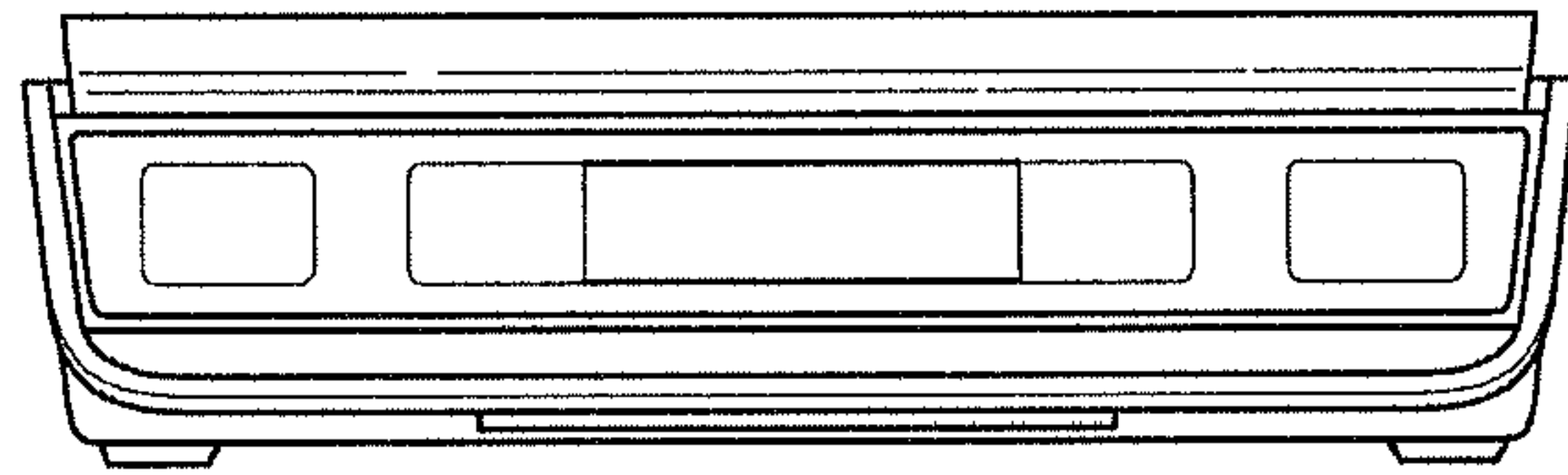

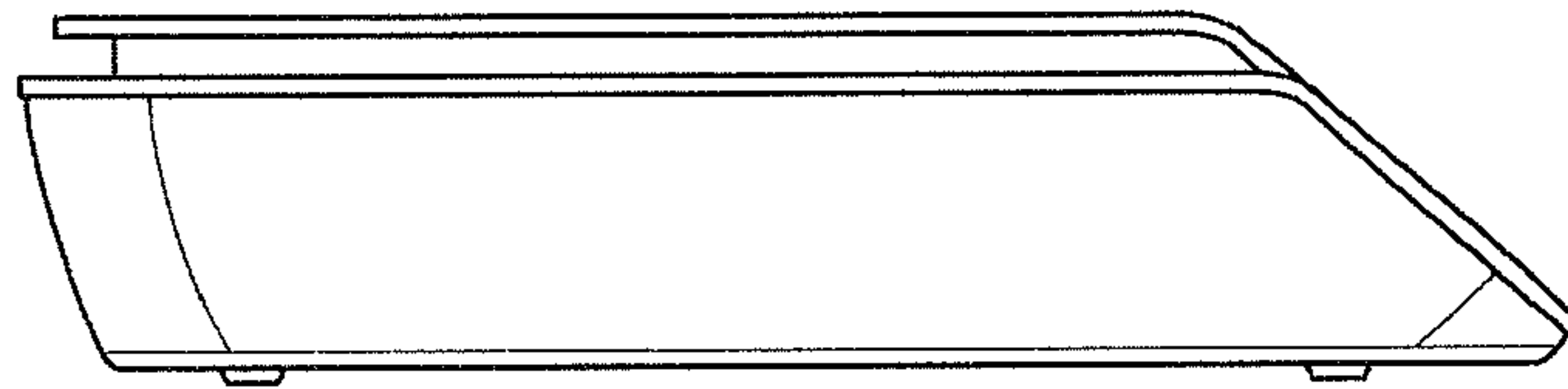
