DESCRIPTION

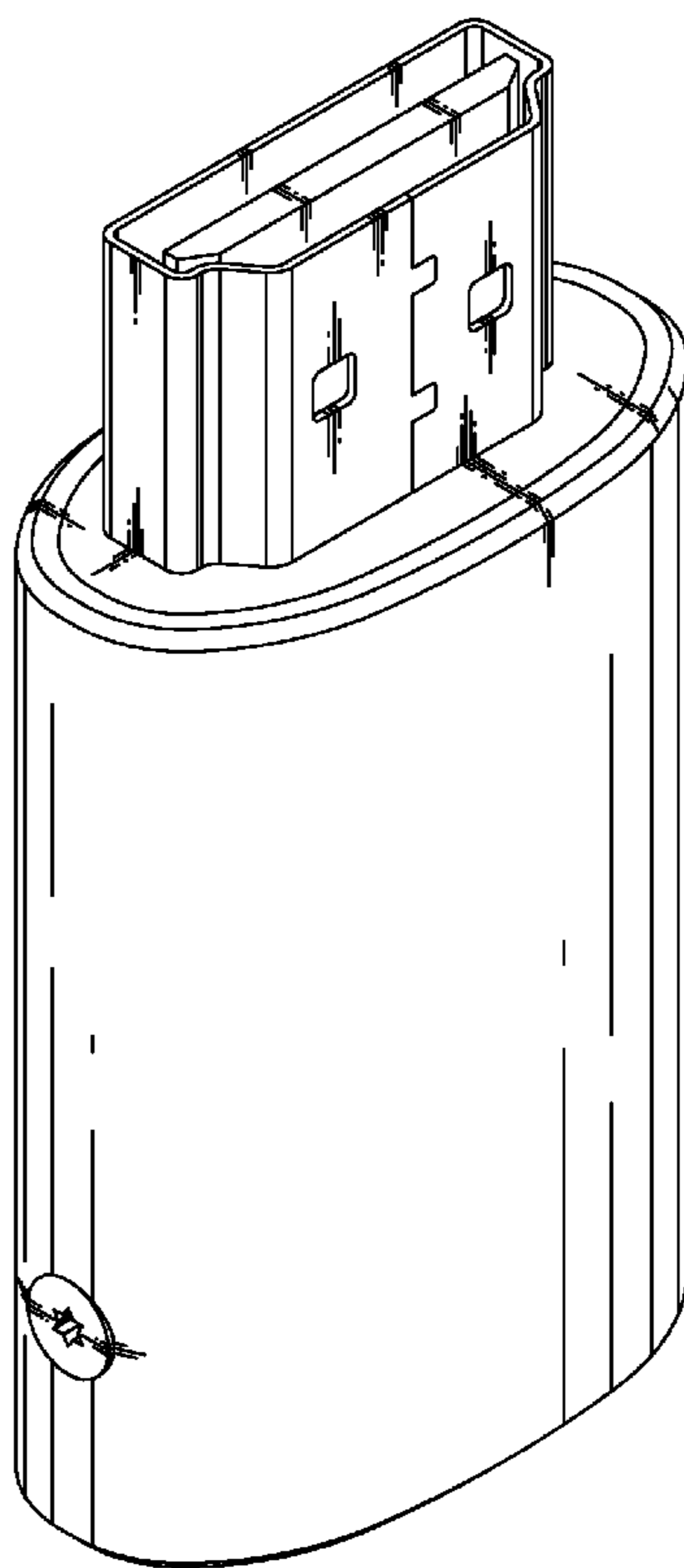

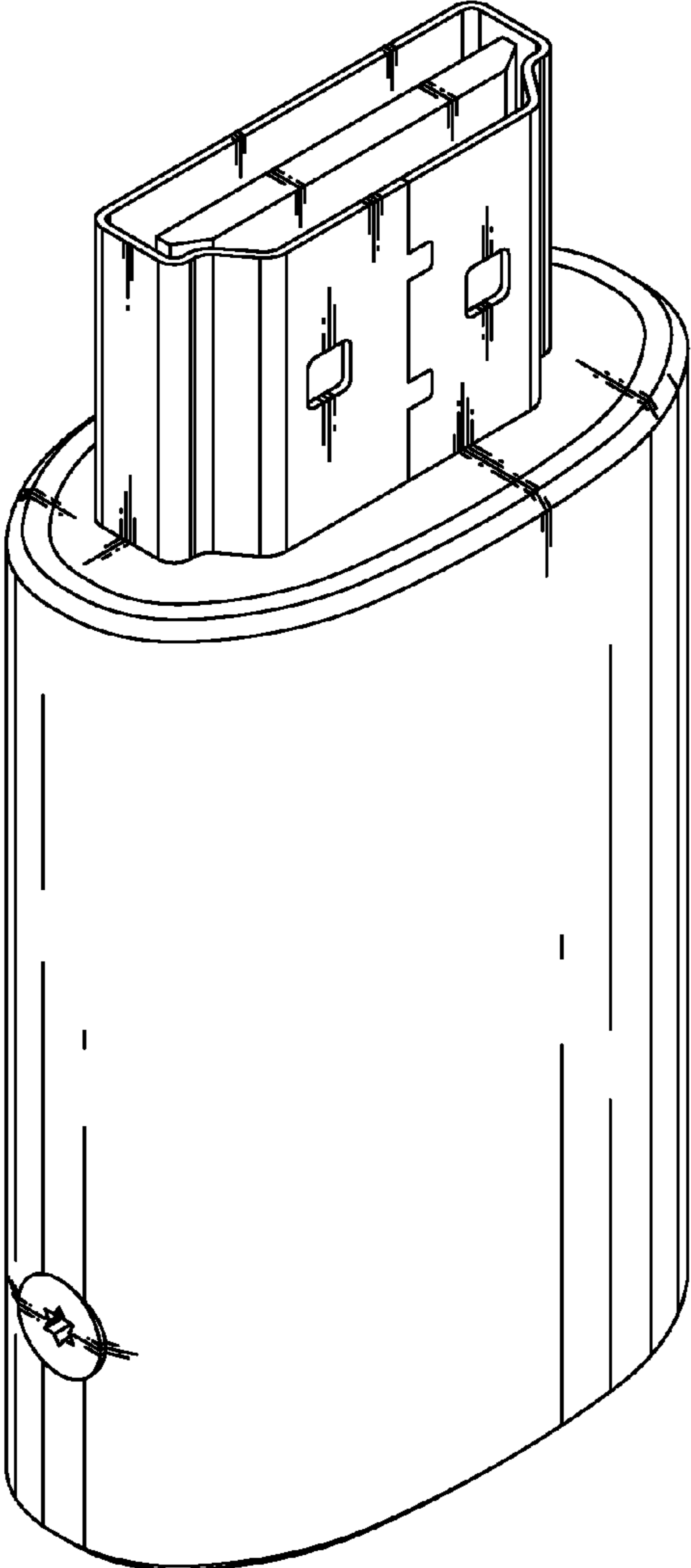

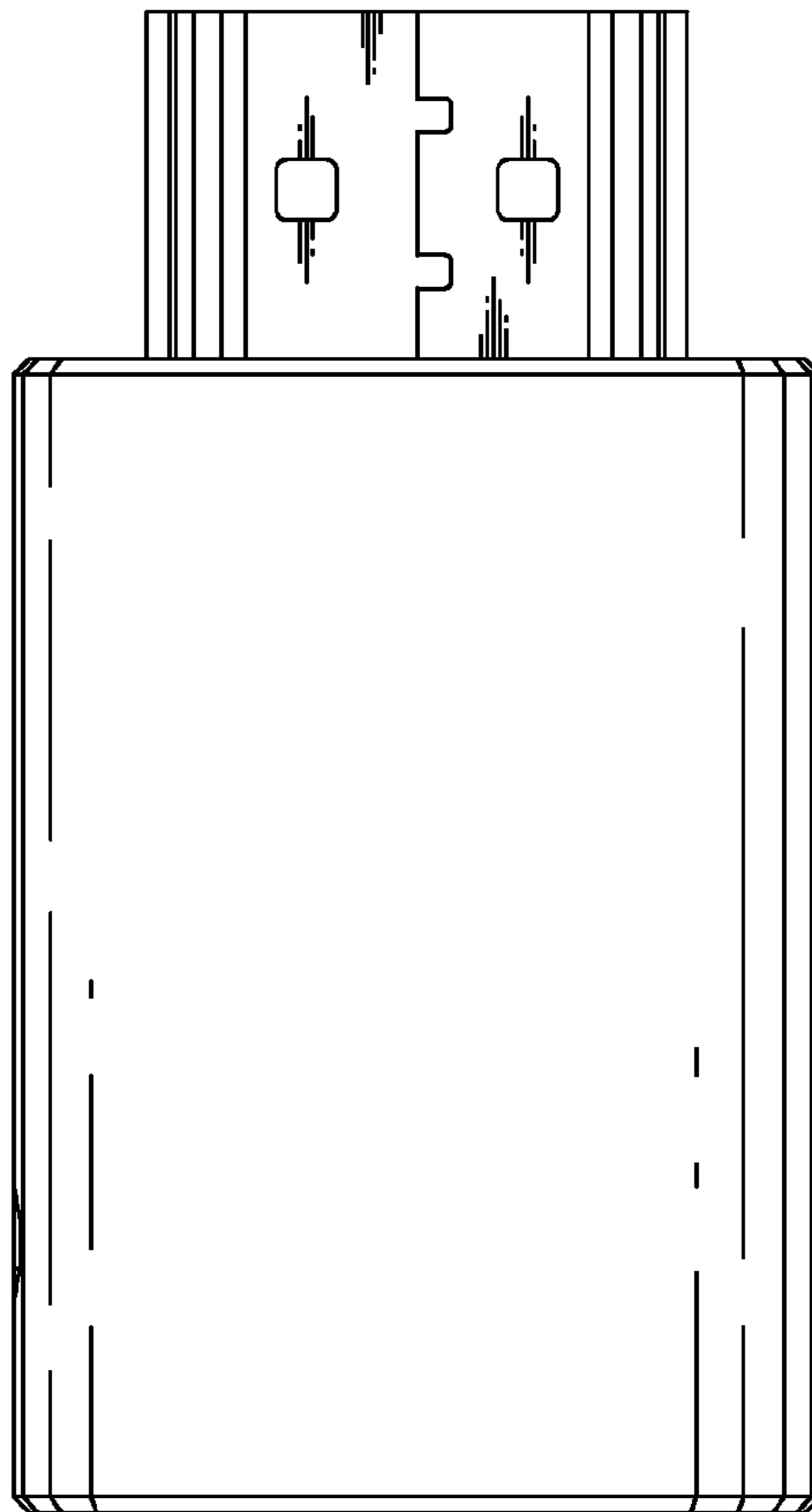

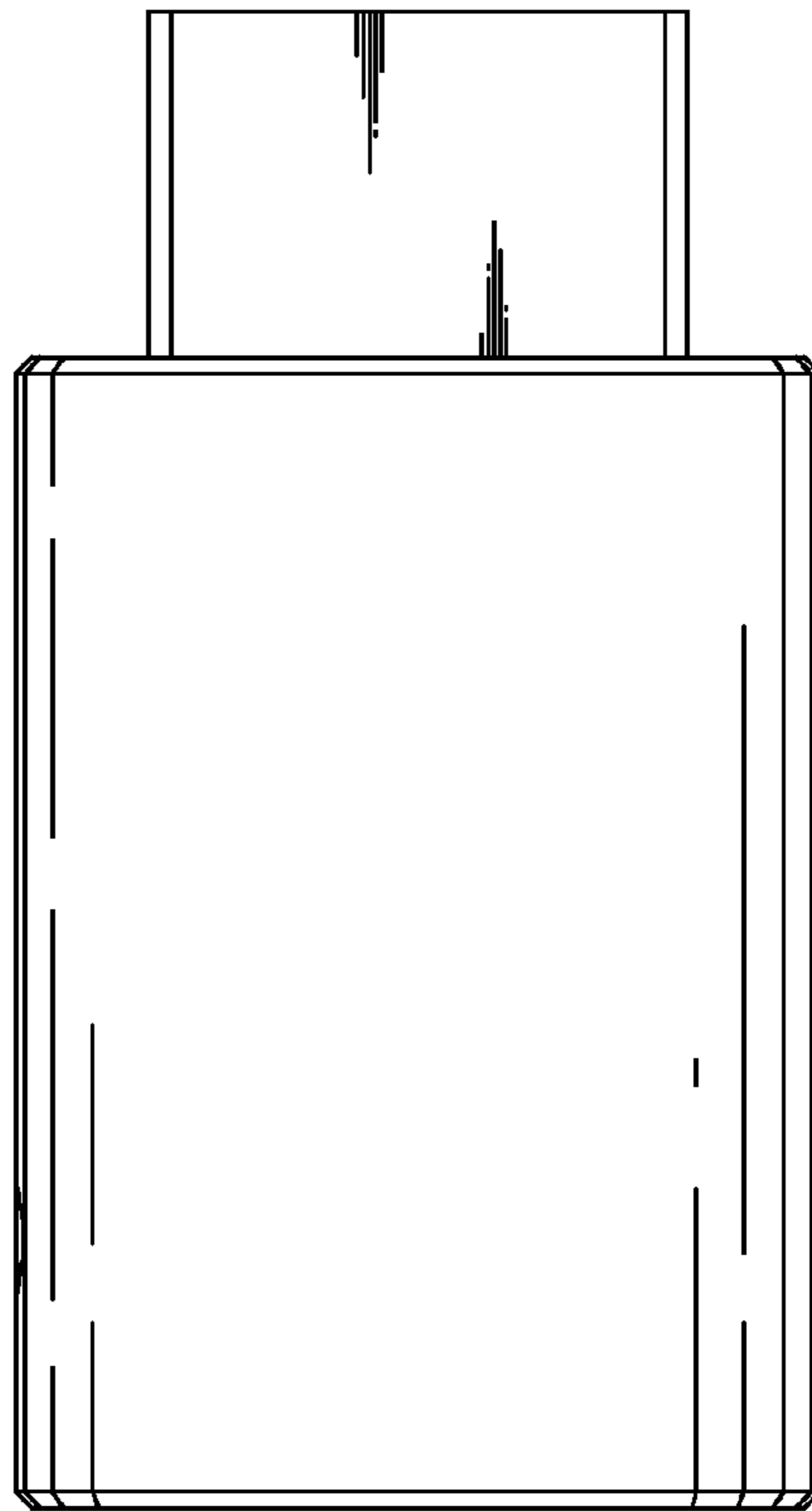

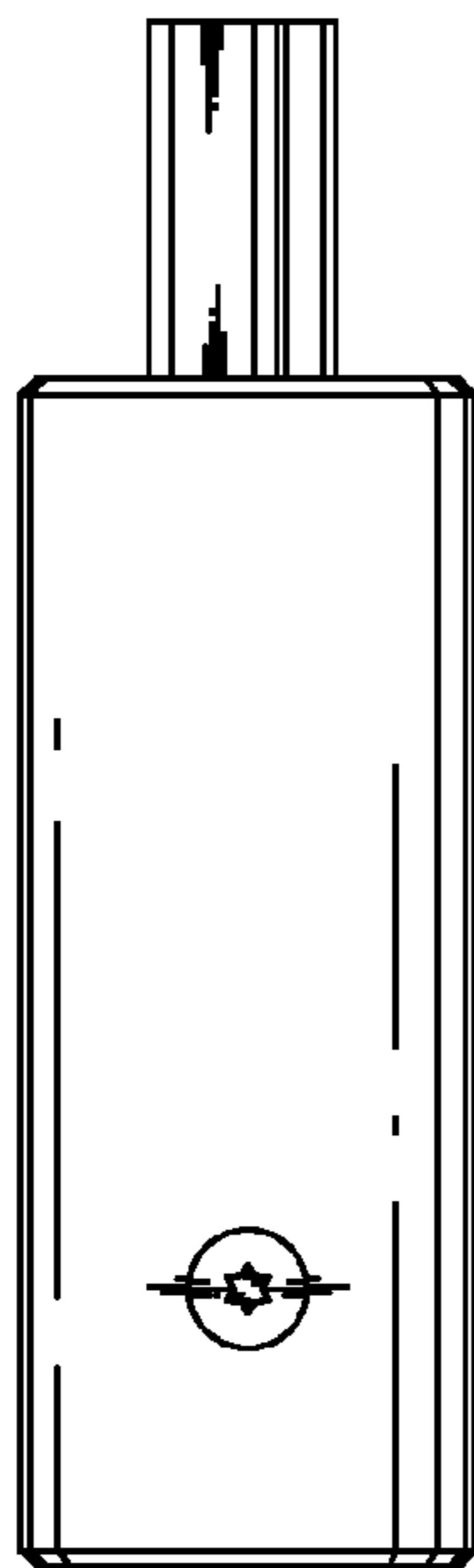

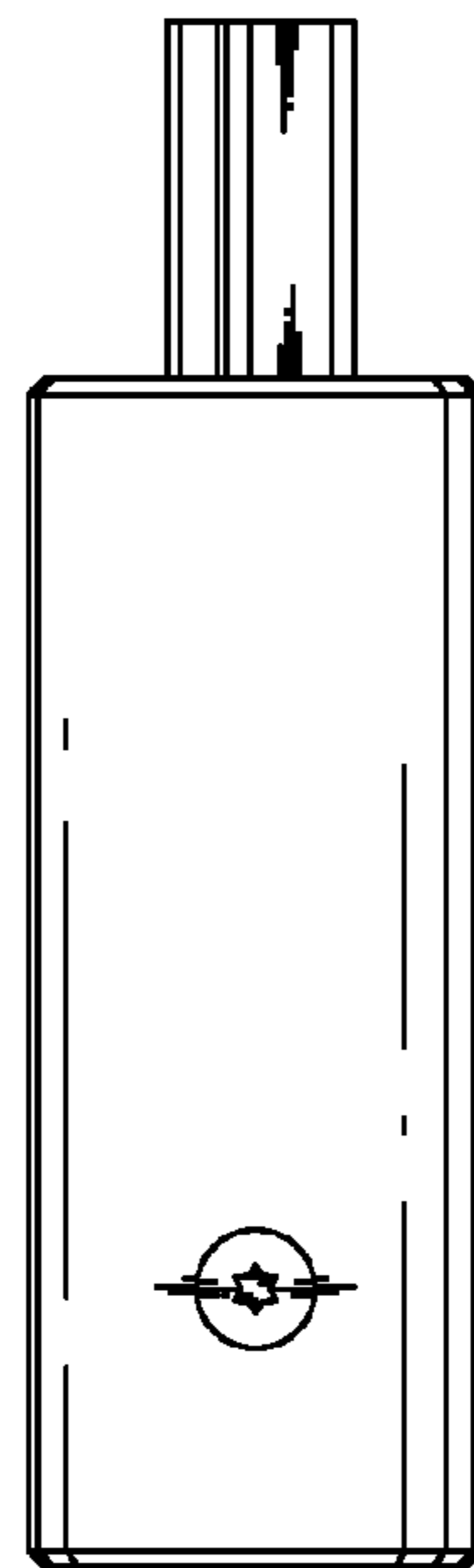

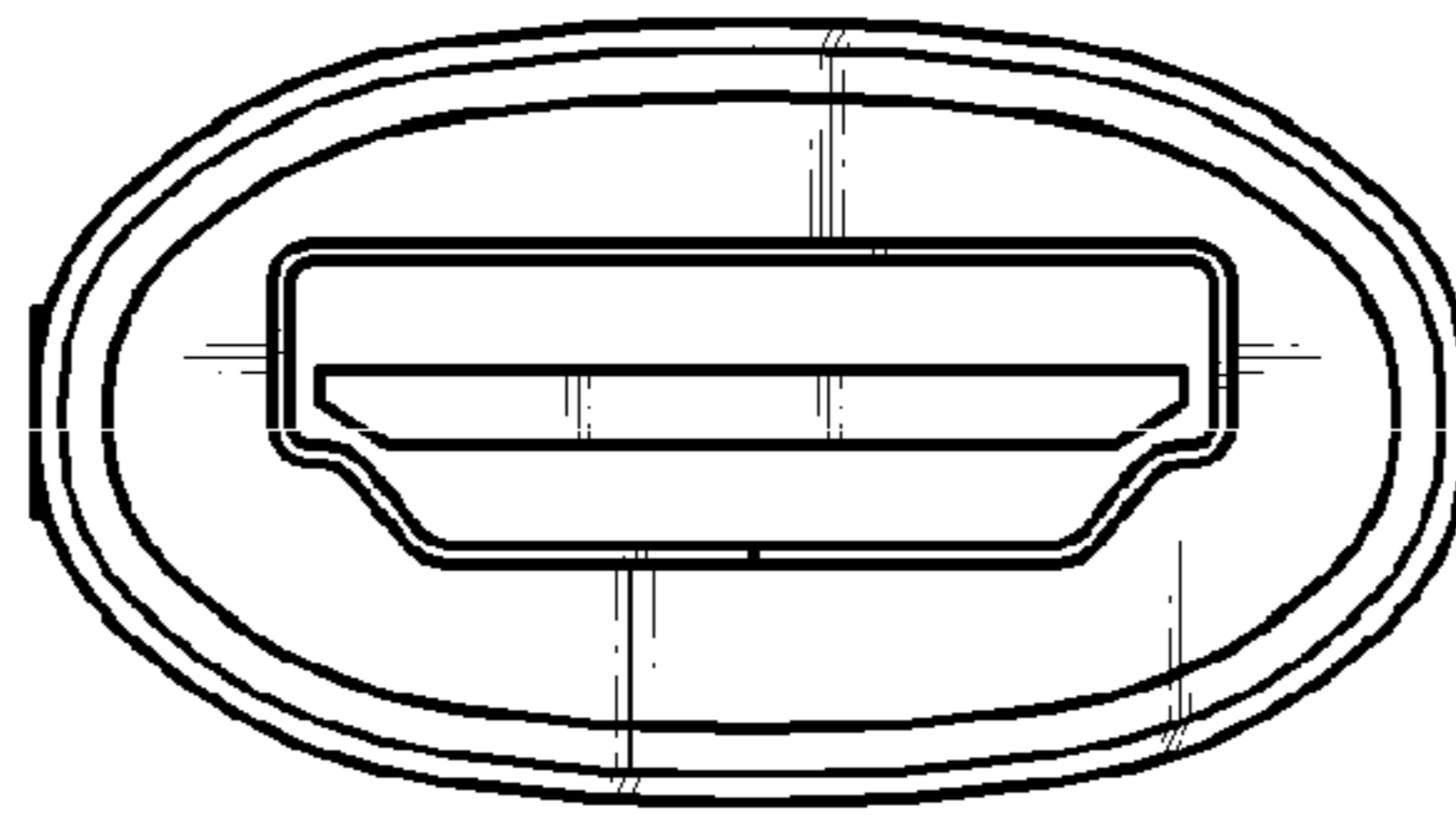

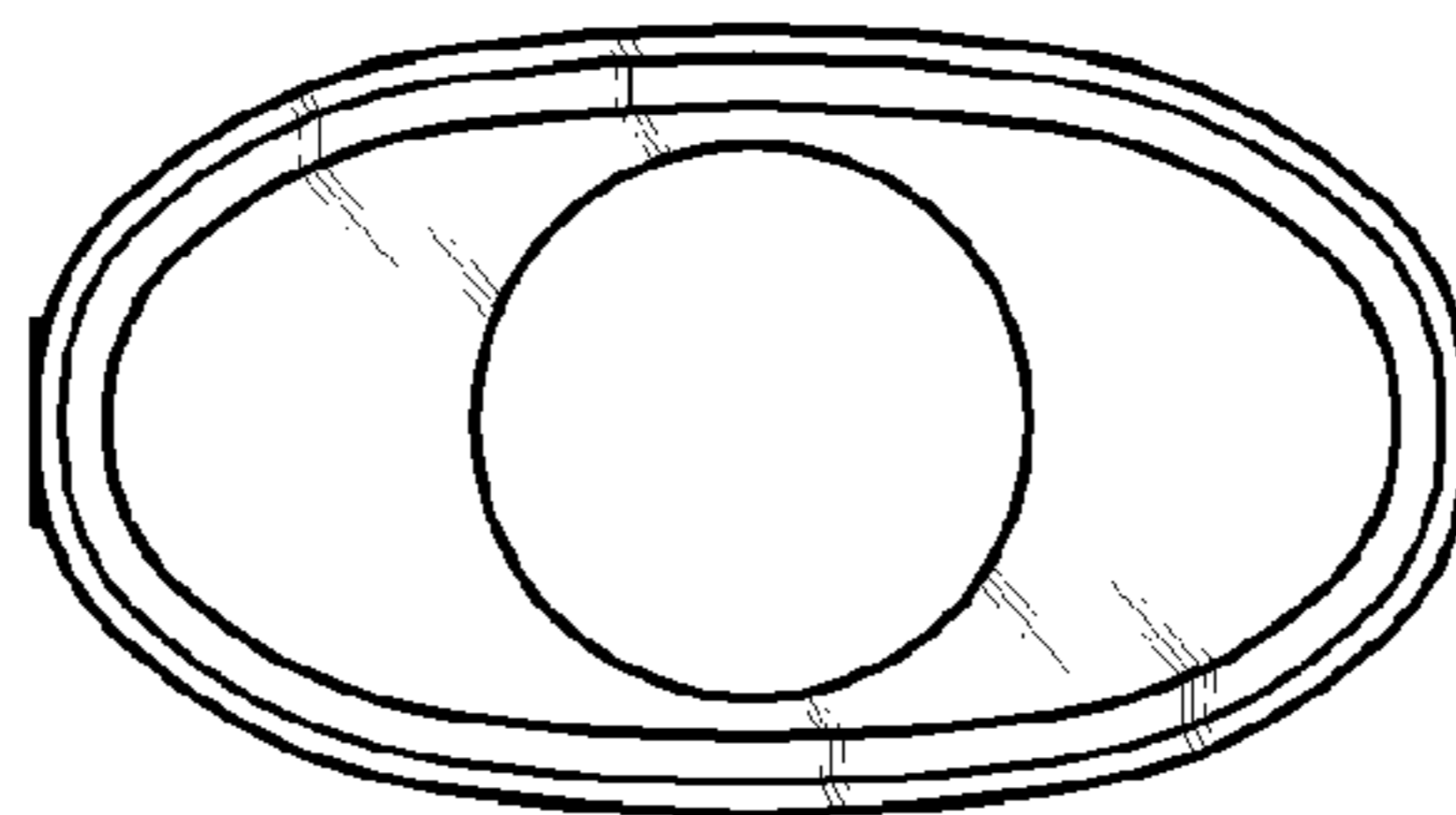

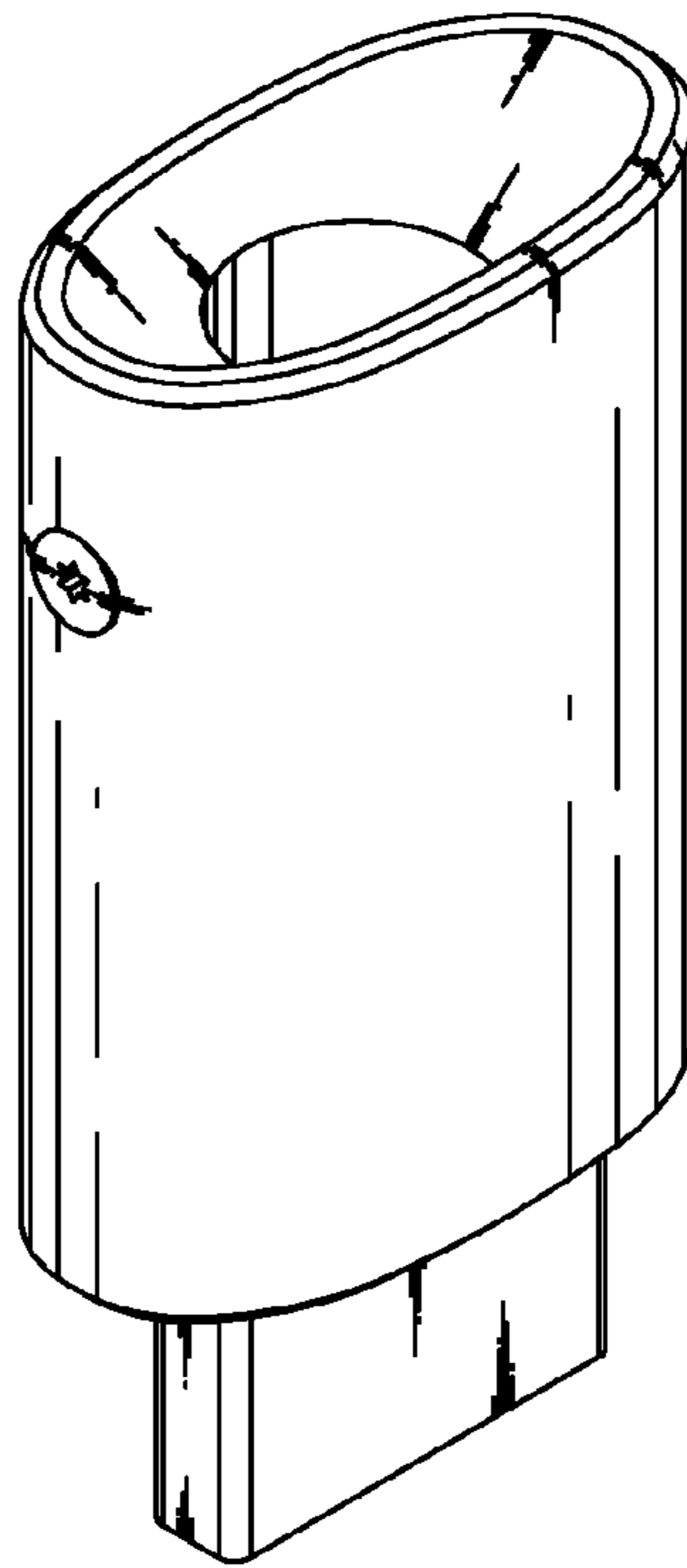
