DESCRIPTION

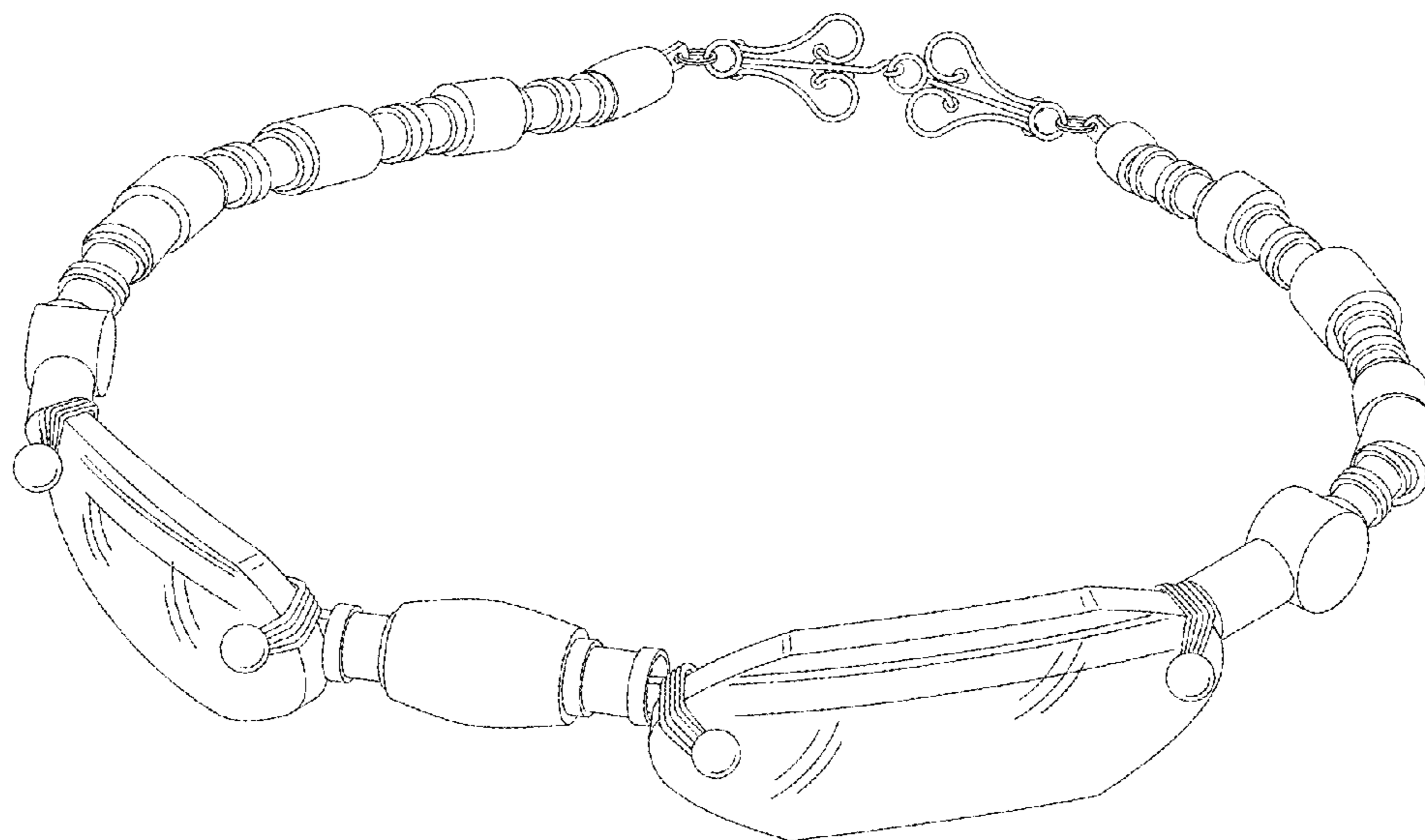
FIG. 1 is a perspective view of an eyeglasses headband and choker showing my new design;

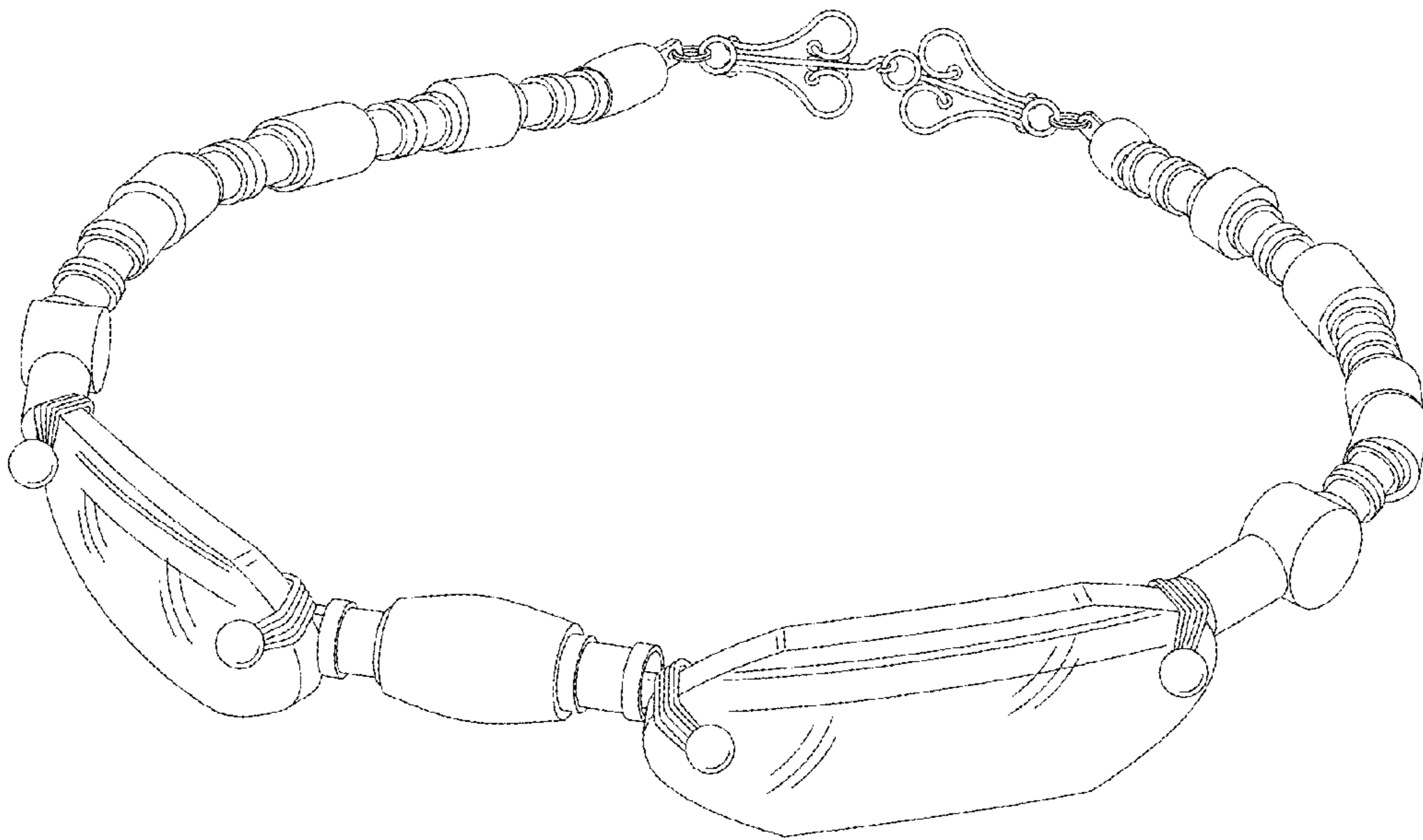

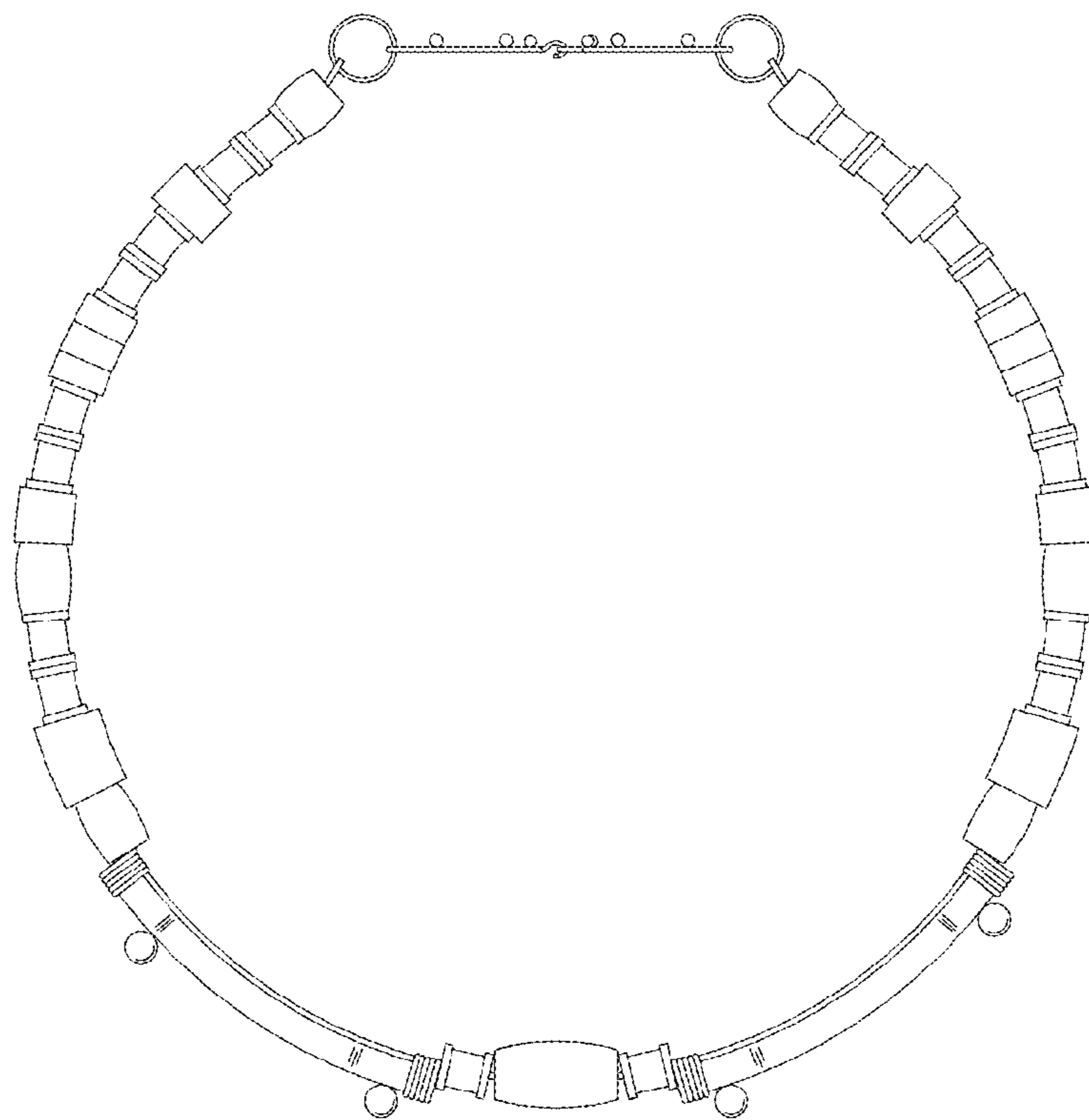

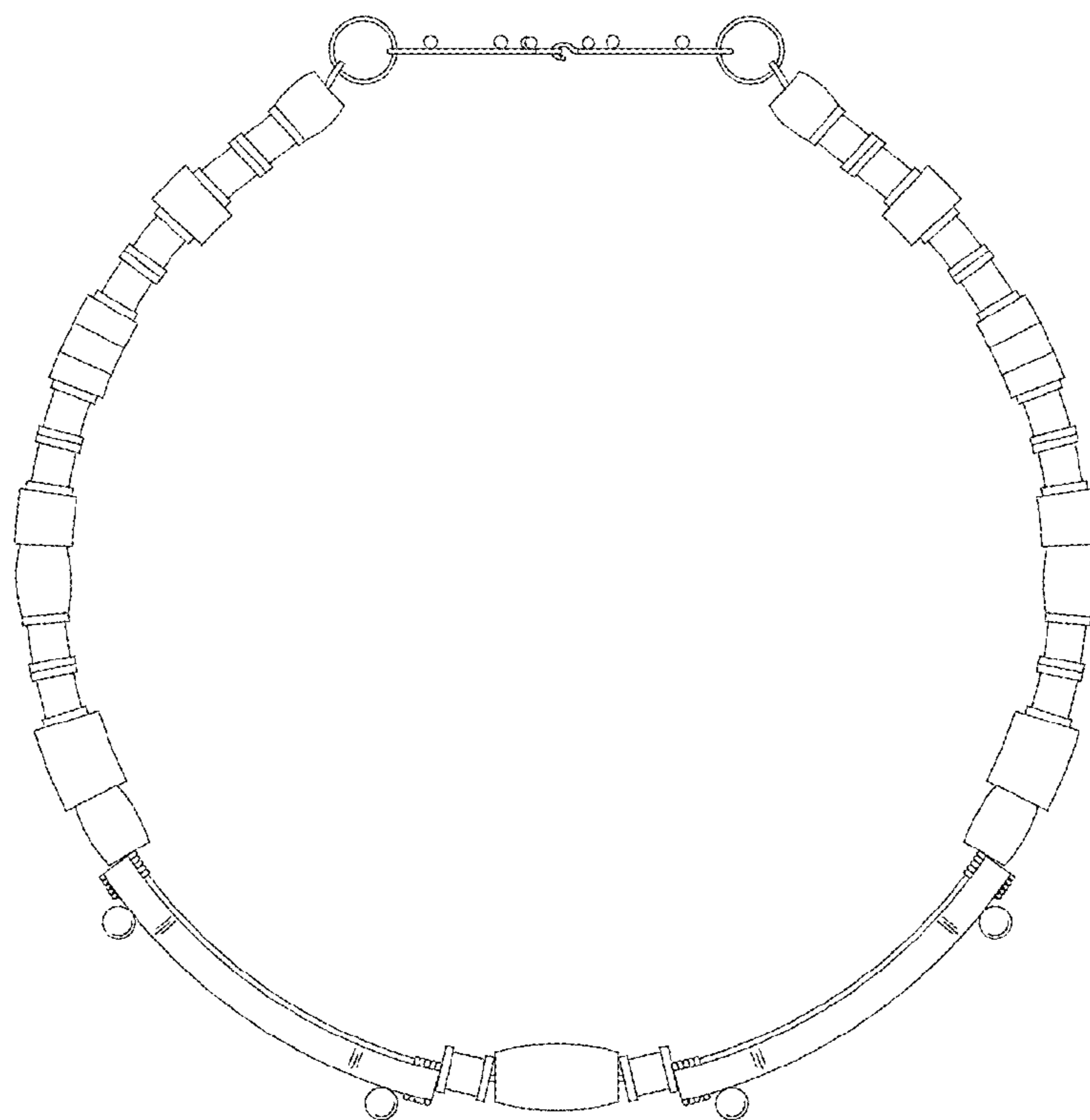

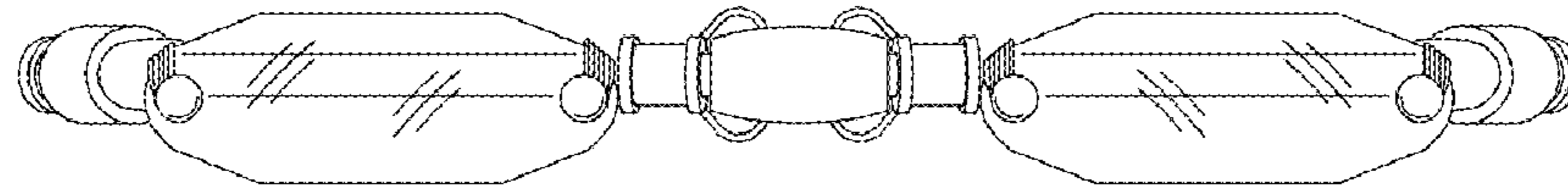

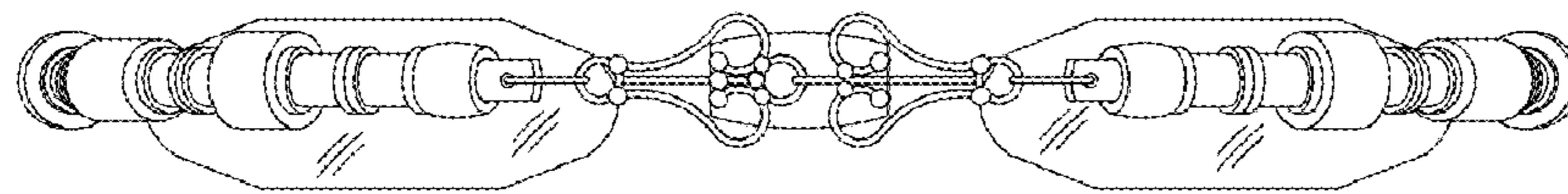

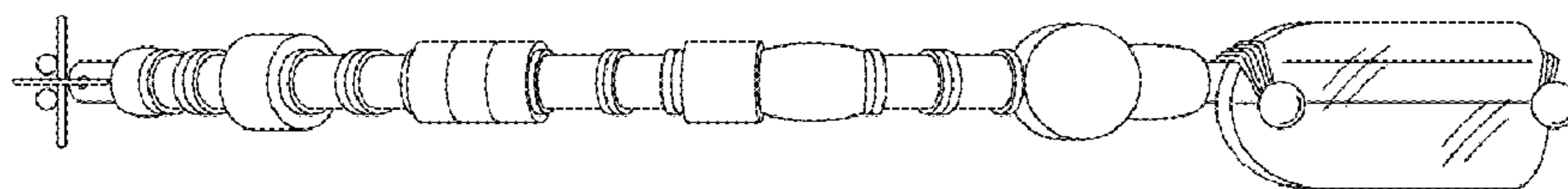

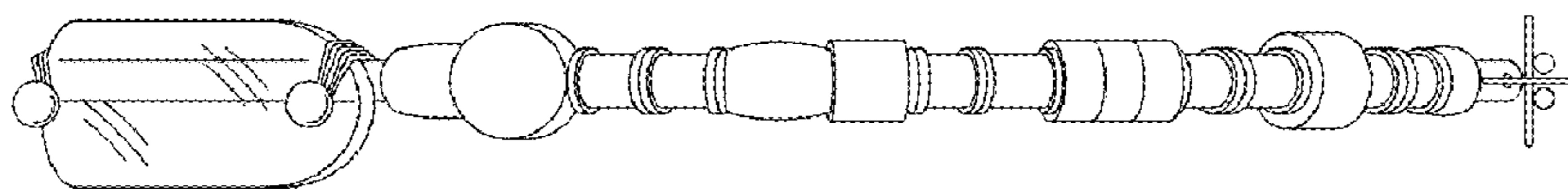
