(57) **CLAIM**

We claim the ornamental design for a roller stamp, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the roller stamp, showing our new design;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a right side view thereof, the left side being a mirror image thereof;

FIG. 5 is a front view of the roller stamp with an end cap removed to expose the roller for stamping;

FIG. 6 is a top view thereof with the end cap removed;

FIG. 7 is a bottom view thereof with the end cap removed

FIG. 8 is a right side view thereof with the end cap removed, the left side being a mirror image thereof;

FIG. 9 is a perspective view of the roller stamp of FIG. 1;

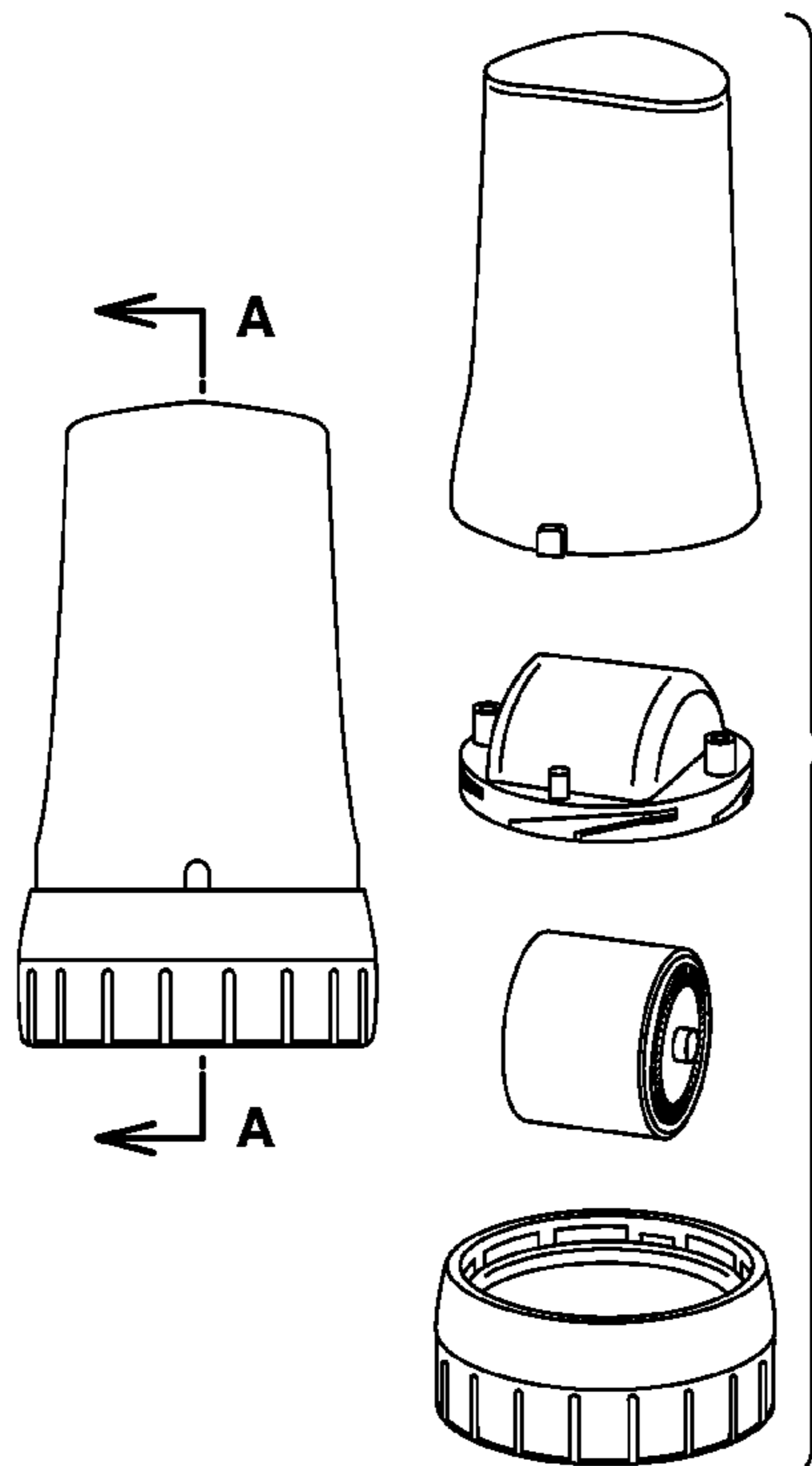
FIG. 10 is a perspective view of the roller stamp of FIG. 5, with the end cap removed;

FIG. 11 is a cross sectional view taken along line A-A of FIG. 1;

FIG. 12 is a cross sectional view taken along the line B-B of FIG. 4; and,

FIG. 13 is an exploded view of the roller stamp of FIG. 1.

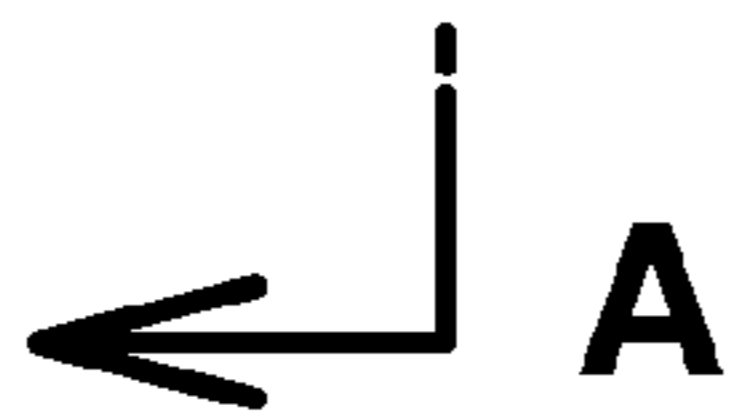
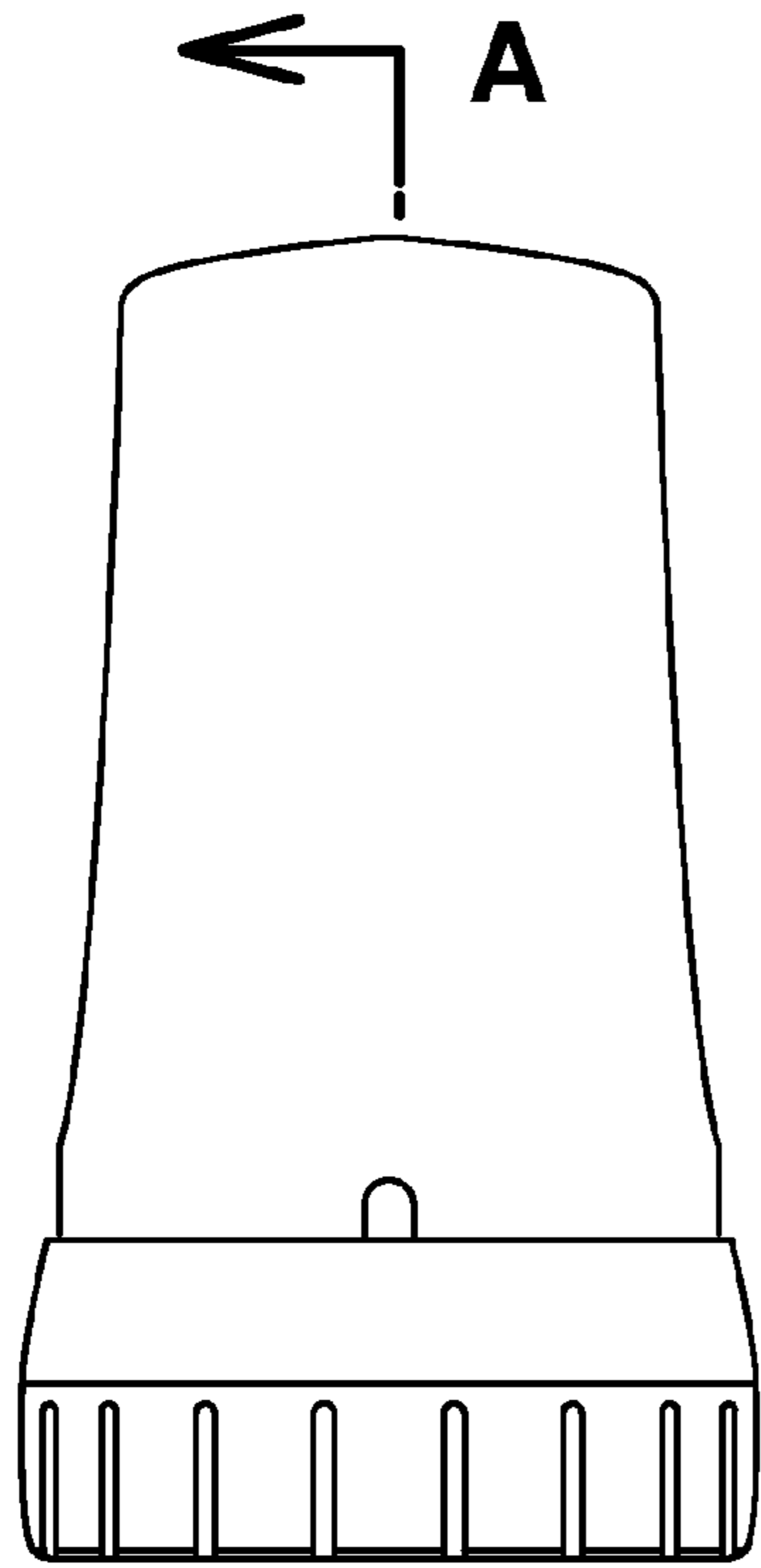

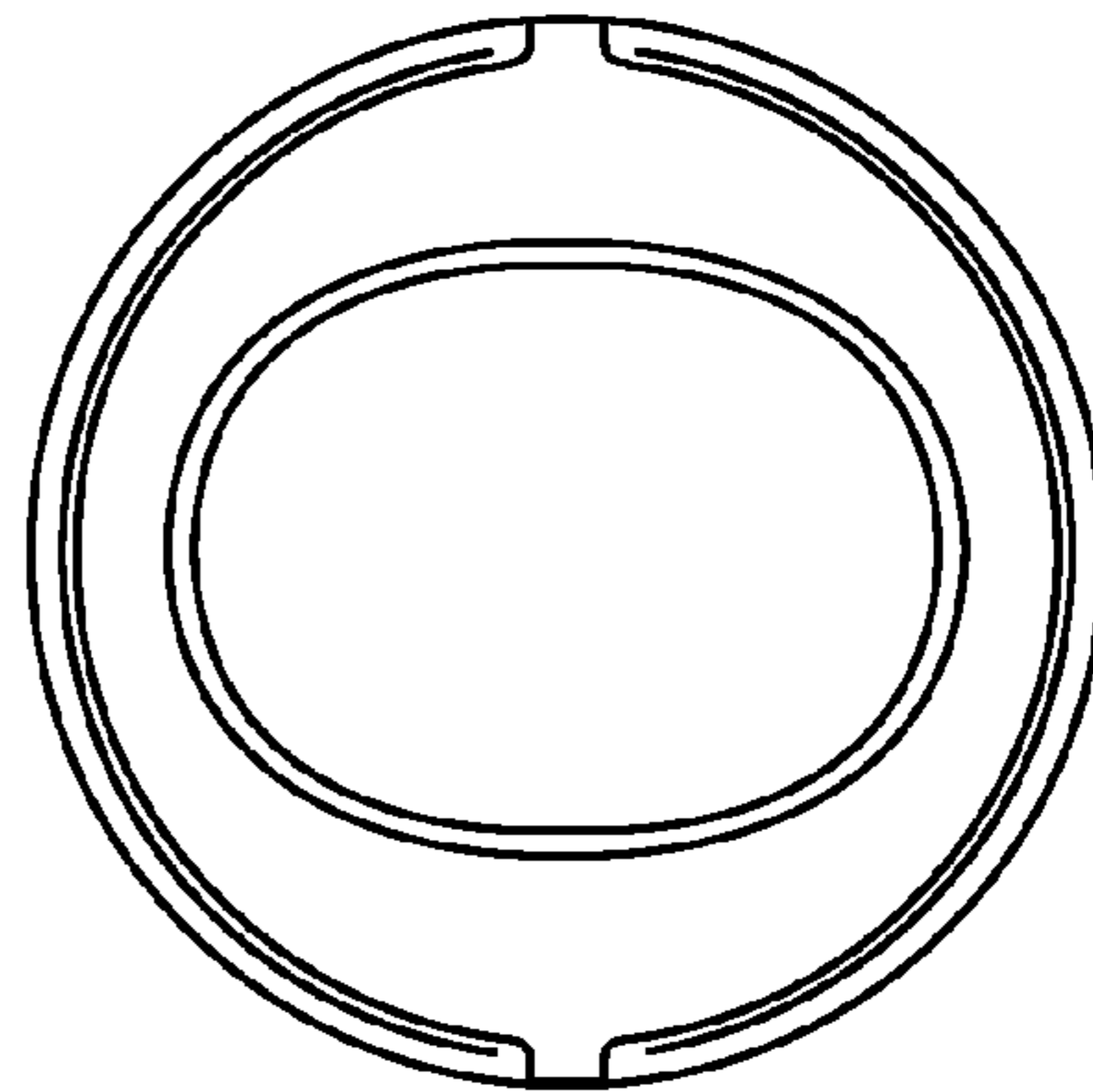

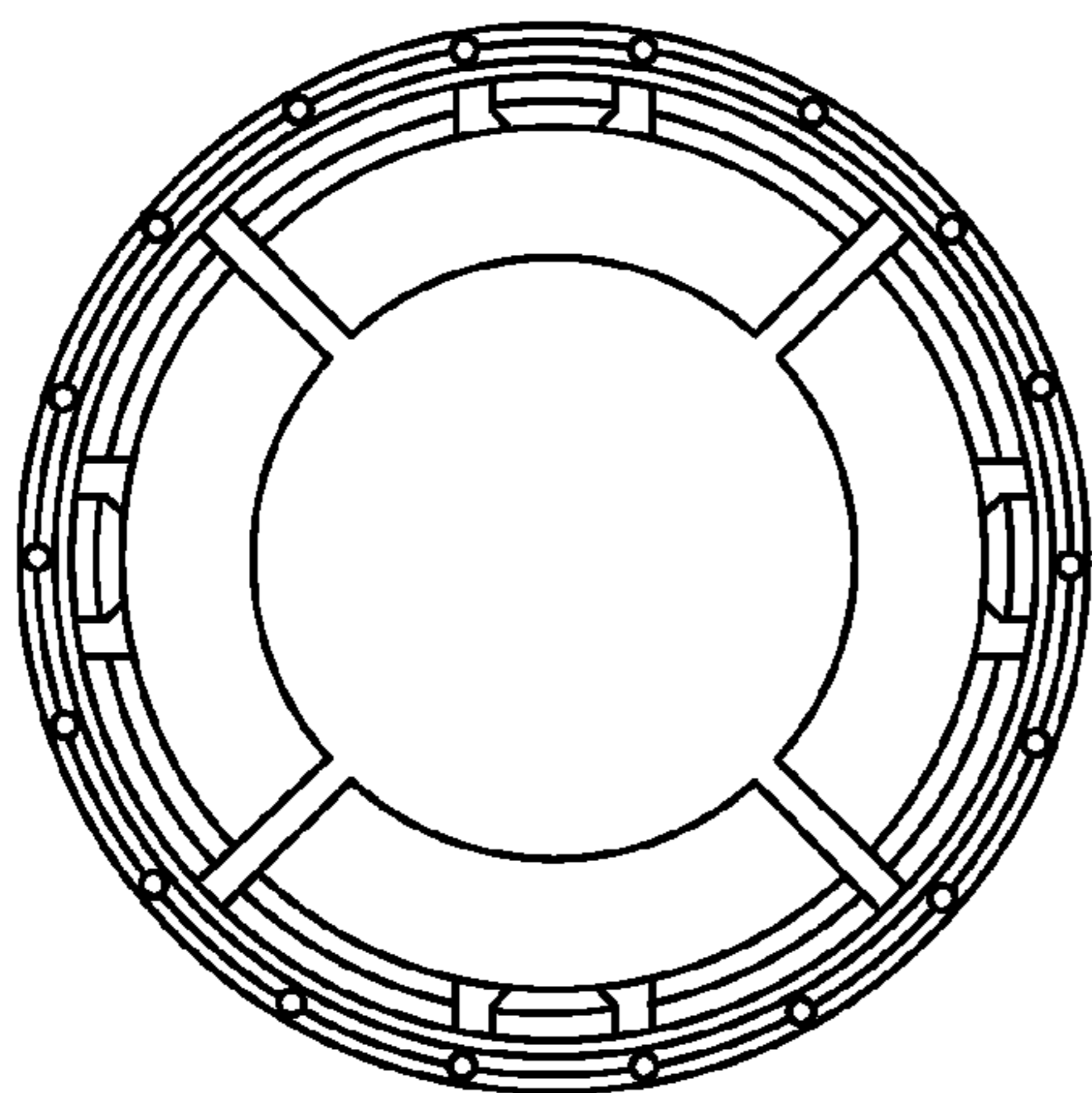

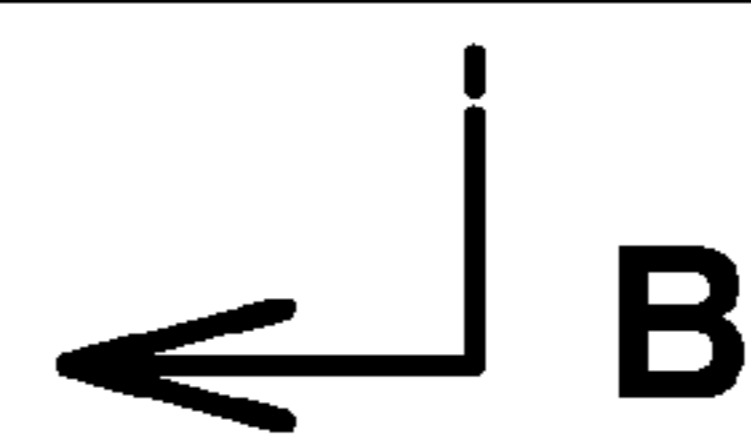
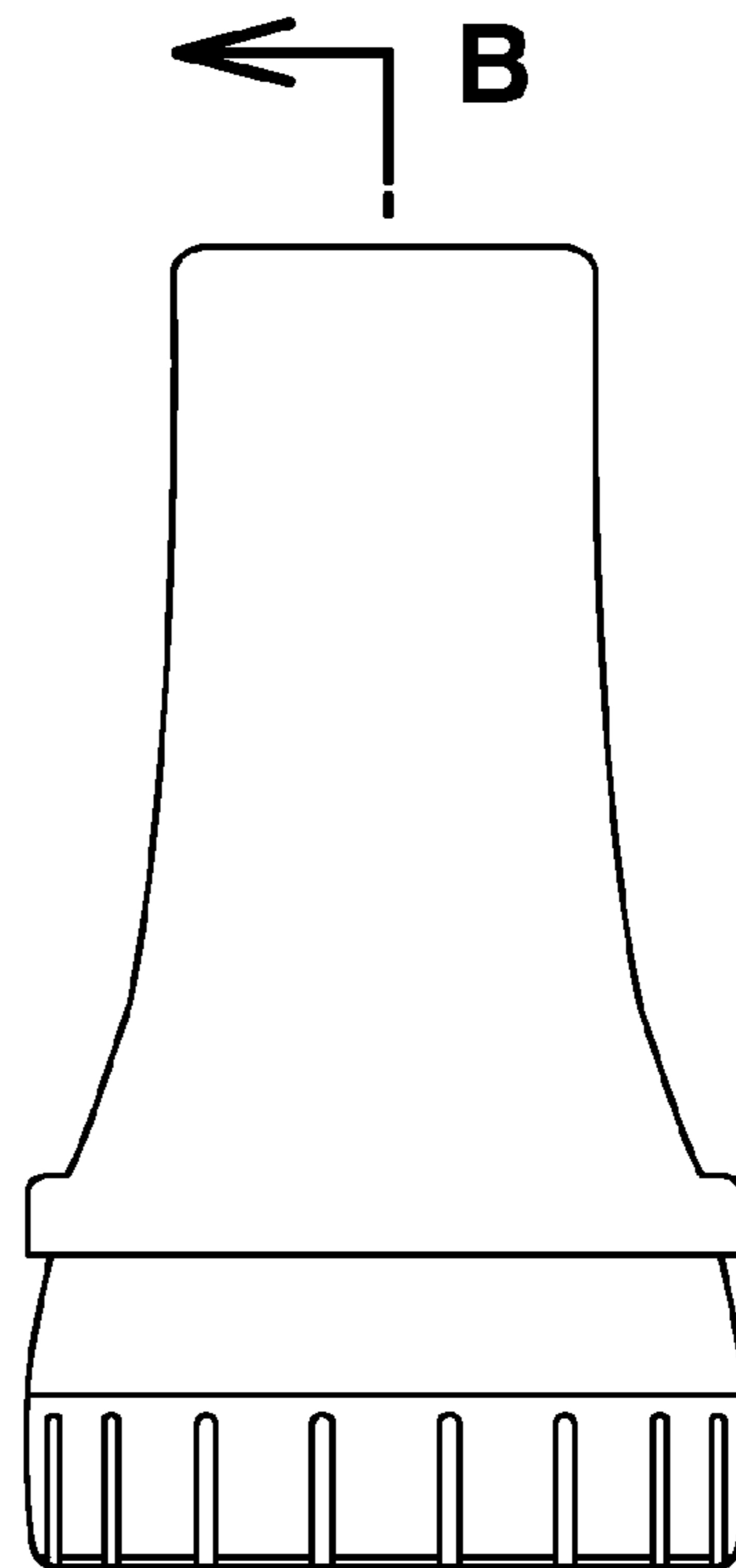

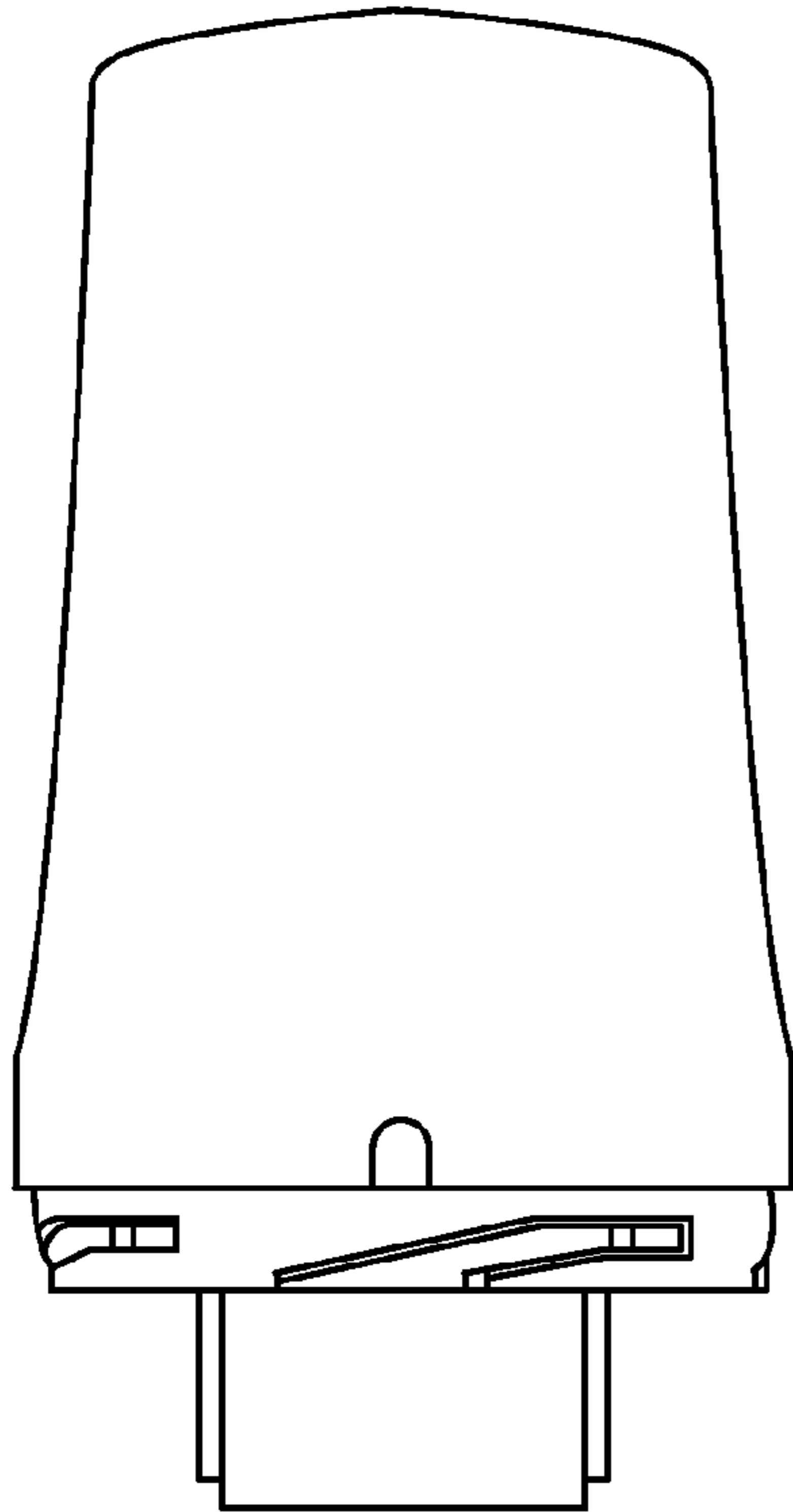

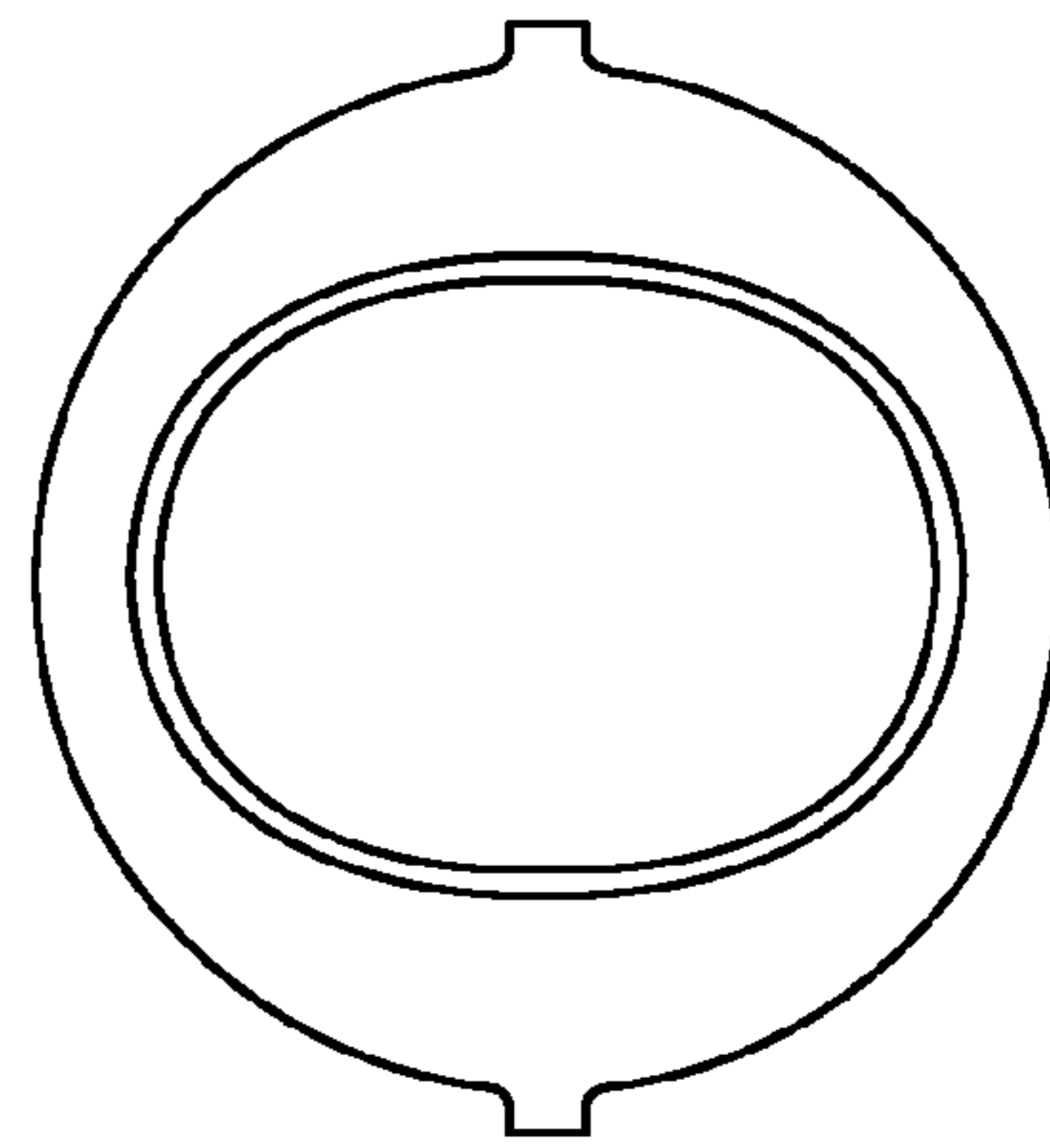

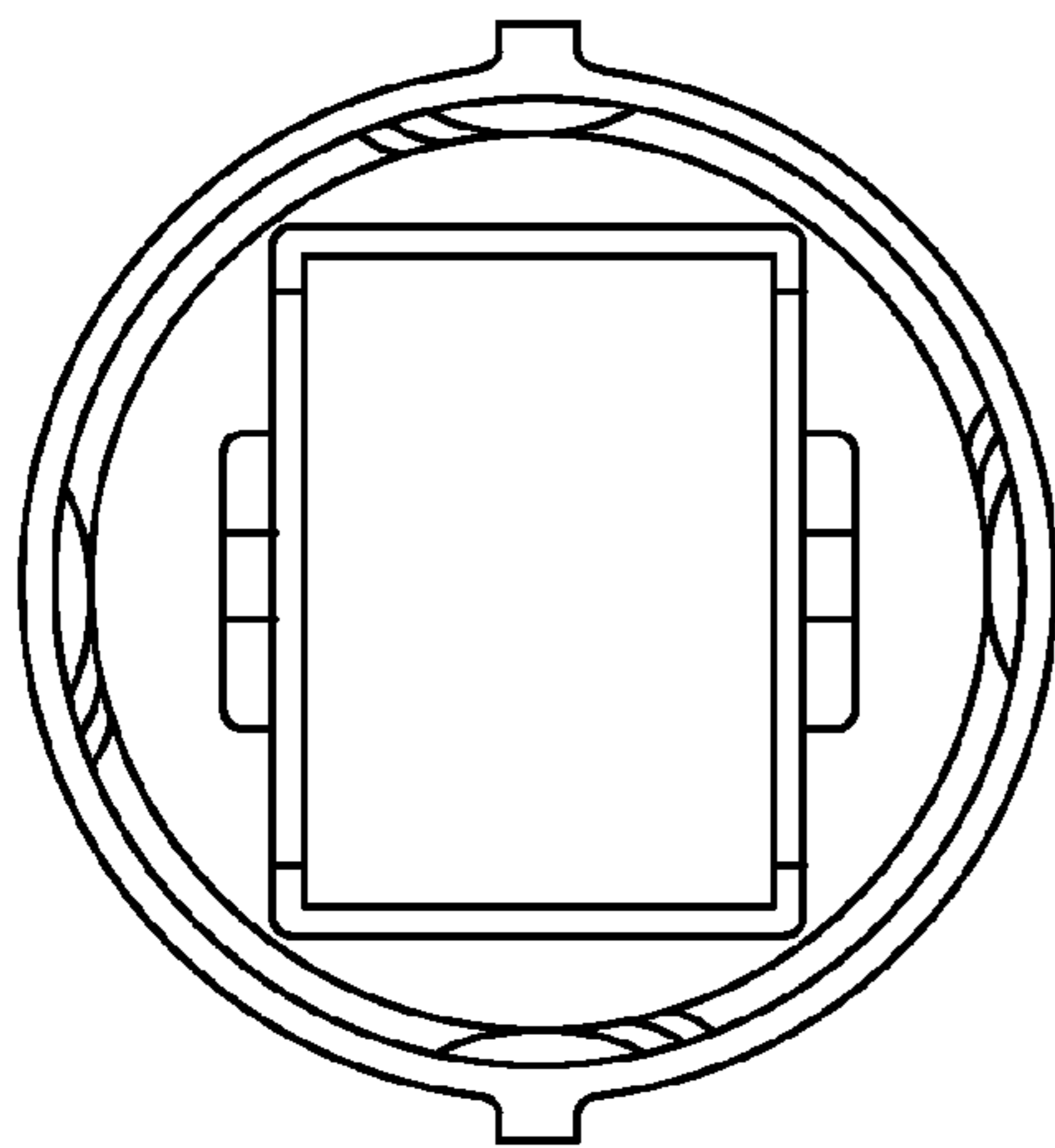

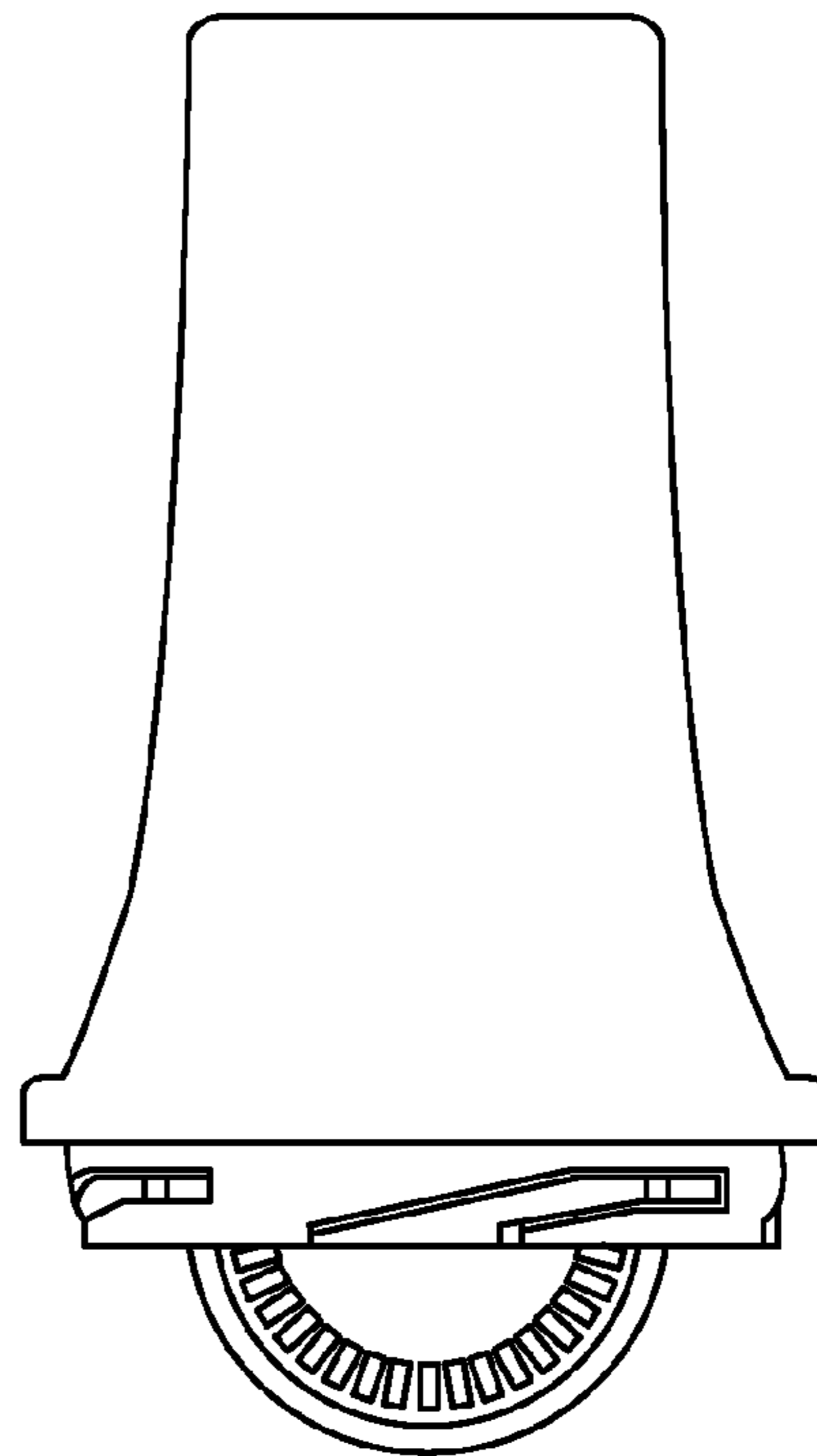

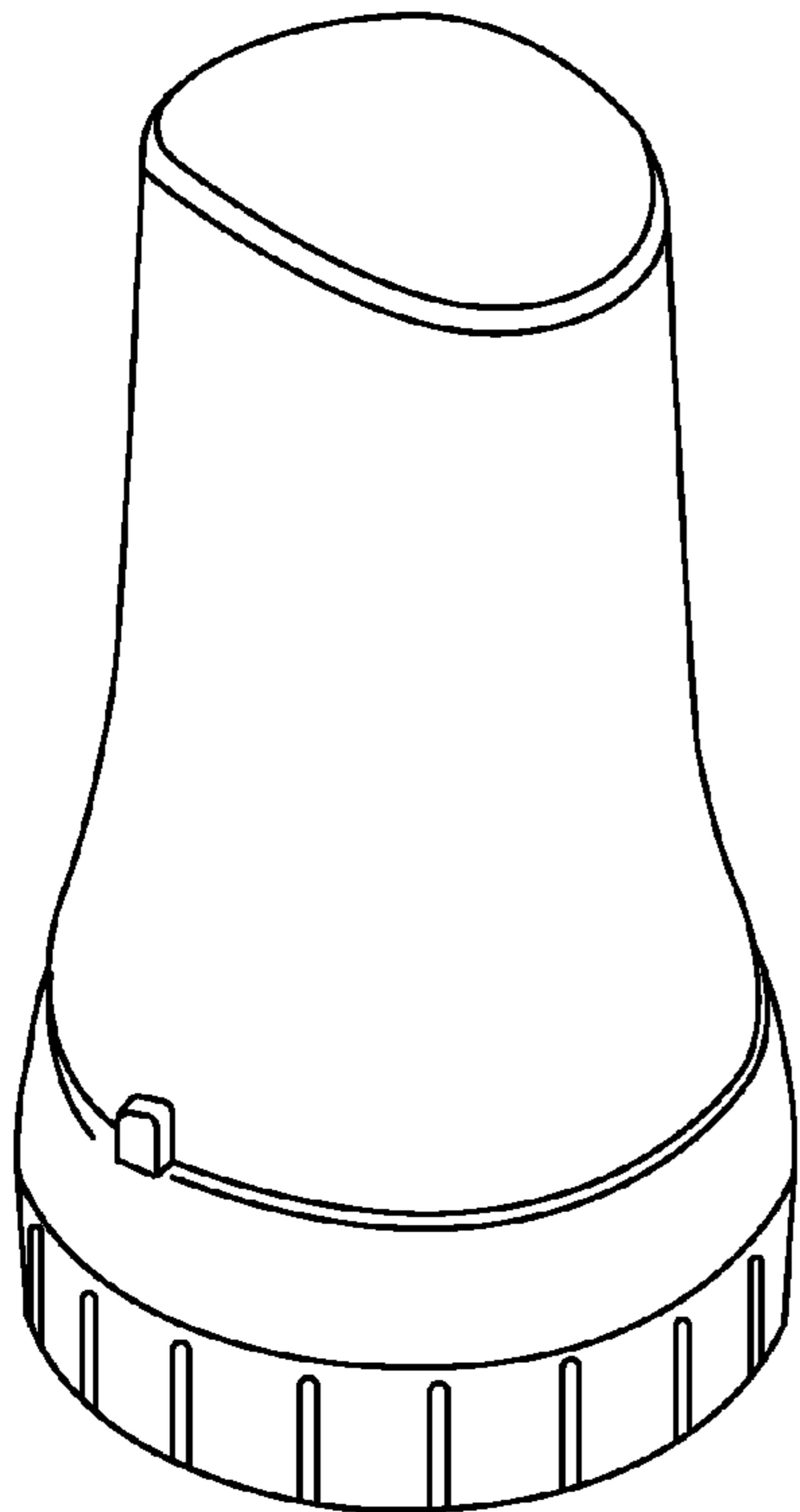

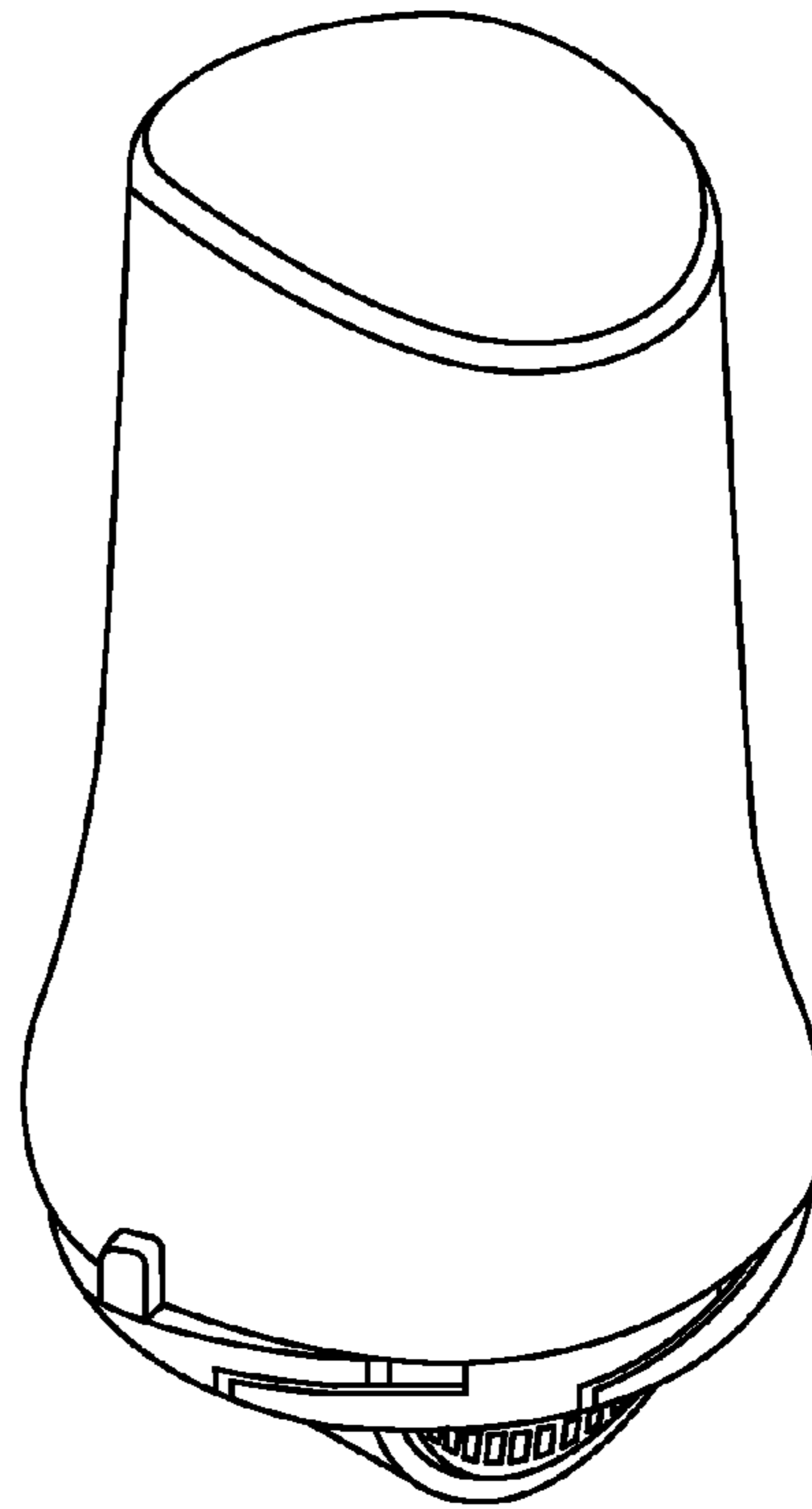

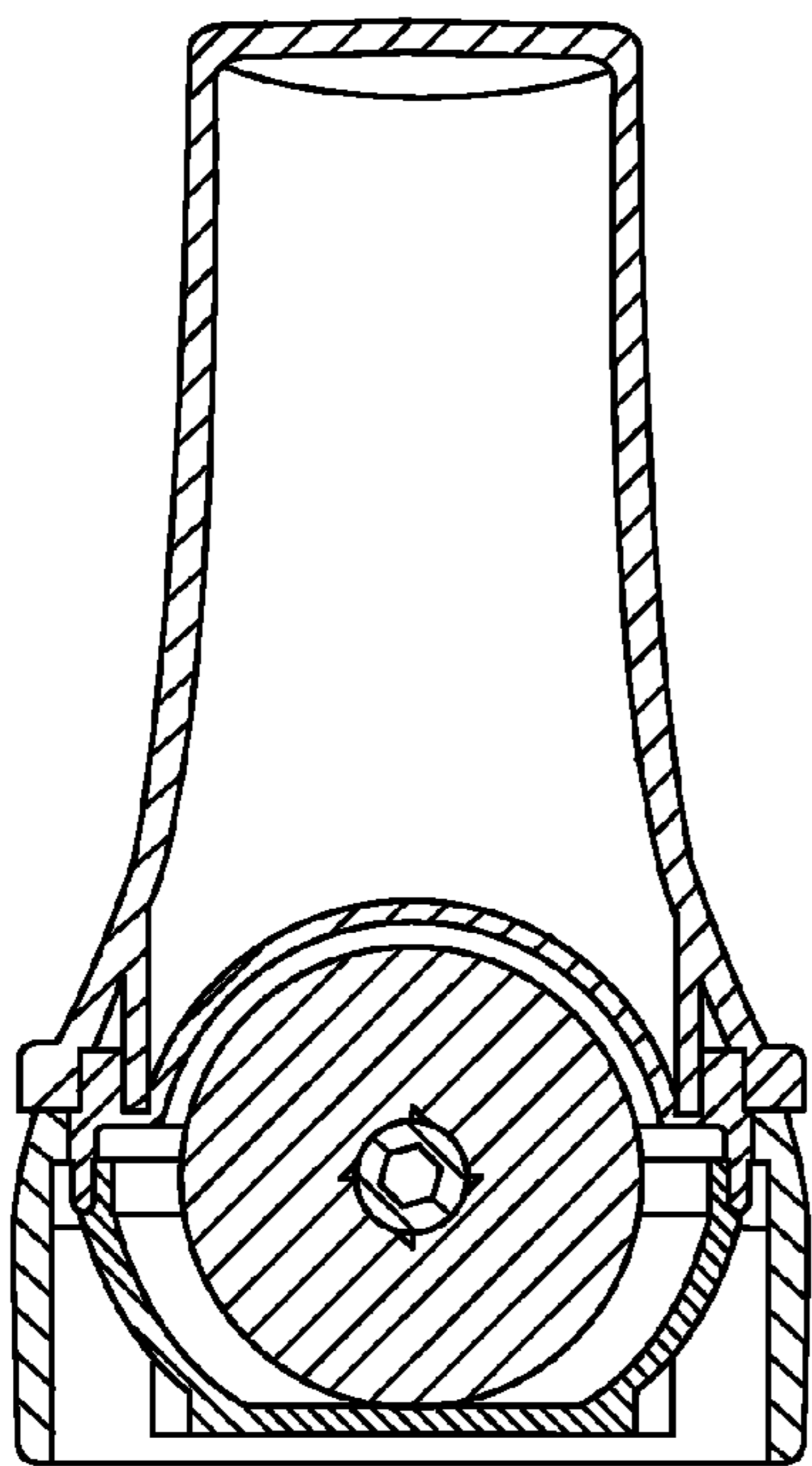

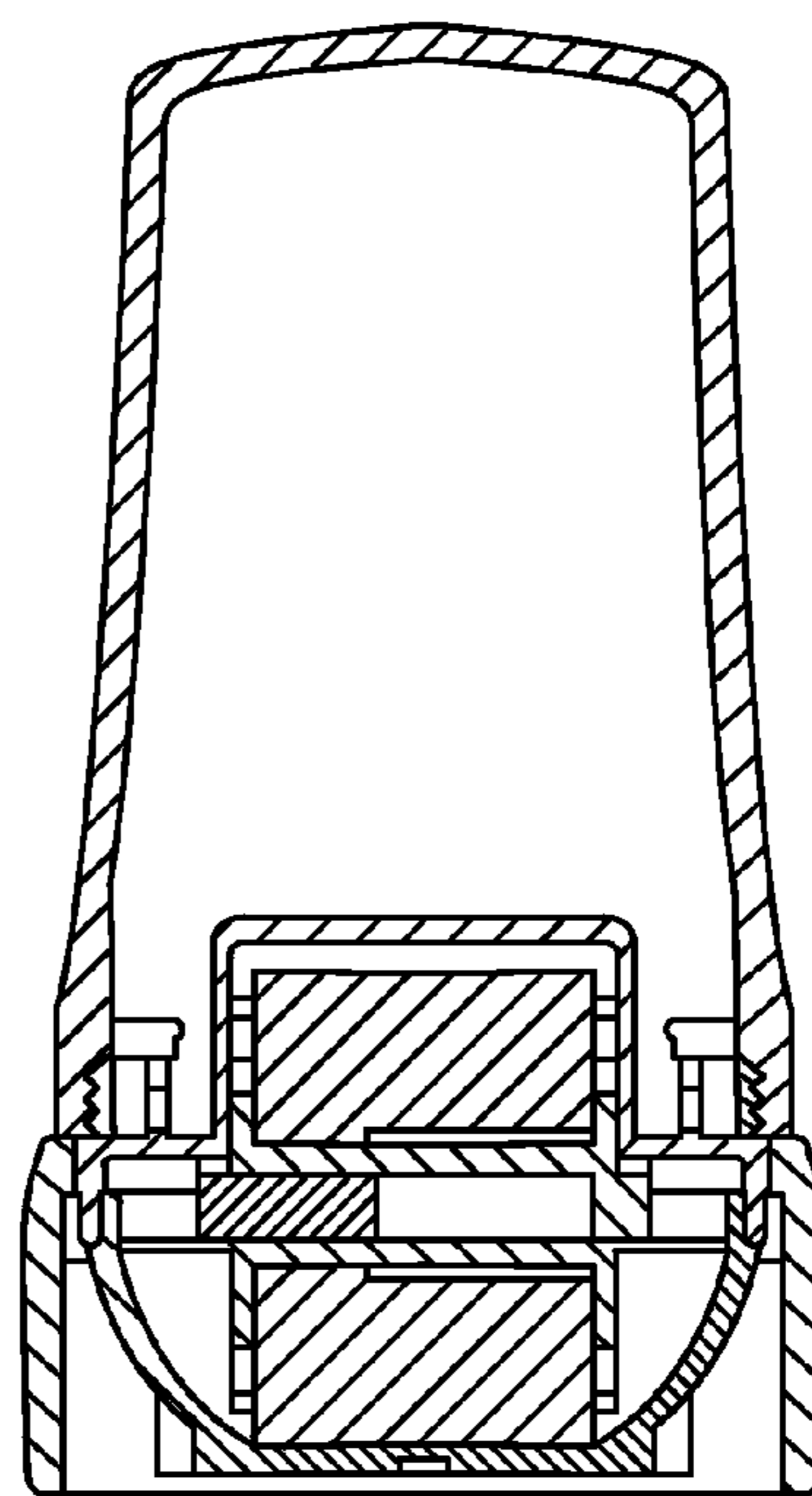

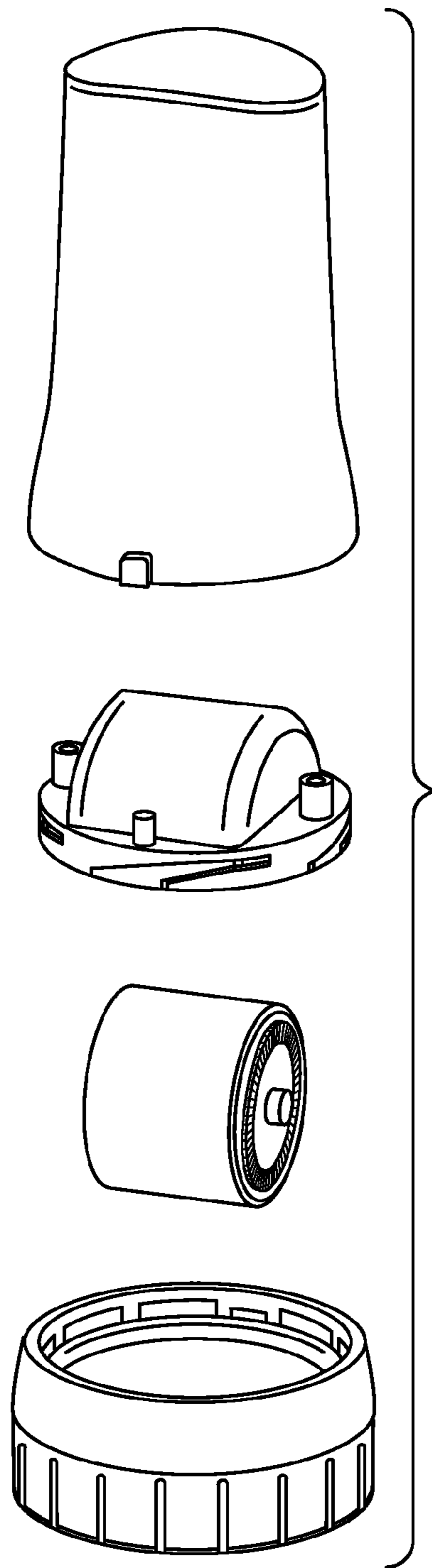
