The ornamental design for a shredder, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a shredder embodying a  
first aspect of the design;

FIG. 2 is a front elevational view of the shredder of FIG. 1;

FIG. 3 is a rear elevational view of the shredder of FIG. 1;

FIG. 4 is a right profile view of the shredder of FIG. 1;

FIG. 5 is a left profile view of the shredder of FIG. 1;

FIG. 7 is a bottom plan view of the shredder of FIG. 1;

FIG. 8 is a bottom perspective view of the shredder of FIG. 1;

FIG. 9 is a top perspective view of a shredder embodying a

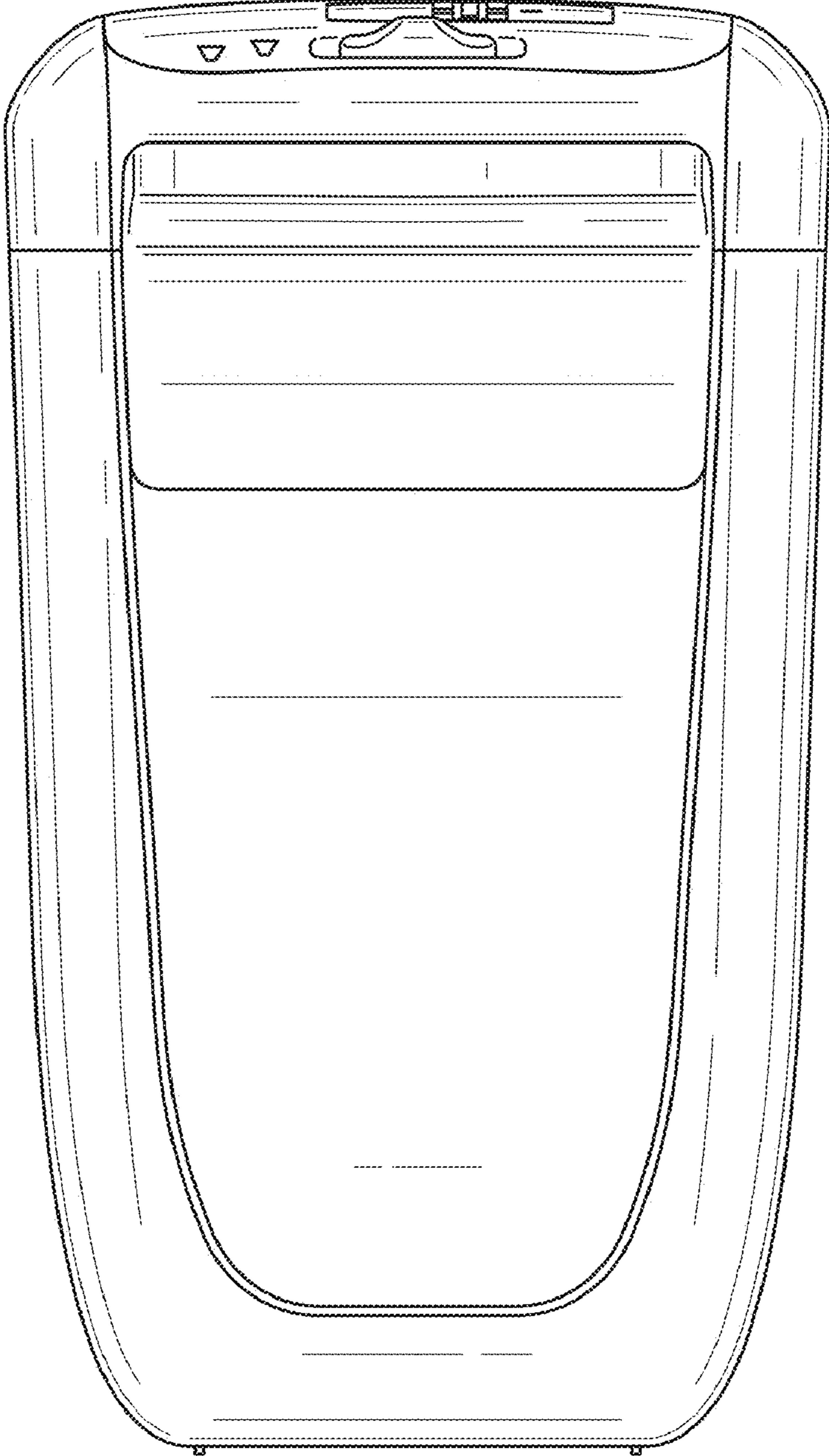

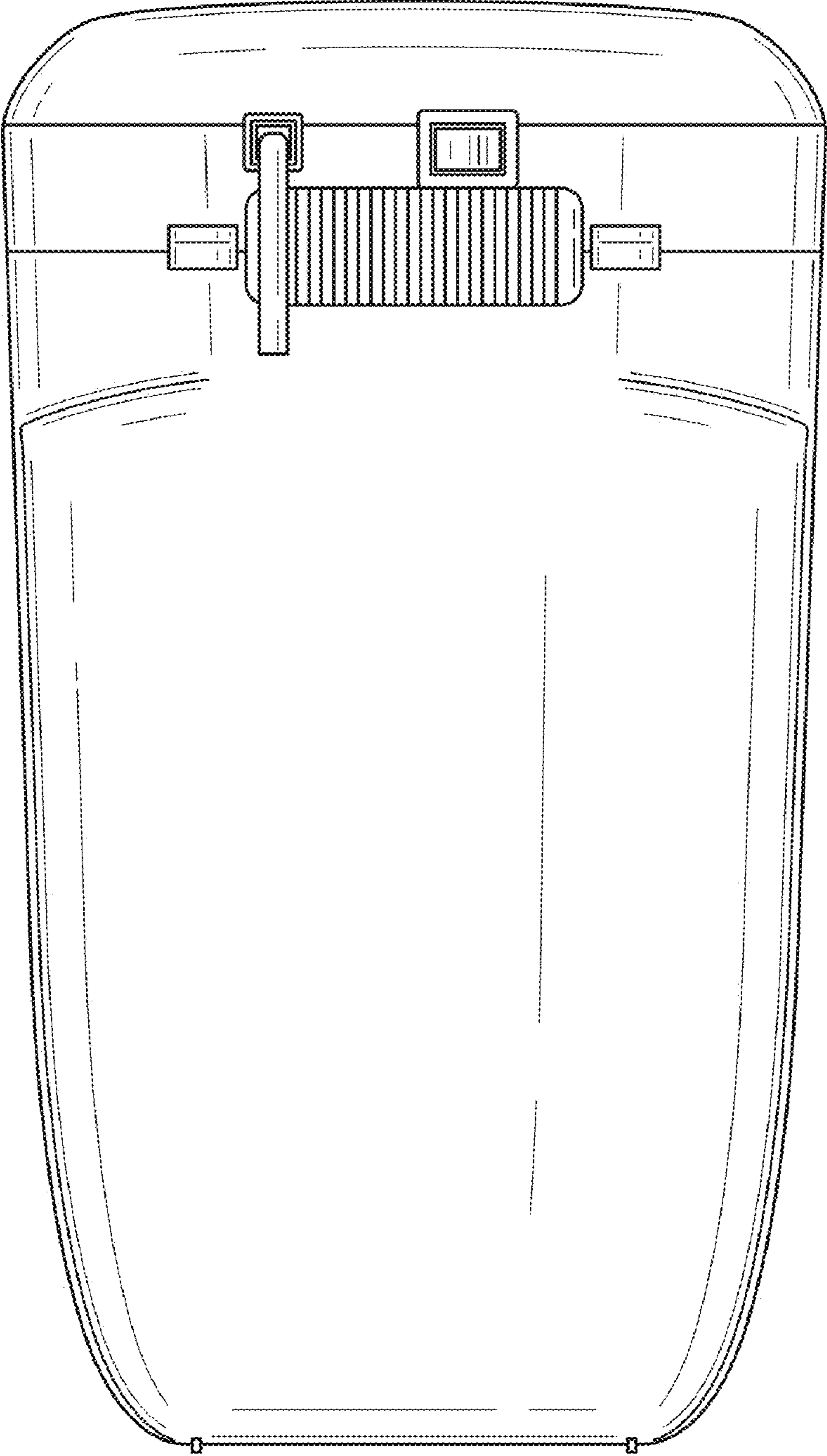

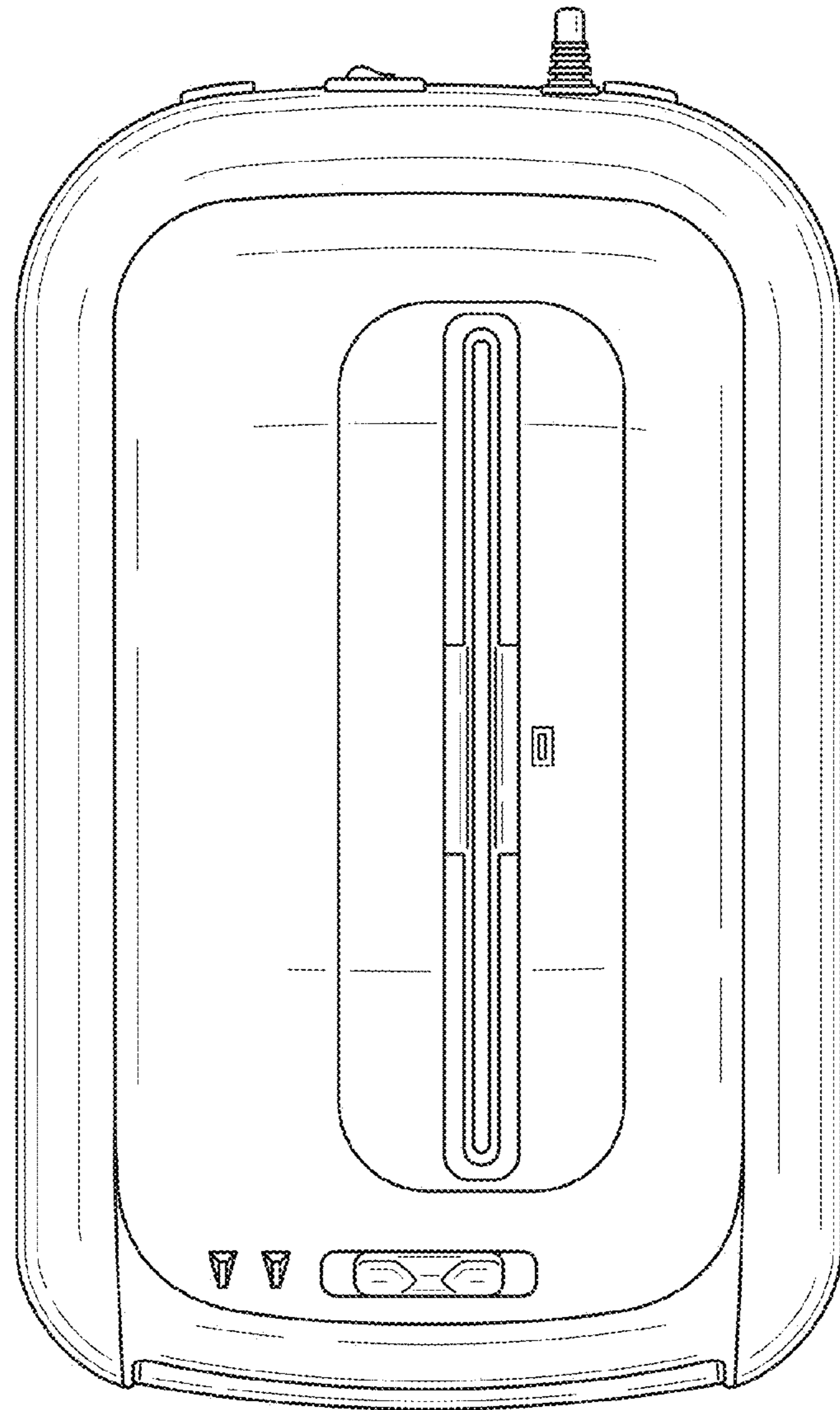

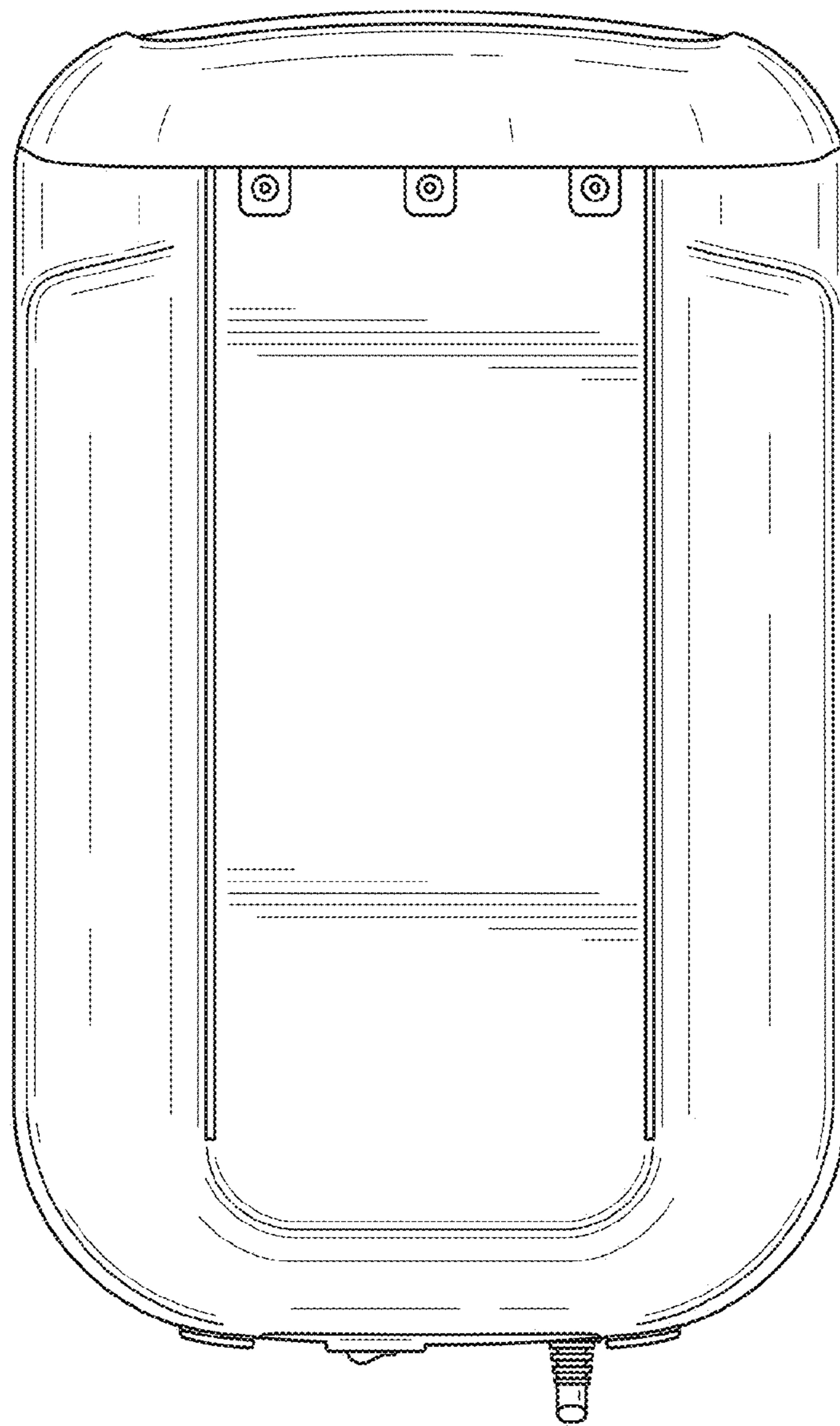

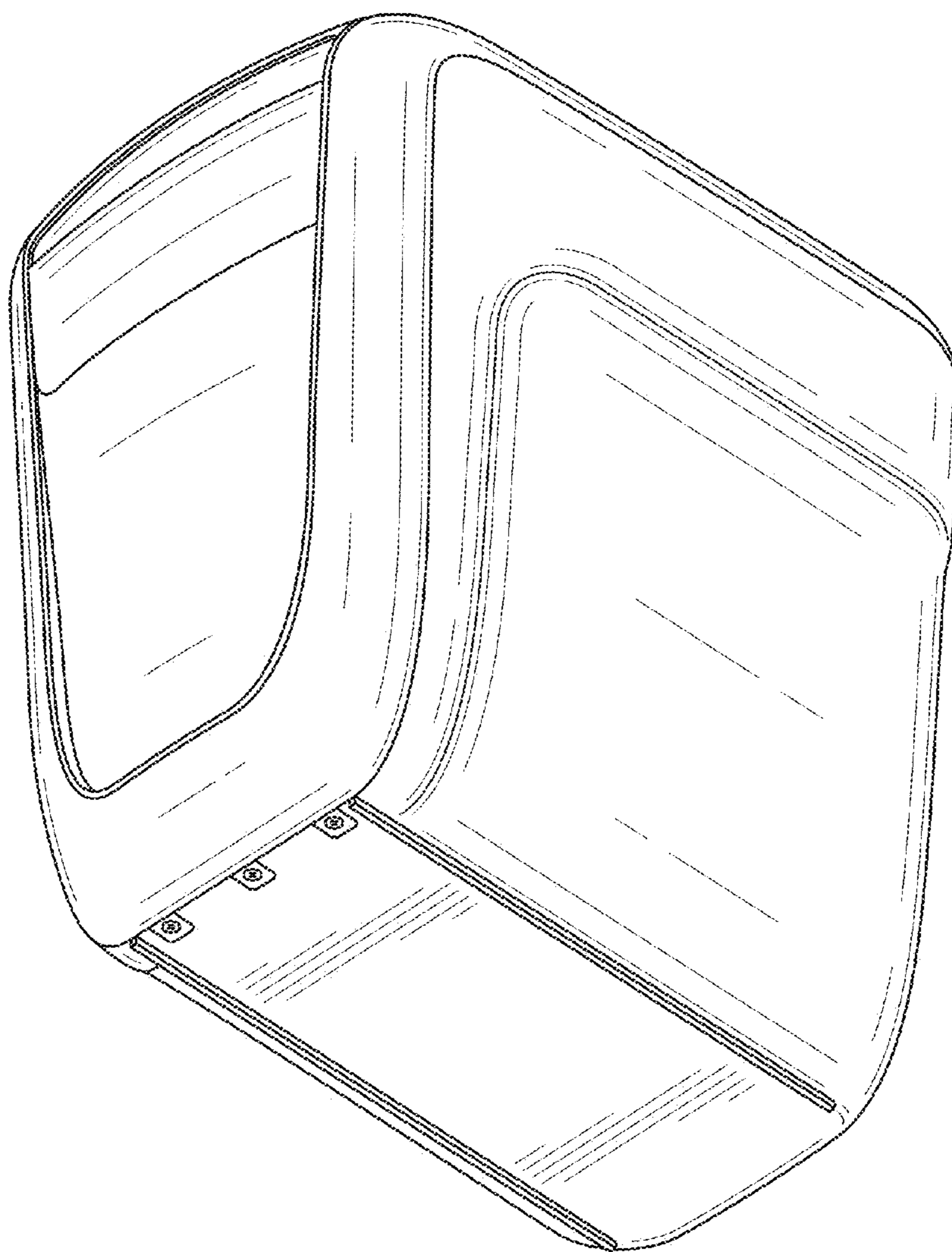

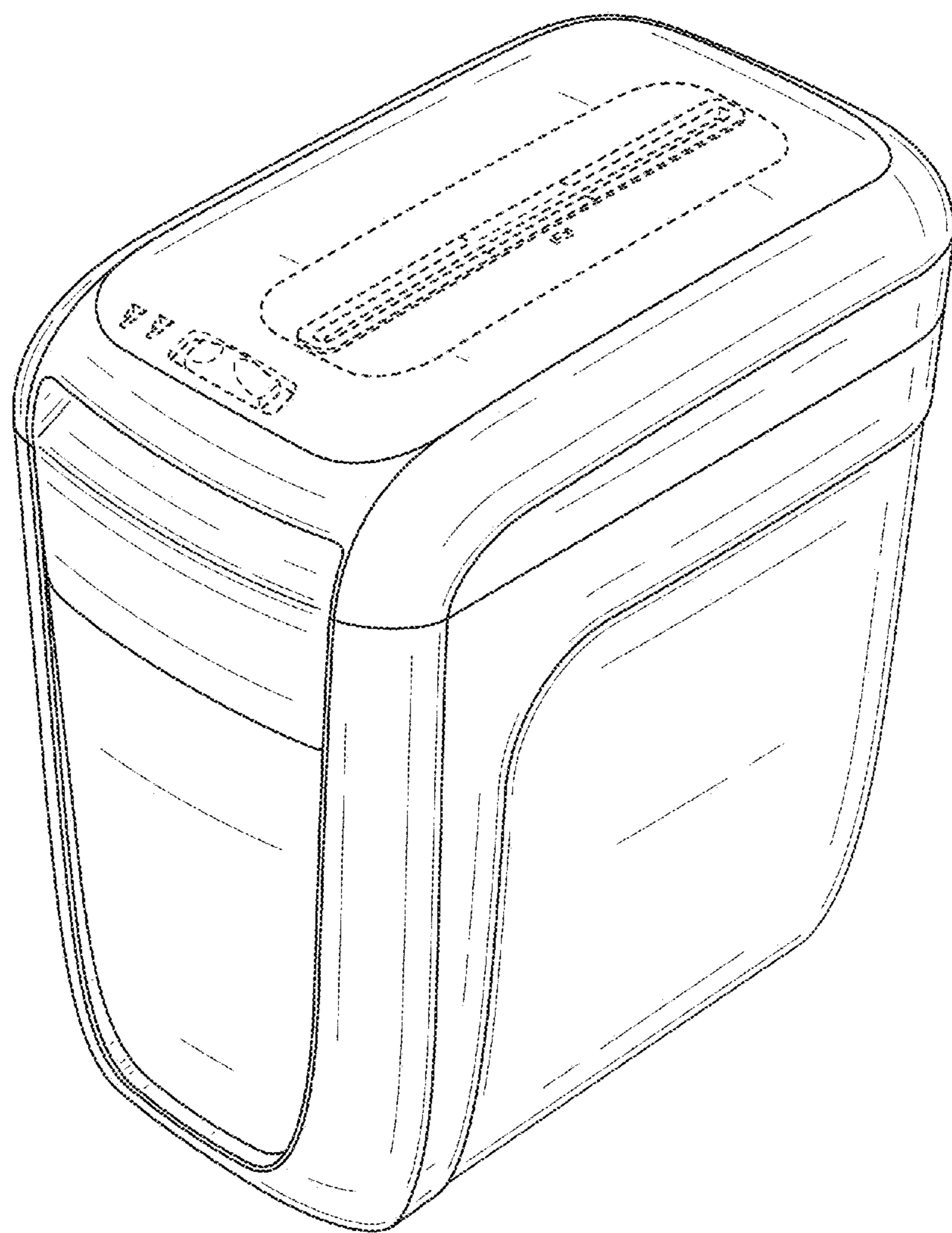

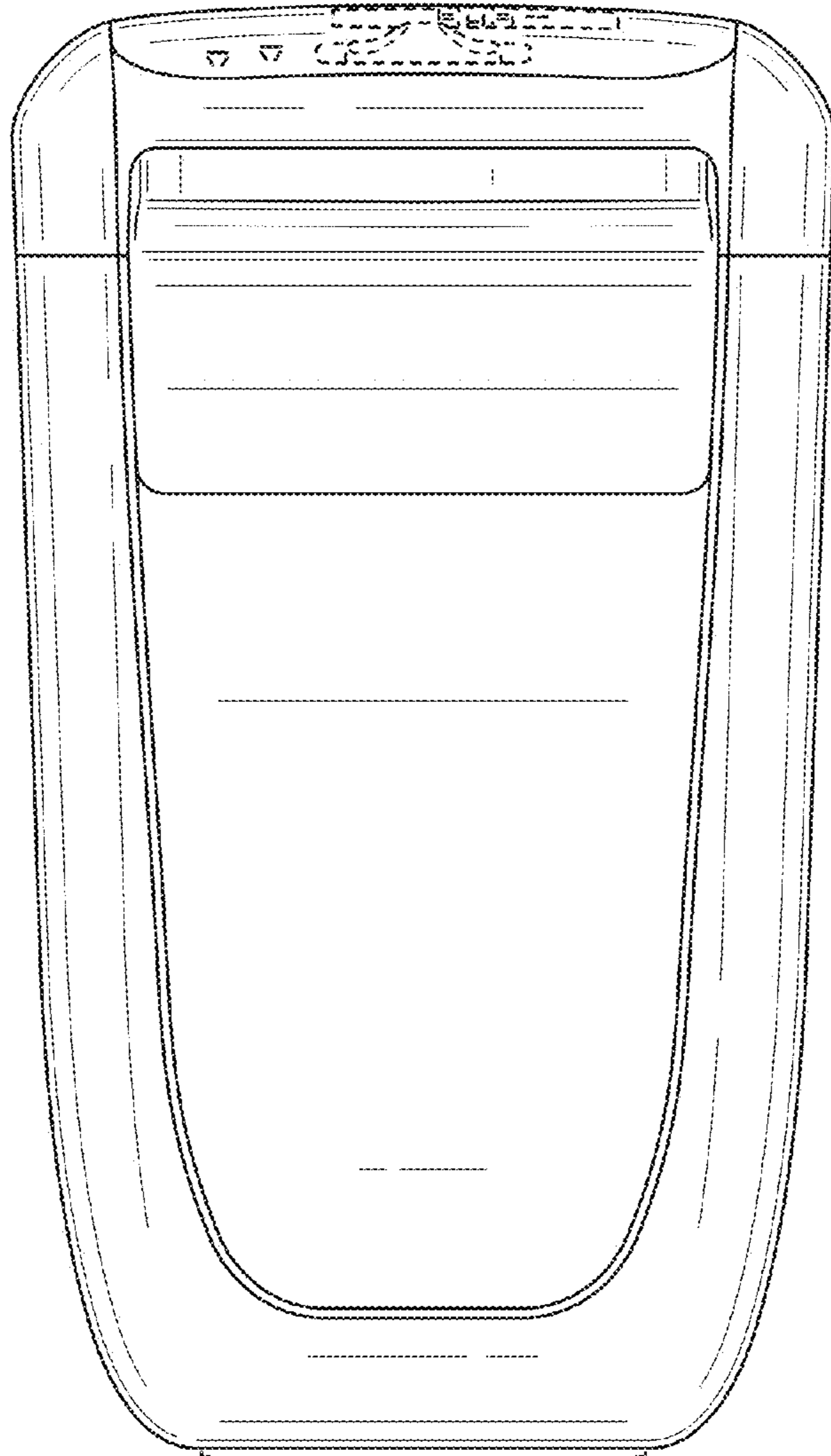

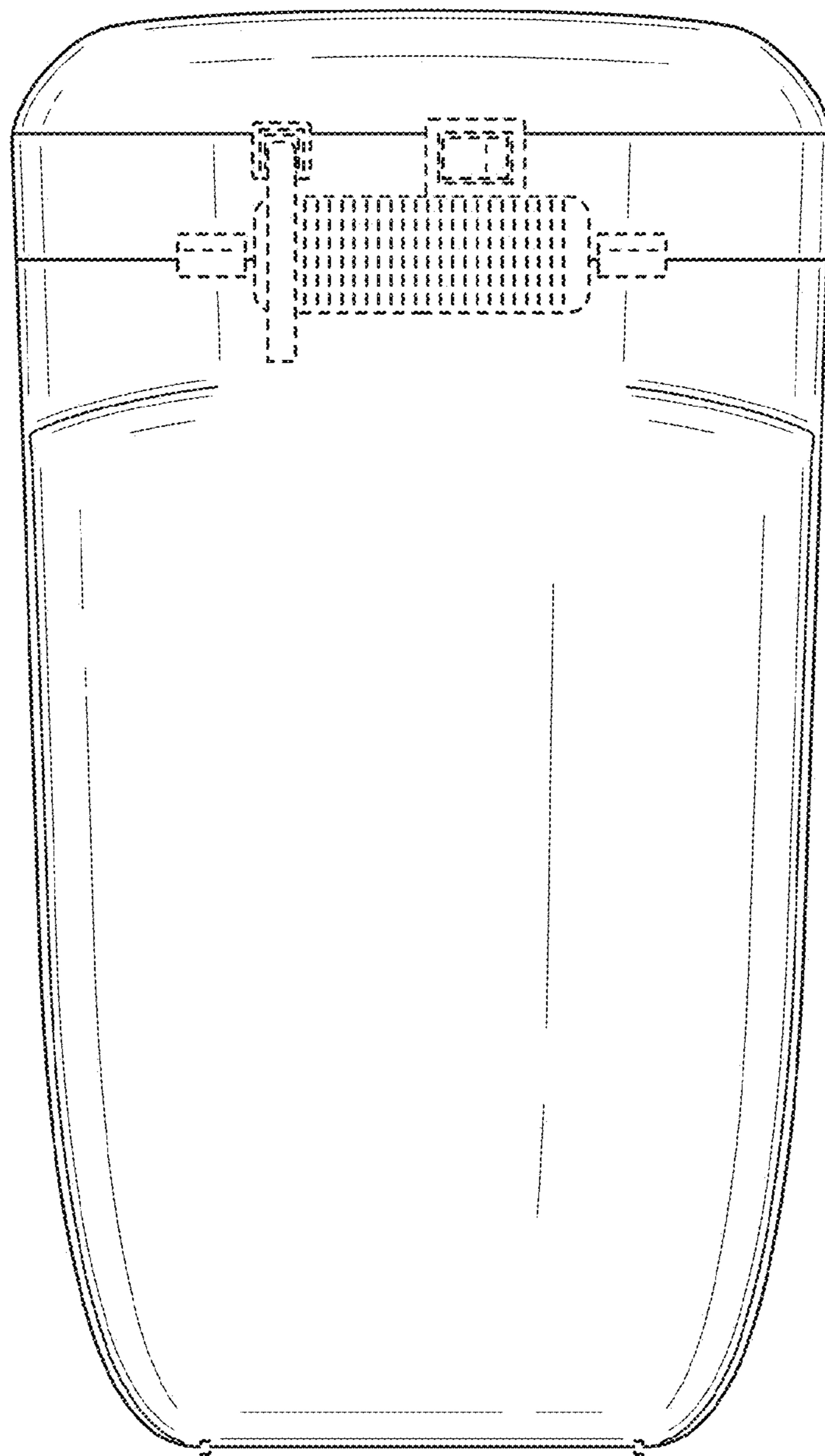

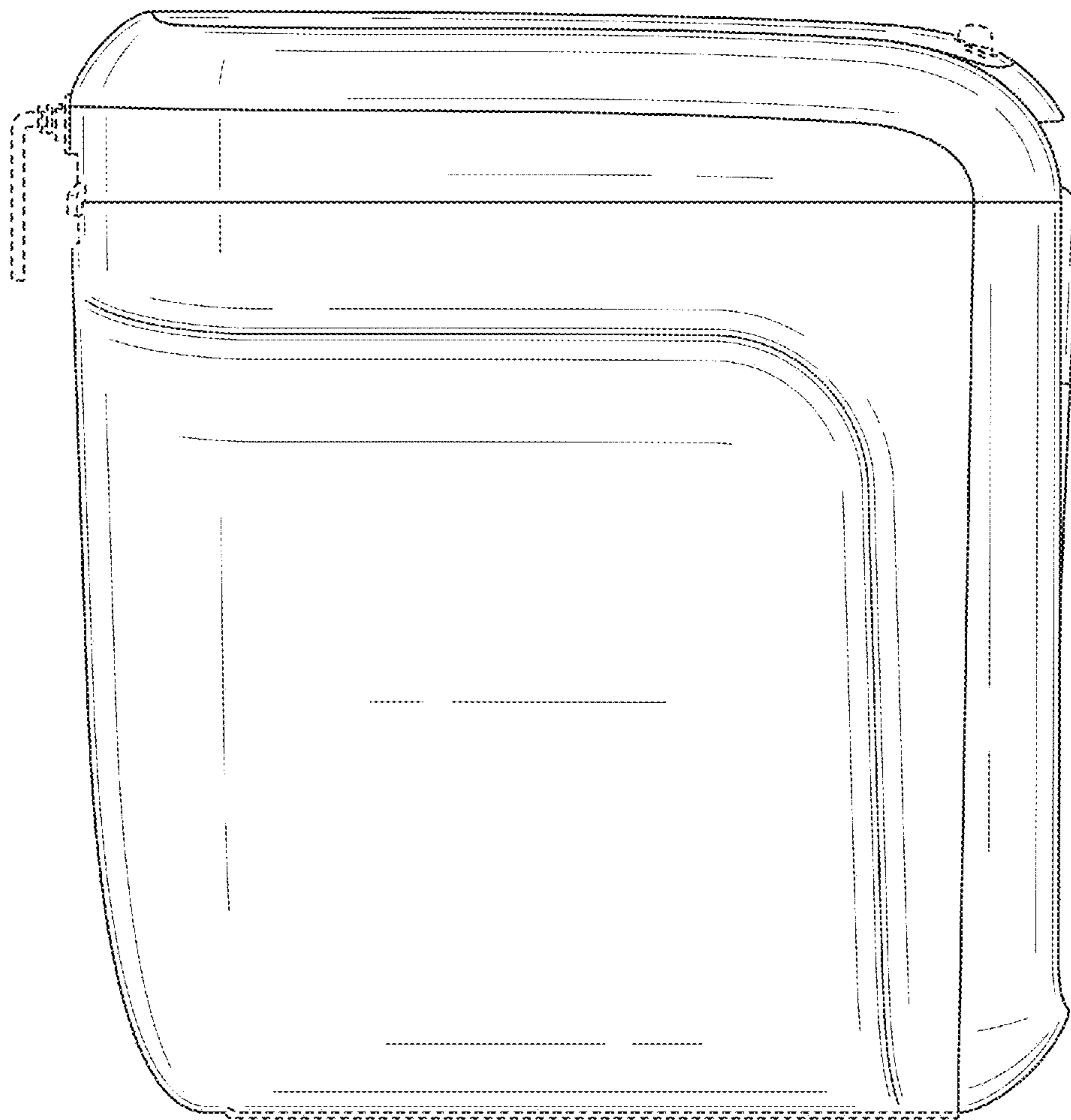

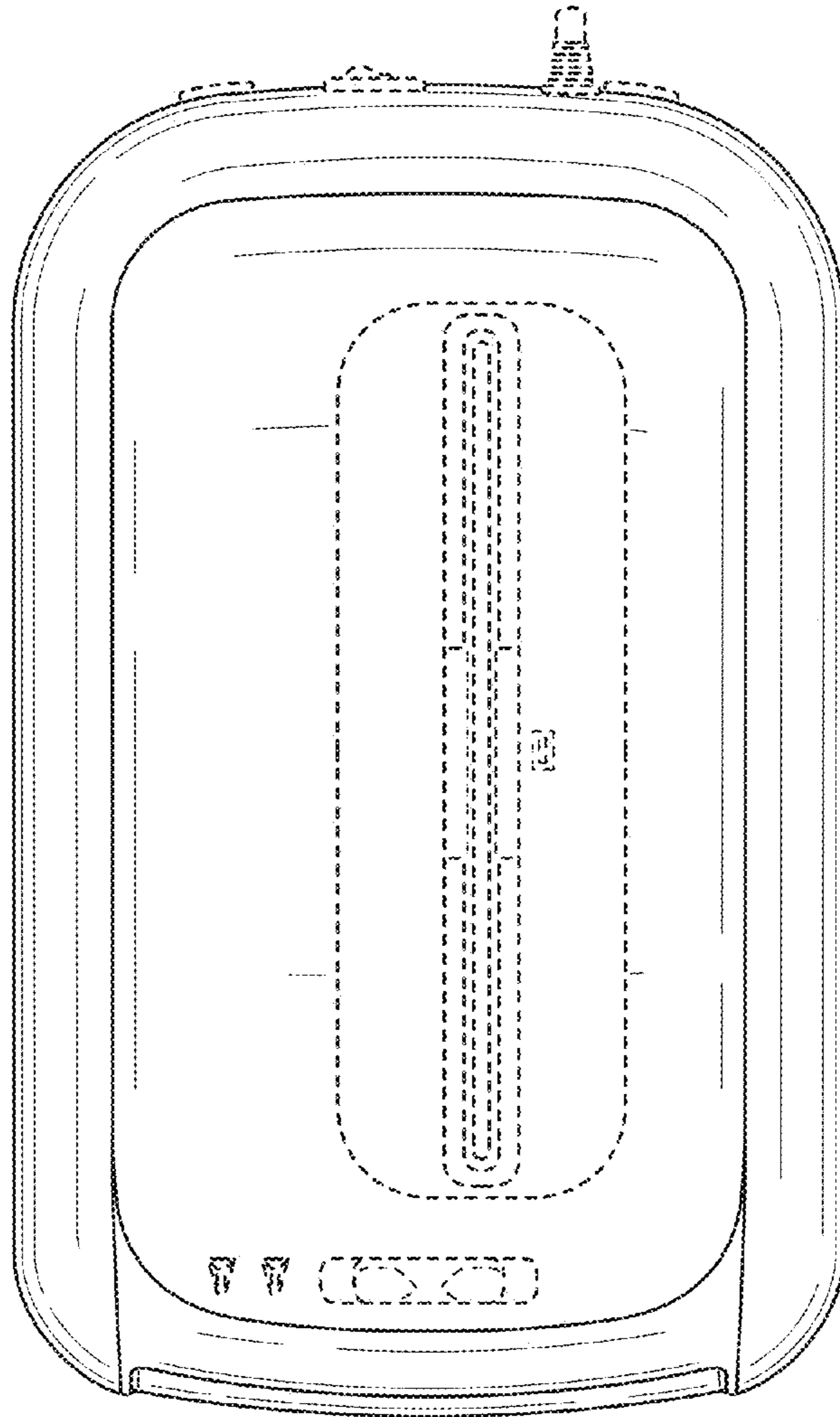

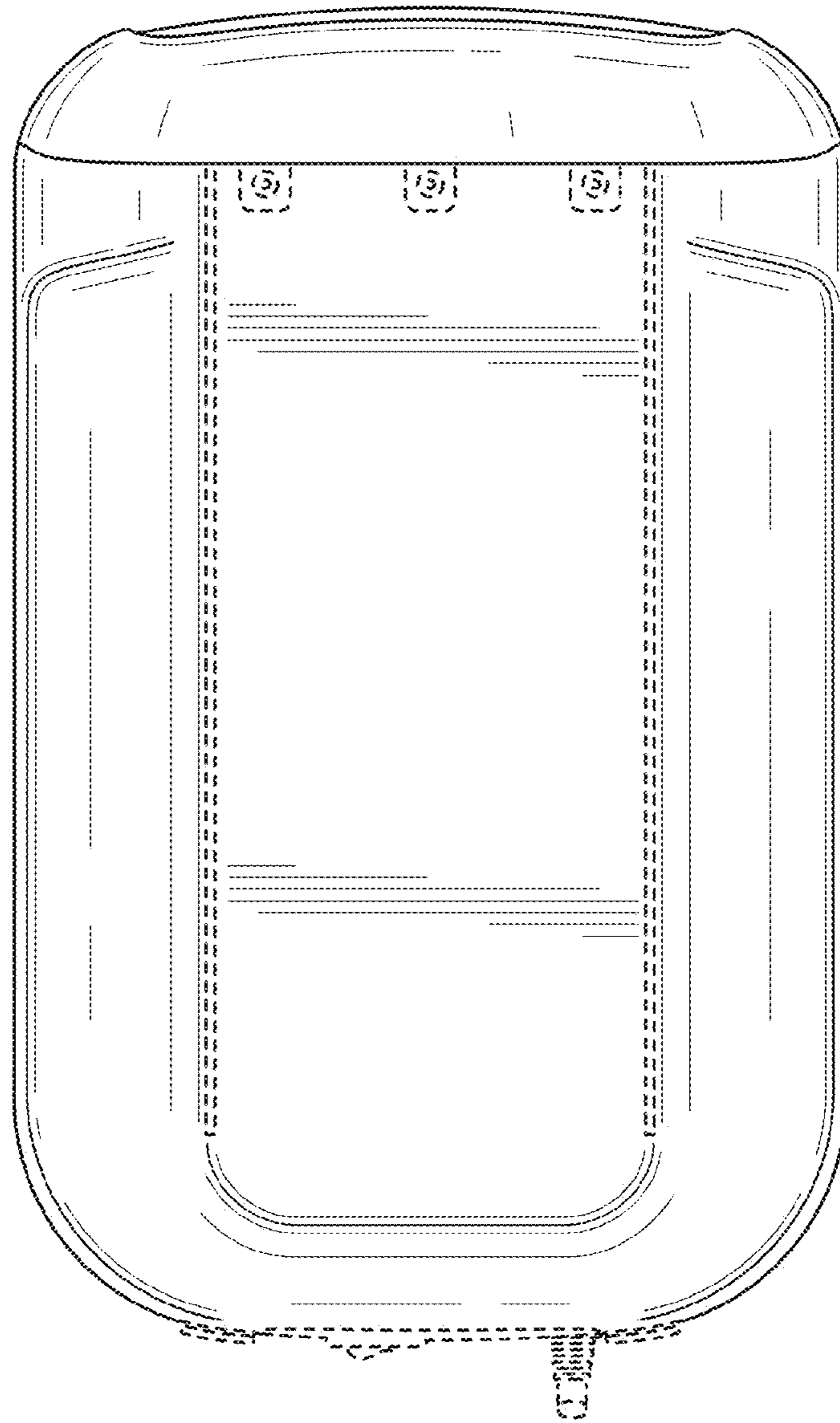

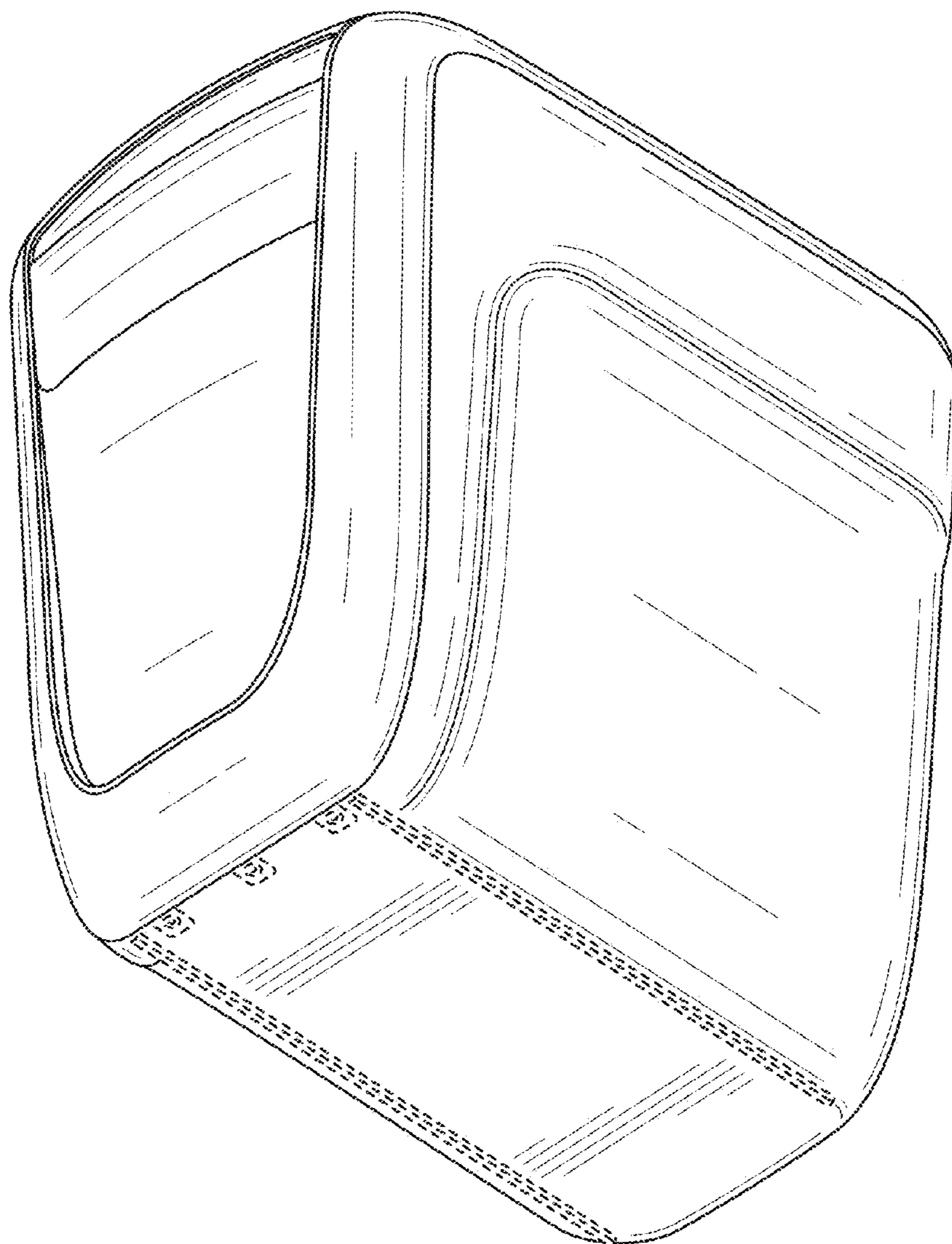
