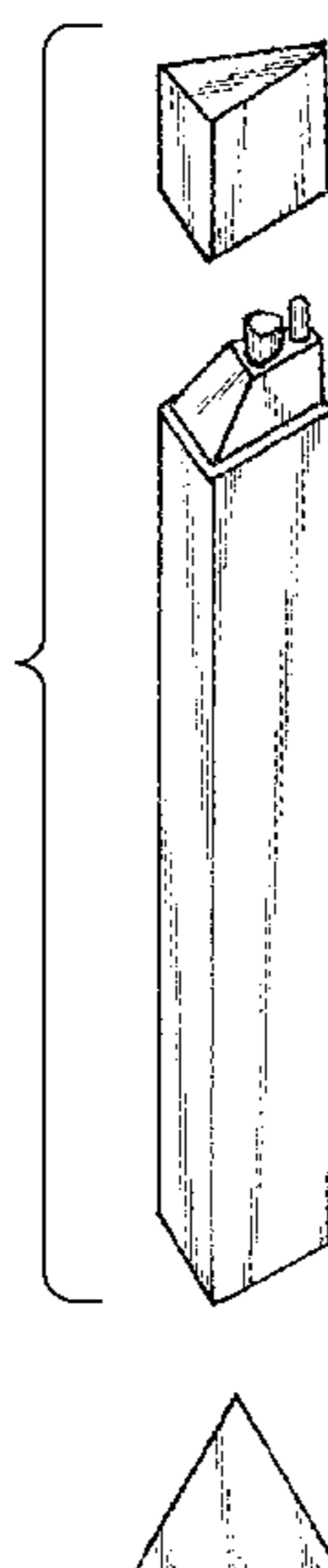
(57) **CLAIM**

The ornamental design for a marking tool with pen and highlighter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the marking tool with pen and highlighter;  
 FIG. 2 is a rear view of FIG. 1;  
 FIG. 3 is a front view of FIG. 1;  
 FIG. 4 is a left side view of FIG. 1, the right side view being a mirror image thereof;  
 FIG. 5 is a left side cross-sectional view of FIG. 3;  
 FIG. 6 is a front, perspective, exploded view of FIG. 1;  
 FIG. 7 is a left side view of FIG. 1 without the cap for convenience the right side view being a mirror image thereof;  
 FIG. 8 is a rear view of FIG. 7;  
 FIG. 9 is a front view of FIG. 7;  
 FIG. 10 is a bottom view of FIG. 7; and,  
 FIG. 11 is a top view of FIG. 7.

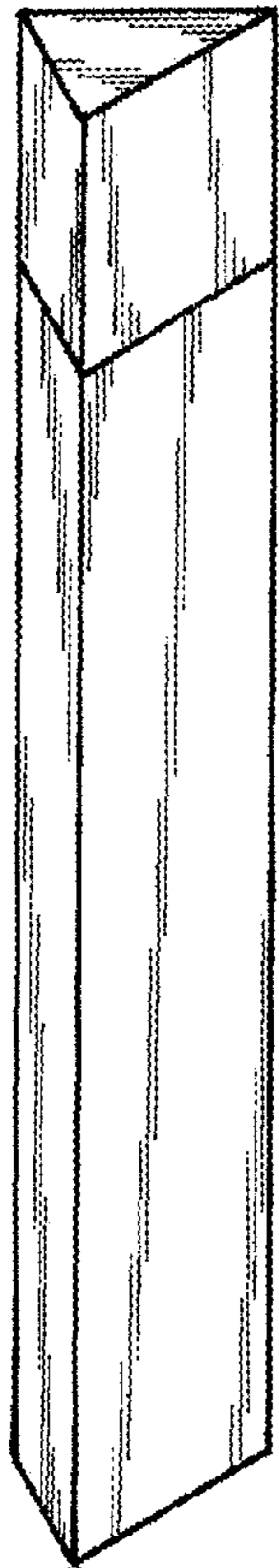

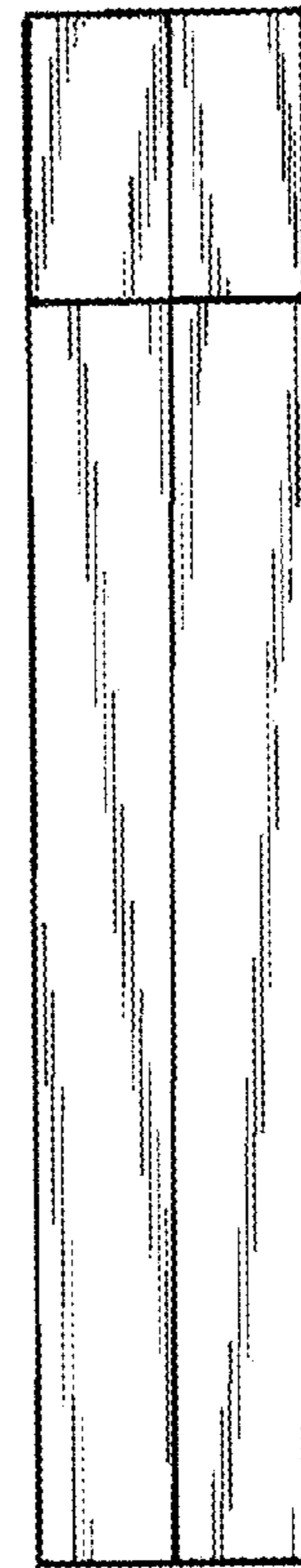

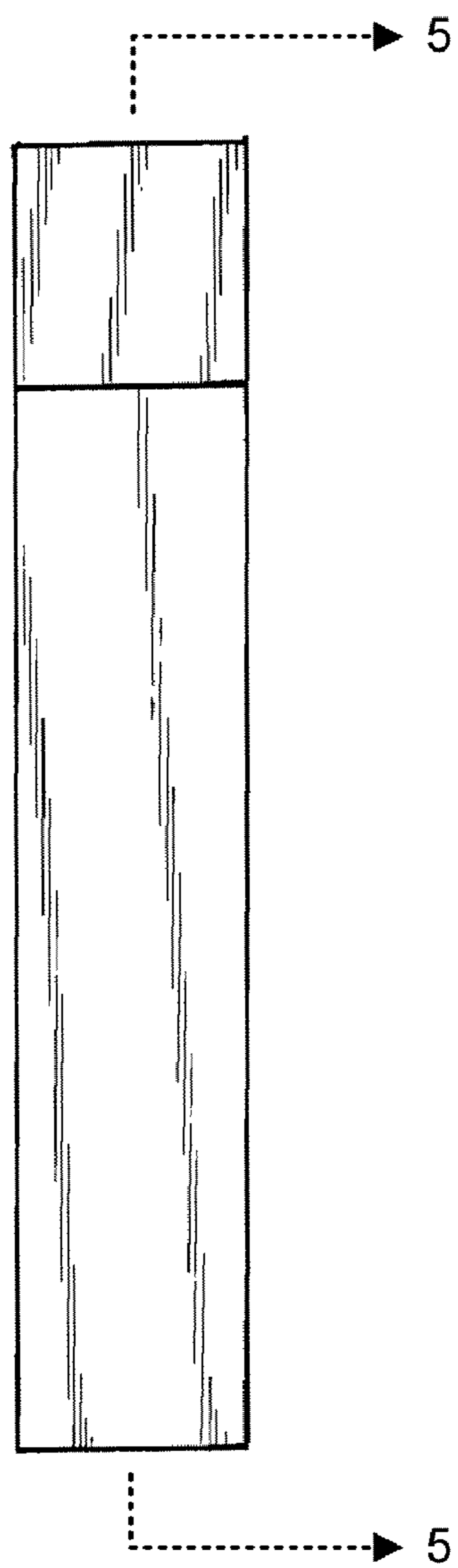

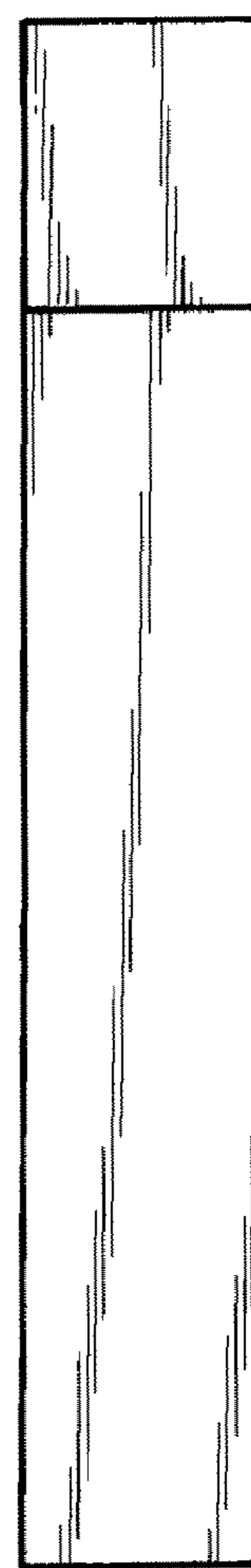

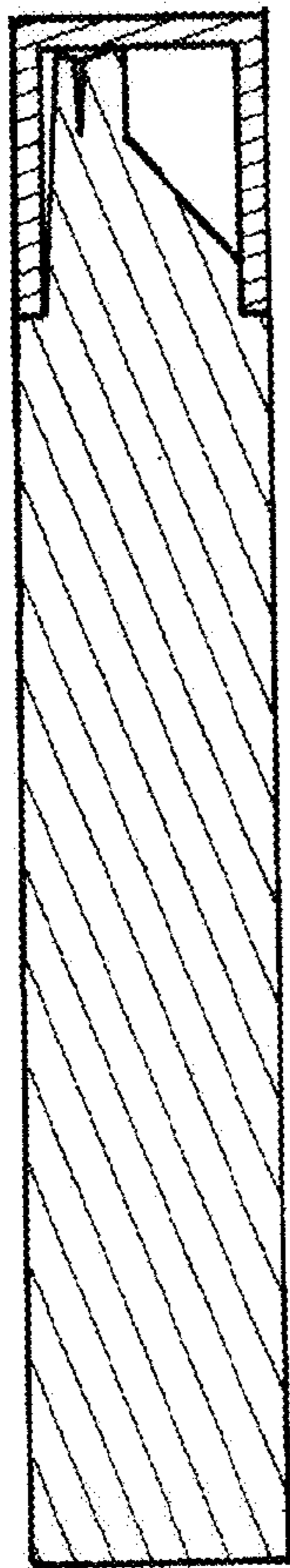

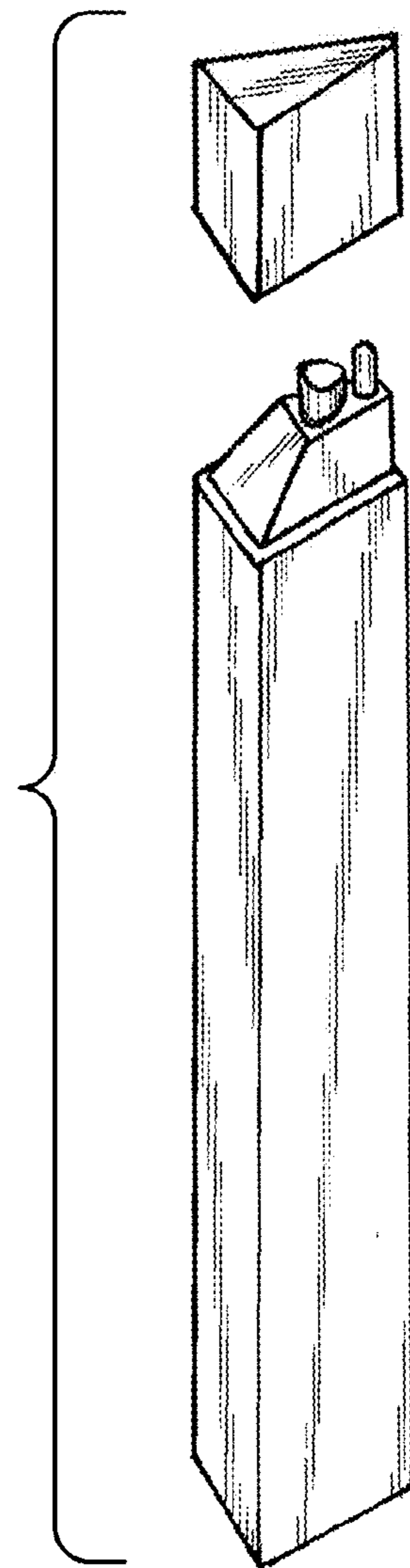

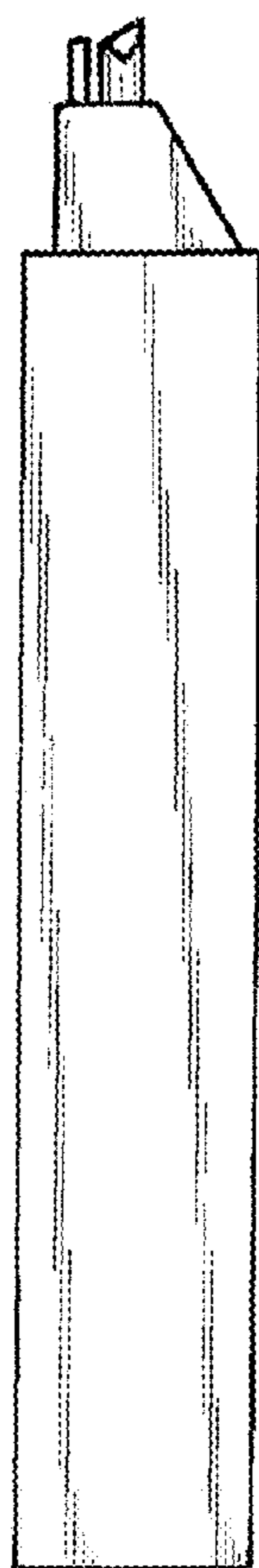

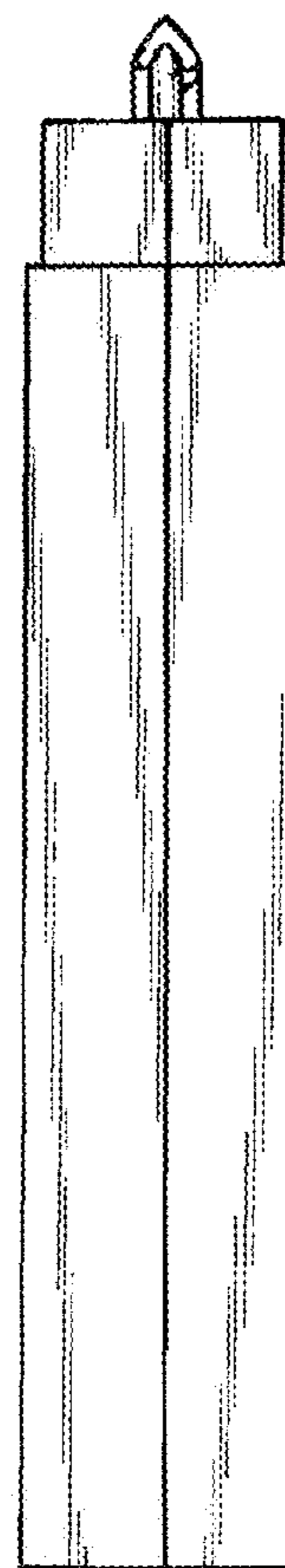

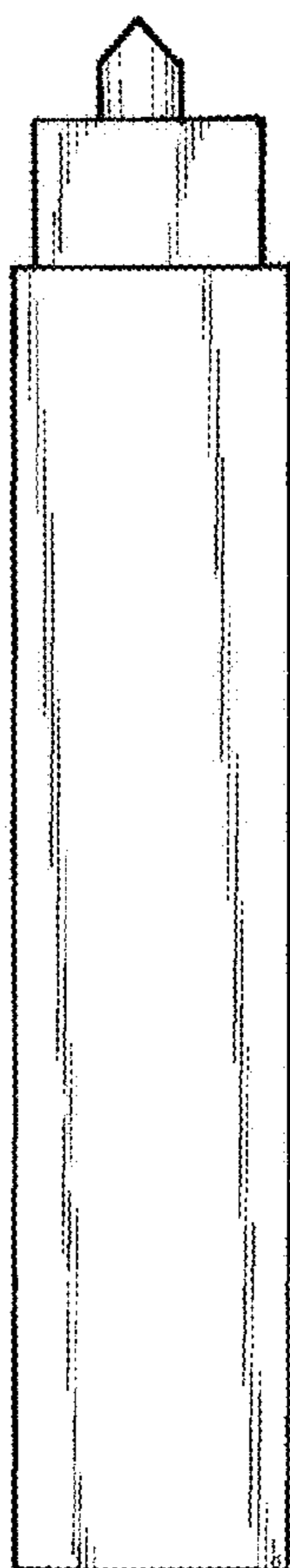

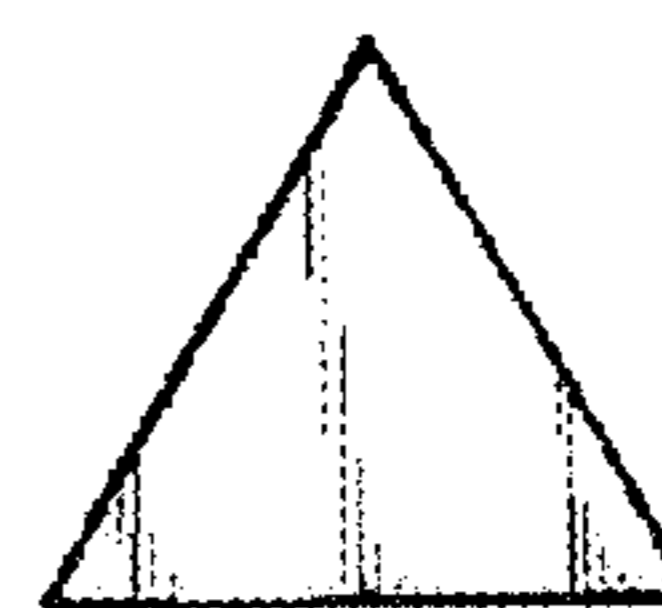

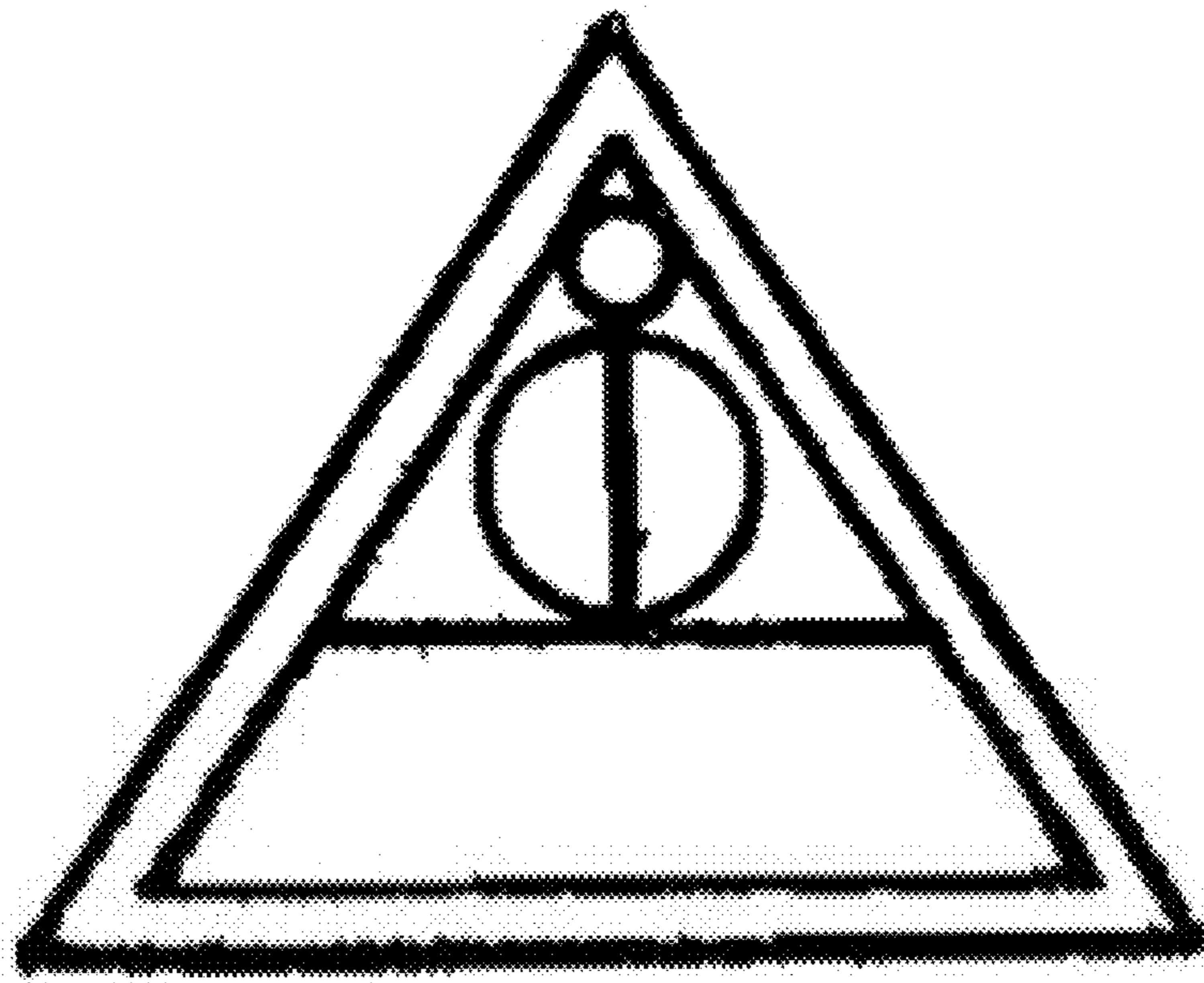
