FIG. 3 is a front view of the intramedullary implant extractor.

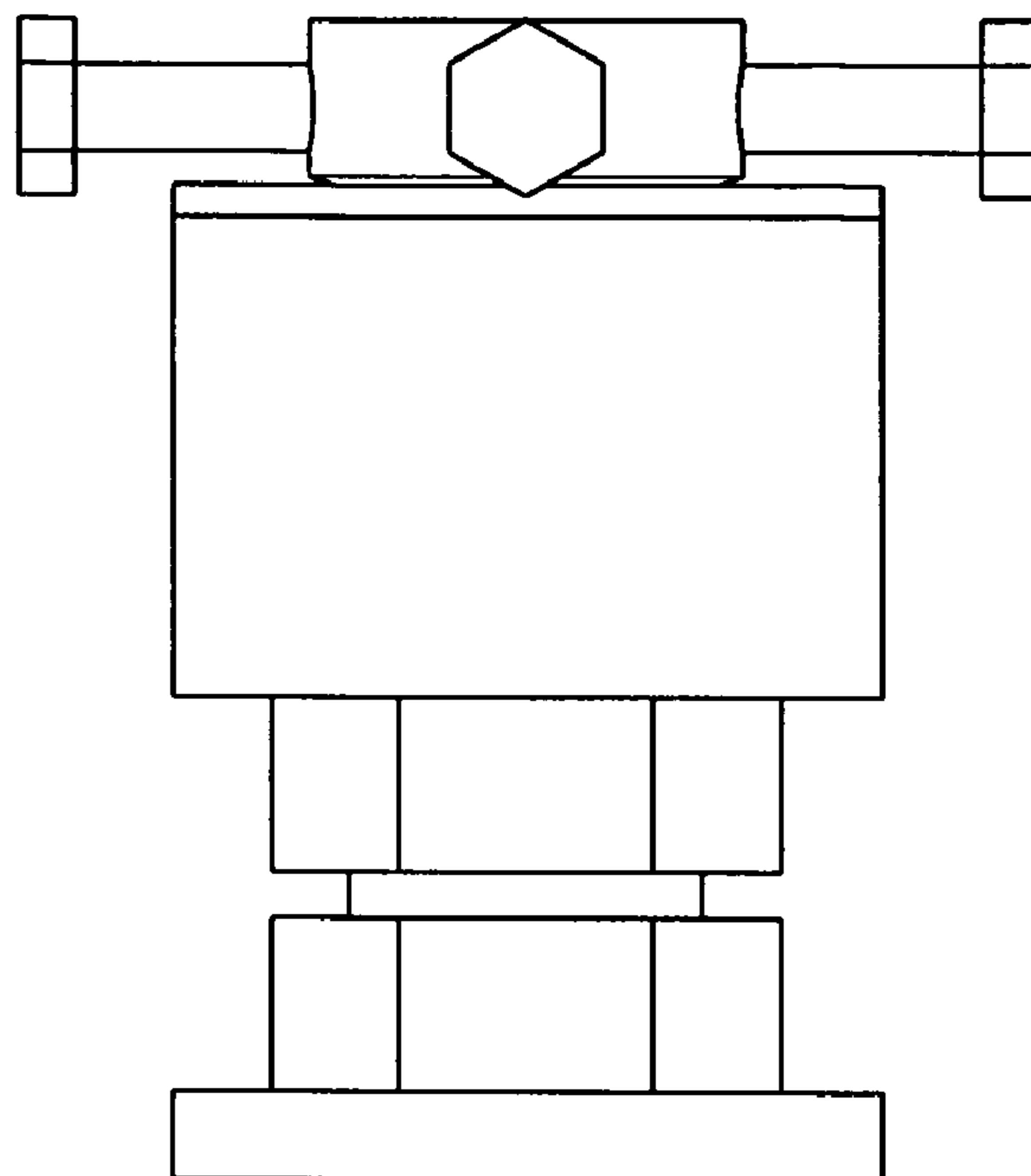
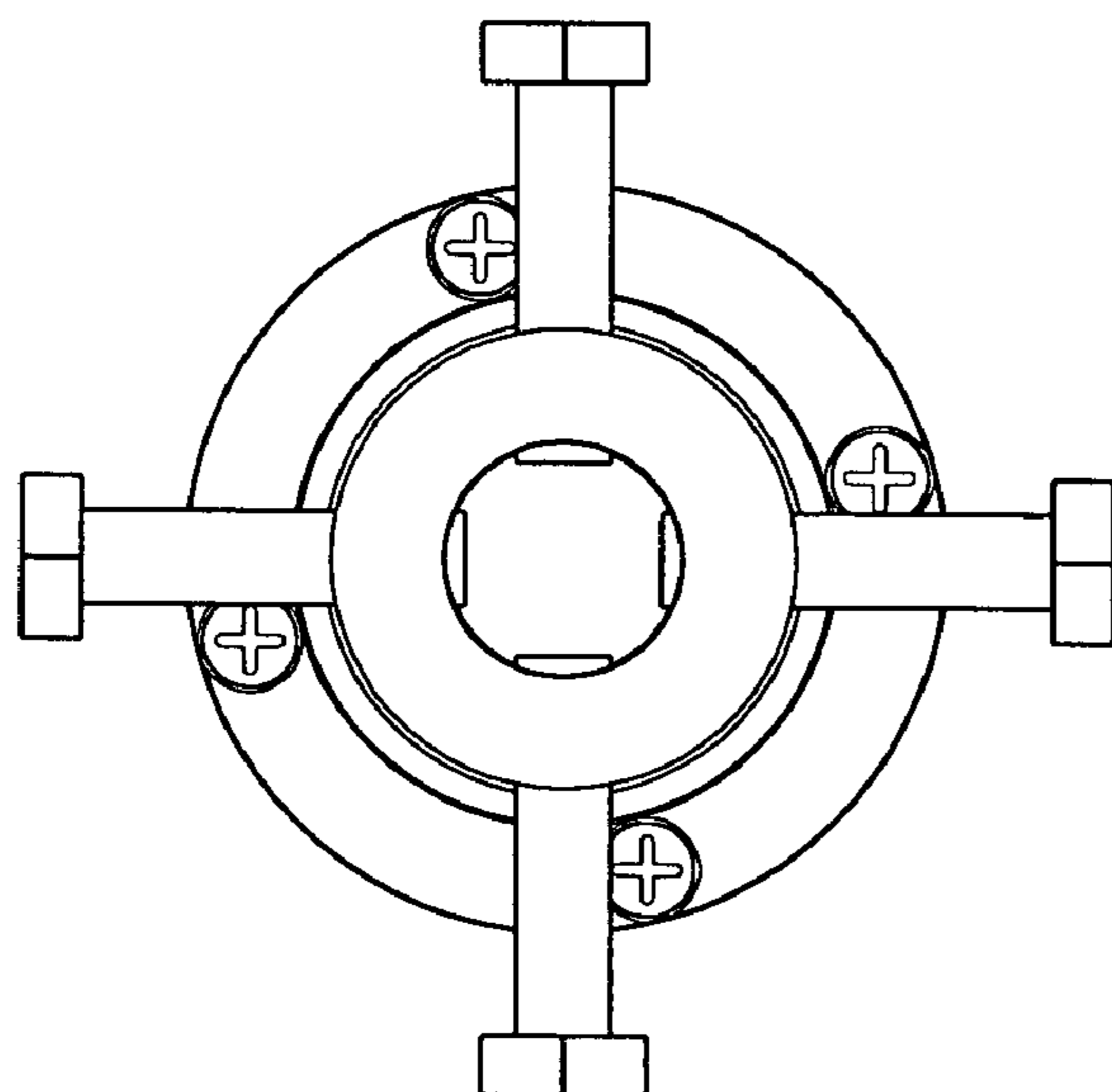
FIG. 4 is a right side view of the intramedullary implant extractor.

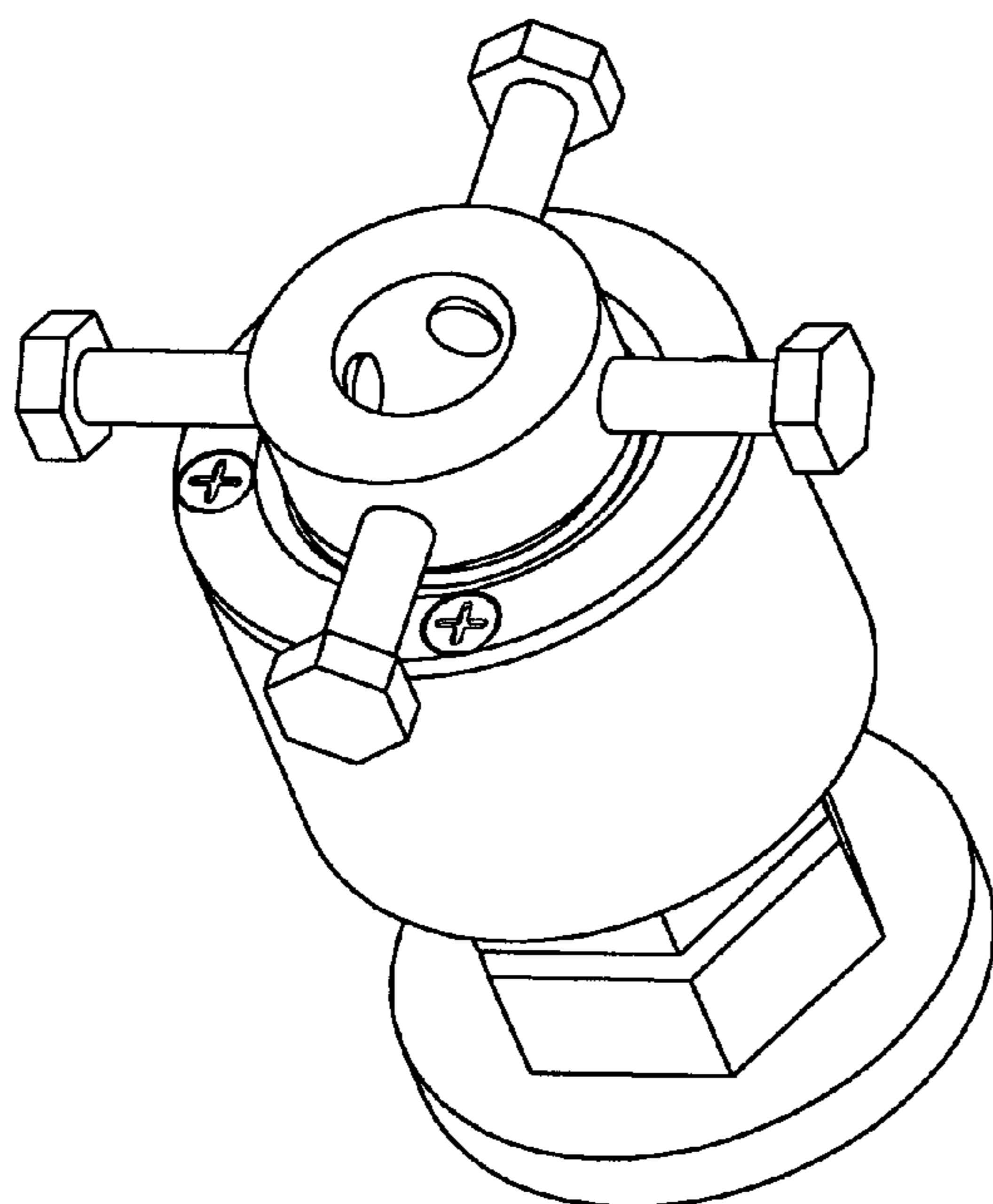

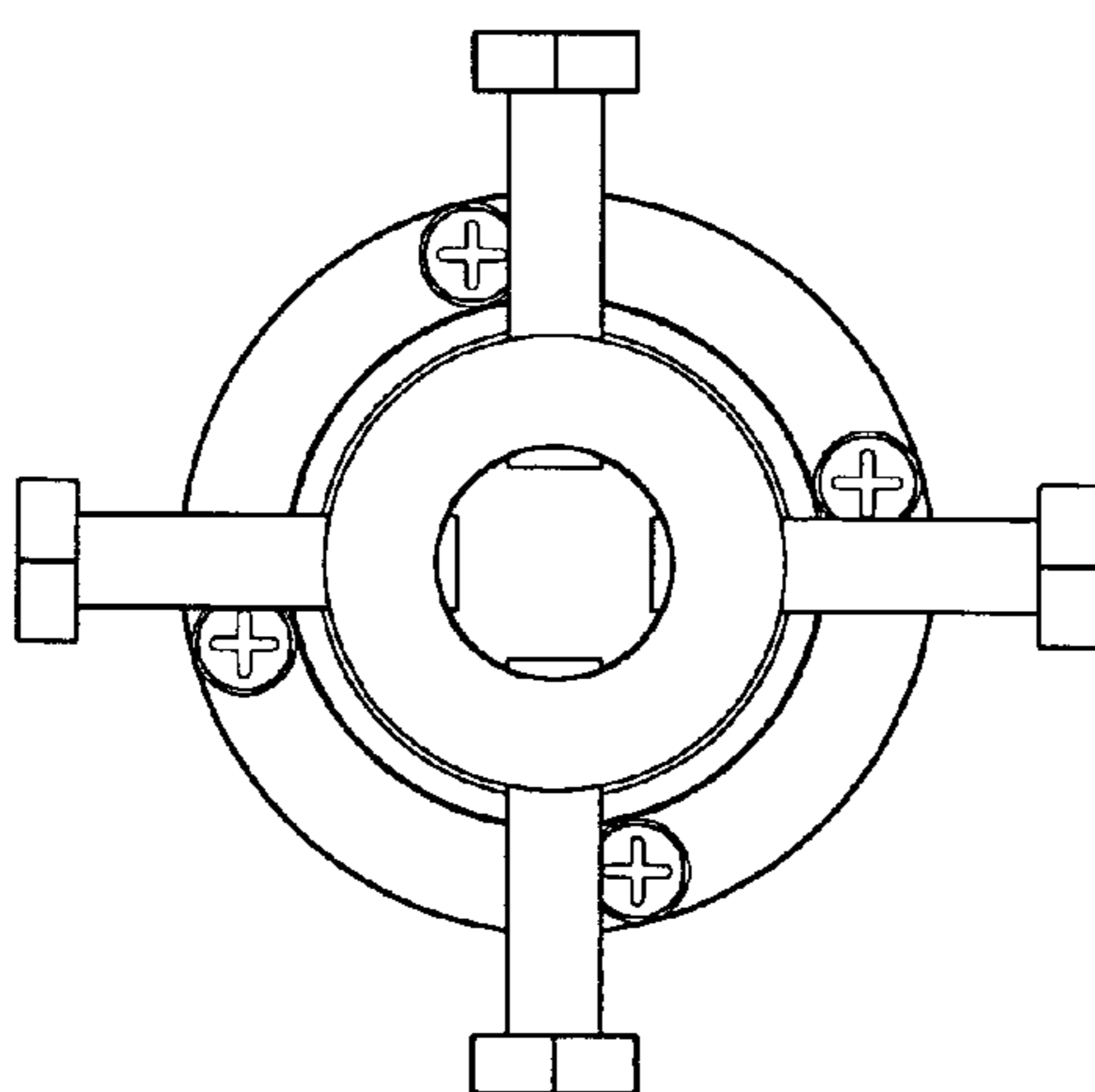

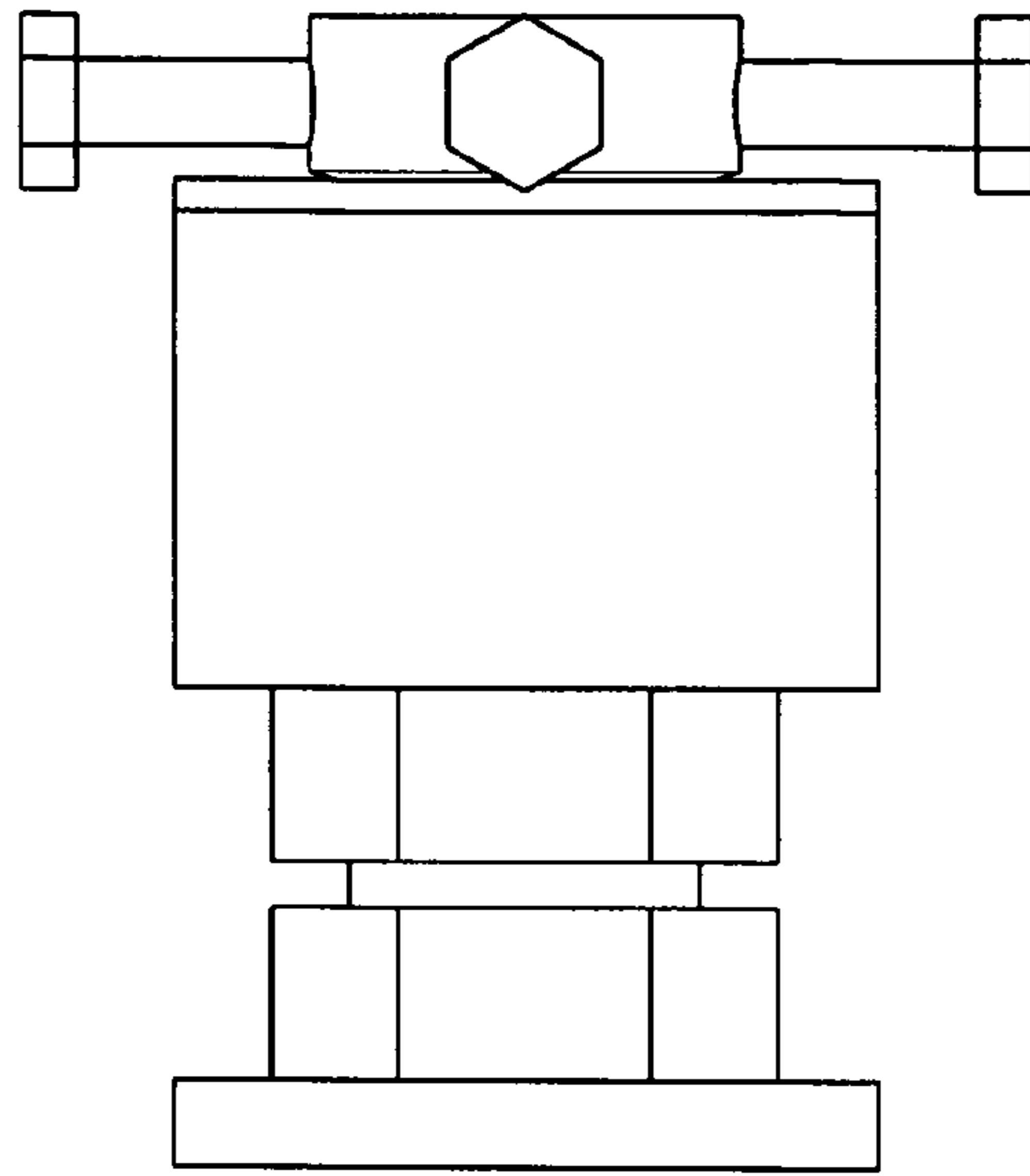

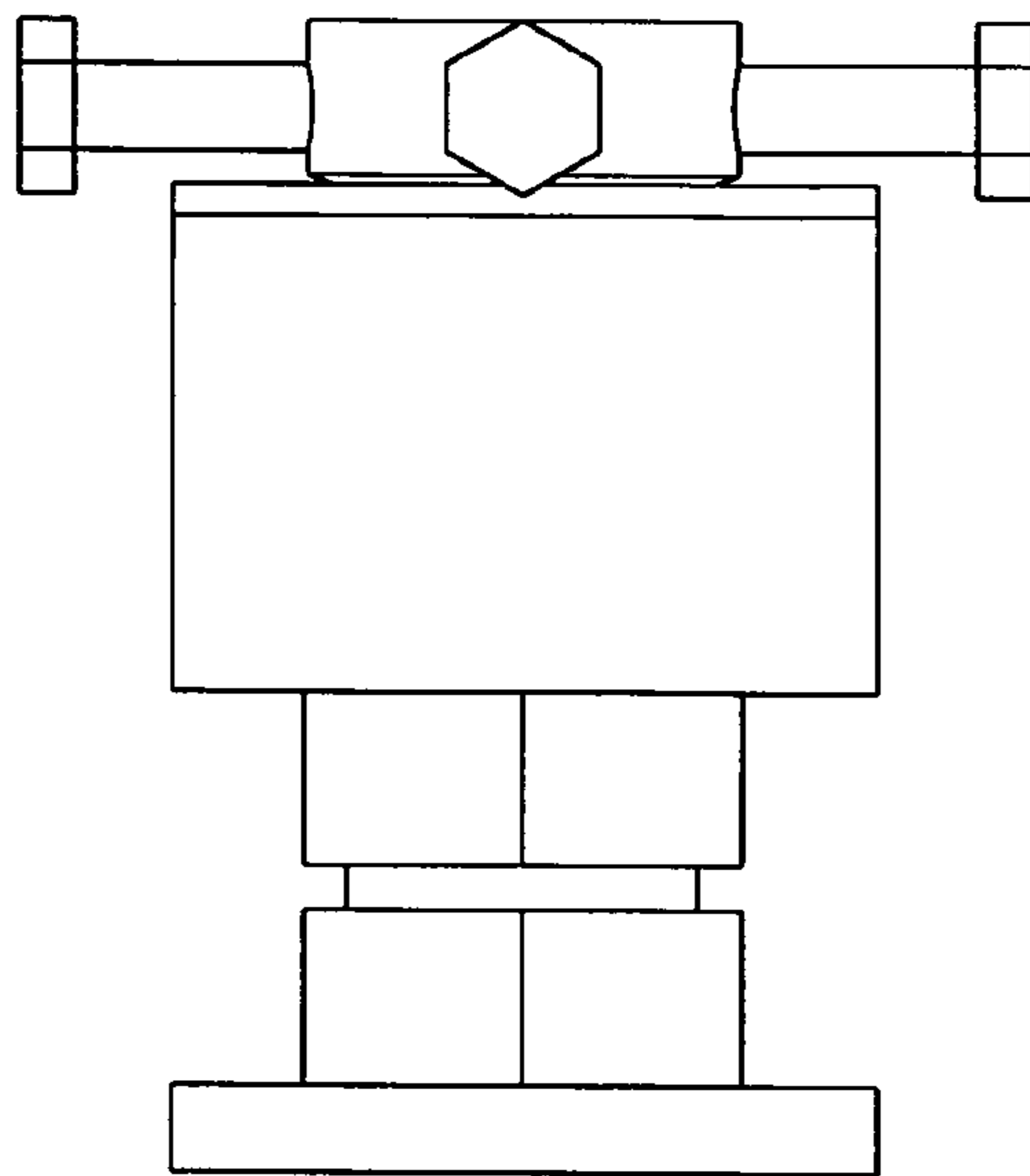

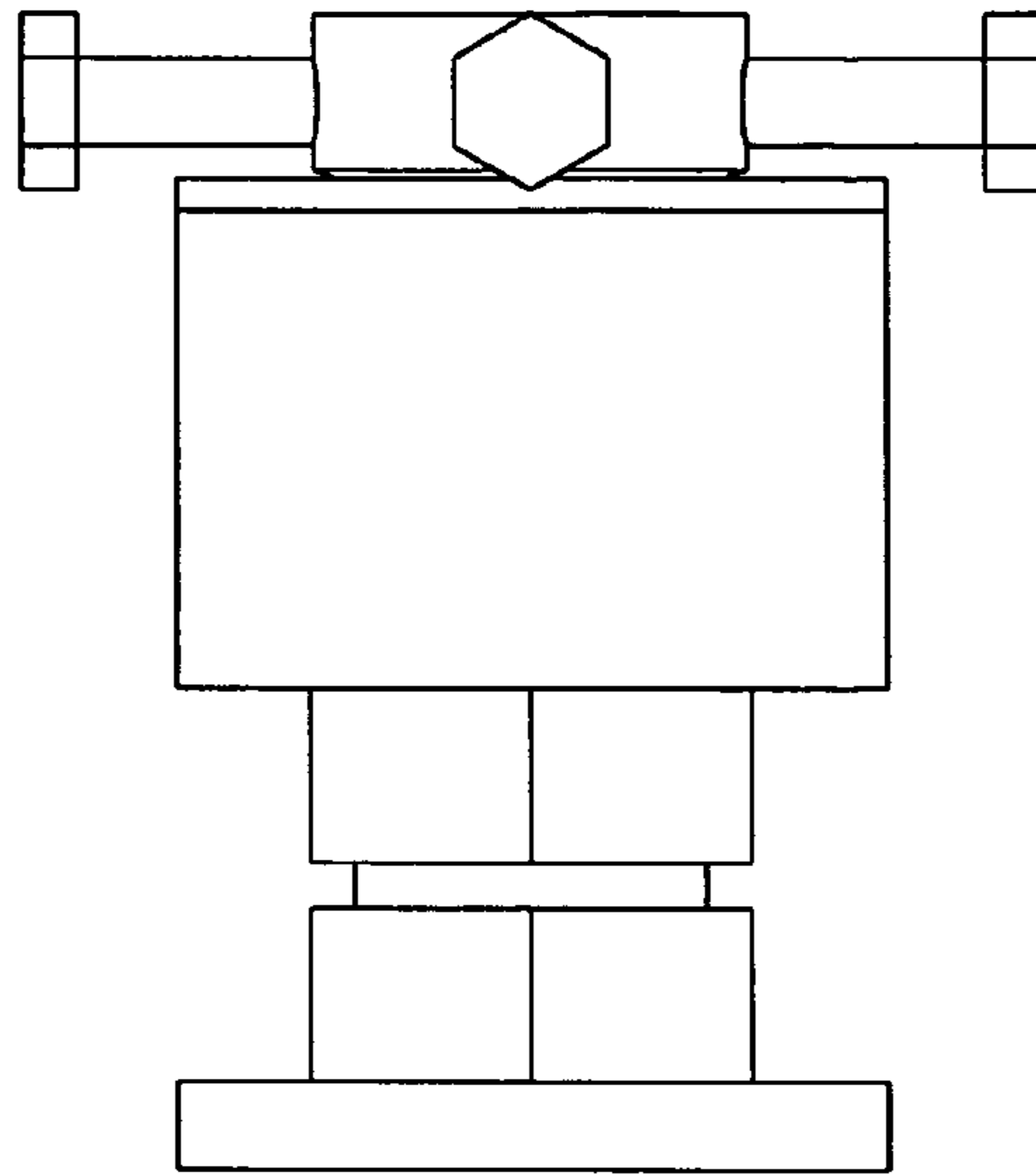

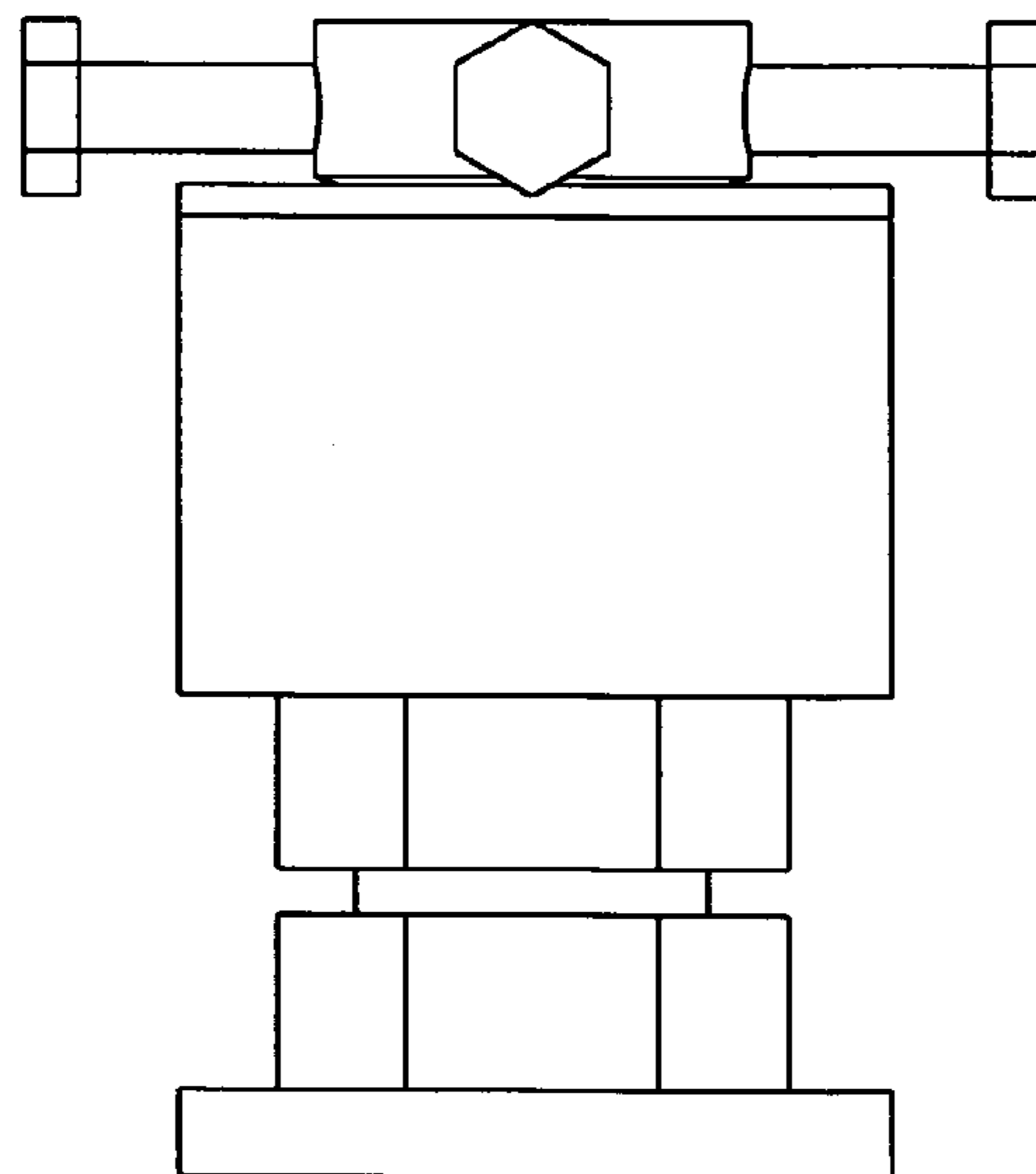

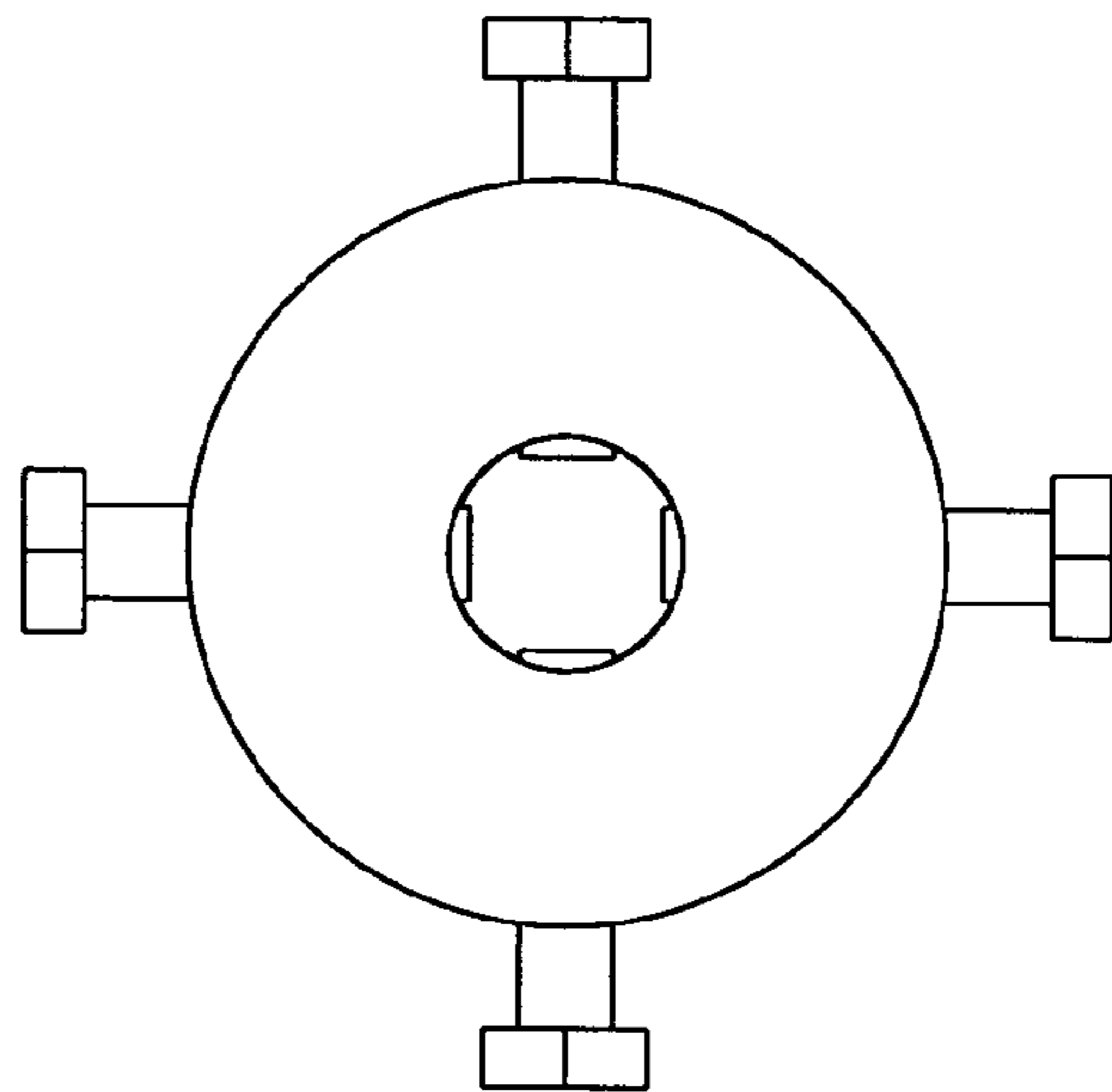
