The ornamental design for a heart rate variability analyzer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective of a heart rate variability analyzer showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side view thereof;

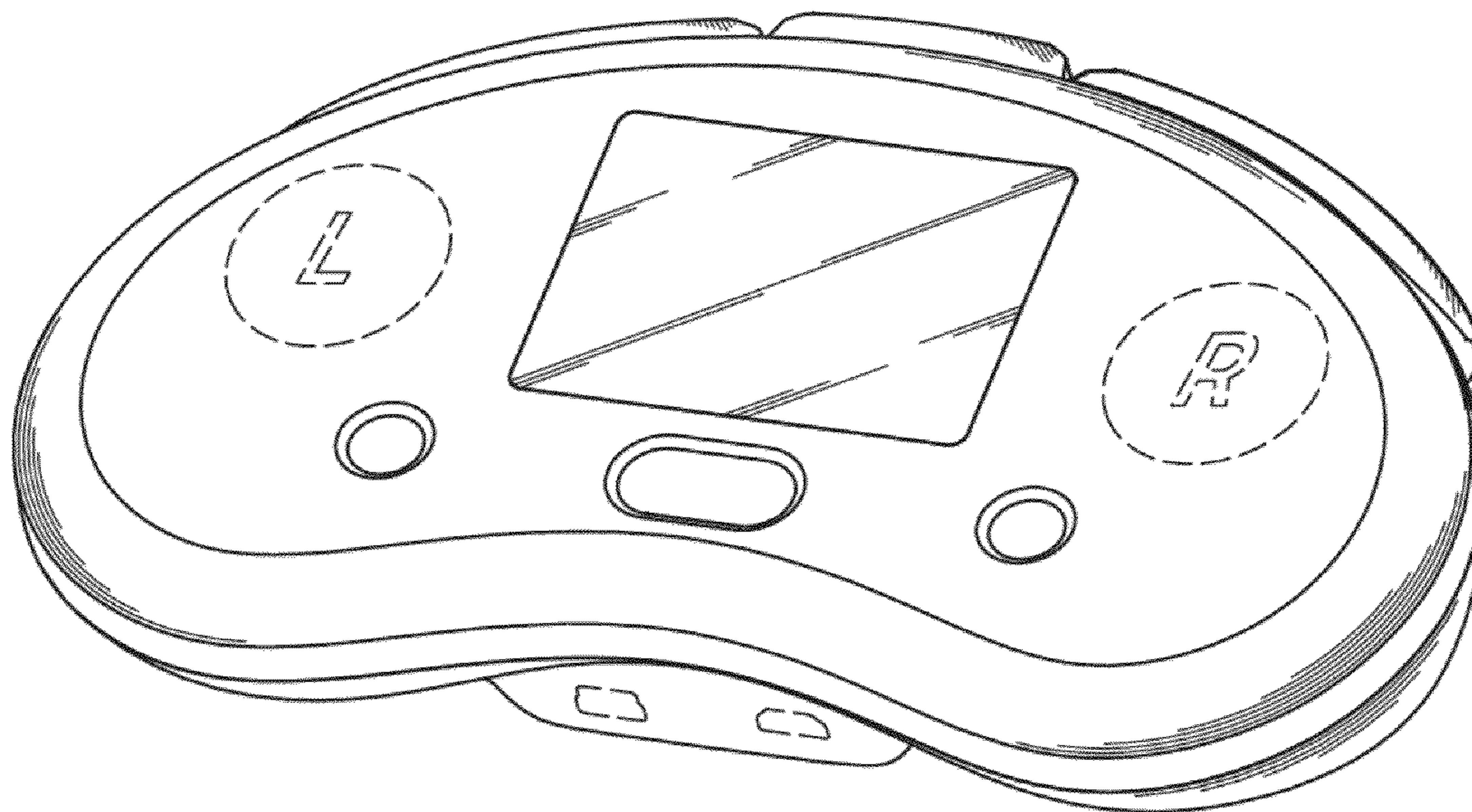

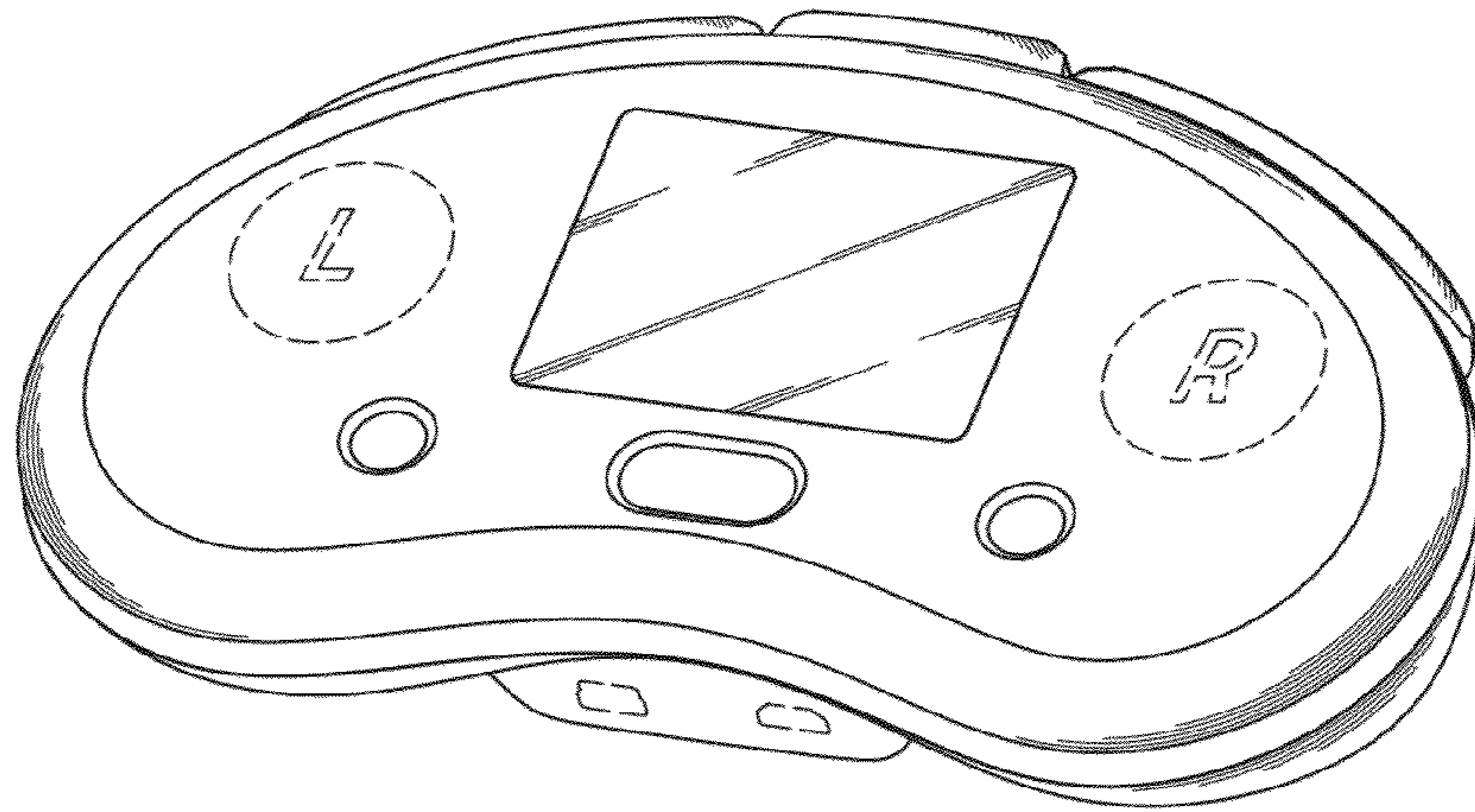

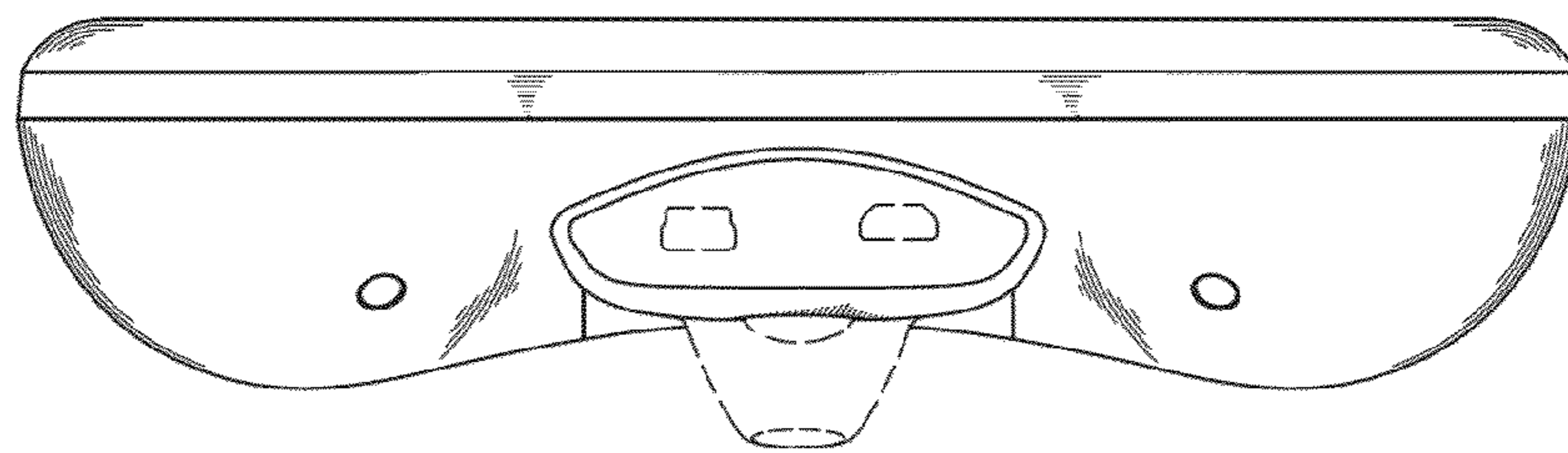

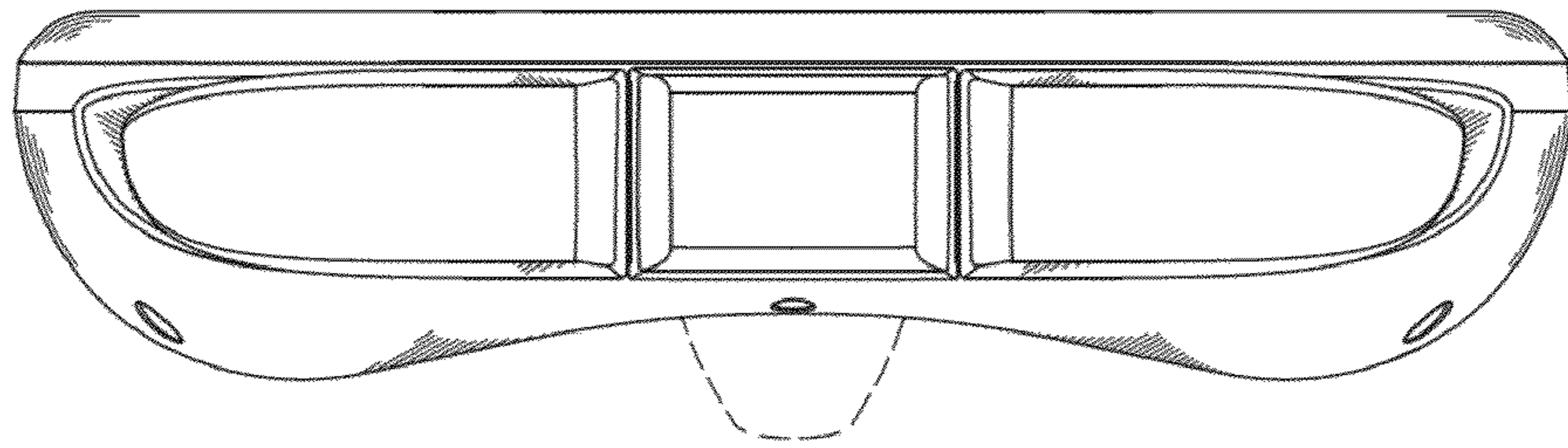

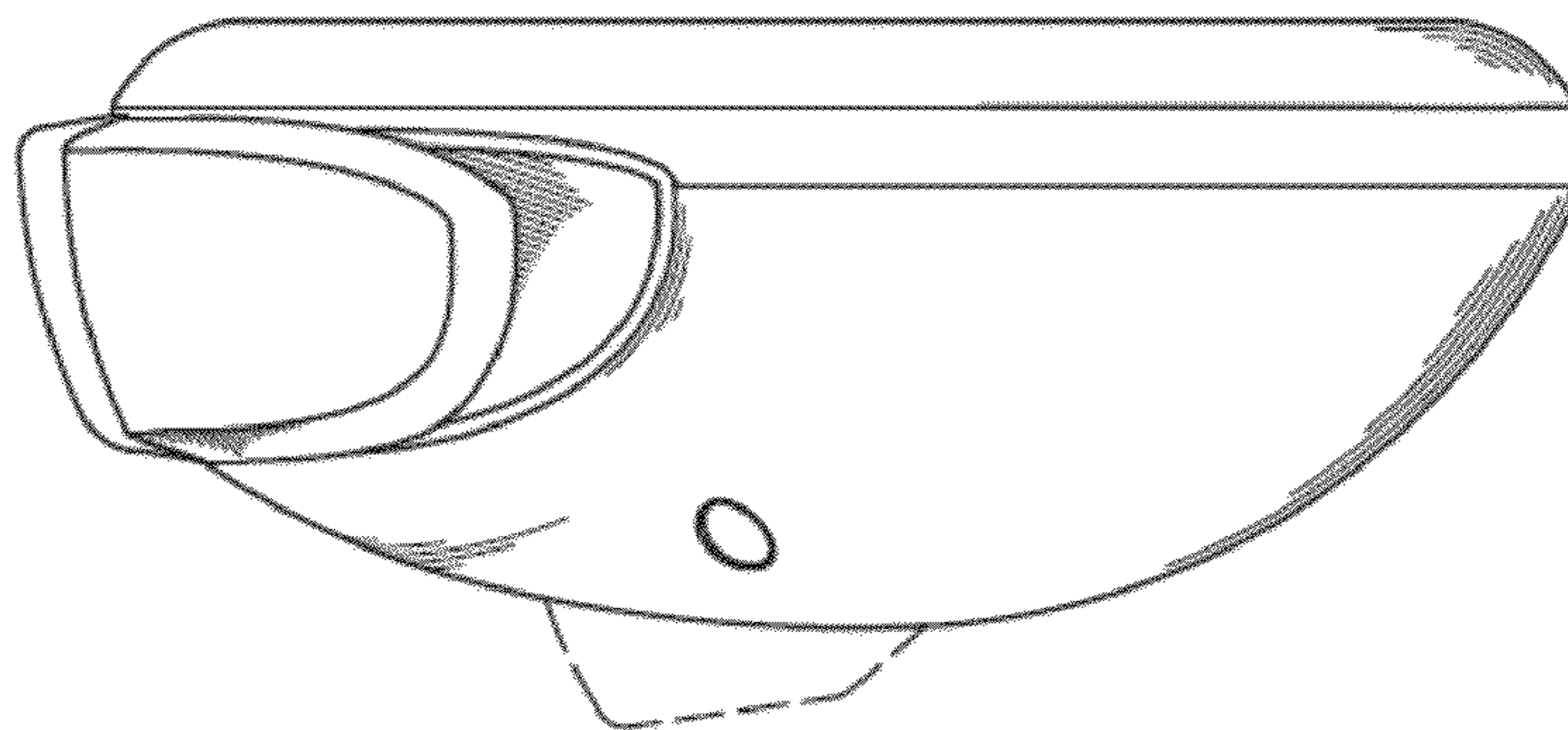

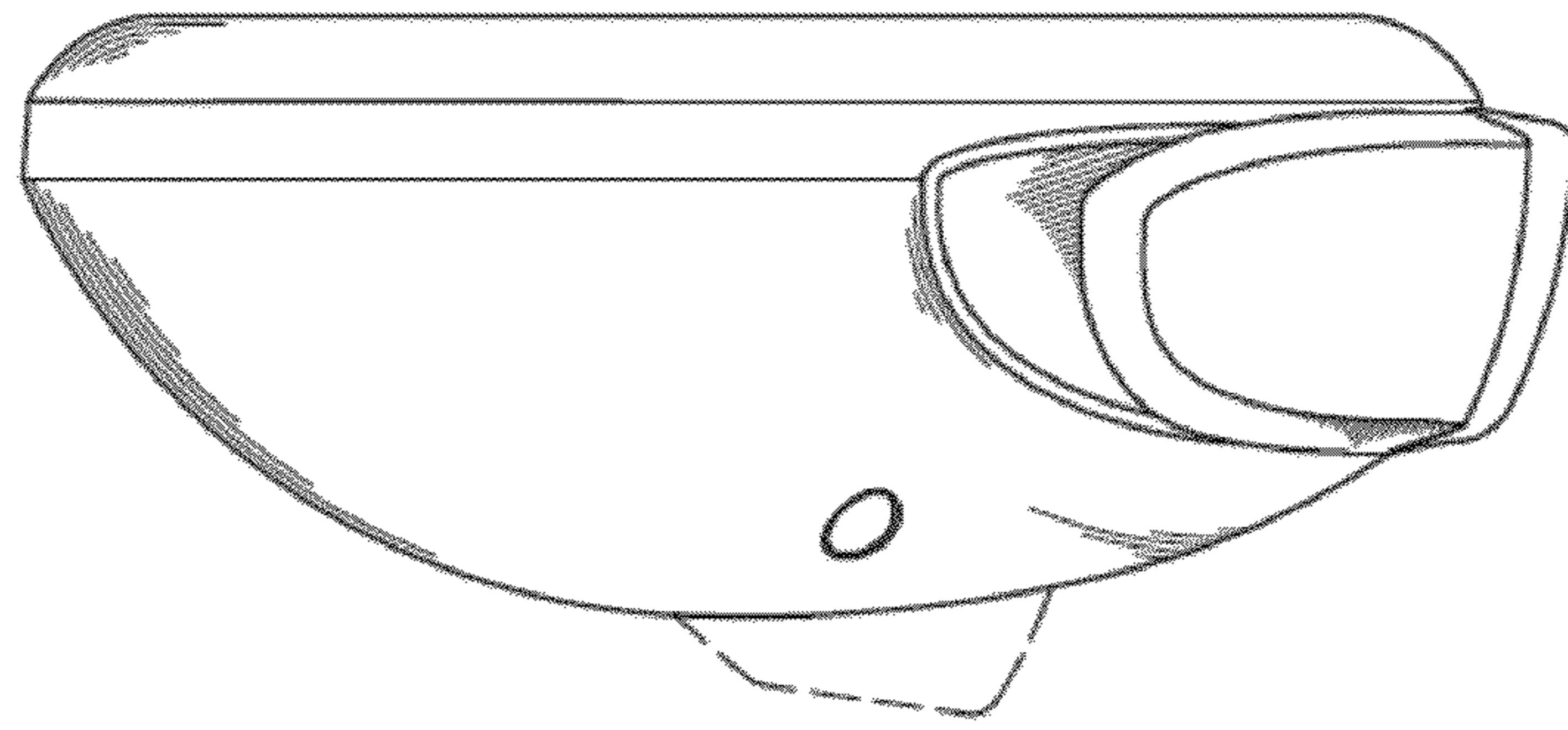

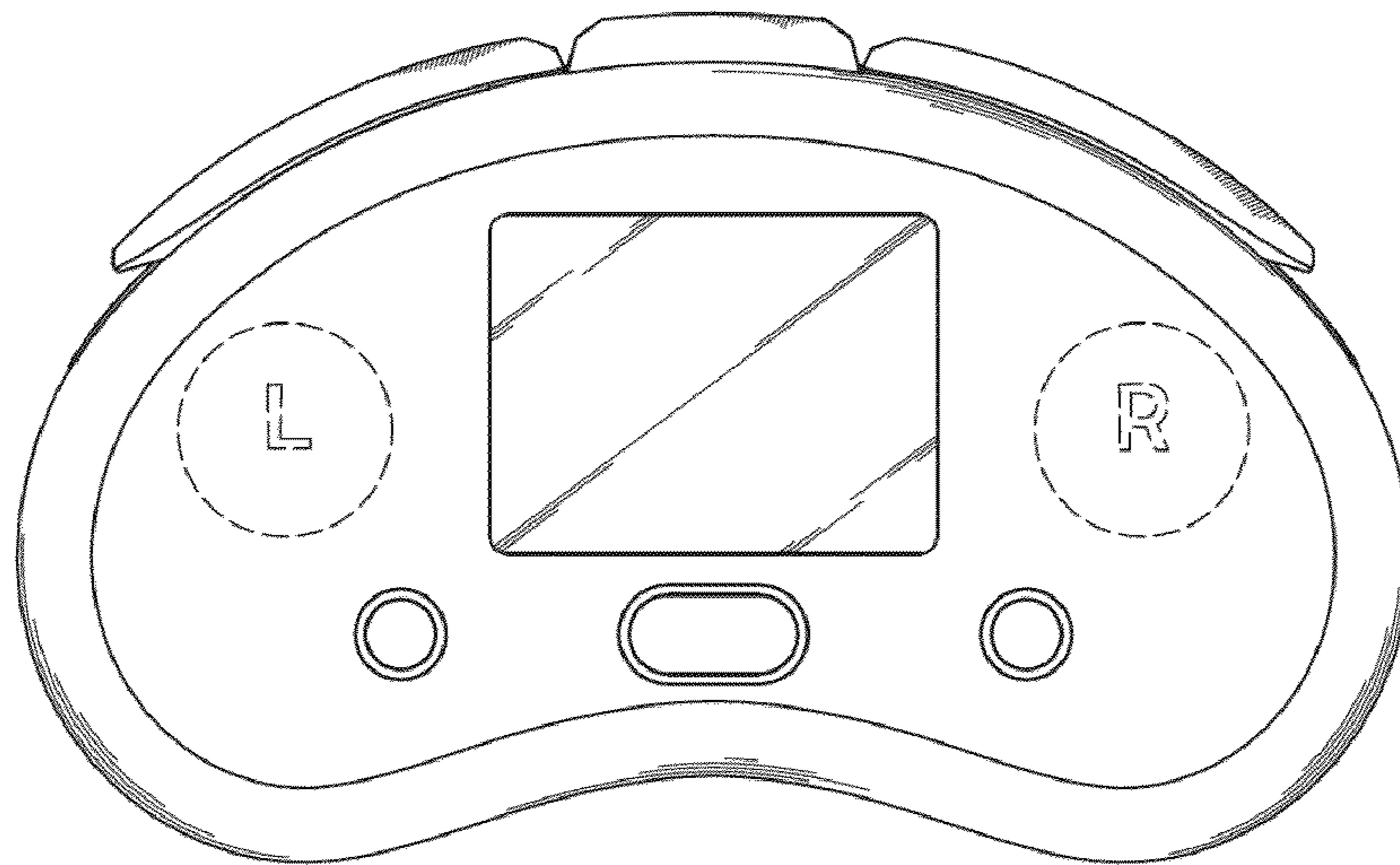
