(57) **CLAIM**

The ornamental design for a centrifuge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a centrifuge showing our new design.

FIG. 2 is a front elevation view of the centrifuge of FIG. 1.

FIG. 3 is a back elevation view of the centrifuge of FIG. 1.

FIG. 4 is a right elevation view of the centrifuge of FIG. 1.

FIG. 5 is a left elevation view of the centrifuge of FIG. 1.

FIG. 6 is a top plan view of the centrifuge of FIG. 1; and,

FIG. 7 is a bottom plan view of the centrifuge of FIG. 1.

The broken lines depict portions of the centrifuge that form no part of the claimed design.

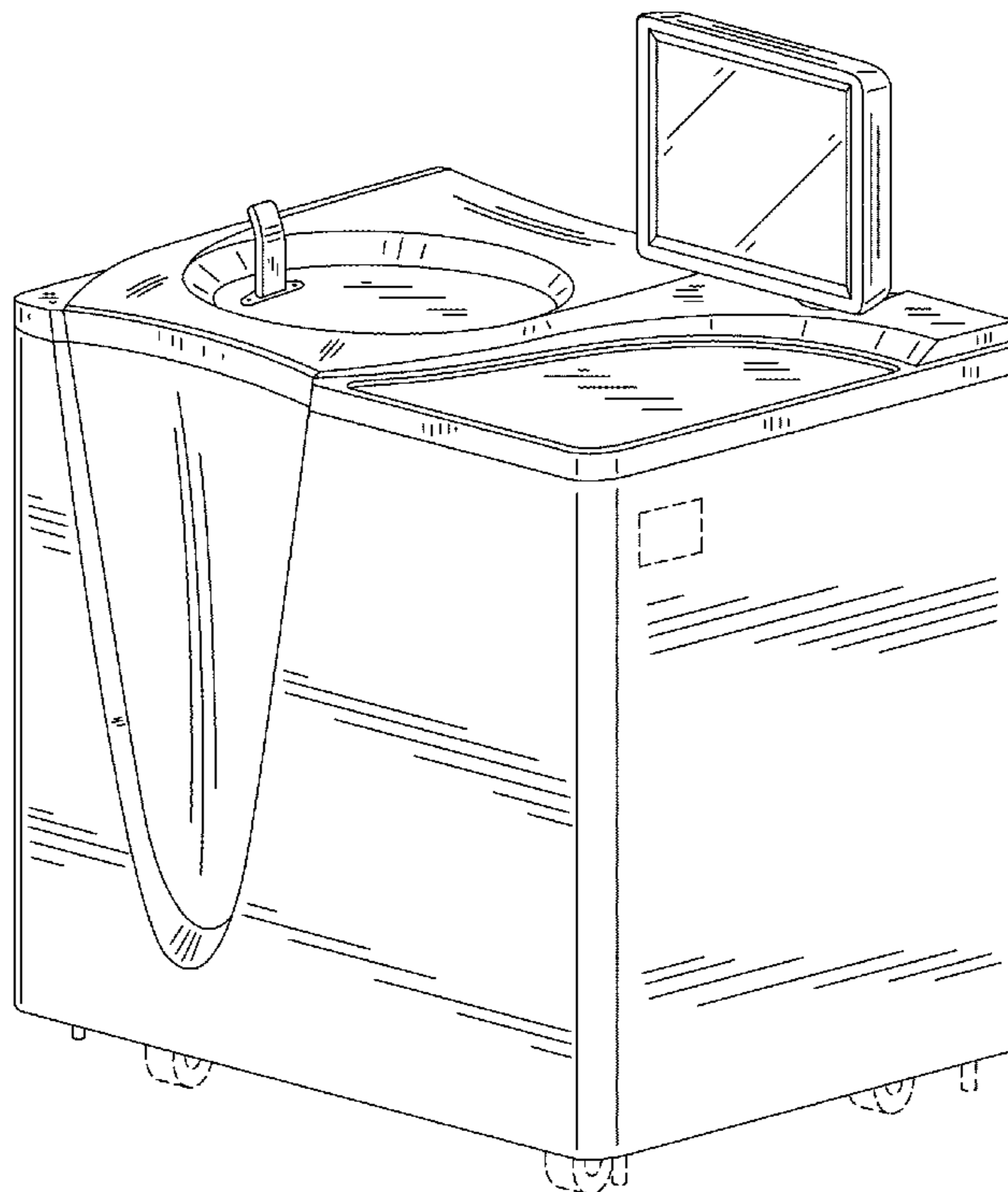

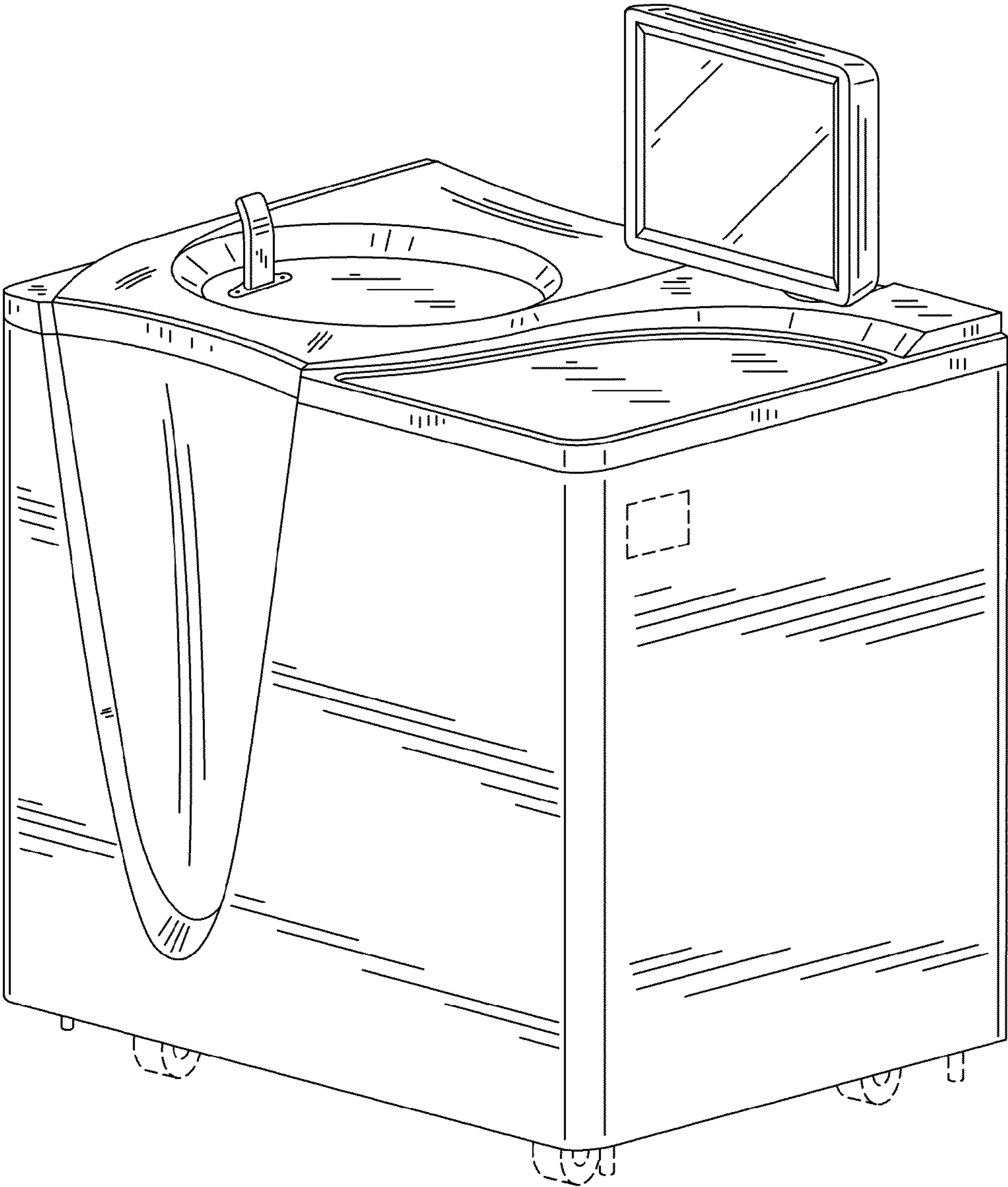

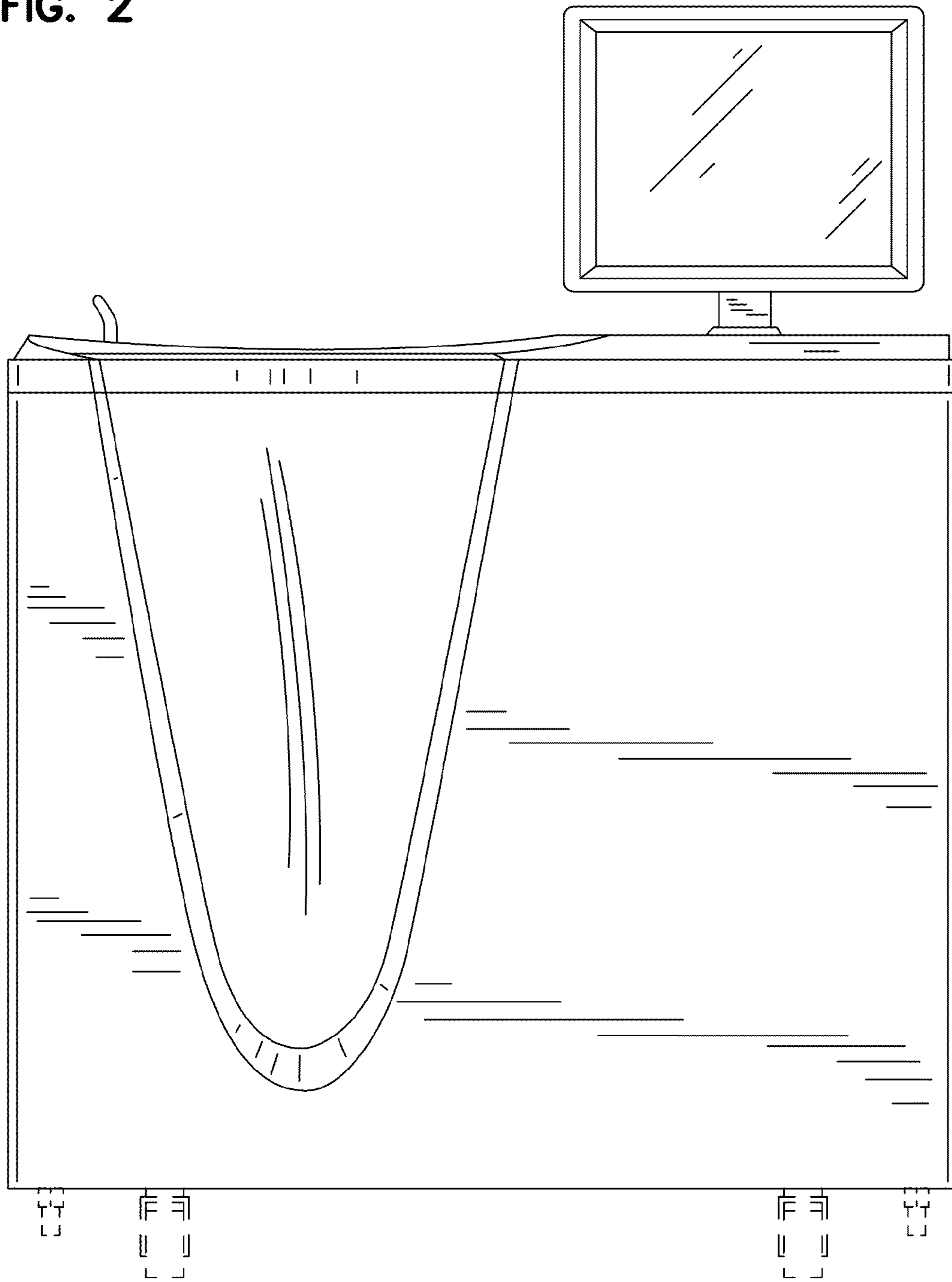

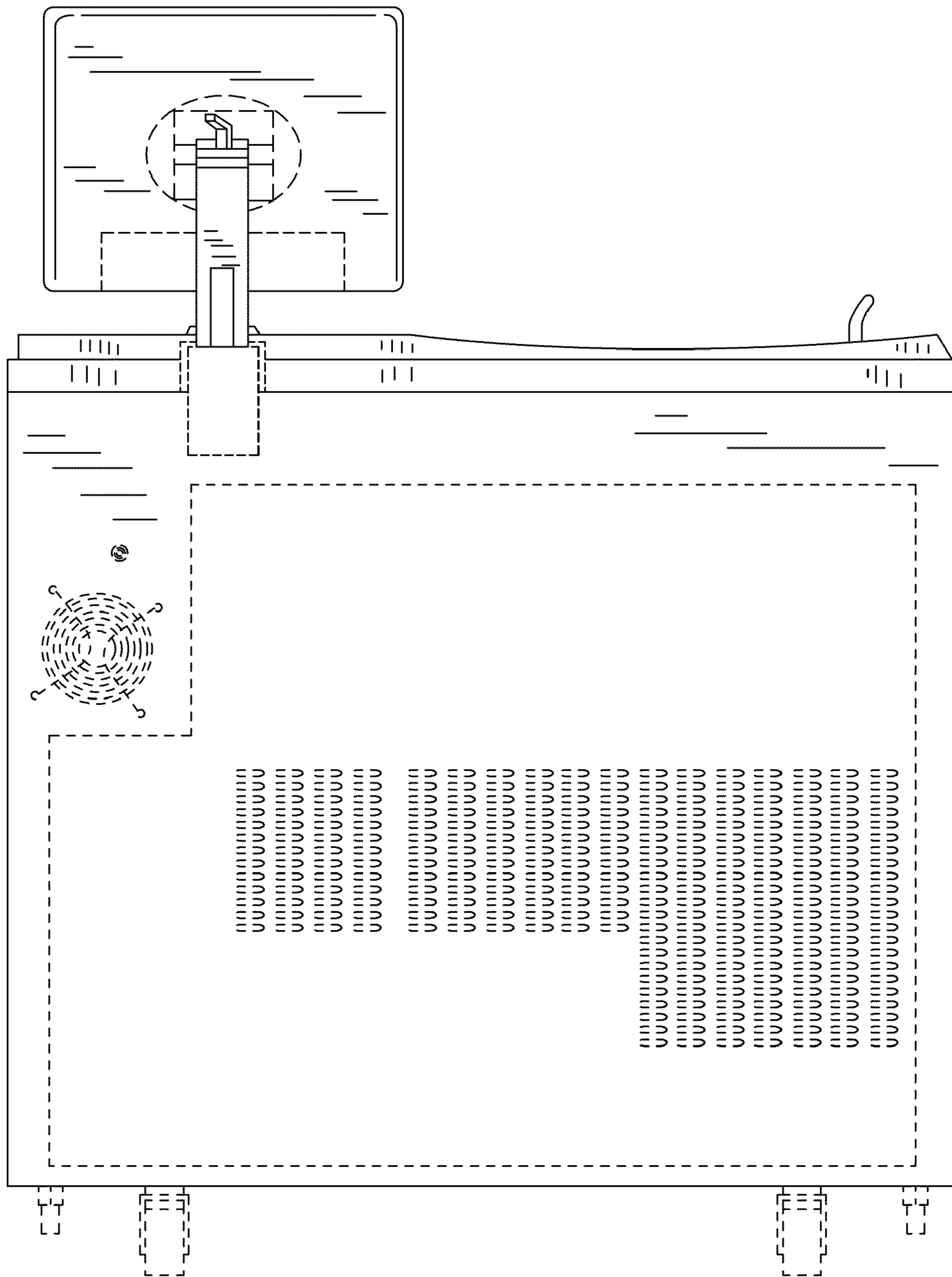

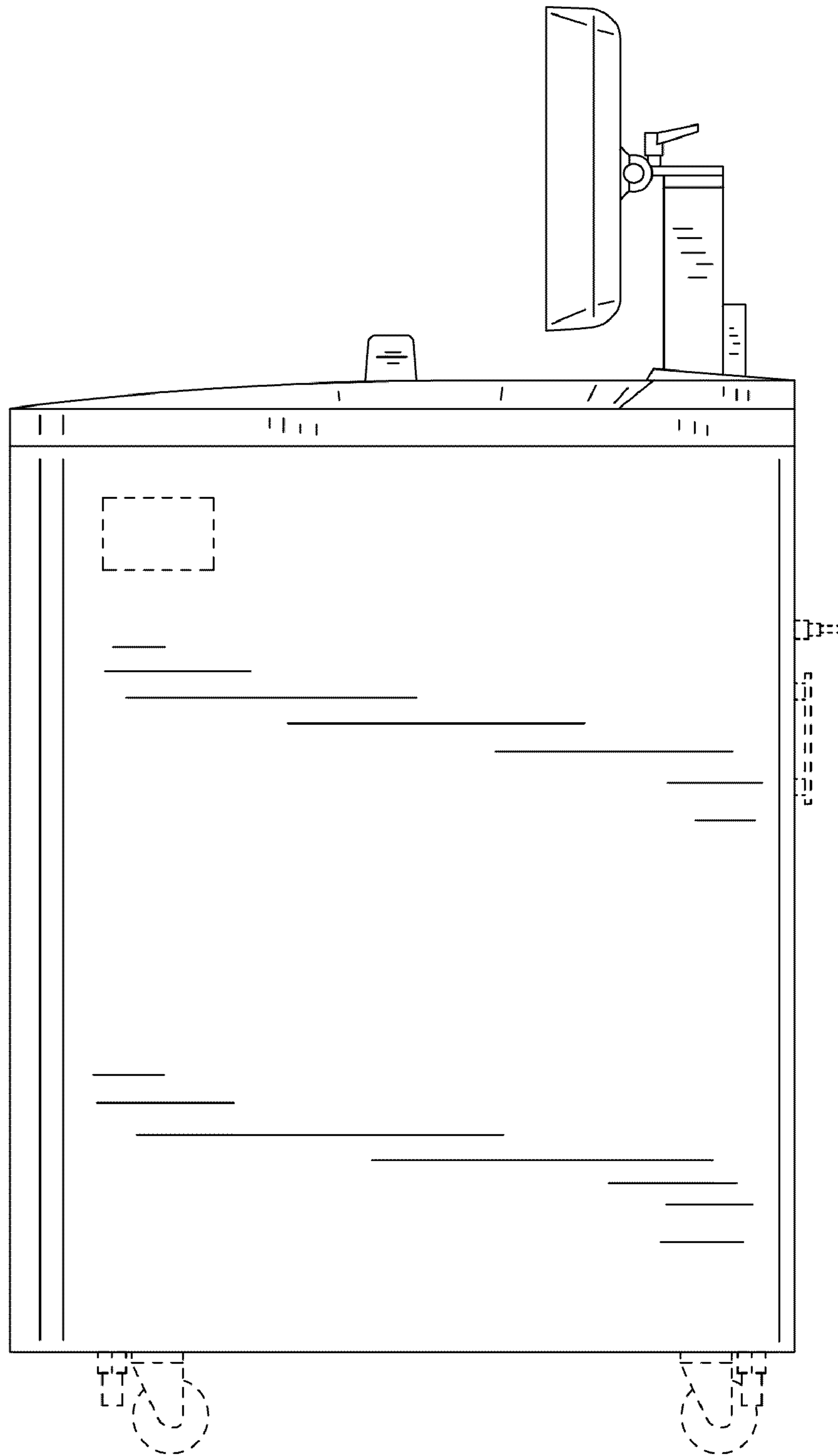
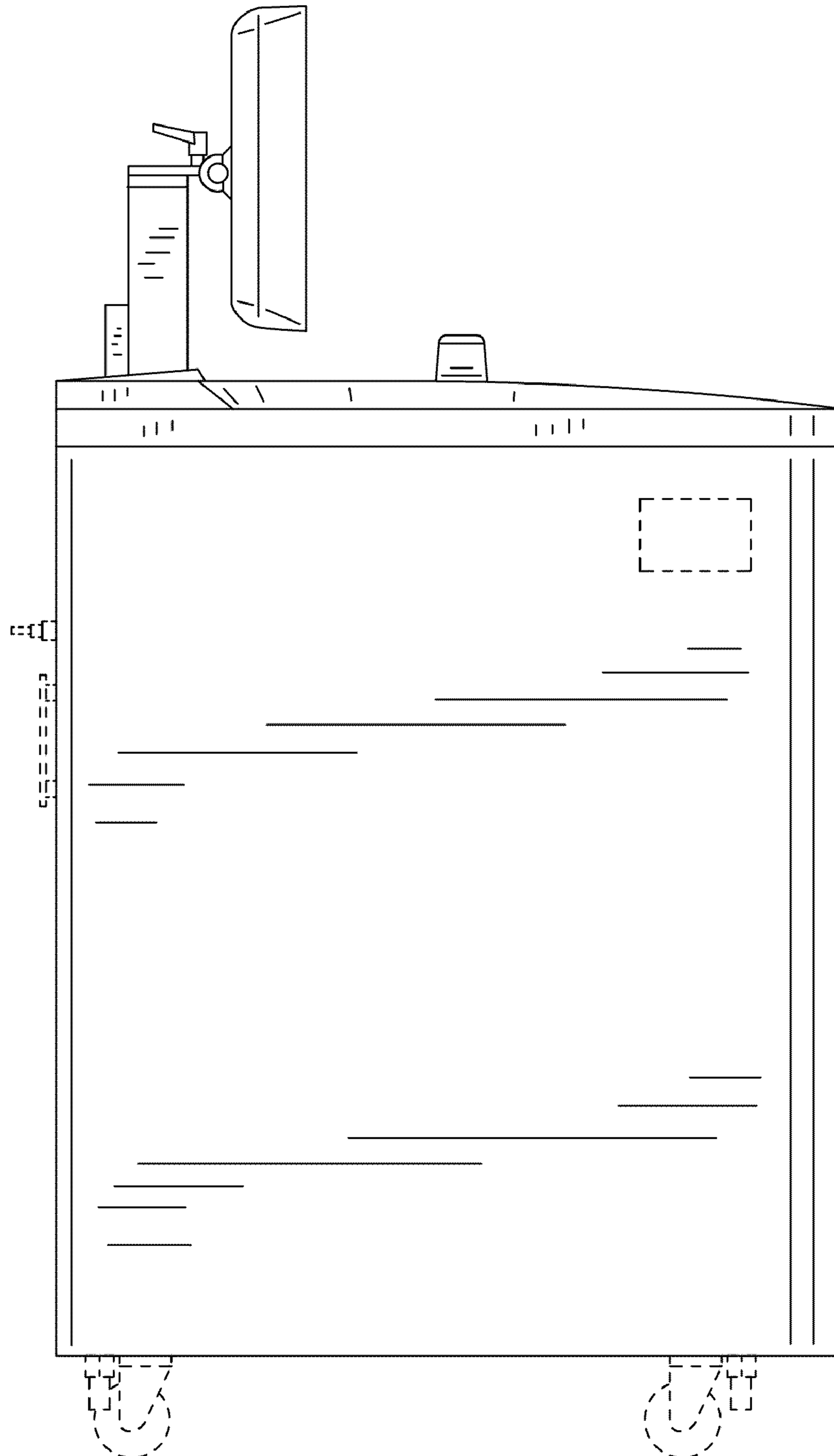

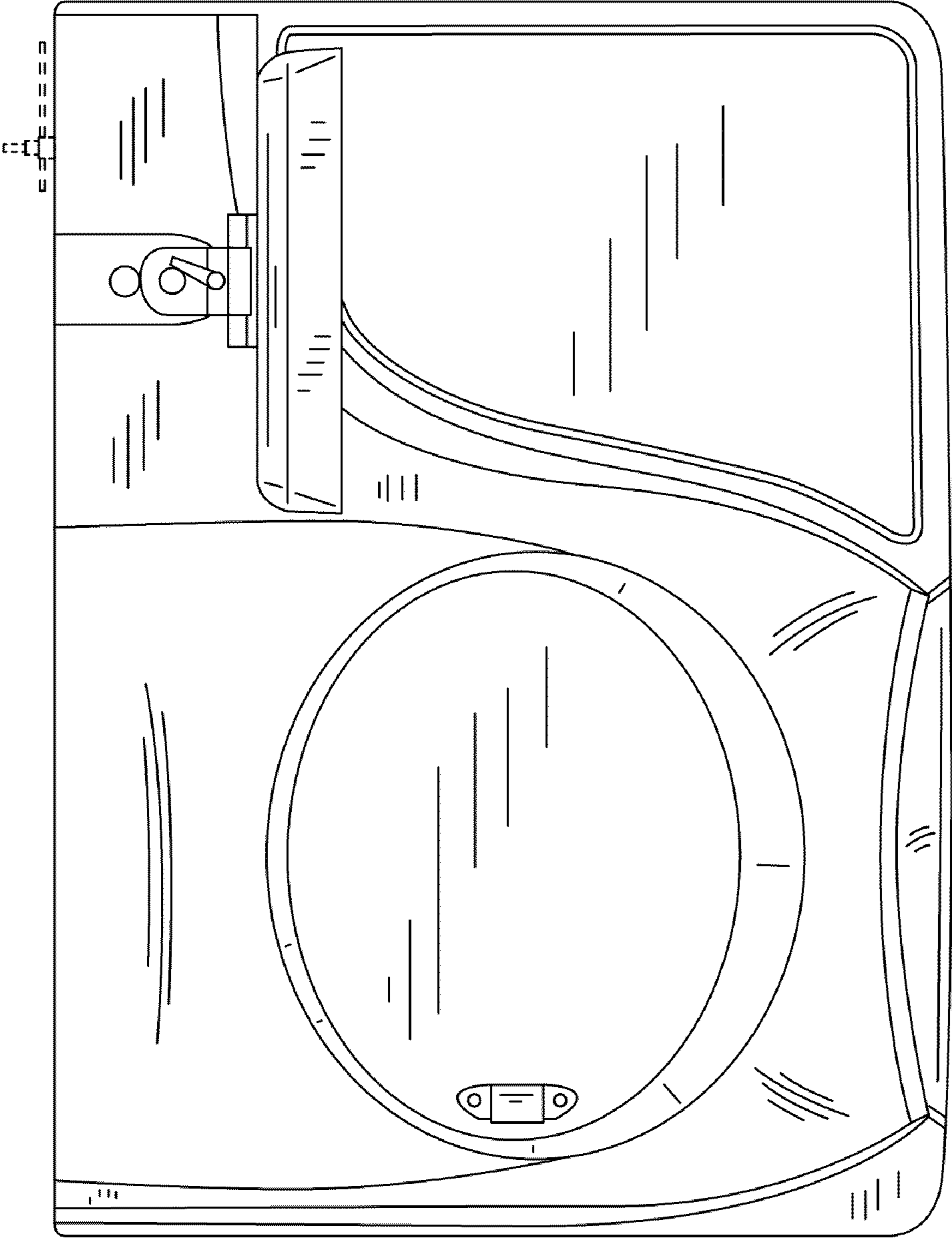

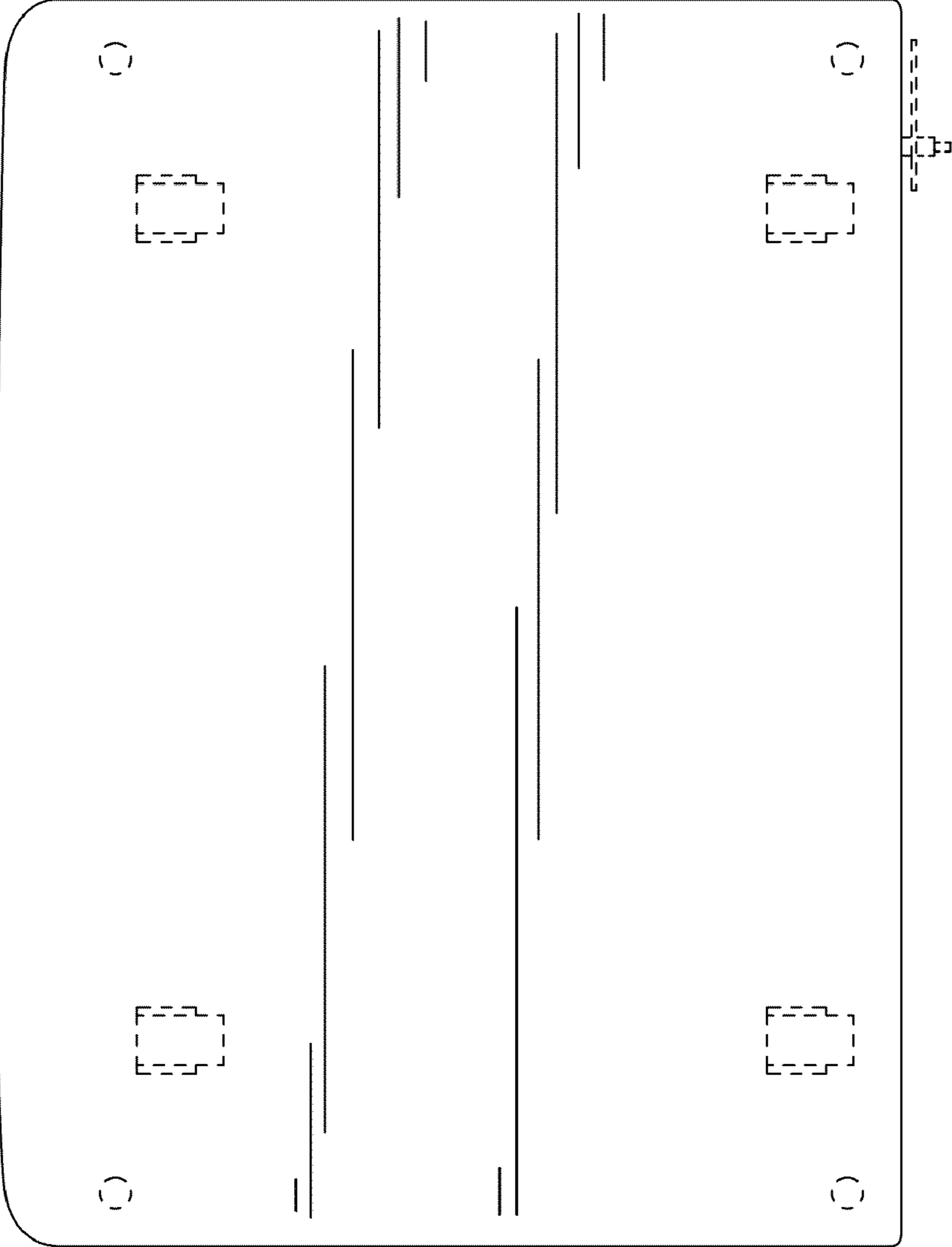
