FIG. 18 is a front elevational view of the short paver;

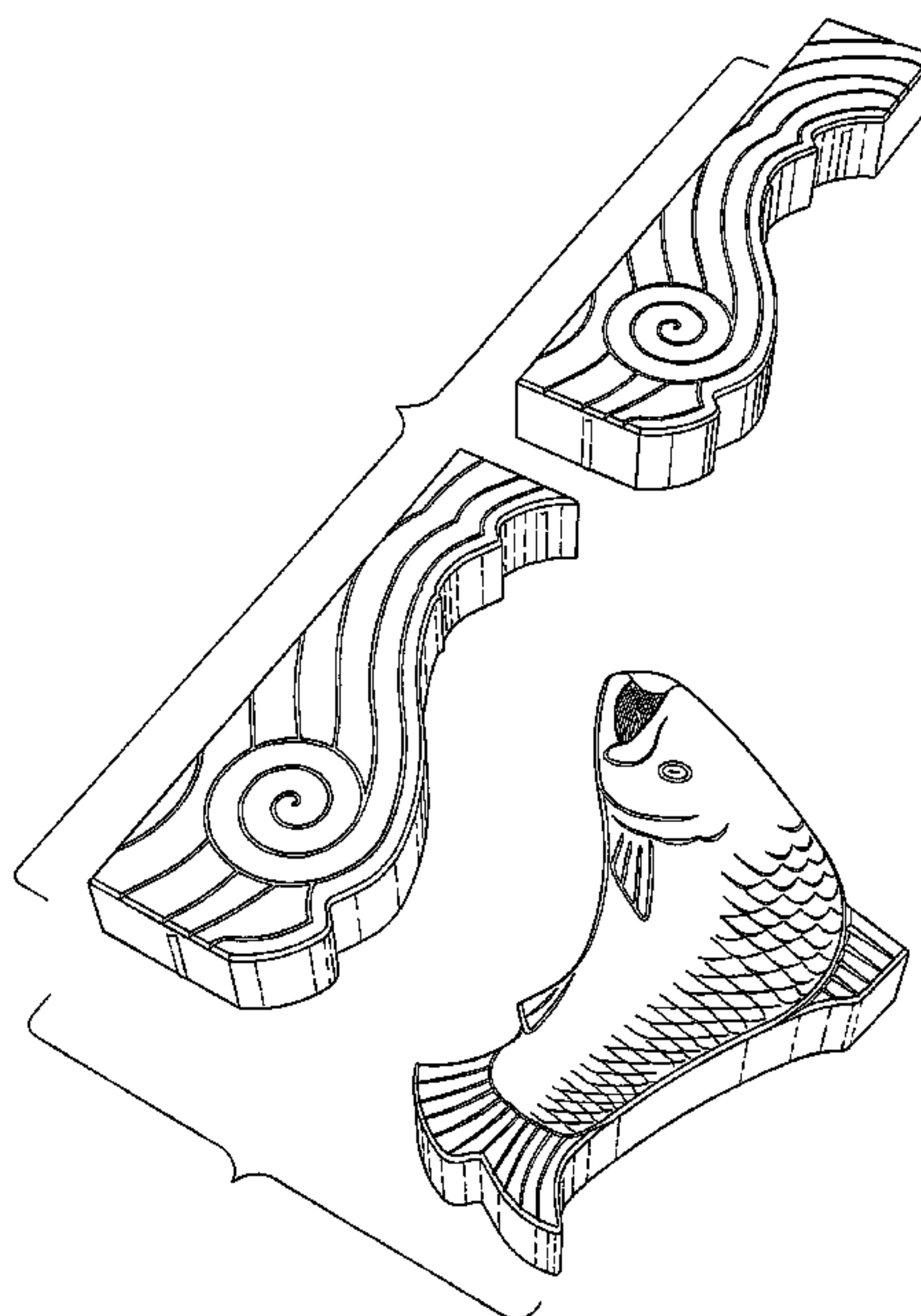
FIG. 19 is a rear elevational view thereof; and,

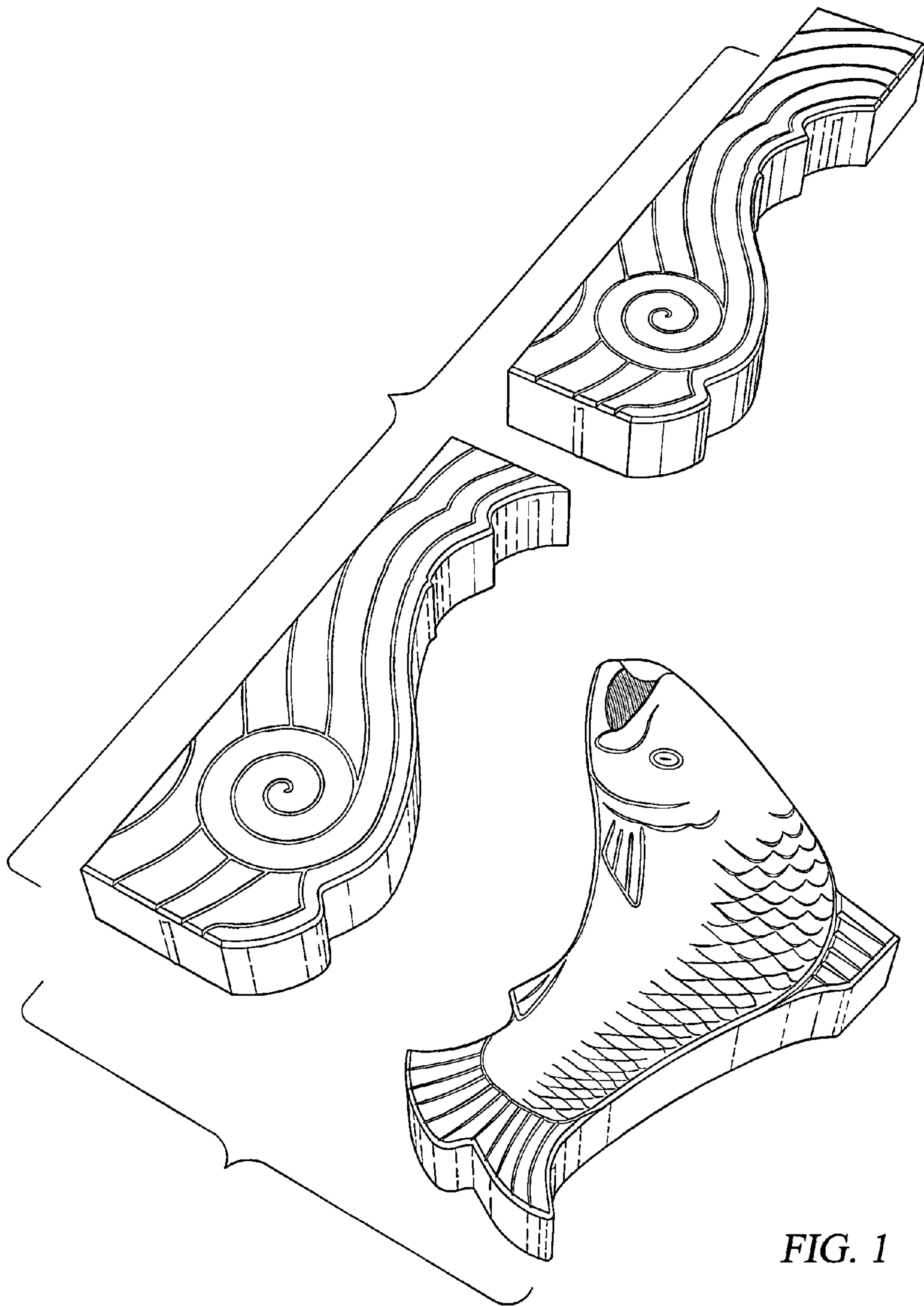

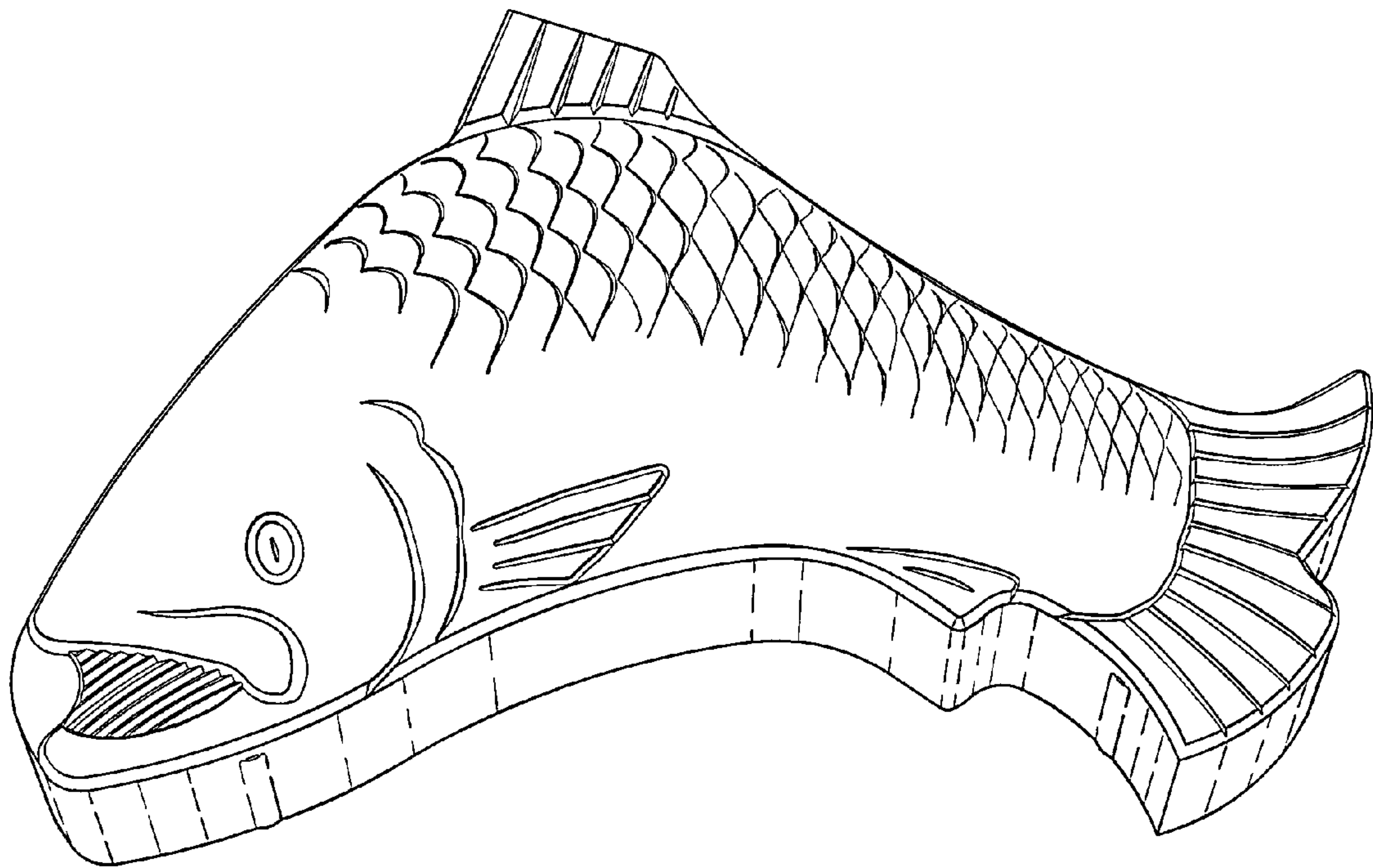

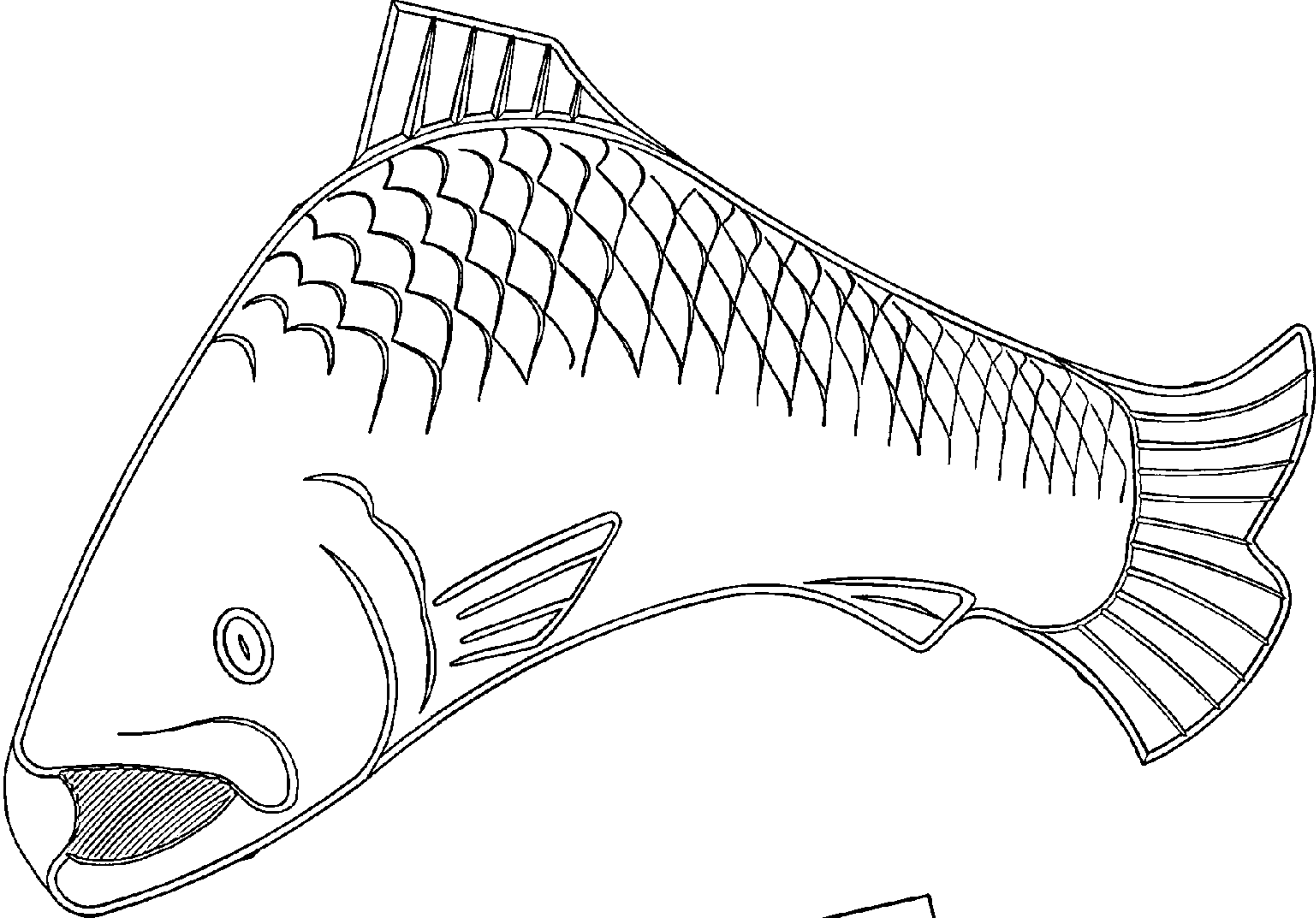

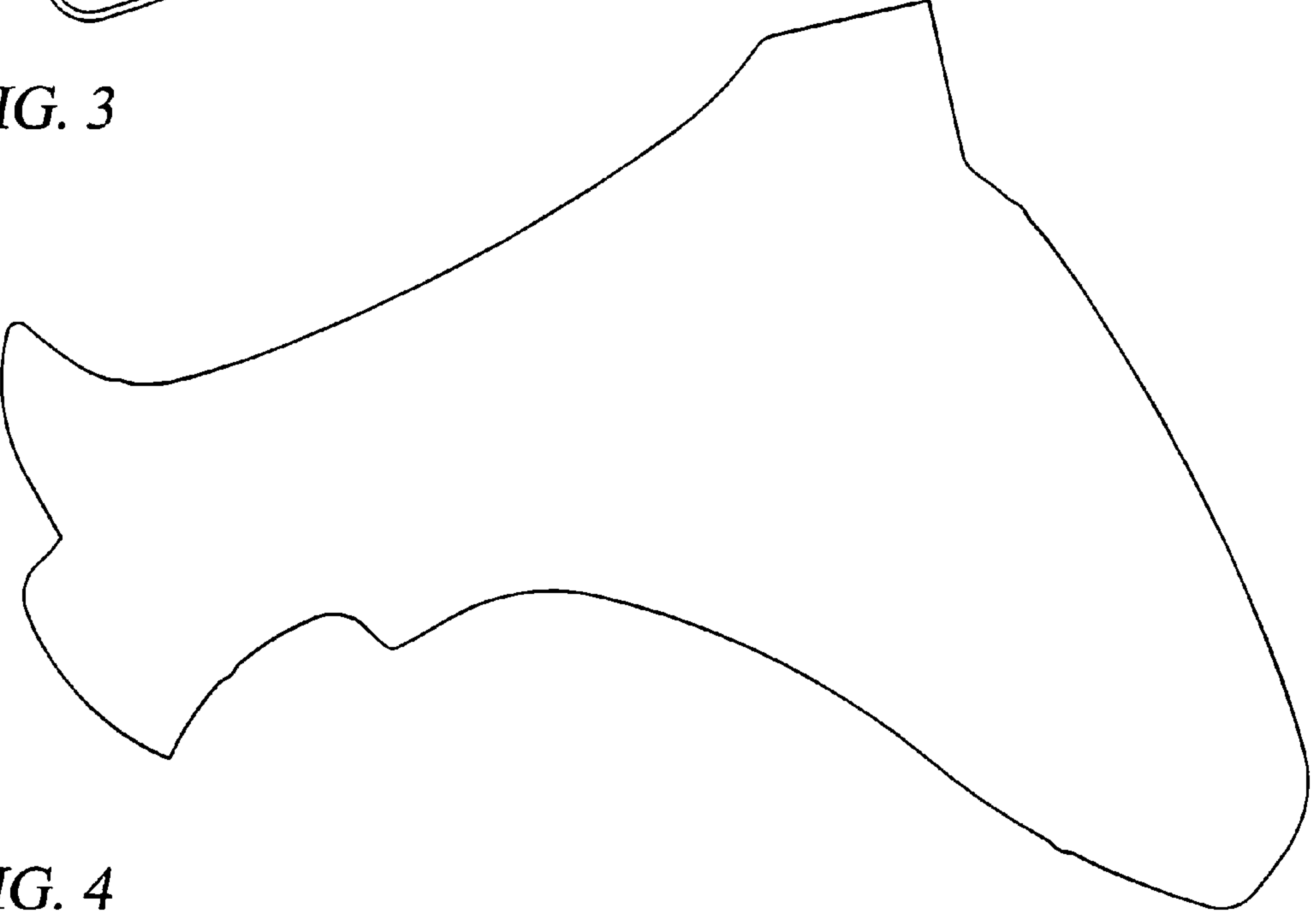

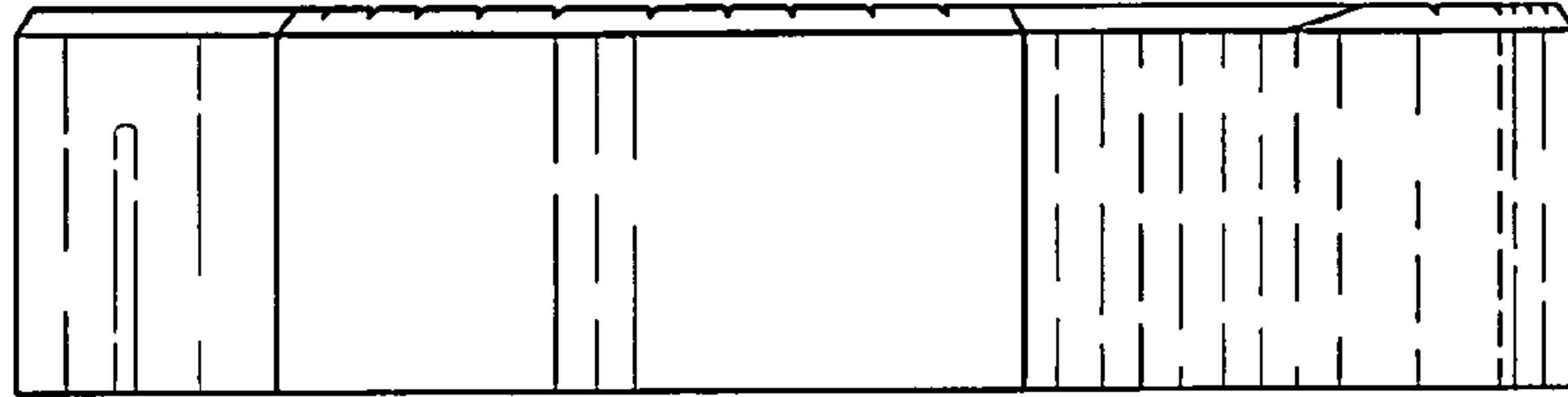

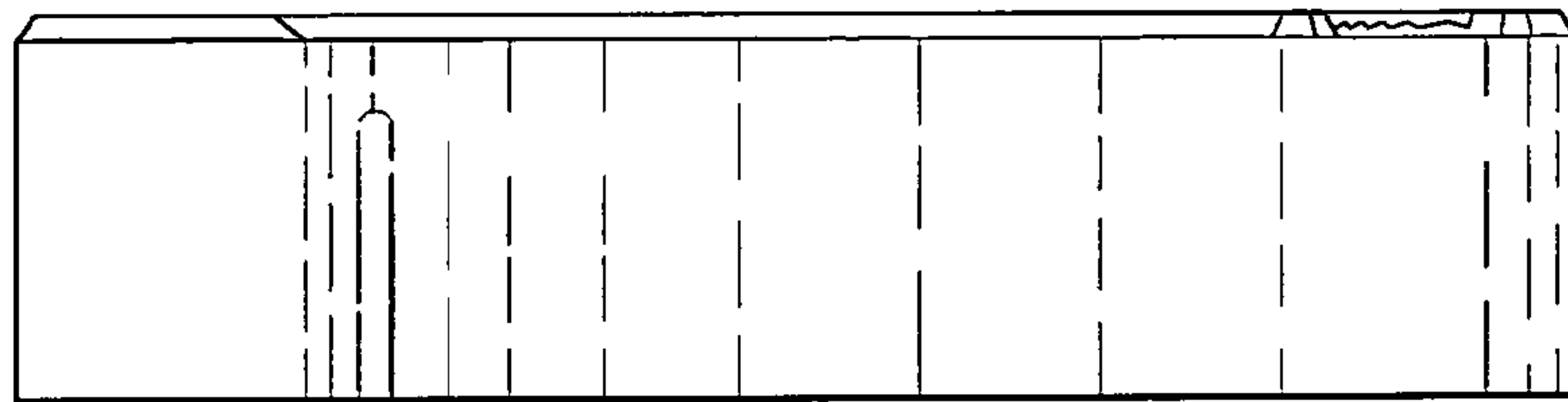

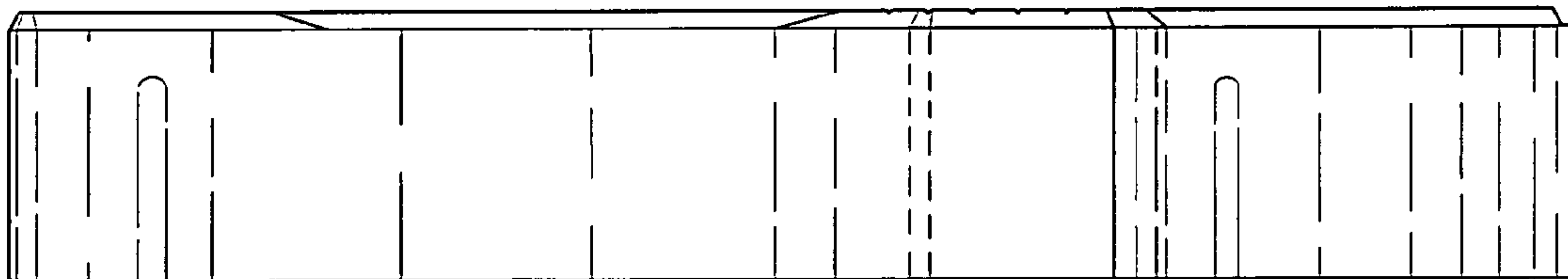

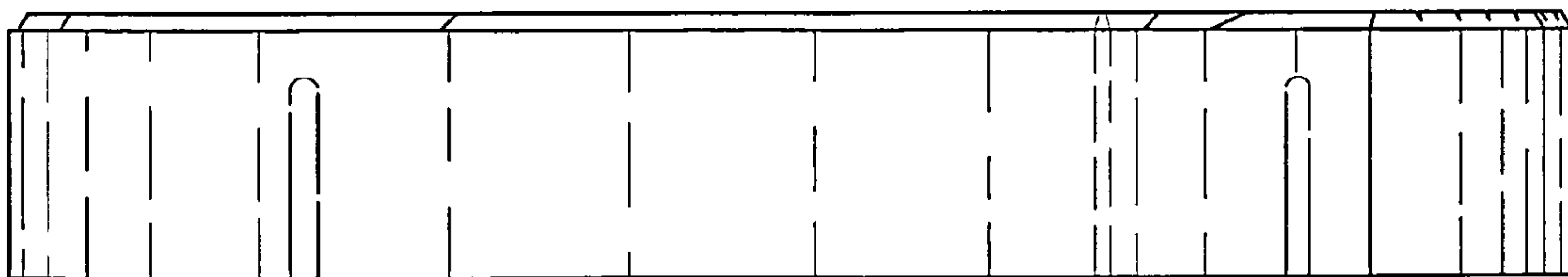

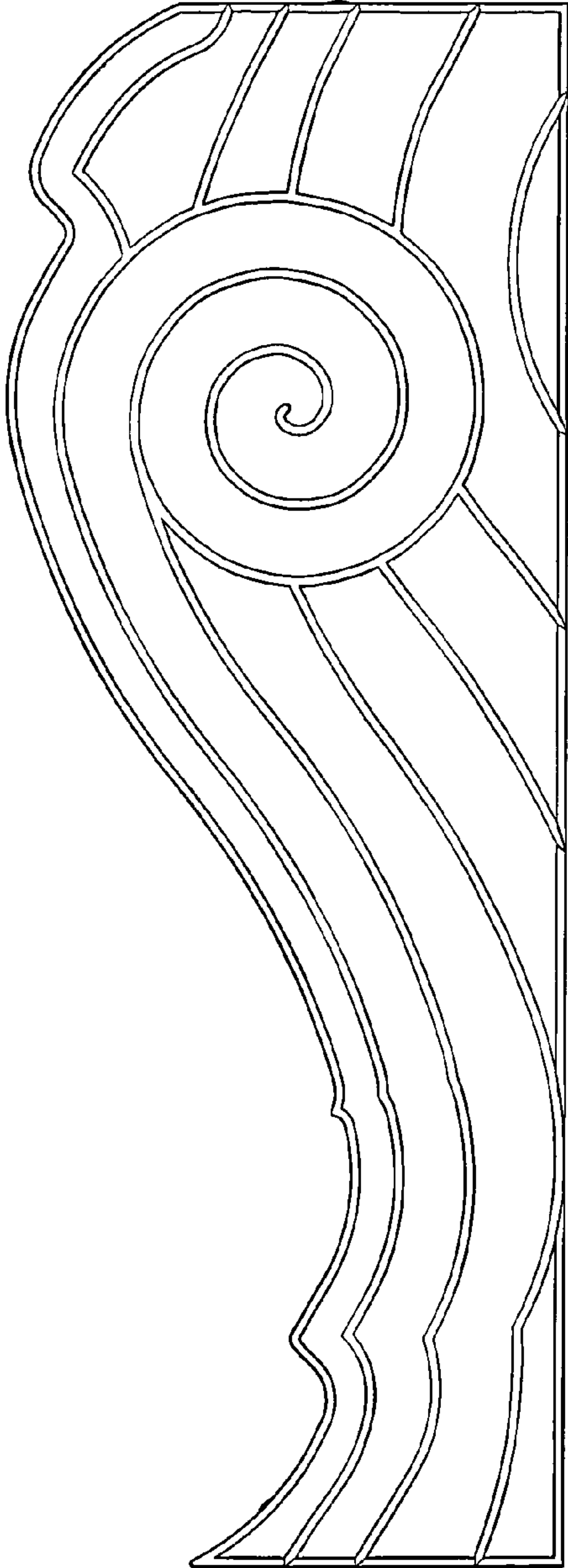

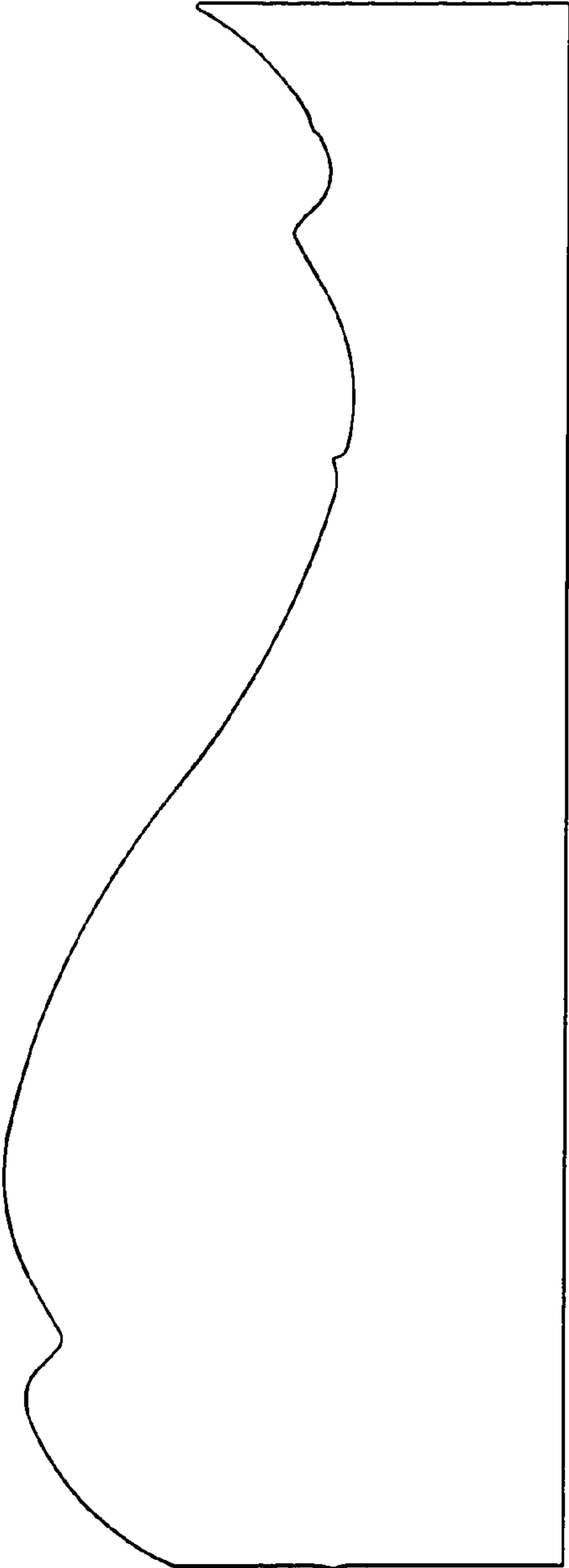

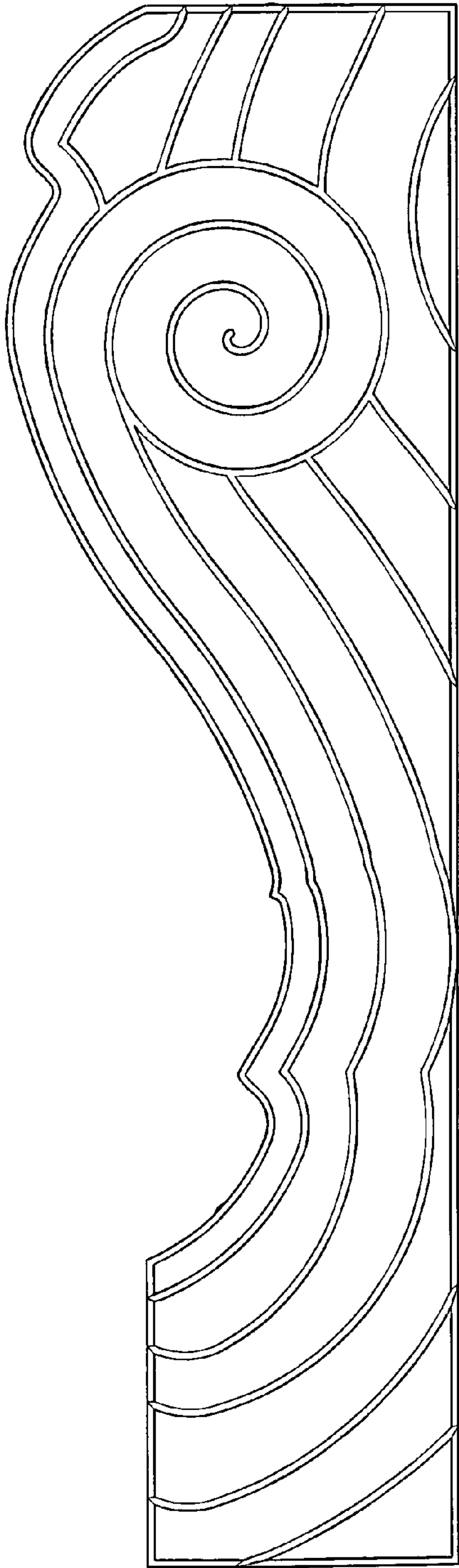

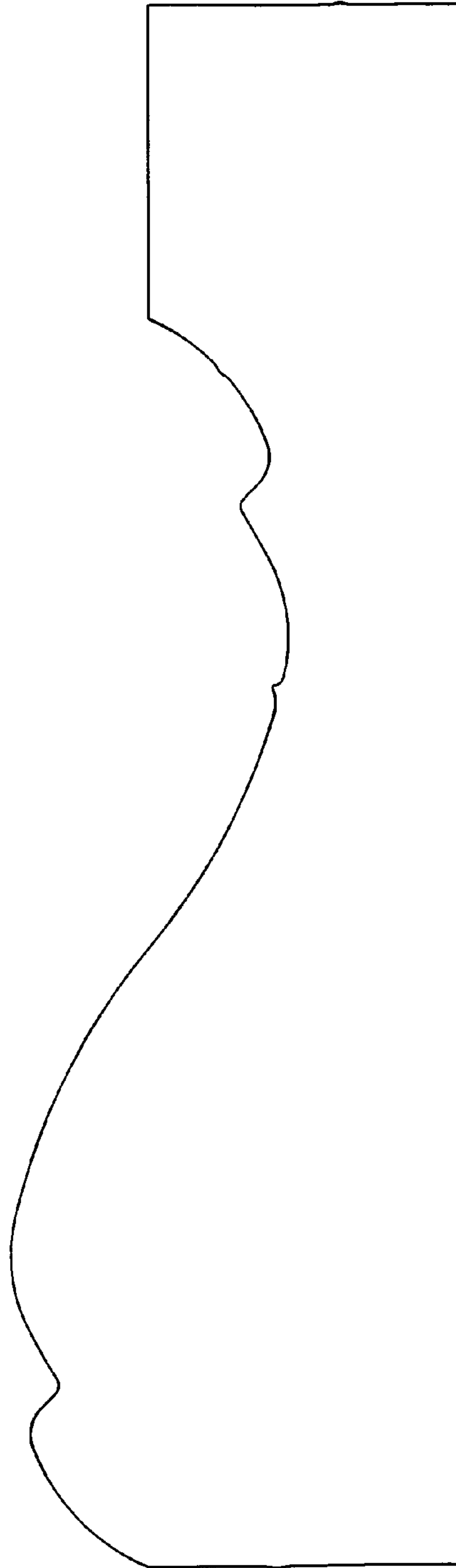

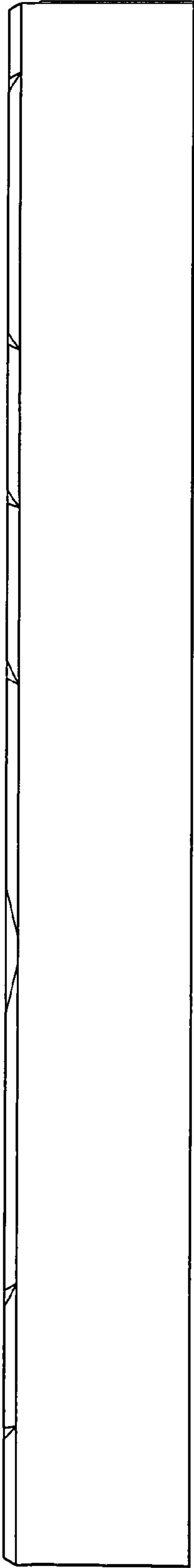

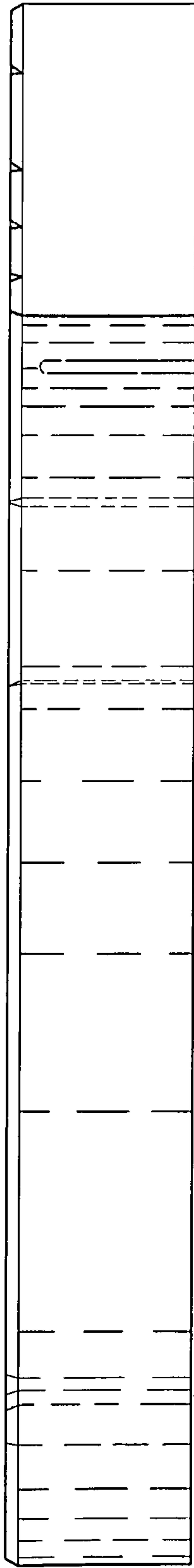

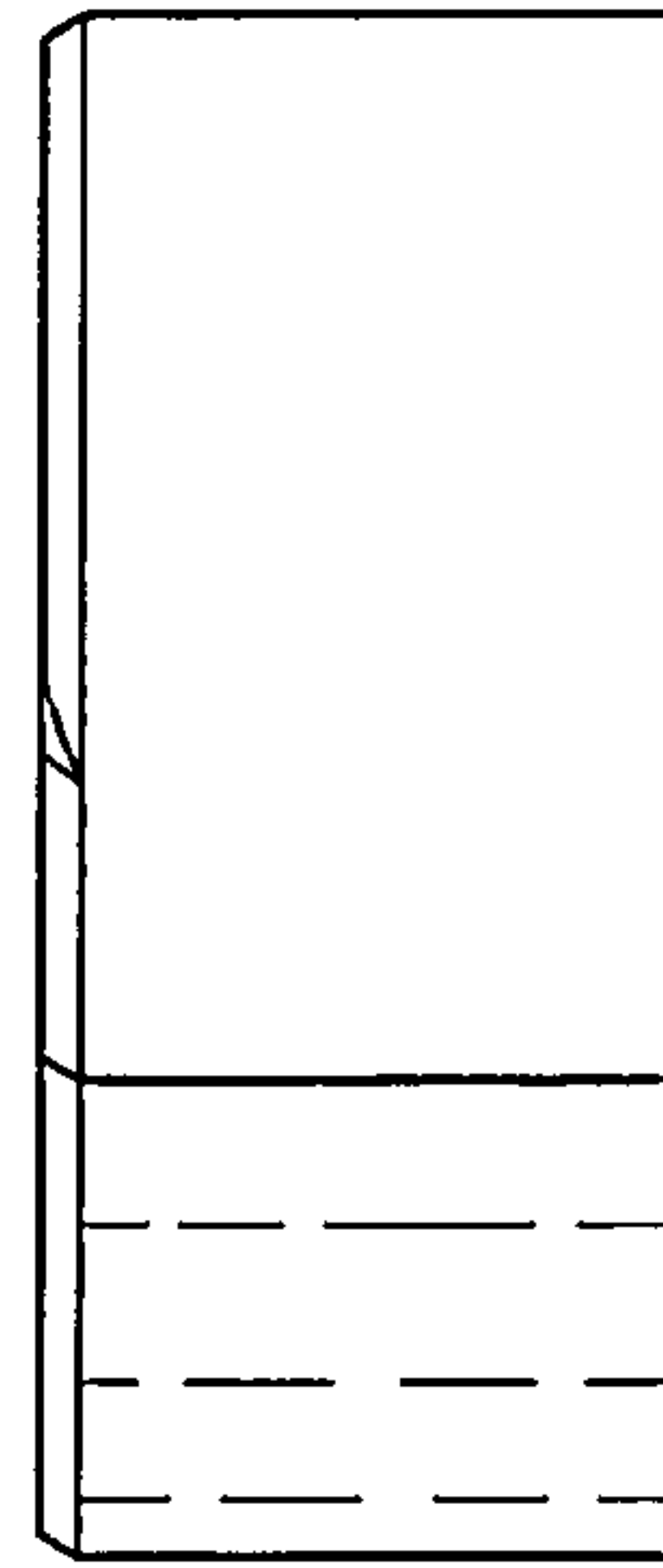

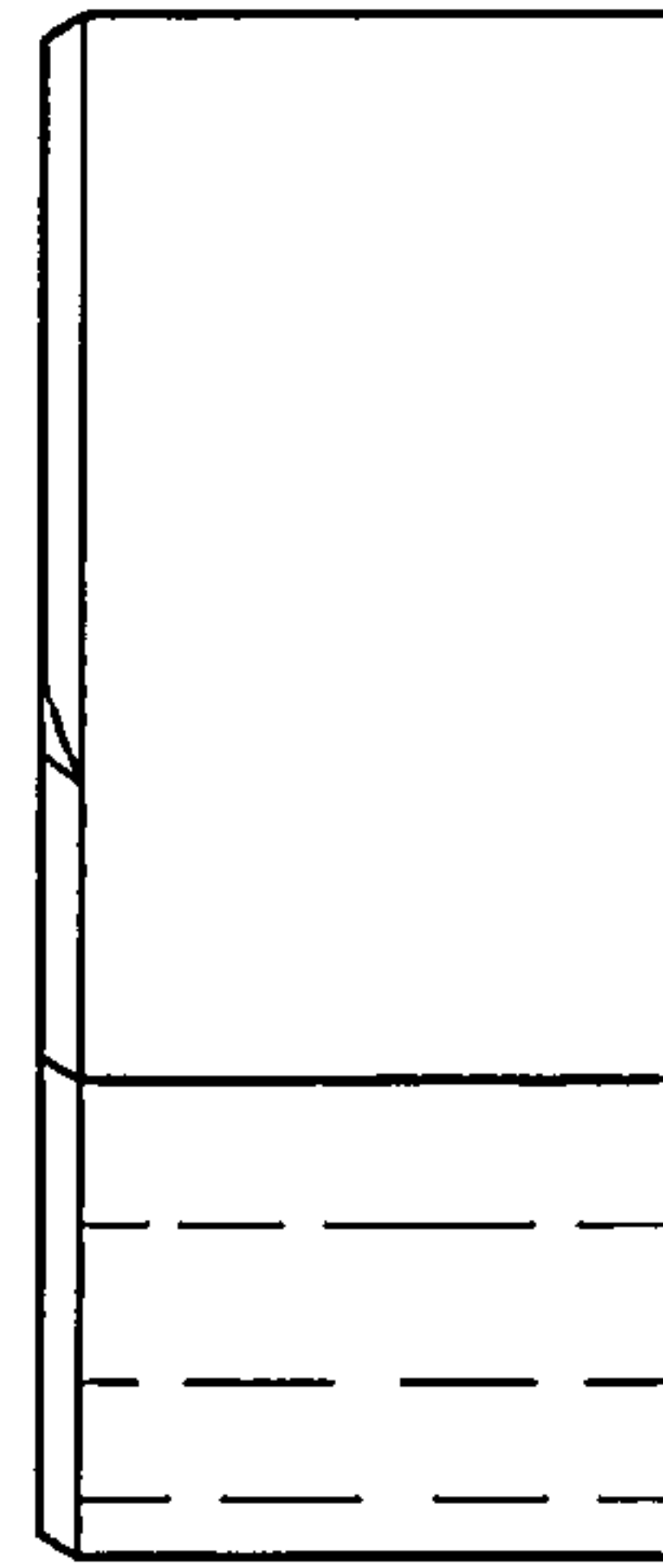

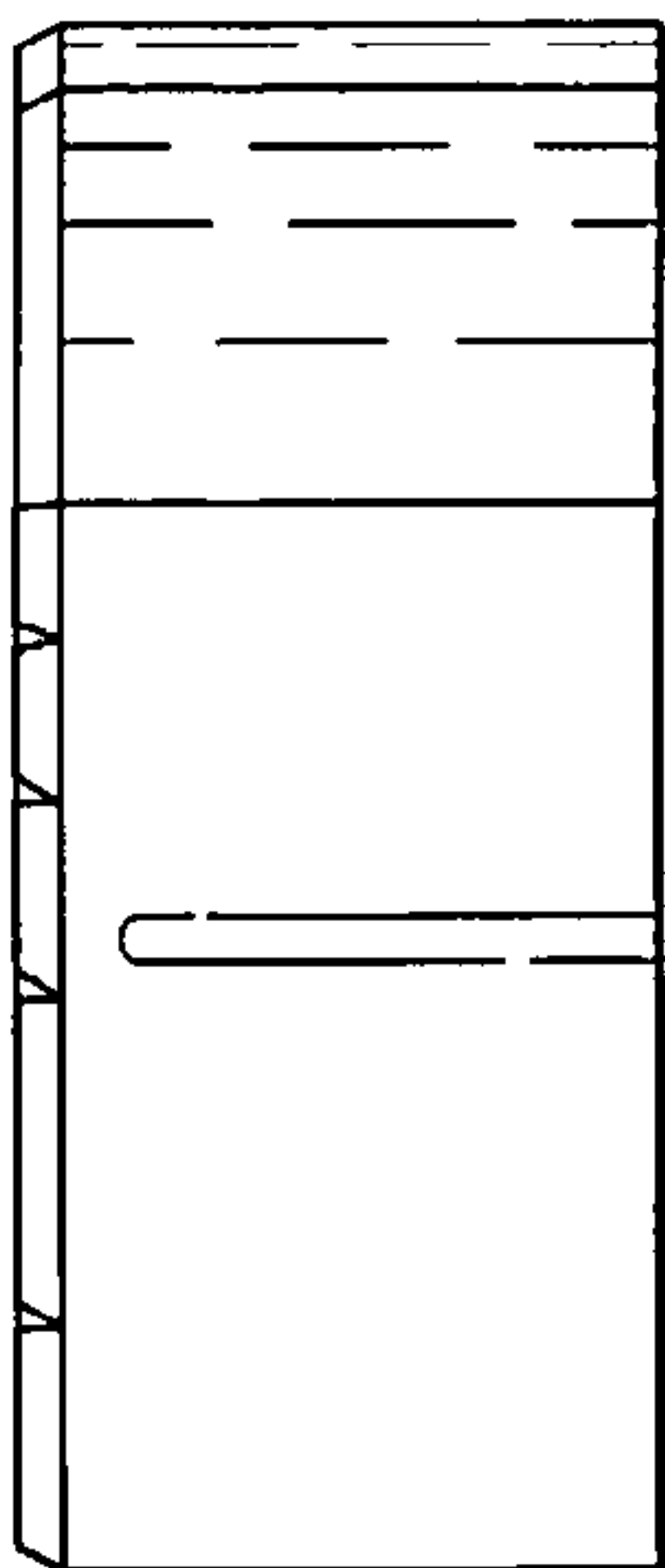

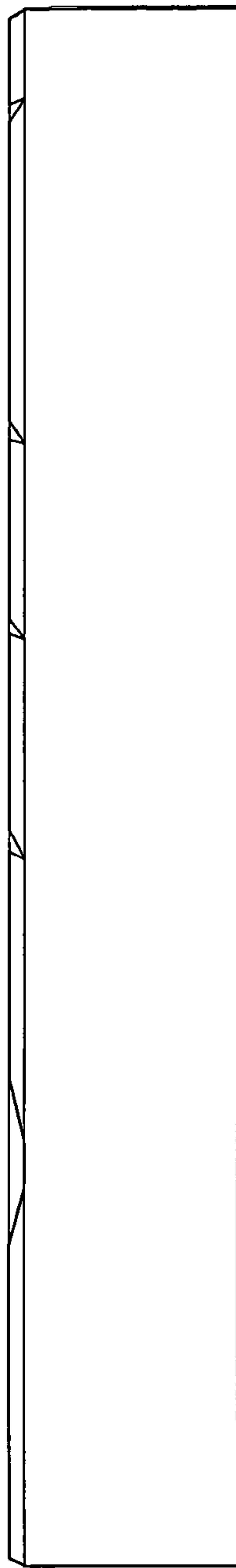

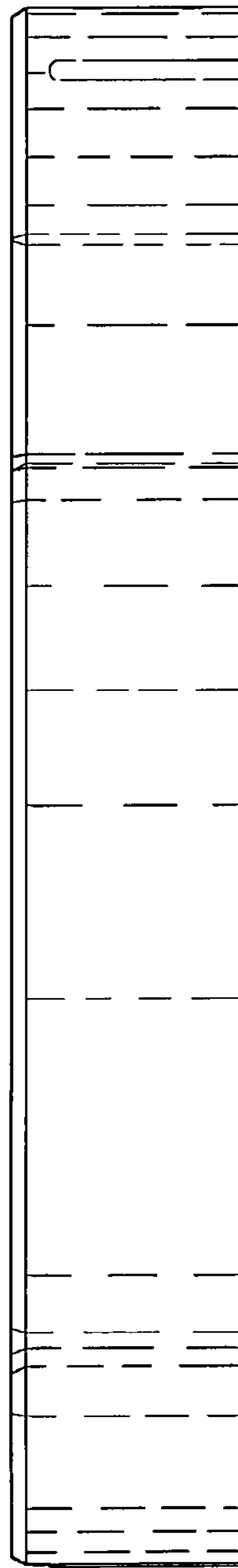

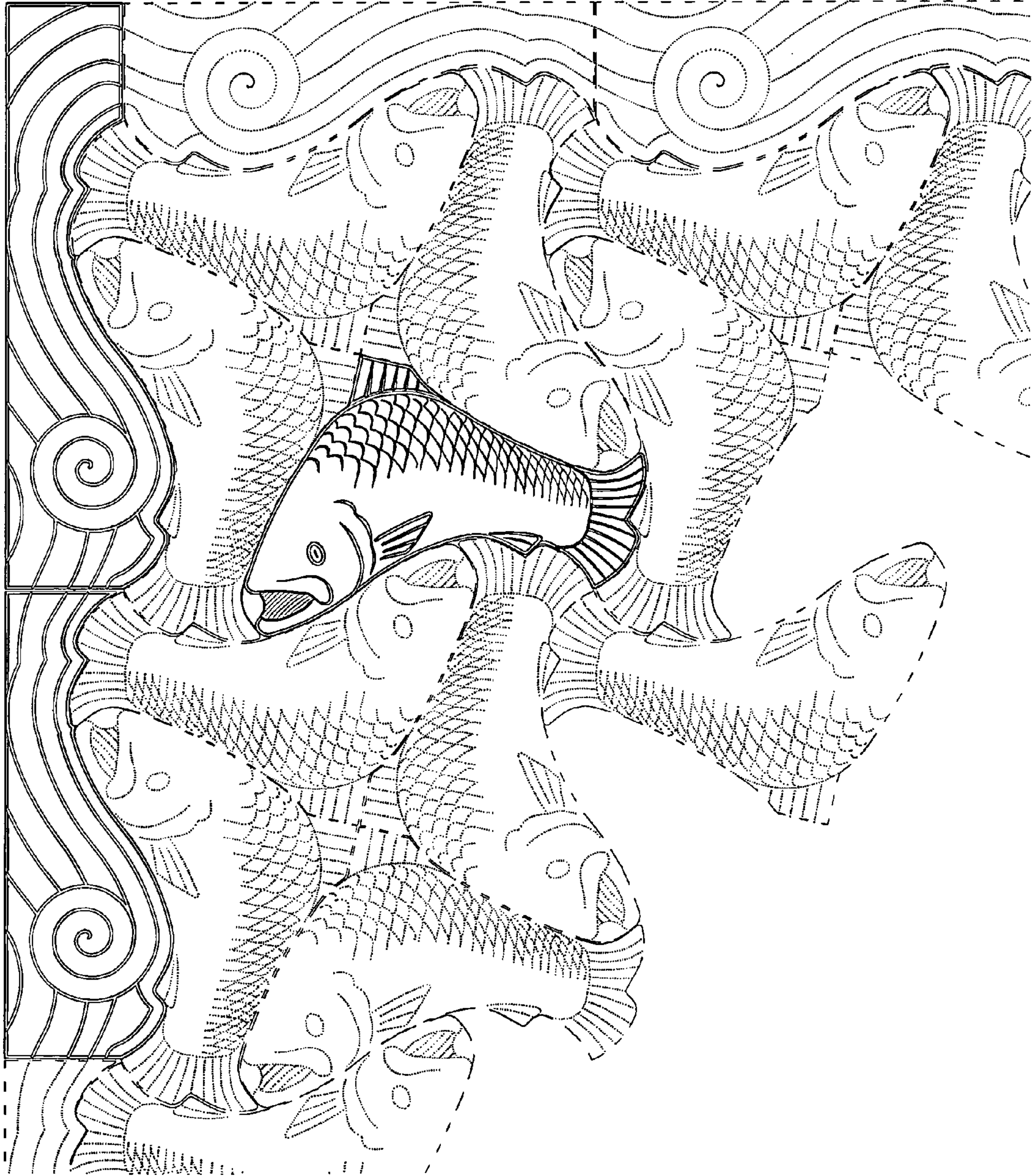
