(57) **CLAIM**

I claim the ornamental design for a tile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tile;
FIG. 2 is a front view of the claimed design;
FIG. 3 is a rear view of the claimed design;
FIG. 4 is a left side view of the claimed design;
FIG. 5 is a right side view of the claimed design;
FIG. 6 is a top plan view of the claimed design; and
FIG. 7 is a bottom plan view of the claimed design.
The plane of the claimed design is formed with minute irregularities, thereby providing a texture of roughness.
The claimed design is directed to protect and decorate indoor and outdoor bottoms of buildings and structures.

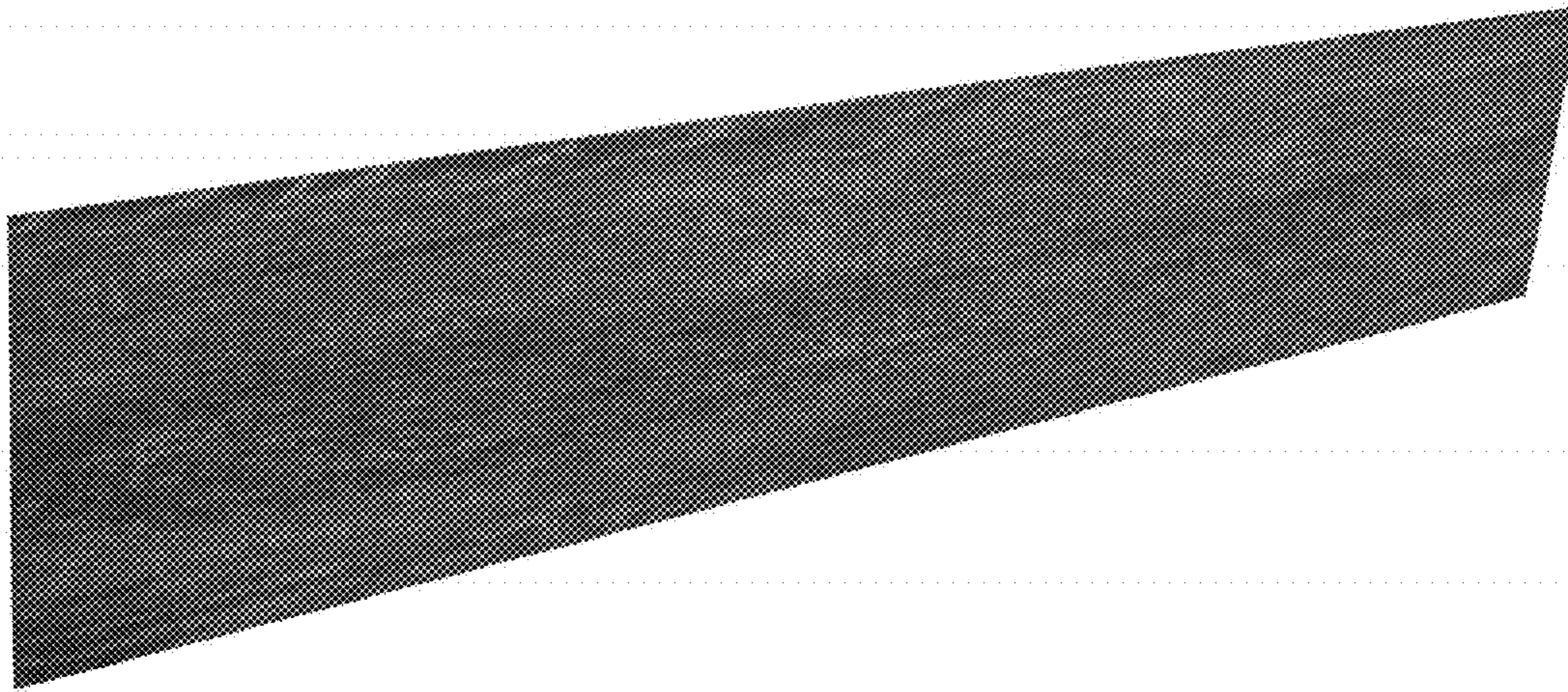

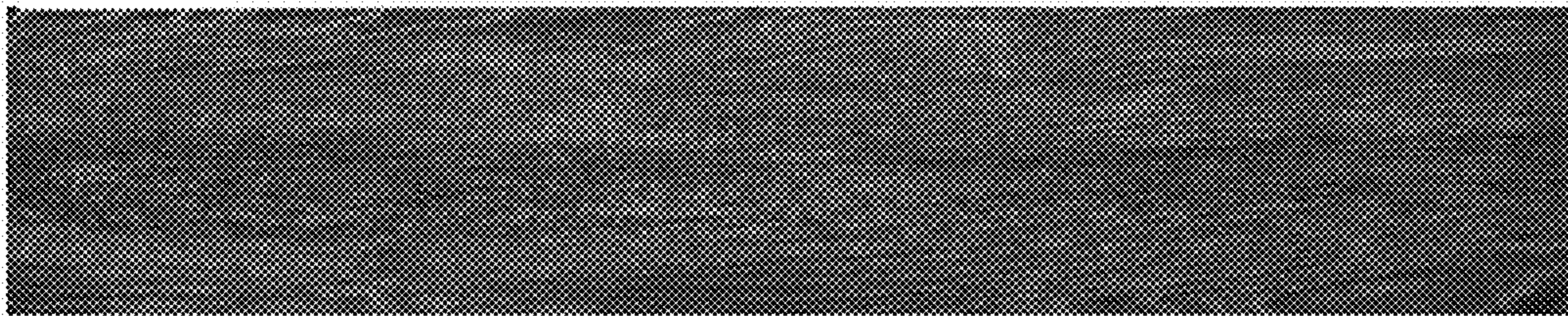

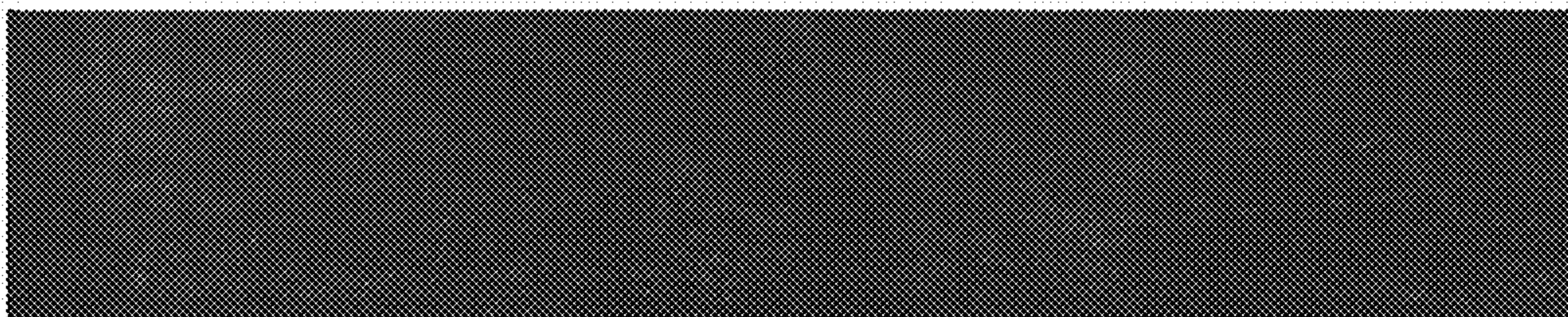

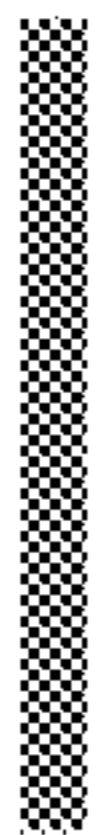
