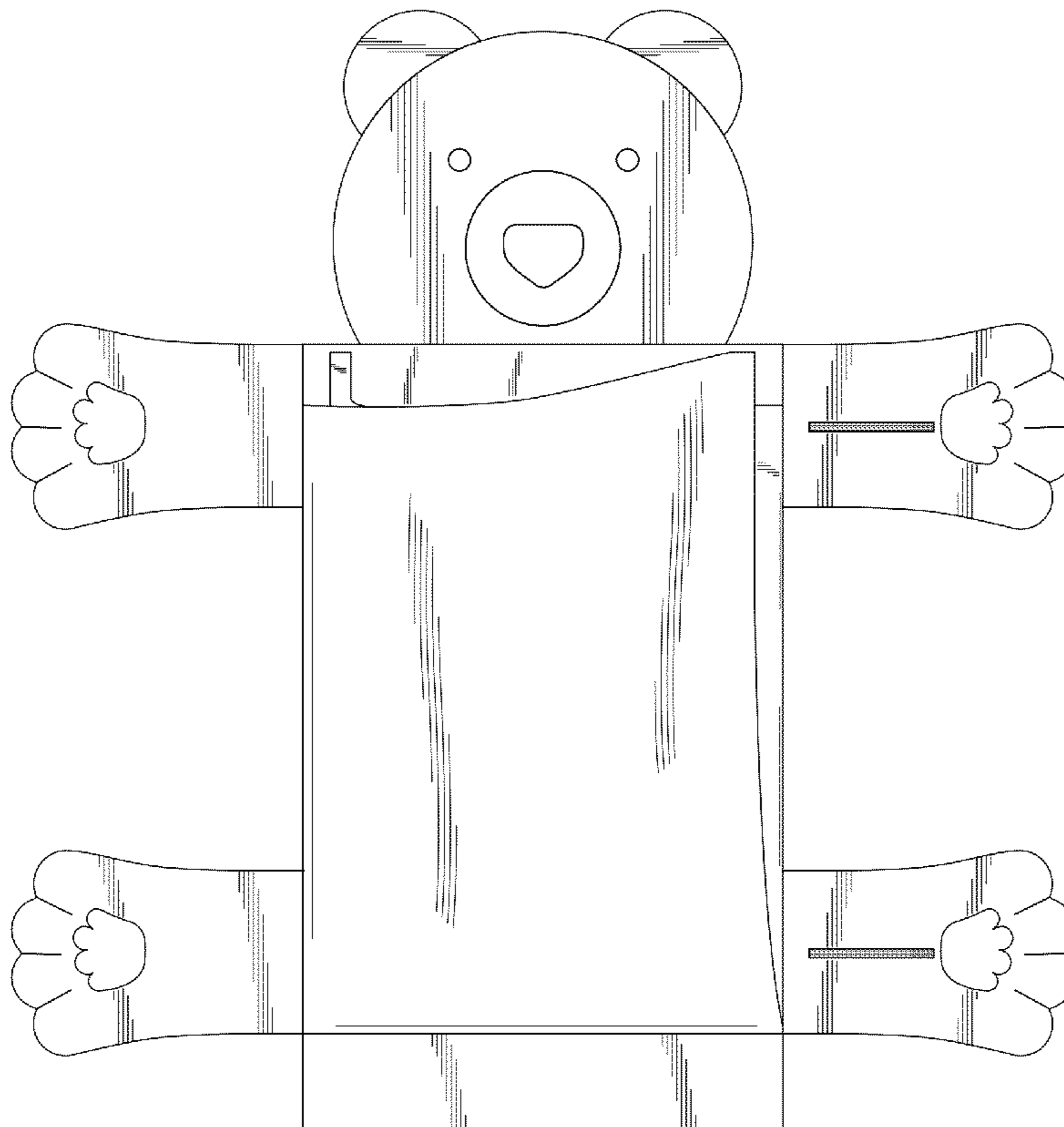
(57) **CLAIM**

The ornamental design for an animal-shaped swaddling blanket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top view of an animal-shaped swaddling blanket, showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a top view thereof depicting interior blanket flaps in a partially unfolded position.

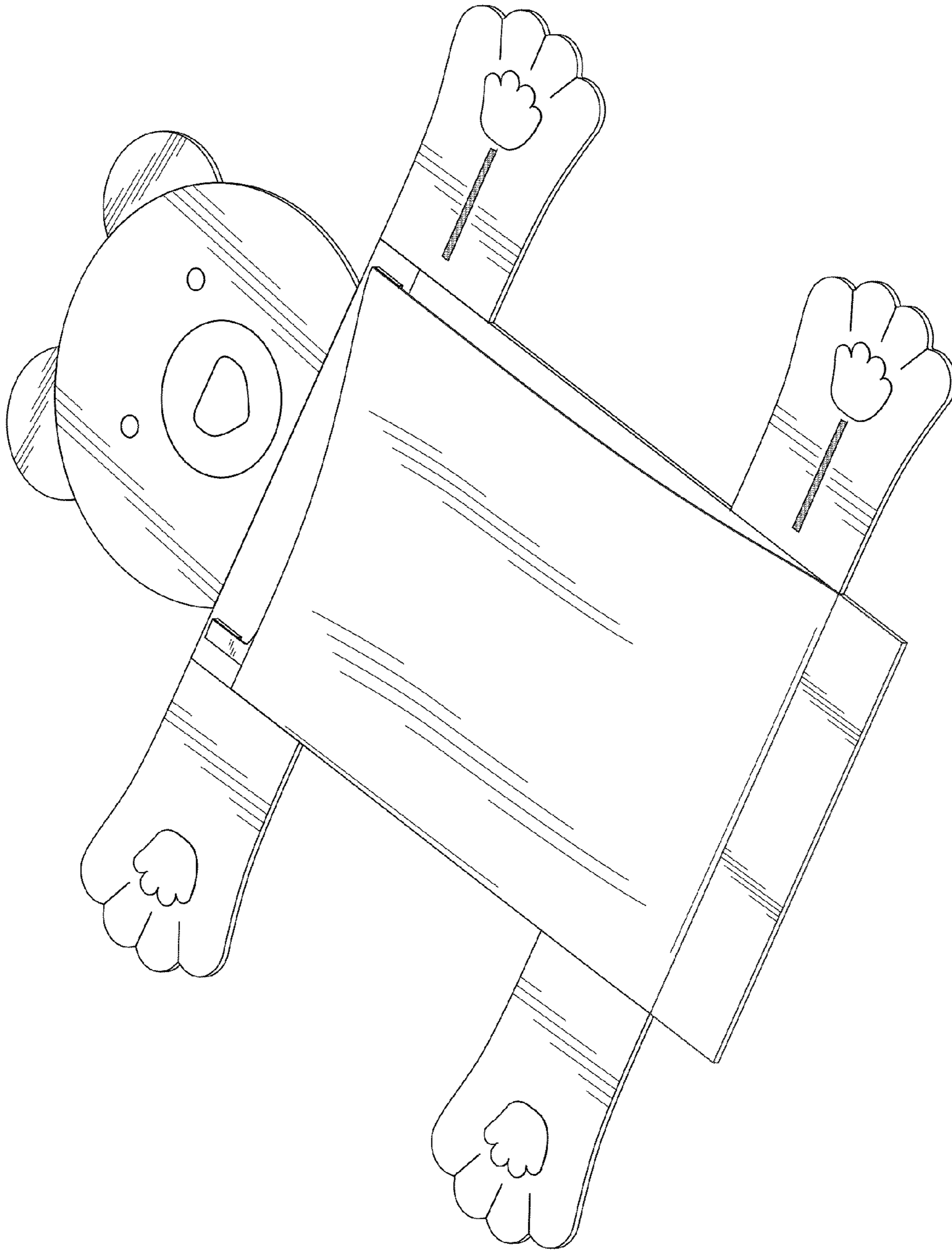

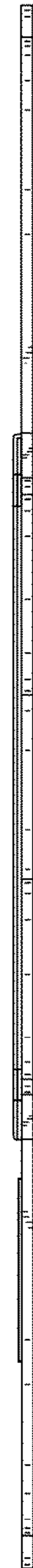

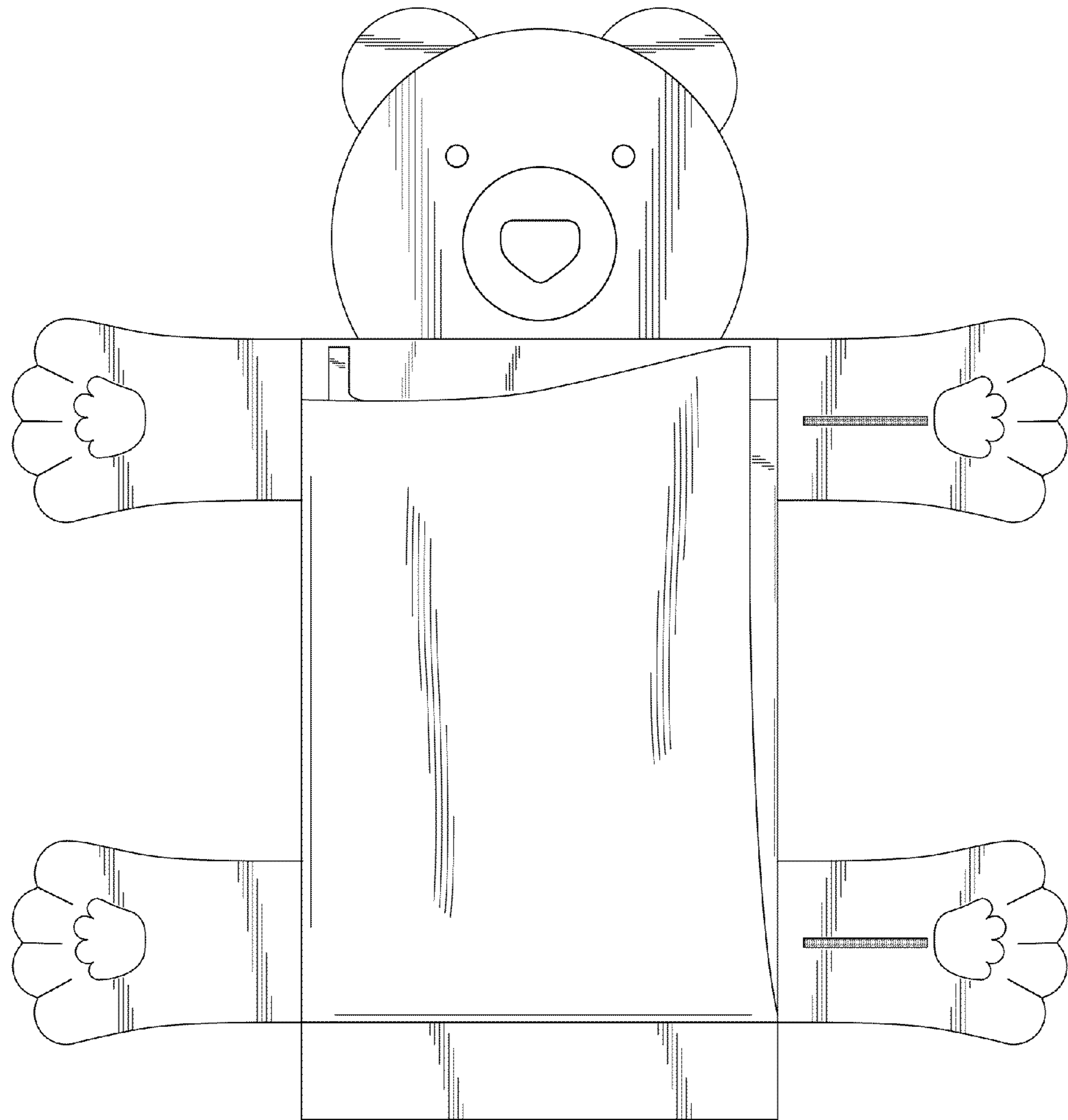

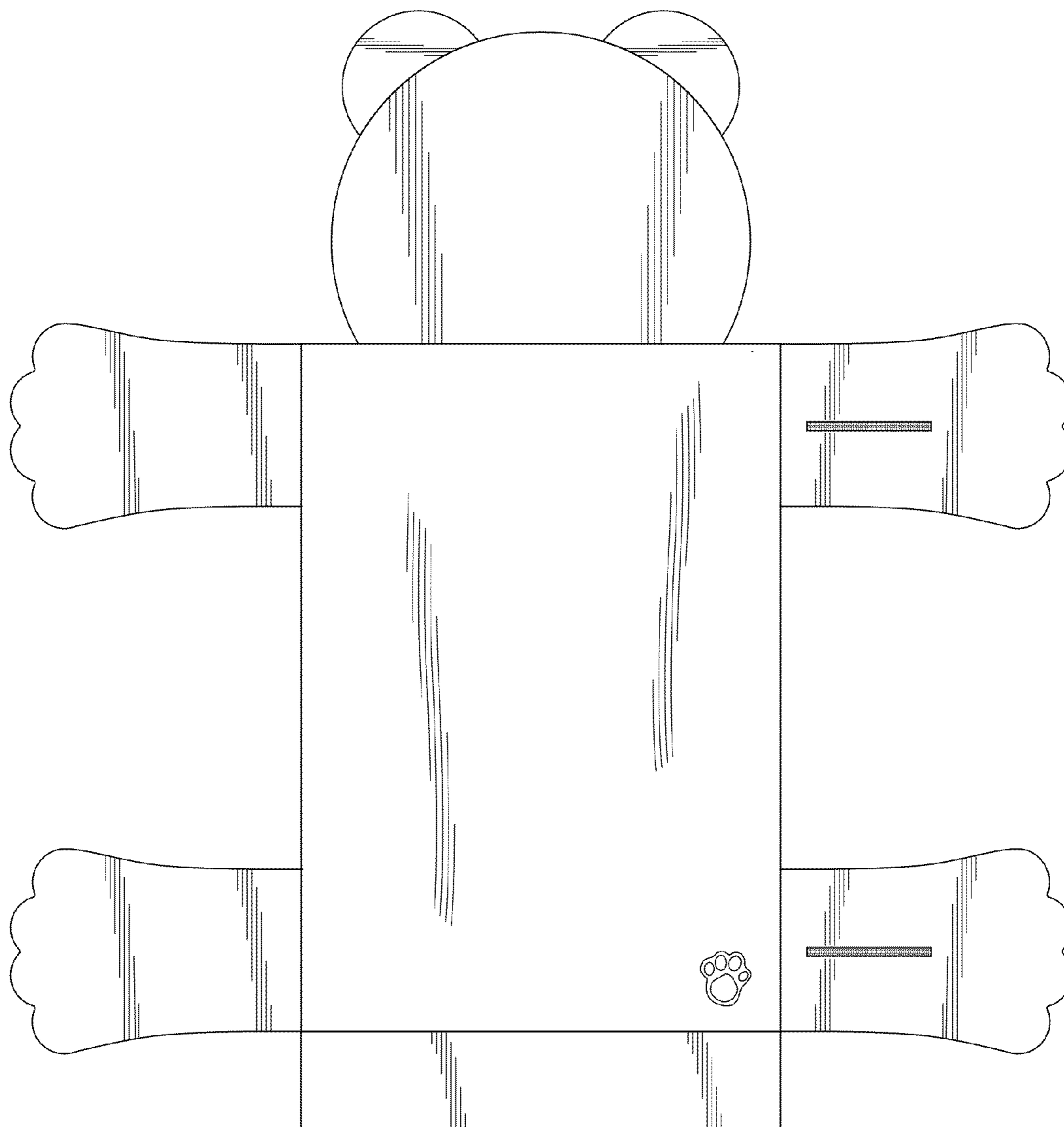

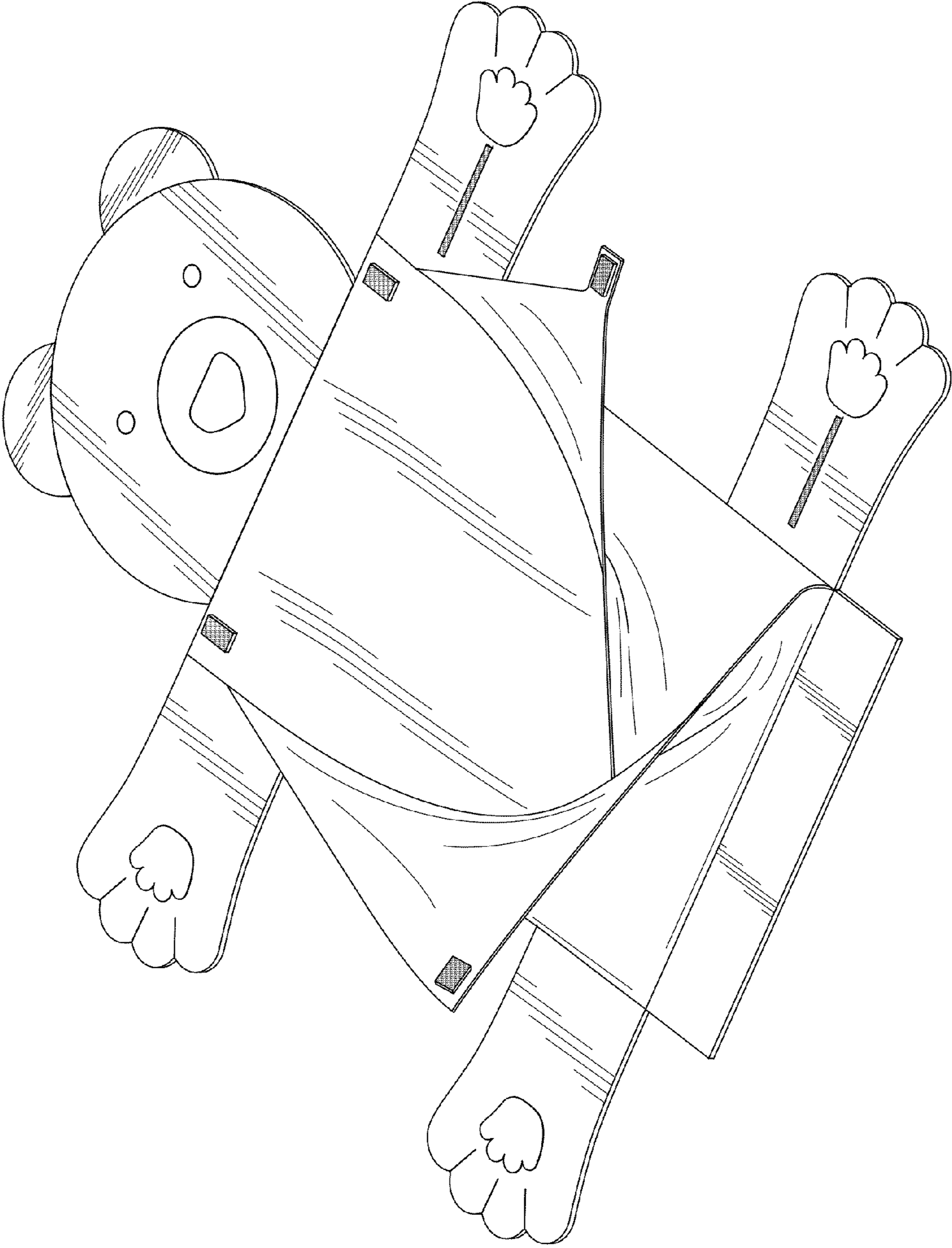
