(57) **CLAIM**

The ornamental design for a mermaid costume, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mermaid costume showing my new design; the costume shown as worn by a human figure represented in broken lines which form no part of the claimed design;

FIG. 2 is another front perspective view thereof of FIG. 1; the broken lines representing the human figure show the costume being worn and form no part of the claimed design;

FIG. 3 is a front elevational view;

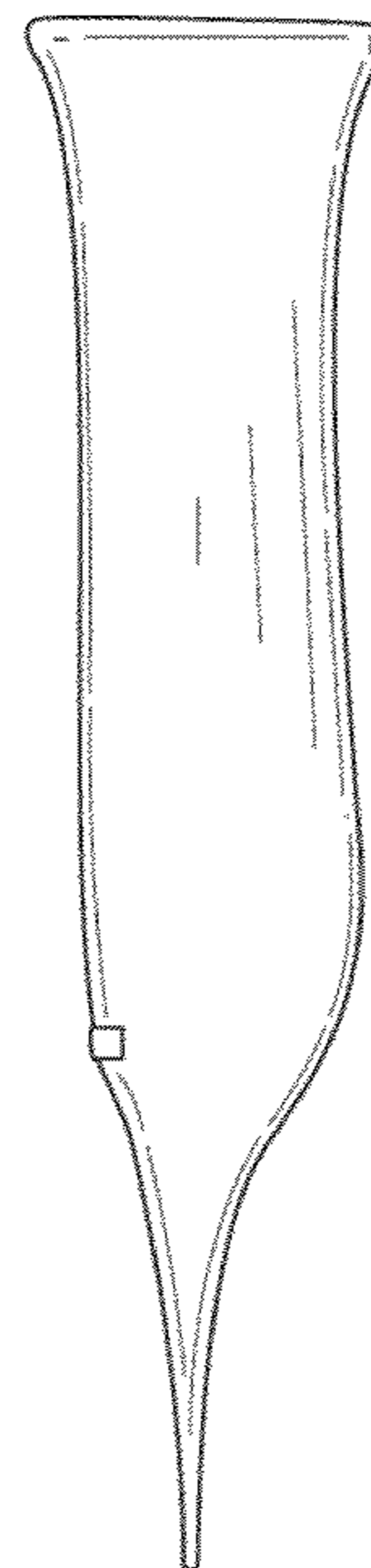
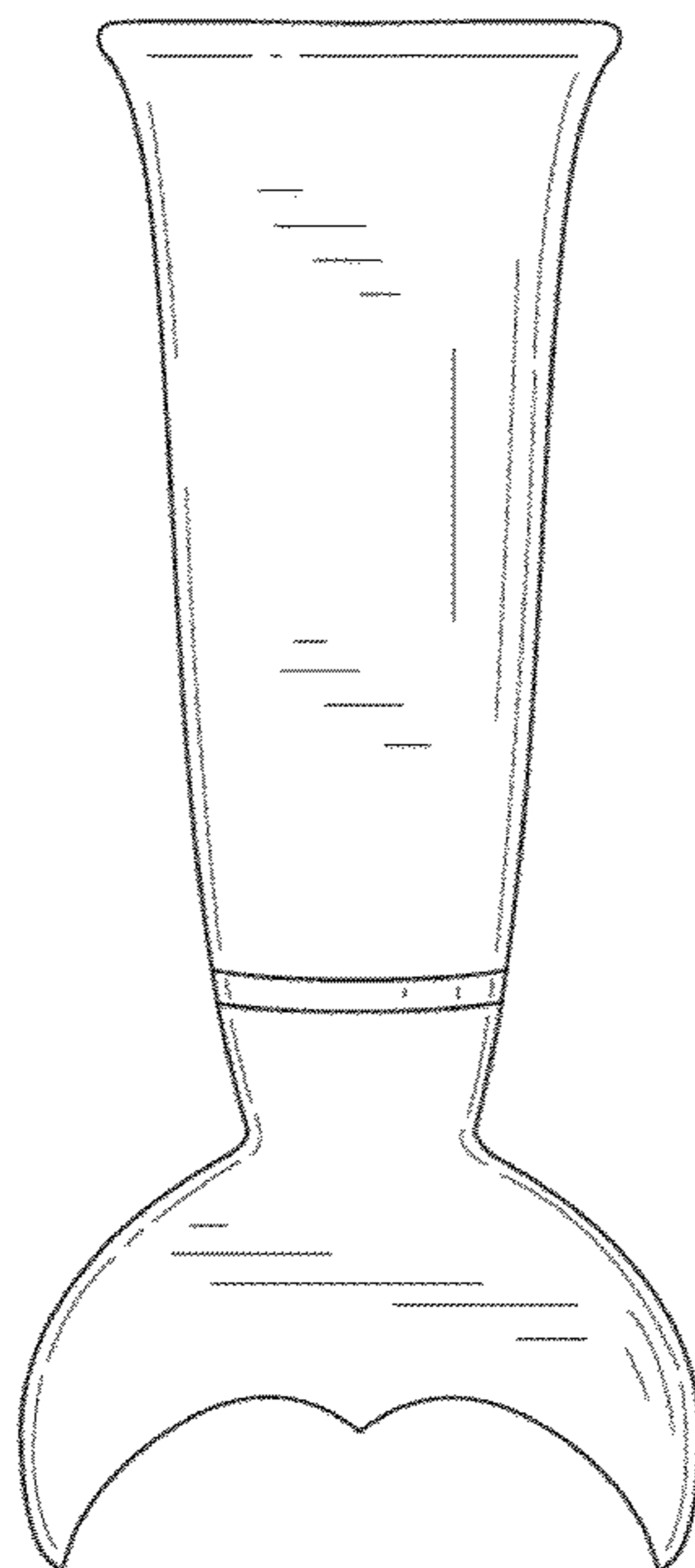
FIG. 4 is a rear elevational view thereof;

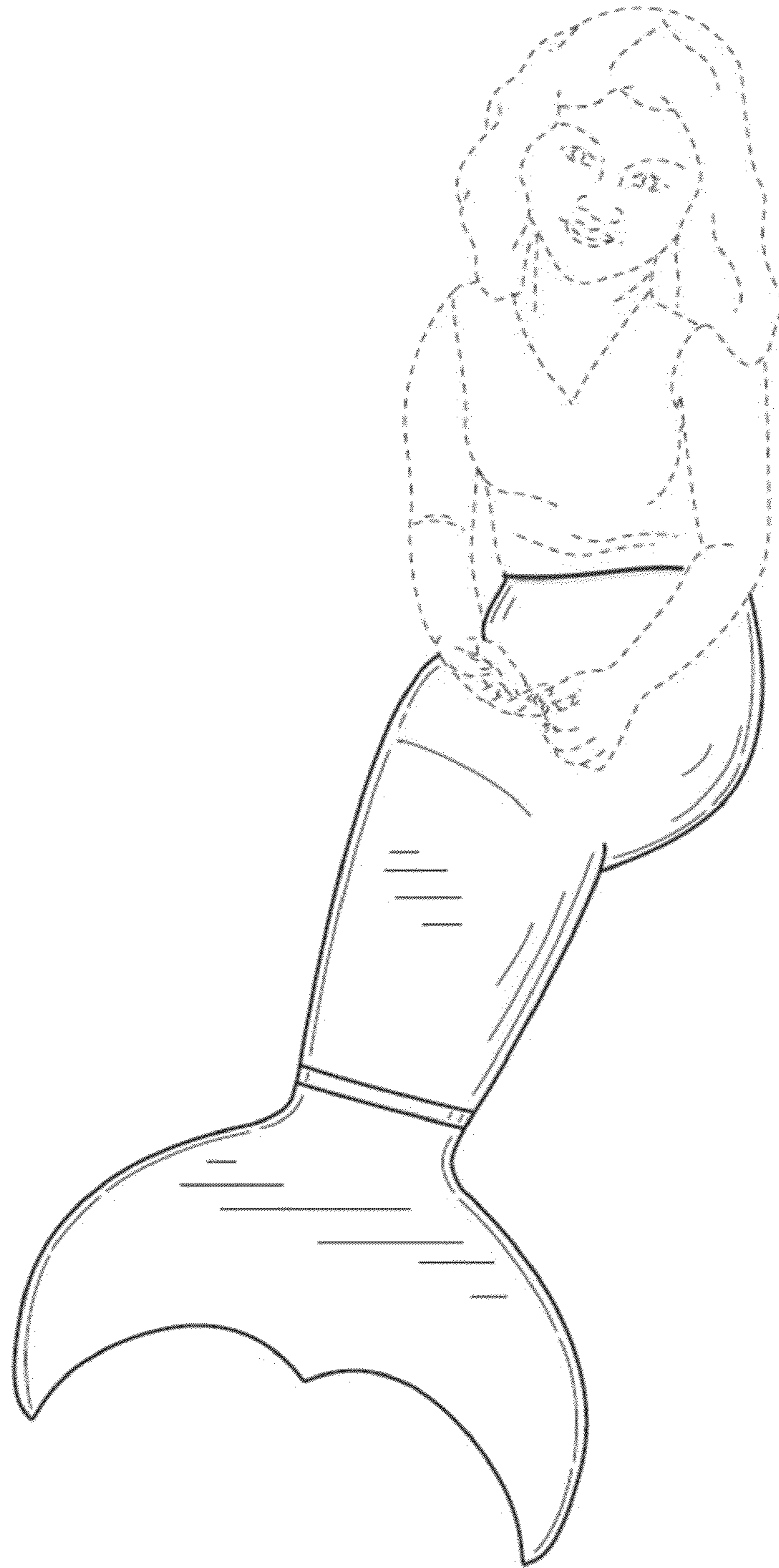

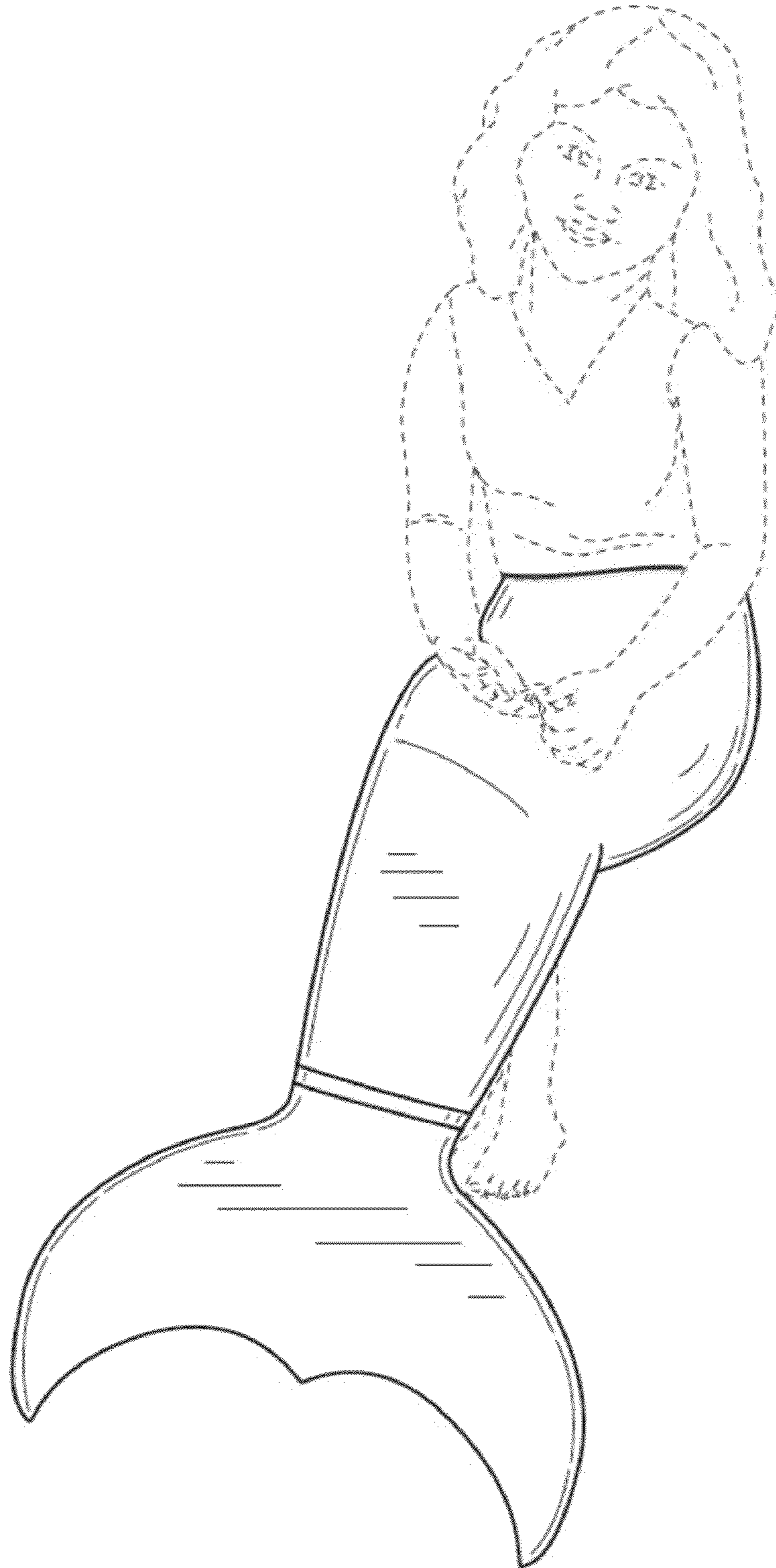

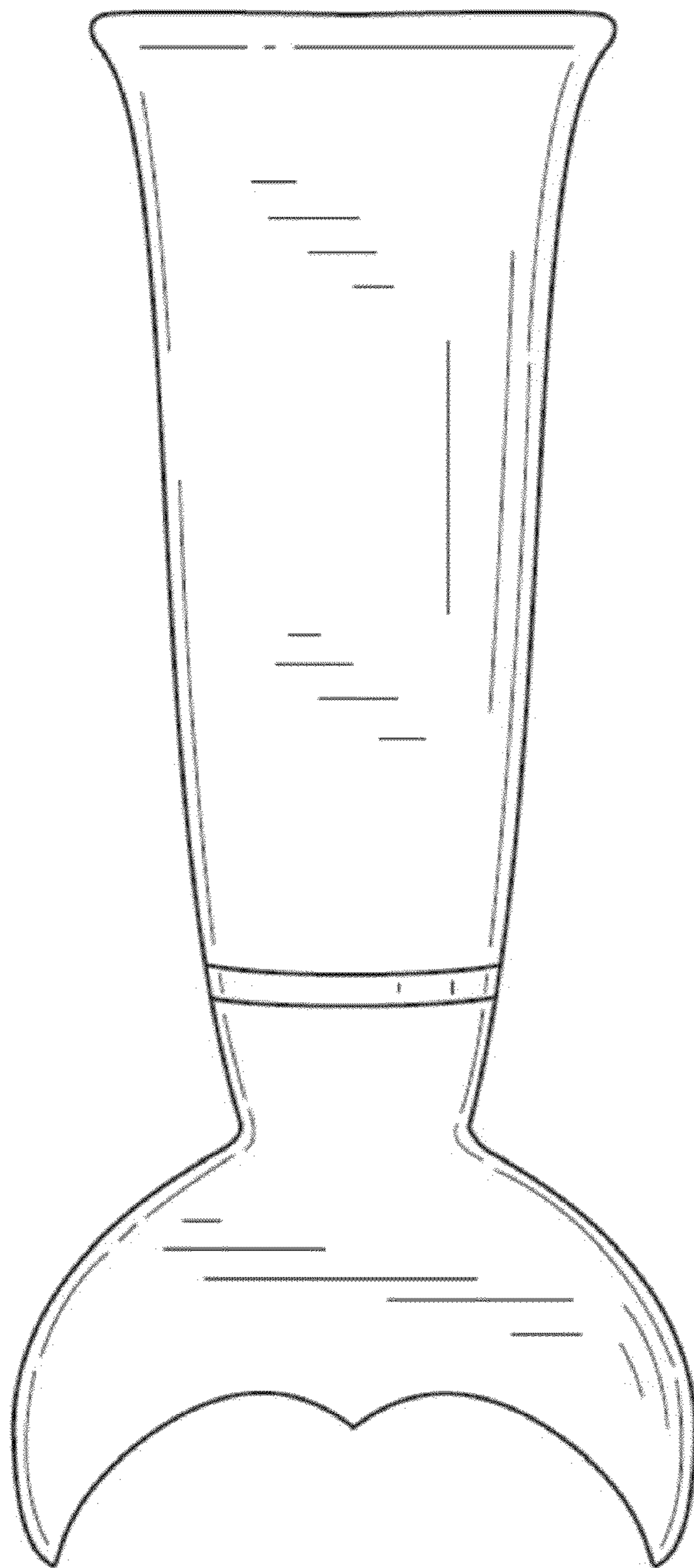

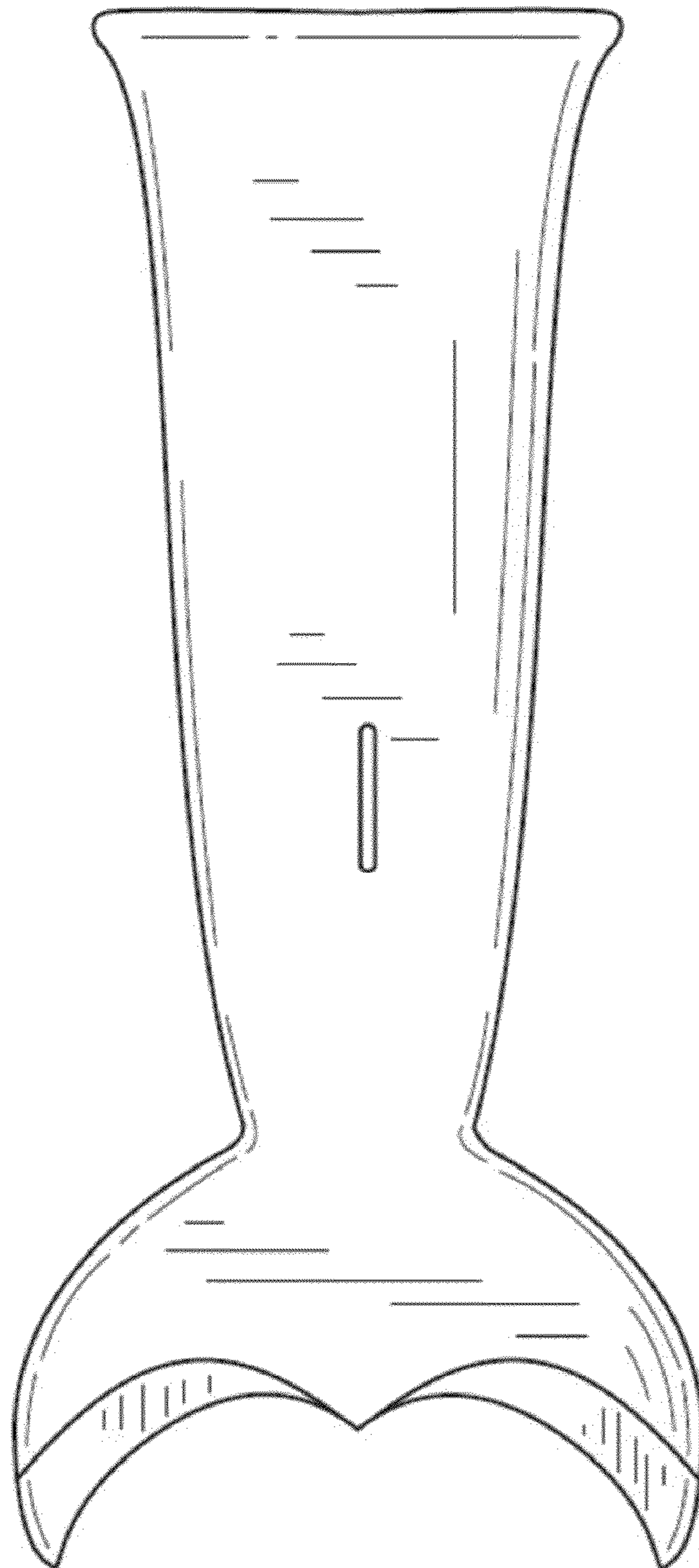

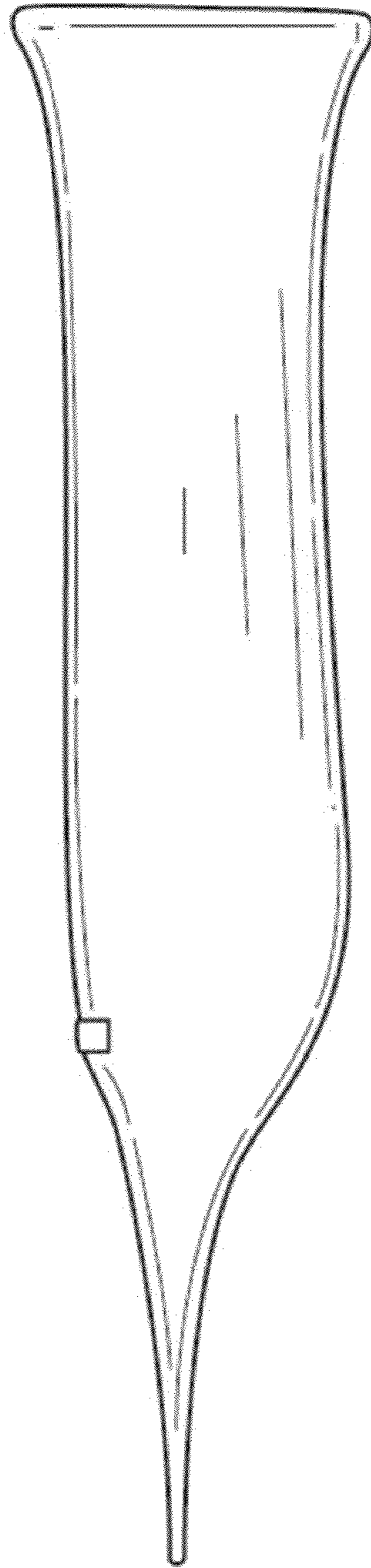

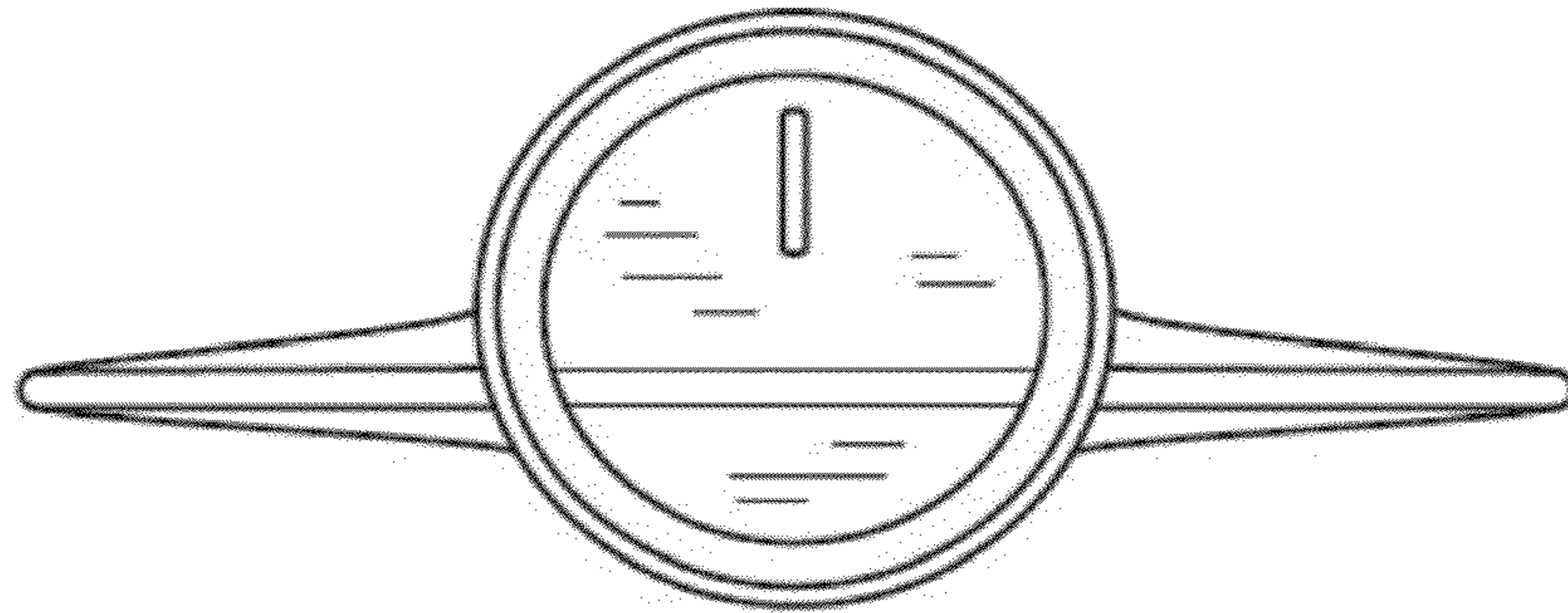

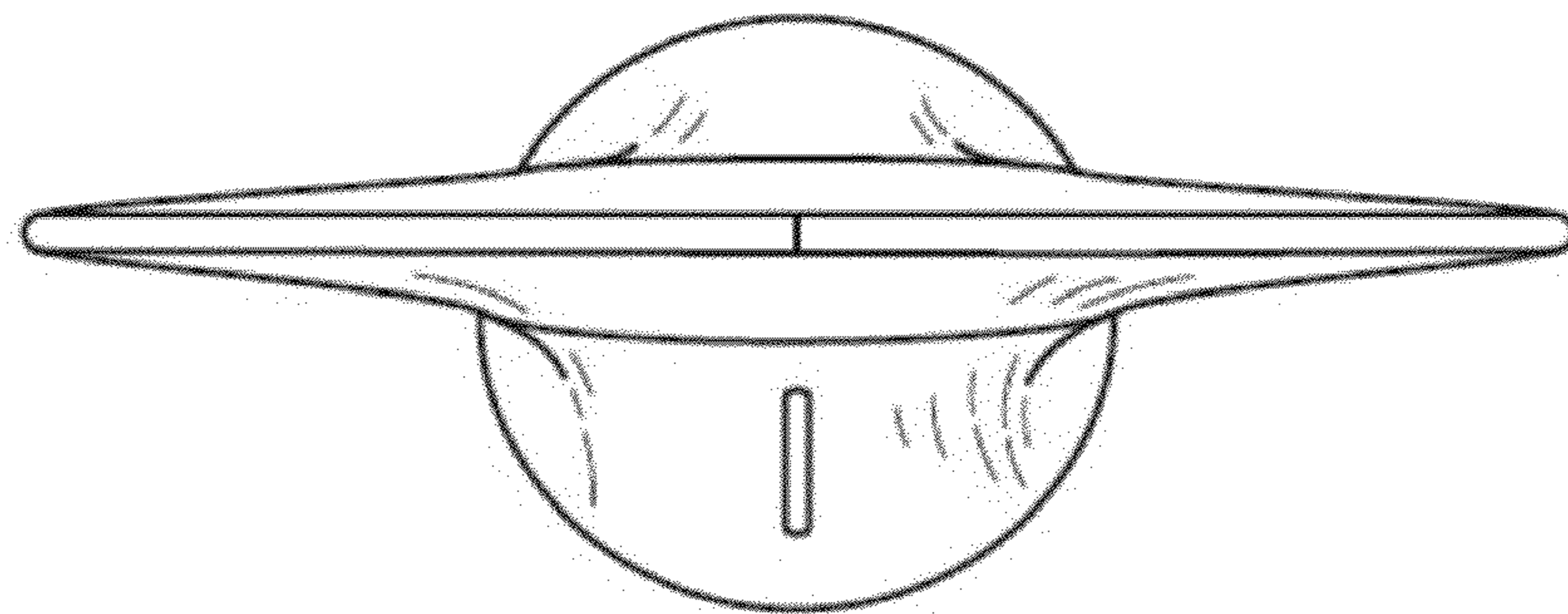
