(57) **CLAIM**

The ornamental design for an electric skin brush, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of the electric skin brush showing the new design;

FIG. 2 is a top view of the electric skin brush;

FIG. 3 is a side elevational view of the electric skin brush, the other side being a mirror image thereof;

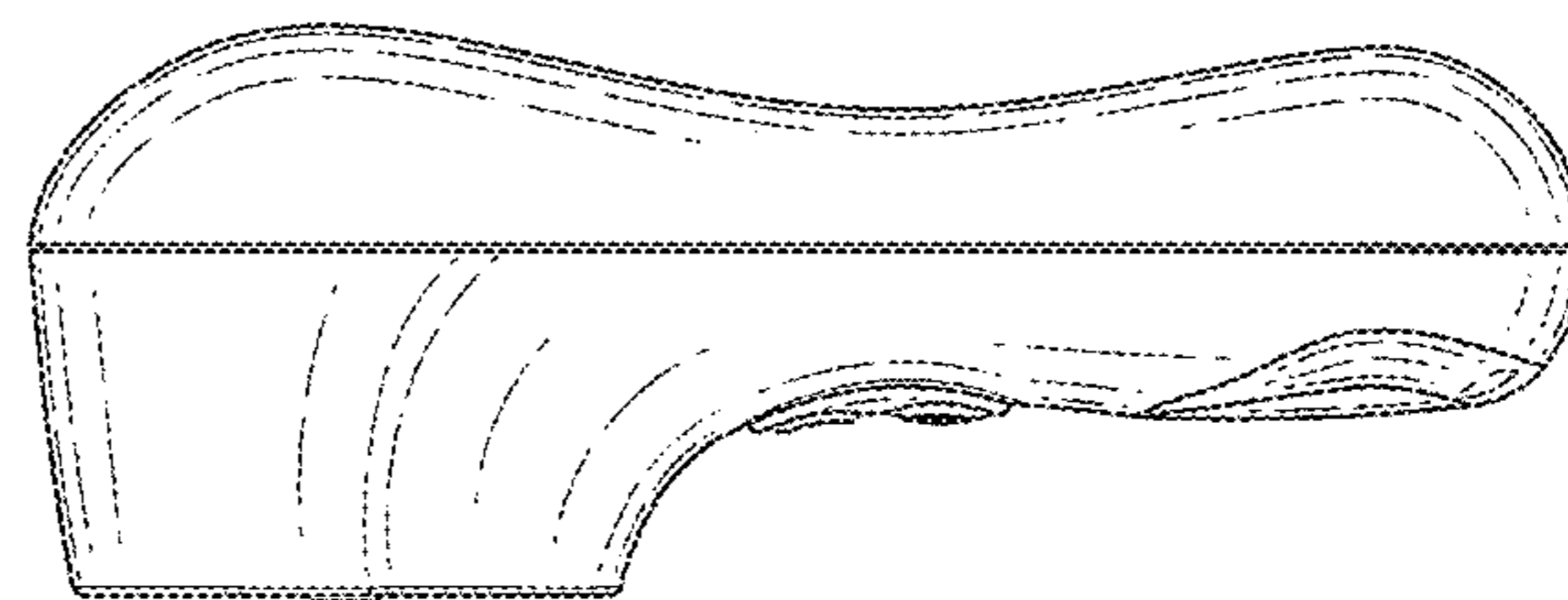
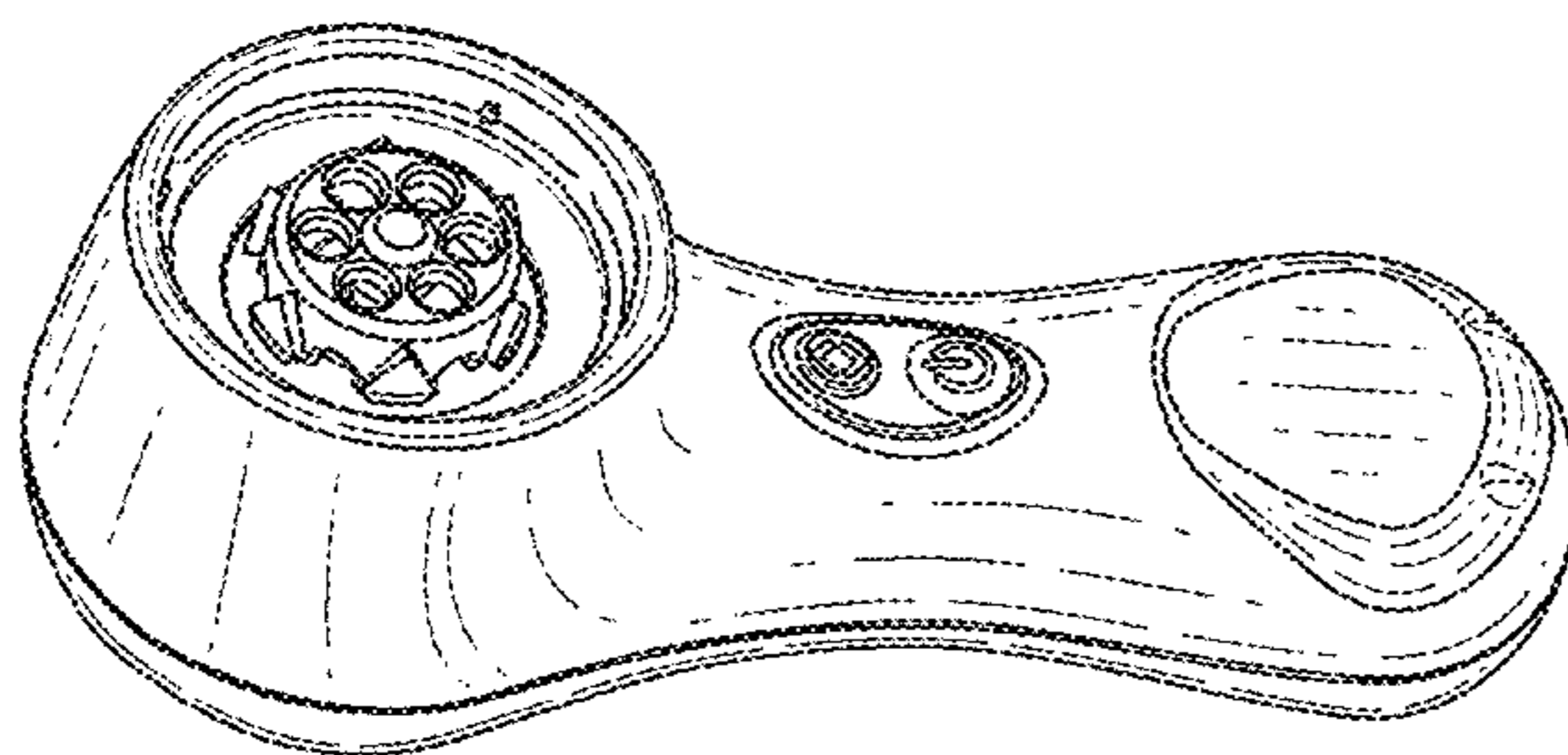
FIG. 4 is a bottom view of the electric skin brush;

FIG. 5 is an elevational view of one end of the electric skin brush; and,

FIG. 6 is an elevational view of an opposing end of the electric skin brush.

The broken lines shown on the distal end of the handle in FIGS. 1-3 and 5 illustrate portions of the electric skin brush that form no part of the claimed design.

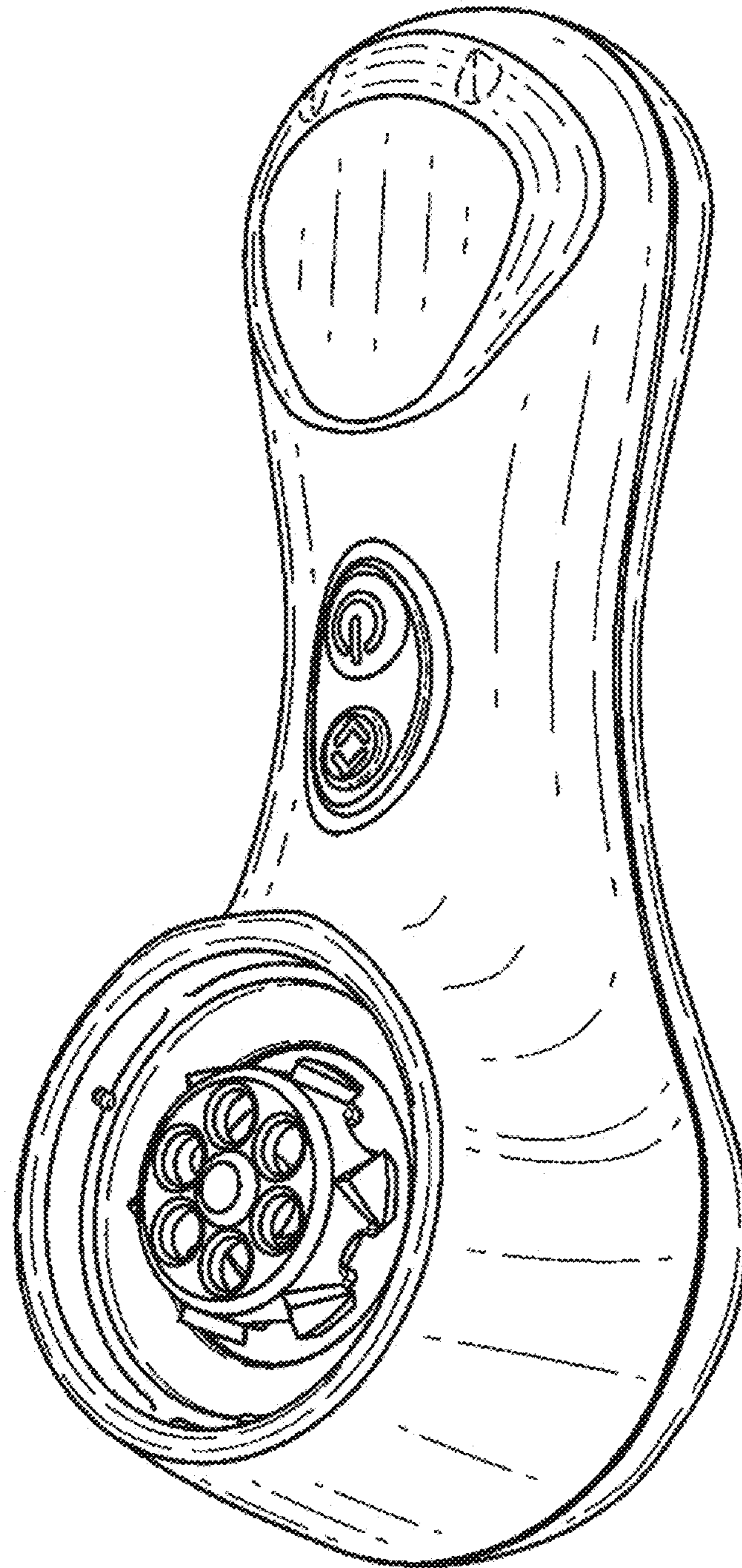

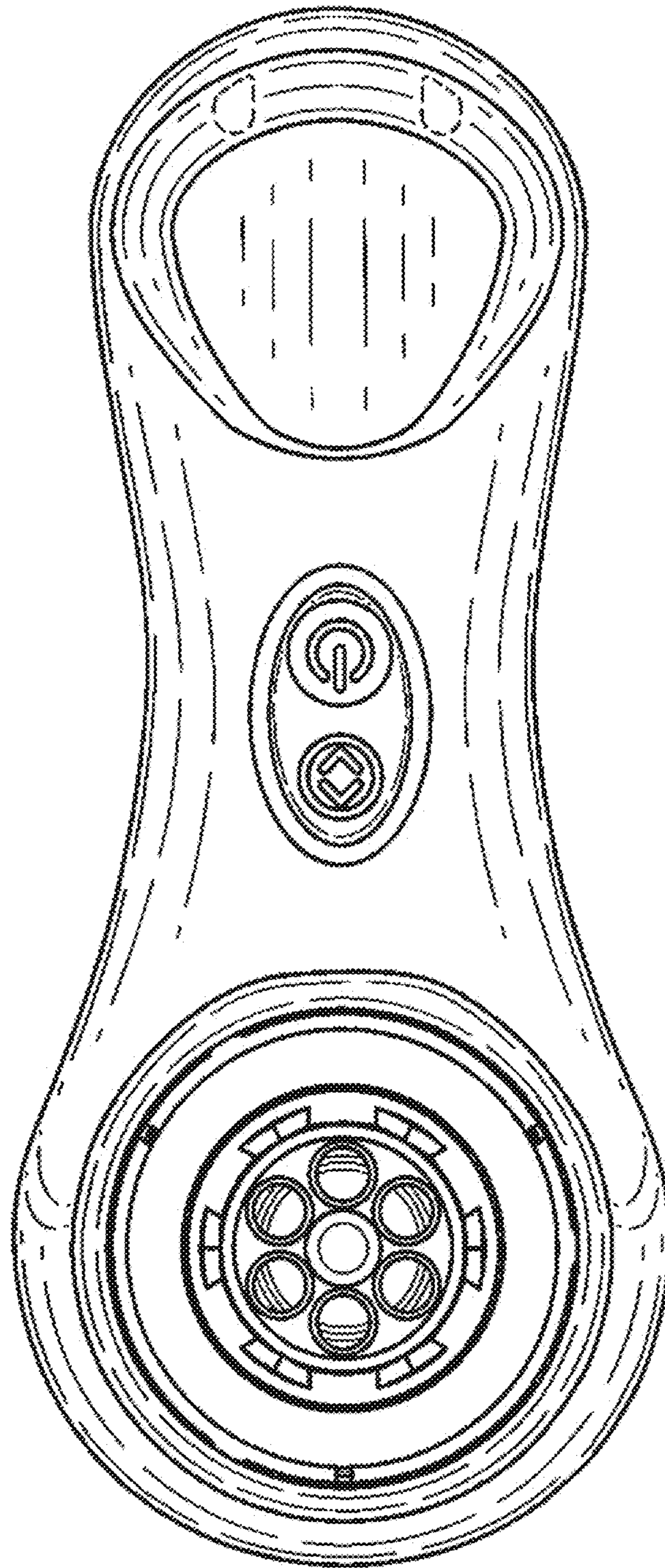

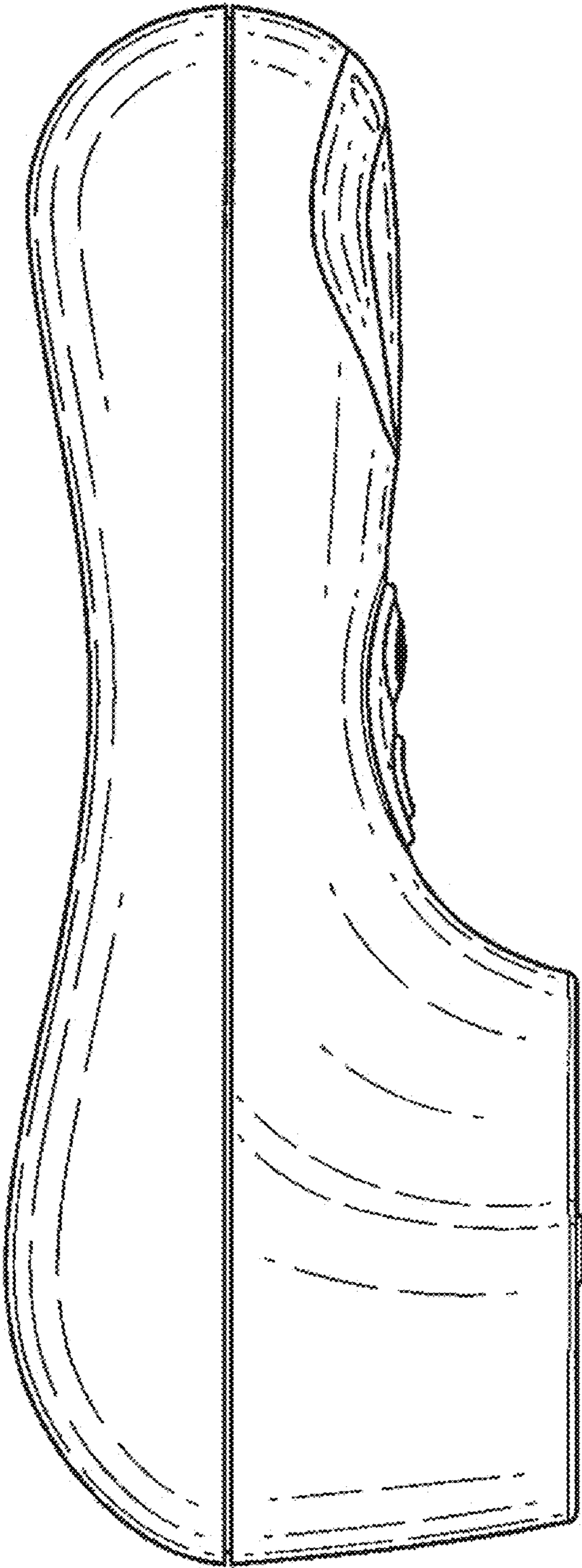

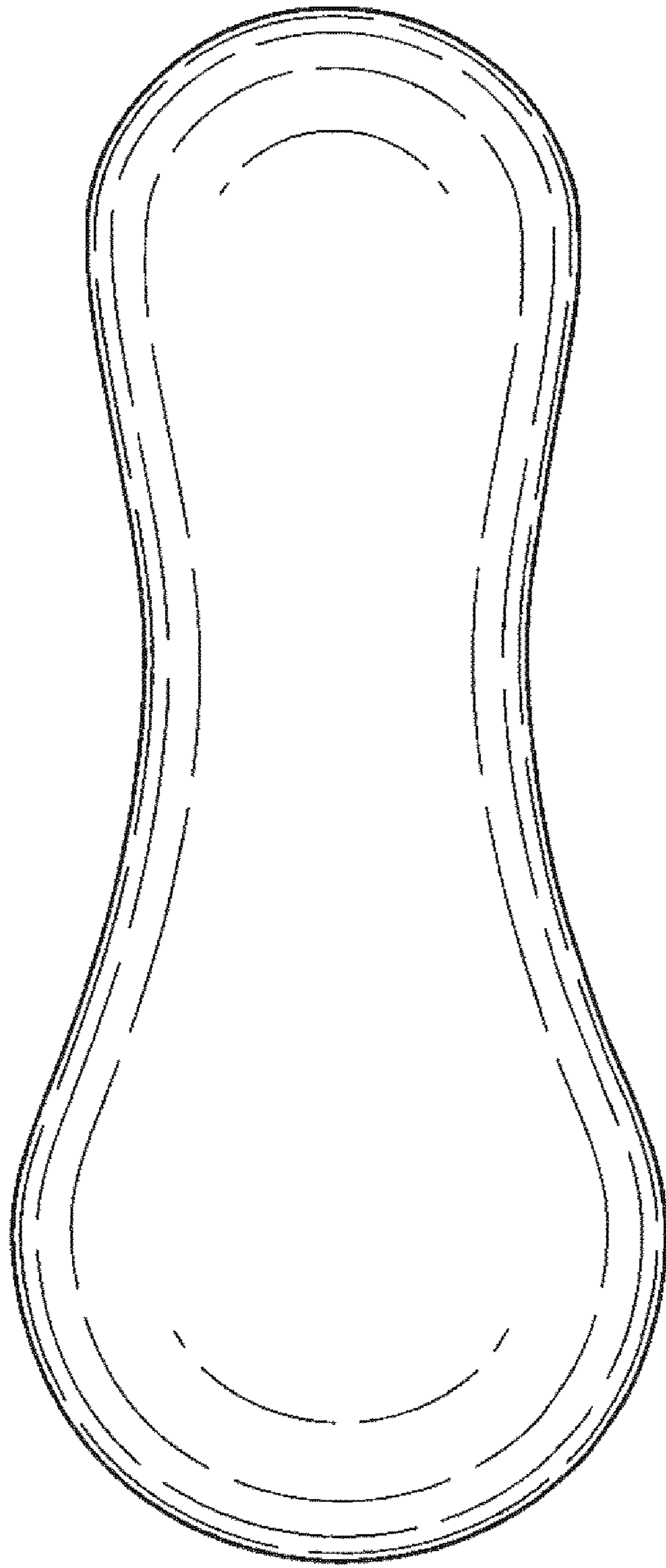

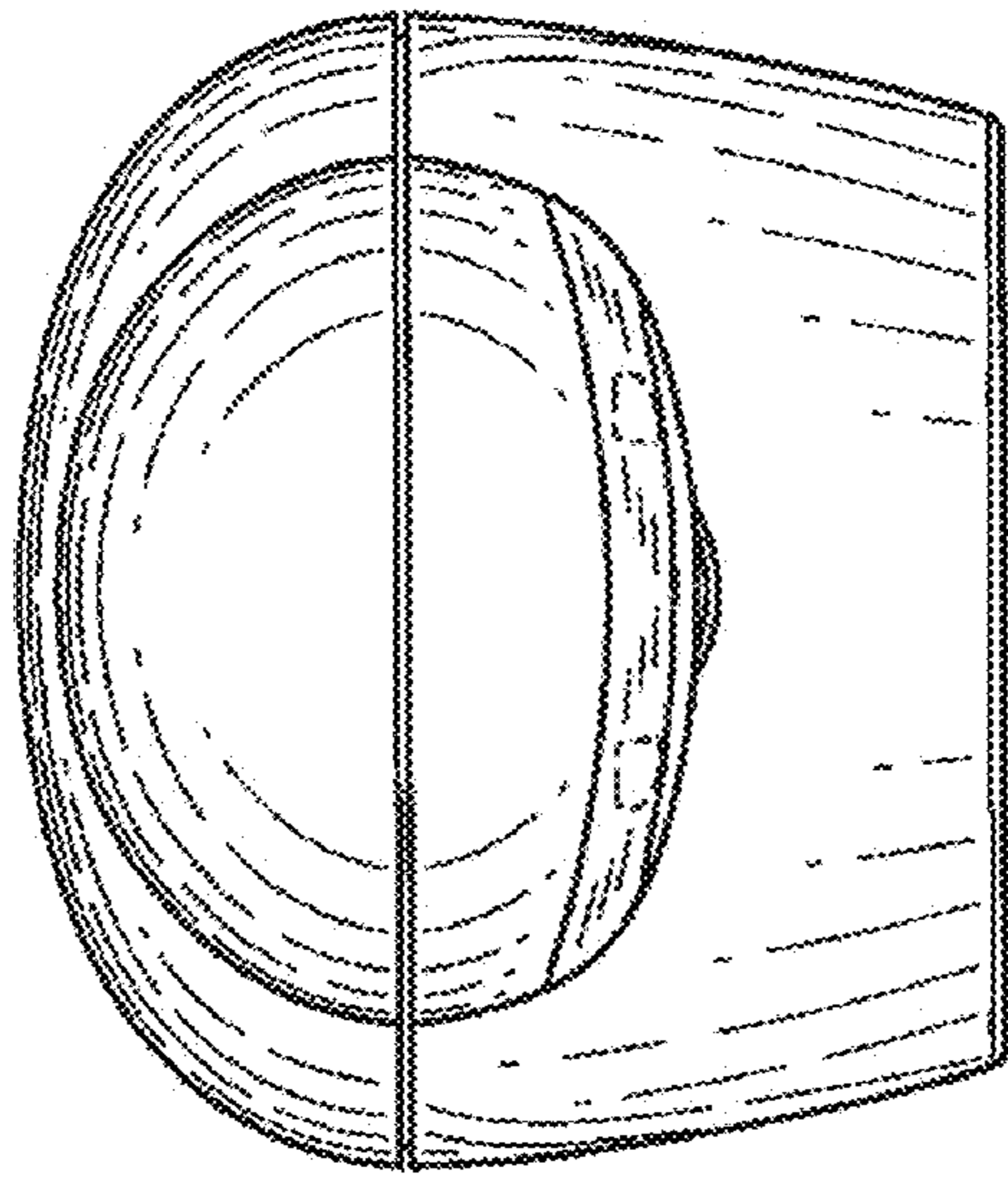

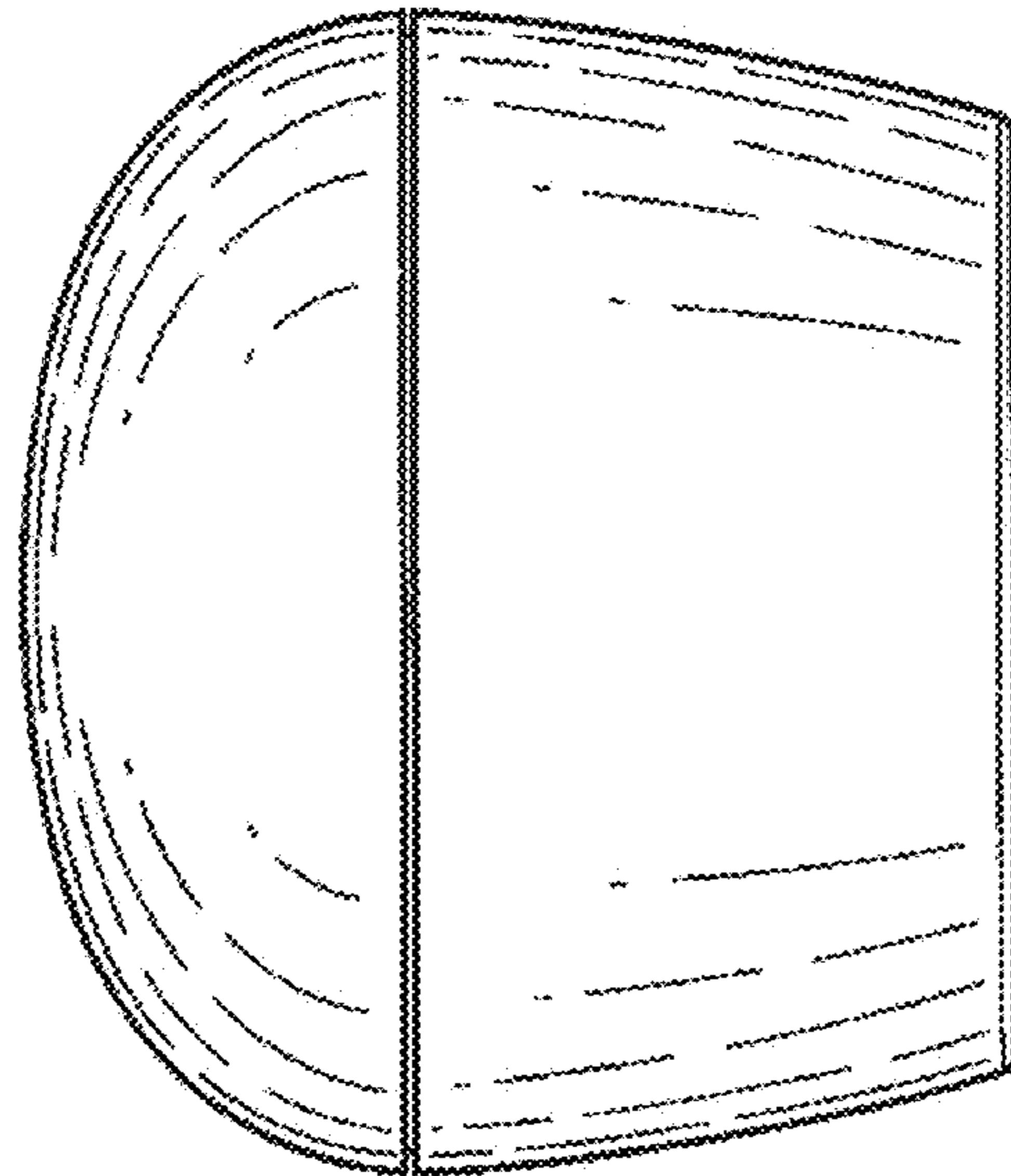
