(57) **CLAIM**

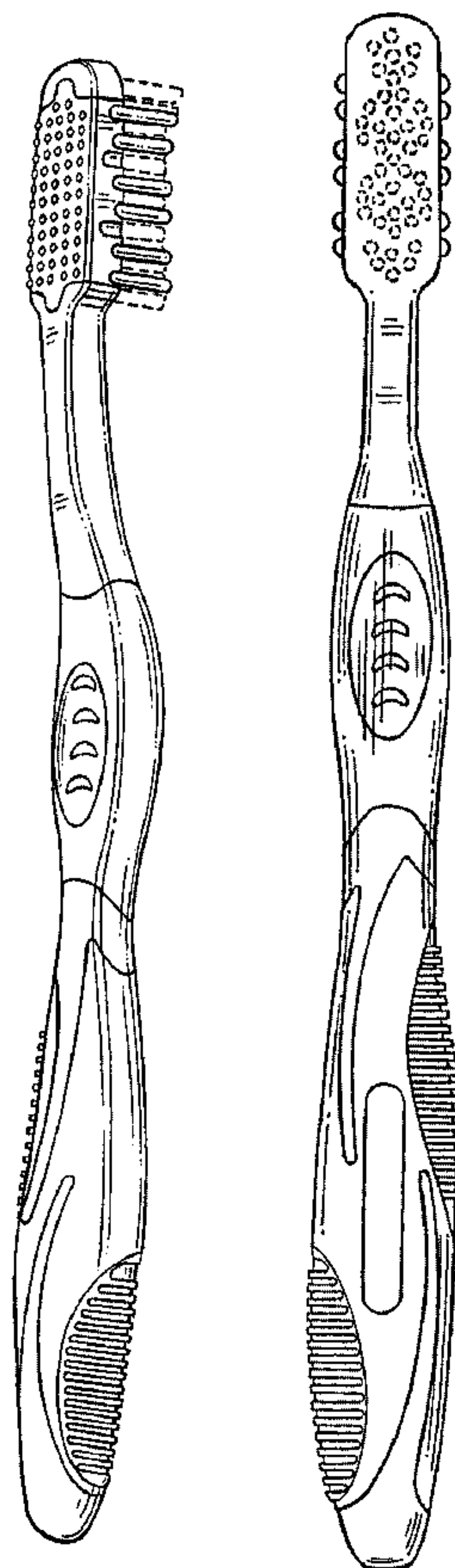
The ornamental design for a “toothbrush with tongue scraper, massaging bristles and unique grip,” as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of my toothbrush with tongue scraper, massaging bristles and unique grip;  
FIG. 2 is a front elevational view of FIG. 1;  
FIG. 3 is a rear elevational view of FIG. 1;  
FIG. 4 is a side elevational view taken from the left of FIG. 2;  
FIG. 5 is a top plan view of FIG. 1; and,  
FIG. 6 is a bottom plan view of FIG. 1.

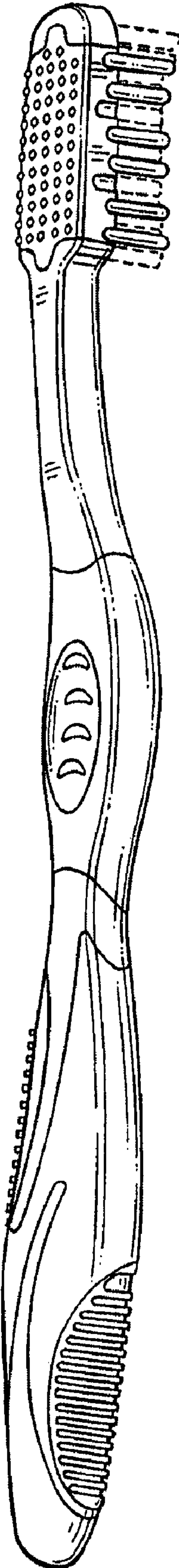

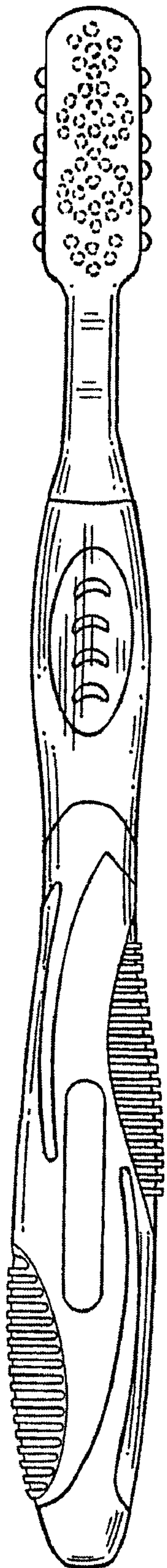
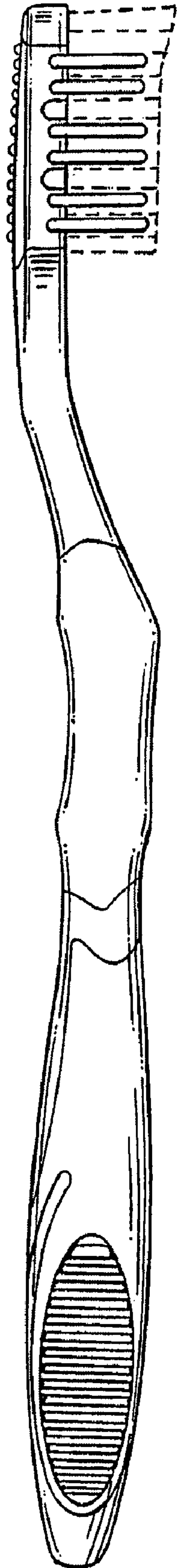


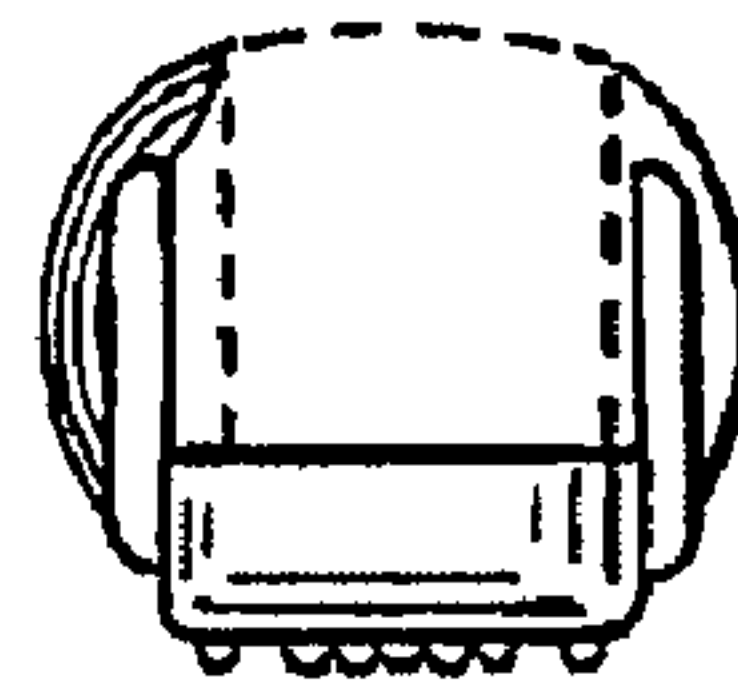

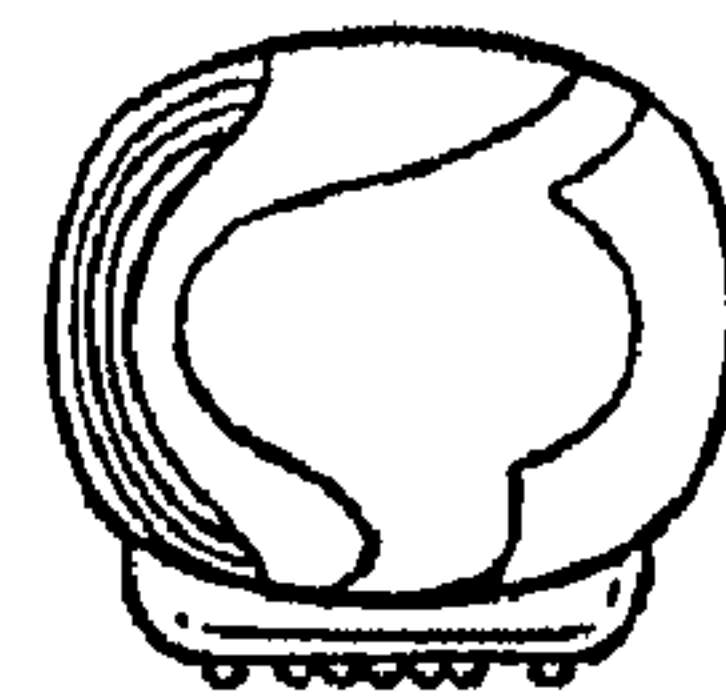
