DESCRIPTION

FIG. 1 is a top view of a first embodiment of the instant invention with the bottom view being a mirror image thereof; FIG. 2 is a left side view of a first embodiment the instant invention with the right side view being a mirror image thereof; and,

FIG. 3 is a perspective view of a first embodiment of the instant invention.

FIG. 4 is a top view of a second embodiment of the instant invention with the bottom view being a mirror image thereof; FIG. 5 is a left side view of a second embodiment the instant invention with the right side view being a mirror image thereof; and,

FIG. 6 is a perspective view of a second embodiment of the instant invention.

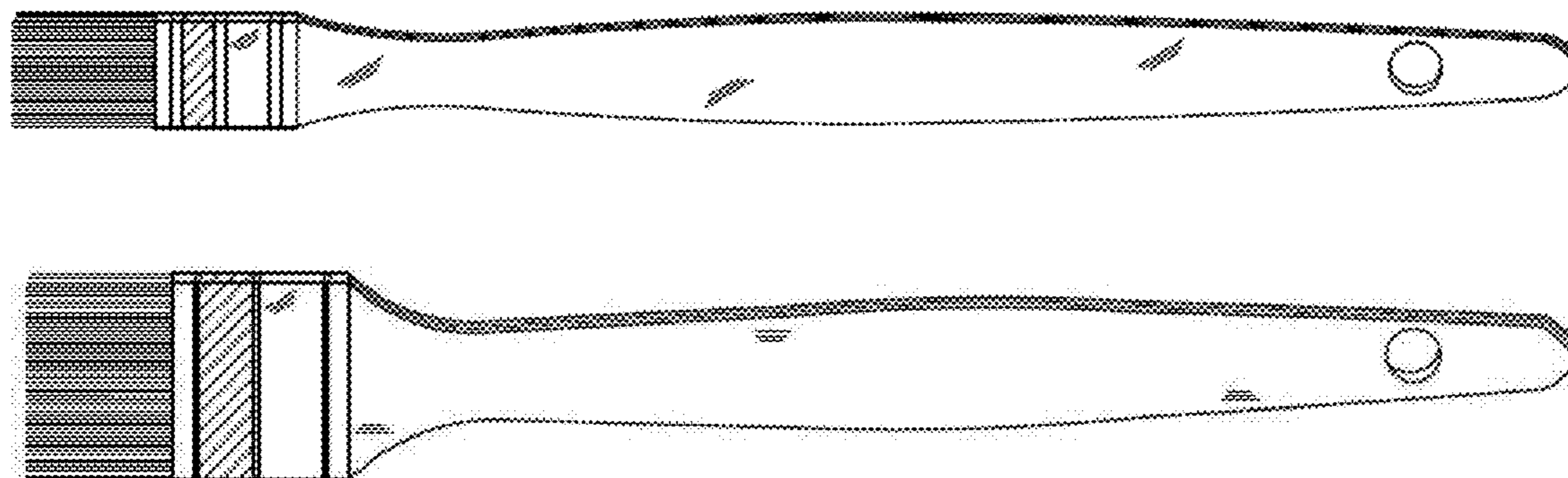

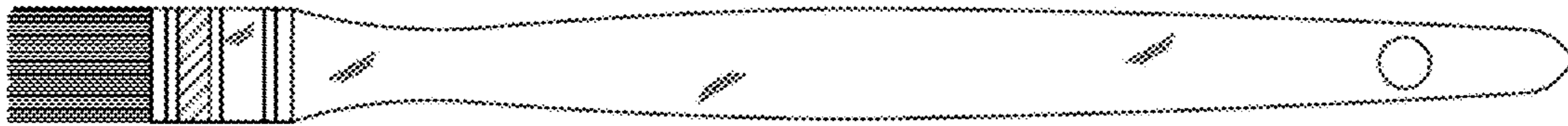

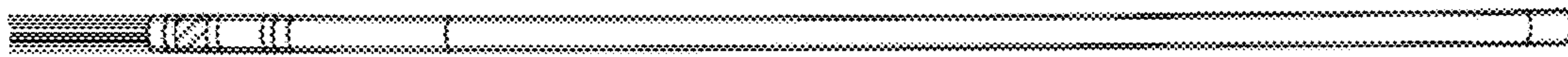

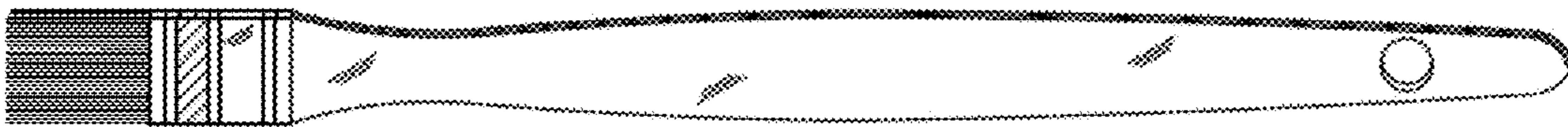

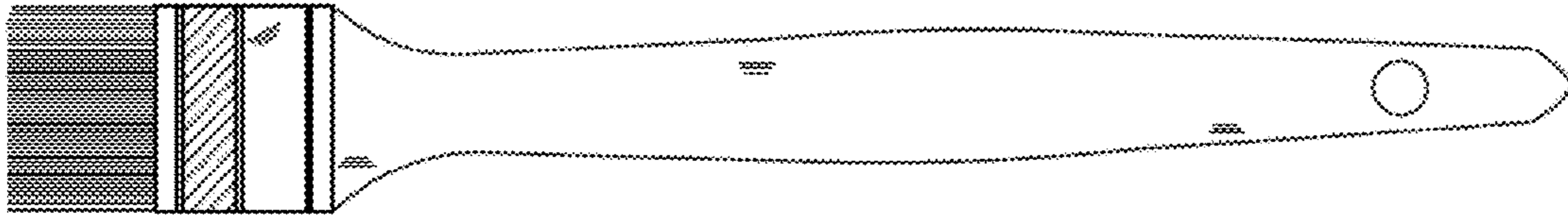

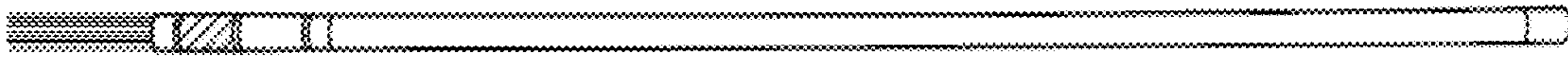

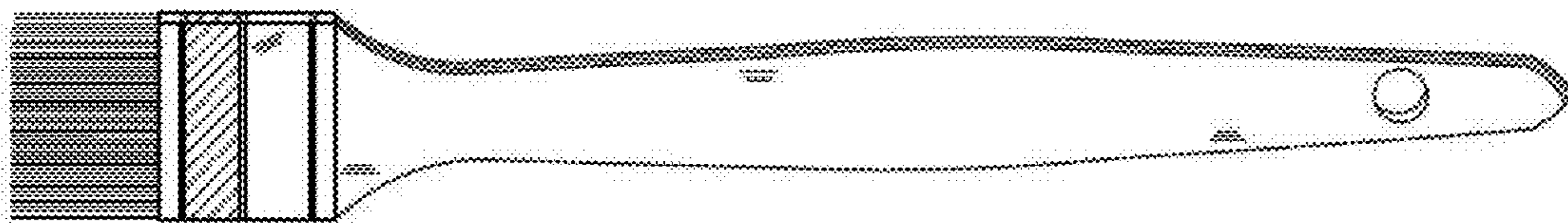

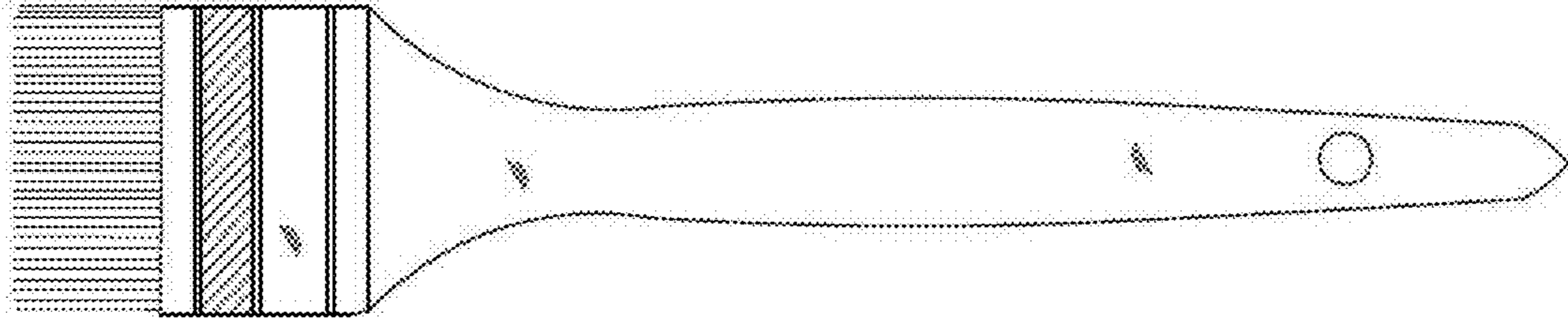

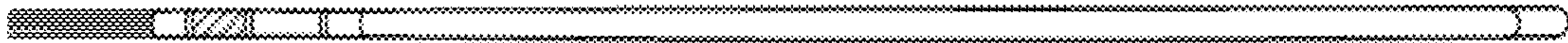

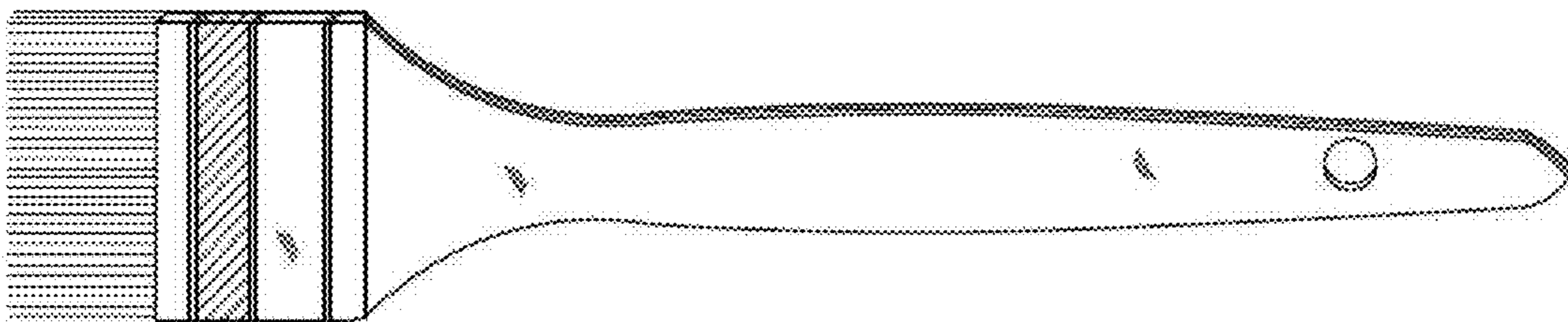

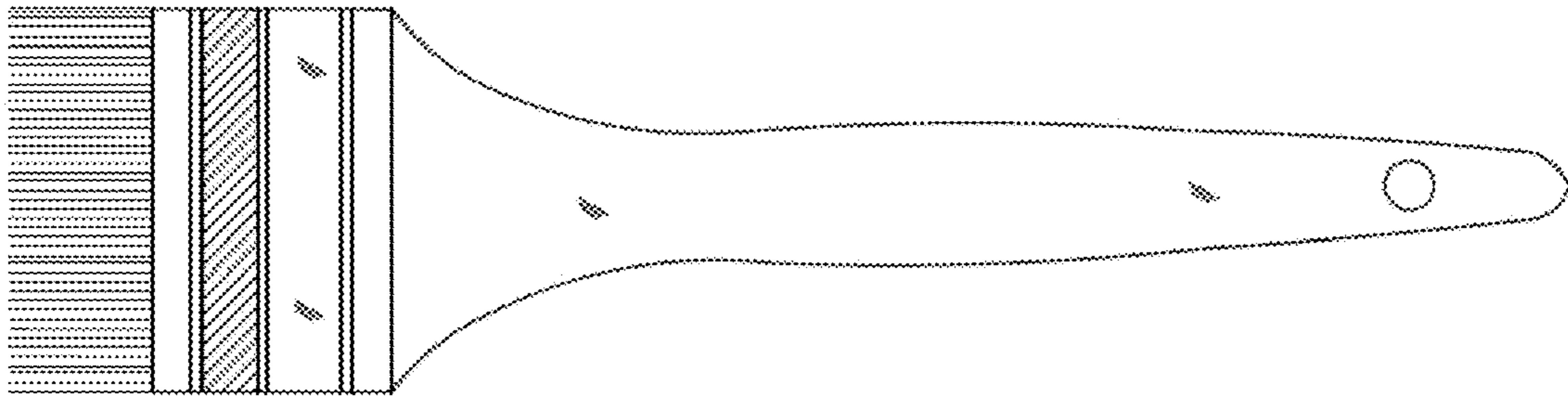

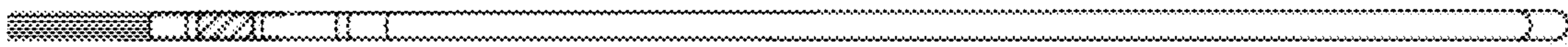

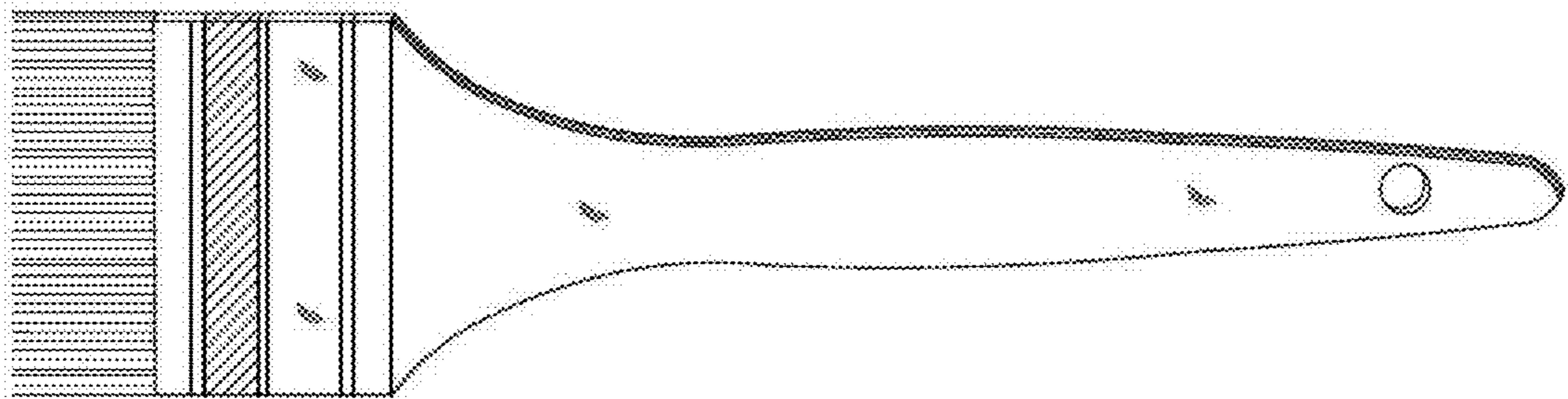
