DESCRIPTION

FIG. 1 is a front perspective view, from above, of the cap design of the invention;

FIG. 5 is an elevational view of the opposite side of the cap design of FIG. 1;

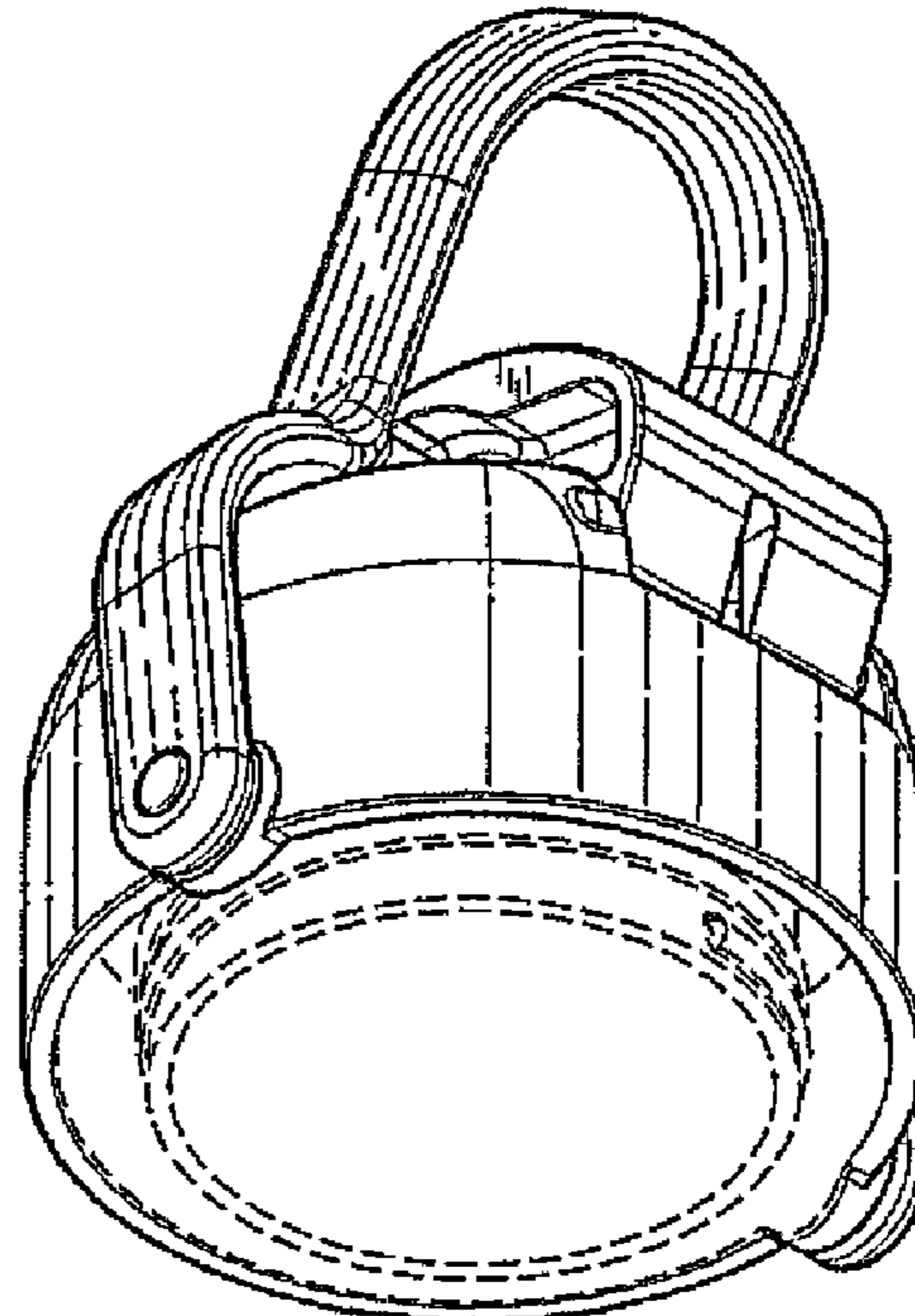
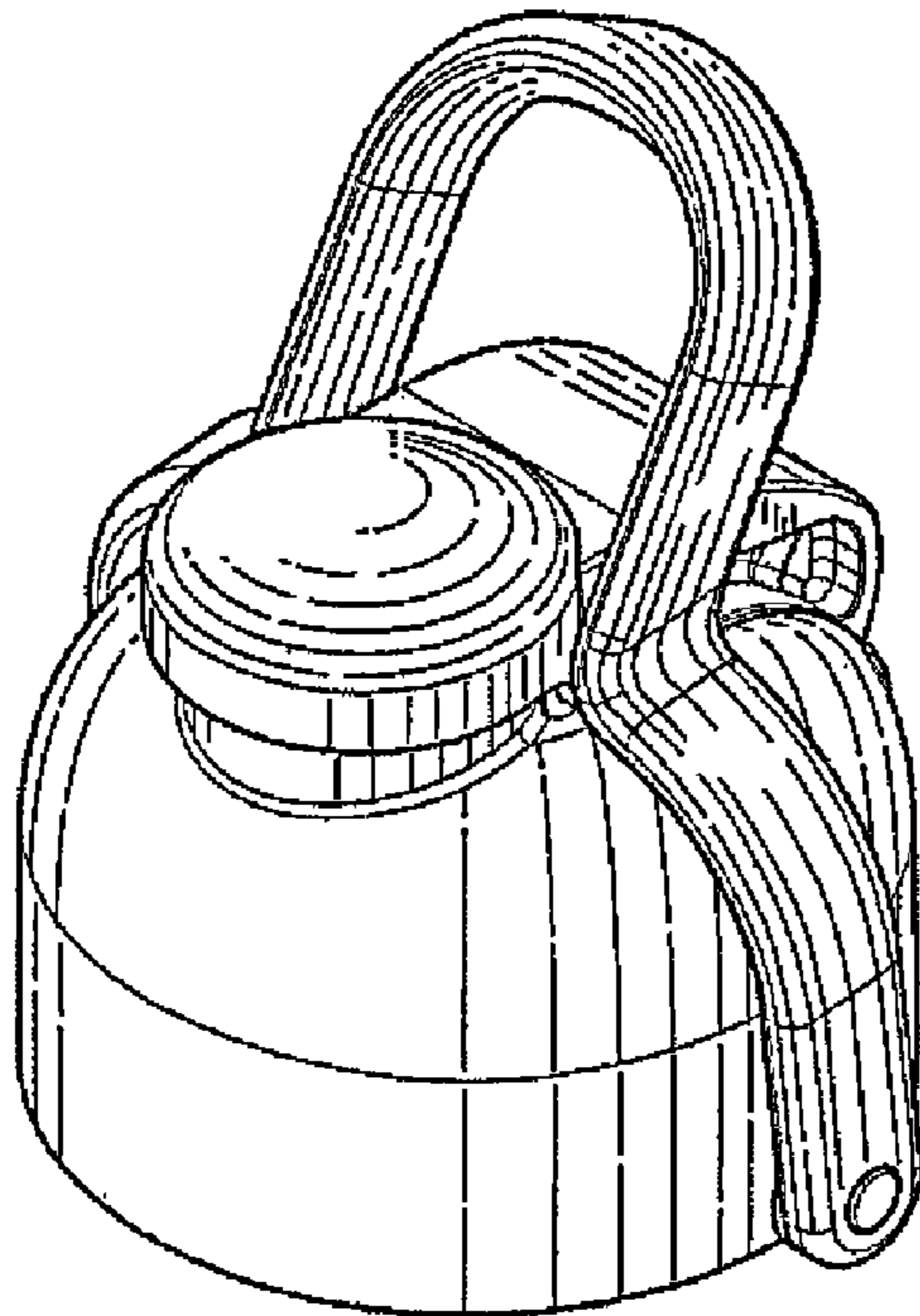
FIG. 6 is a bottom plan view of the cap design of FIG. 1;

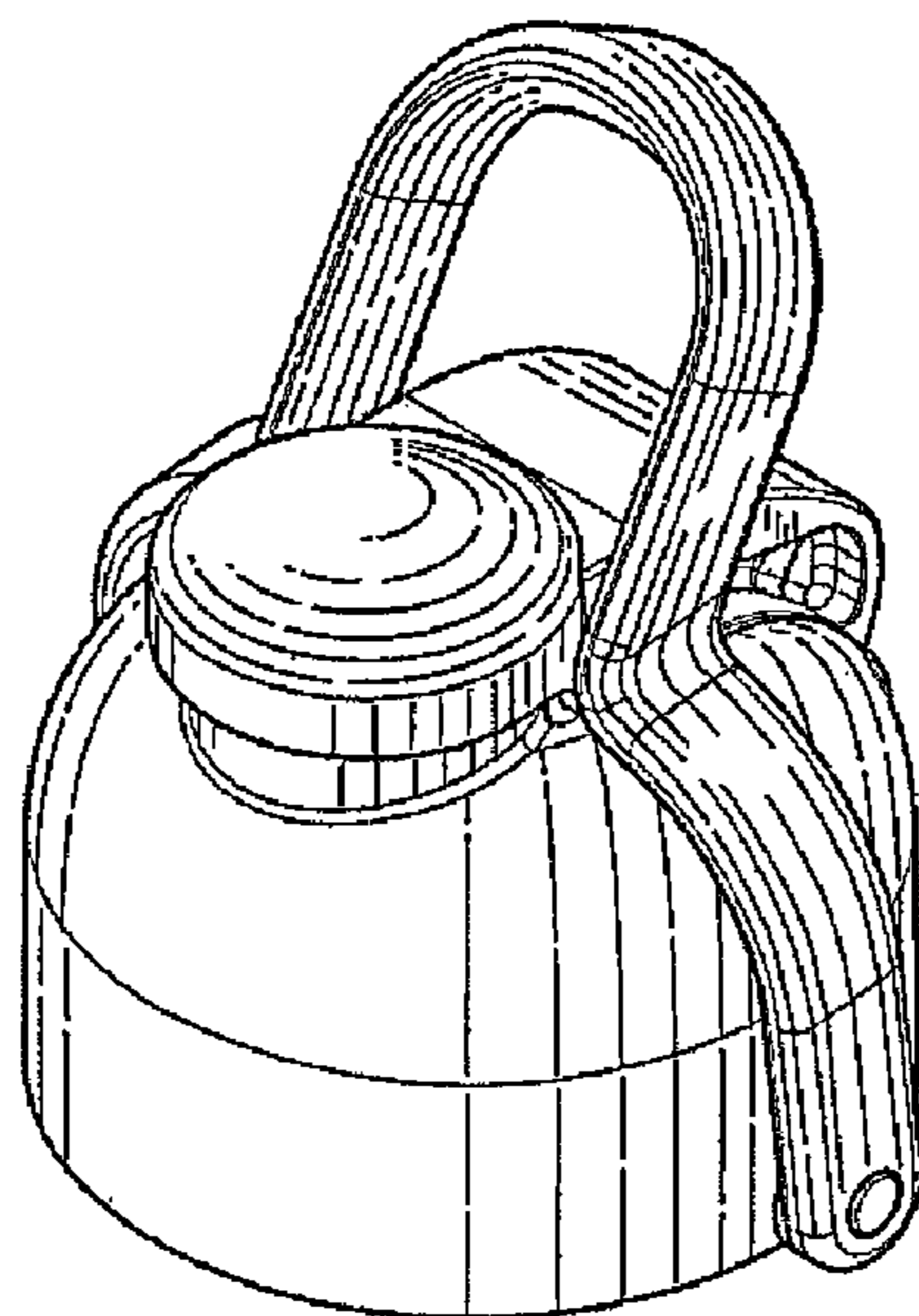

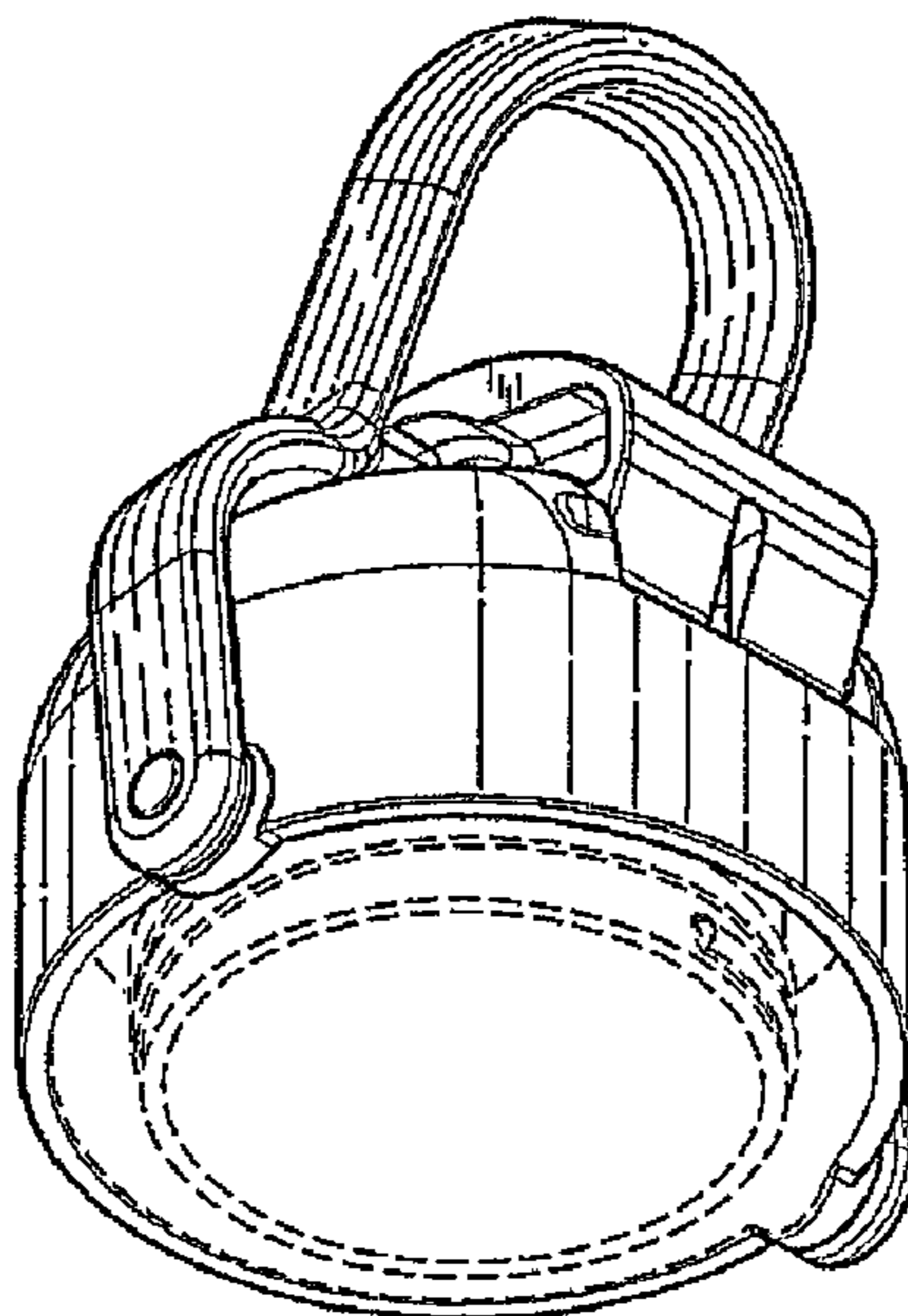

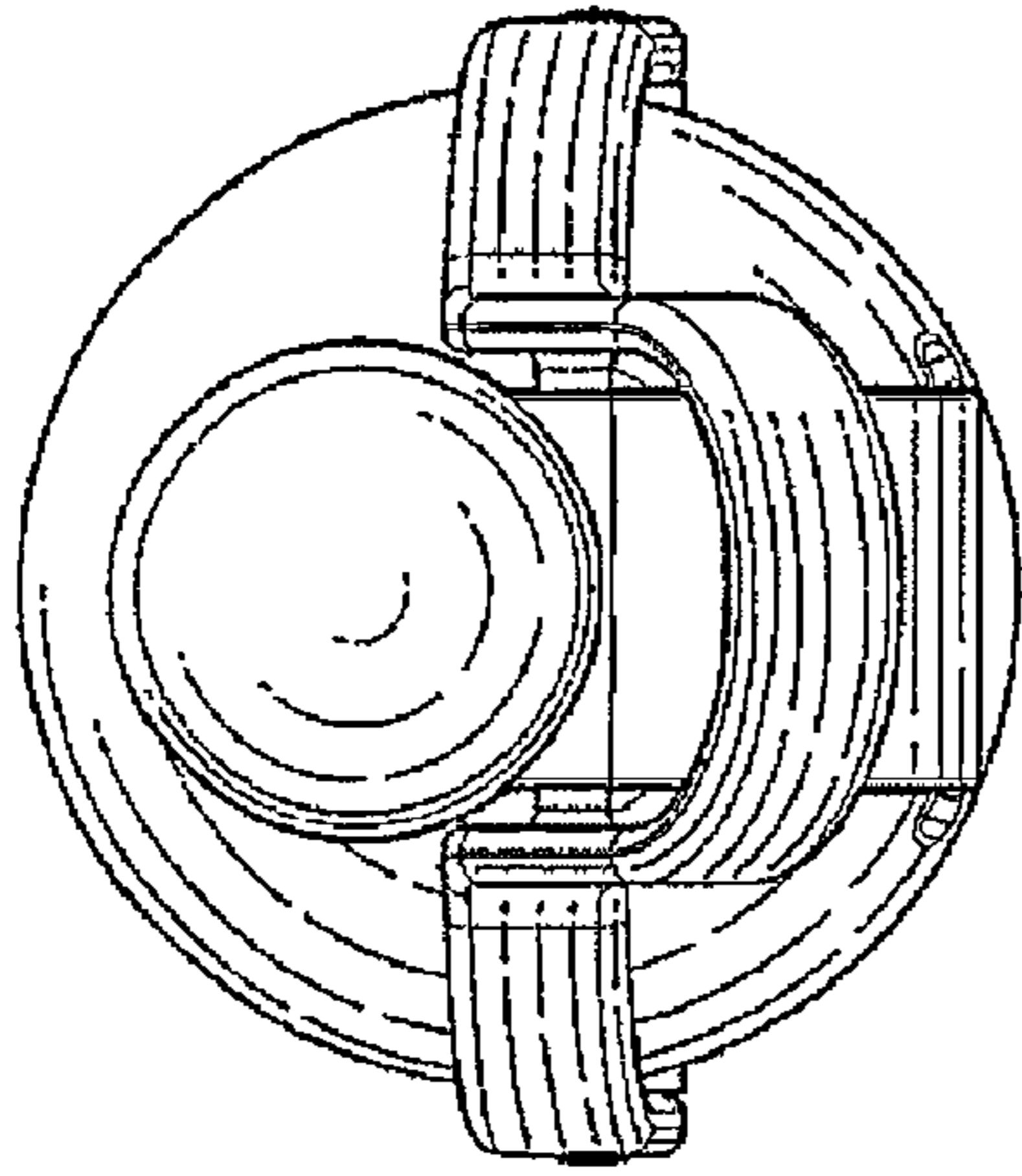

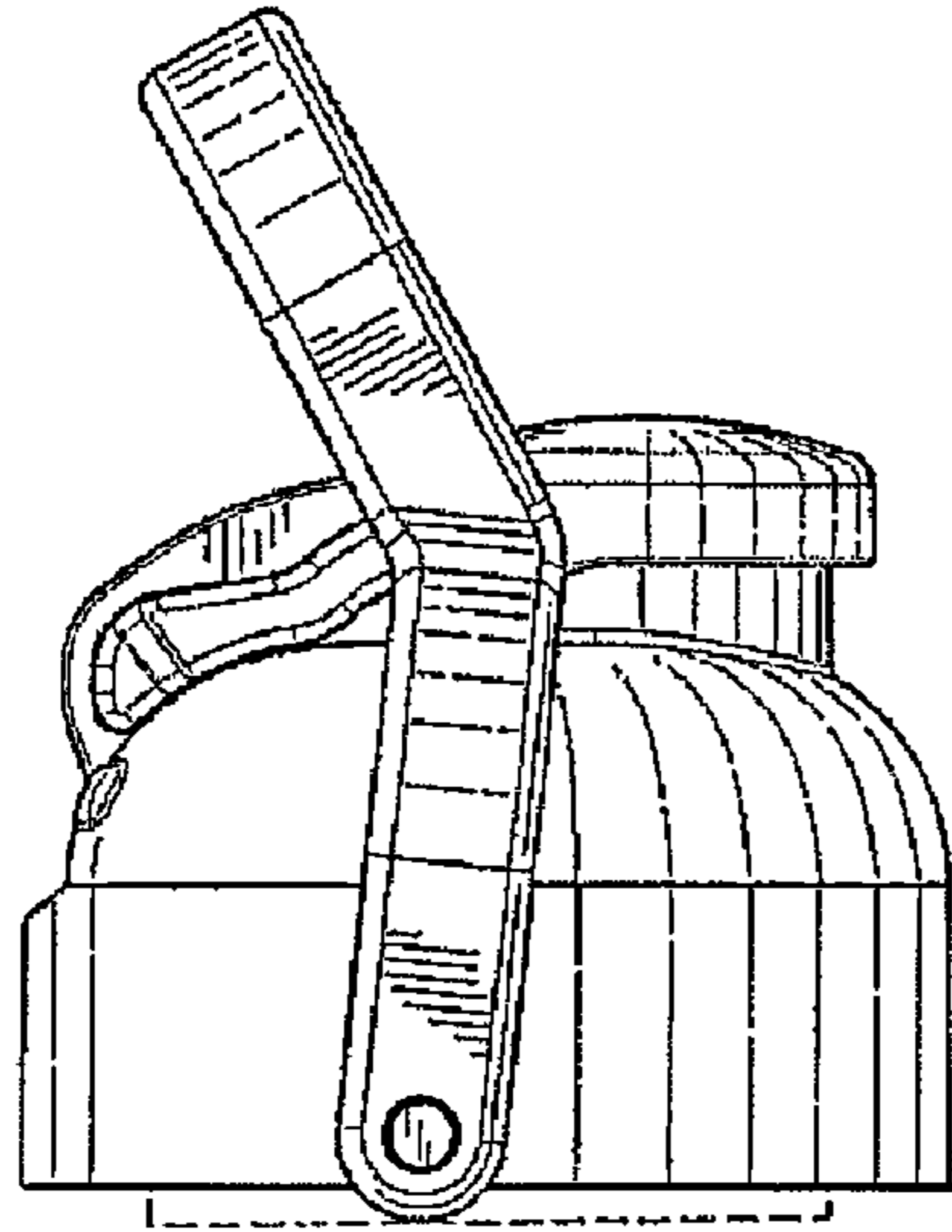

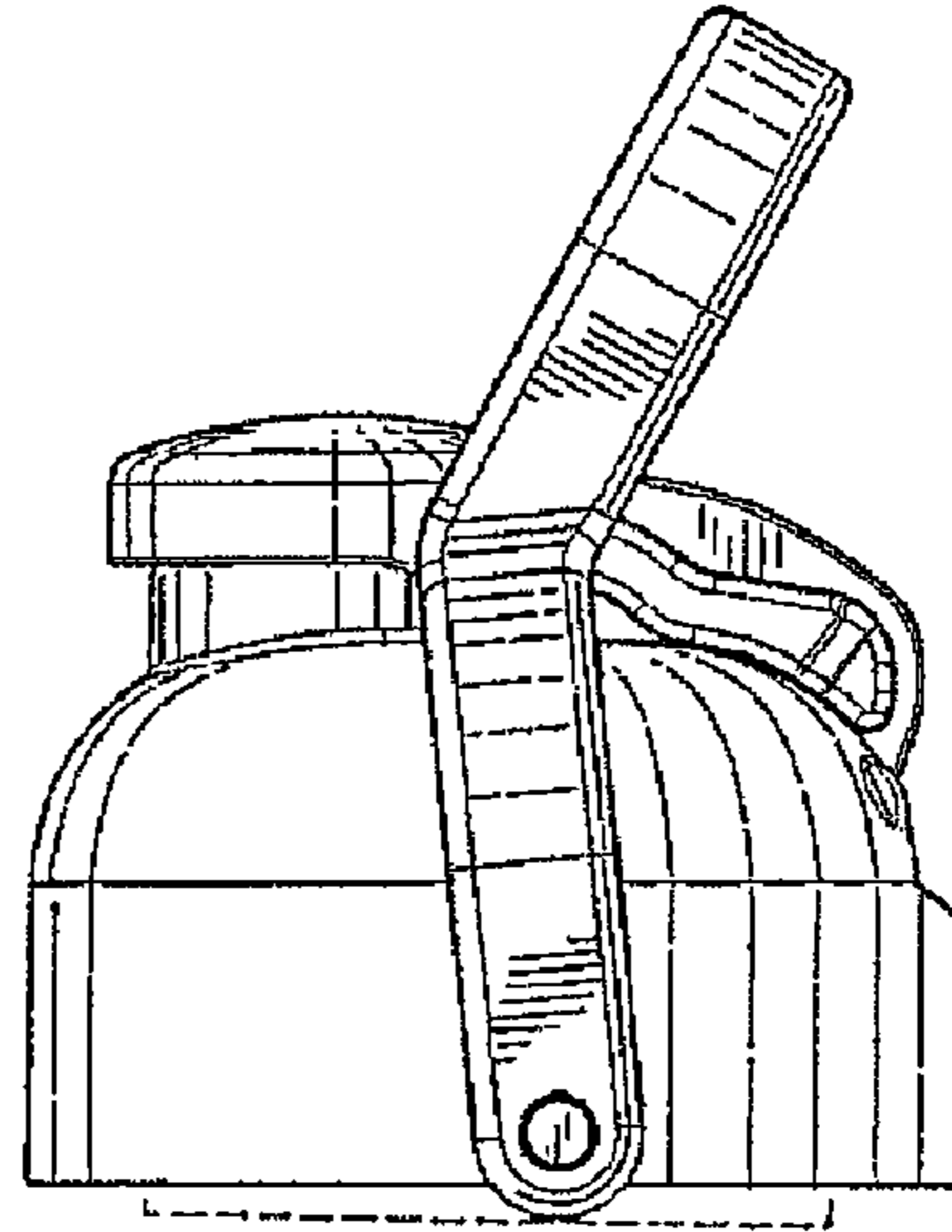

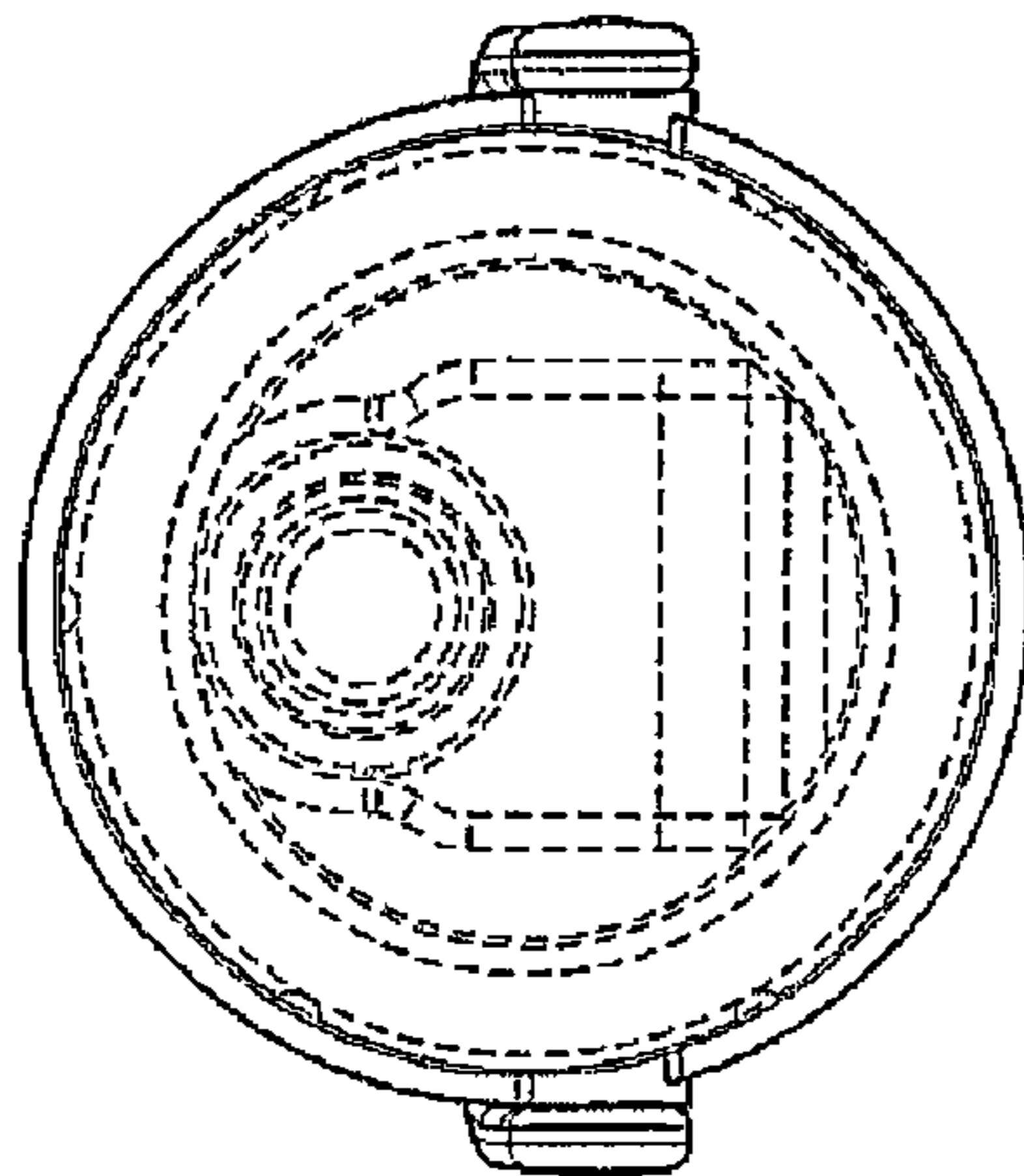

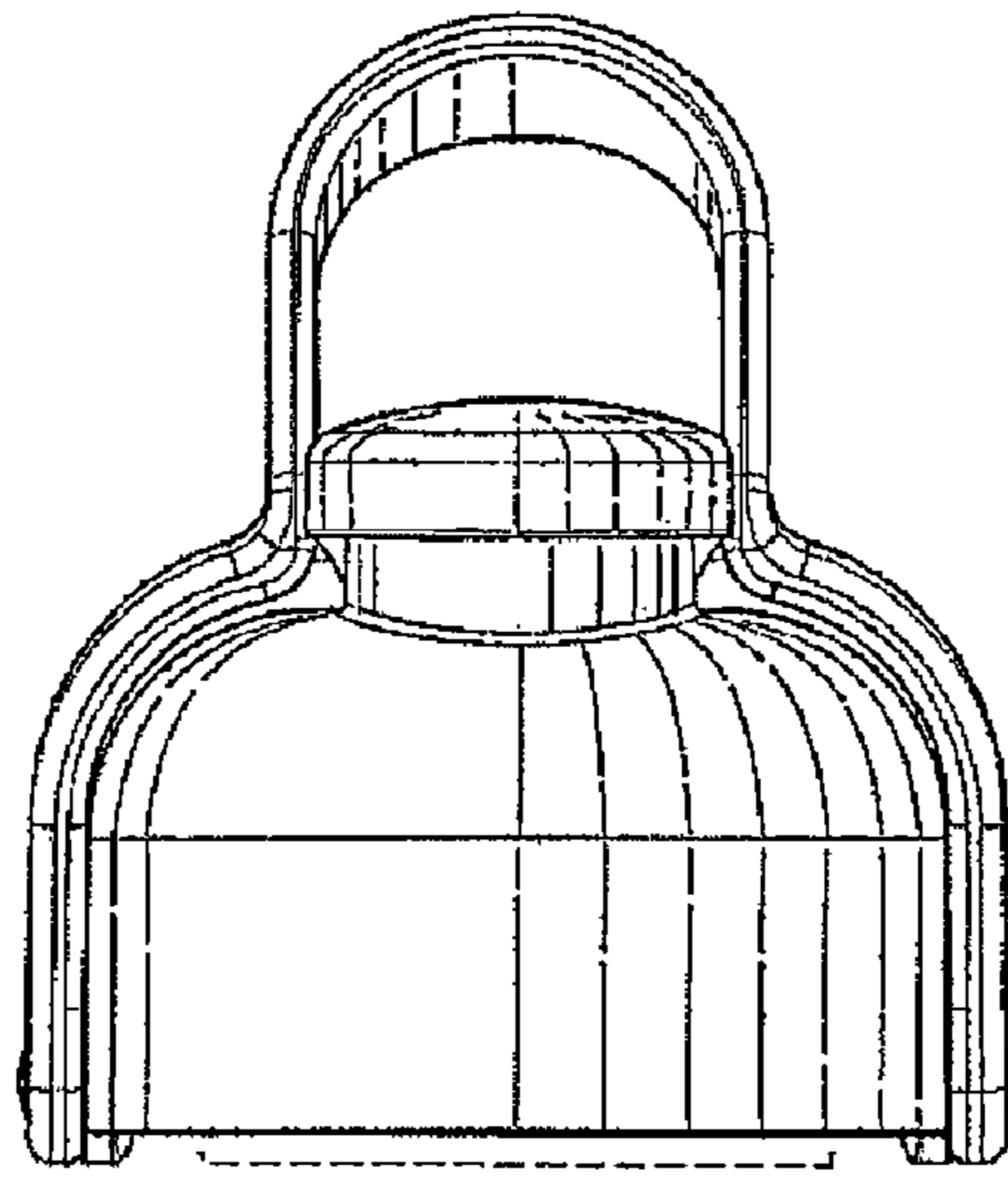

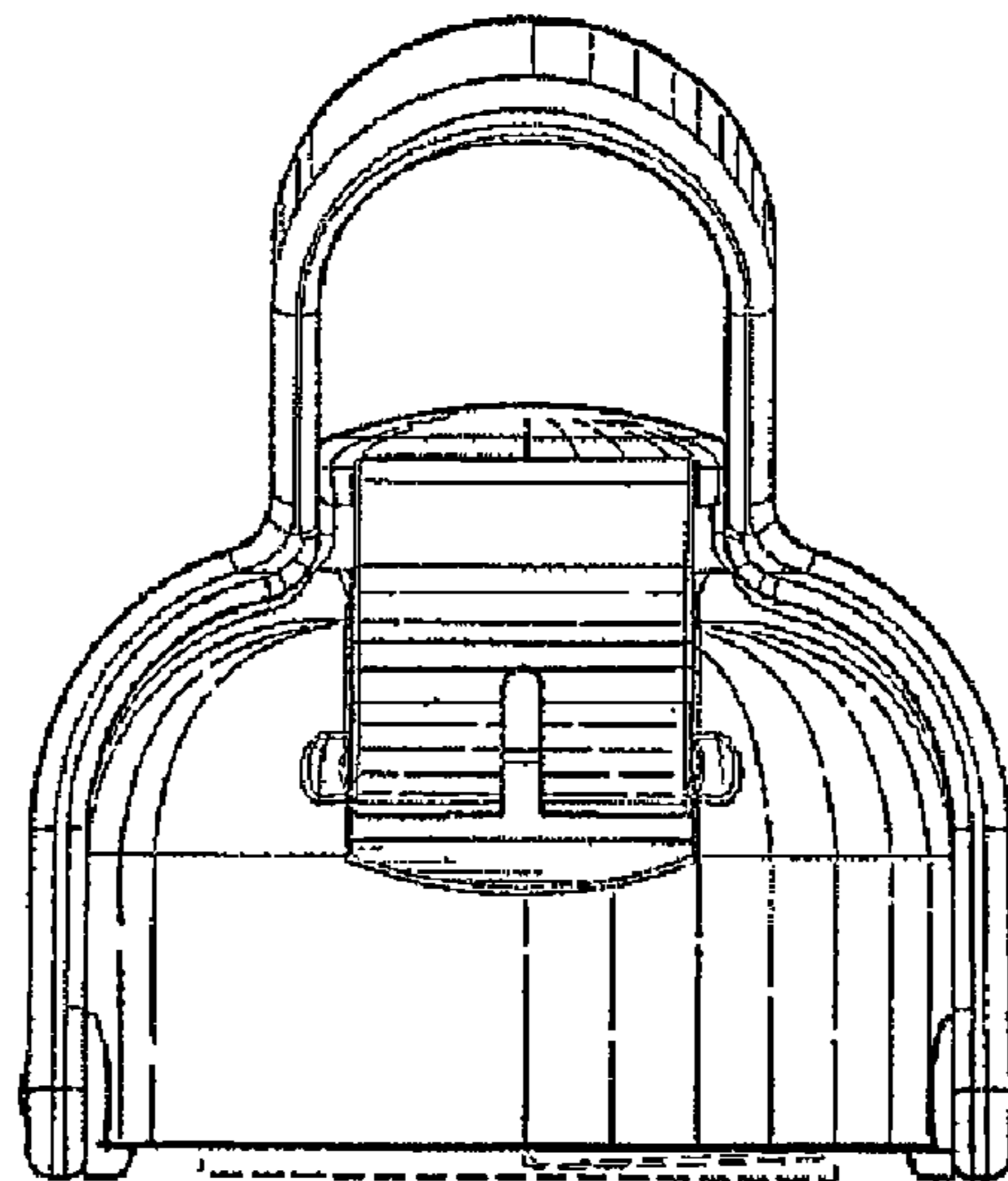
