We claim the ornamental design for a cutting tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the claimed design;

FIG. 4 is a right side view of the claimed design of FIG. 1;
FIG. 5 is a left side view of the claimed design of FIG. 1;

FIG. 7 is a rear view of the claimed design of FIG. 1.

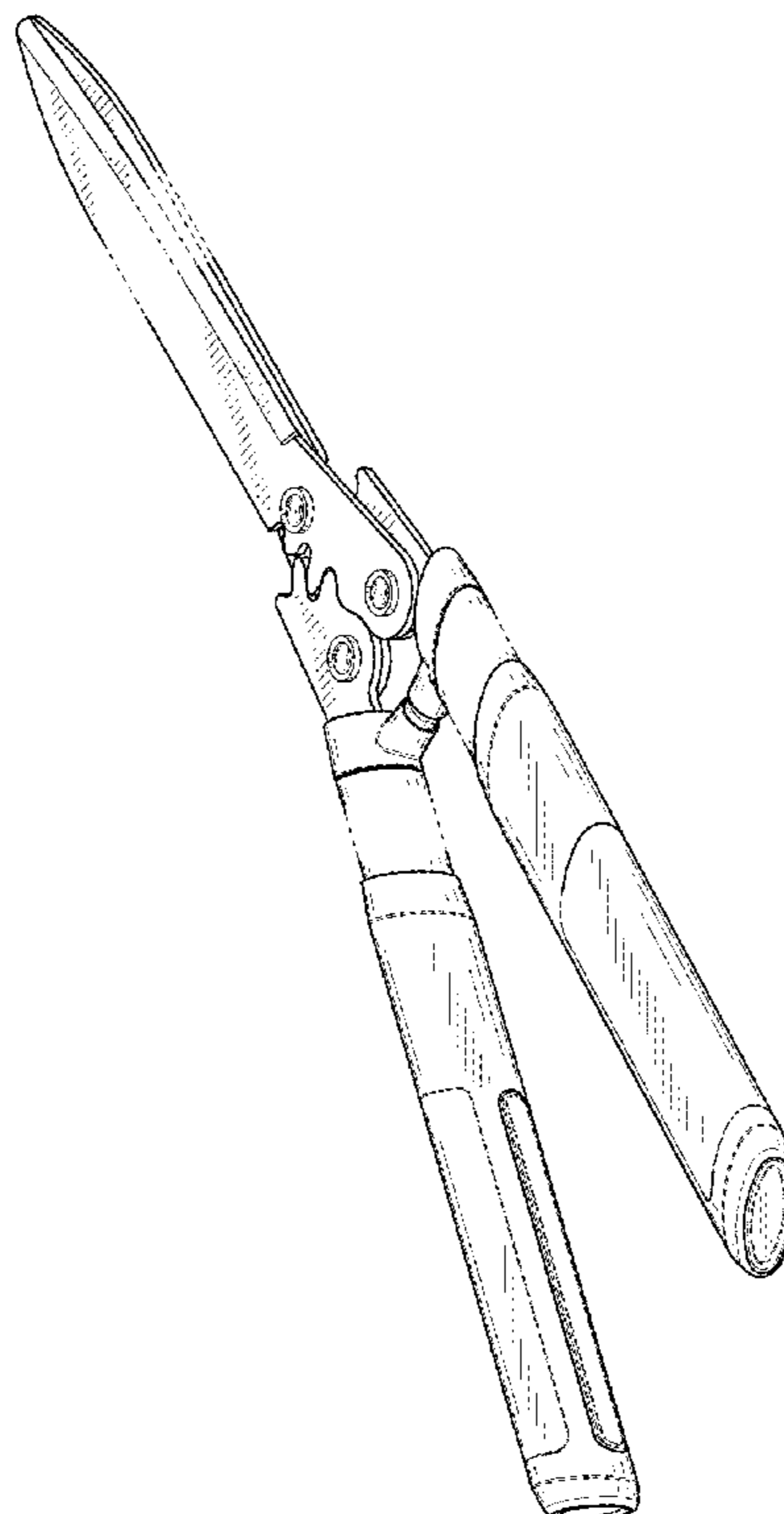

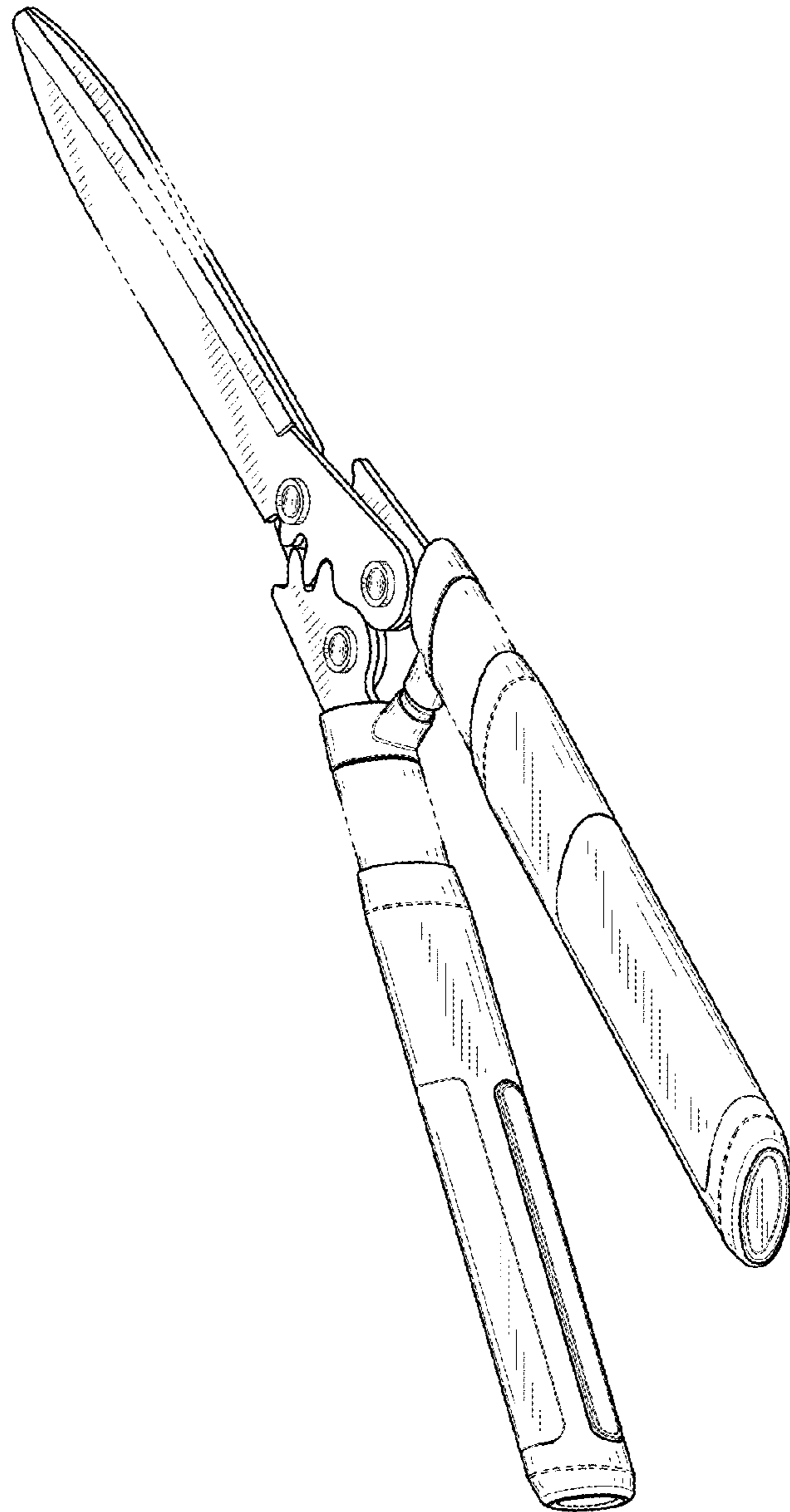

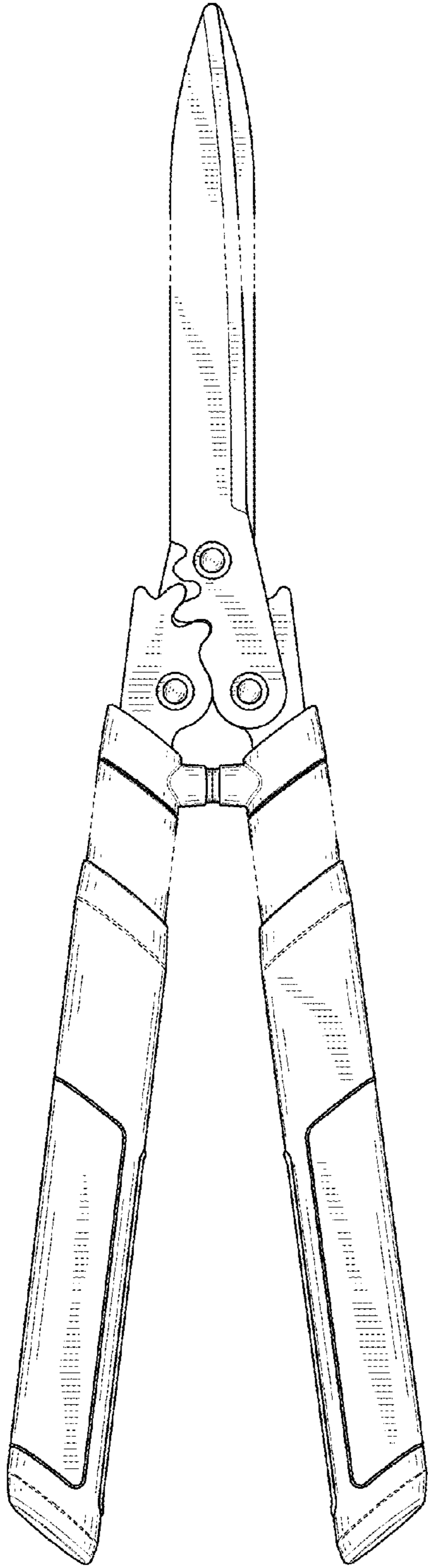

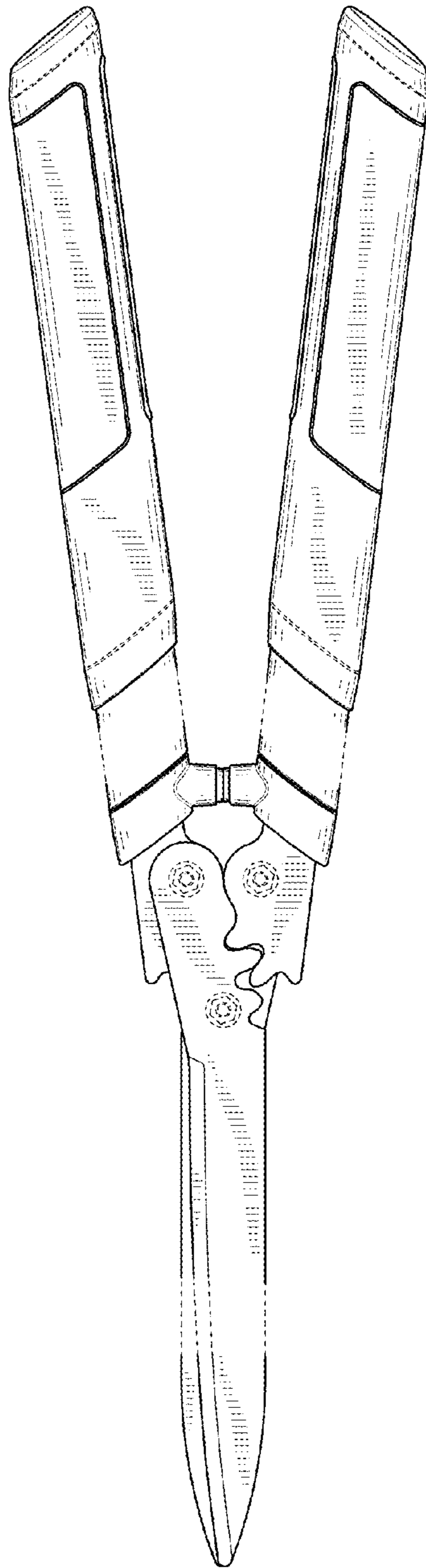

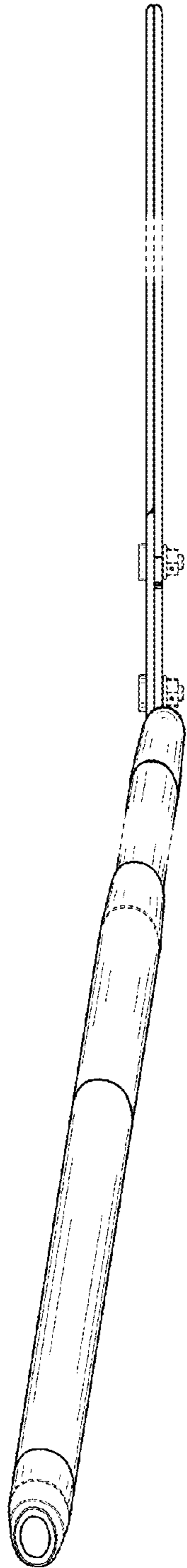

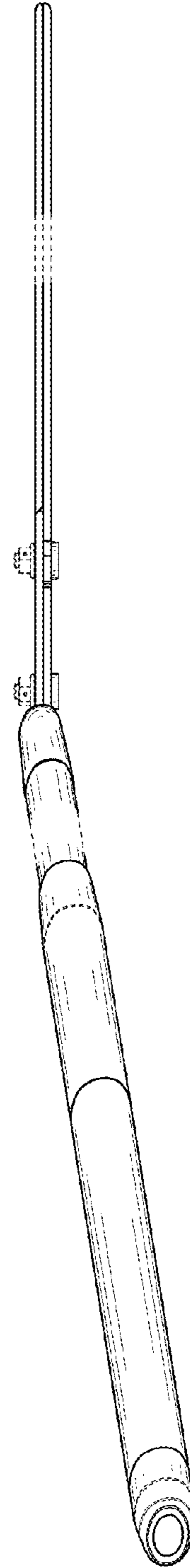

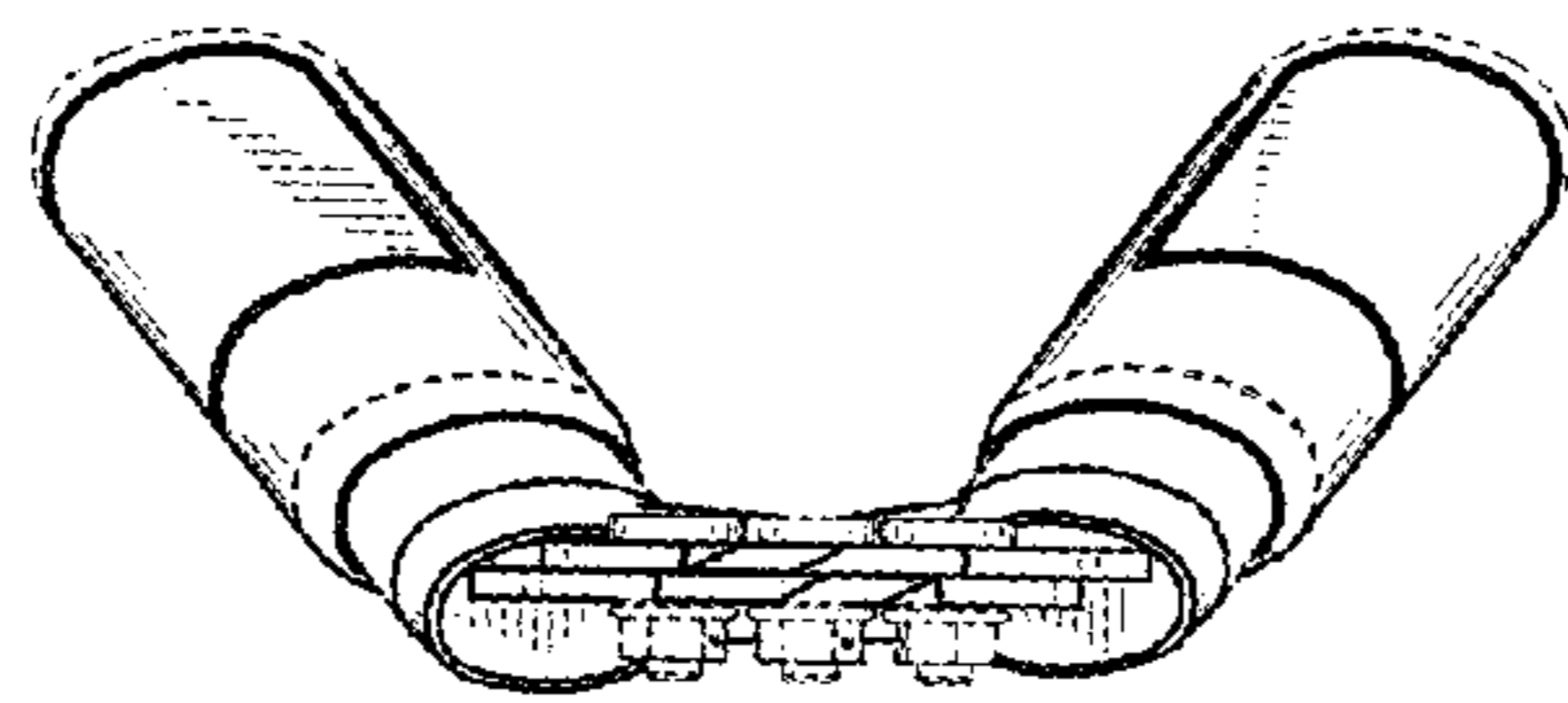
