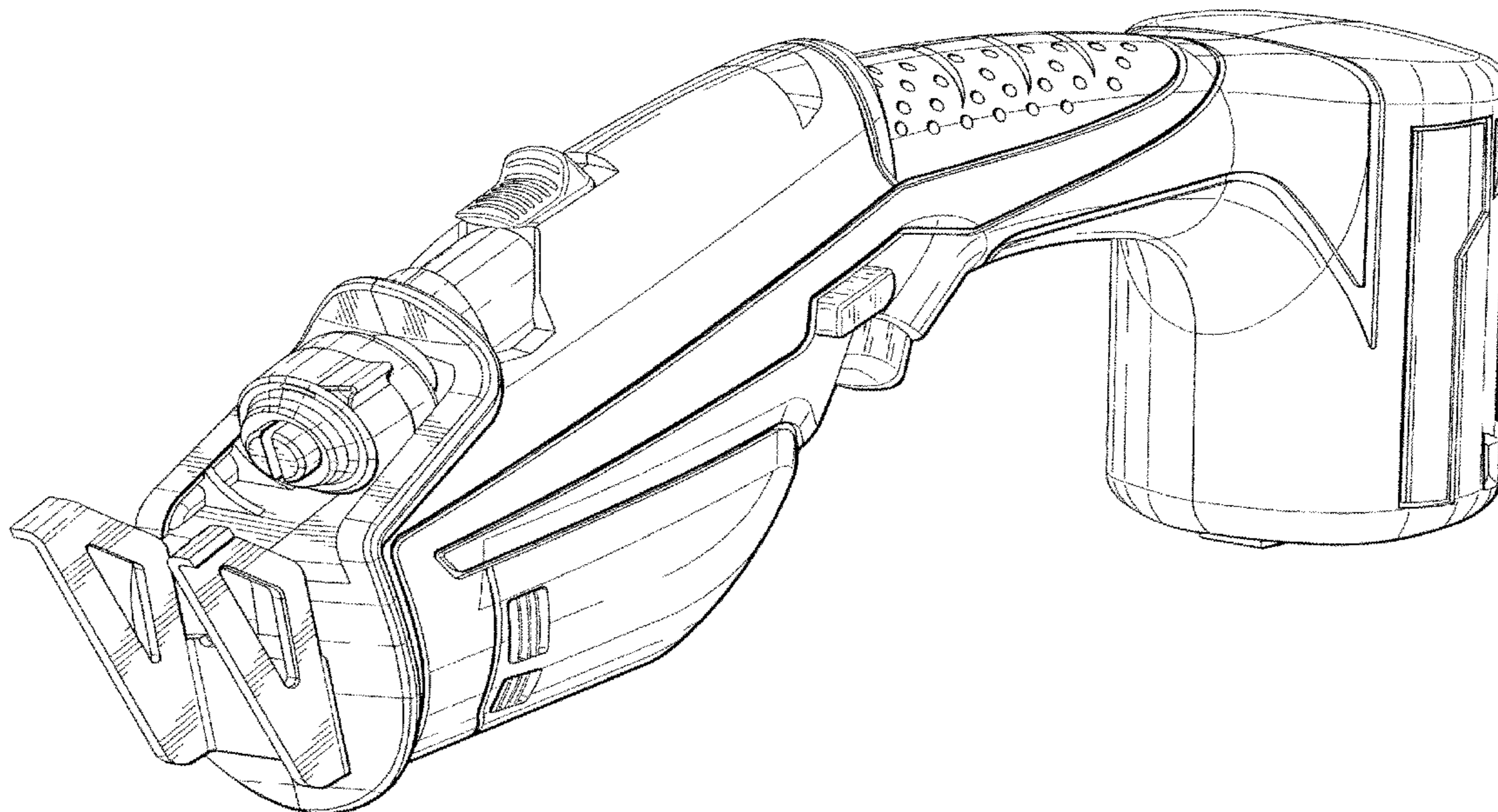
FIG. 1 is a perspective view of a saw showing my new design;

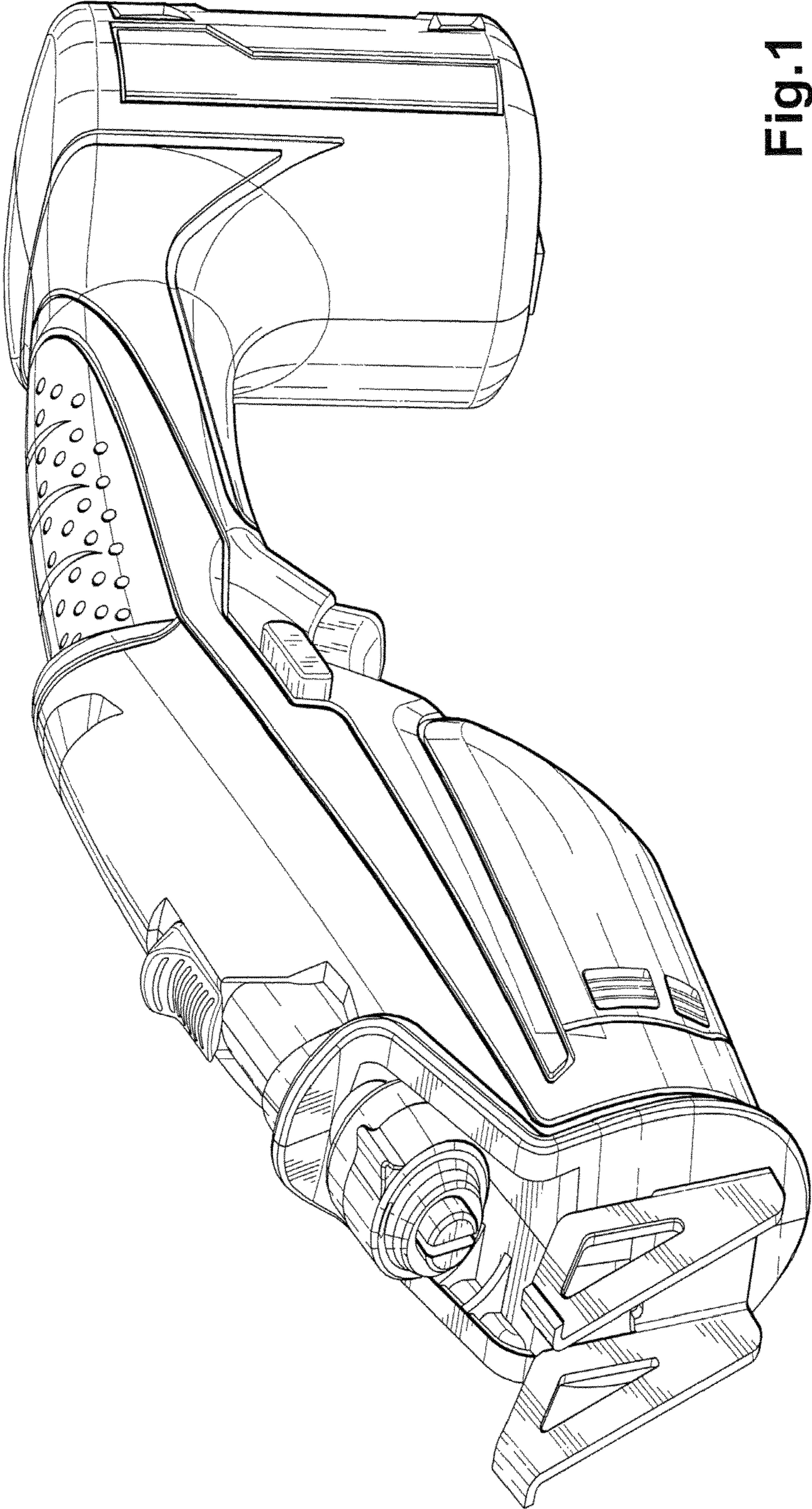

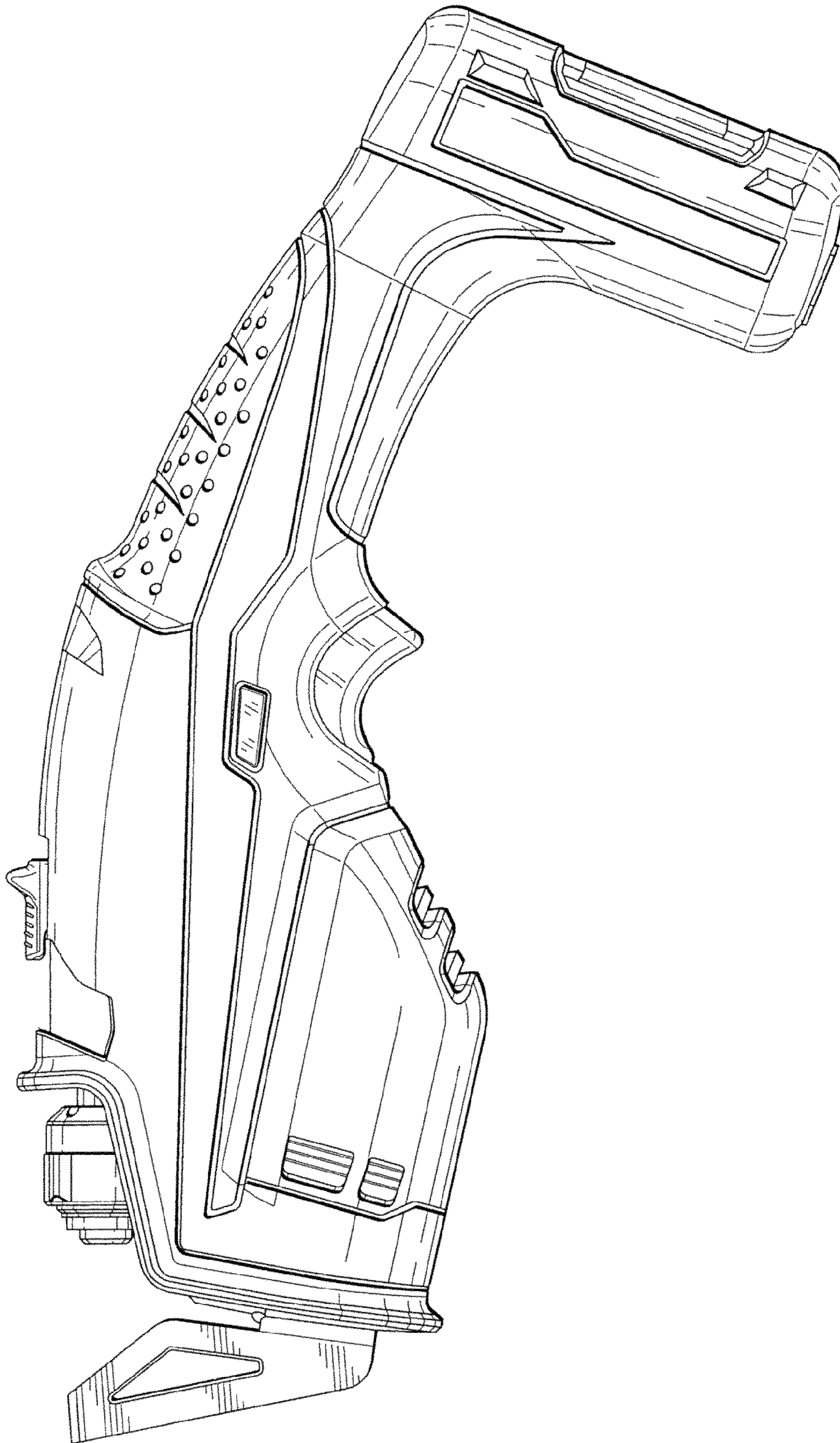

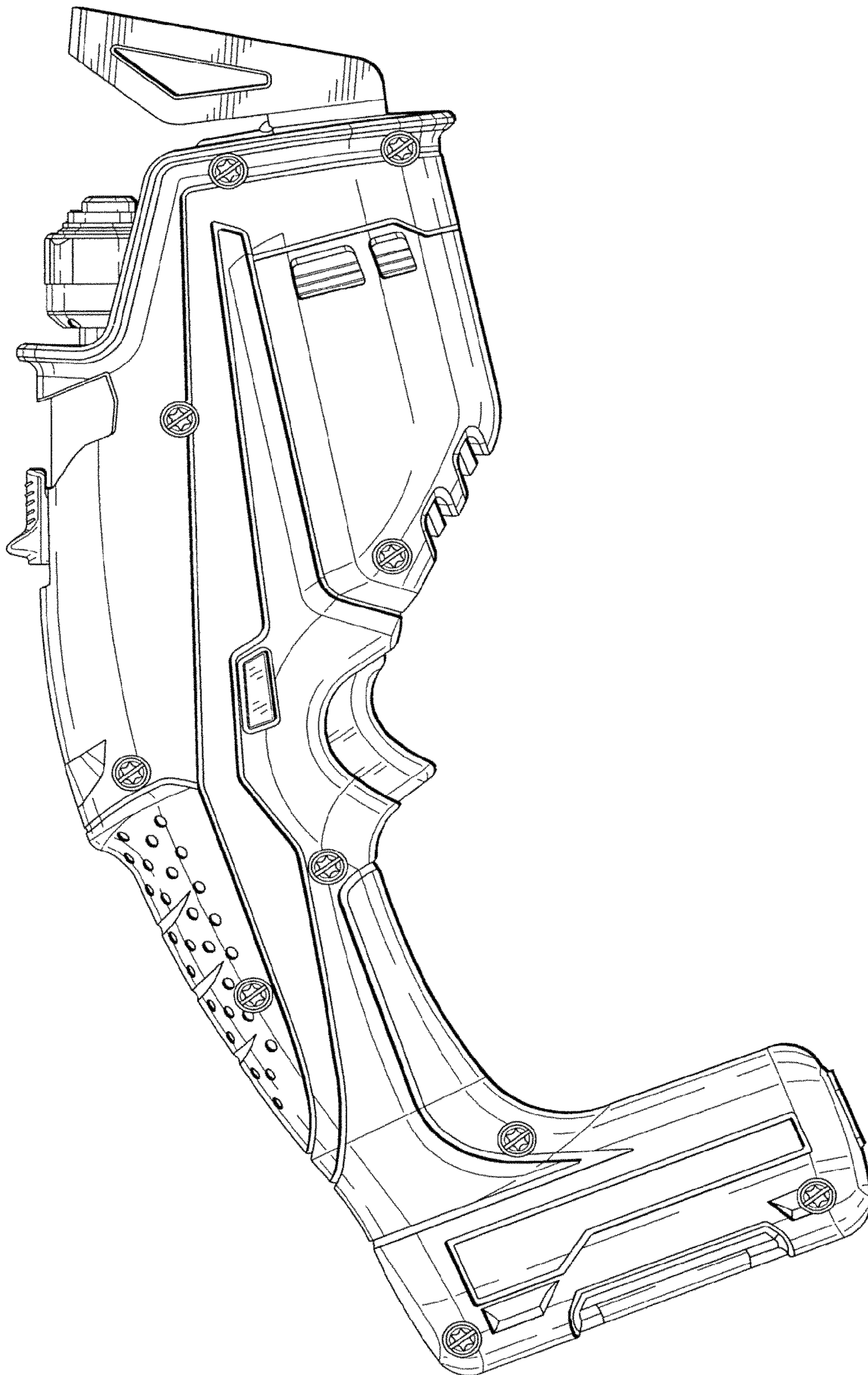

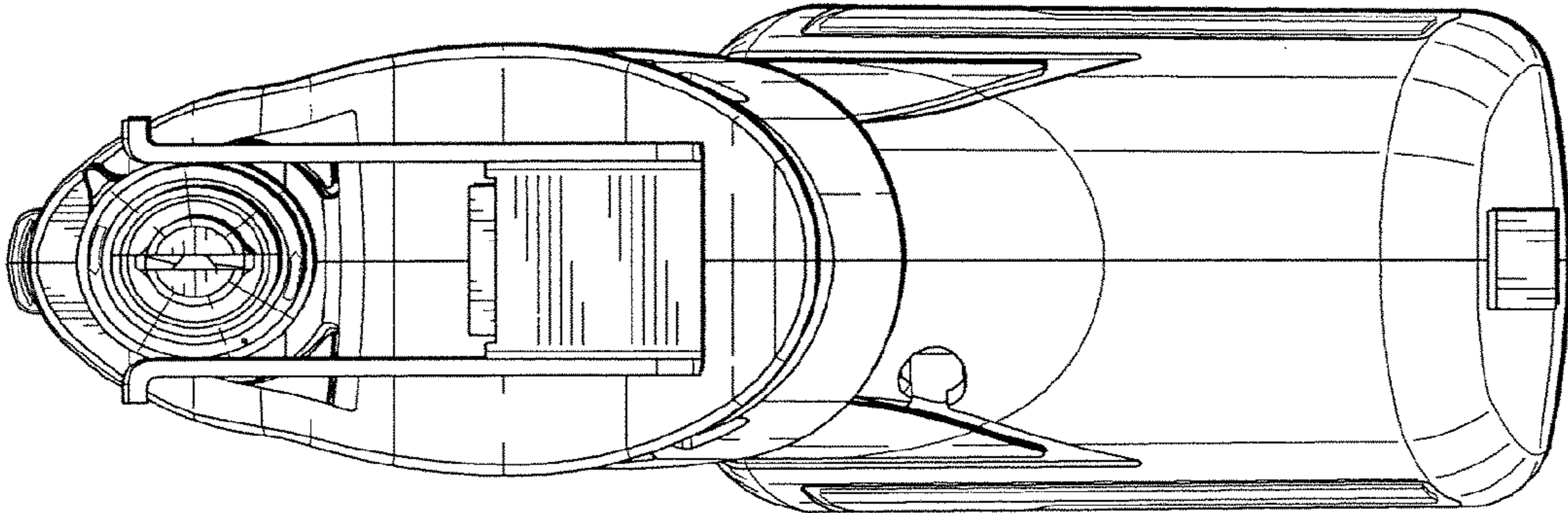

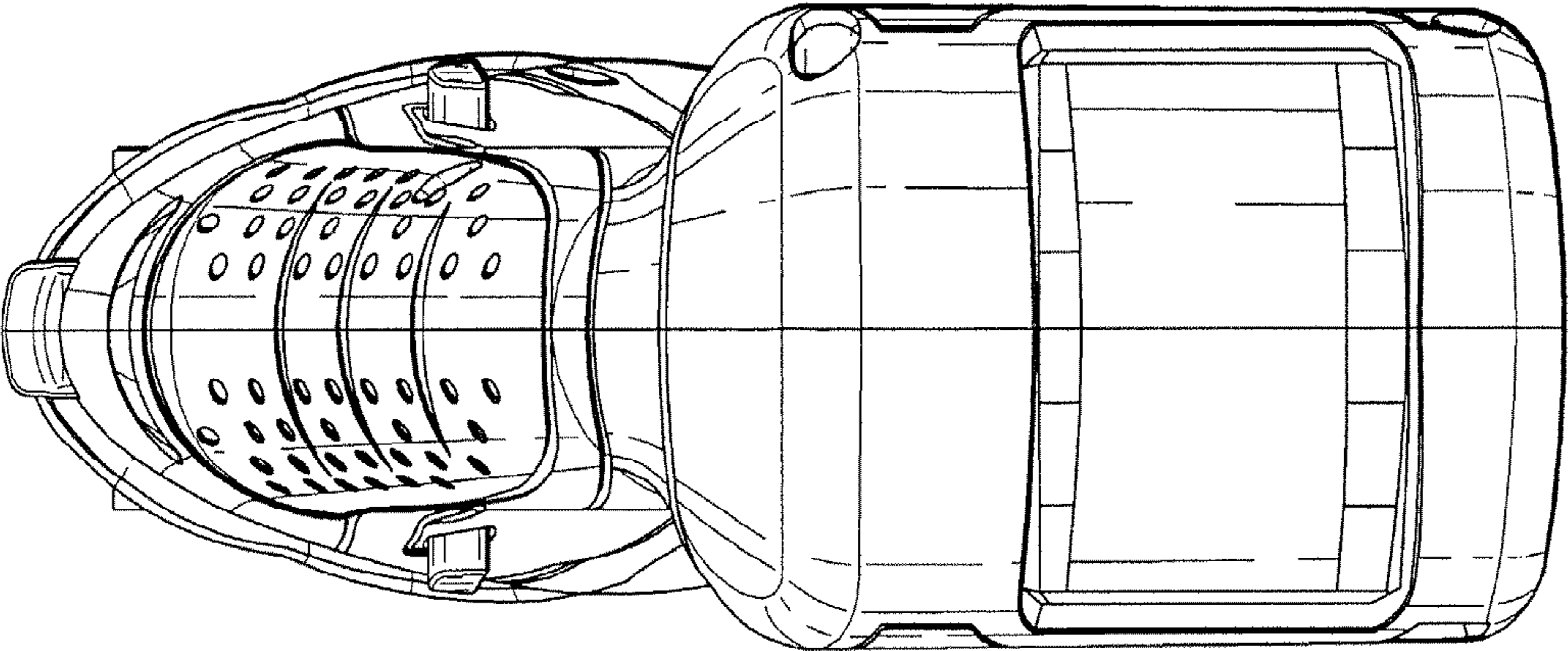

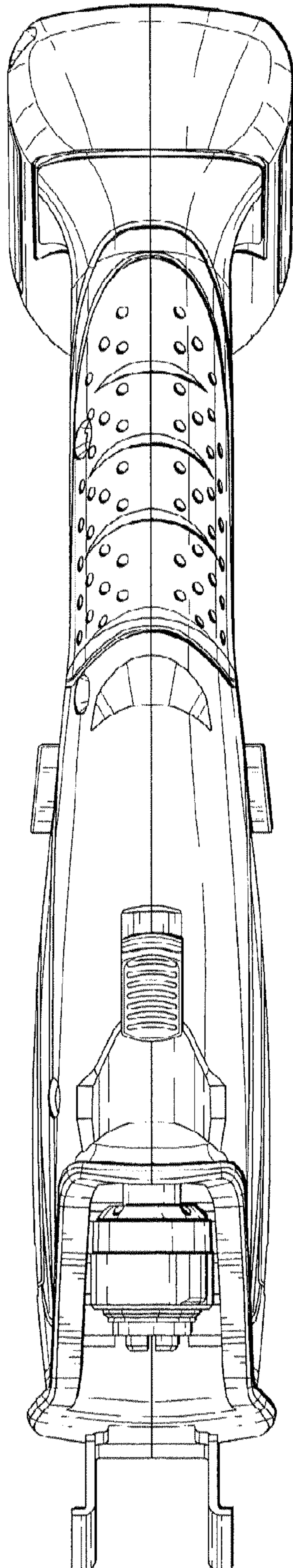

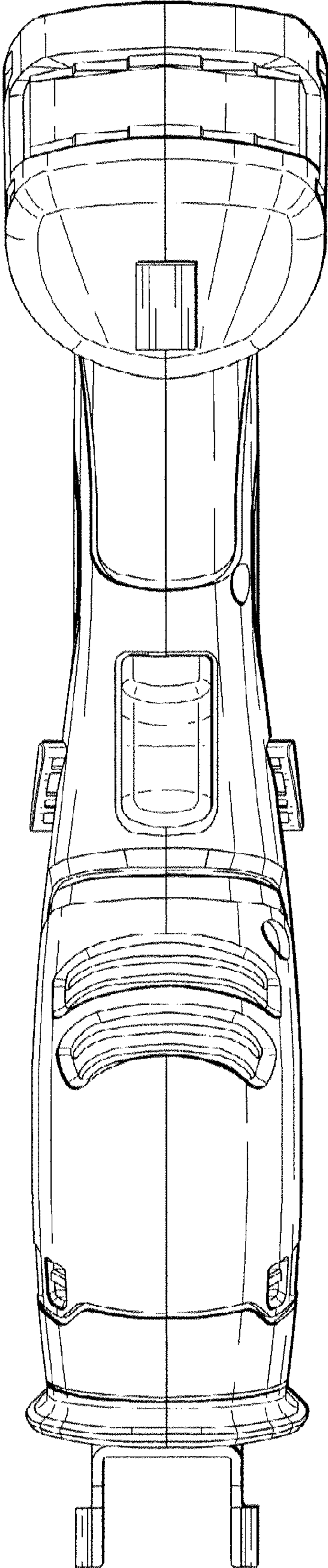
