(57) **CLAIM**

We claim the ornamental design for a flask with cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our new design for a flask with cap, shown with the cap removed;

FIG. 8 is a left side elevation view thereof;

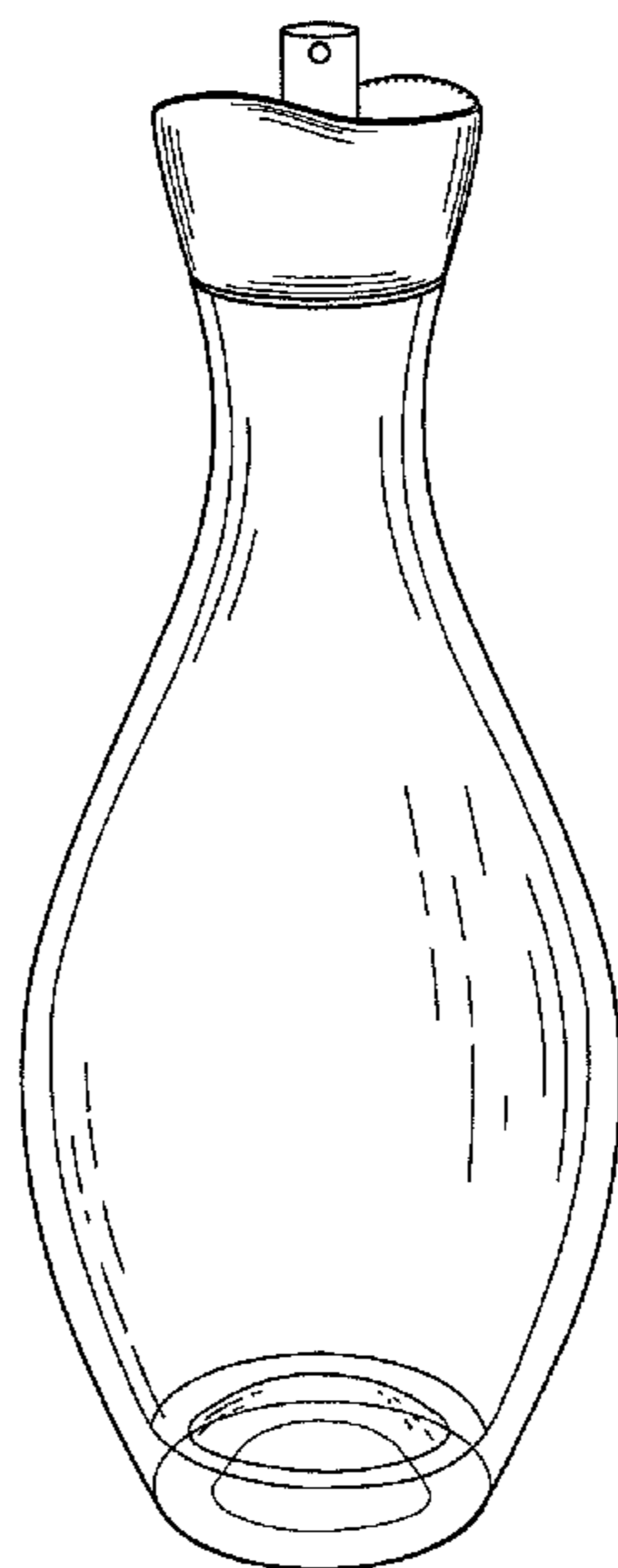
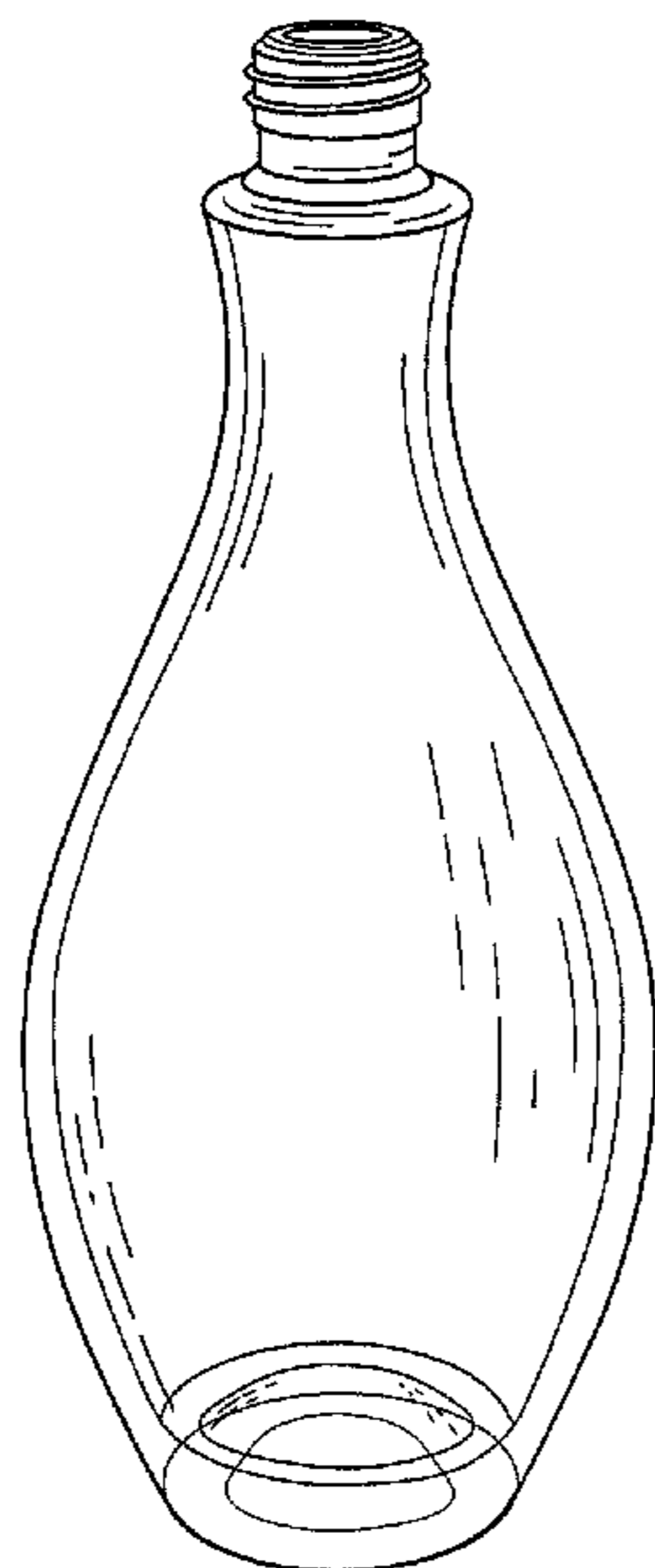
FIG. 9 is a top plan view thereof; and,

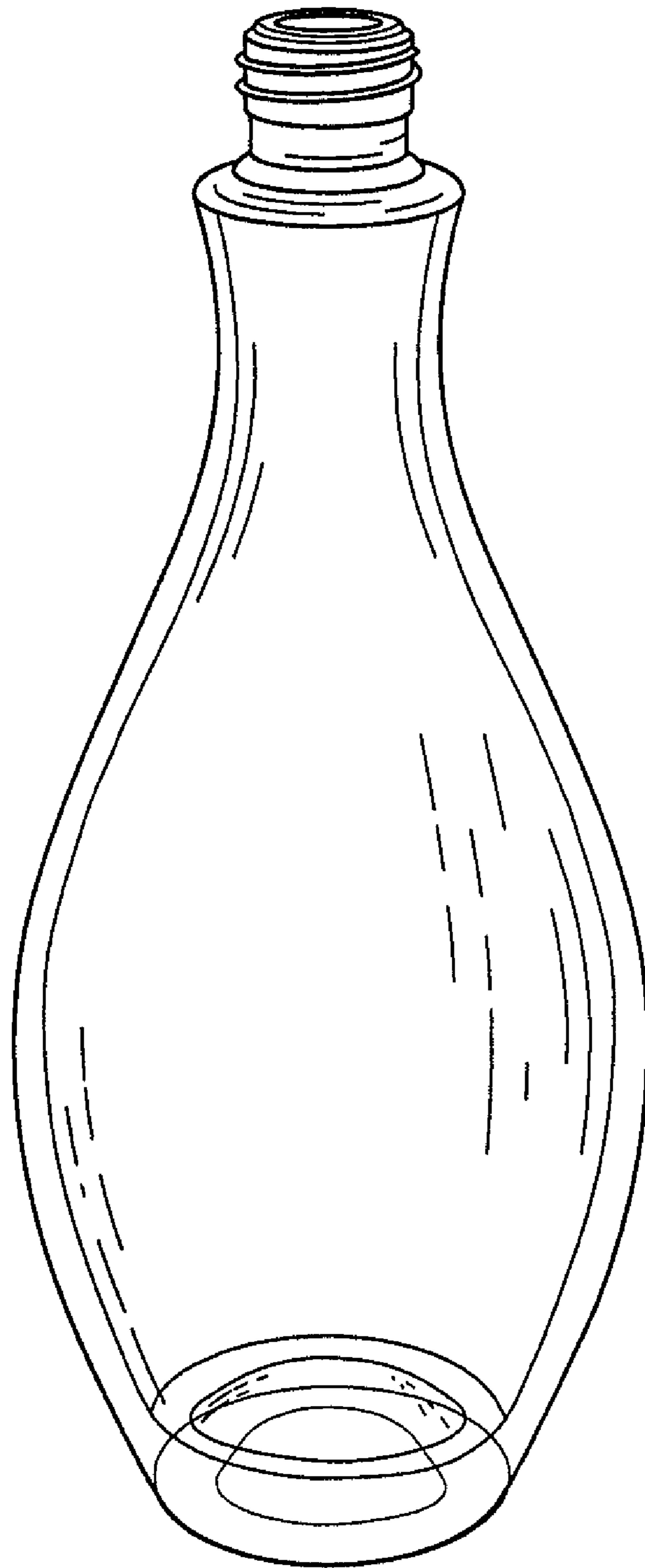

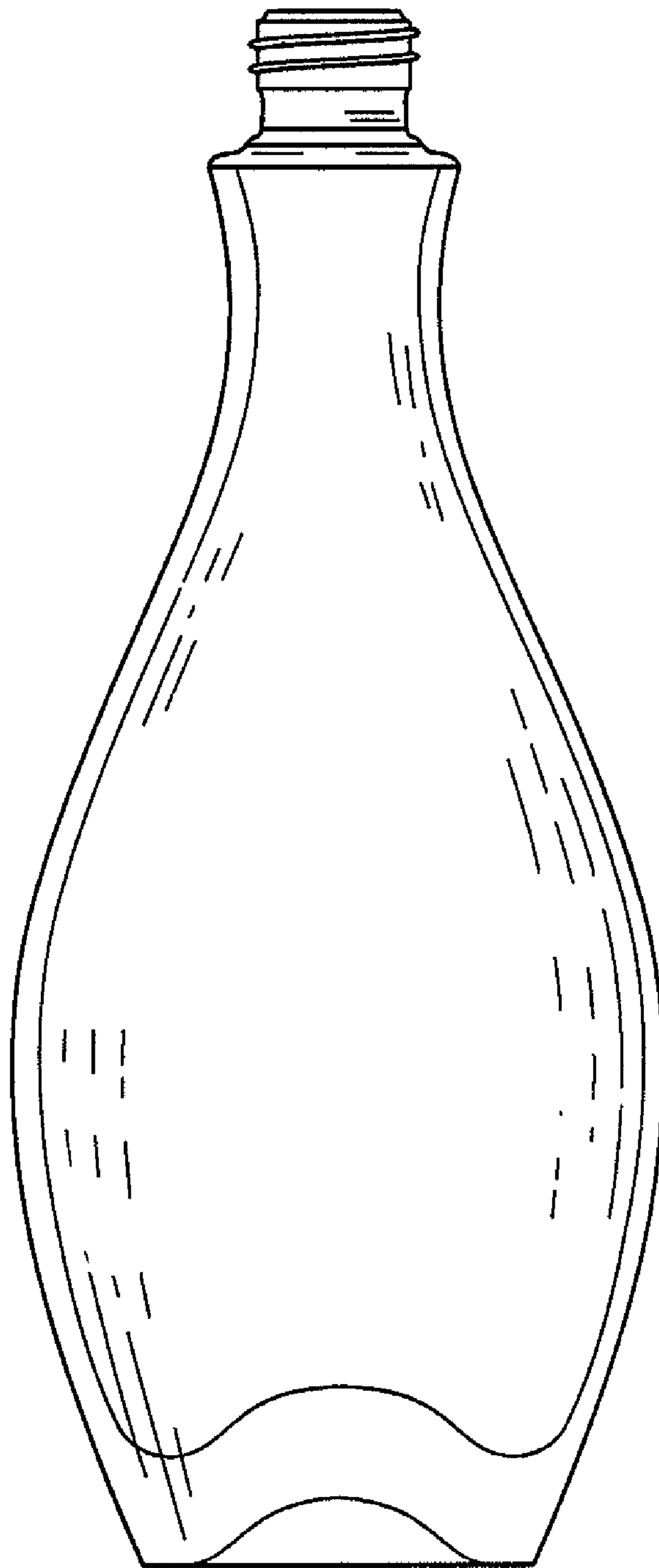

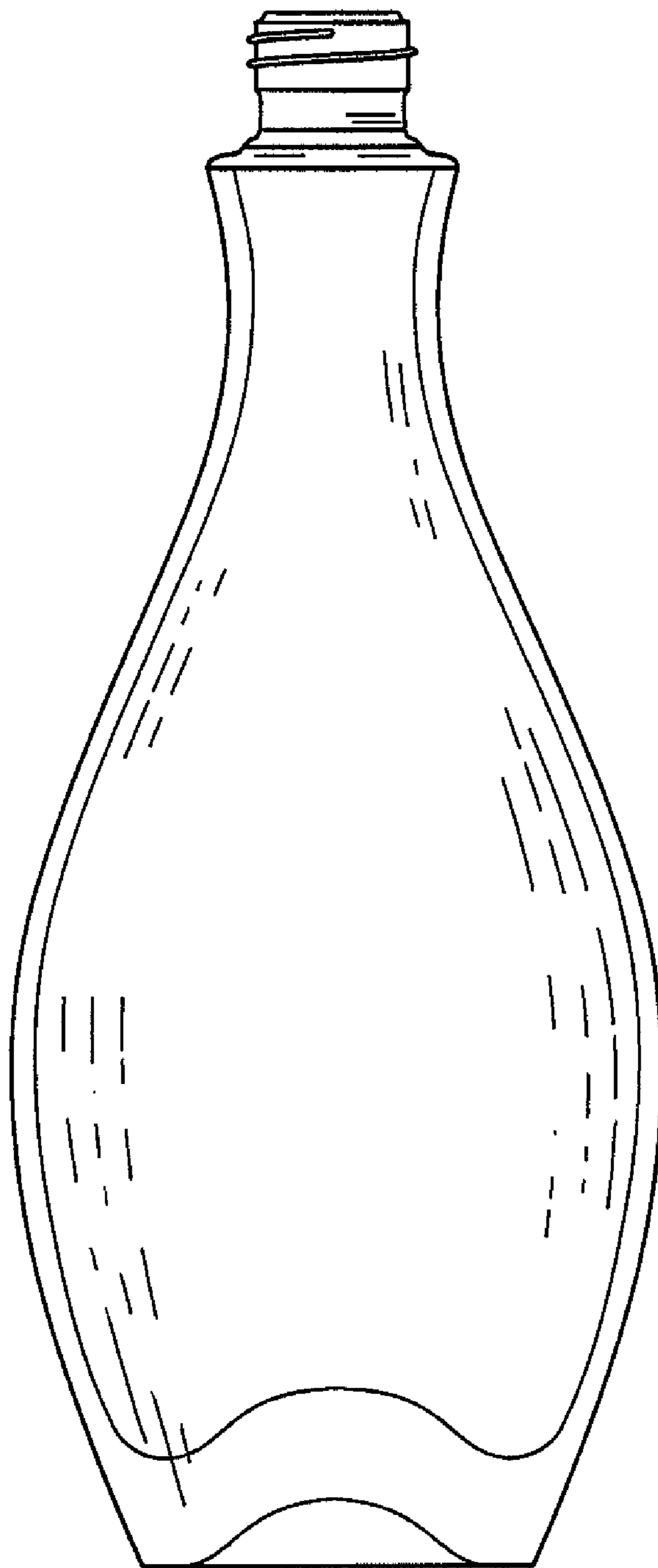

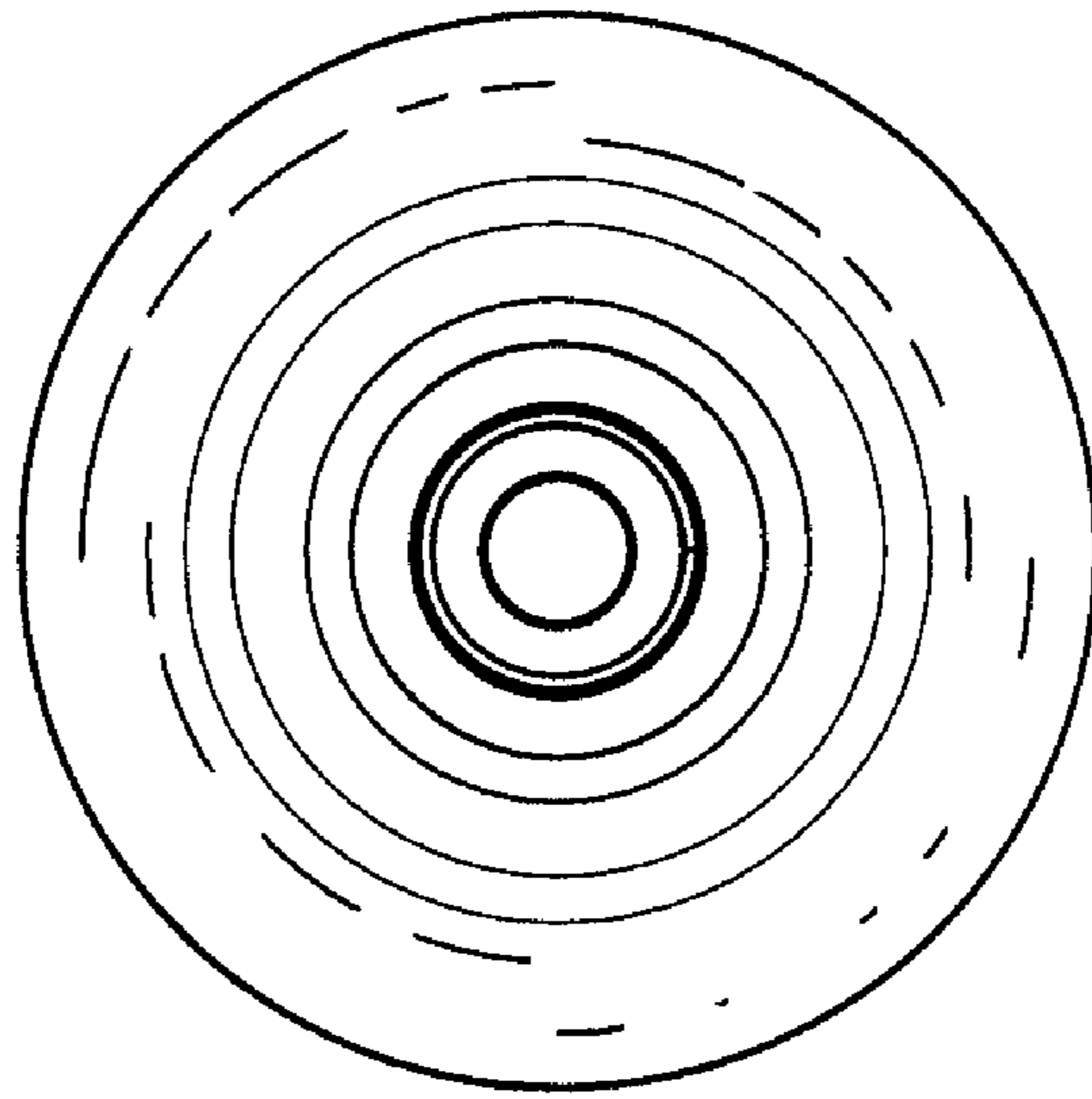

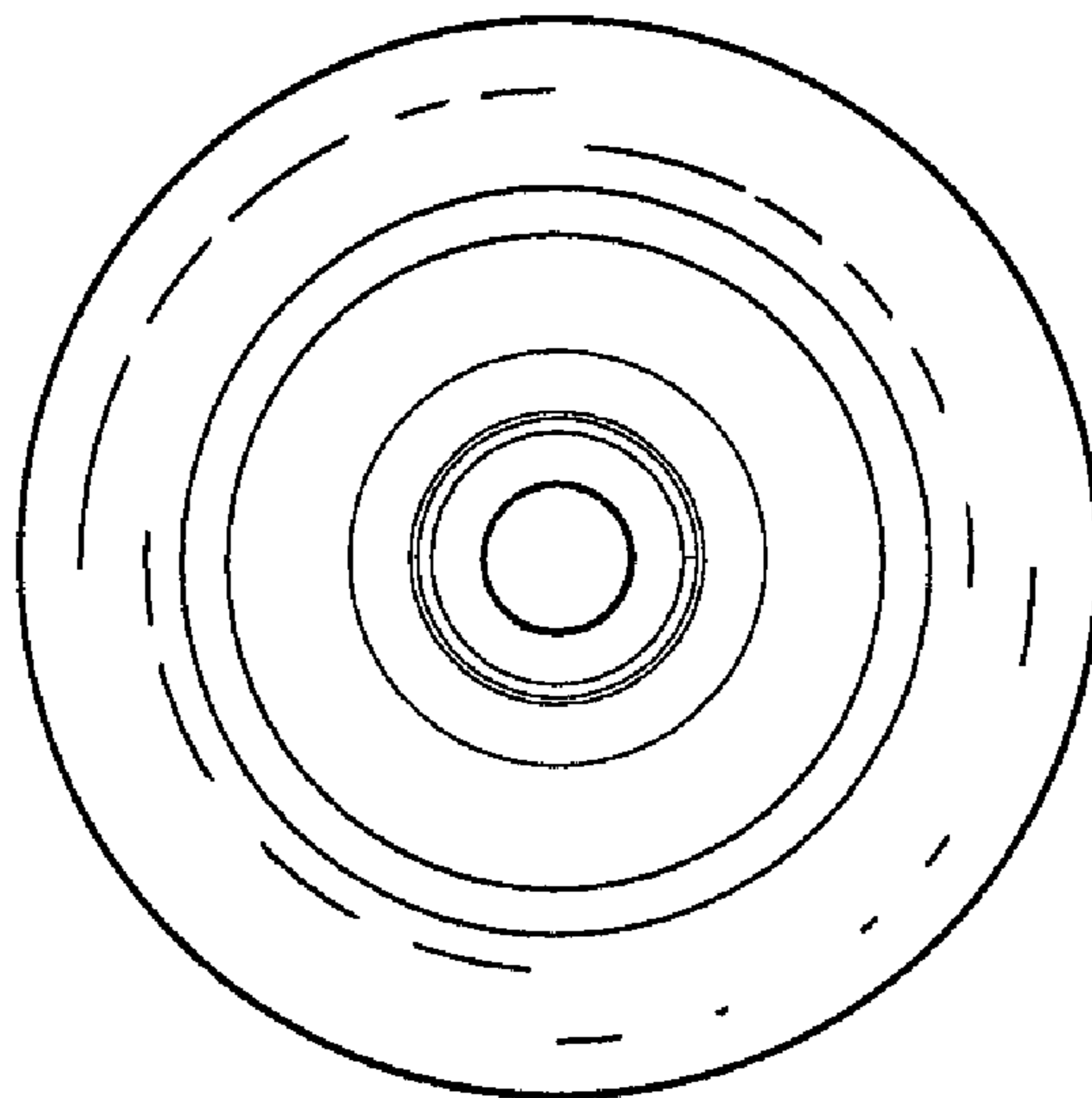

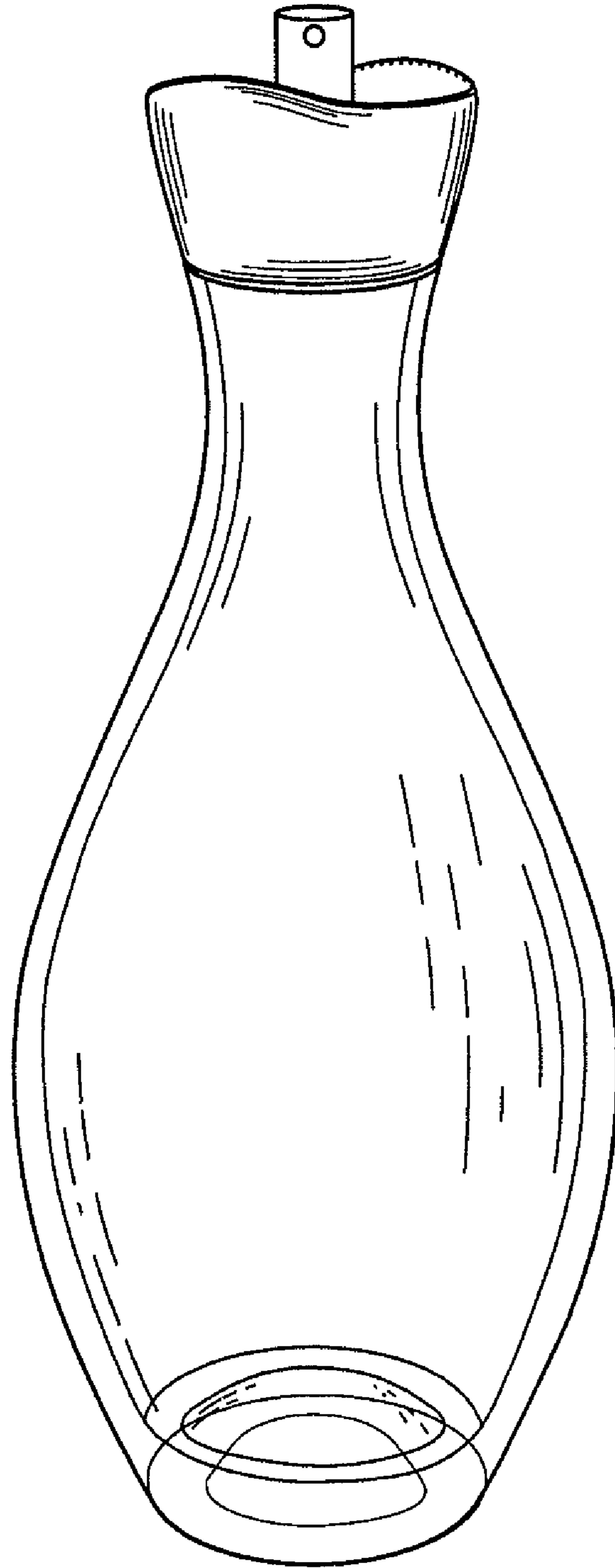

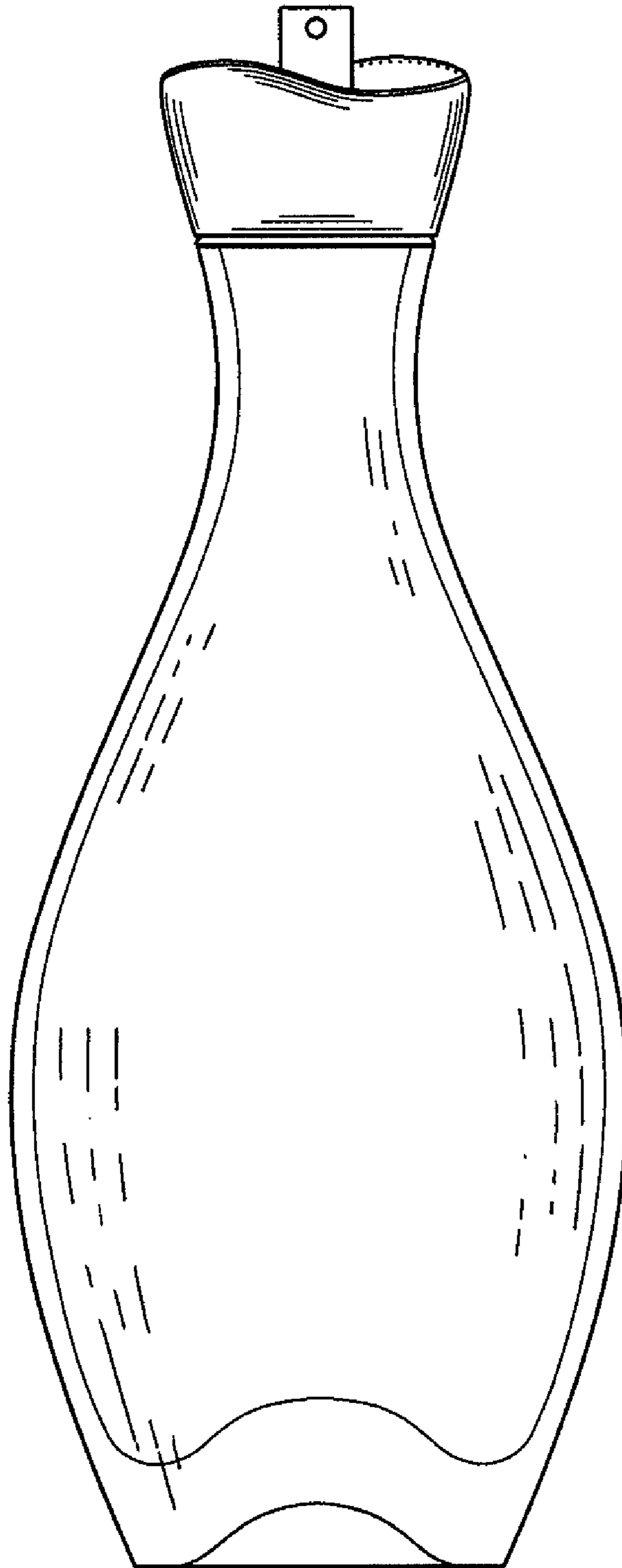

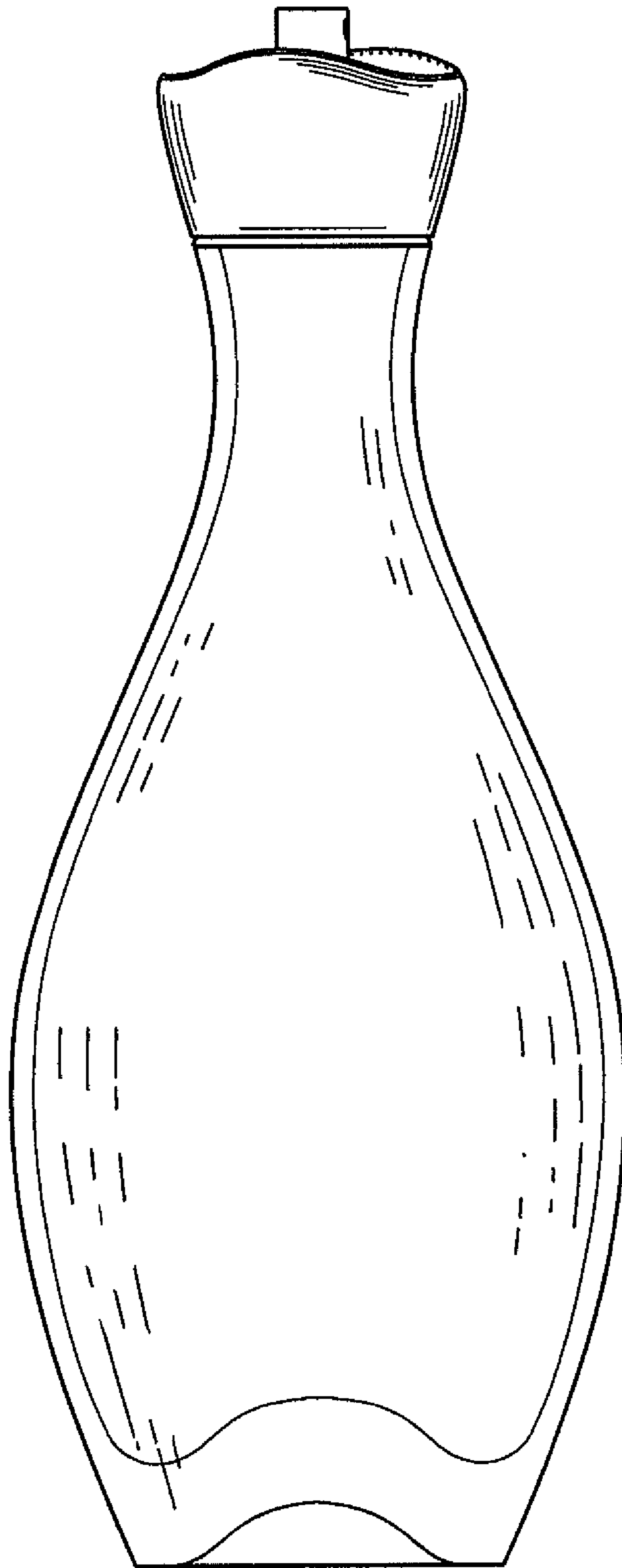

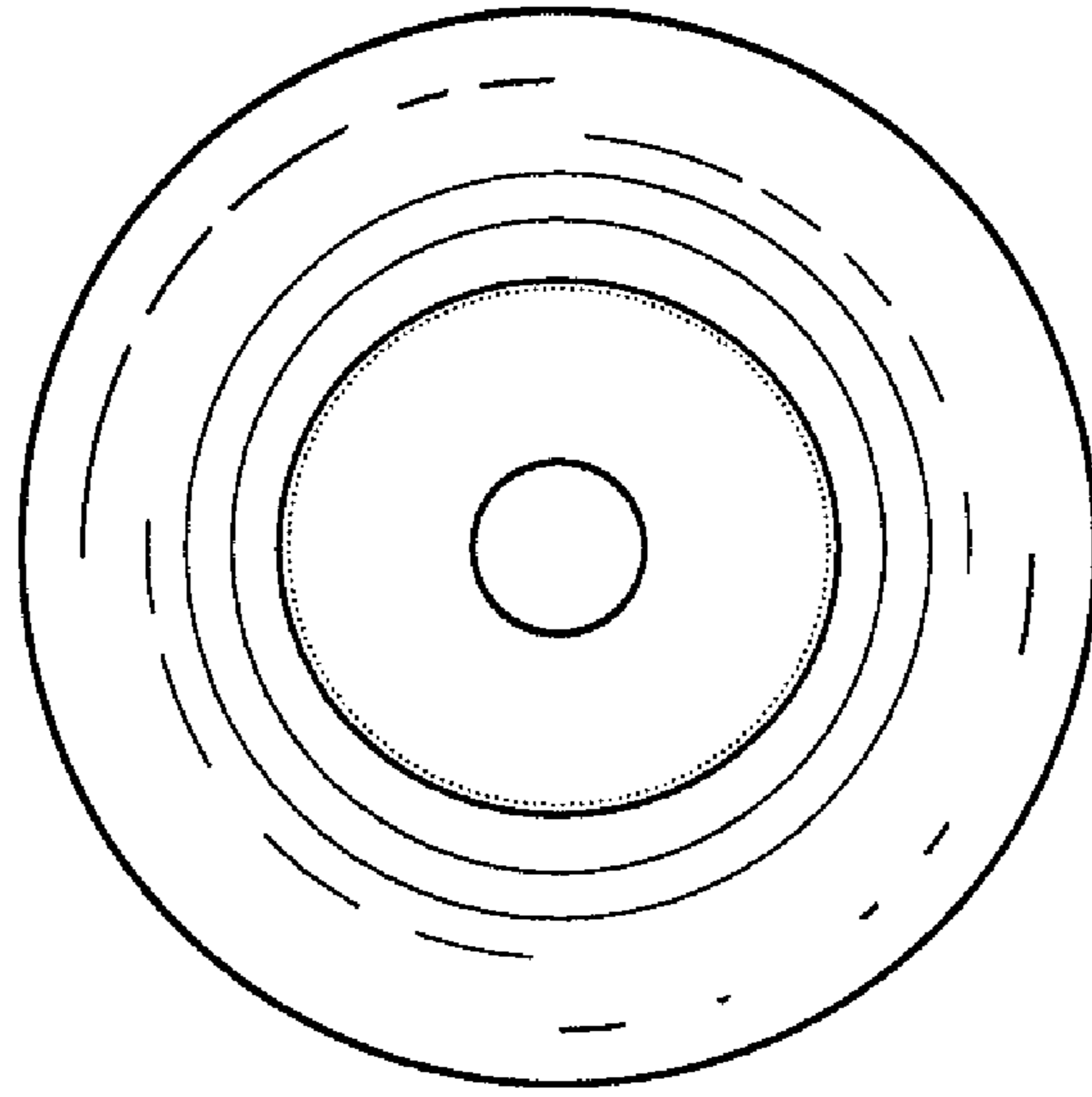

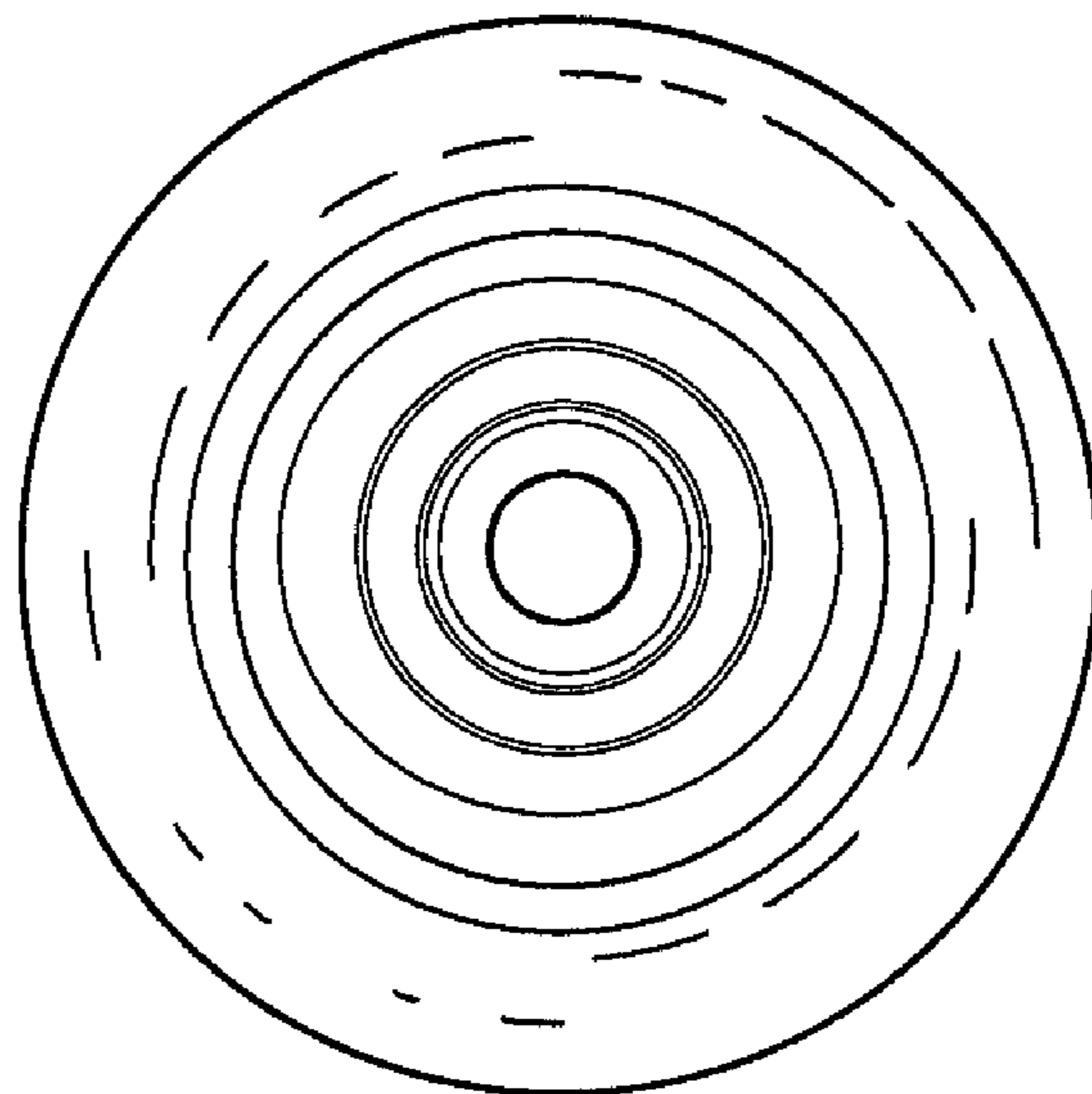
