**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a design for a front portion of an automobile showing our new design;

FIG. 6 is a top plan view thereof.

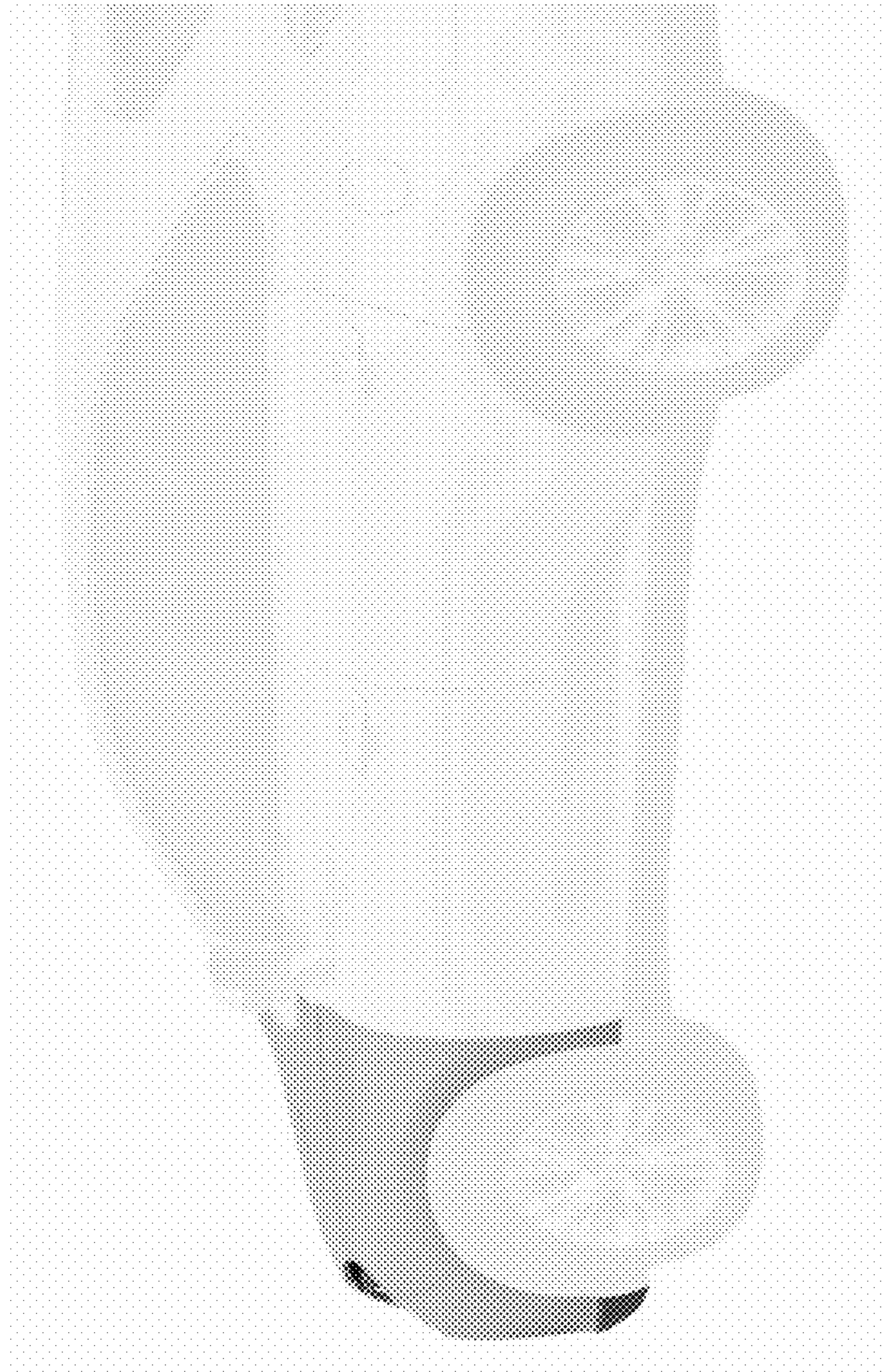
The portion of the vehicle in light contrast is environment and is not a part of the claimed design.

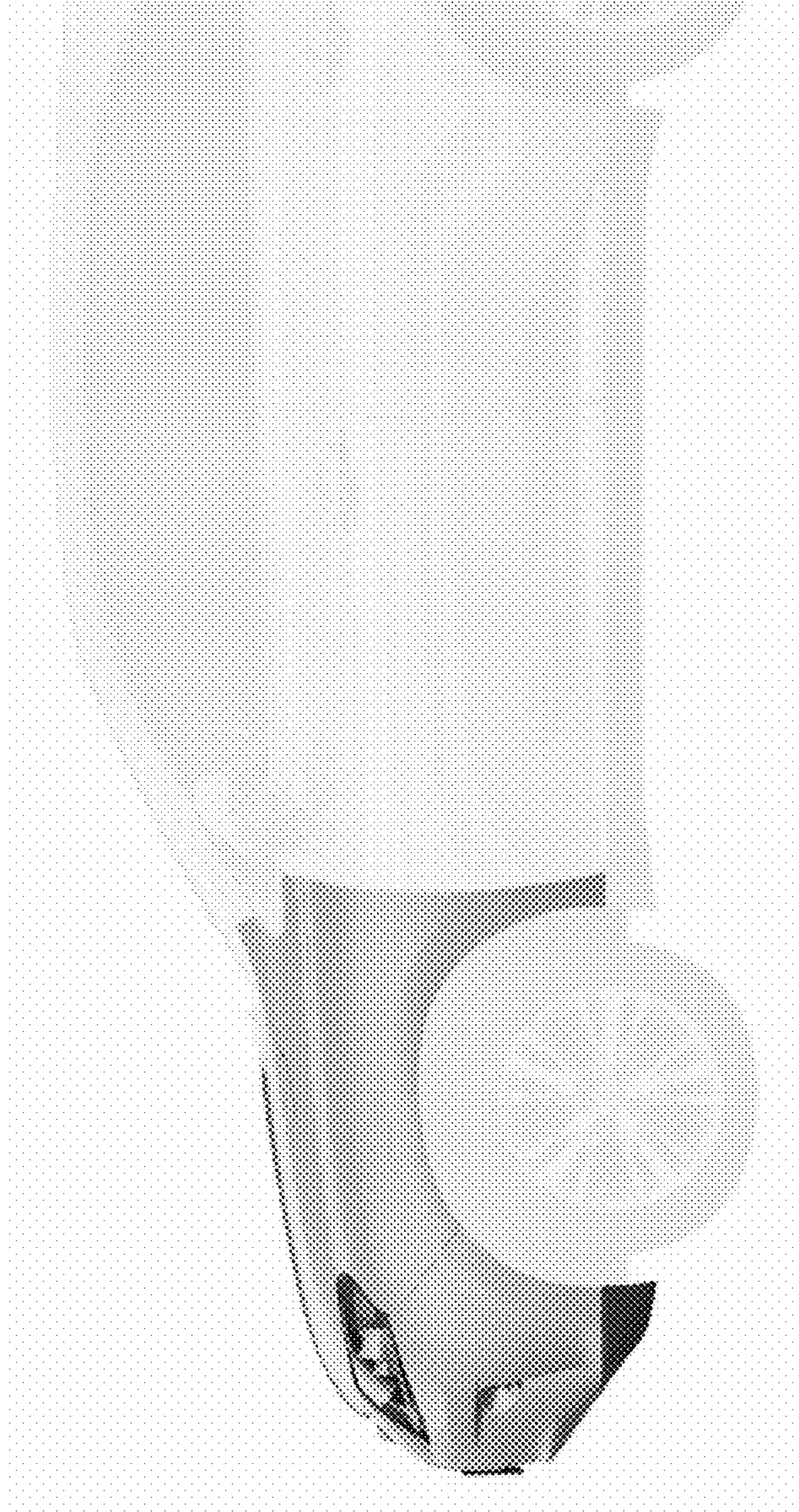

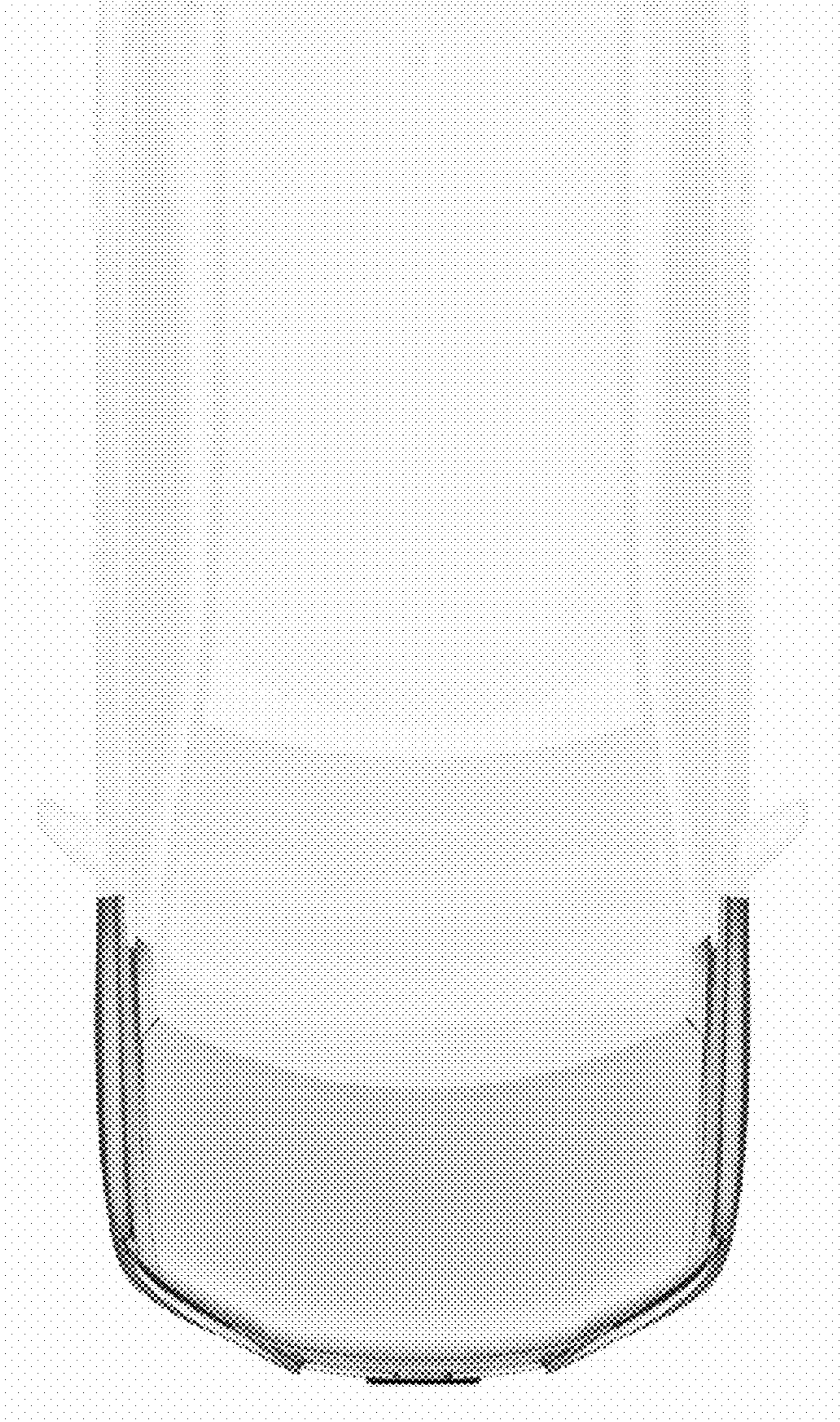
