FIG. 2 is a perspective bottom view thereof;

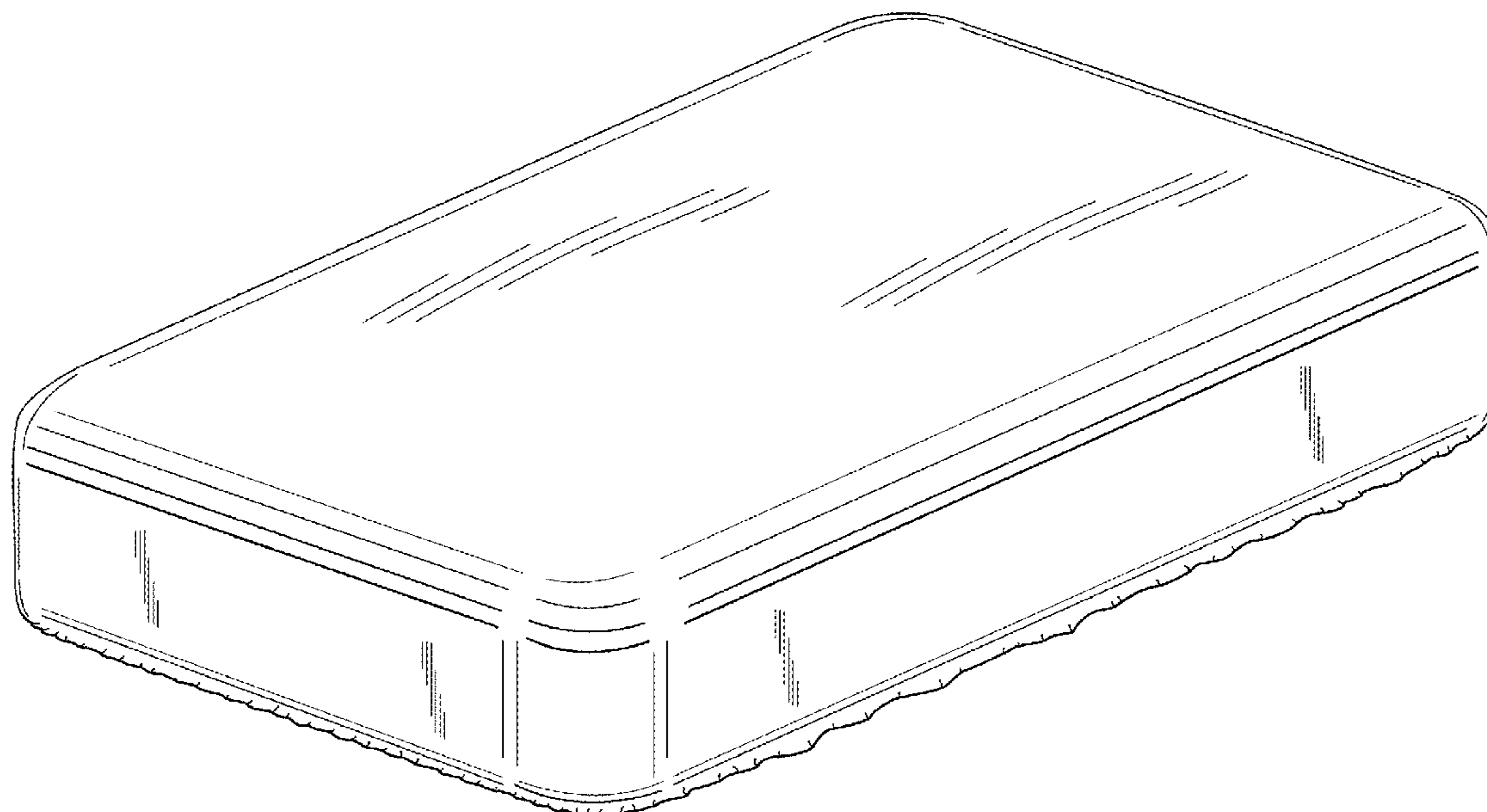
FIG. 3 is a front view thereof with a rear view being a mirror image;

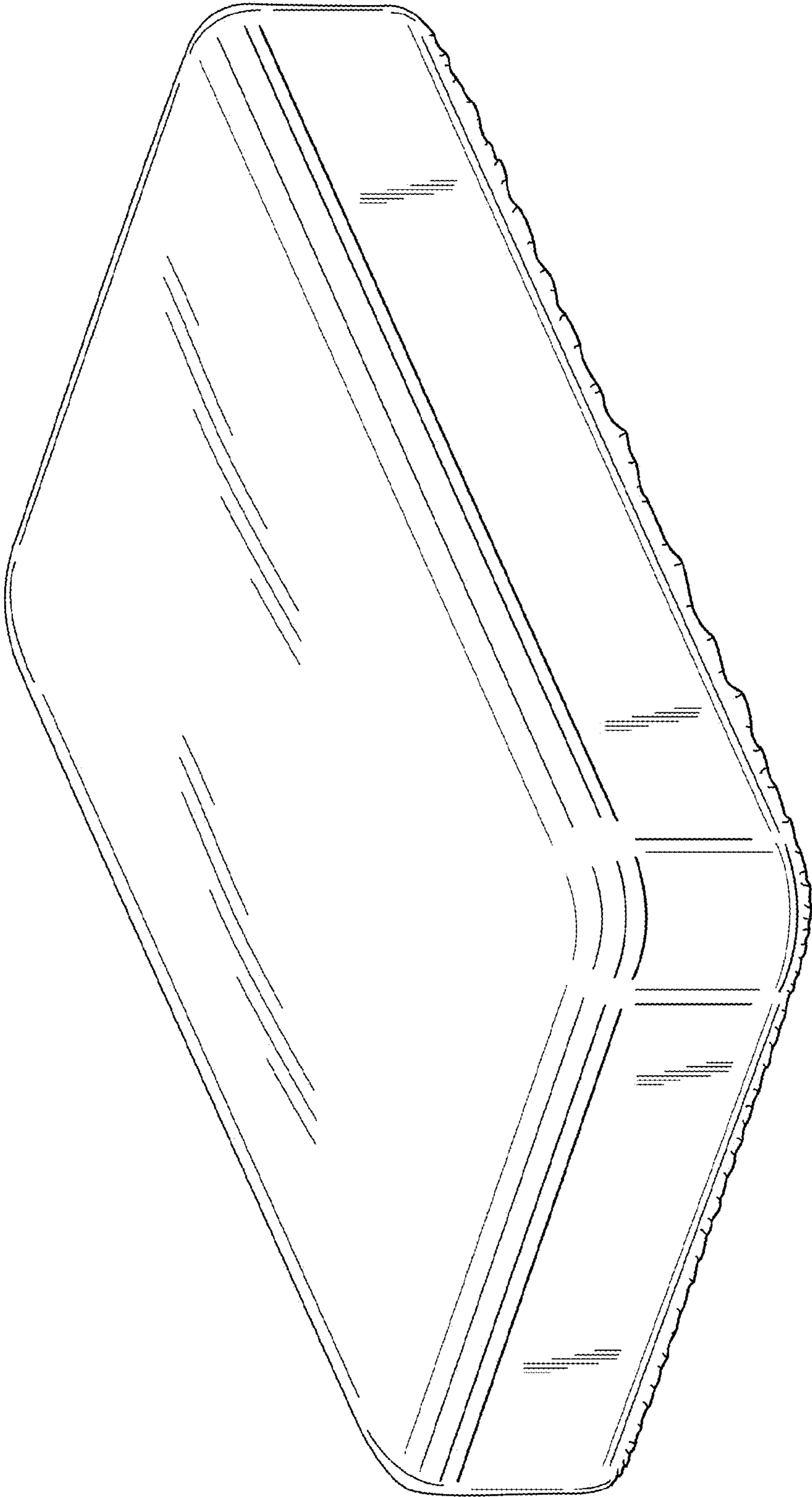

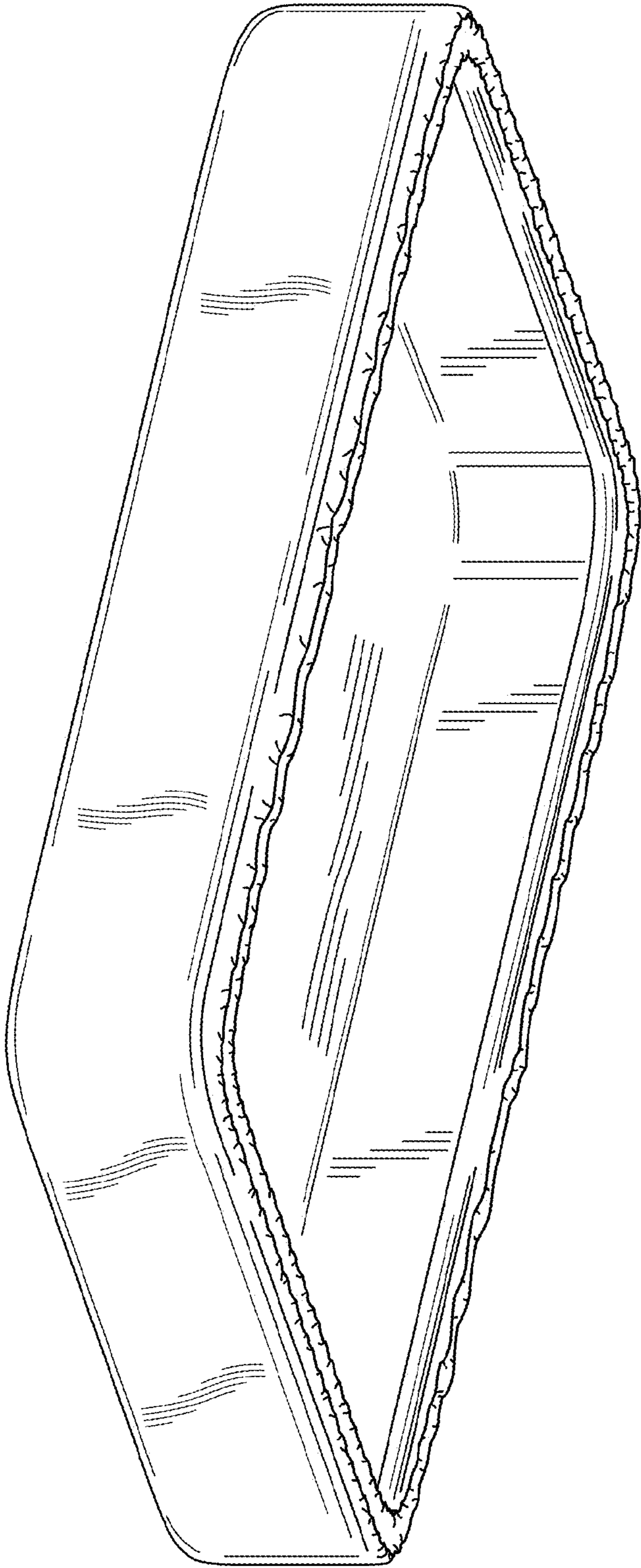

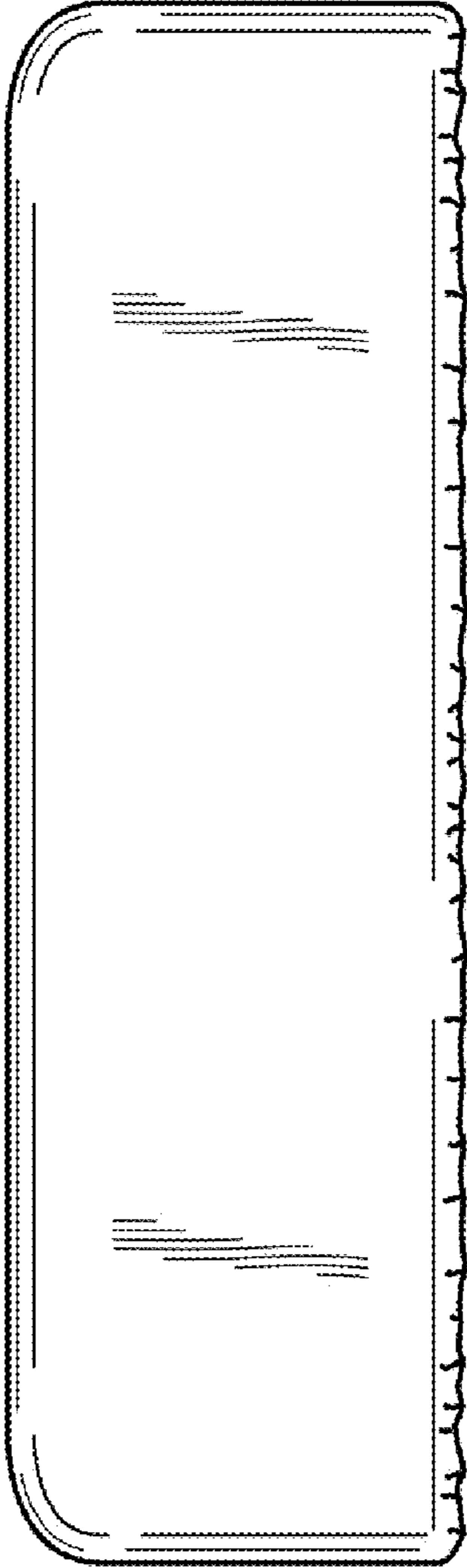

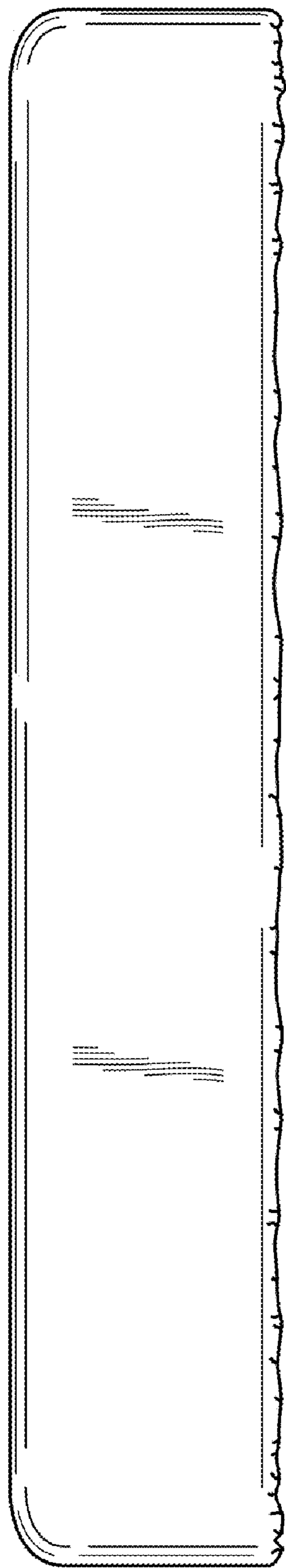

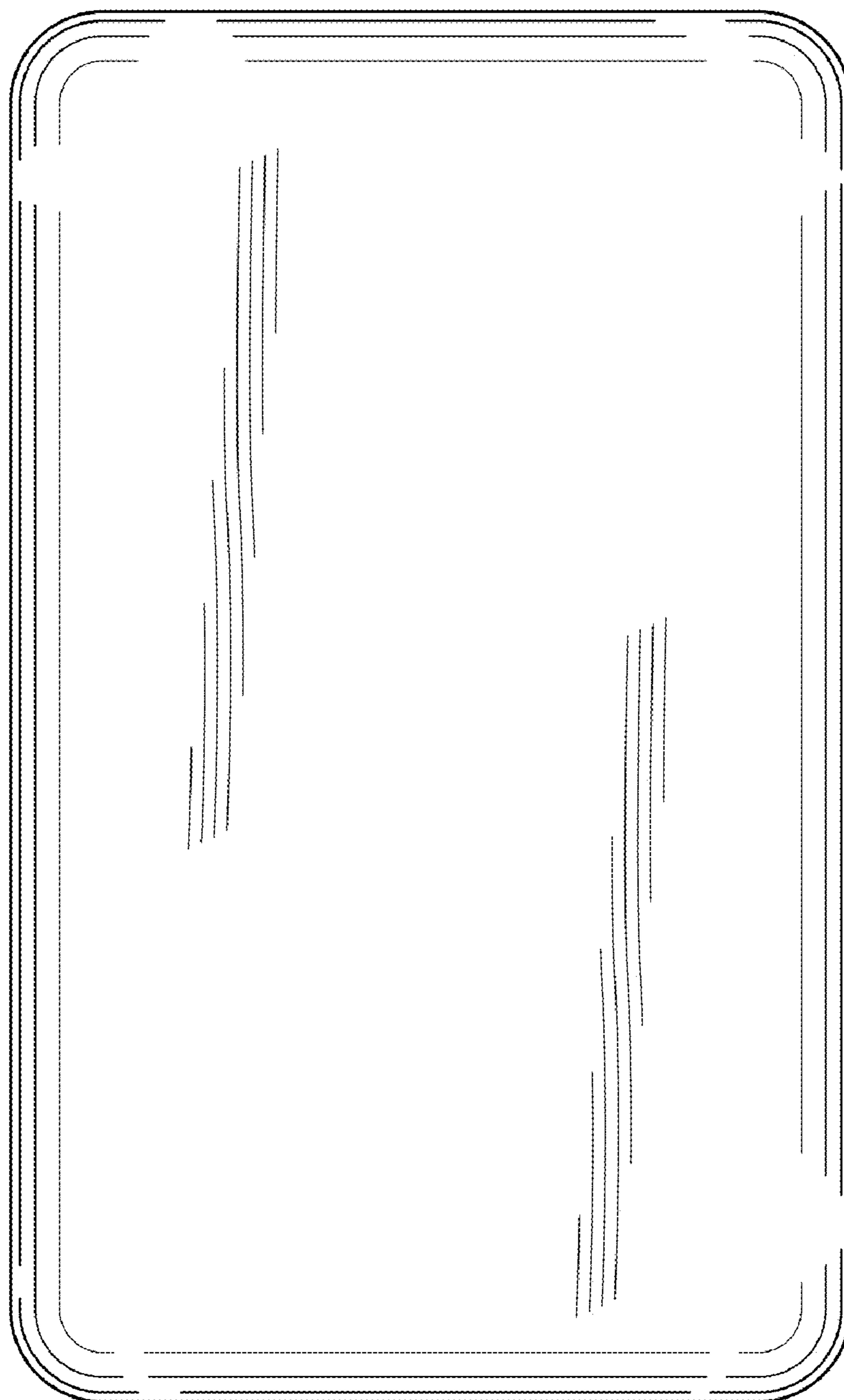

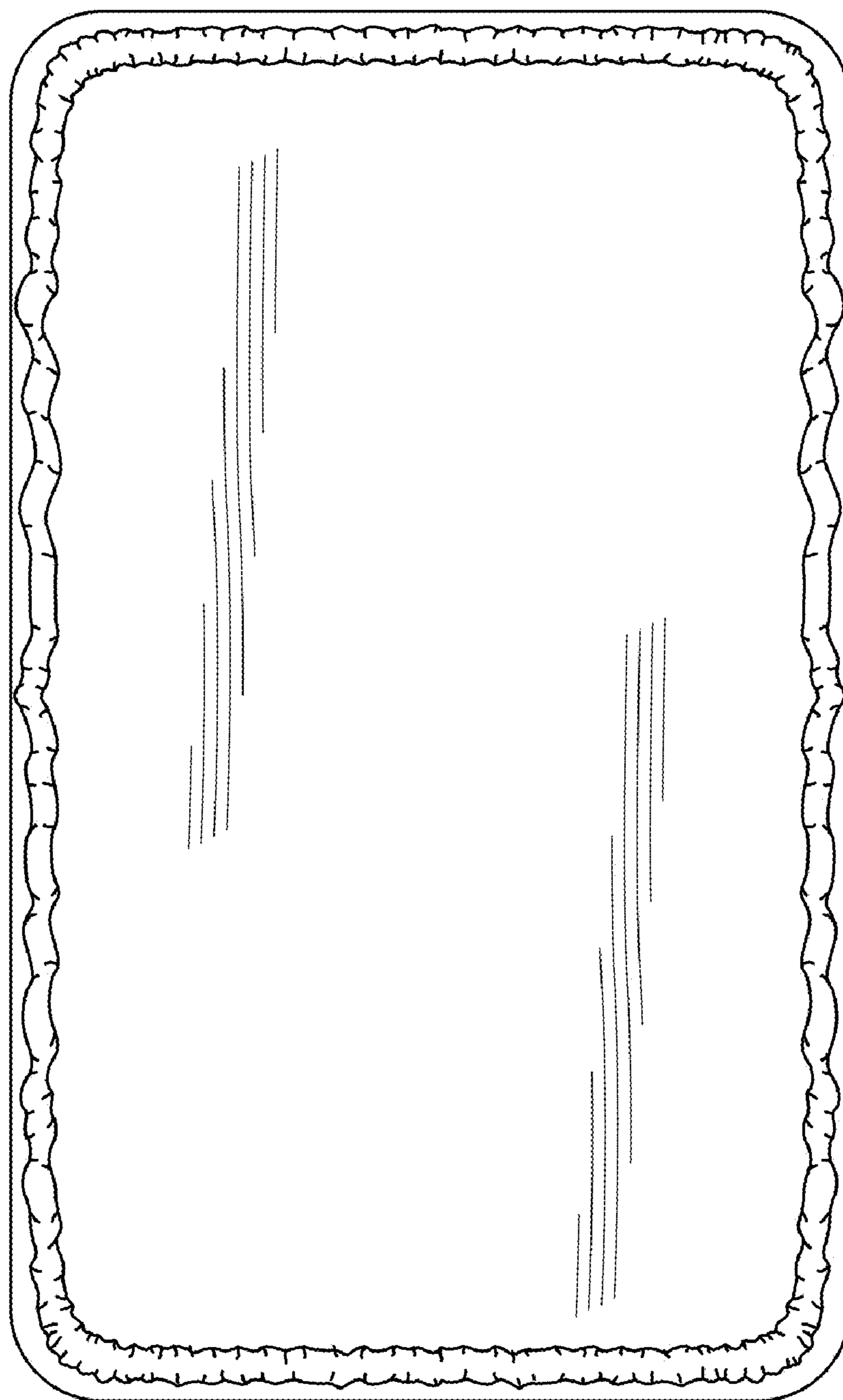
