(57) **CLAIM**

I claim the ornamental design for a speaker, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the speaker according to the claimed design.

FIG. 2 is a rear view of the speaker according to the claimed design.

FIG. 3 is a left side view of the speaker according to the claimed design.

FIG. 4 is a right side view of speaker according to the claimed design.

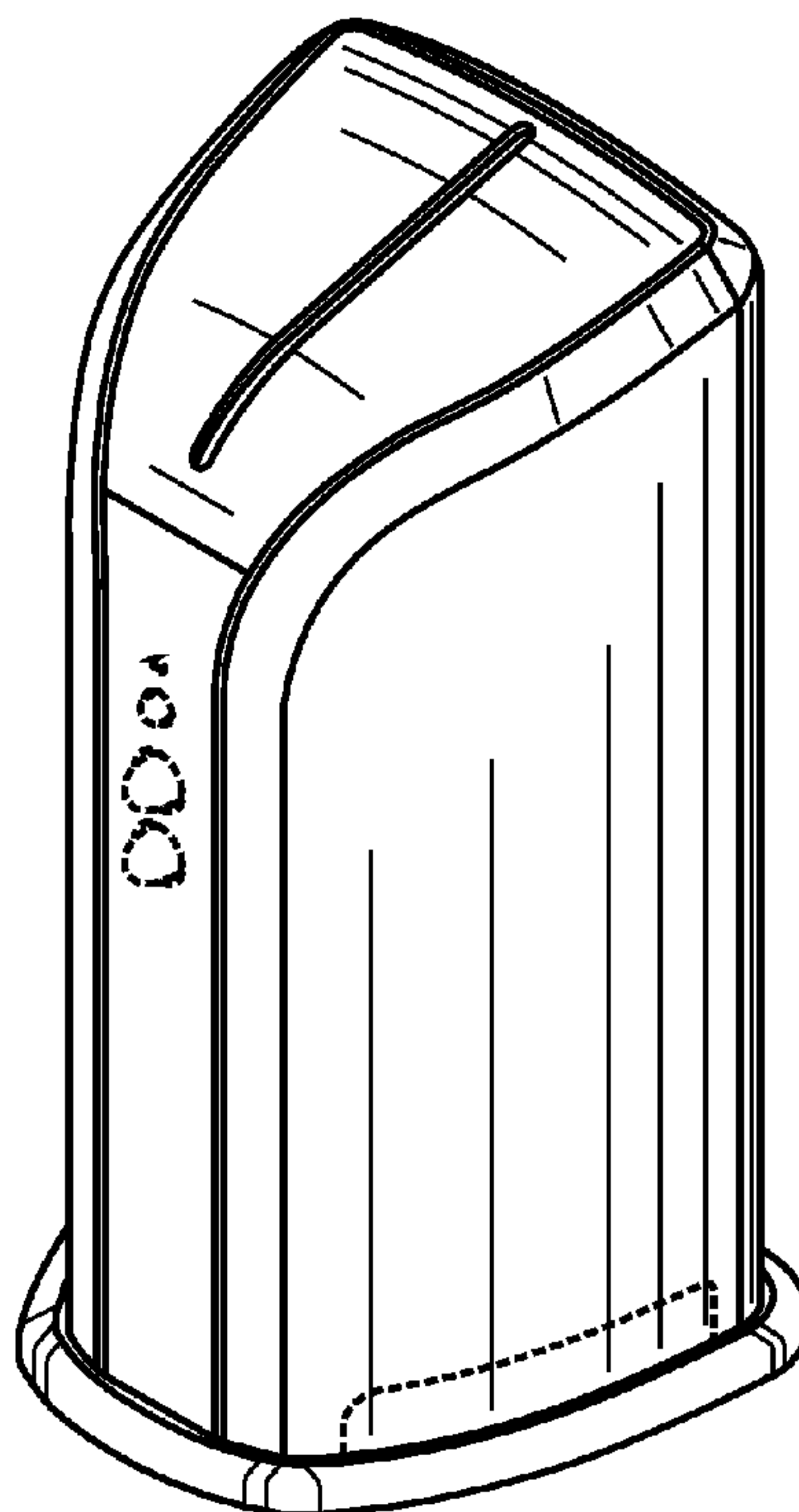
FIG. 5 is a top view of the speaker according to the claimed design.

FIG. 6 is a bottom view of the speaker according to the claimed design; and,

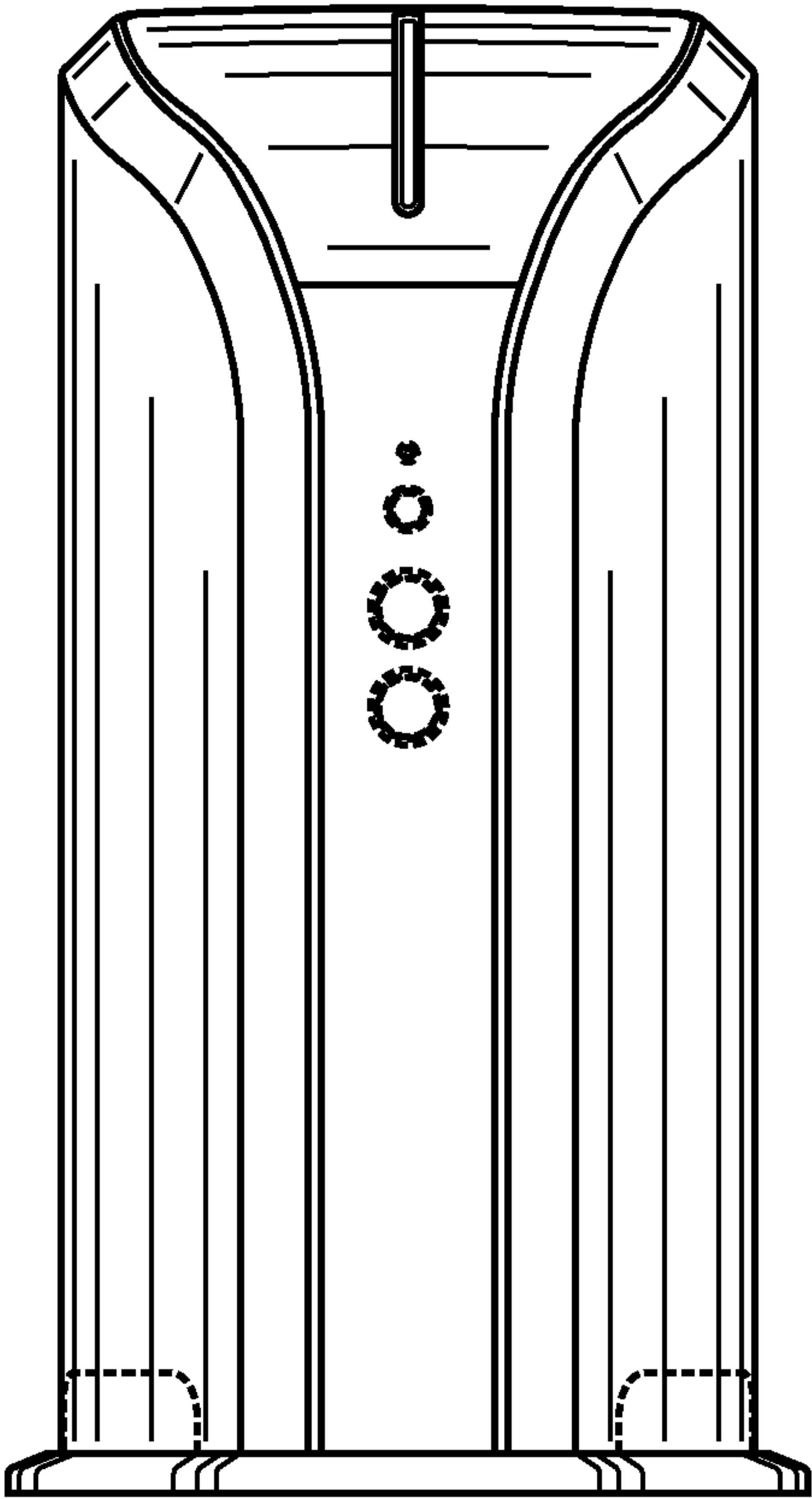

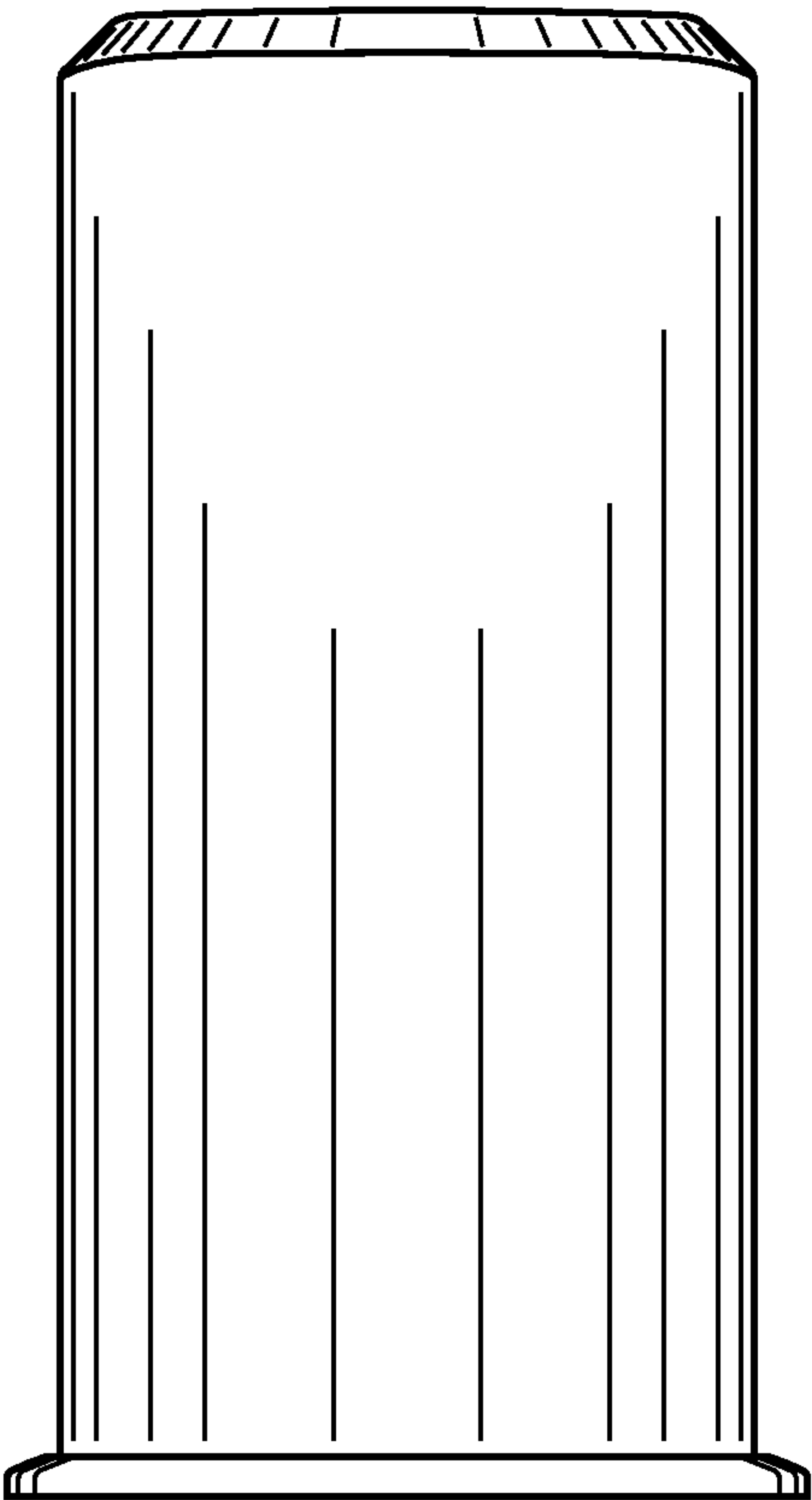

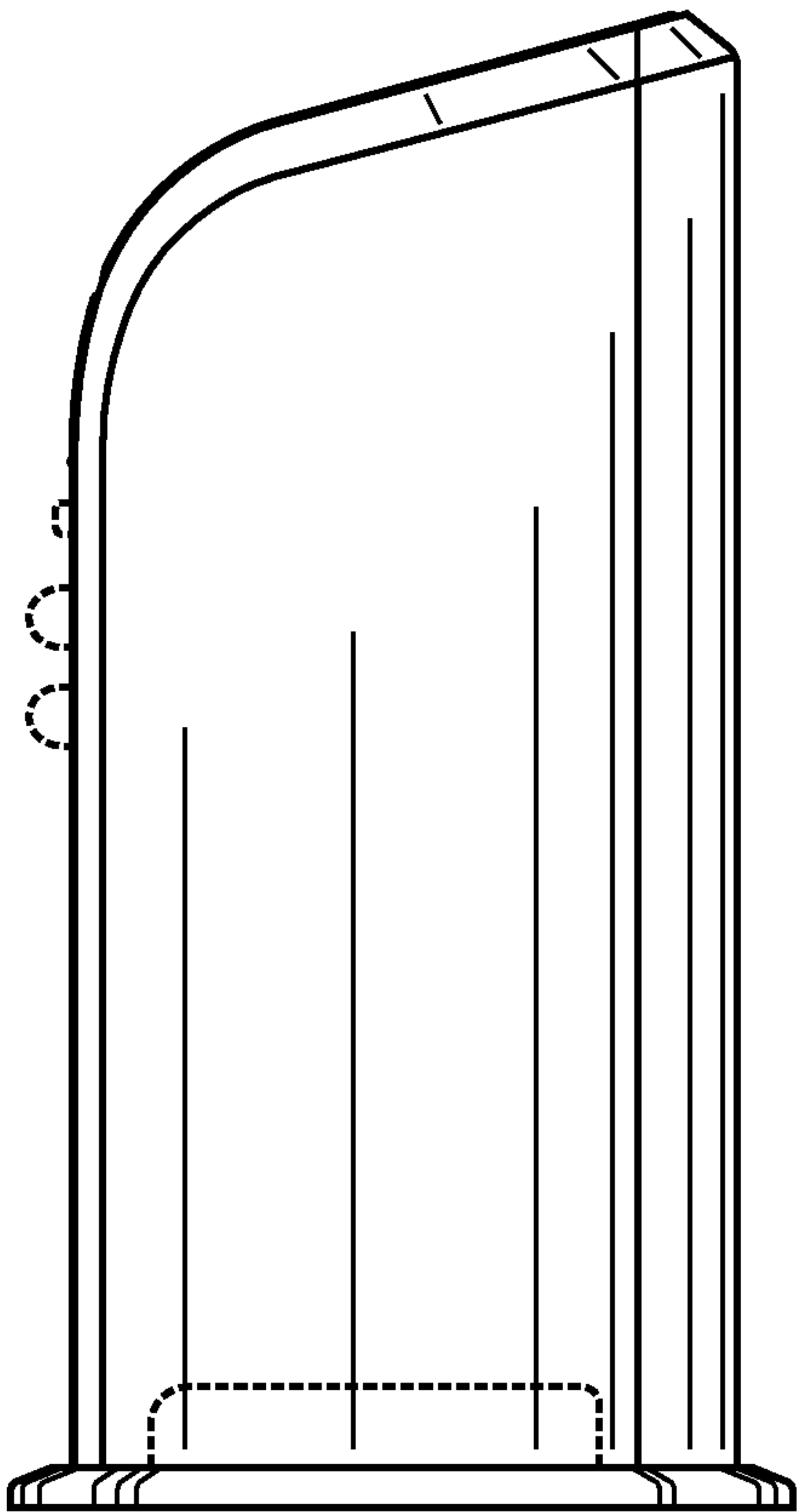

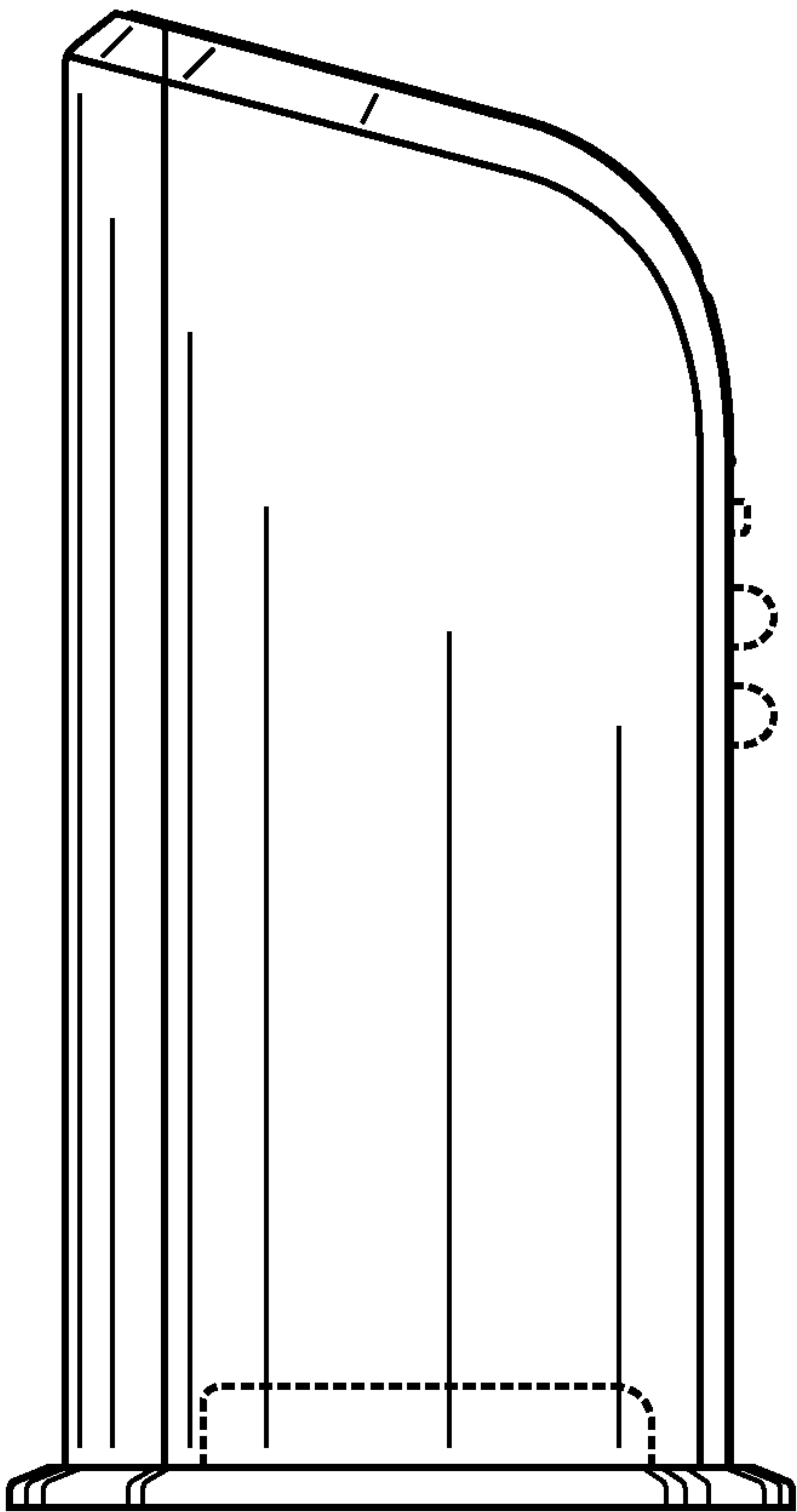

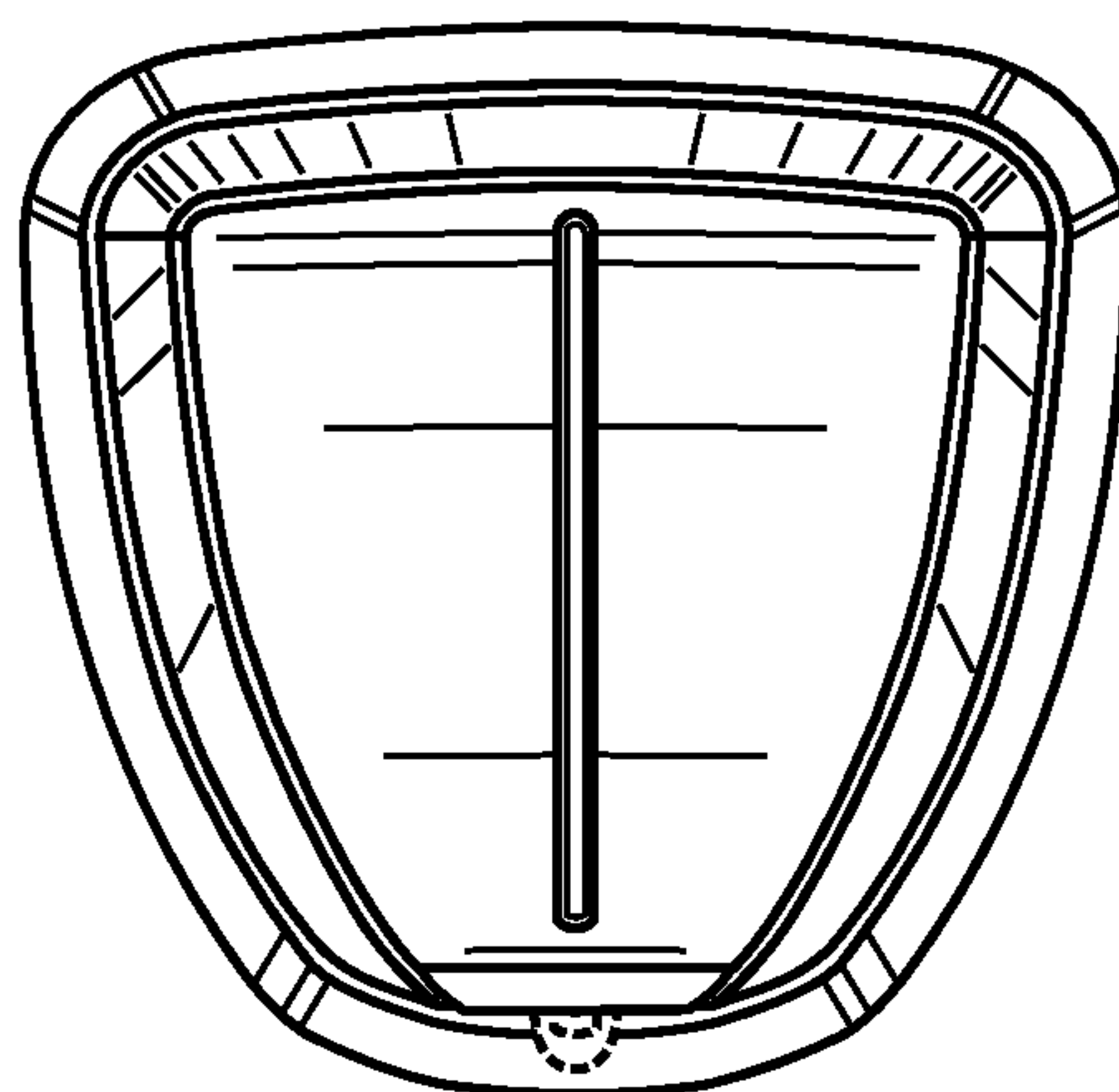

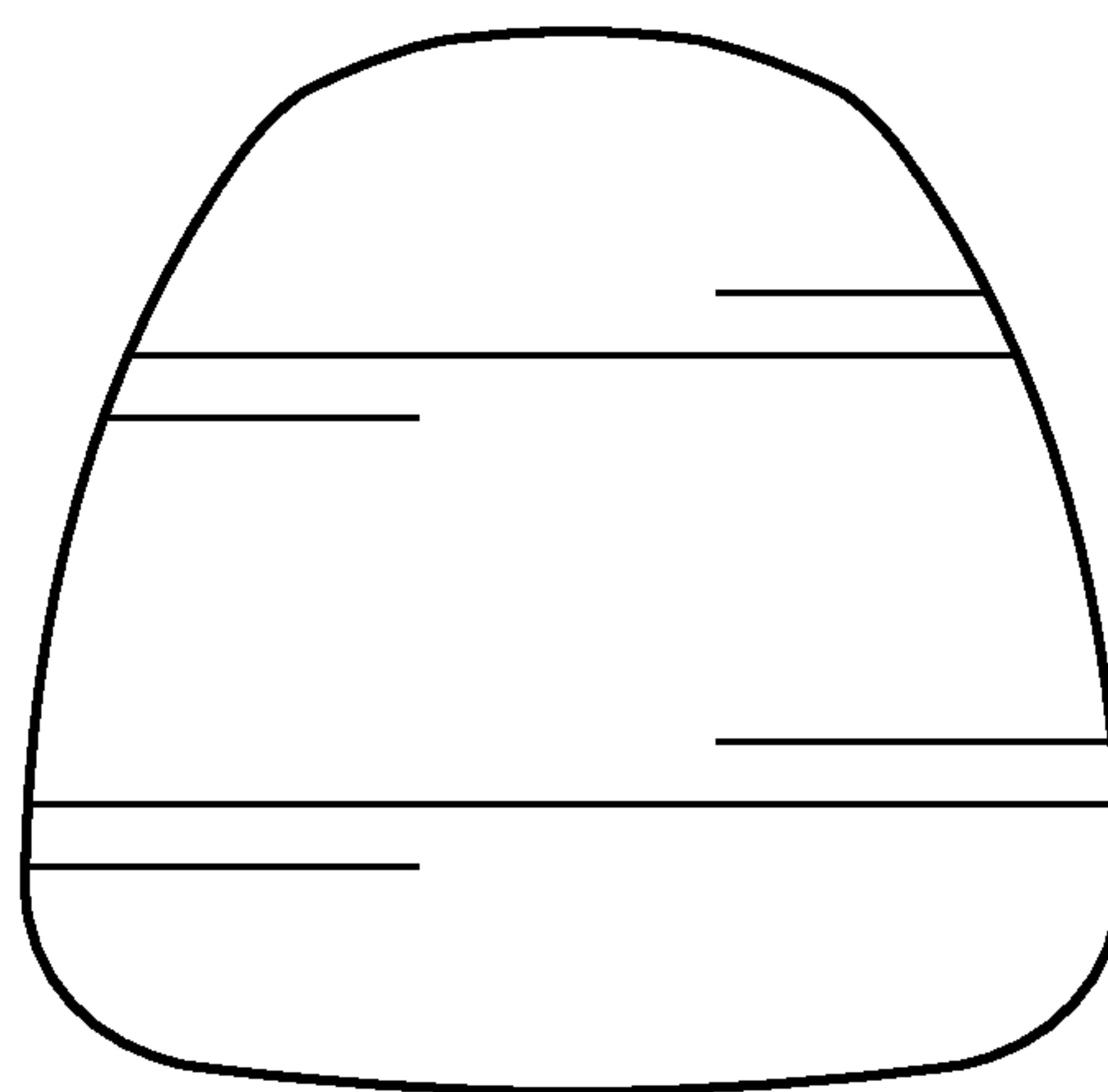

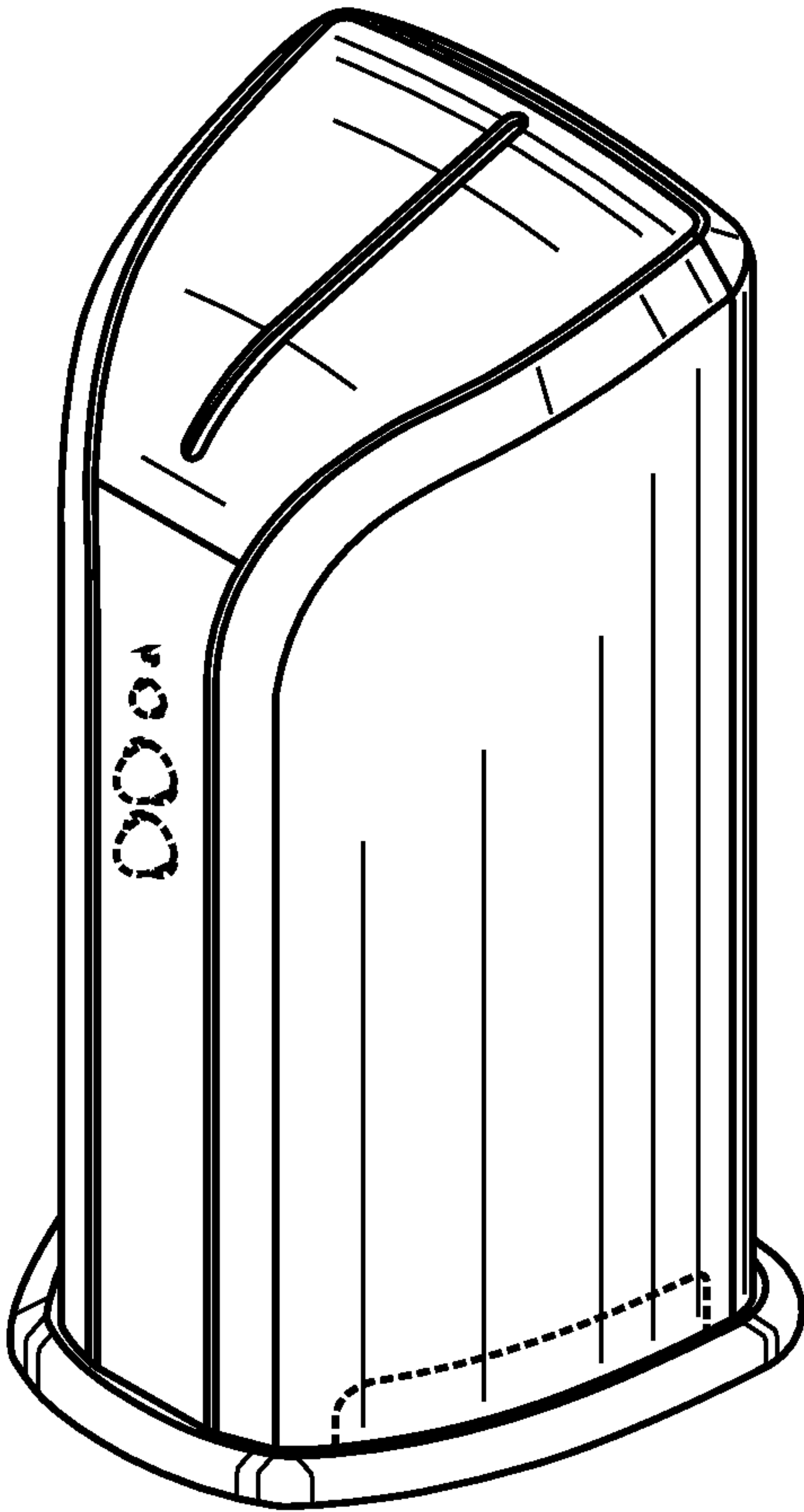
