(57) **CLAIM**

The ornamental designs for a greeting card mask—lion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the greeting card mask—lion of the present invention, in a closed position.

FIG. 2 is a perspective view of the greeting card mask—lion of FIG. 1, in an open position.

FIG. 3 is a front view of the greeting card mask—lion of FIG. 1.

FIG. 4 is a rear view of the greeting card mask—lion of FIG. 1.

FIG. 5 is a right side view of the greeting card mask—lion of FIG. 1.

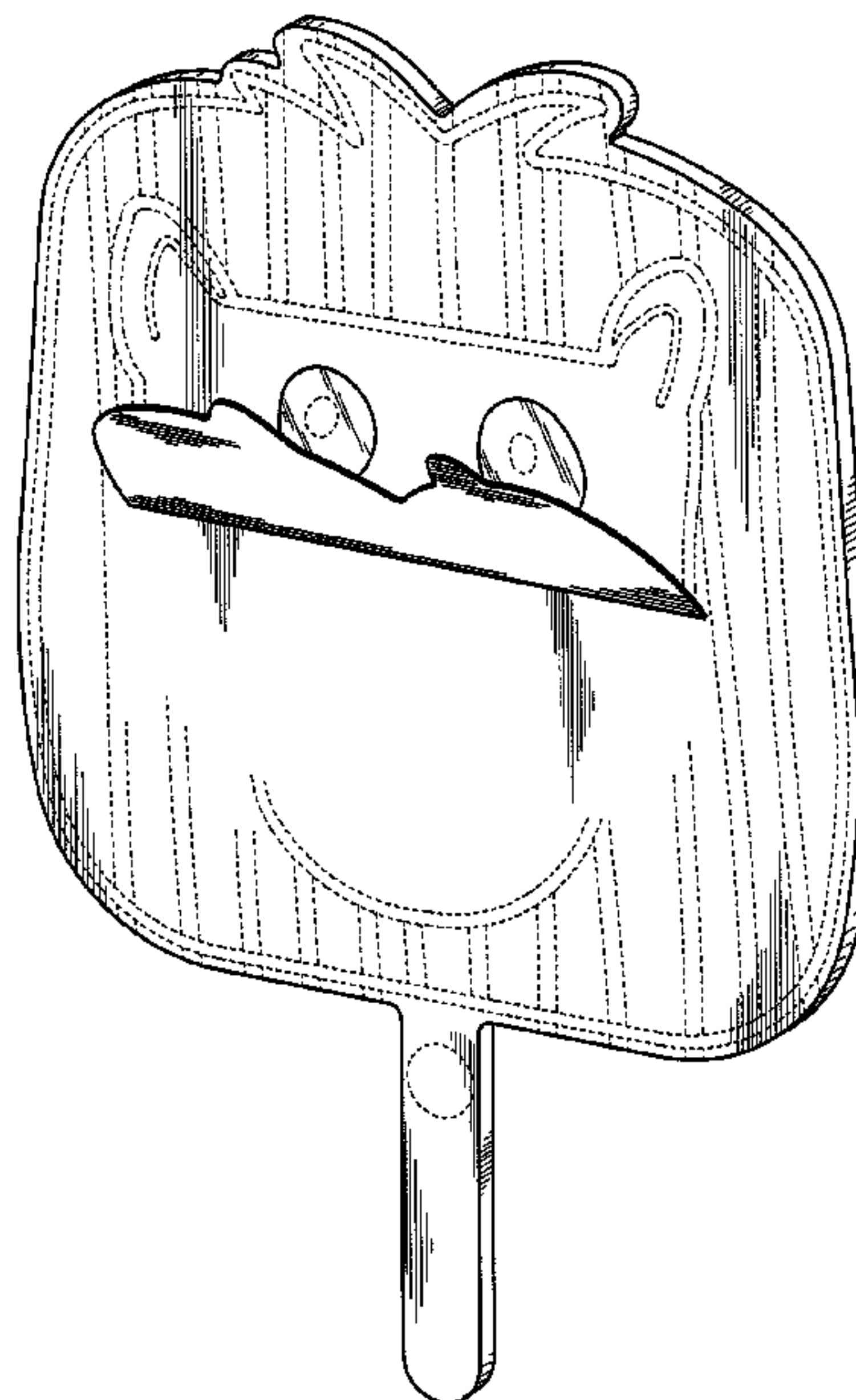
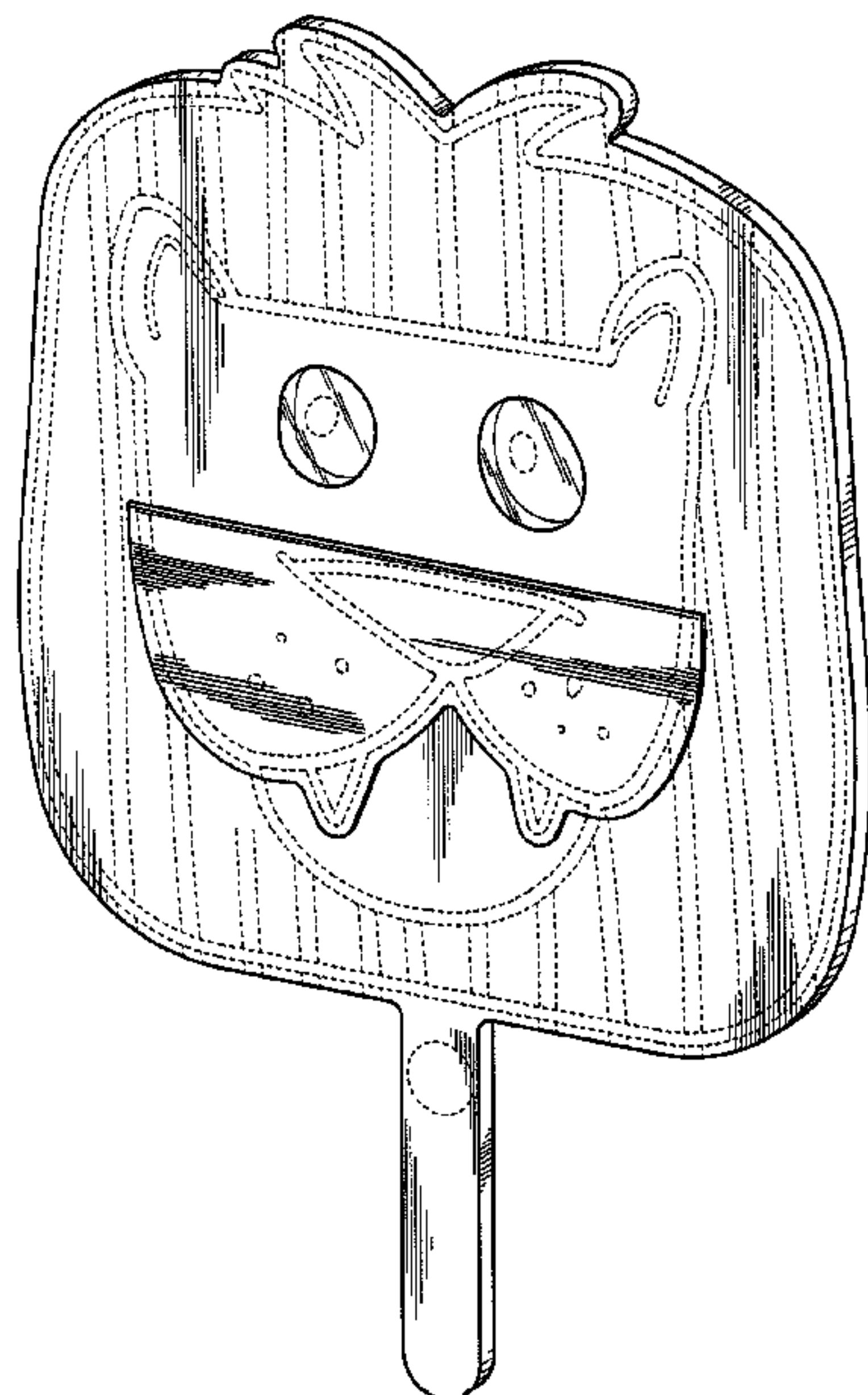
FIG. 6 is a left side view of the greeting card mask—lion of FIG. 1.

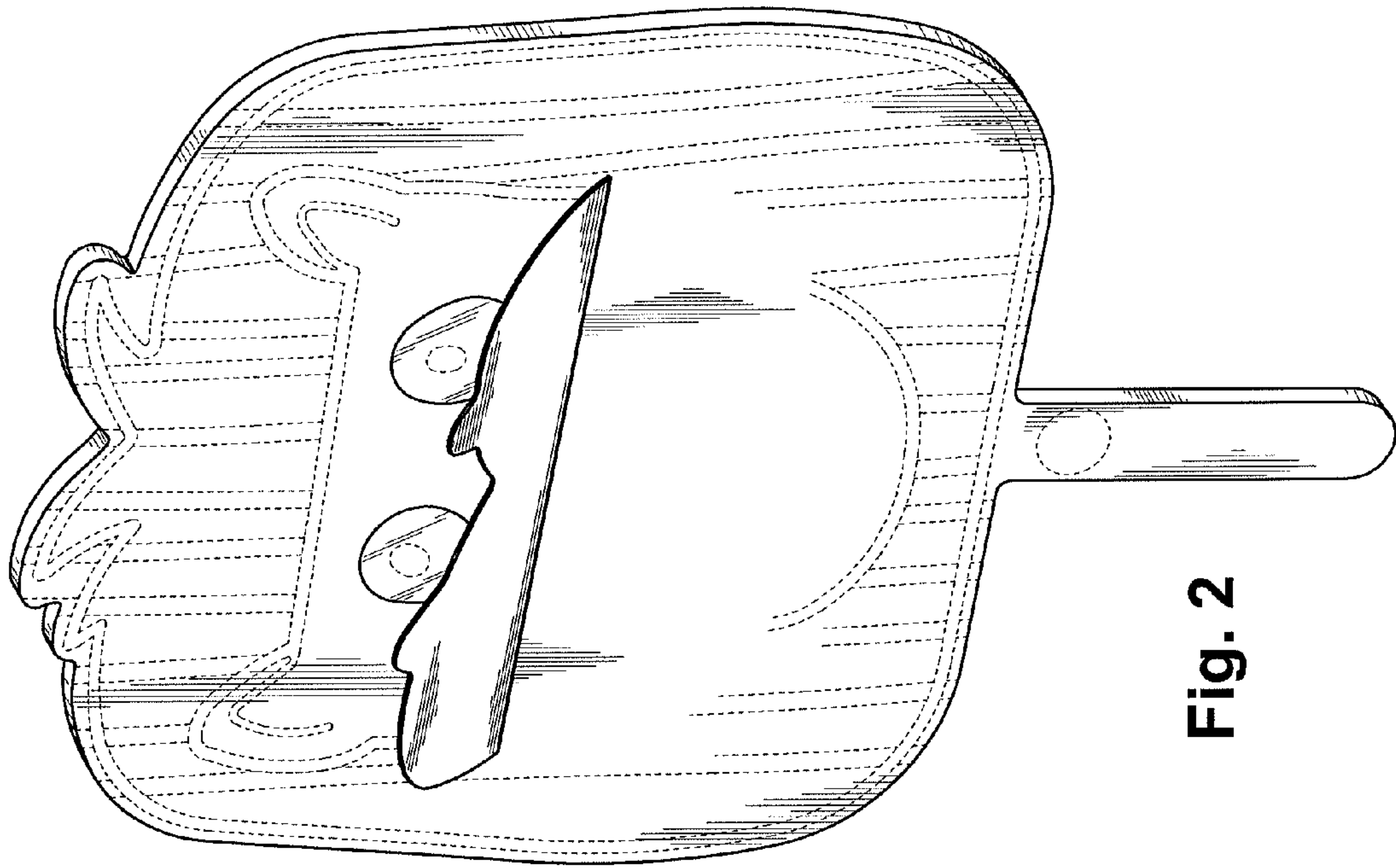

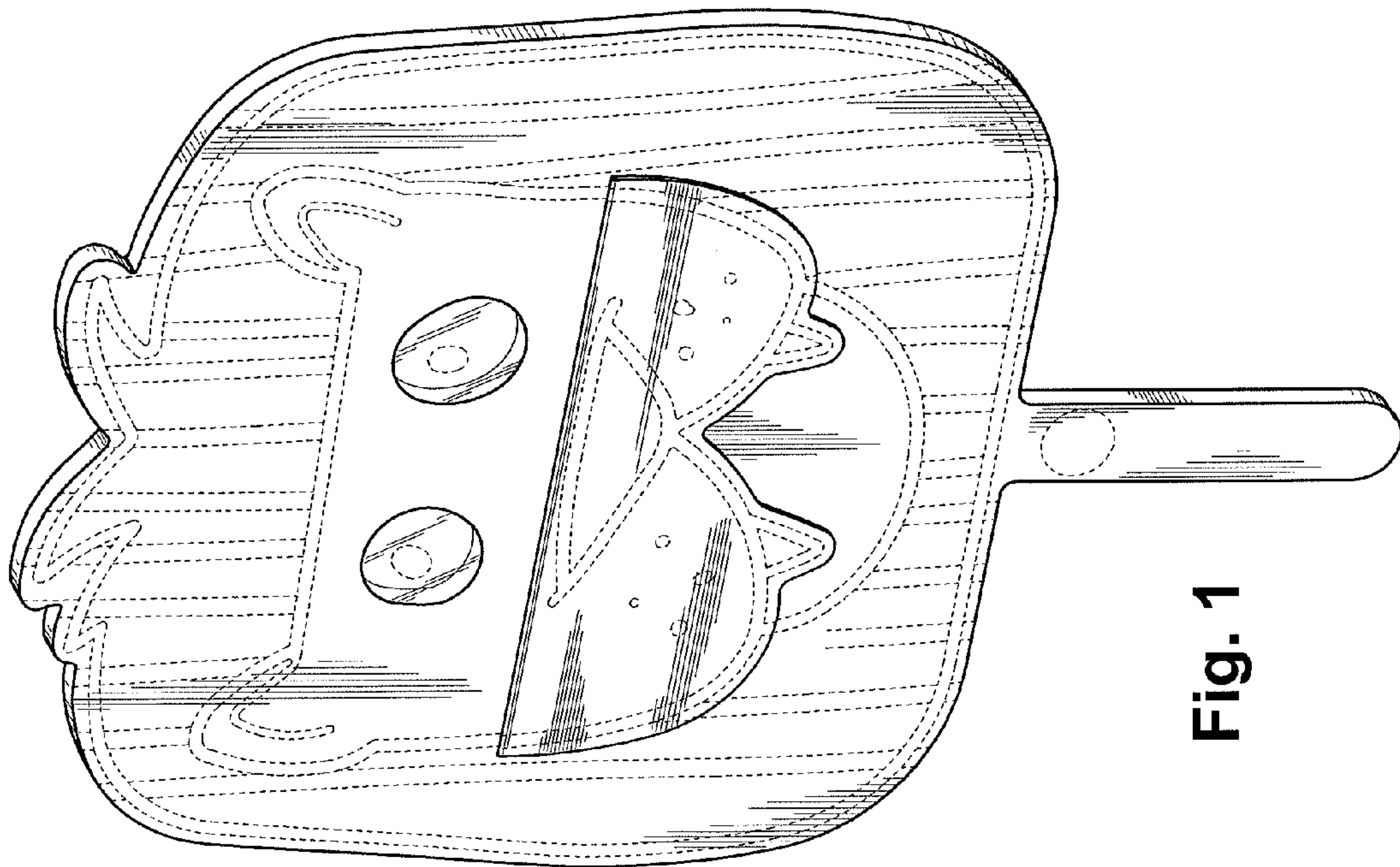

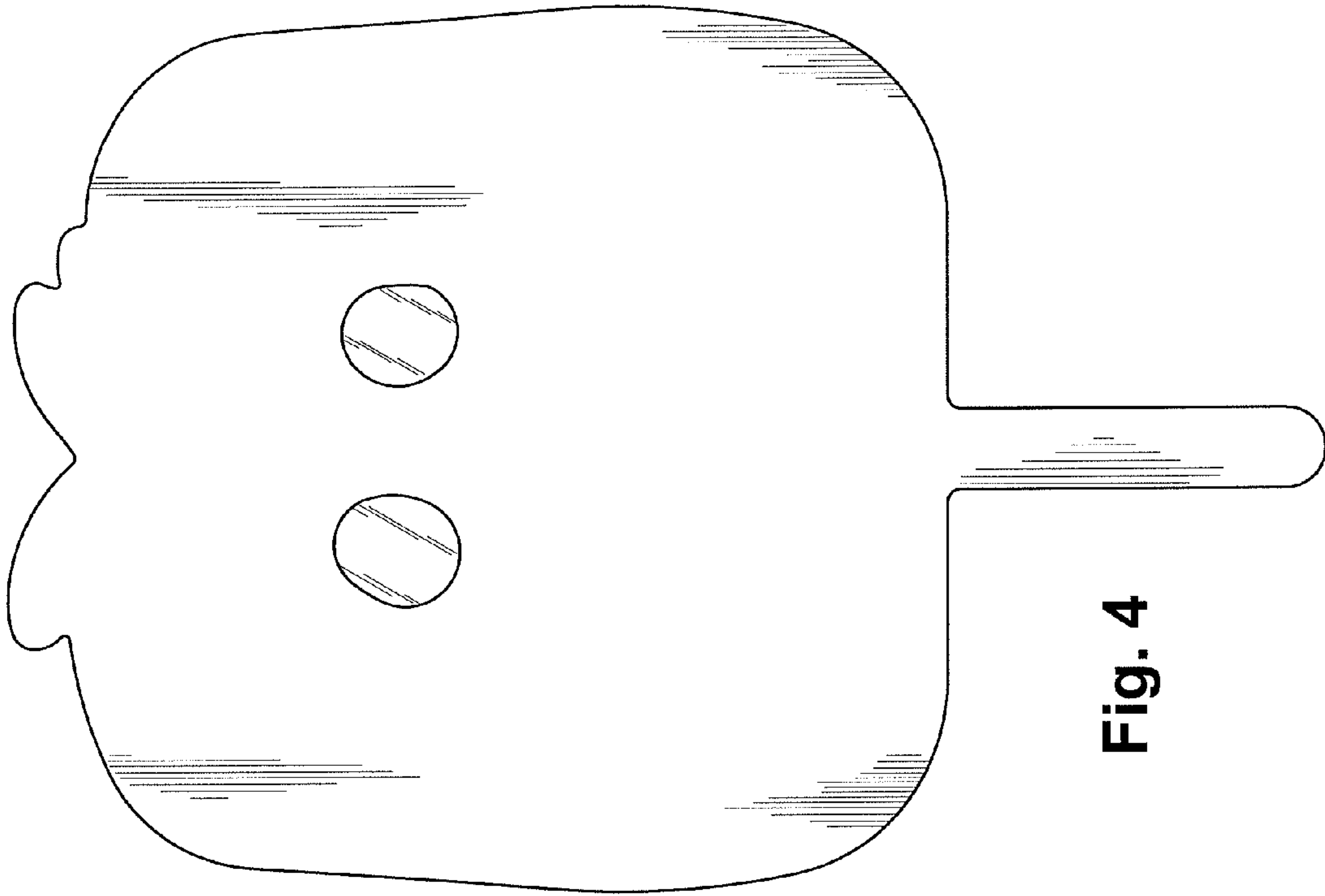

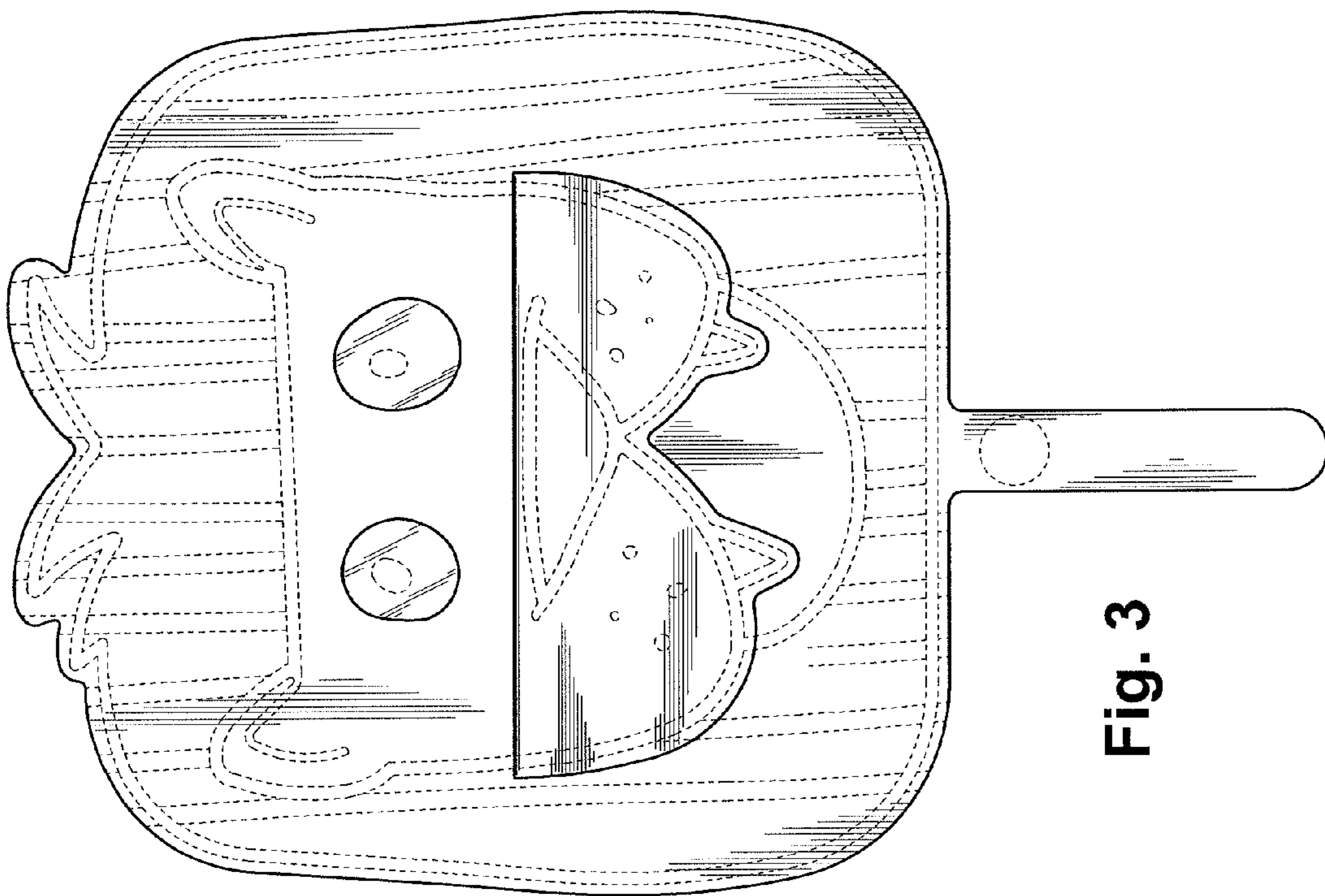
