(57) **CLAIM**

The ornamental design for “skateboard,” as shown and described.

**DESCRIPTION**

FIG. 1 is a partial right side view of the skateboard, the partial left side view being a mirror image thereof.

FIG. 2 is a partial top view of the skateboard.

FIG. 3 is a completion of the right side view of the skateboard shown in FIG. 1, the completion of the left side view being a mirror image thereof.

FIG. 4 is a completion of the top view of the skateboard shown in FIG. 2.

FIG. 5 is a front view of the skateboard, the rear view being a mirror image thereof.

FIG. 6 is a partial bottom view of the skateboard.

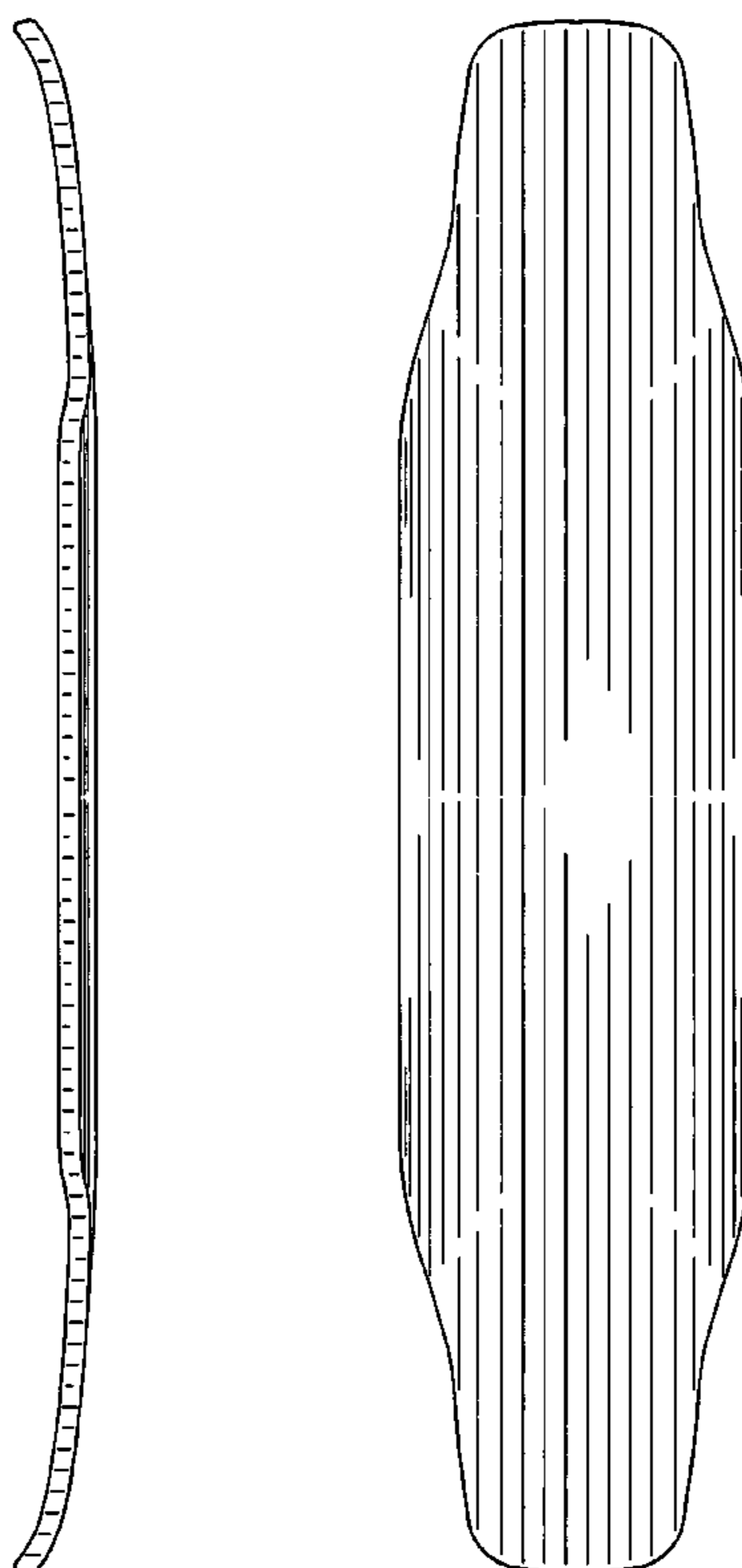
FIG. 7 is a completion of the bottom view of the skateboard shown in FIG. 6.

FIG. 8 is a reduced right side view showing the complete skateboard; and,

FIG. 9 is a reduced top view showing the complete skateboard.

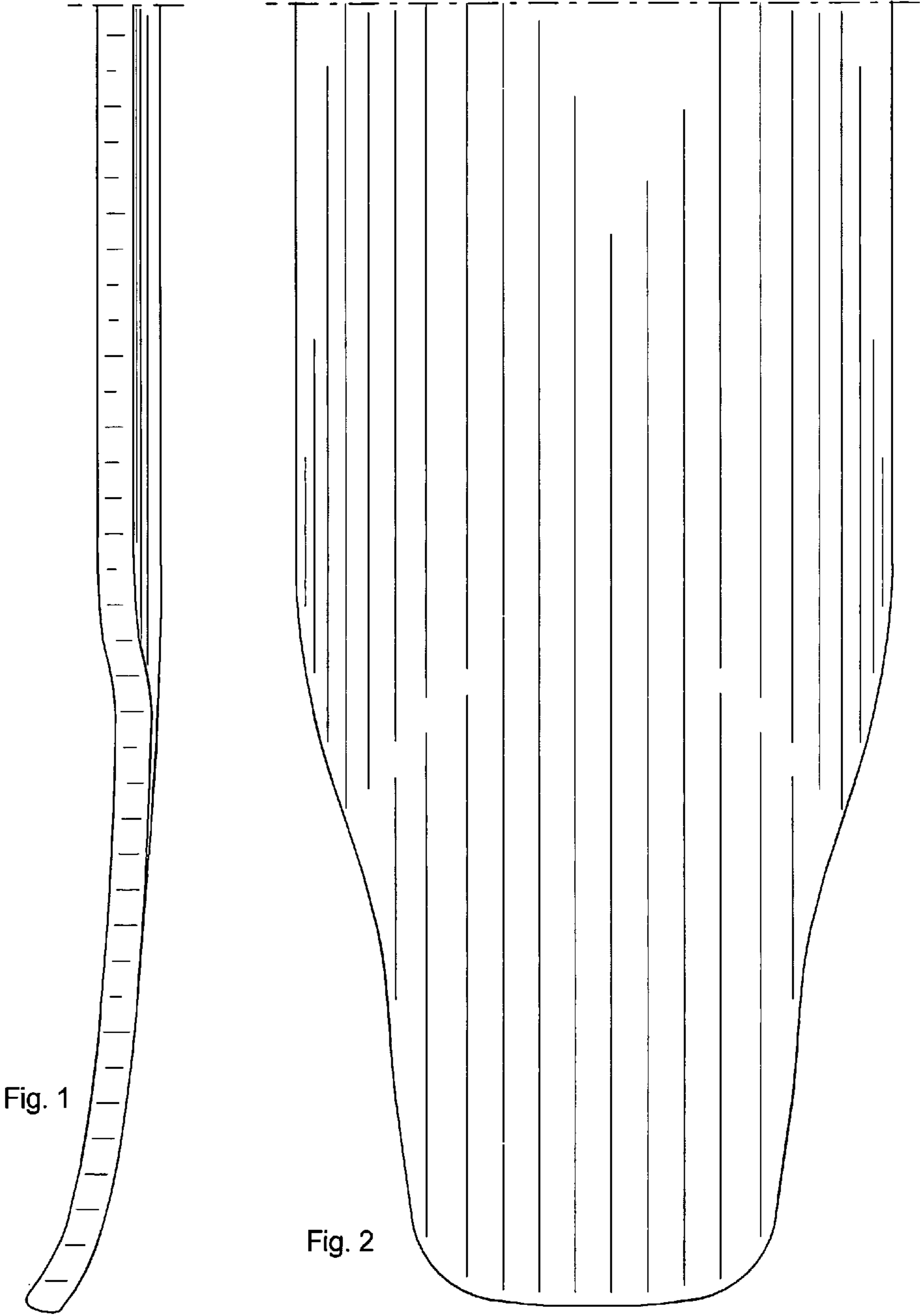

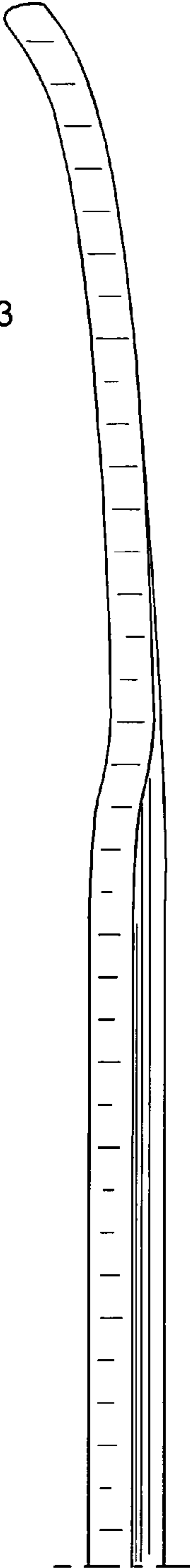
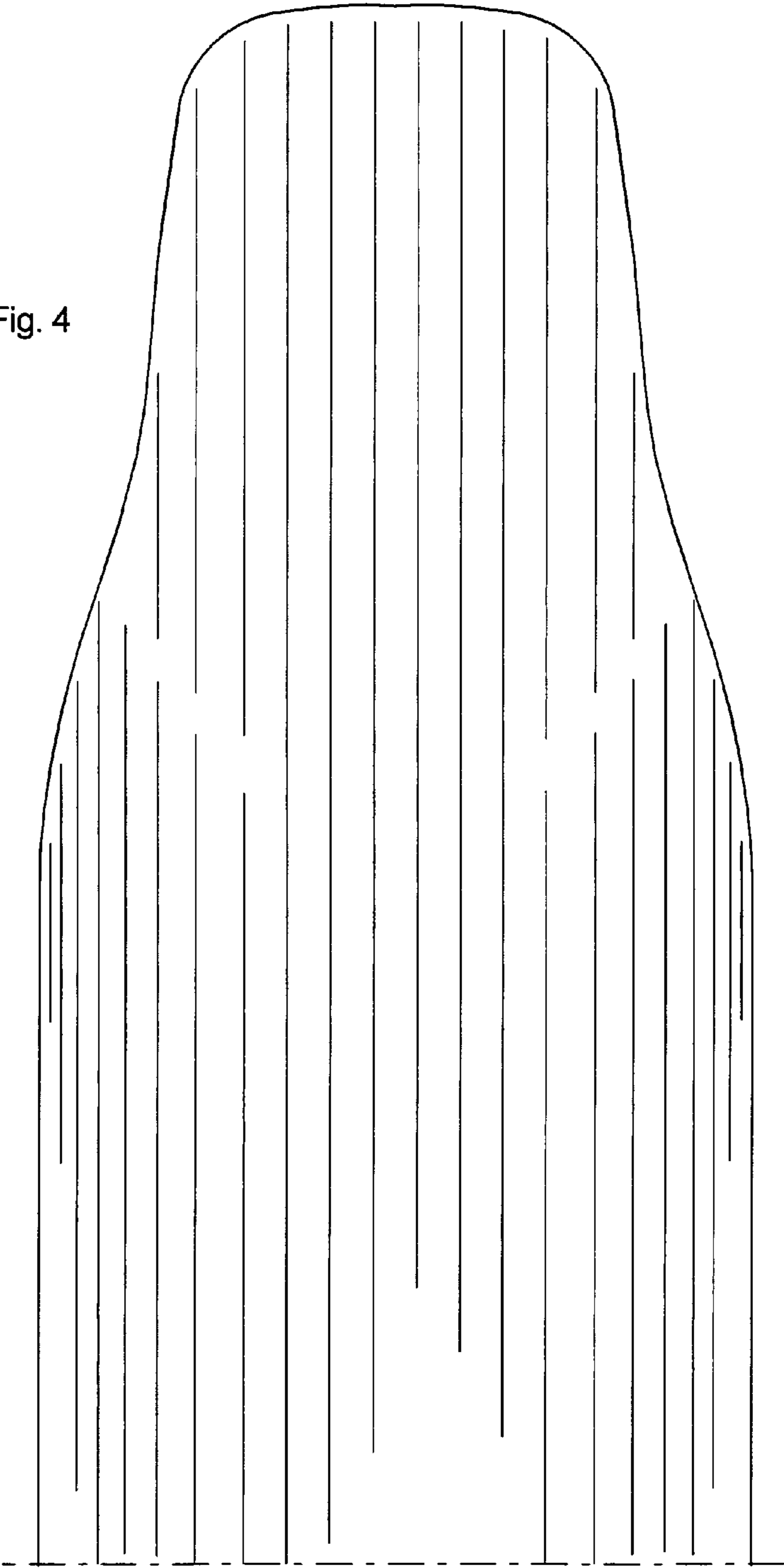

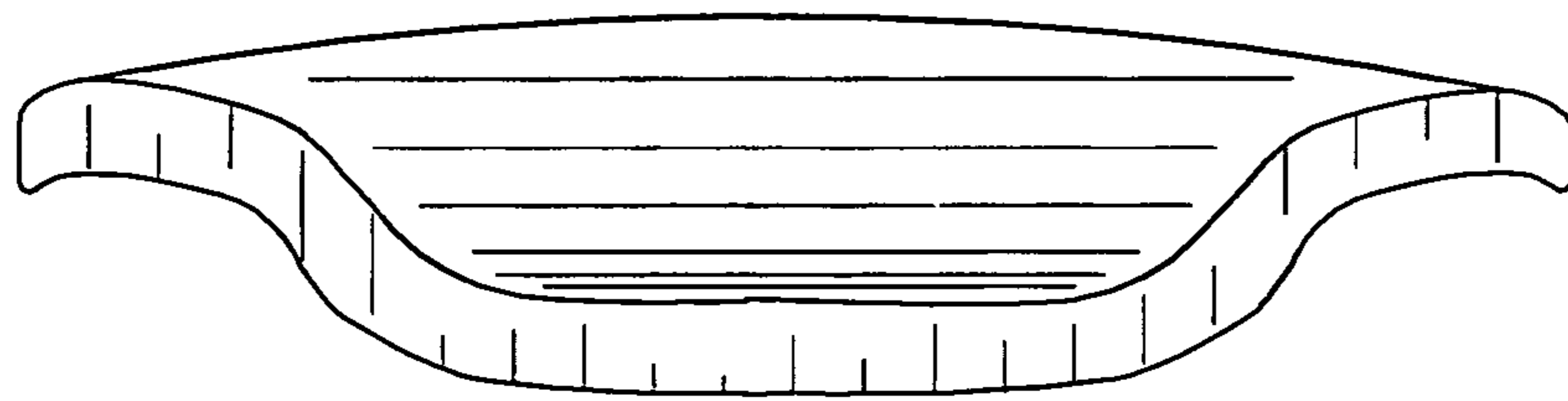

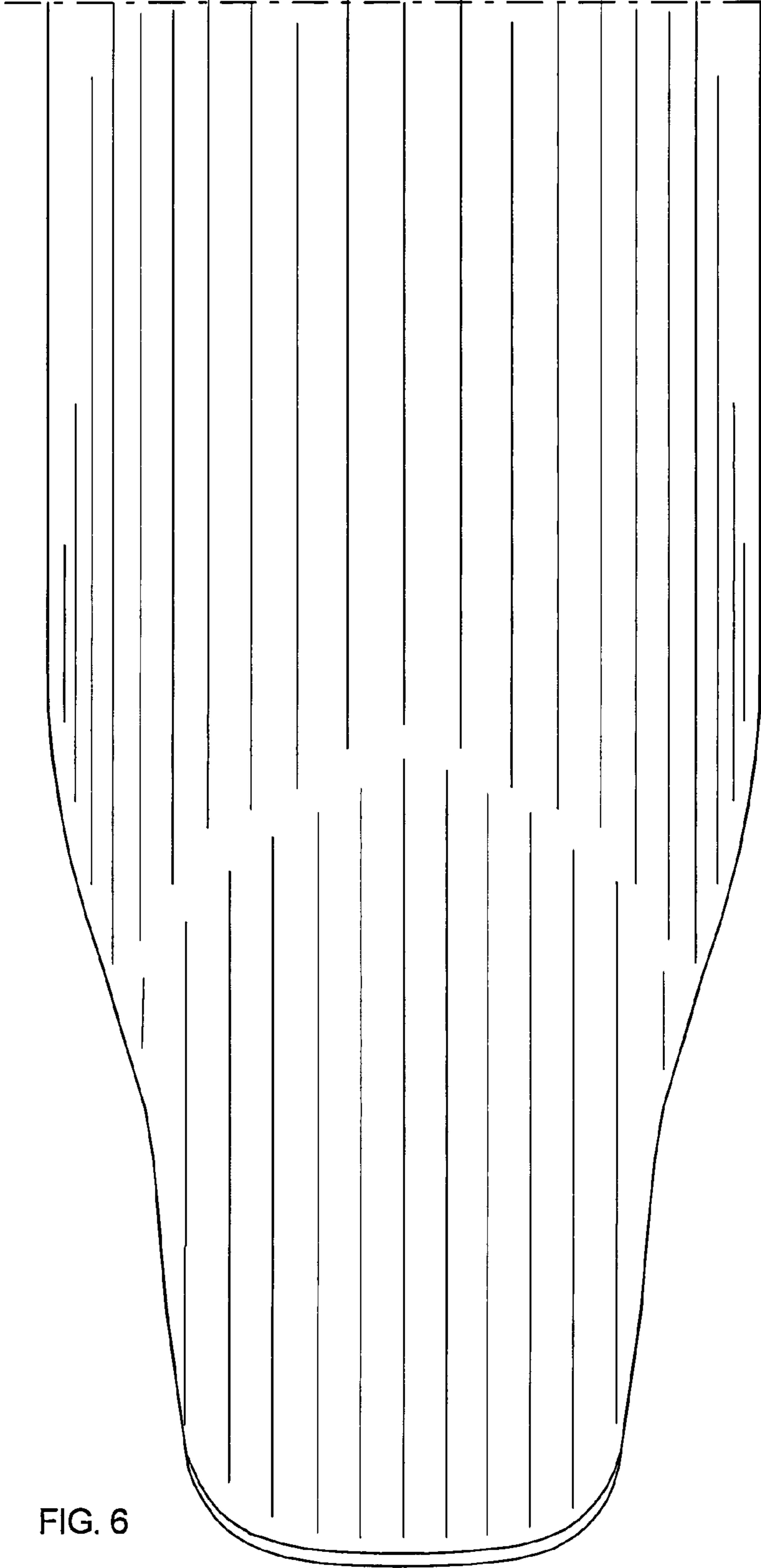

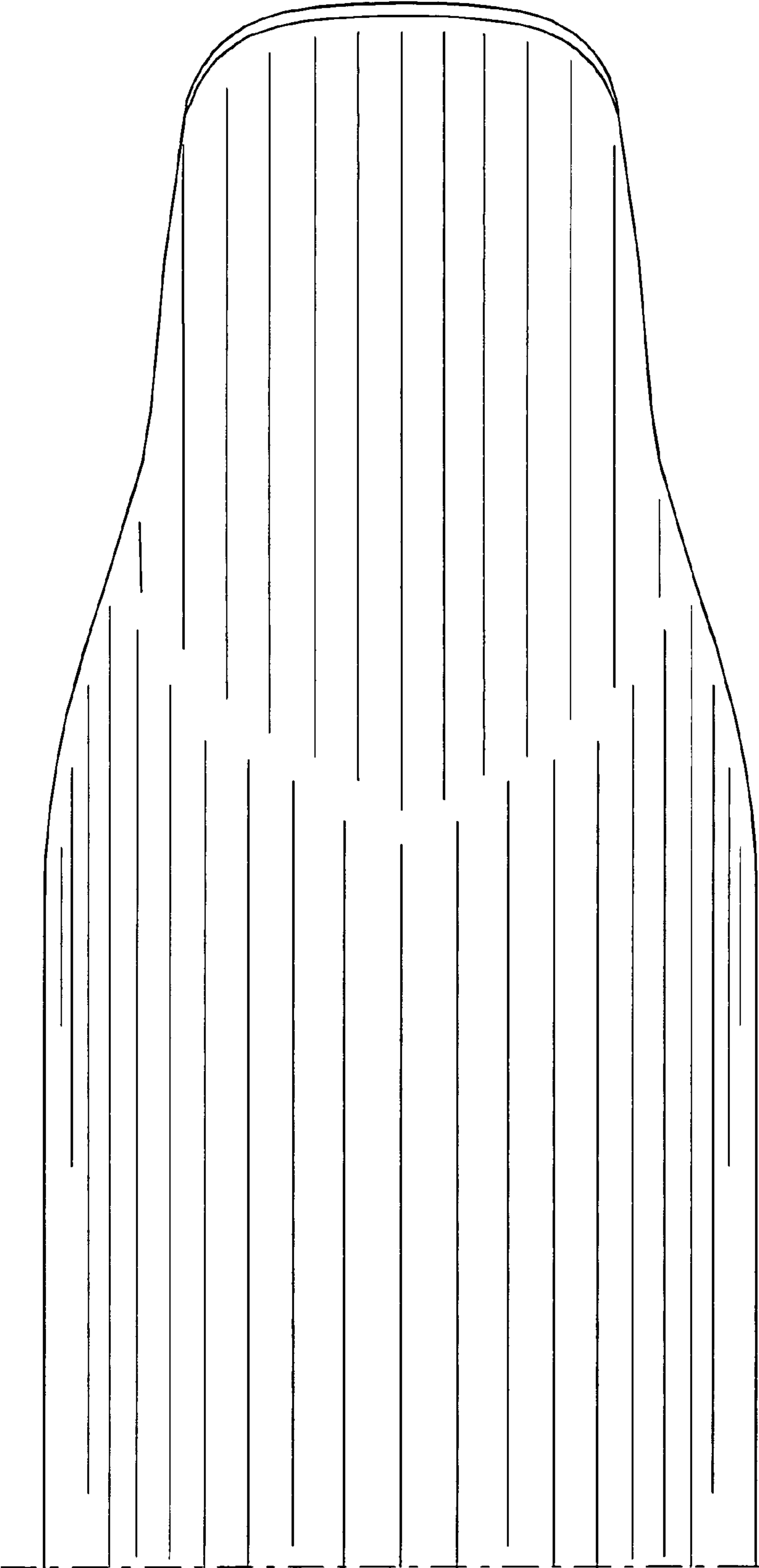

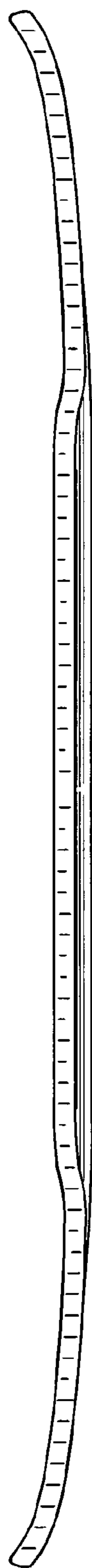

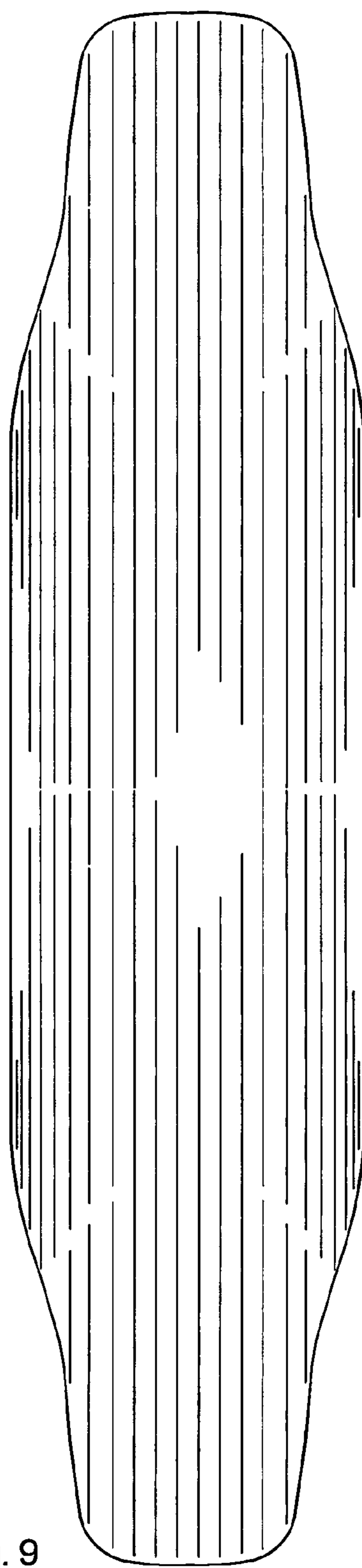
