(57) **CLAIM**

The ornamental design for a ceiling fan blade, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a ceiling fan blade according to the present design;

FIG. 2 is a left side elevation view of the ceiling fan blade shown in FIG. 1;

FIG. 3 is a top plan view of the ceiling fan blade shown in FIG. 1;

FIG. 4 is a bottom plan view of the ceiling fan blade shown in FIG. 1;

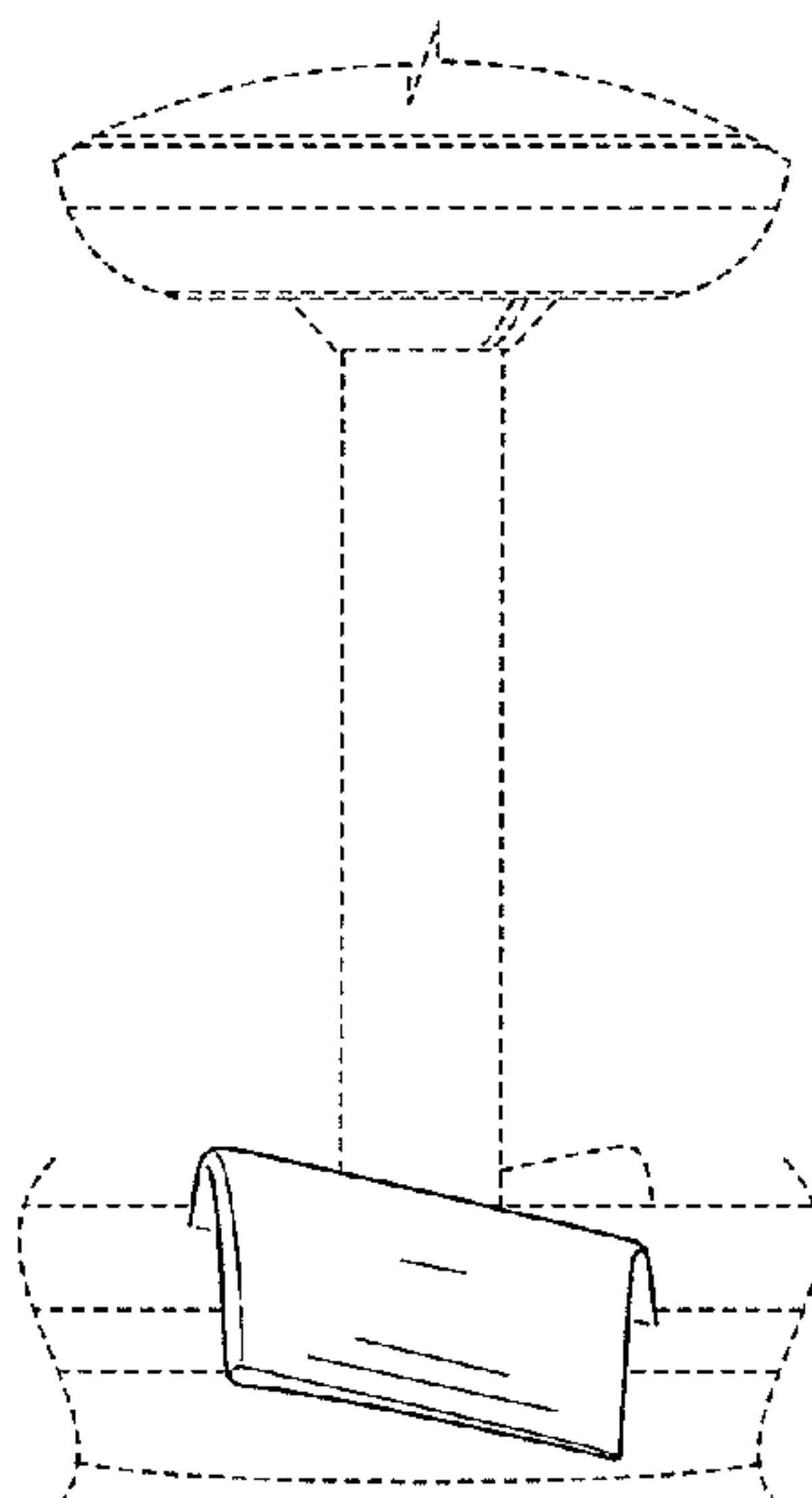
FIG. 5 is a right side elevation view of the ceiling fan blade shown in FIG. 1;

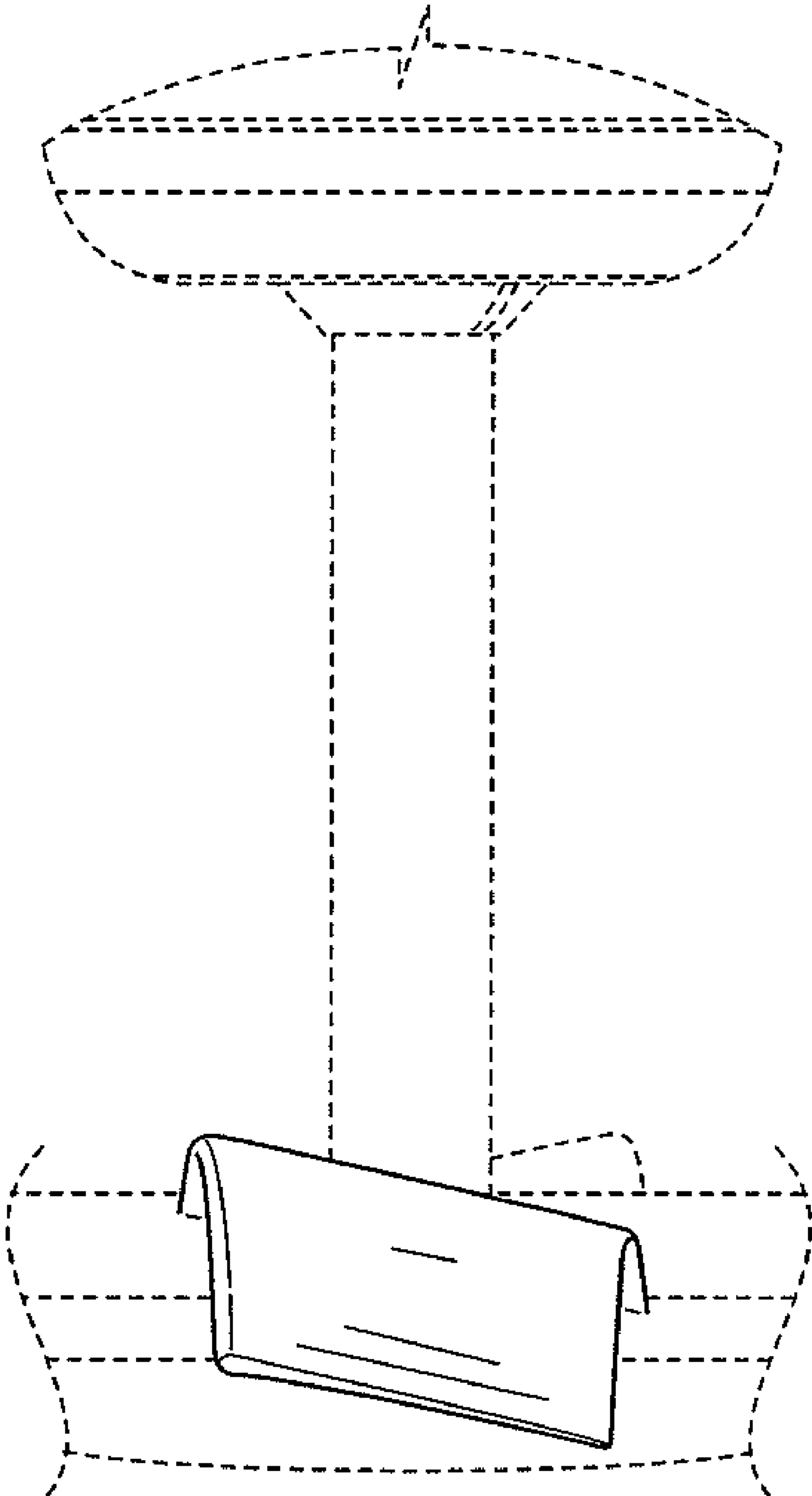

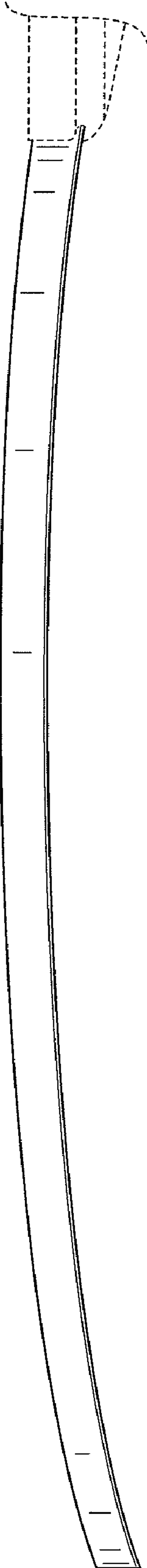

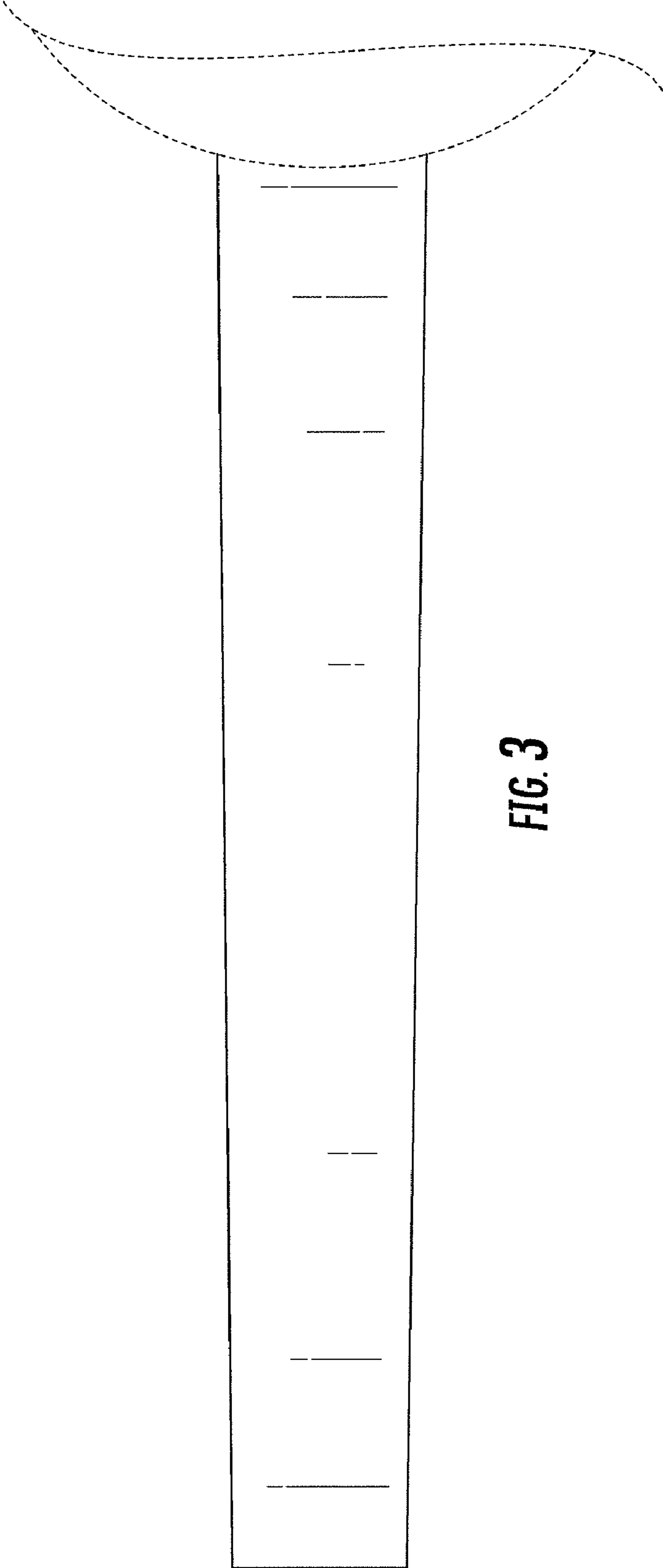

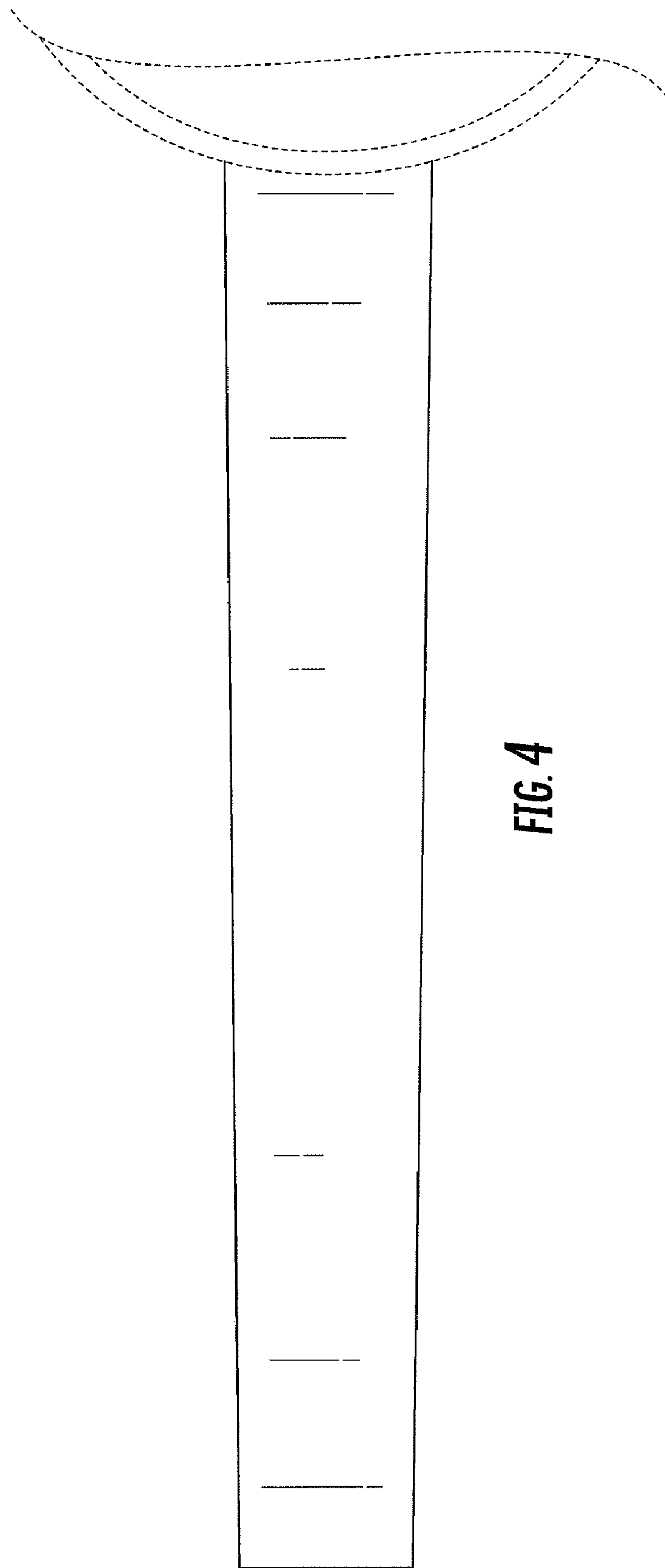

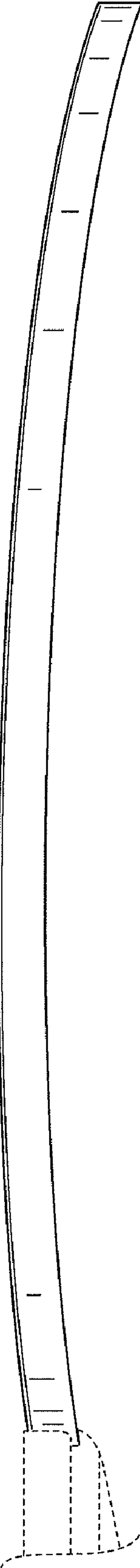

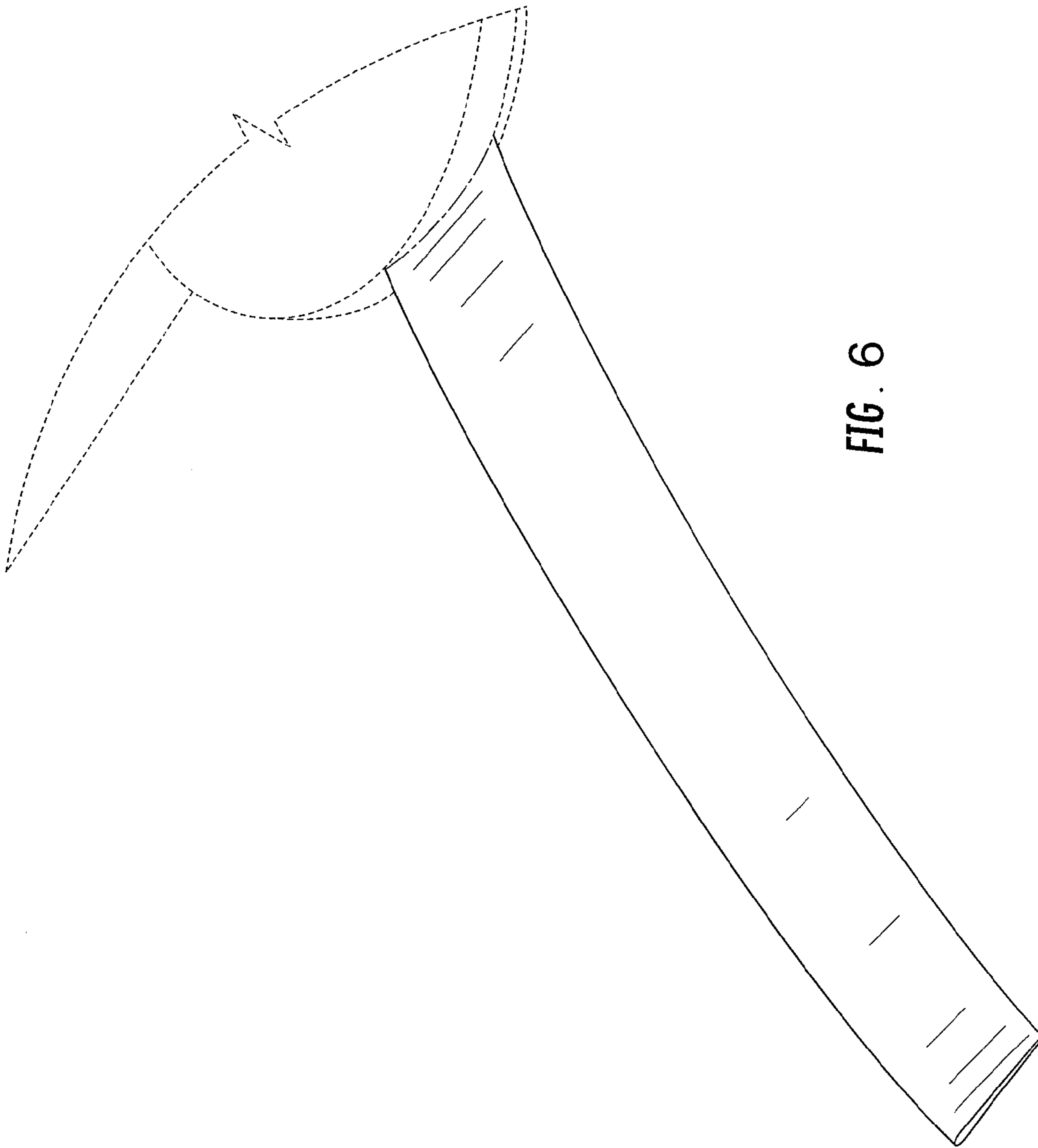

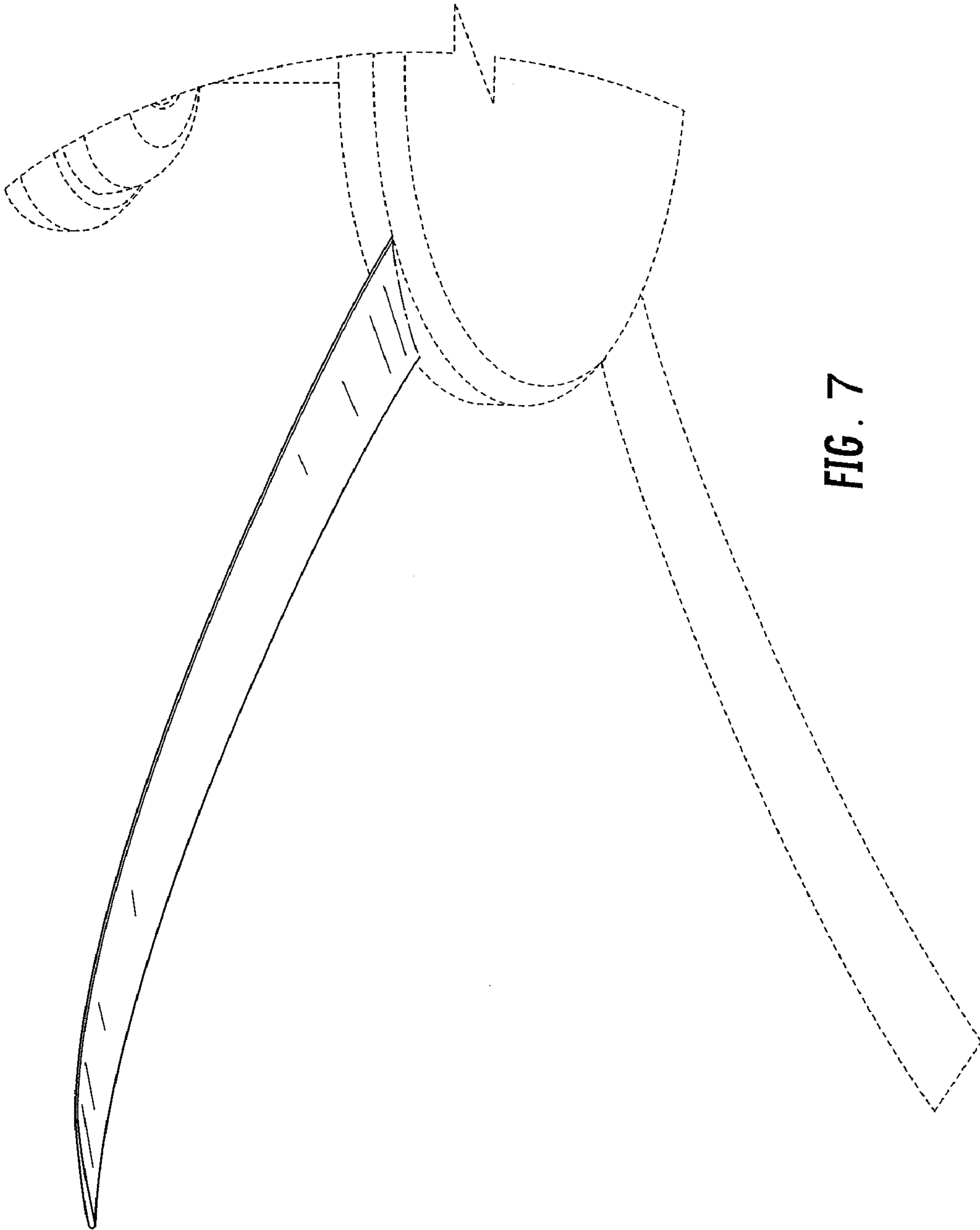
