(57) **CLAIM**

The ornamental design for filter pipette tip, as shown and described.

**DESCRIPTION**

 FIG. 17 is a side elevation view thereof;

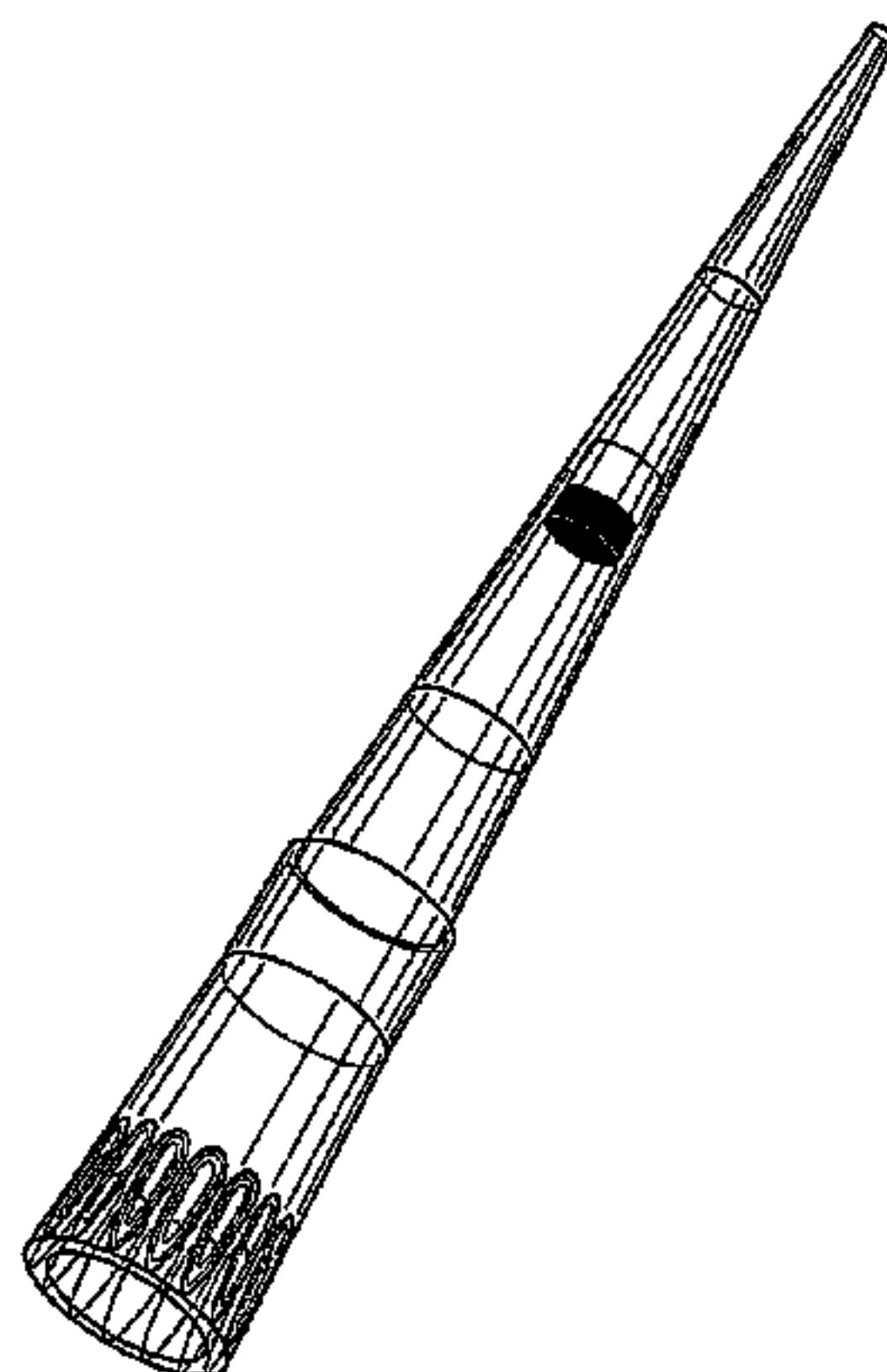


FIG. **18** is another side elevation view thereof;

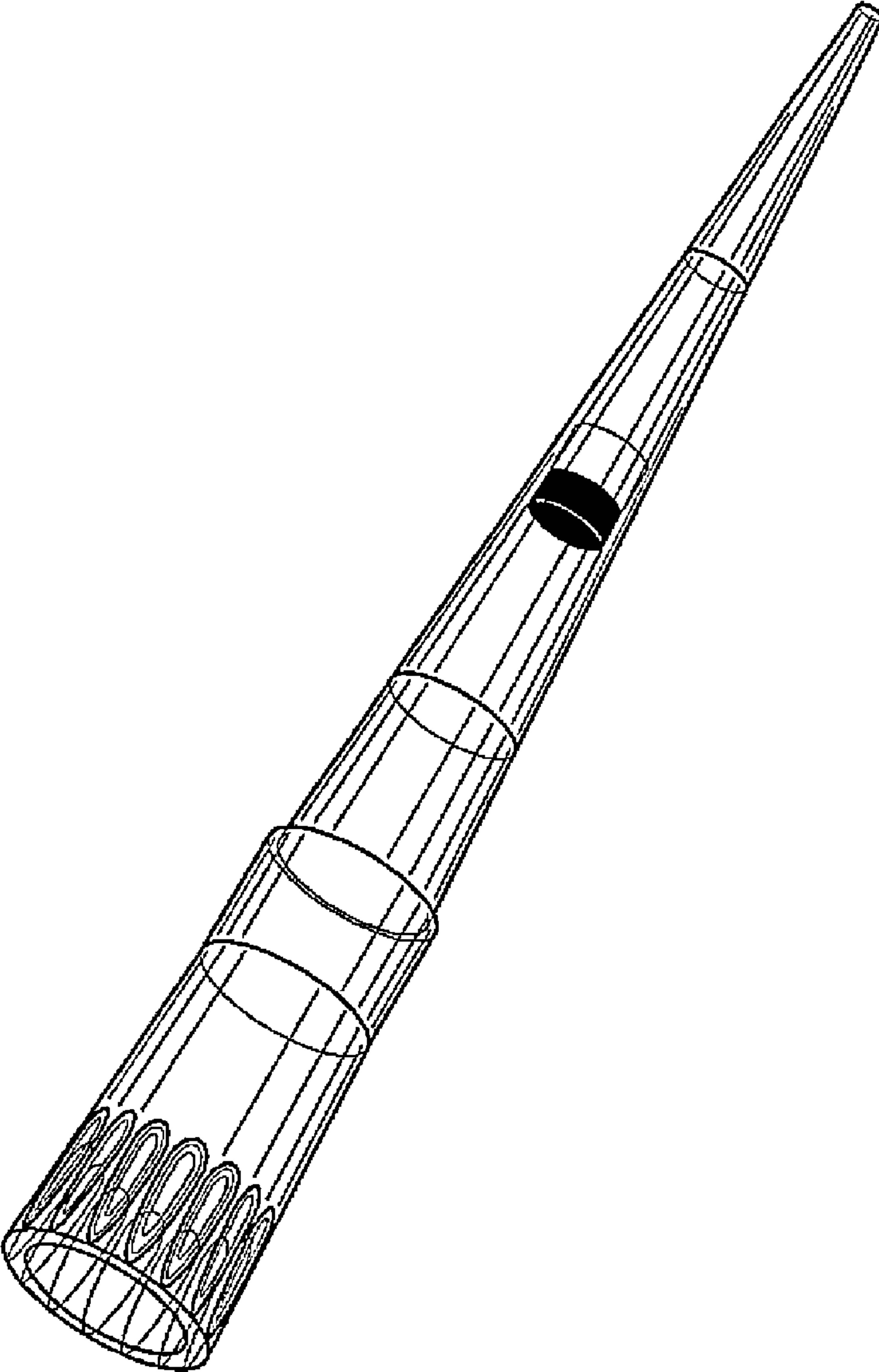

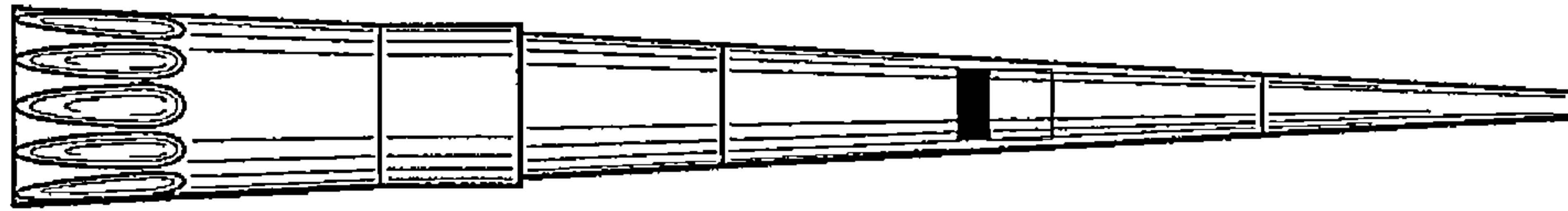

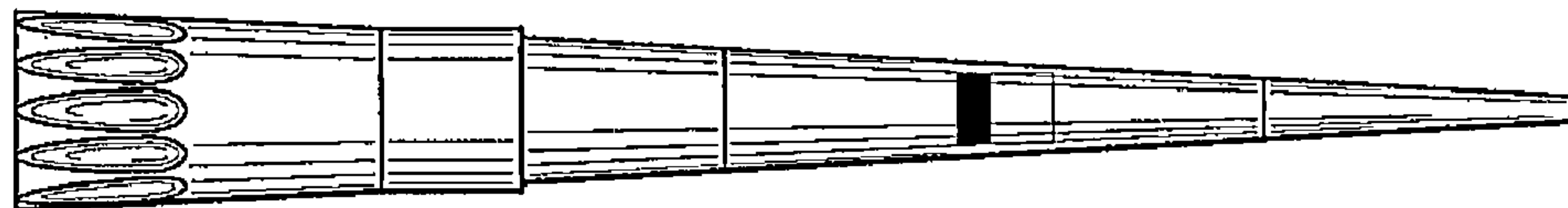

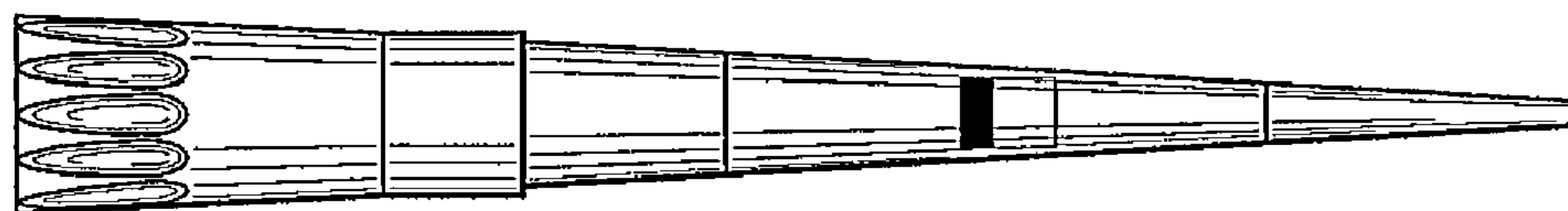

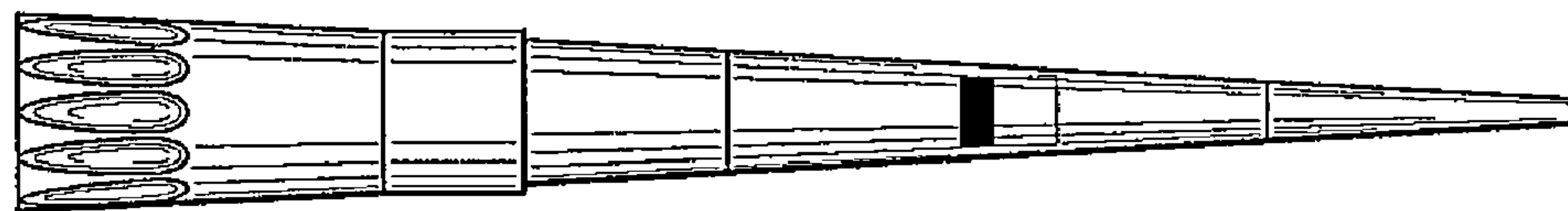

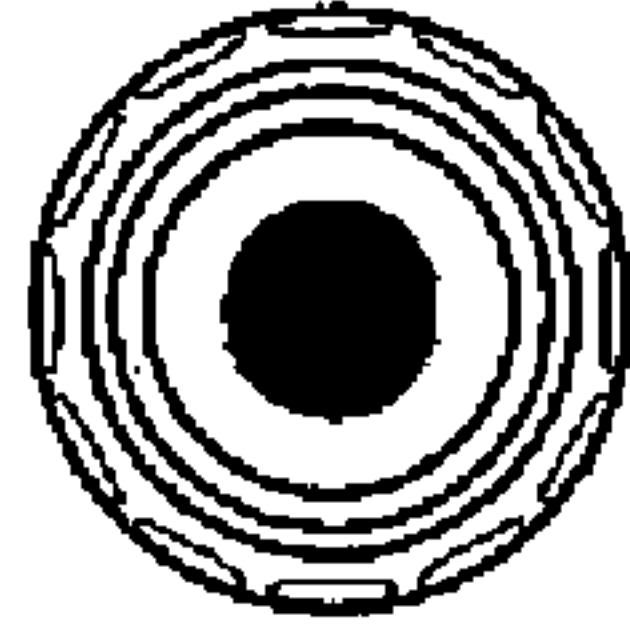

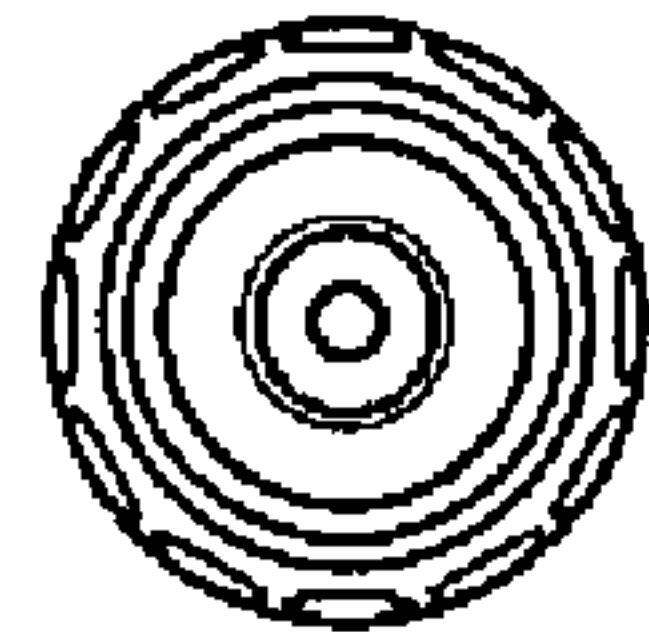

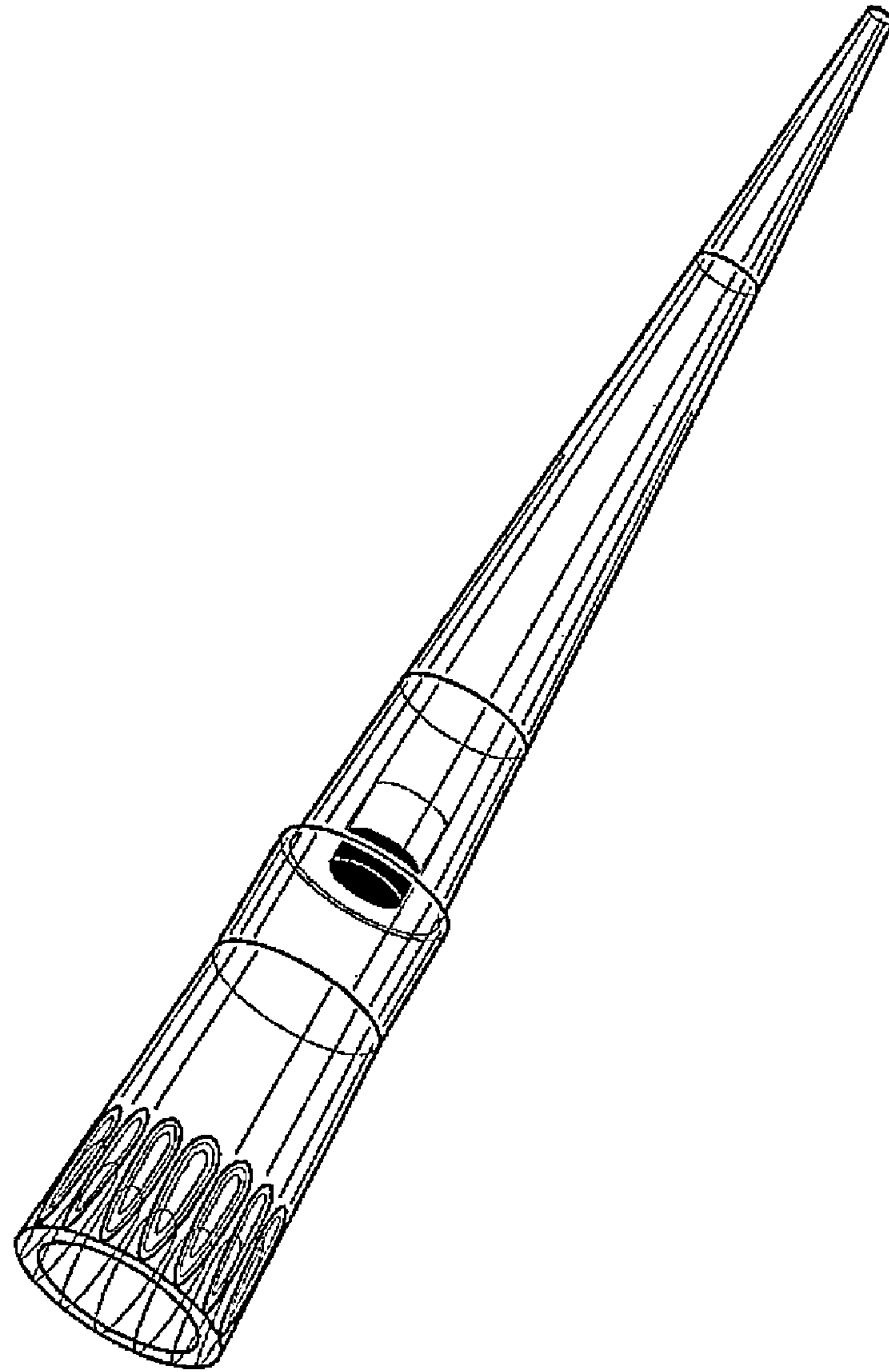

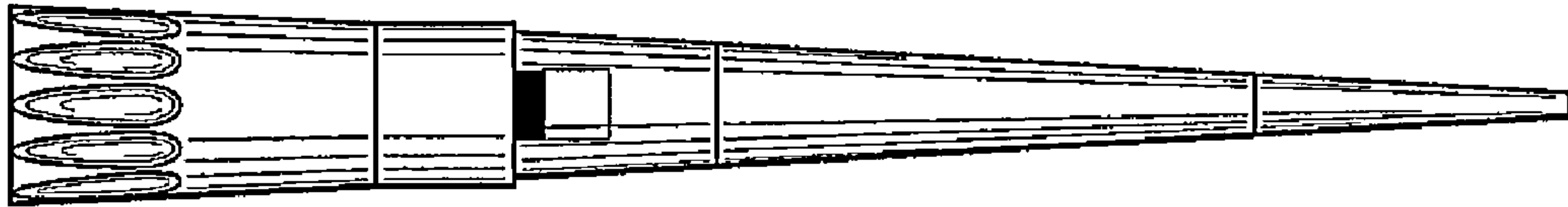

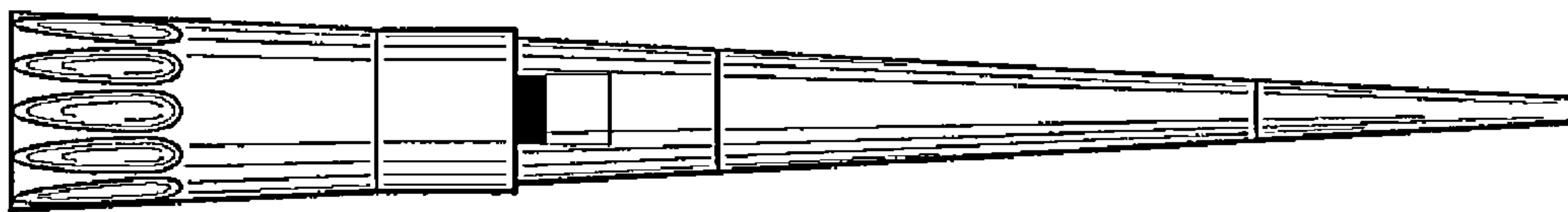

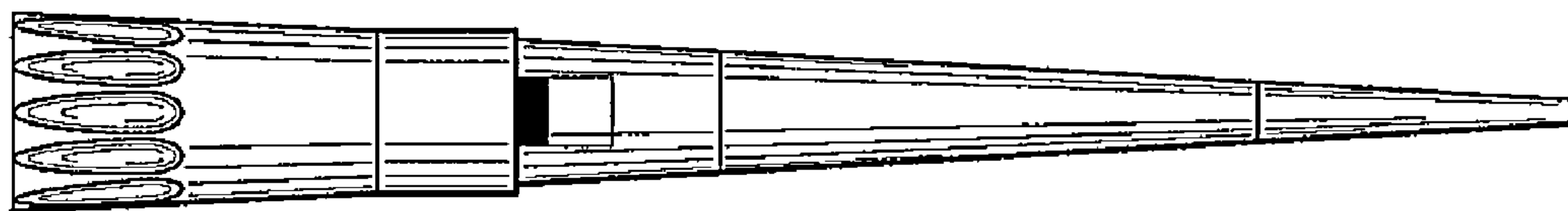

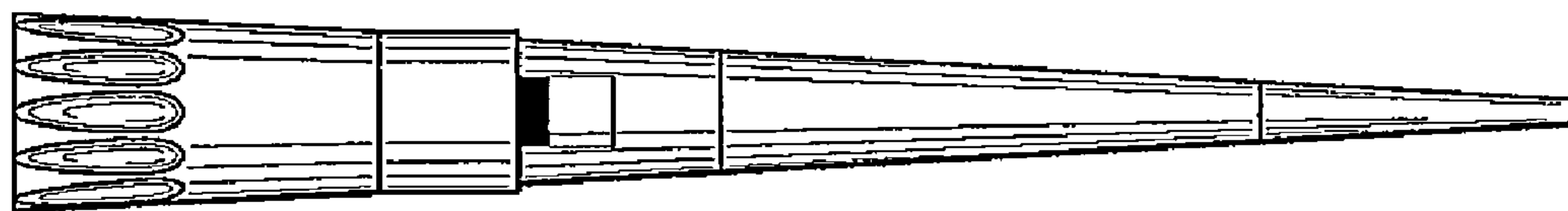

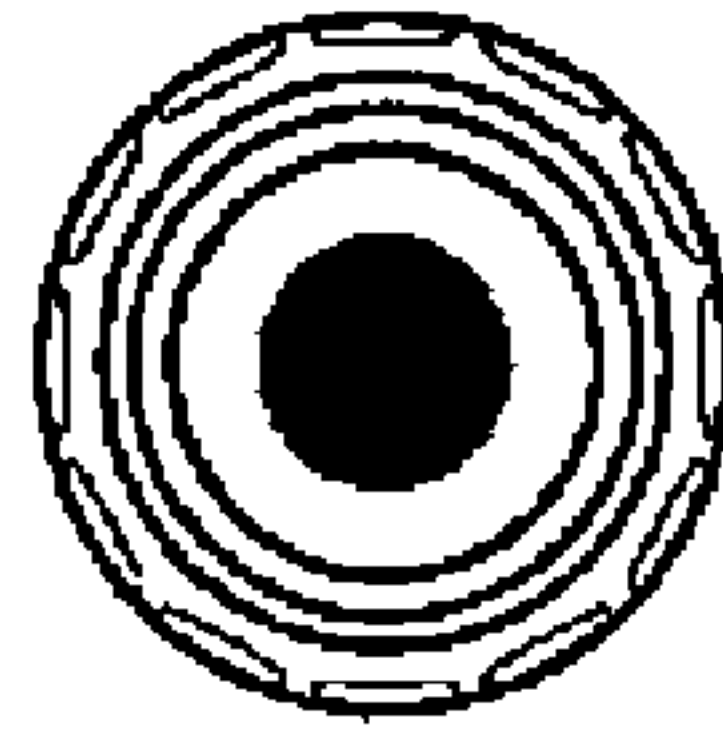

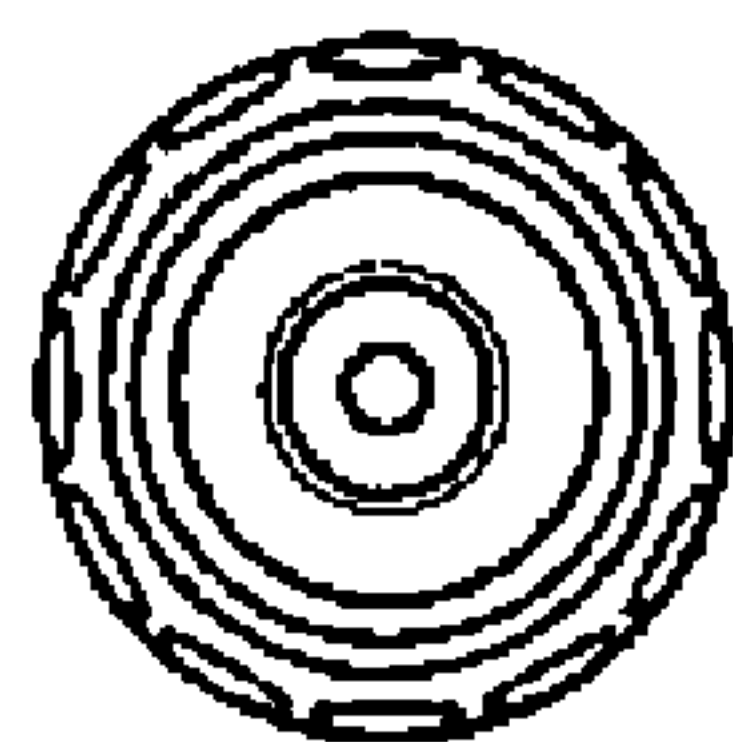

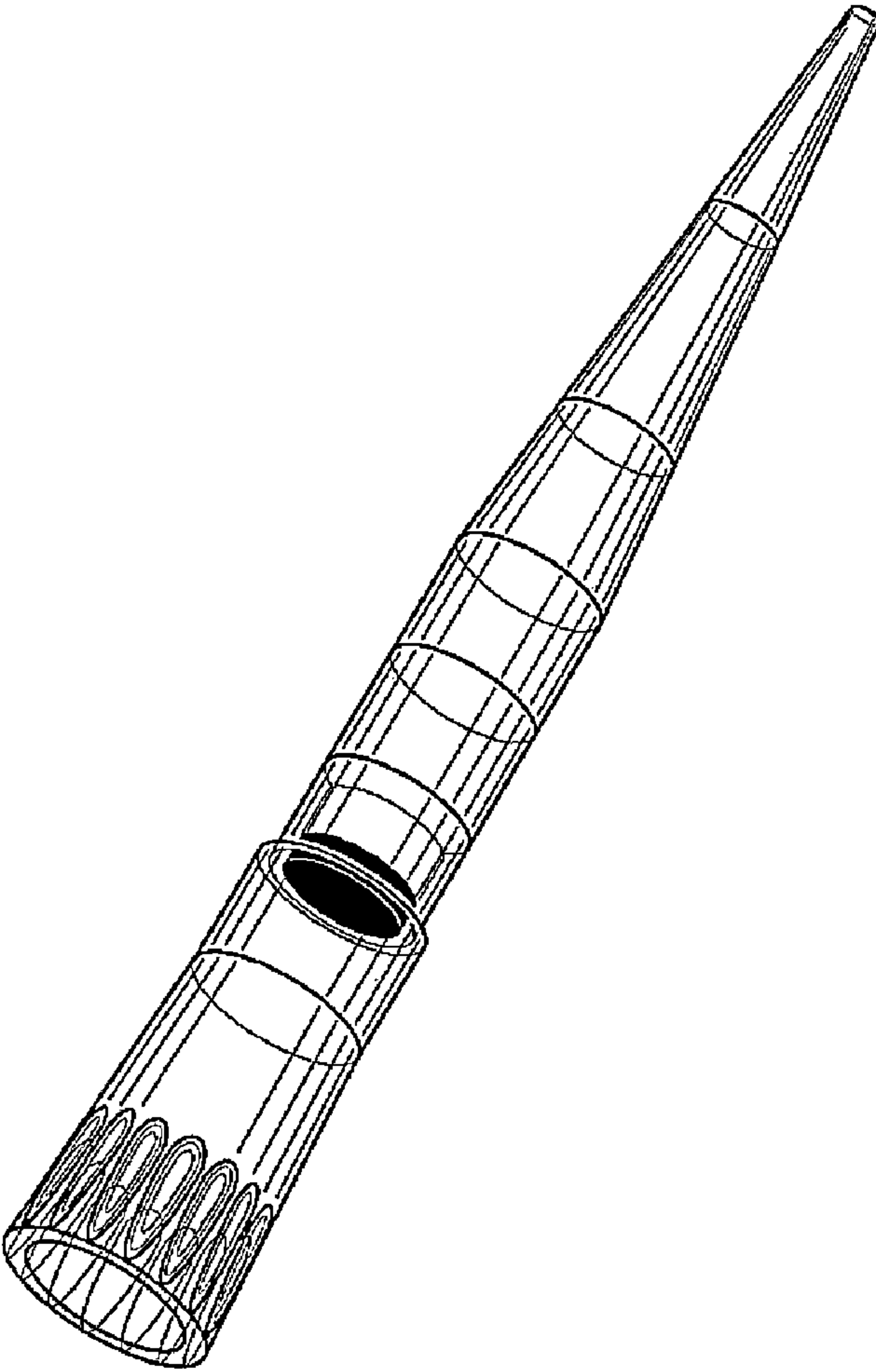

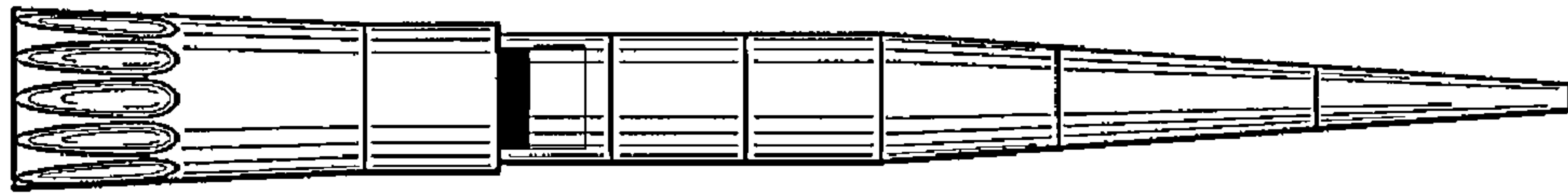

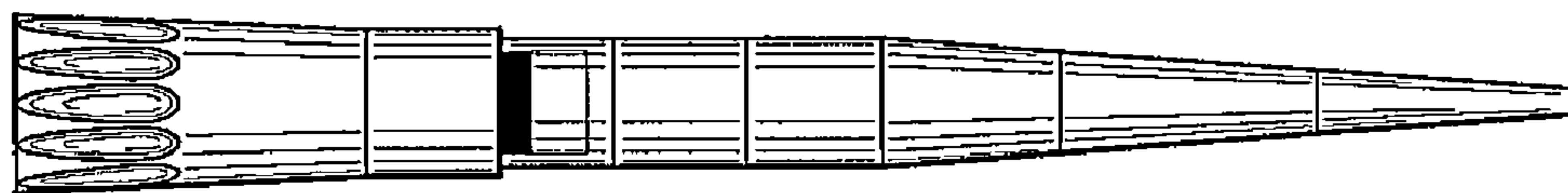

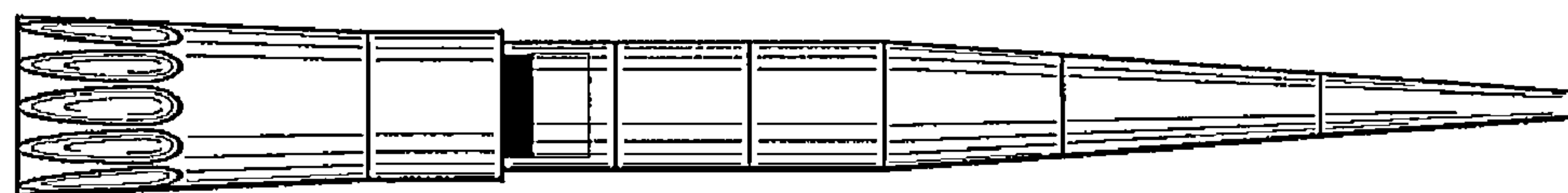

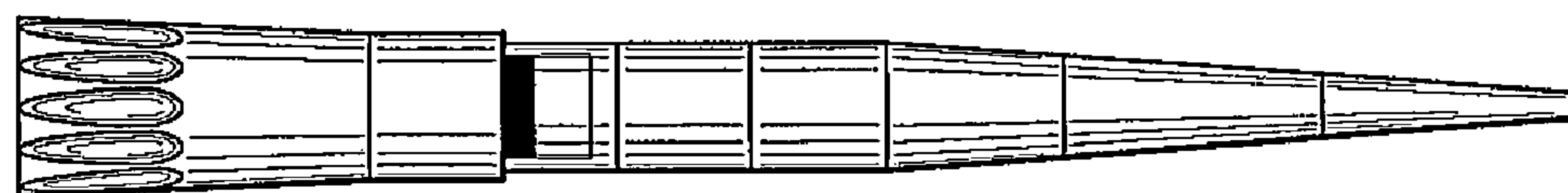

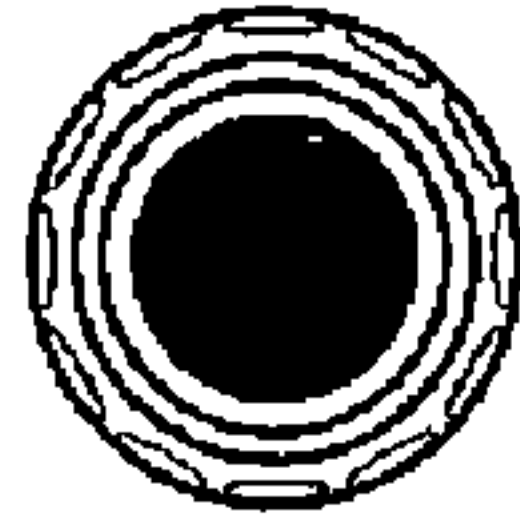

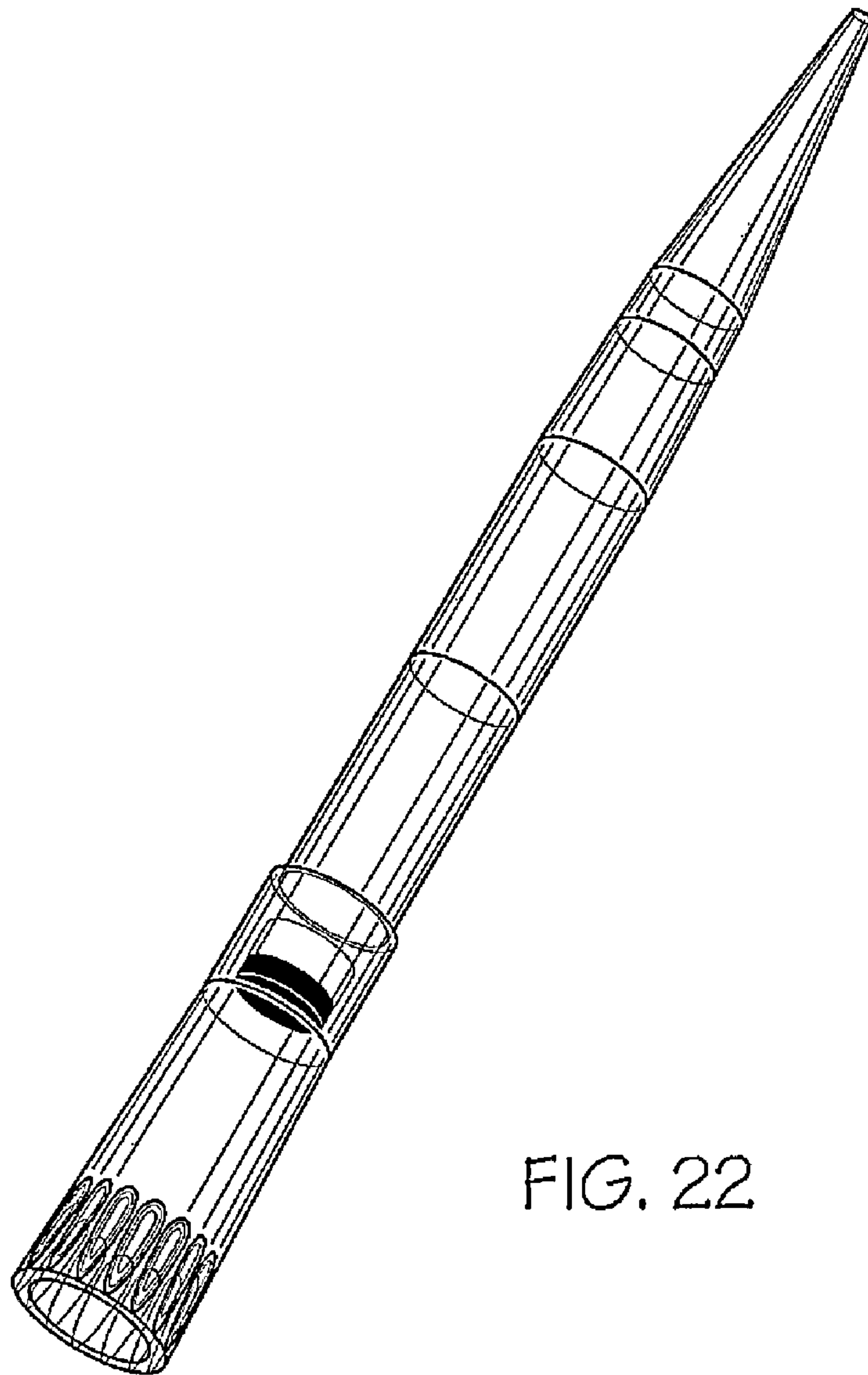

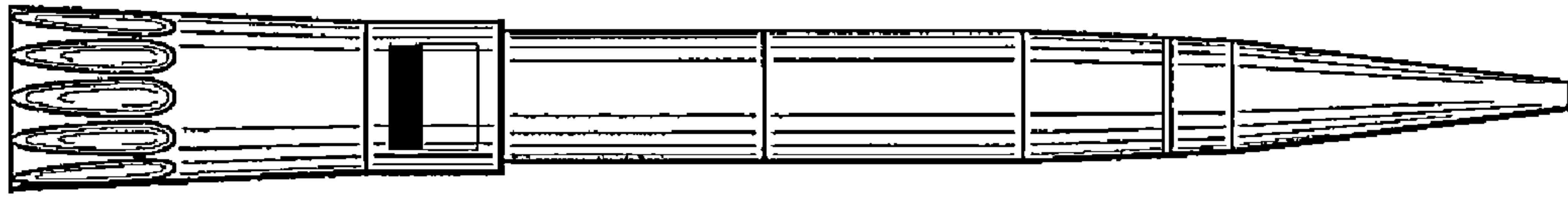

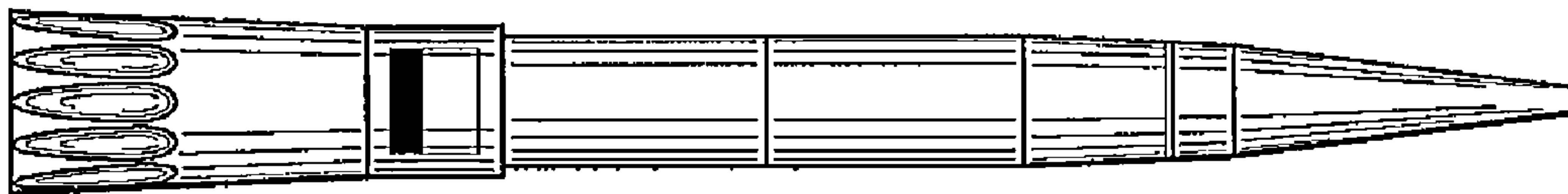

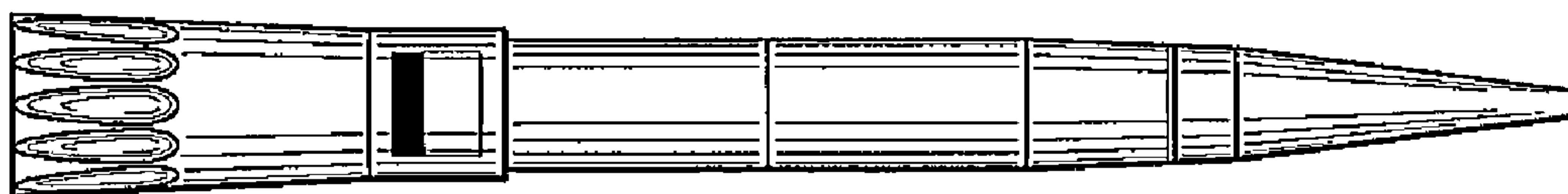

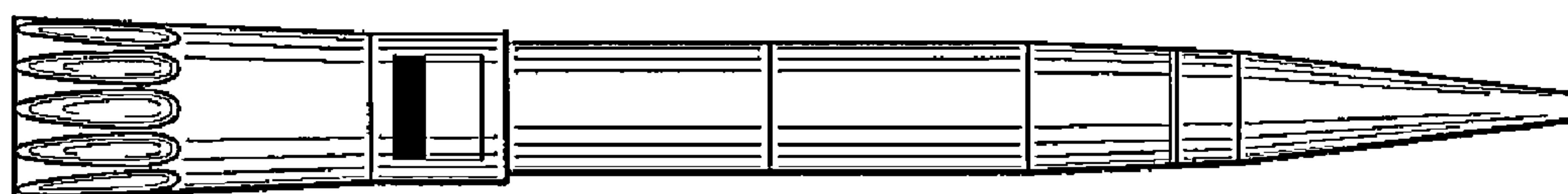

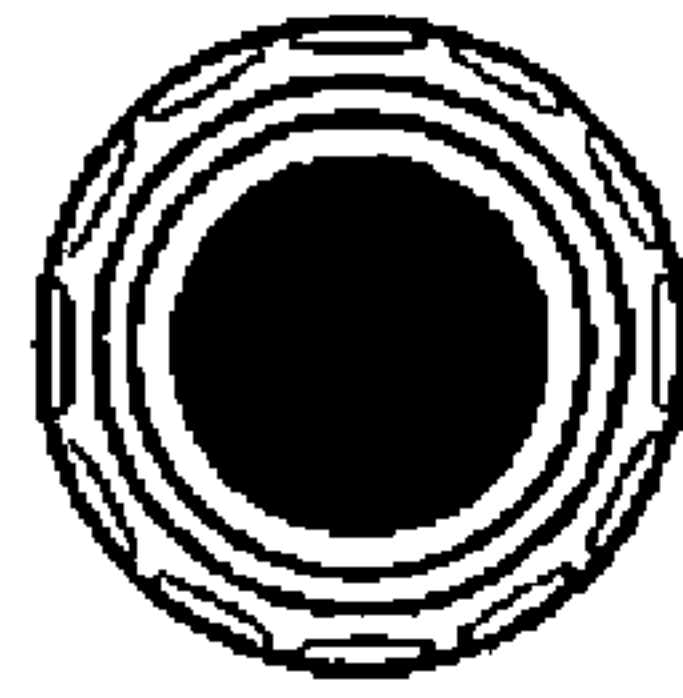

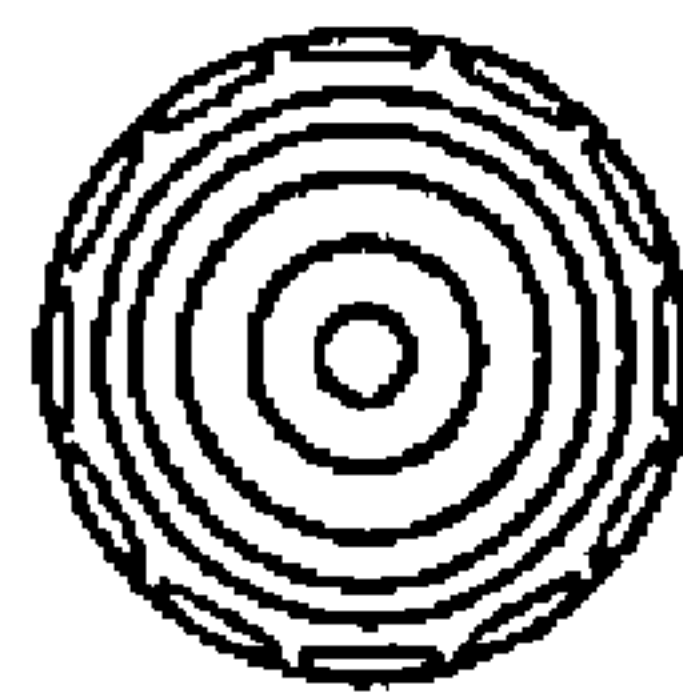
