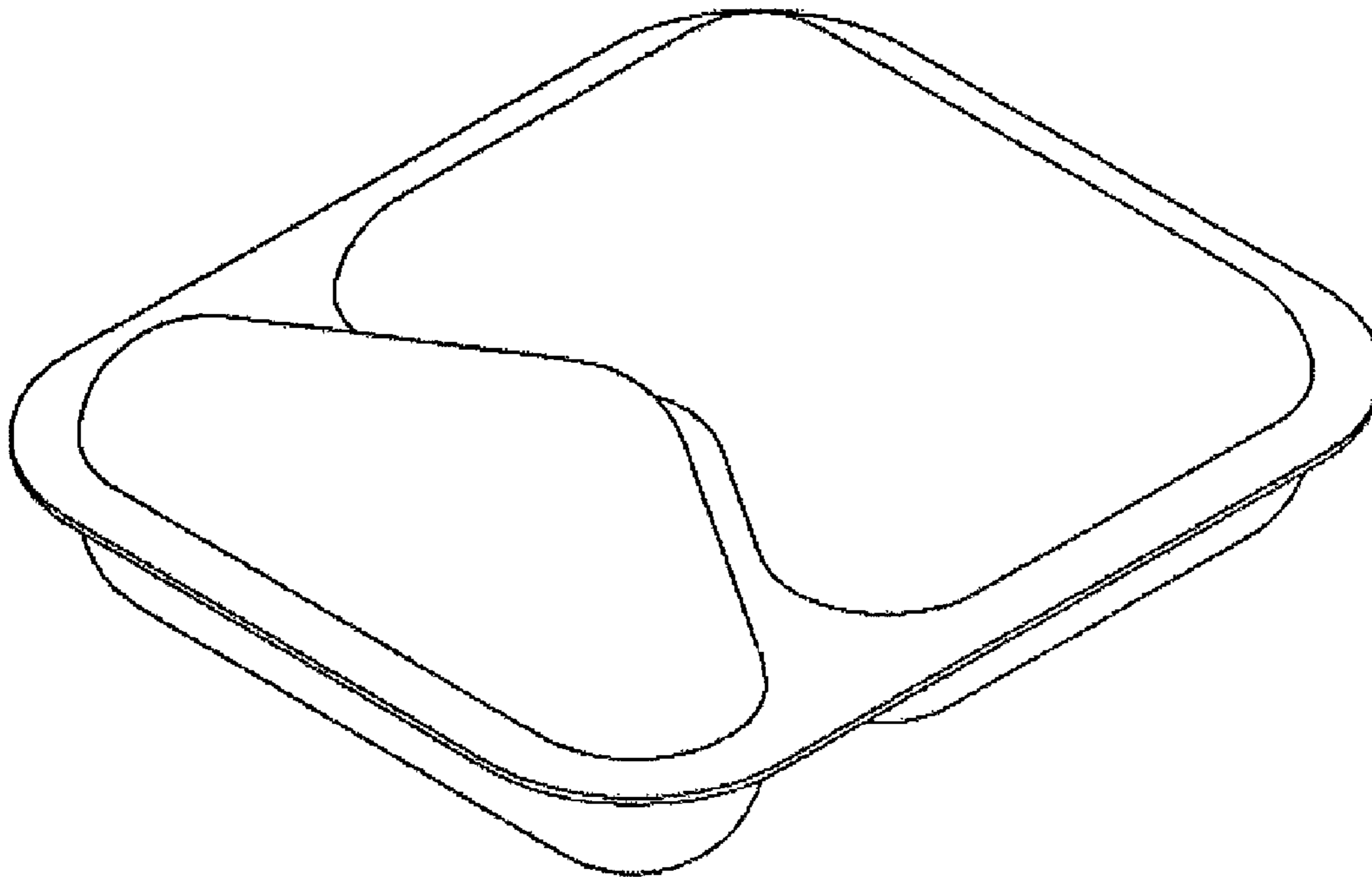
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a capsule for washing products embodying our new design;

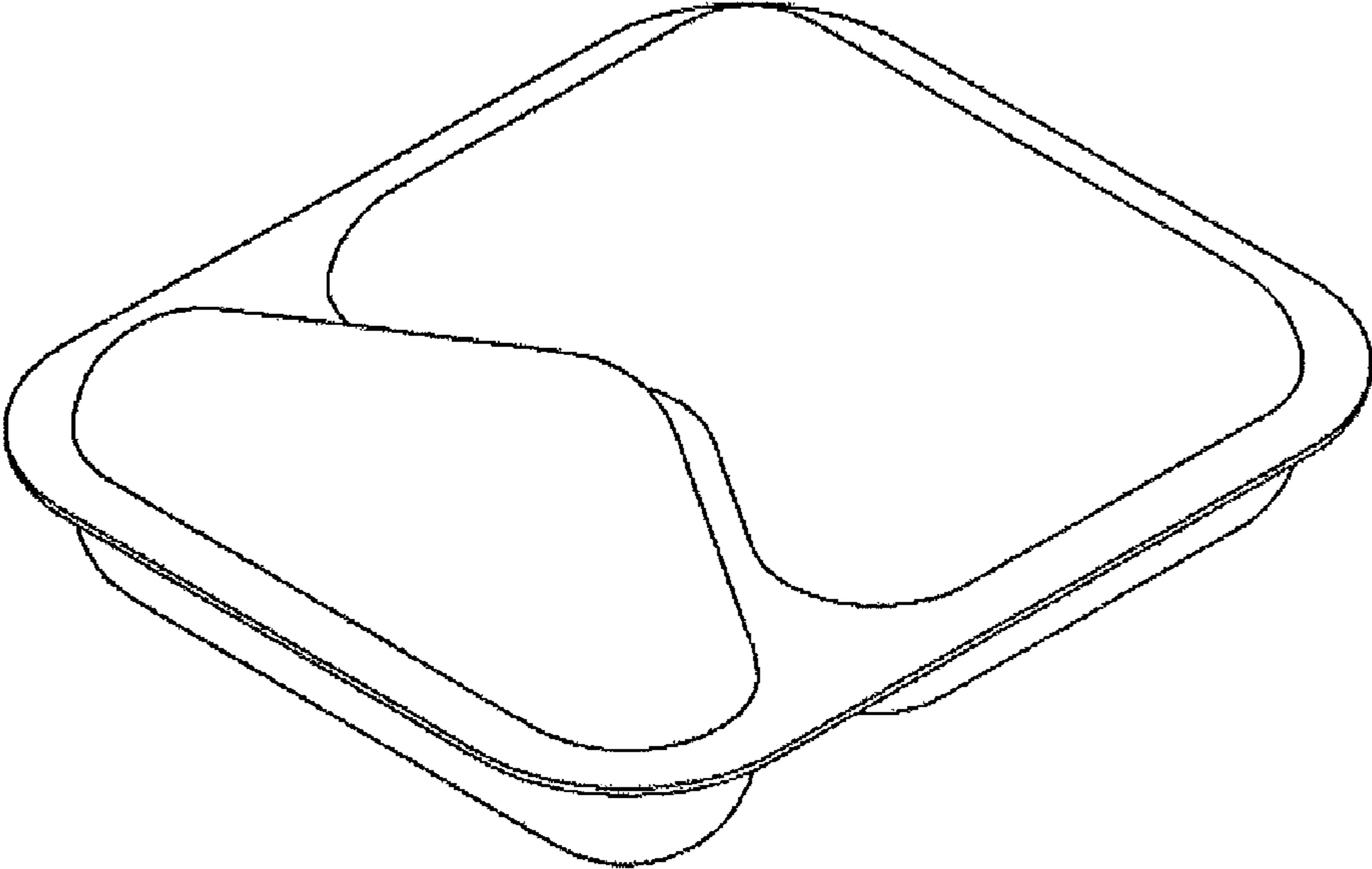

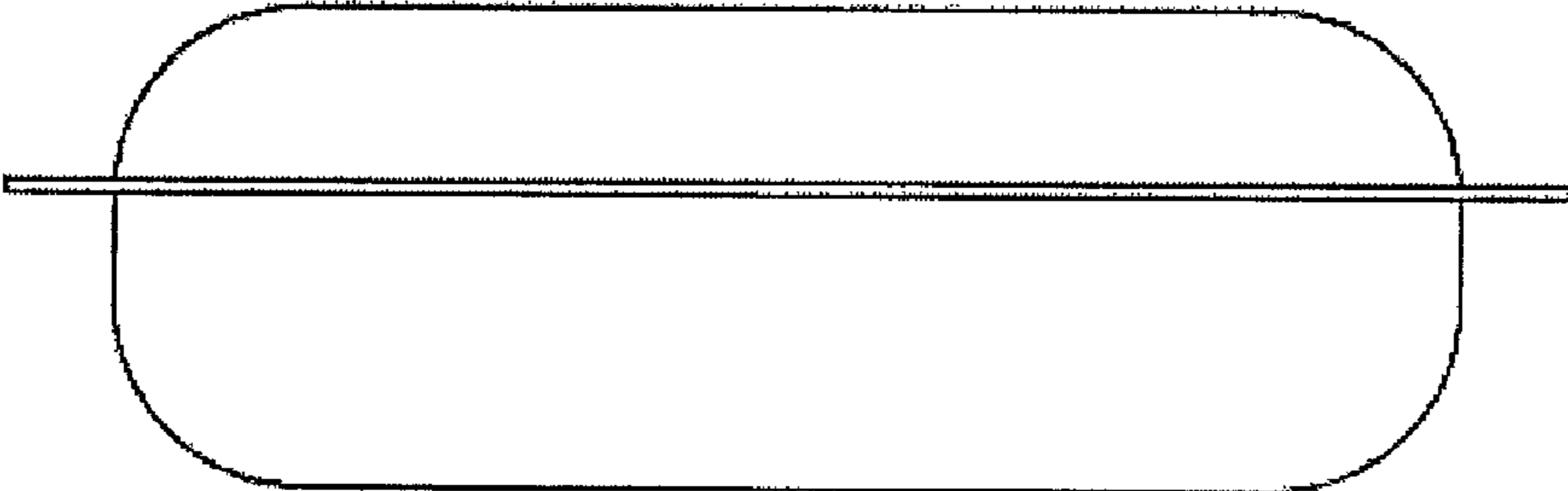

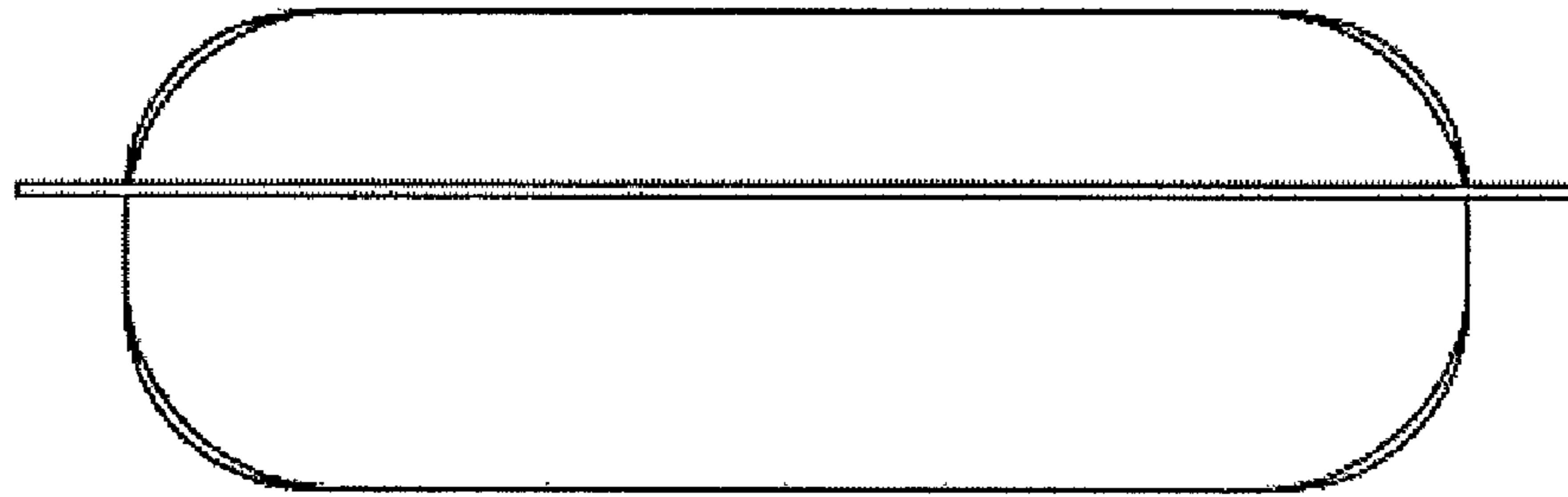

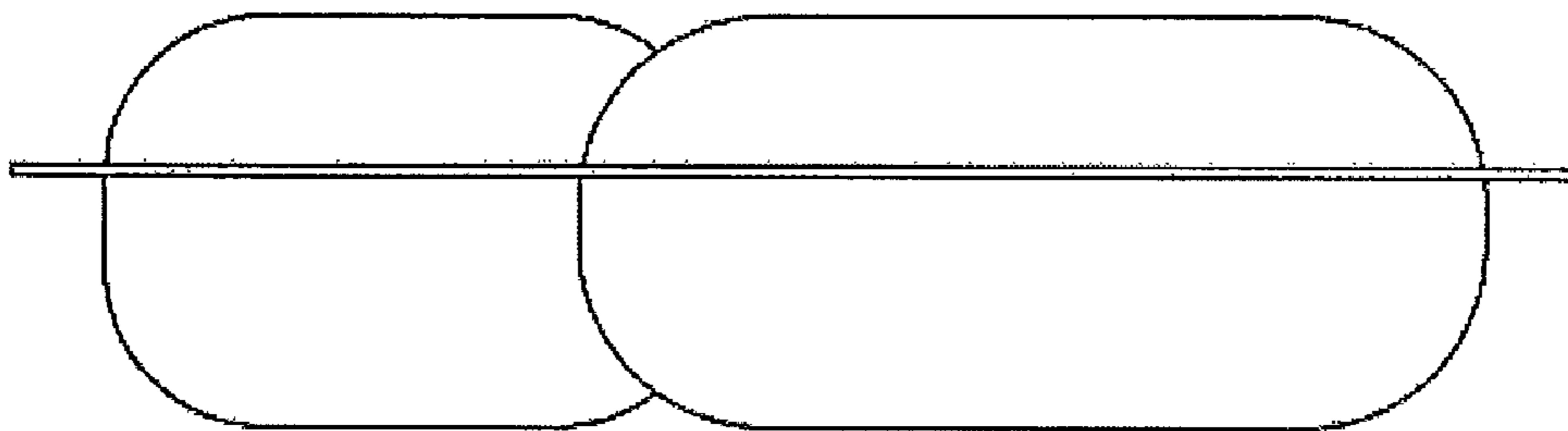

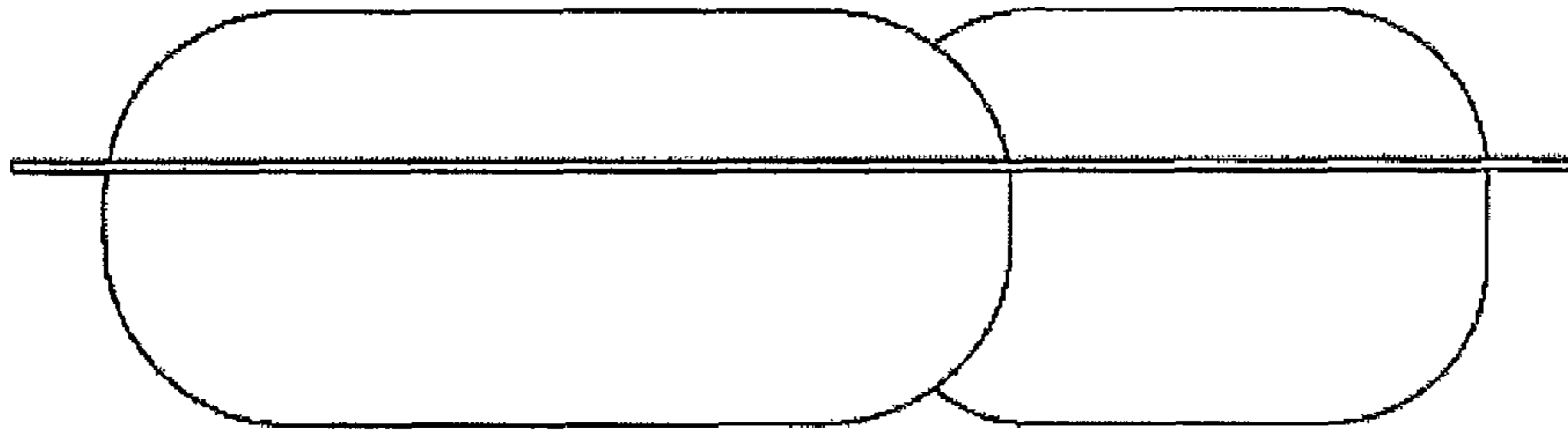

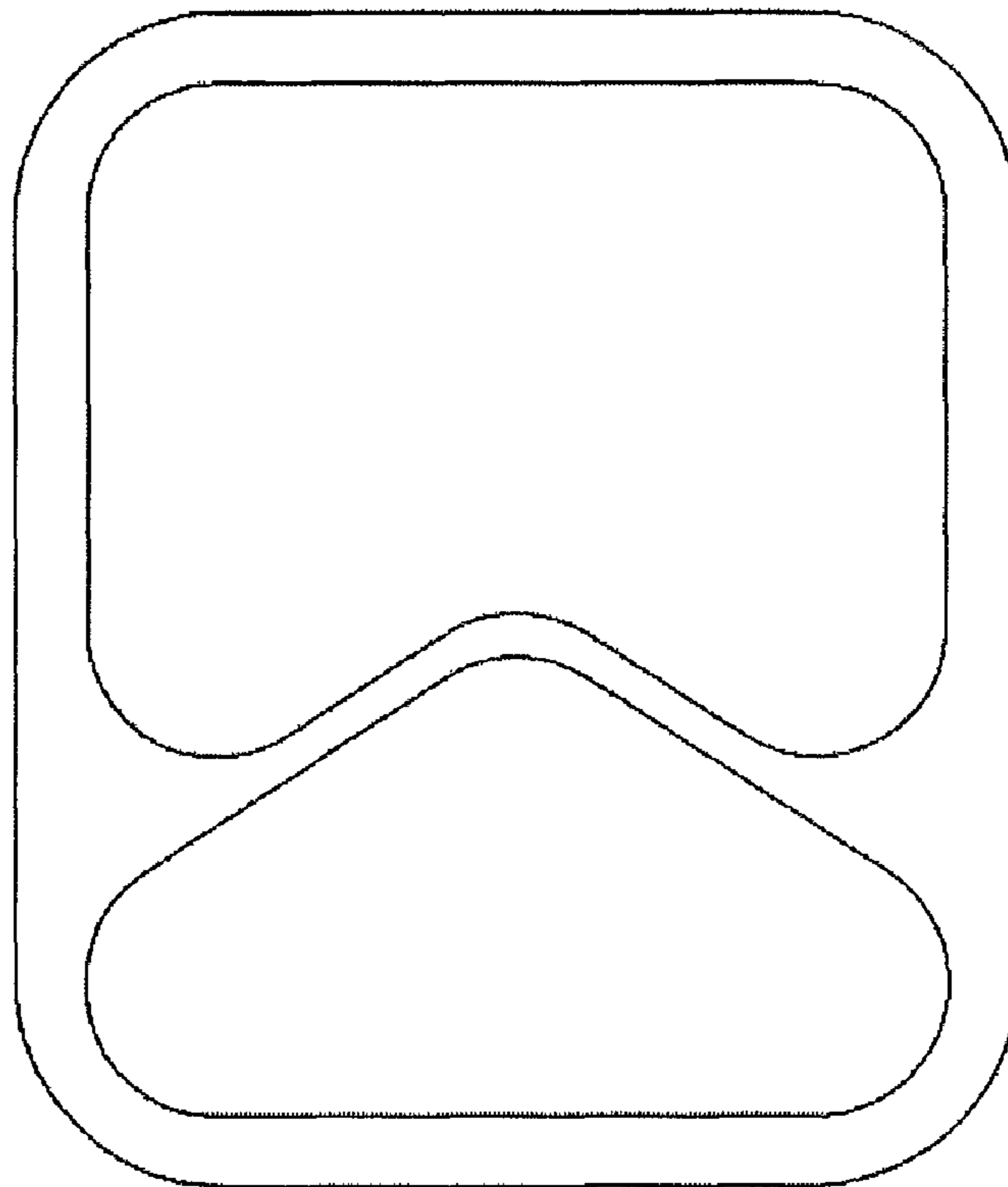

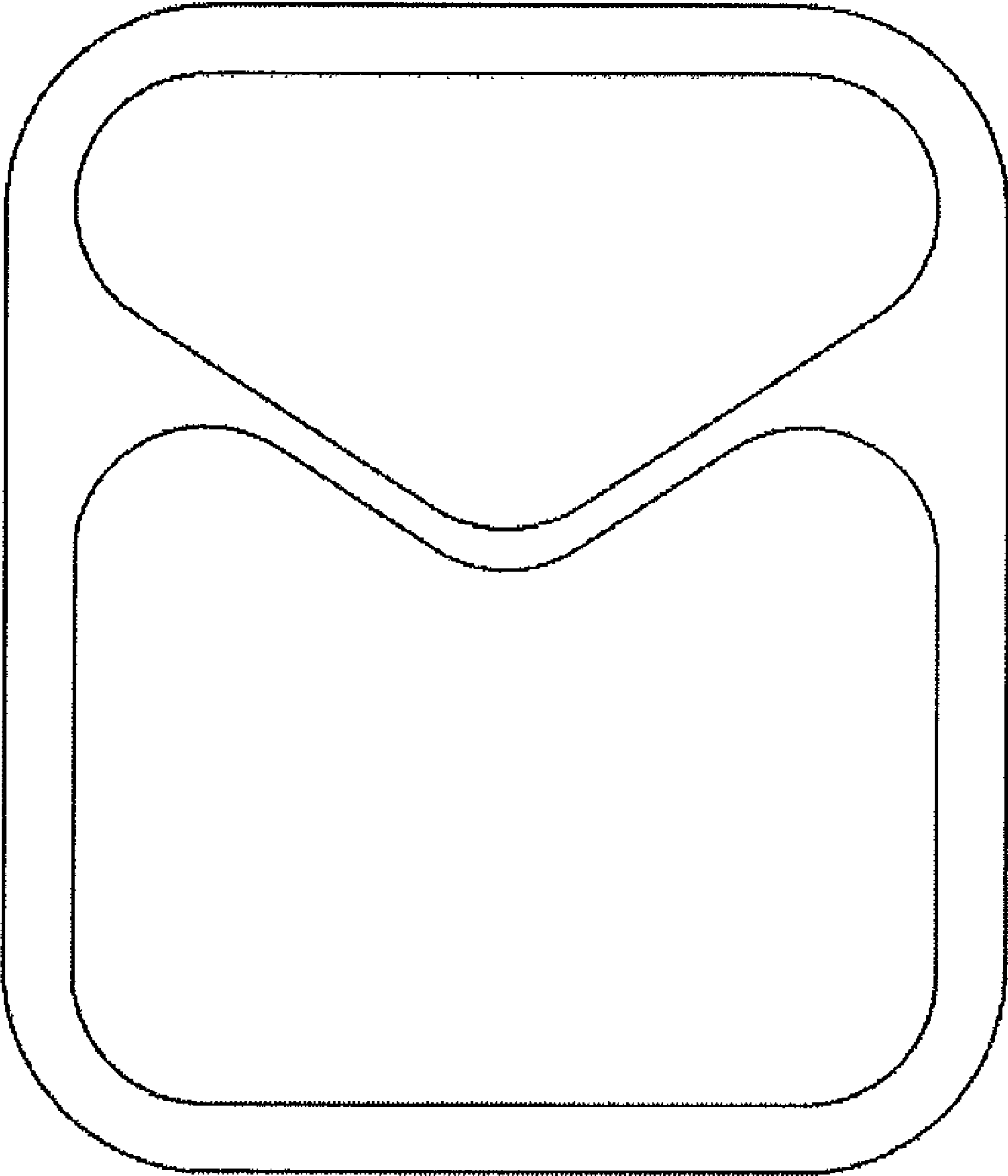
