(57) **CLAIM**

The ornamental design for a jet bridge shuttle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a jet bridge shuttle constructed according to the principles of the present invention;

FIG. 2 is a left side view of the shuttle shown in FIG. 1;

FIG. 3 is a front view of the shuttle shown in FIG. 1;

FIG. 4 is a rear view of the shuttle shown in FIG. 1;

FIG. 5 is top view of the shuttle shown in FIG. 1; and,

FIG. 6 is bottom view of the shuttle shown in FIG. 1.

The right side is a mirror image of the left side.

The broken lines in the drawings showing portions of the jet bridge shuttle are for purposes of illustrating the portions that form no part of the claimed design.

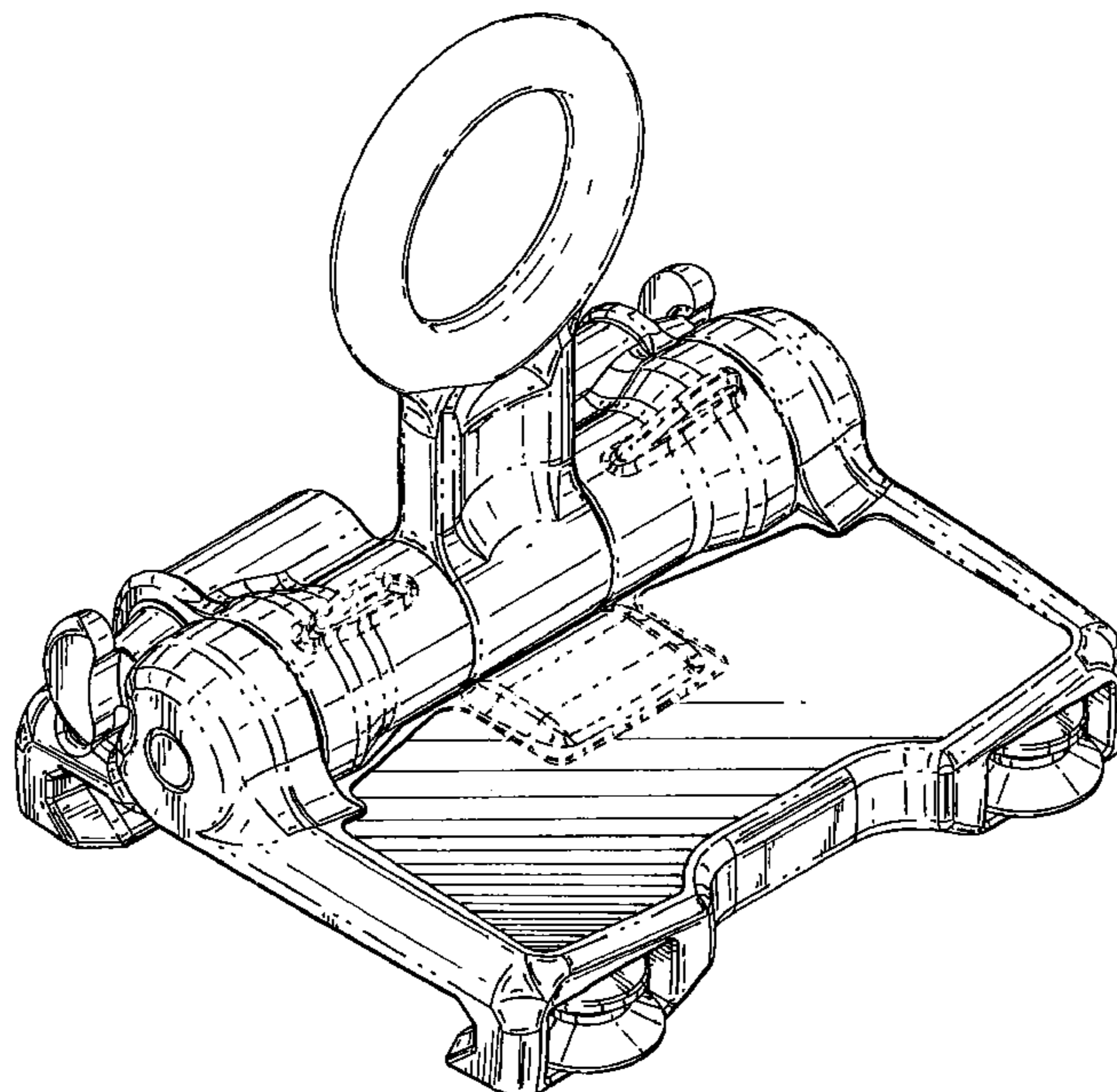

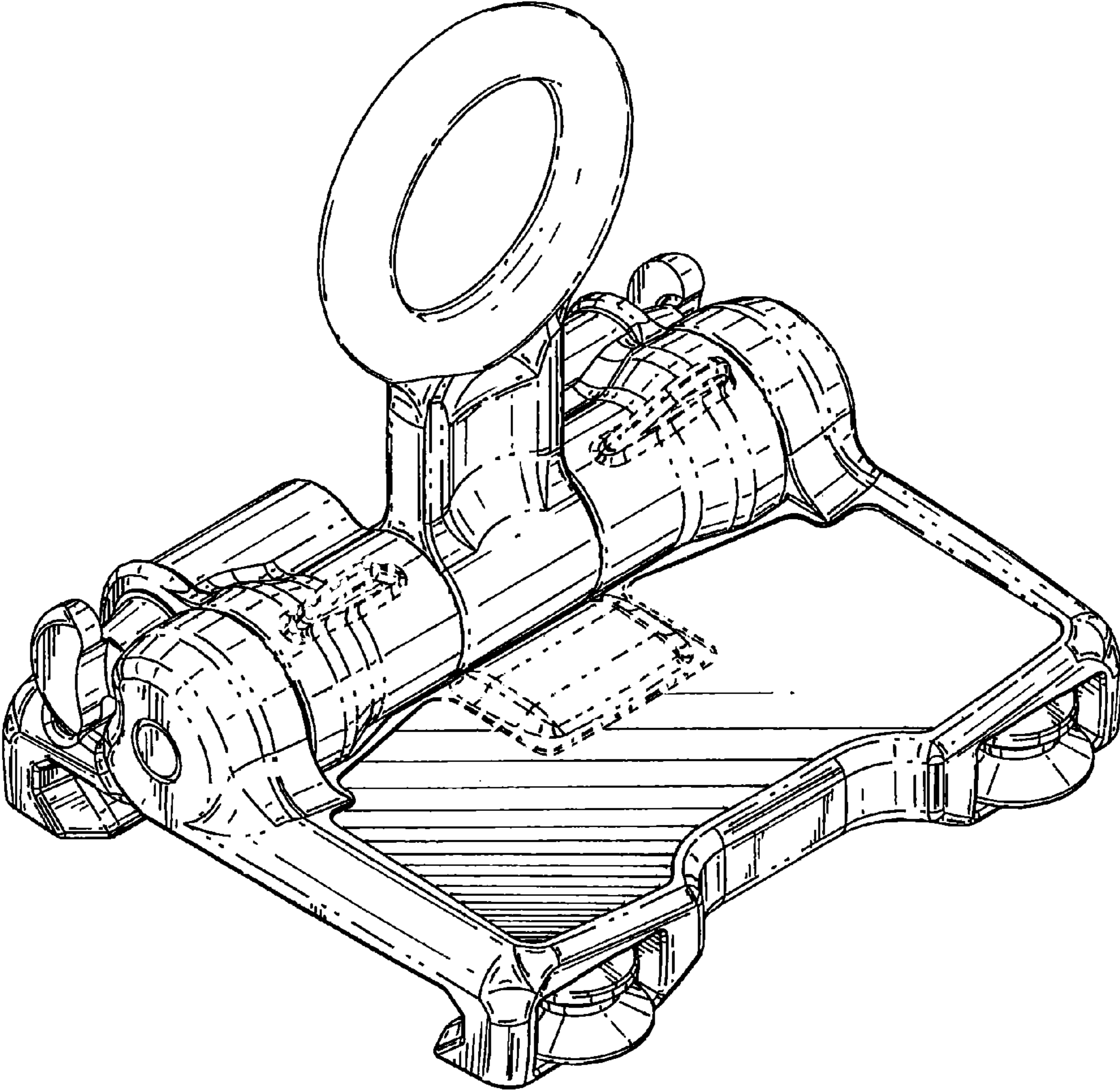
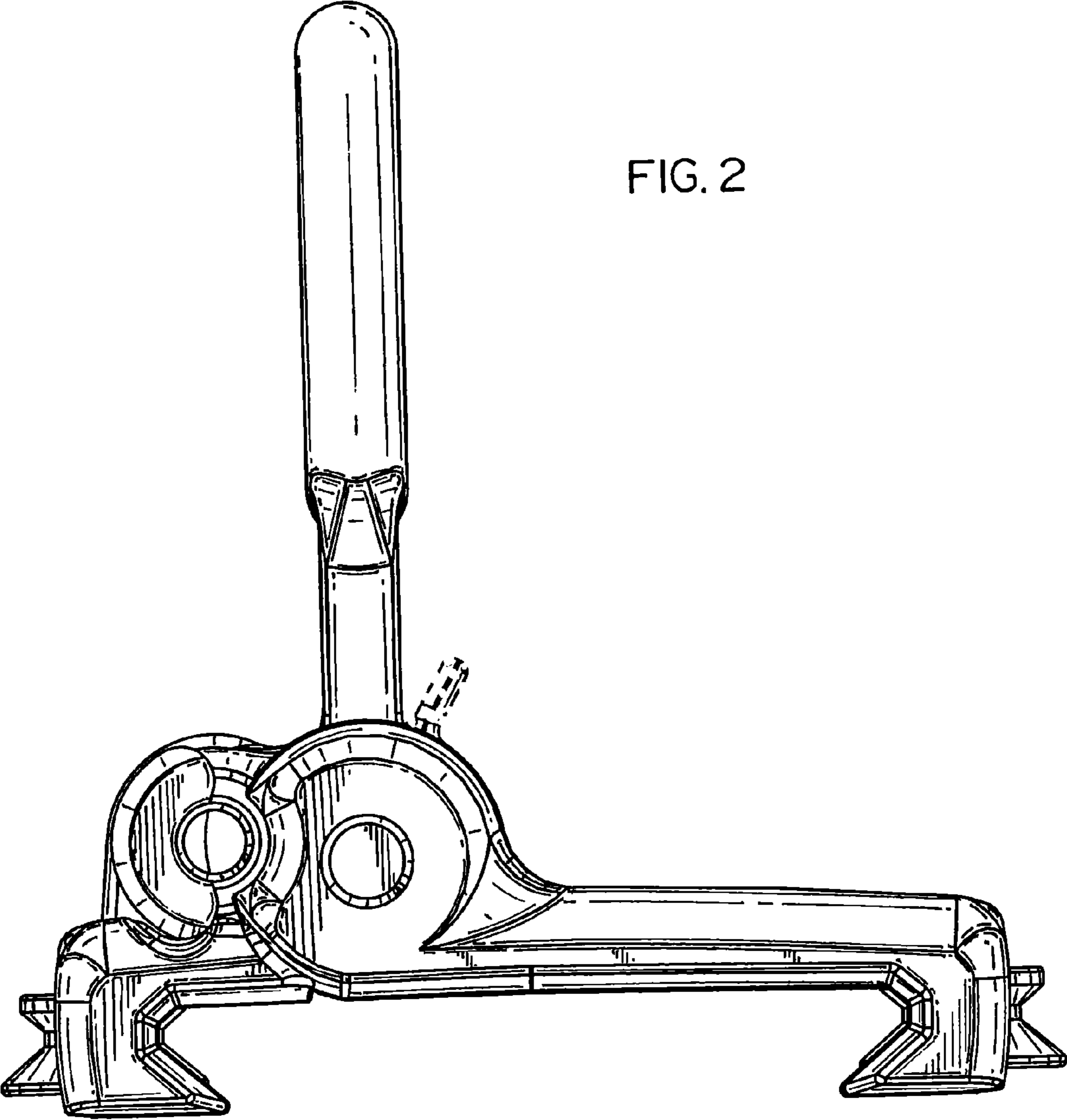

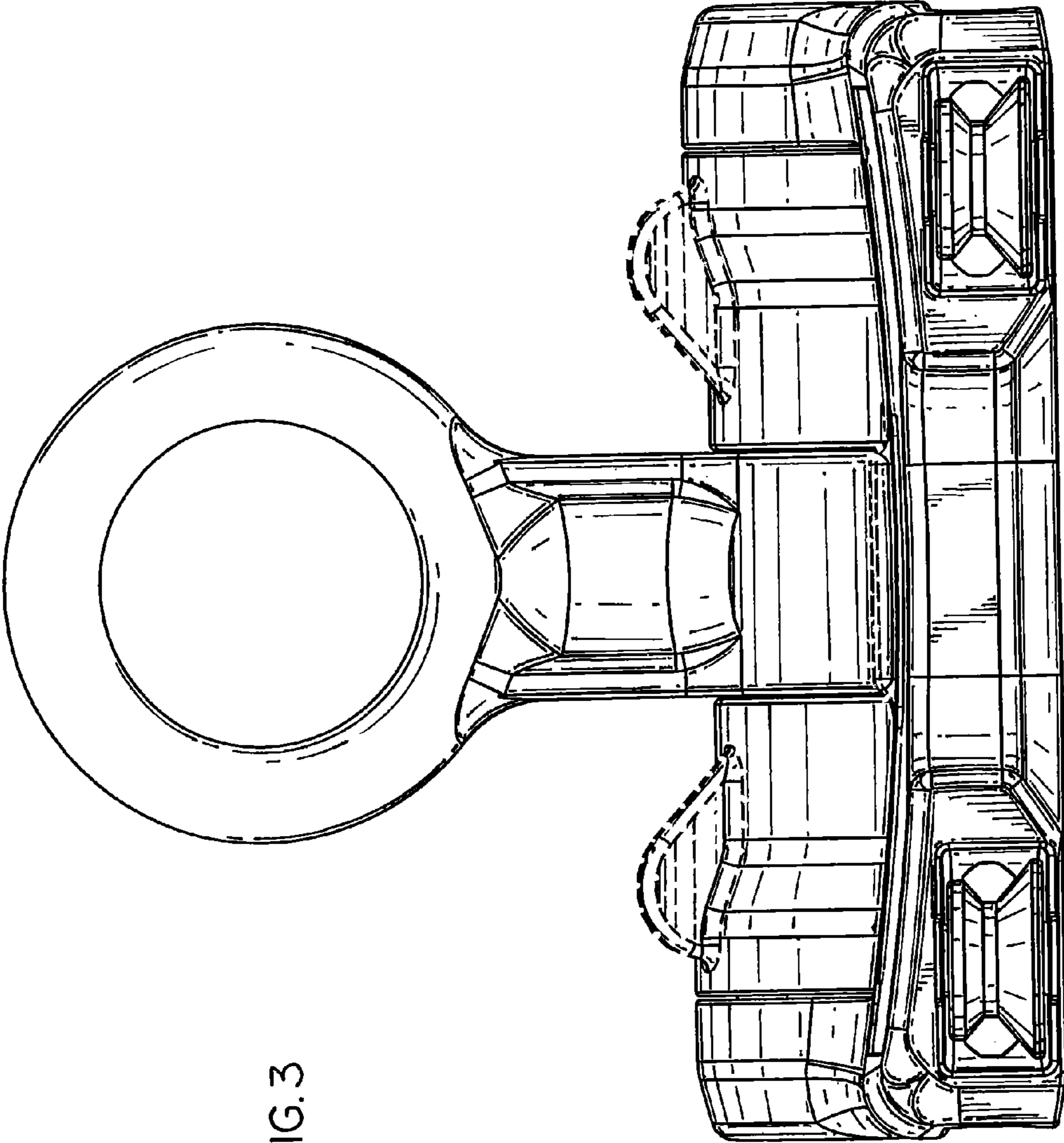

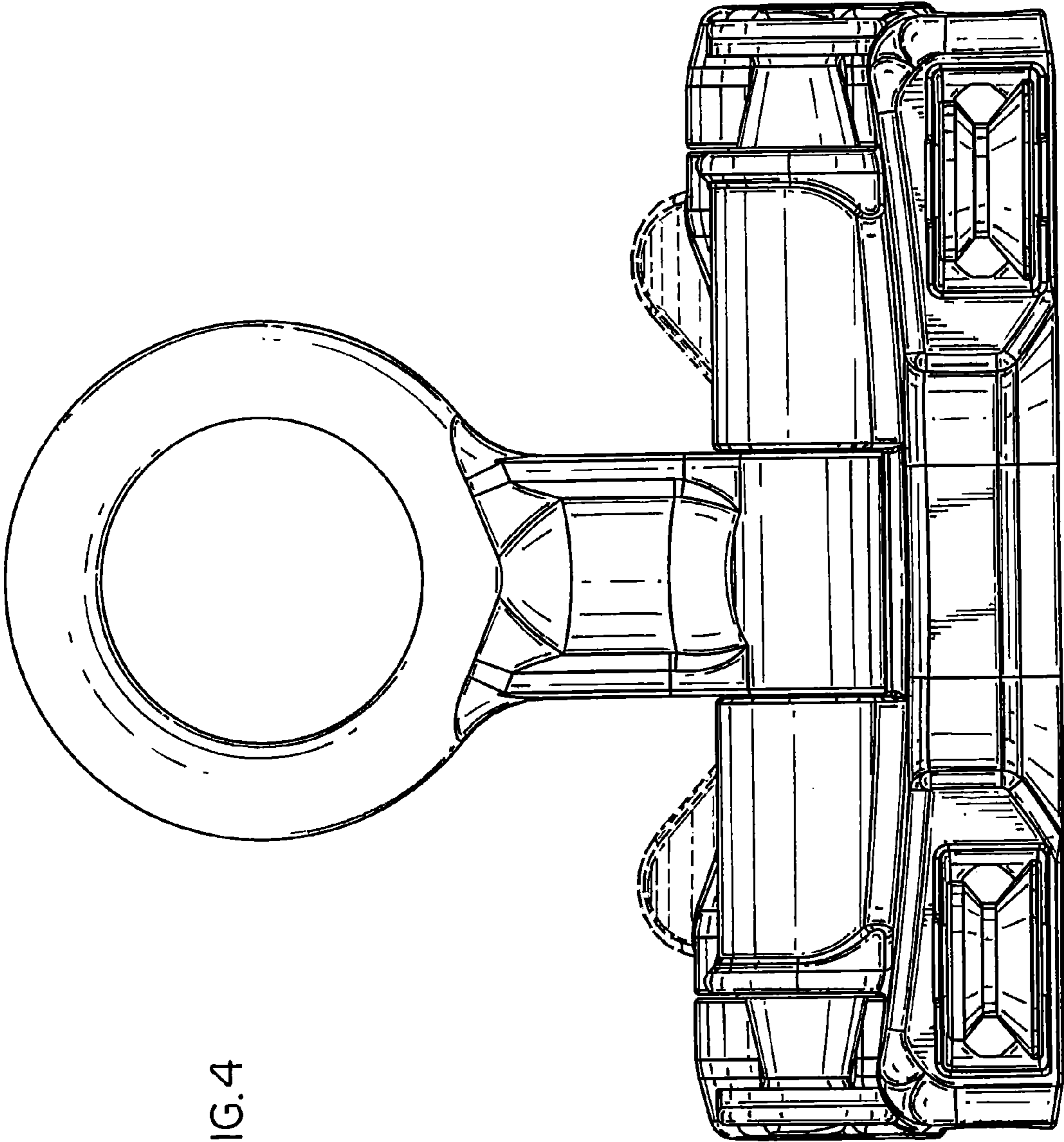

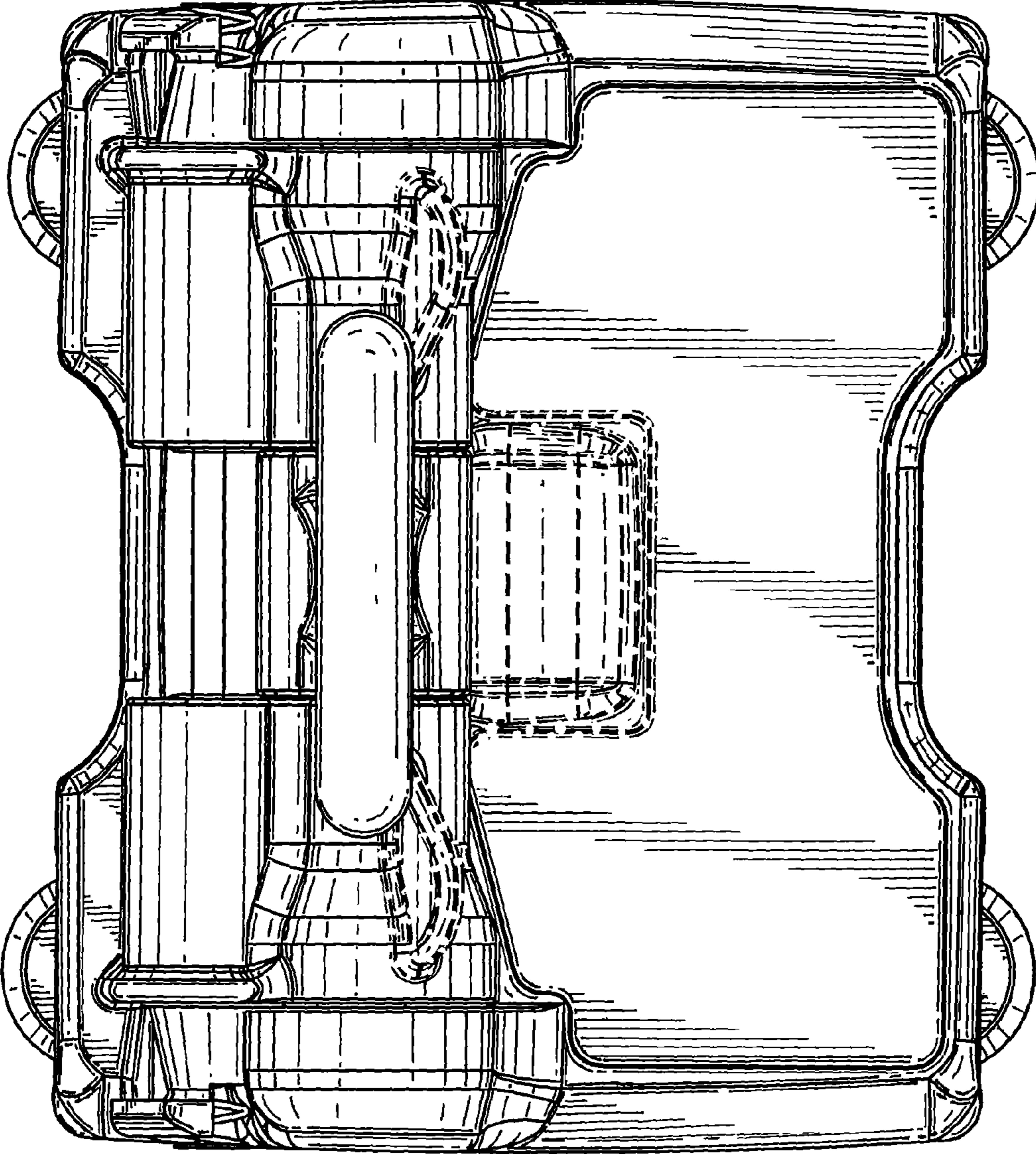

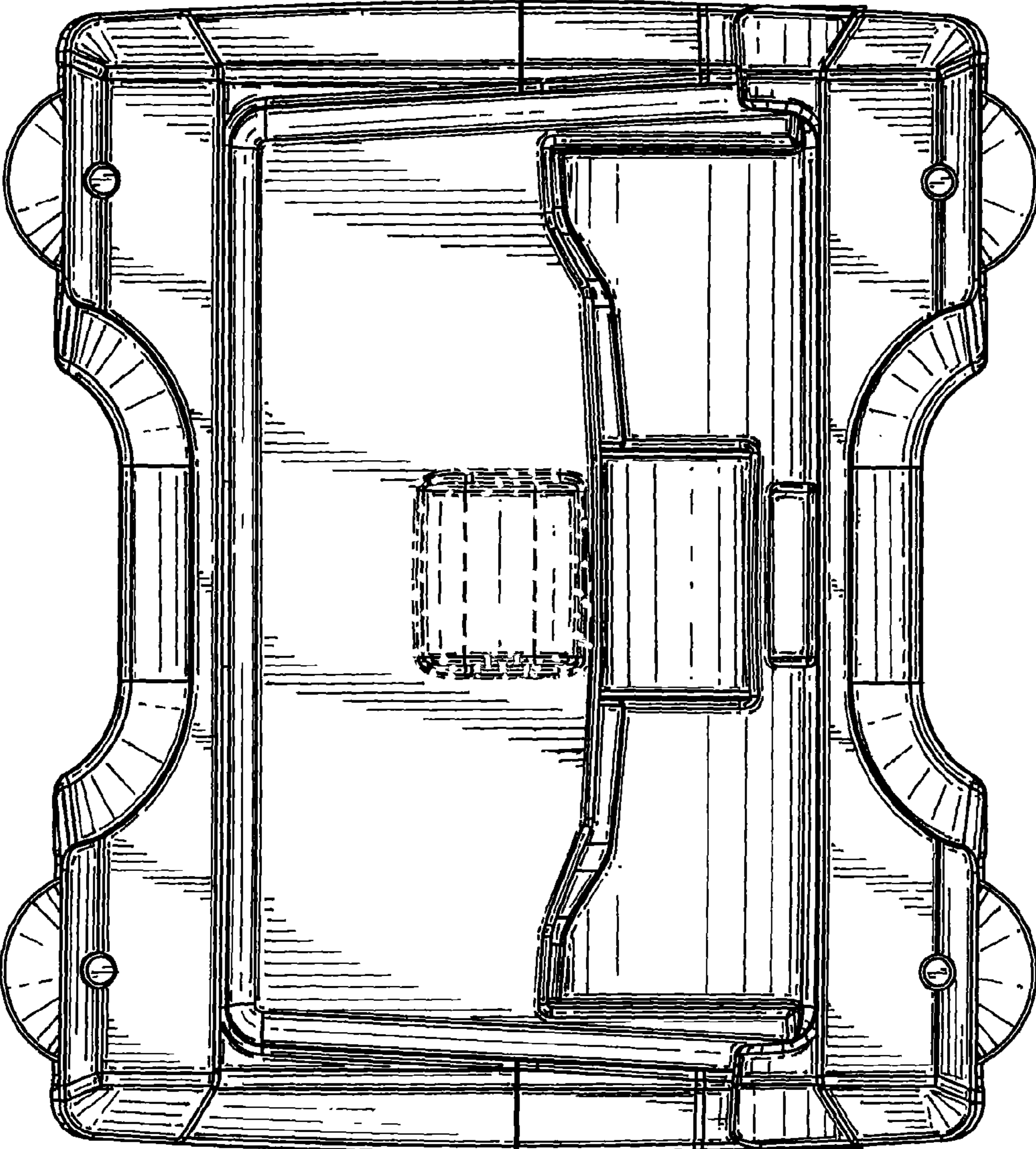
