DESCRIPTION

FIG. 1 is a perspective view of a pet litter scoop showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left-side elevational view thereof, the right side being a mirror image thereof;

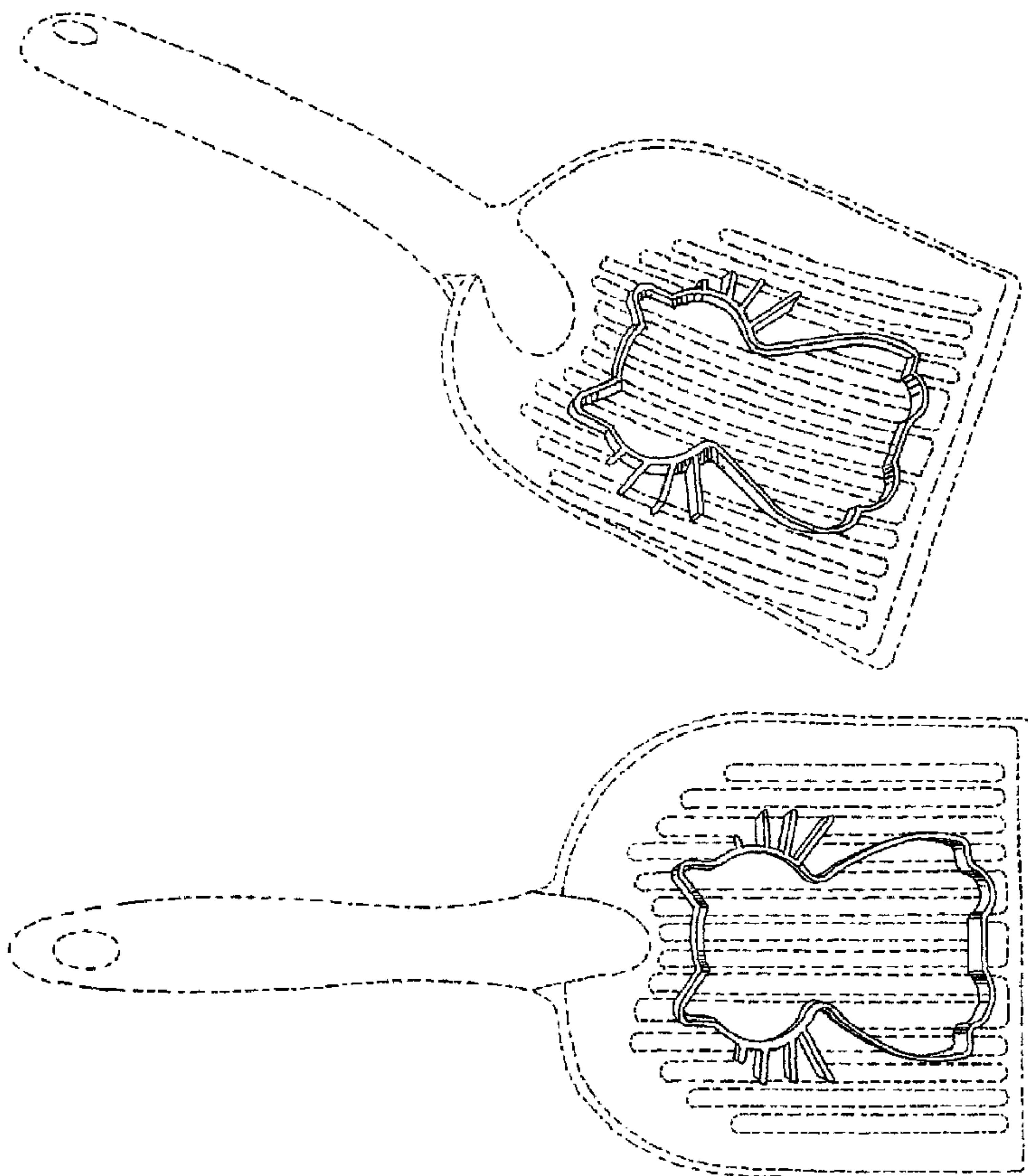
FIG. 4 is a bottom plan view thereof;

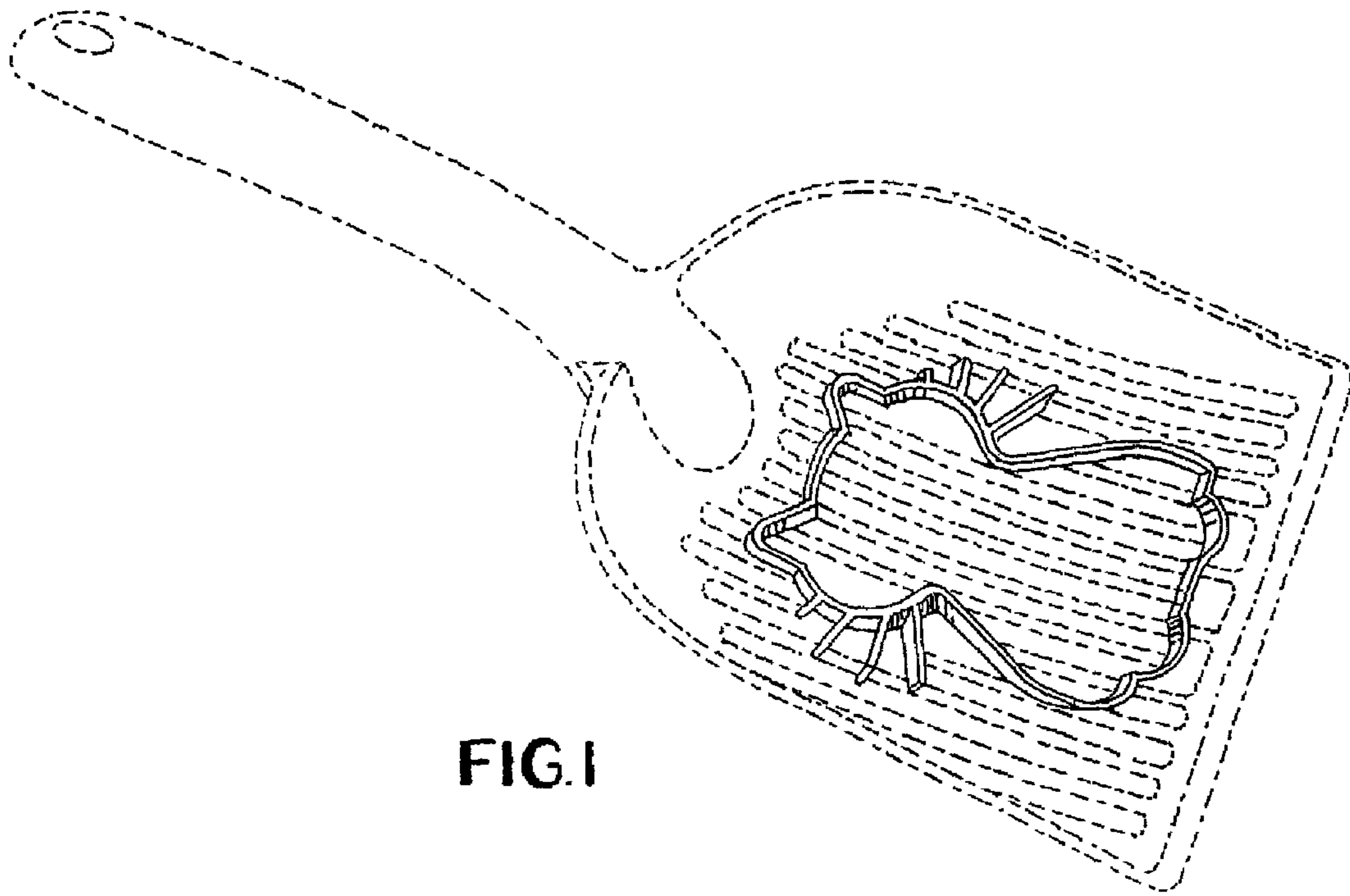

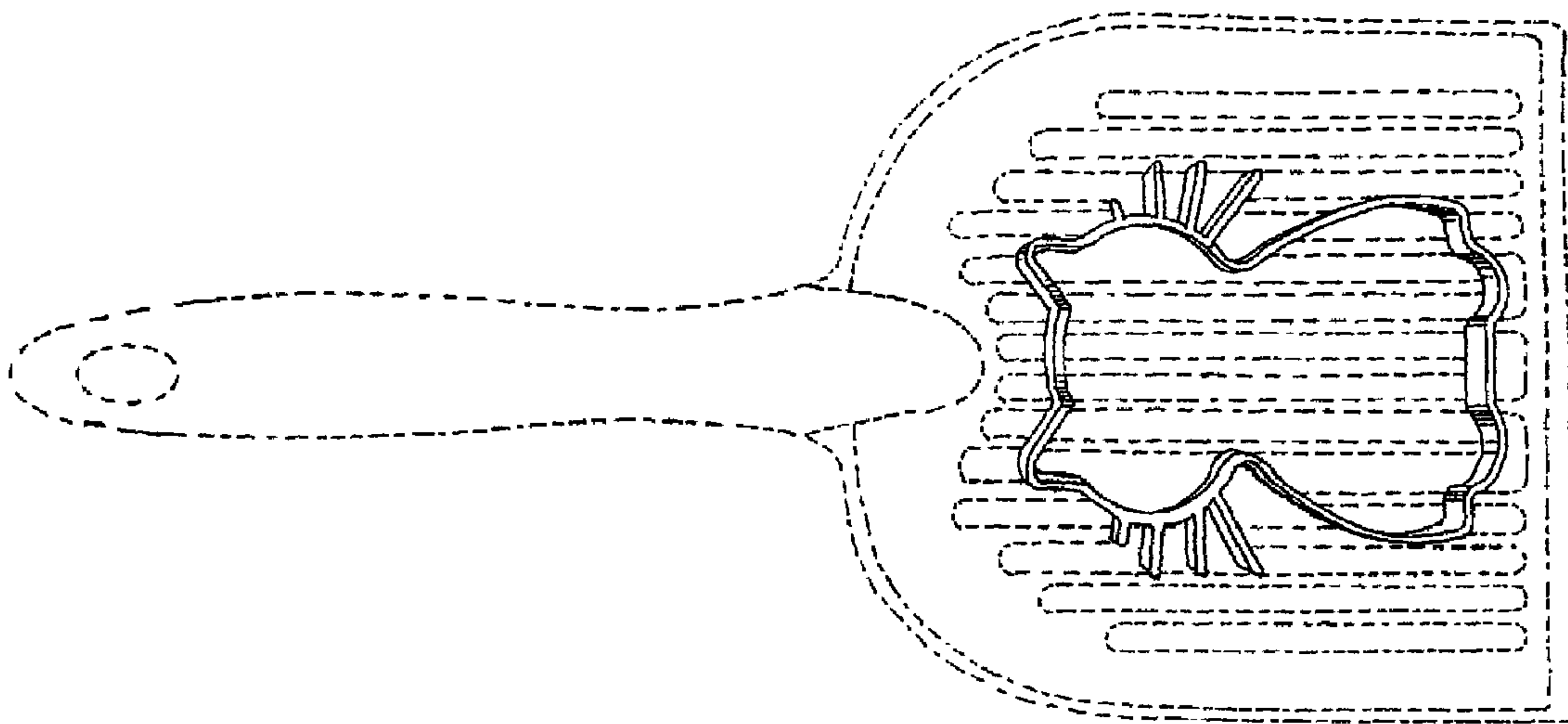

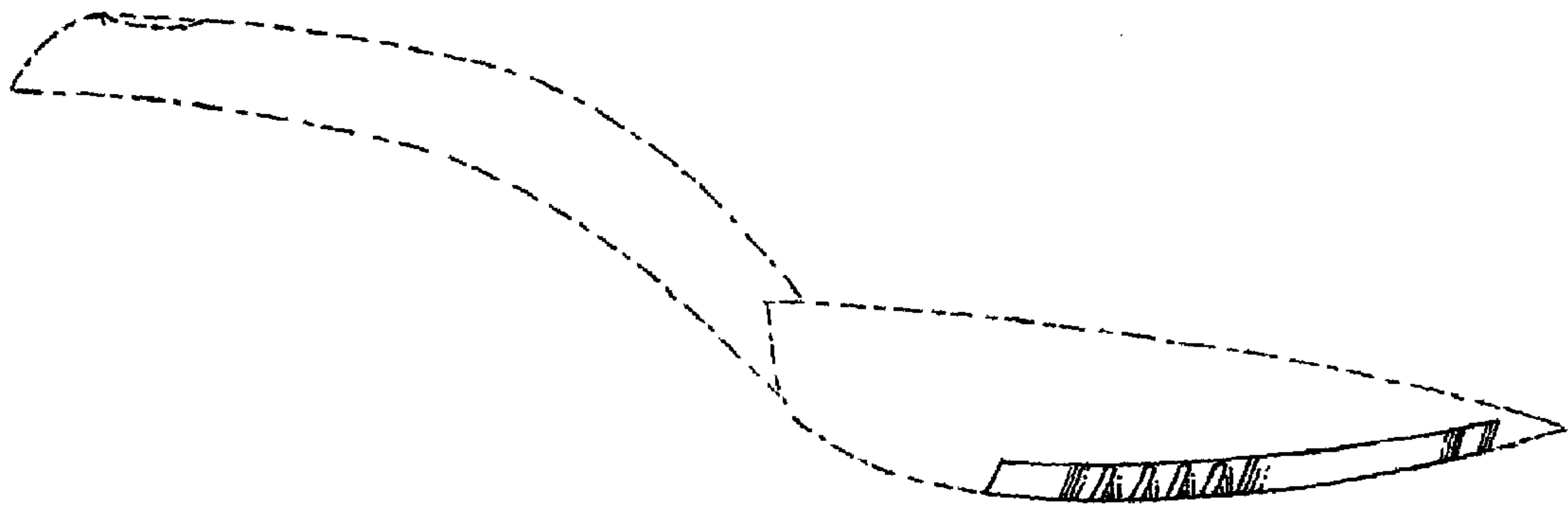

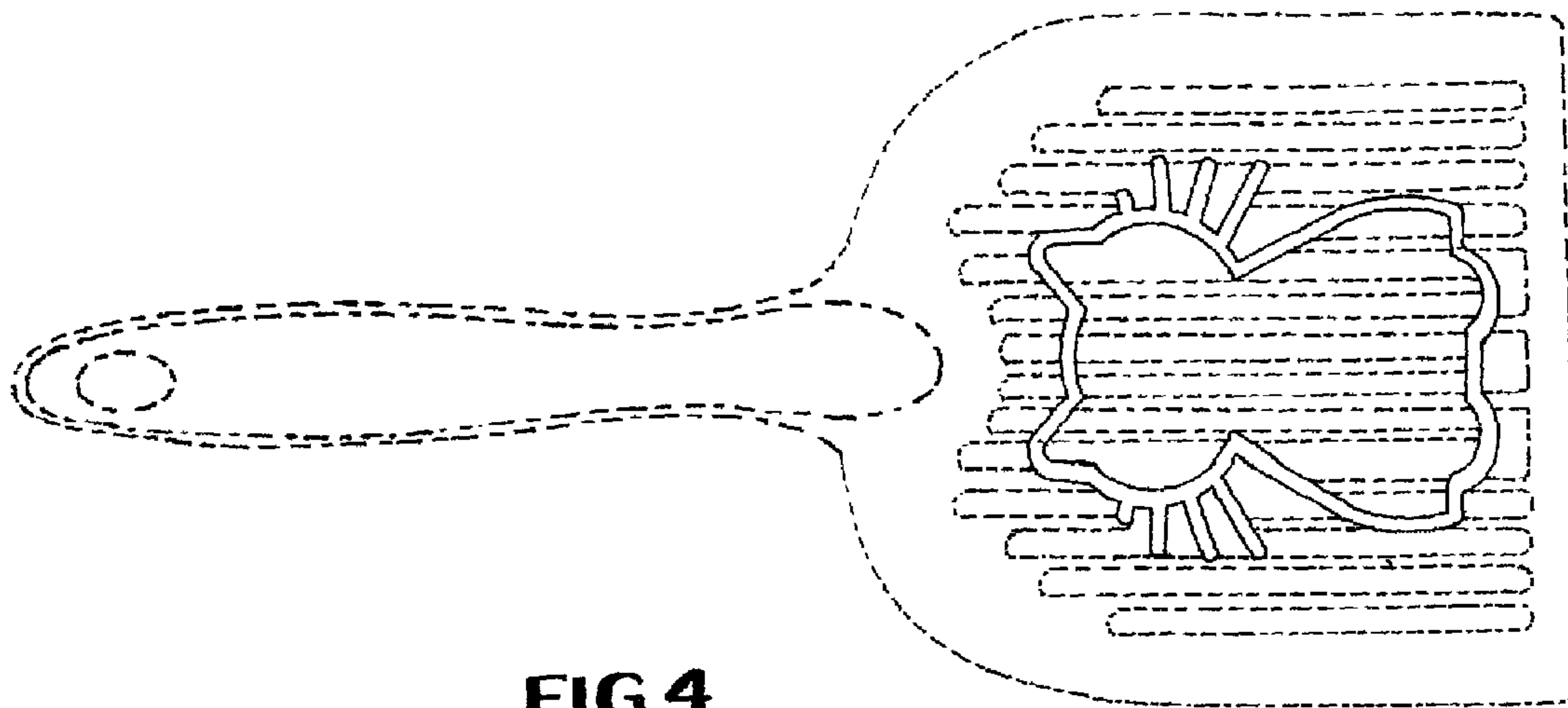

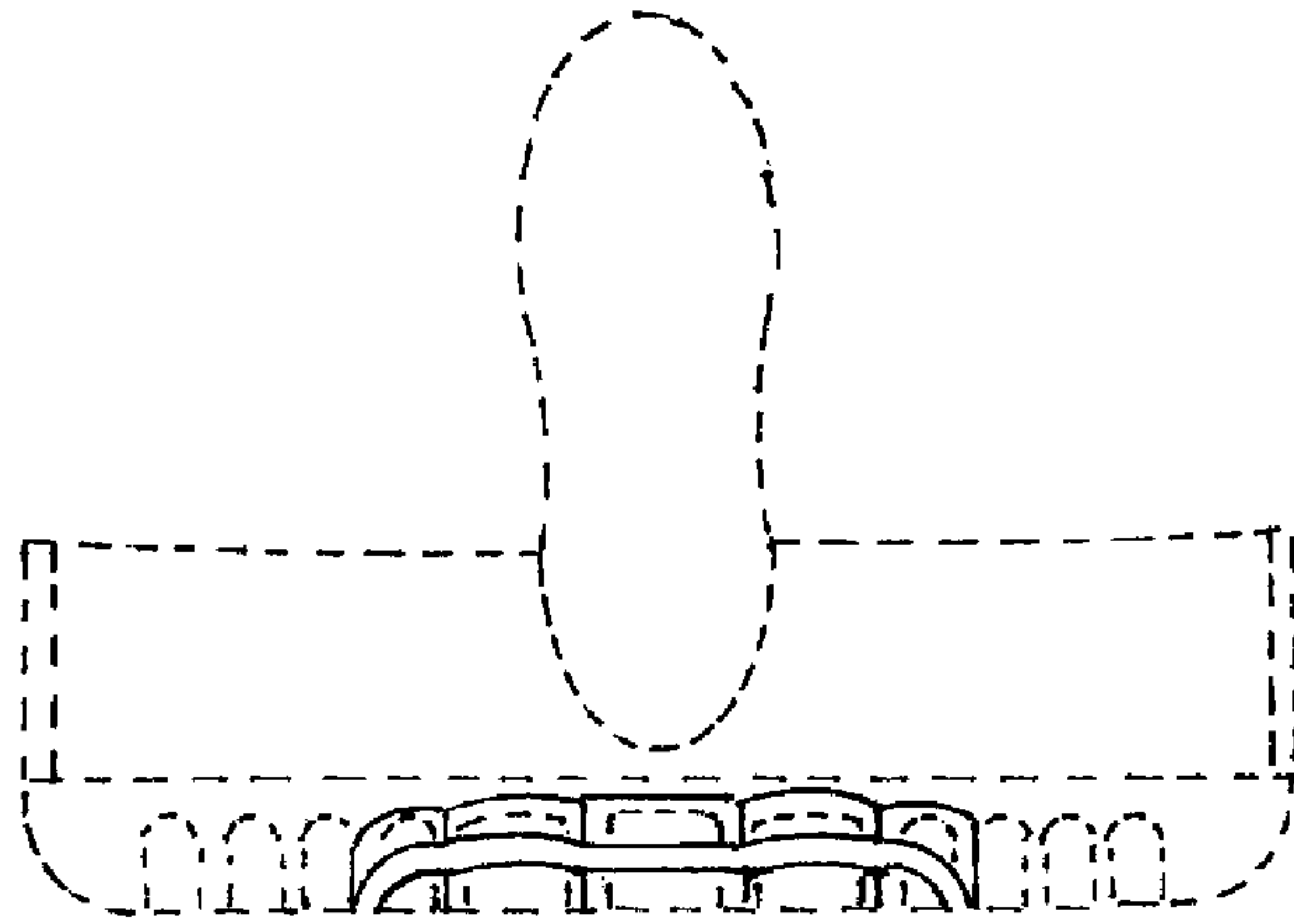

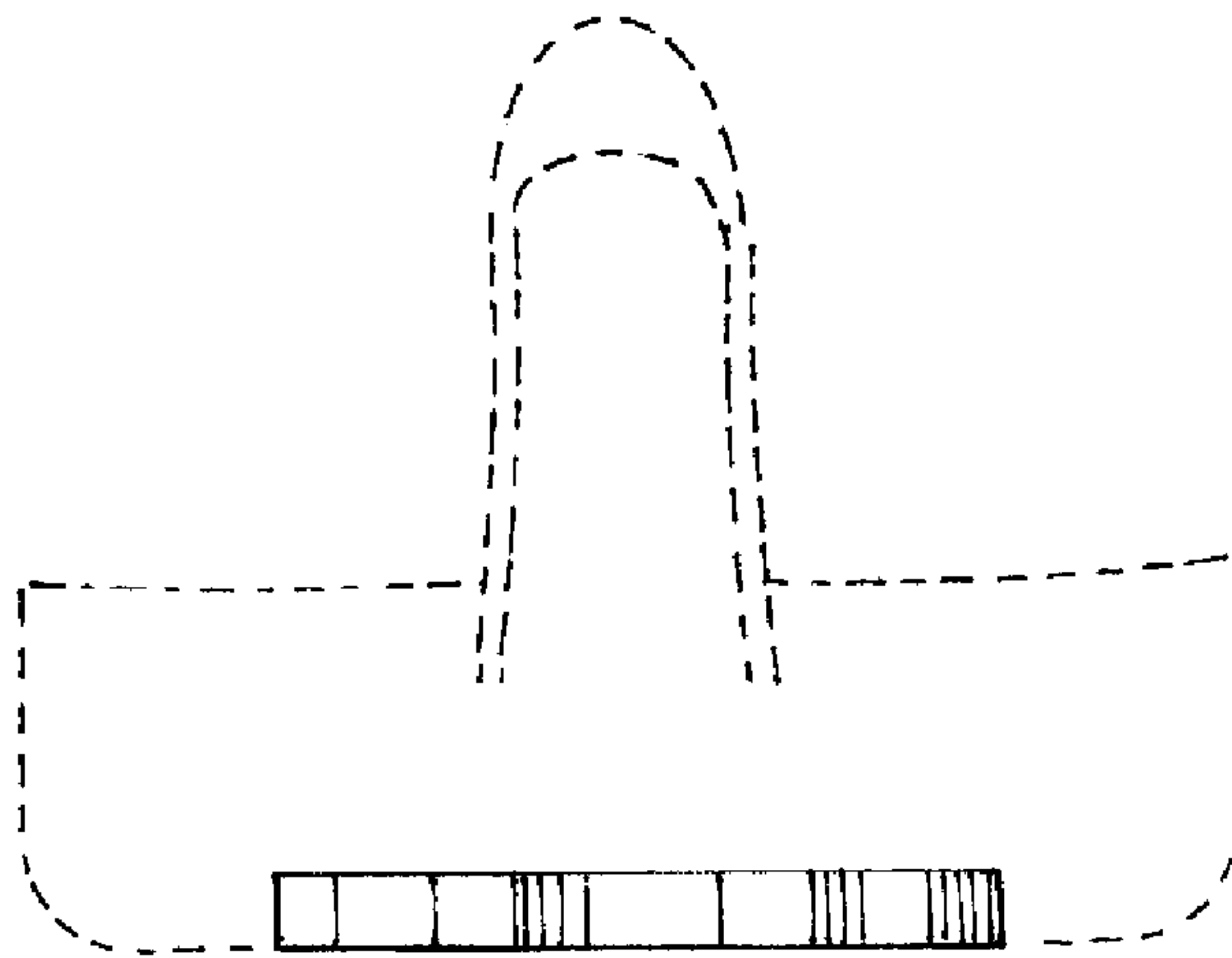
