The ornamental design for a sleeved garment, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the sleeved garment worn on a person, the person illustrated in dashed lines and forming no part of the claimed design;

FIG. 2 is a front perspective view sleeved garment worn on a person, the person illustrated in dashed lines and forming no part of the claimed design;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side view thereof;

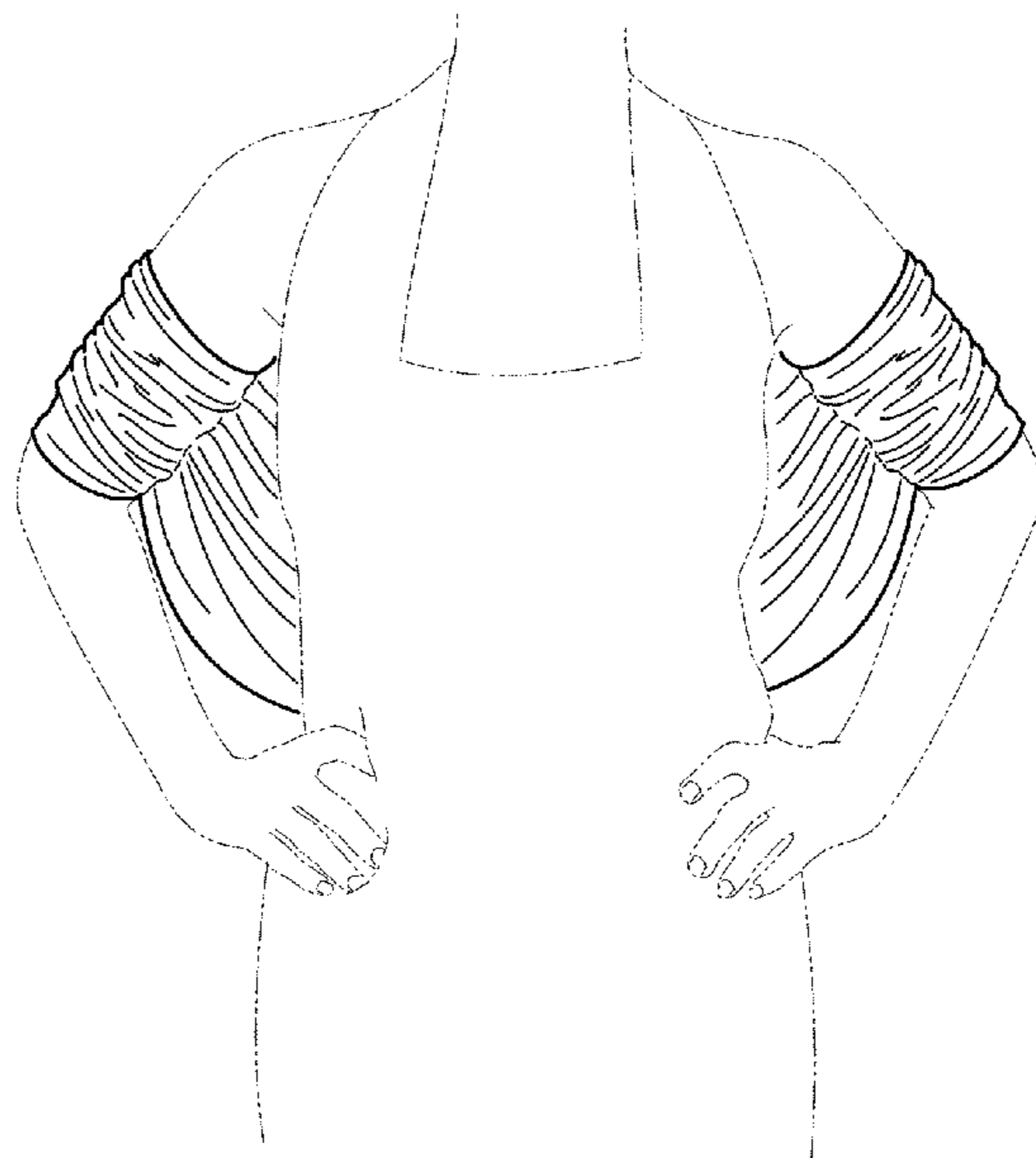
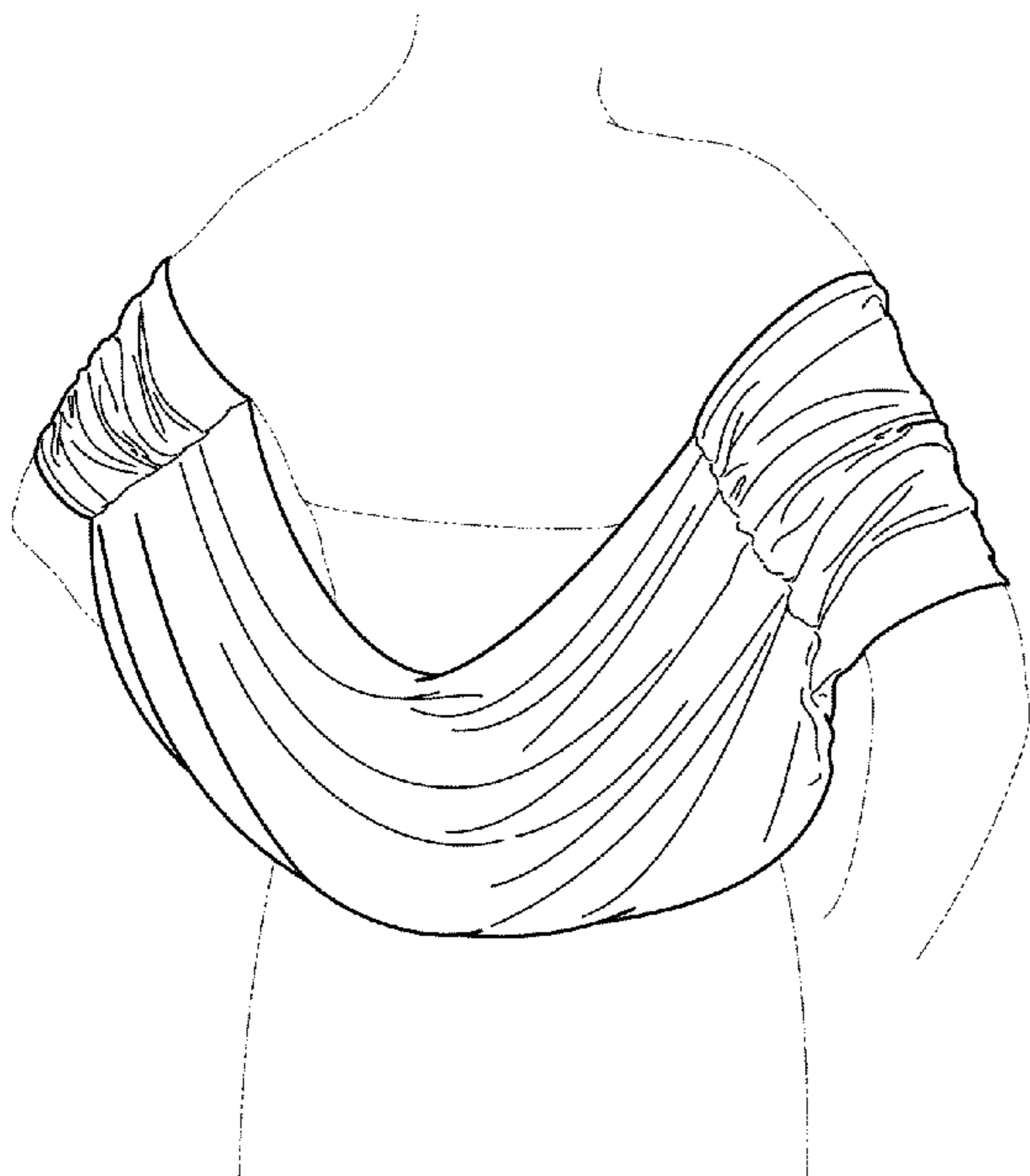
FIG. 6 is a right side view thereof;

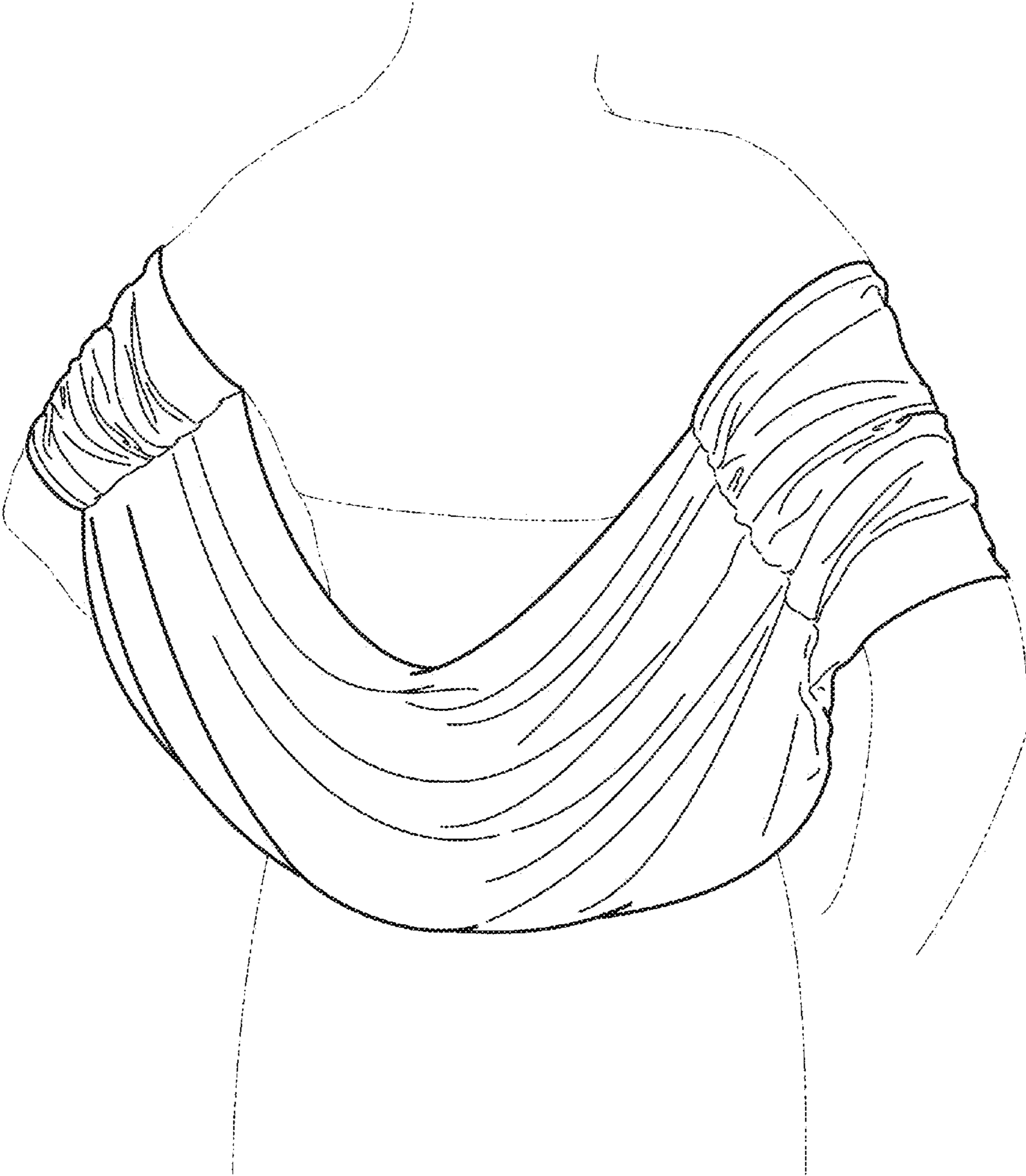

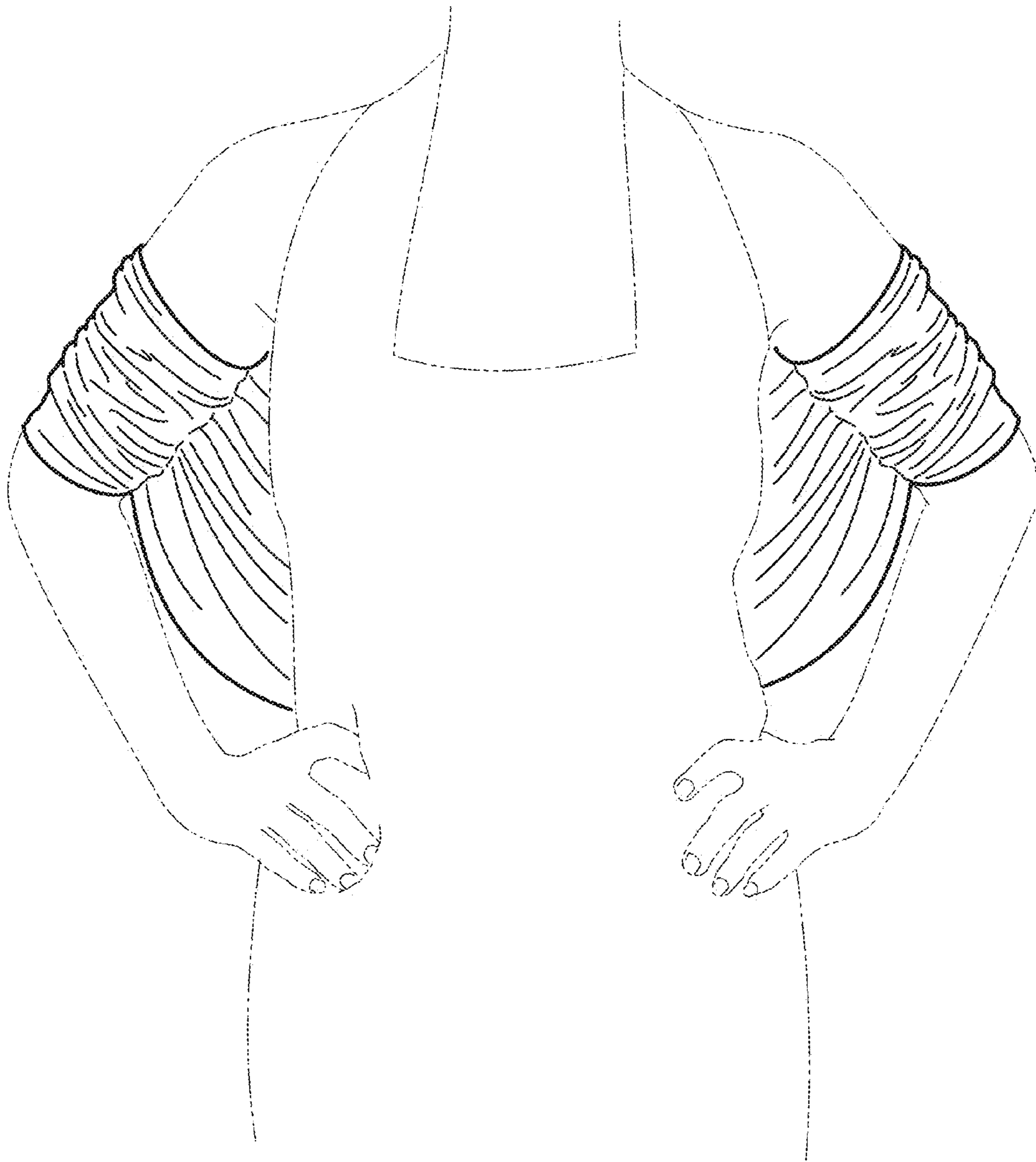

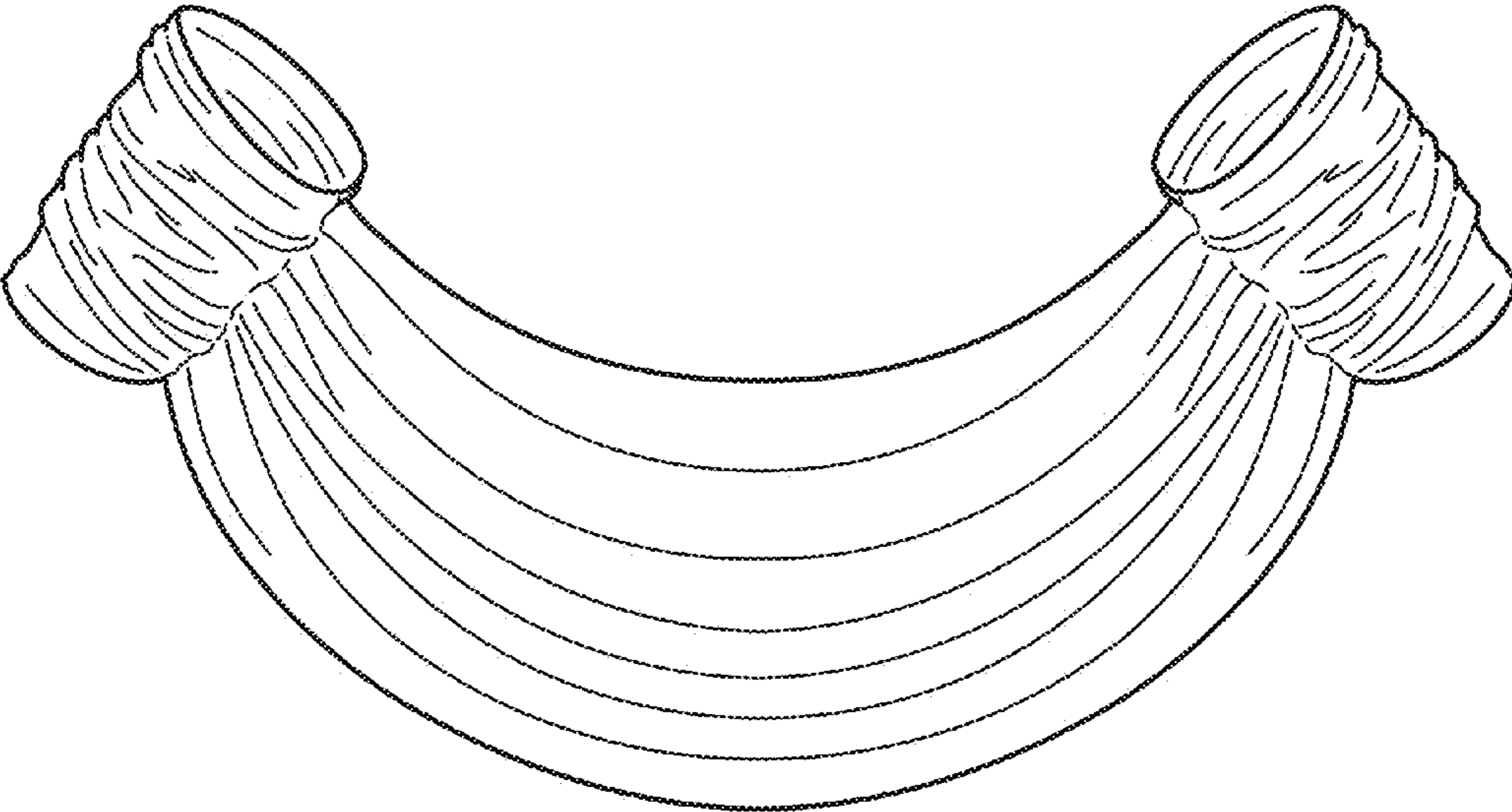

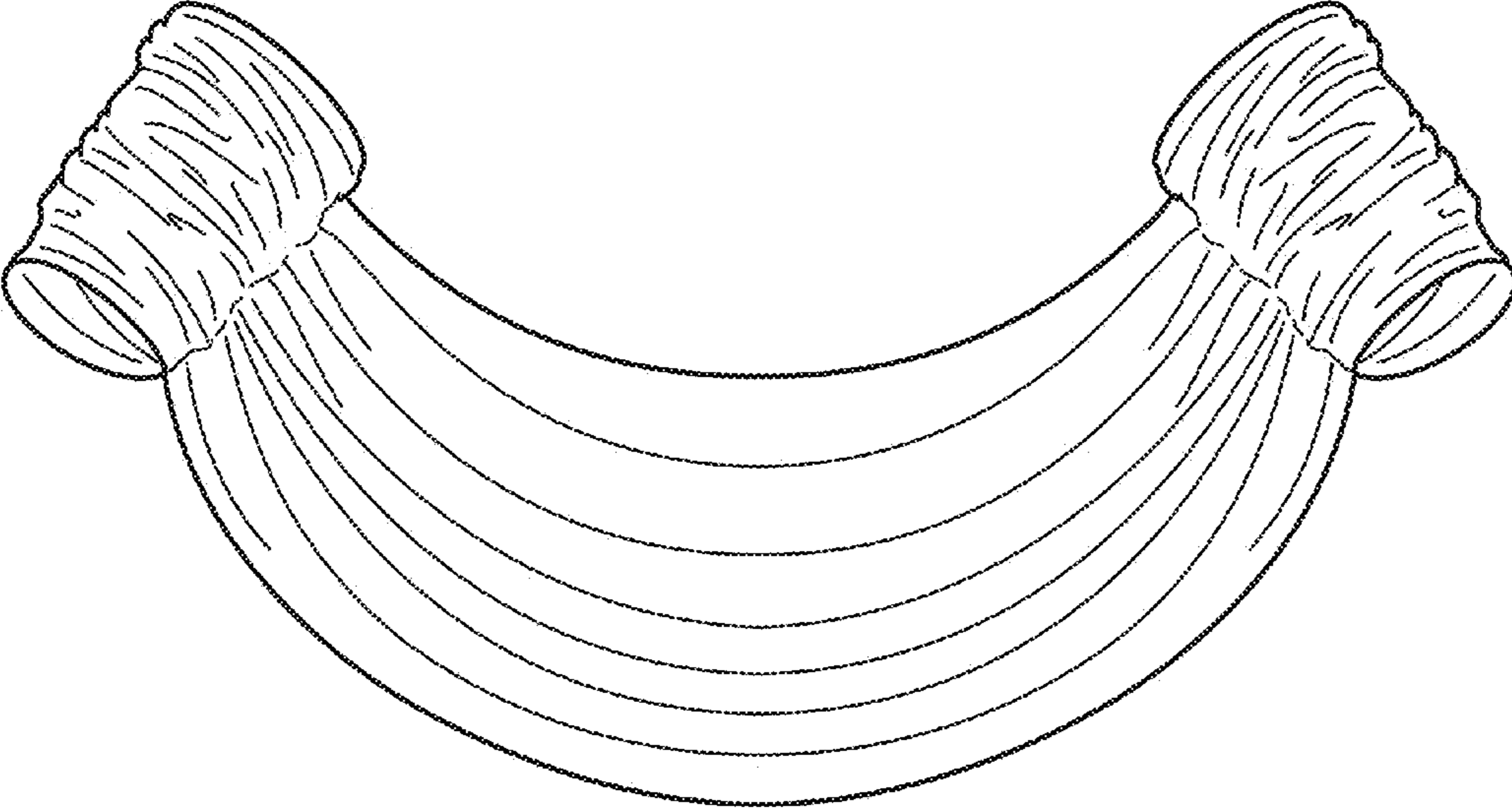

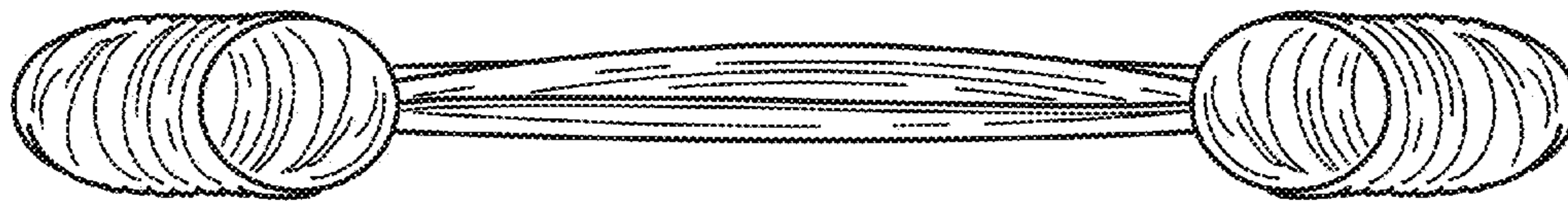
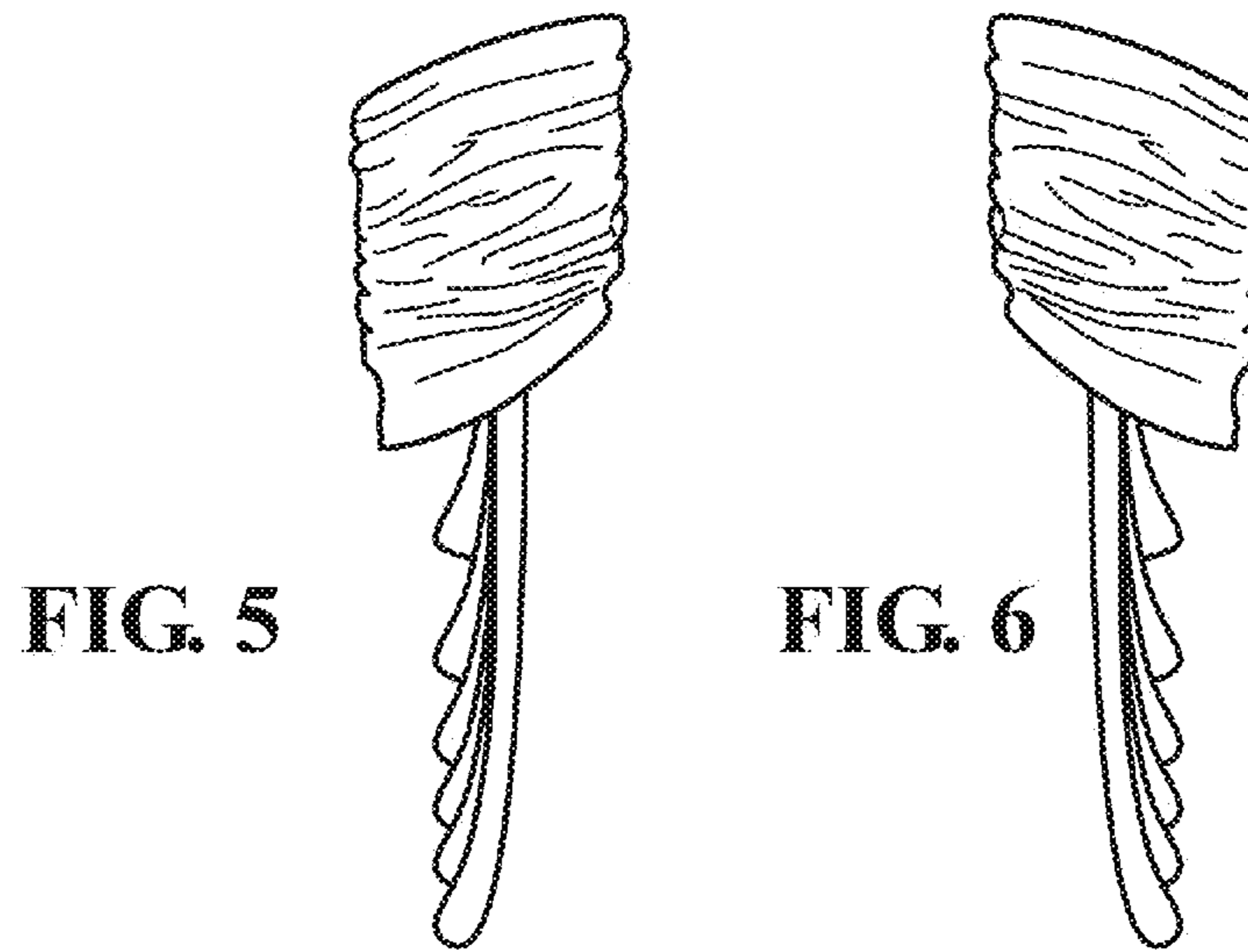

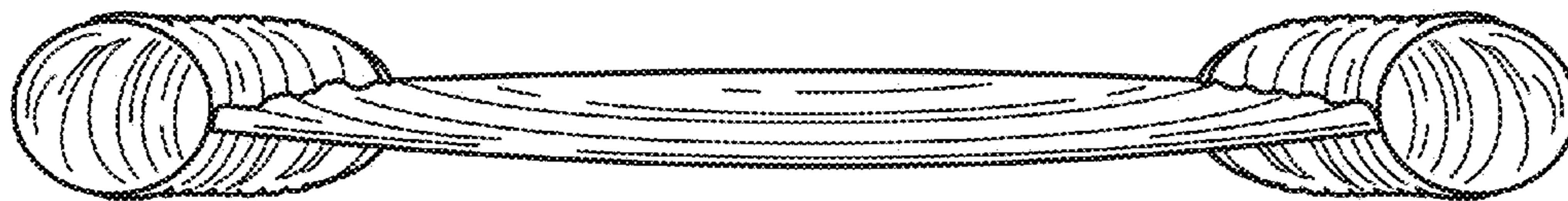
