**DESCRIPTION**

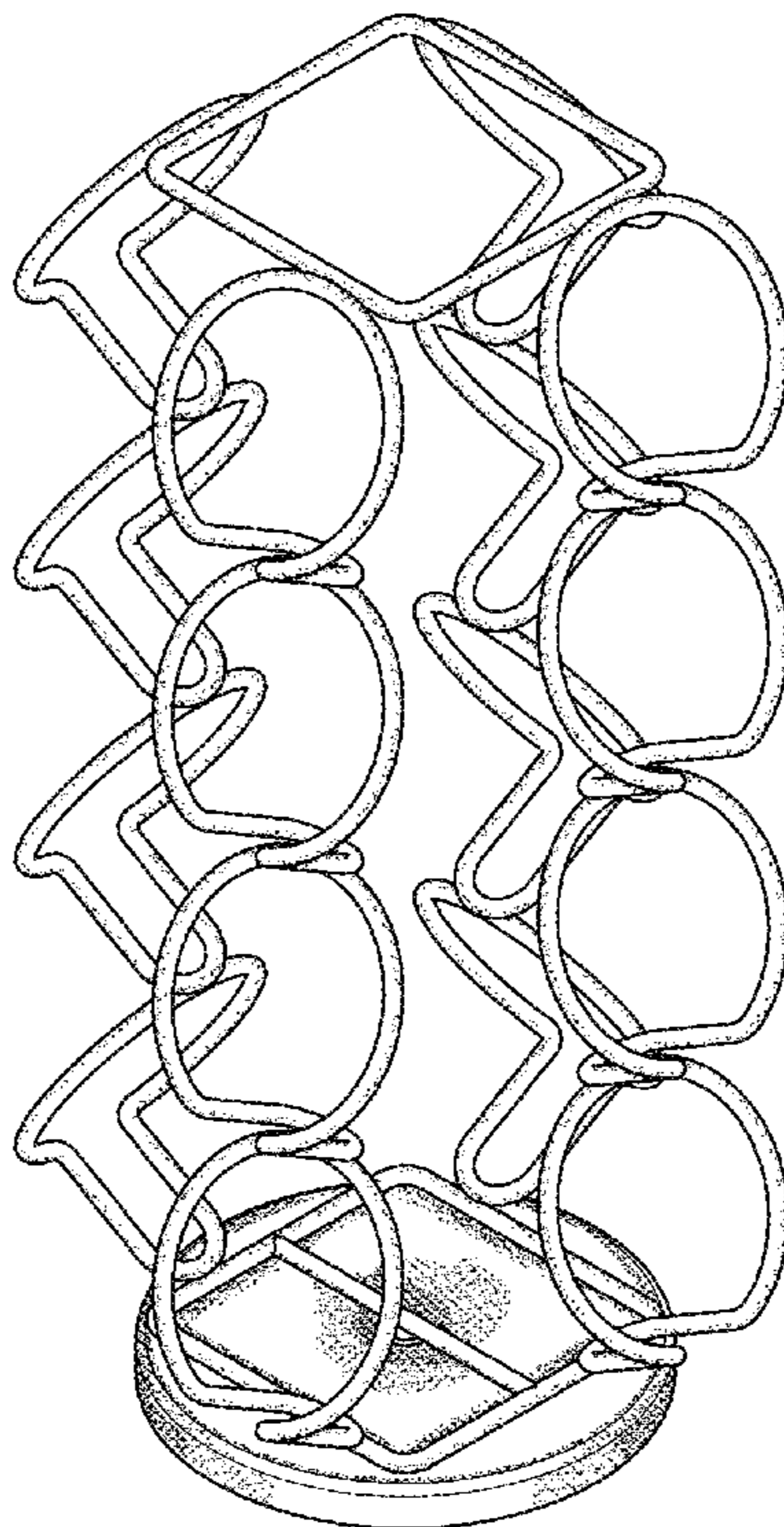
FIG. 1 is an upper perspective view of the rack for food showing my design.

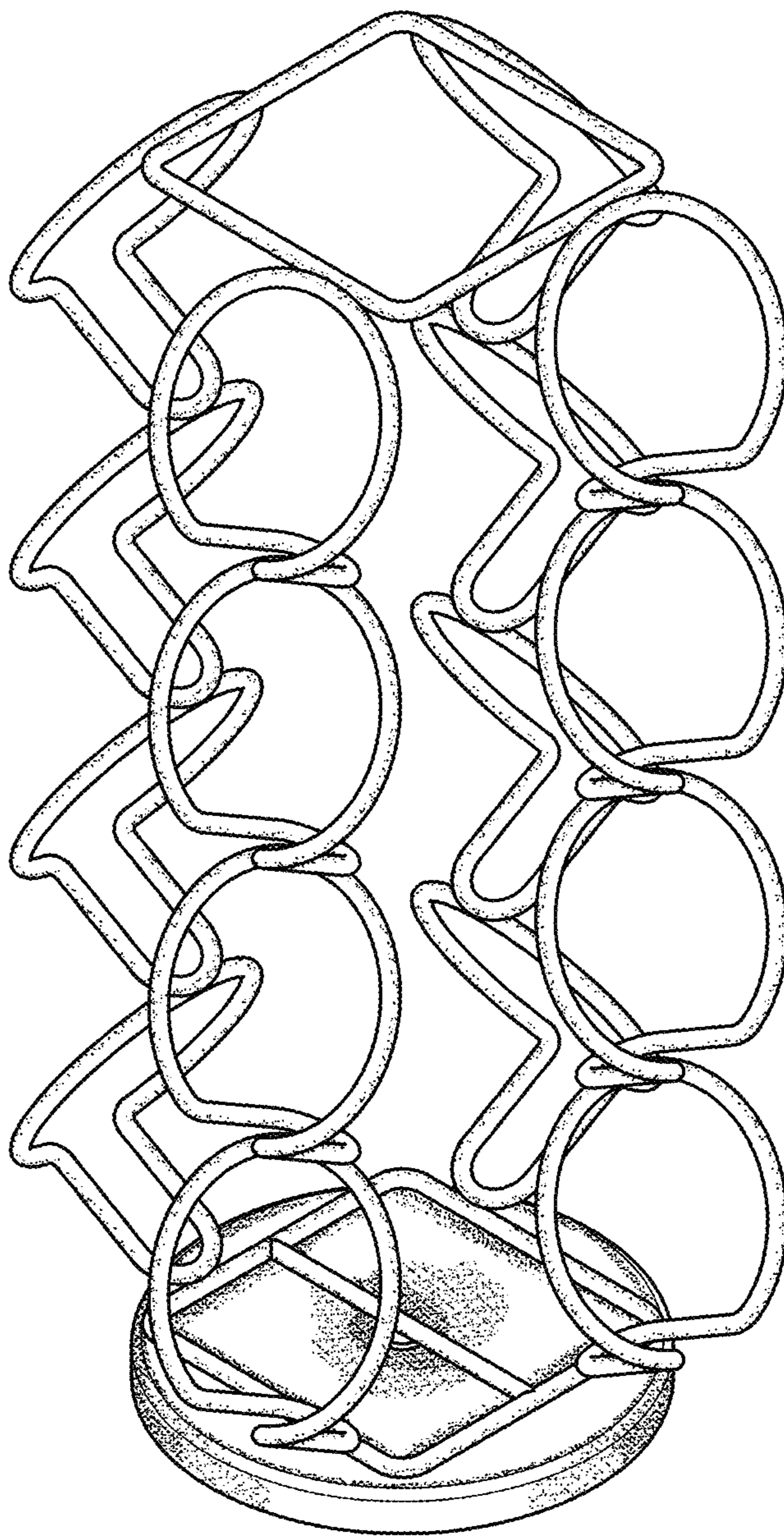

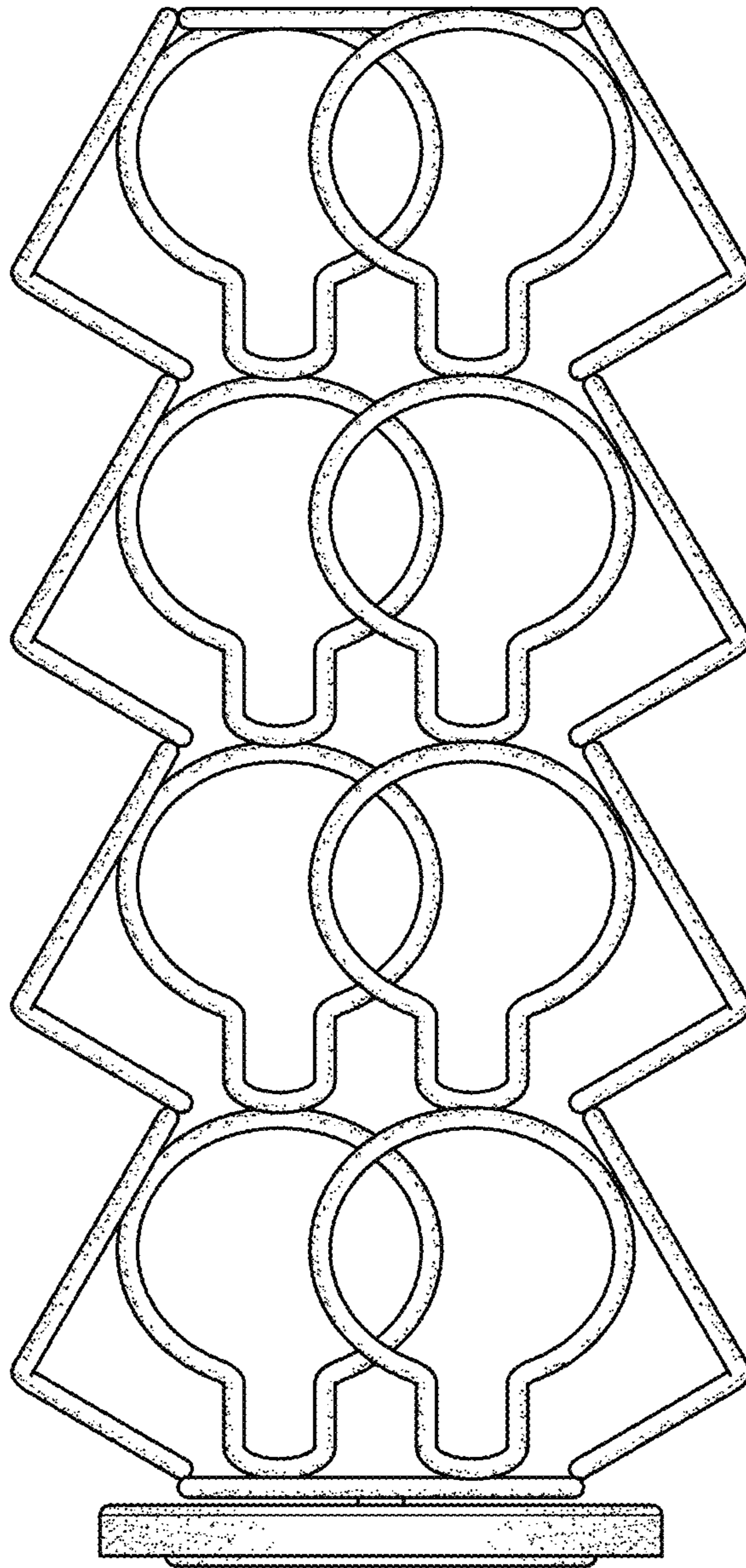

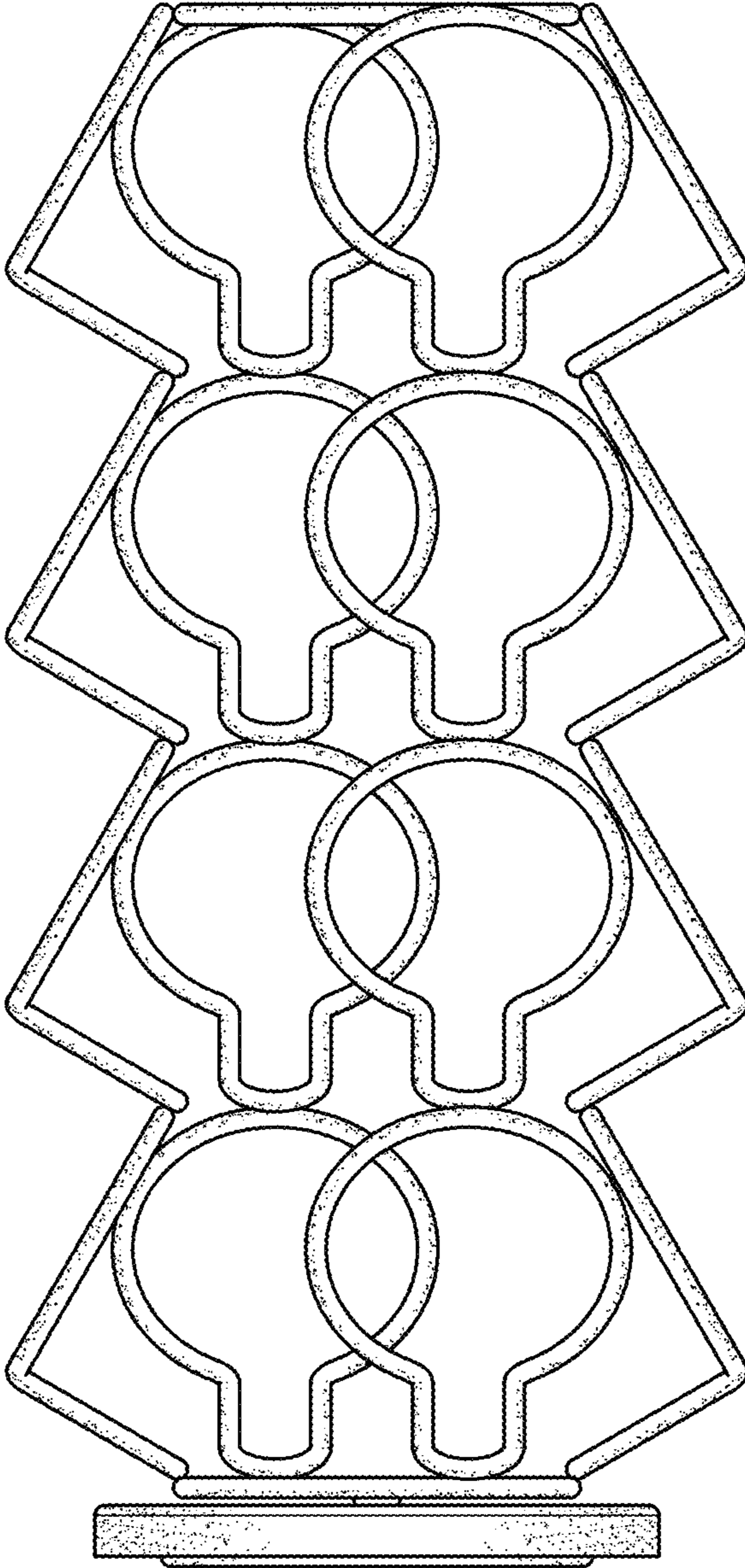

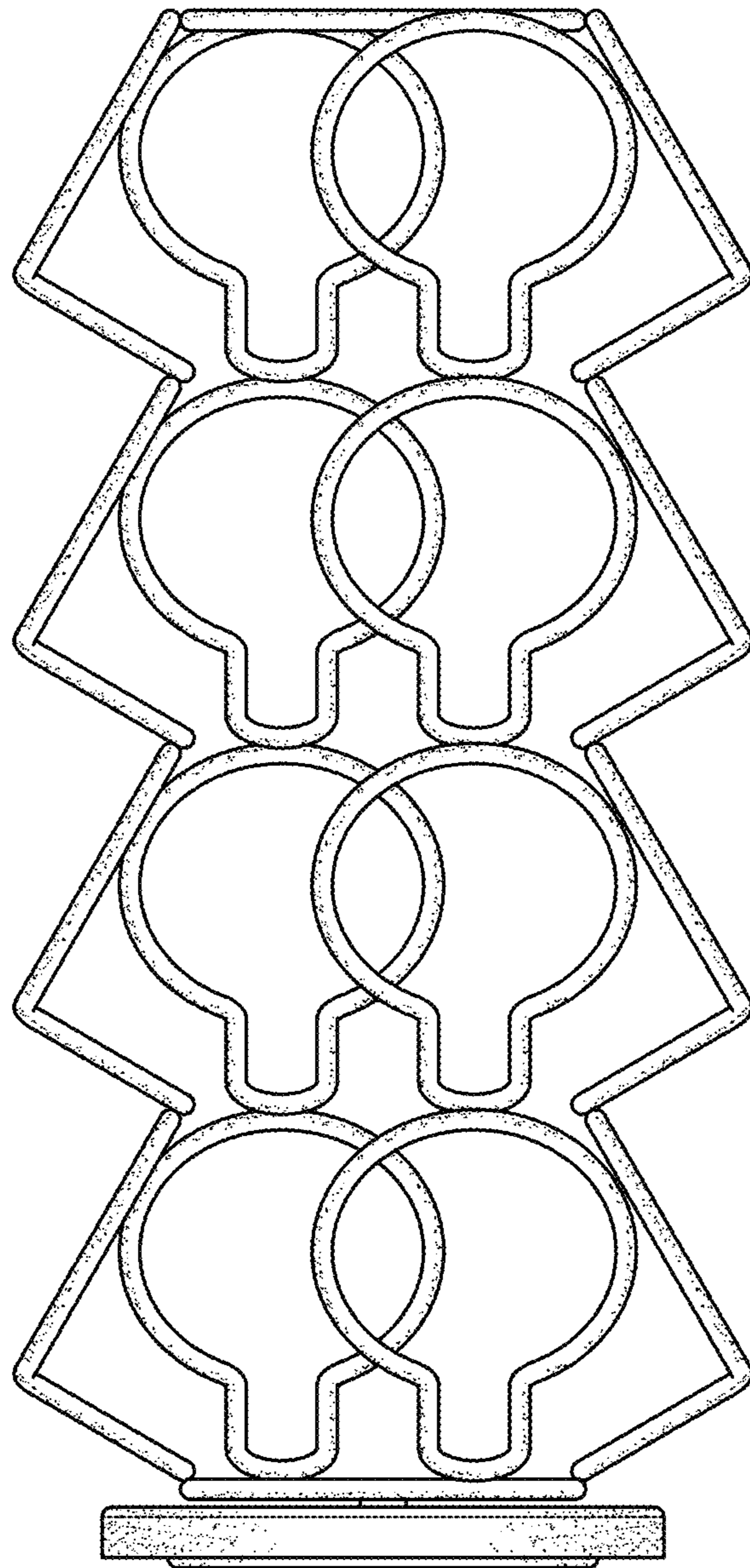

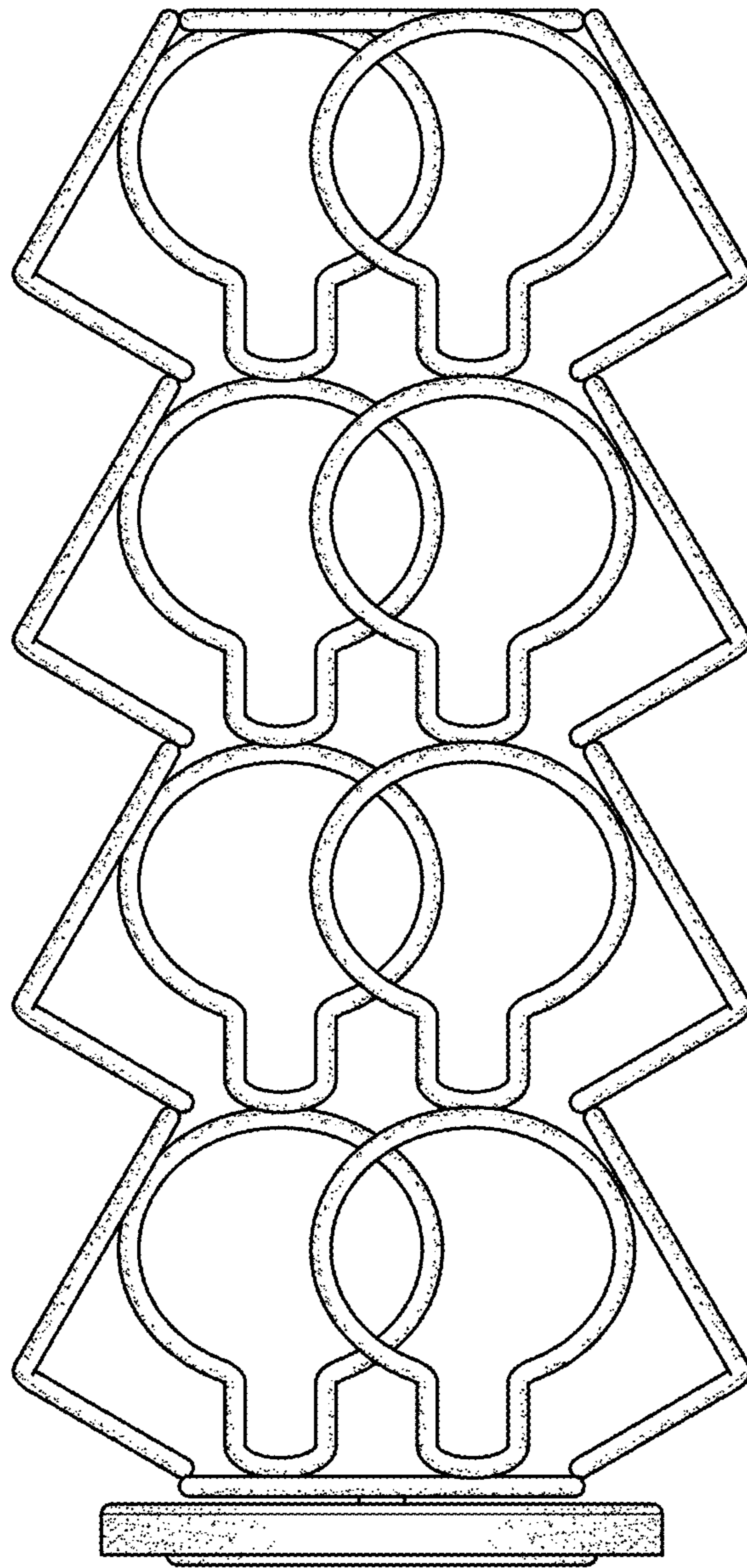

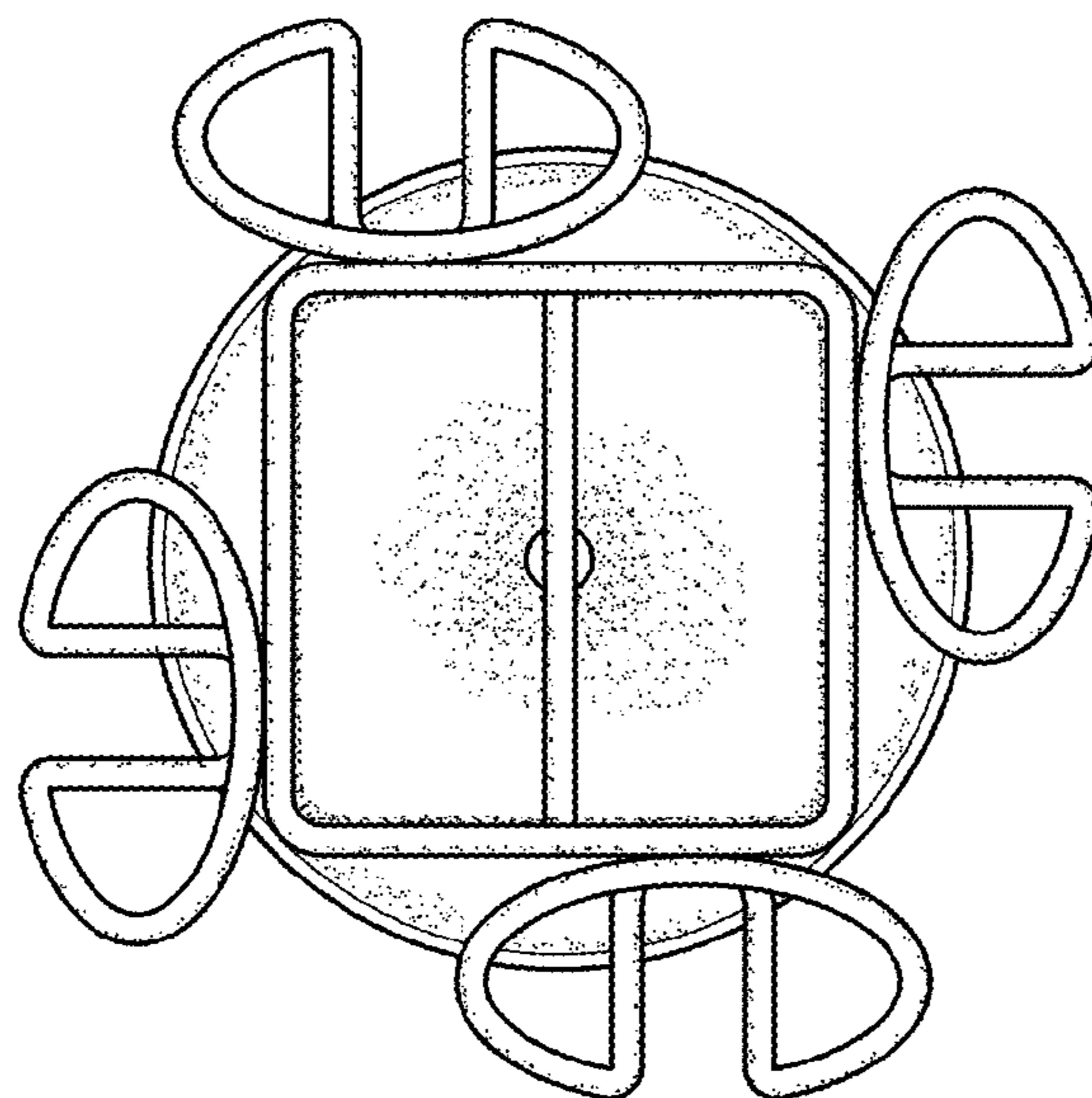

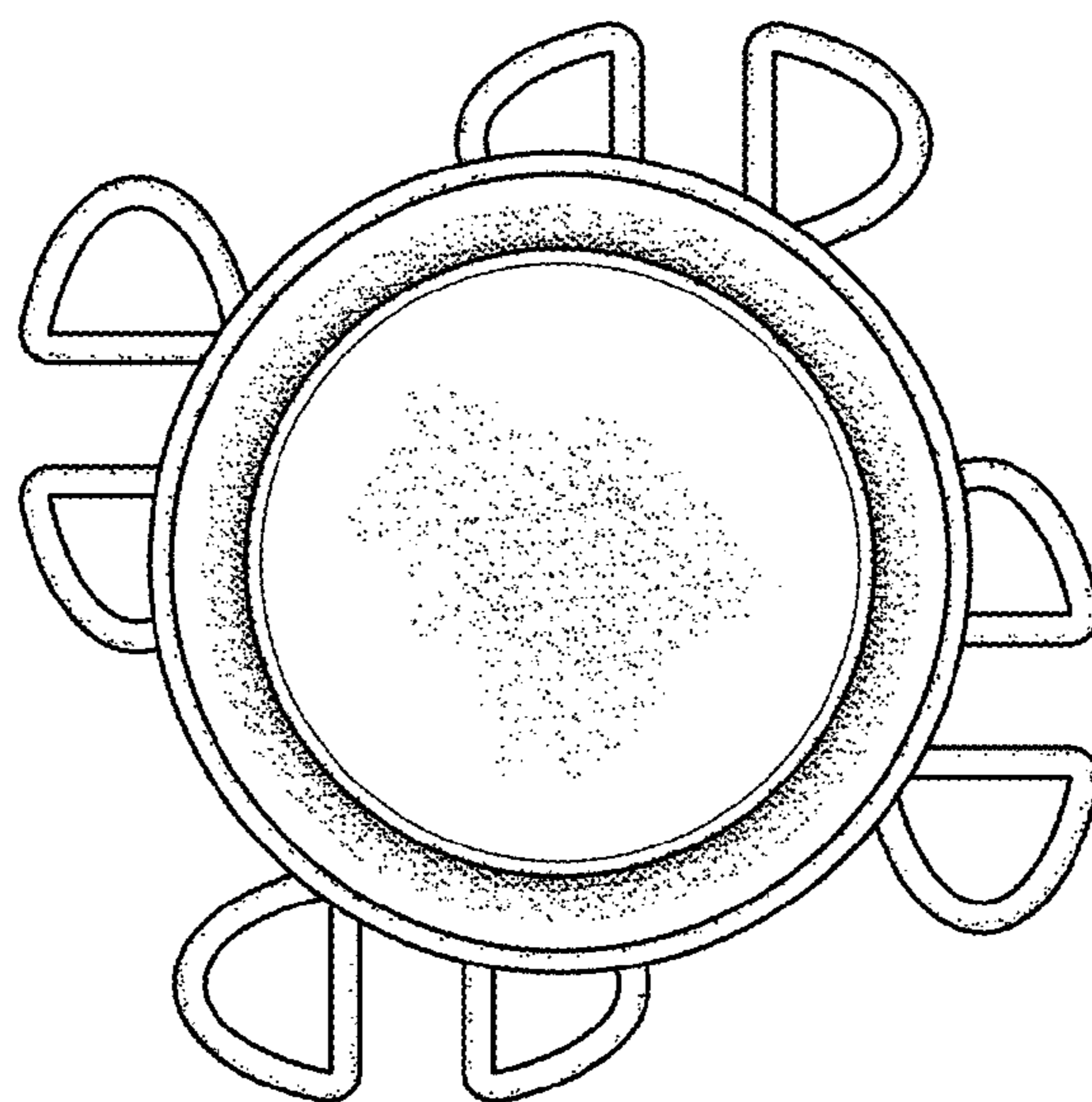

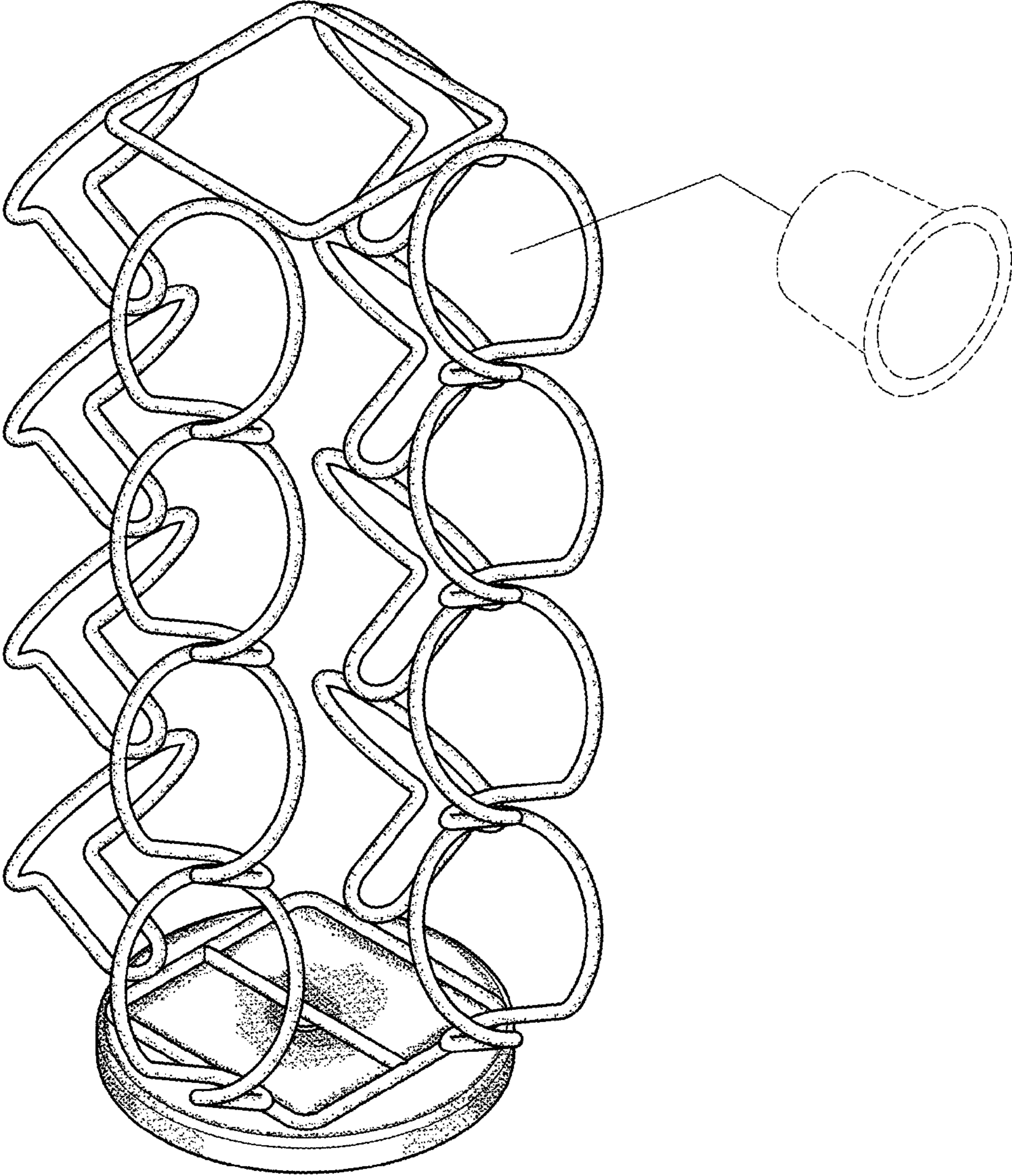
