FIG. 7 is a top plan view of the food jar with latch-released hinged lid of FIG. 1; and,

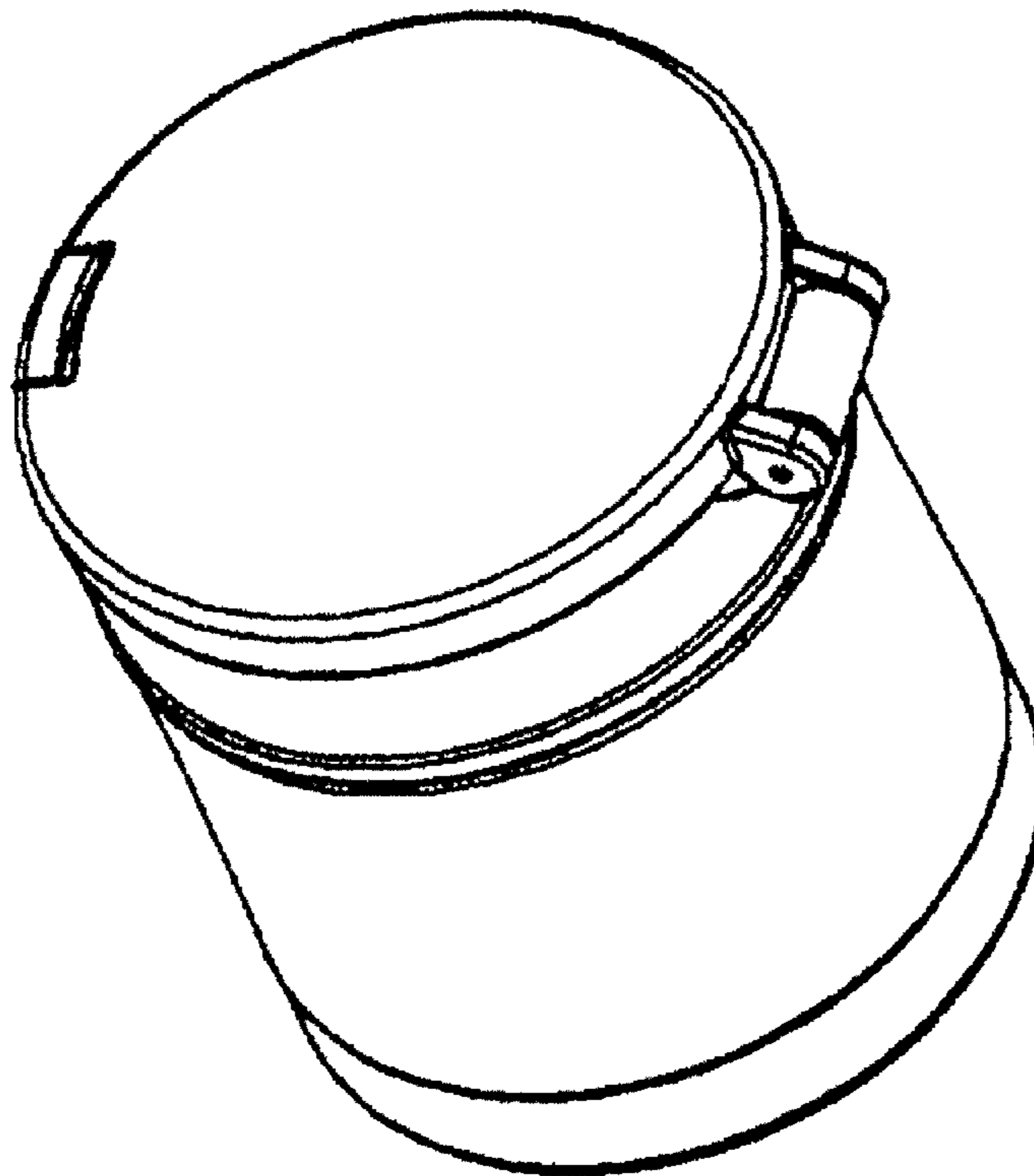
FIG. 8 is a bottom plan view of the food jar with latch-released hinged lid of FIG. 1.

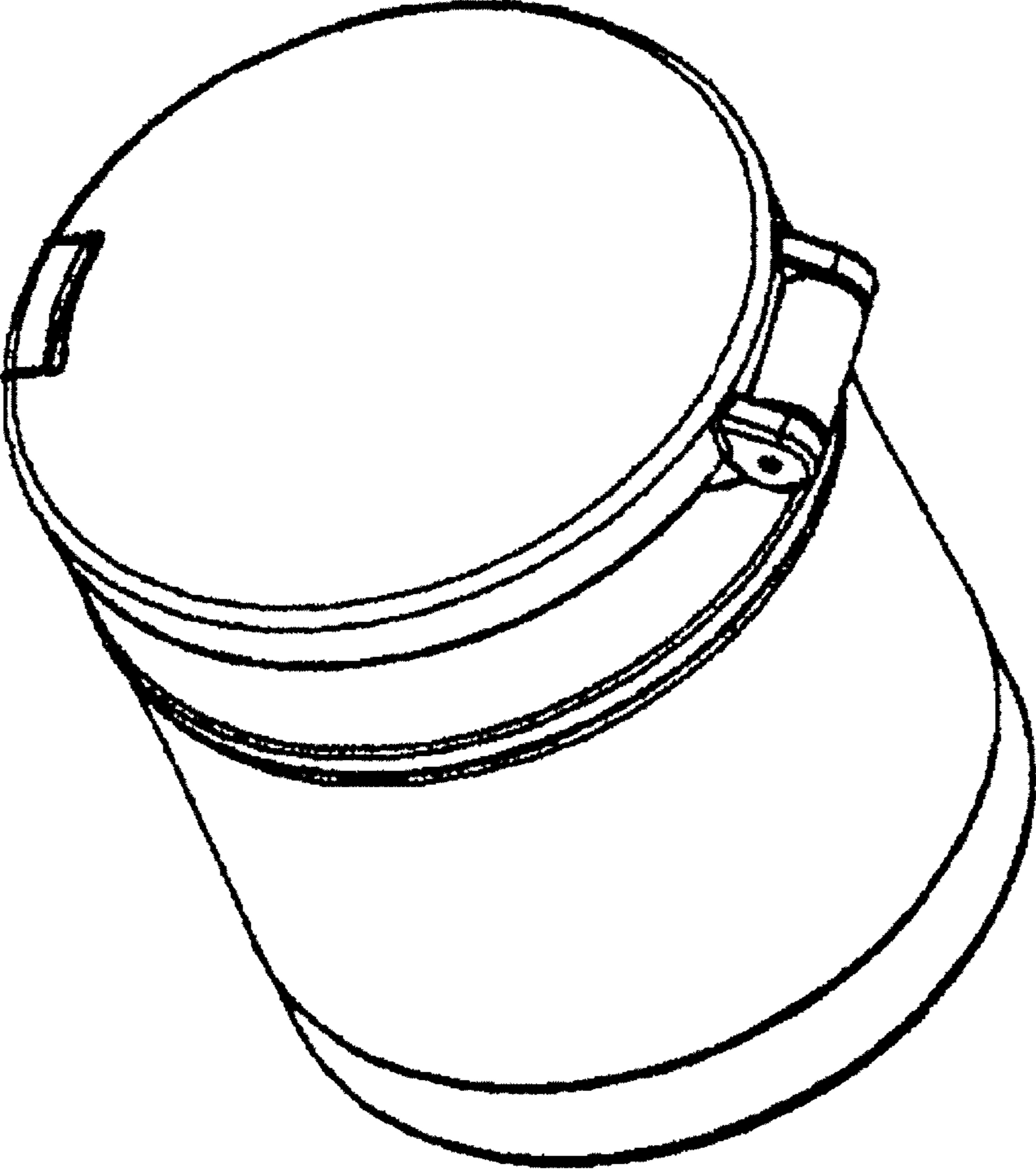

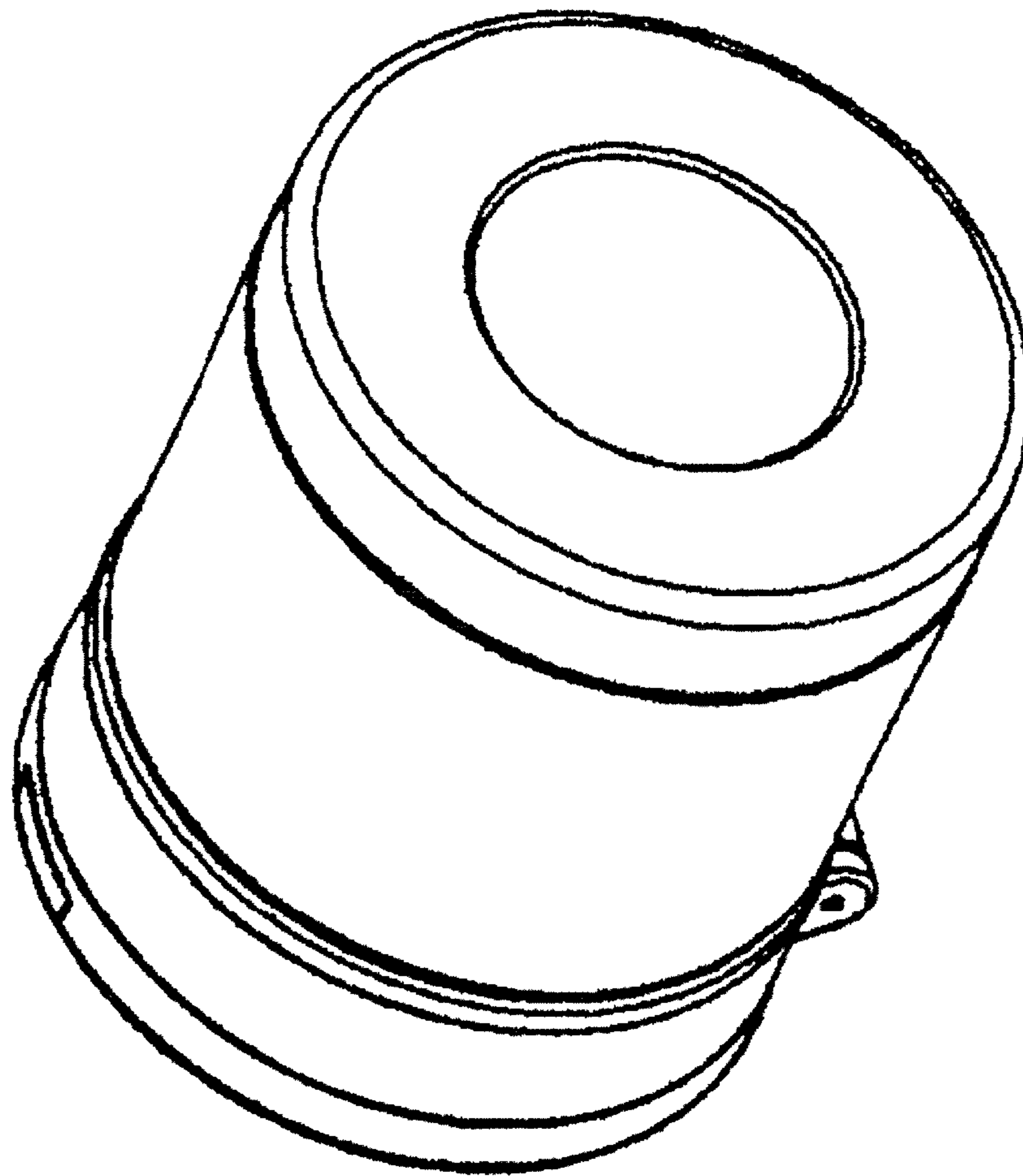

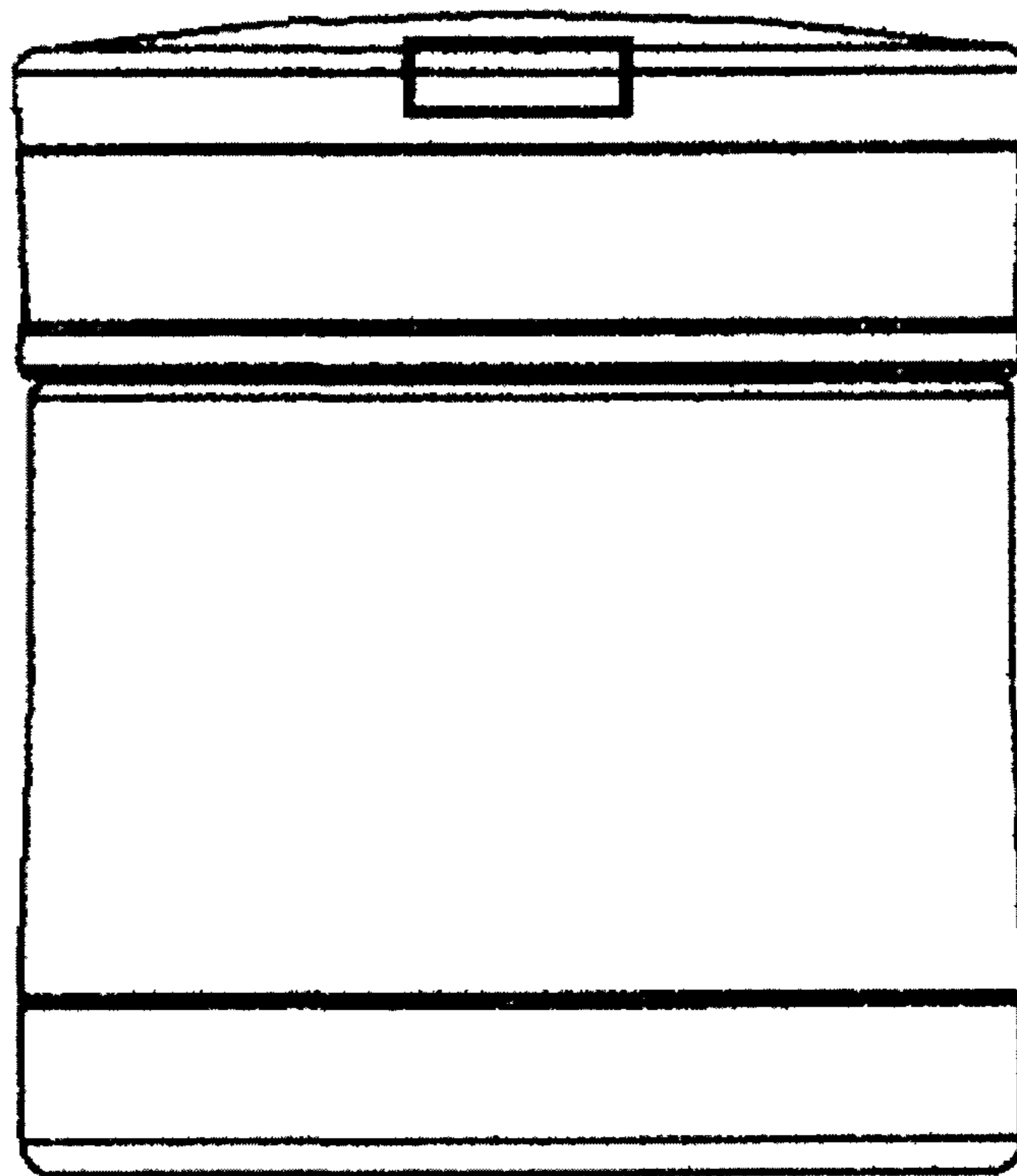

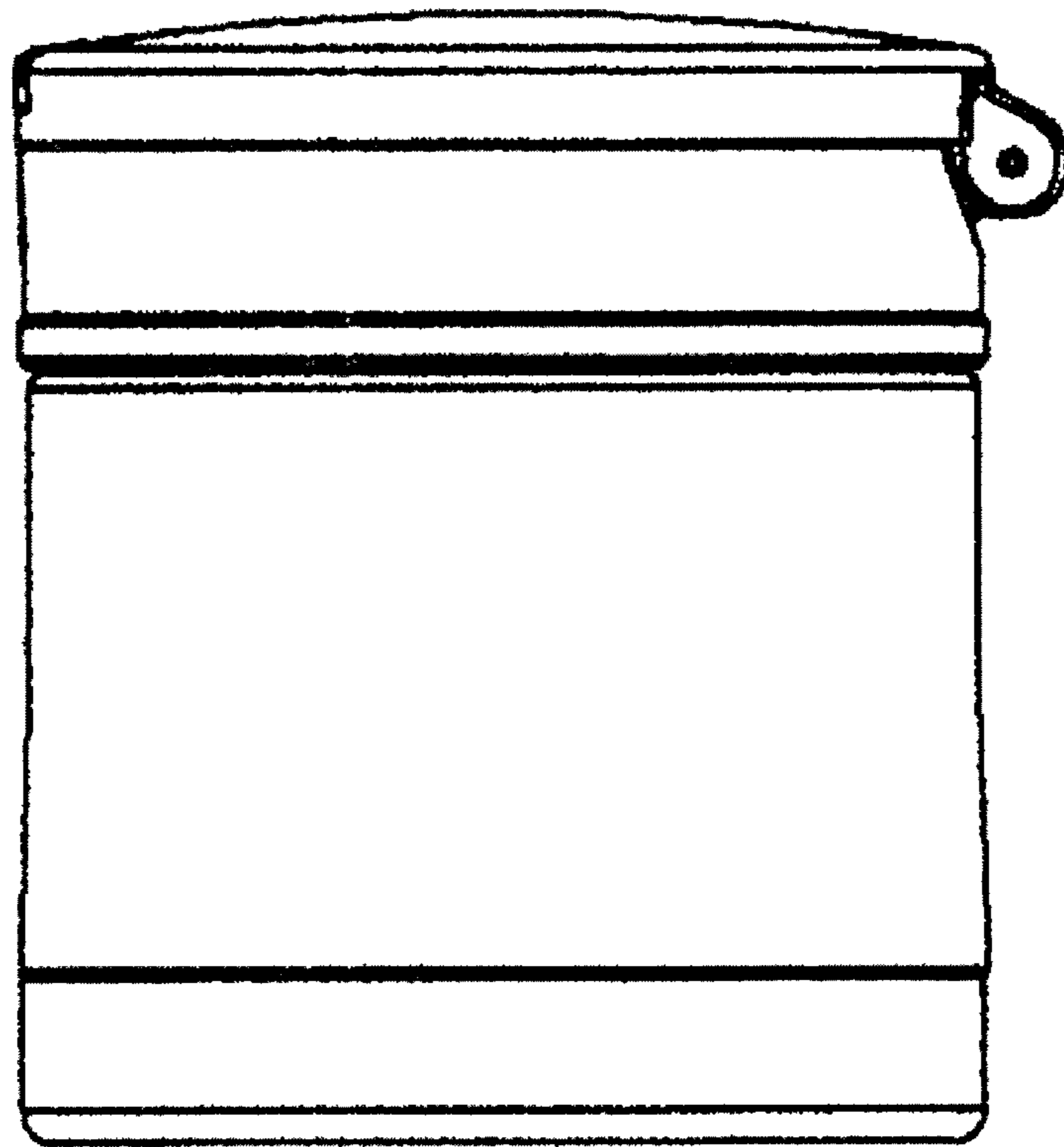

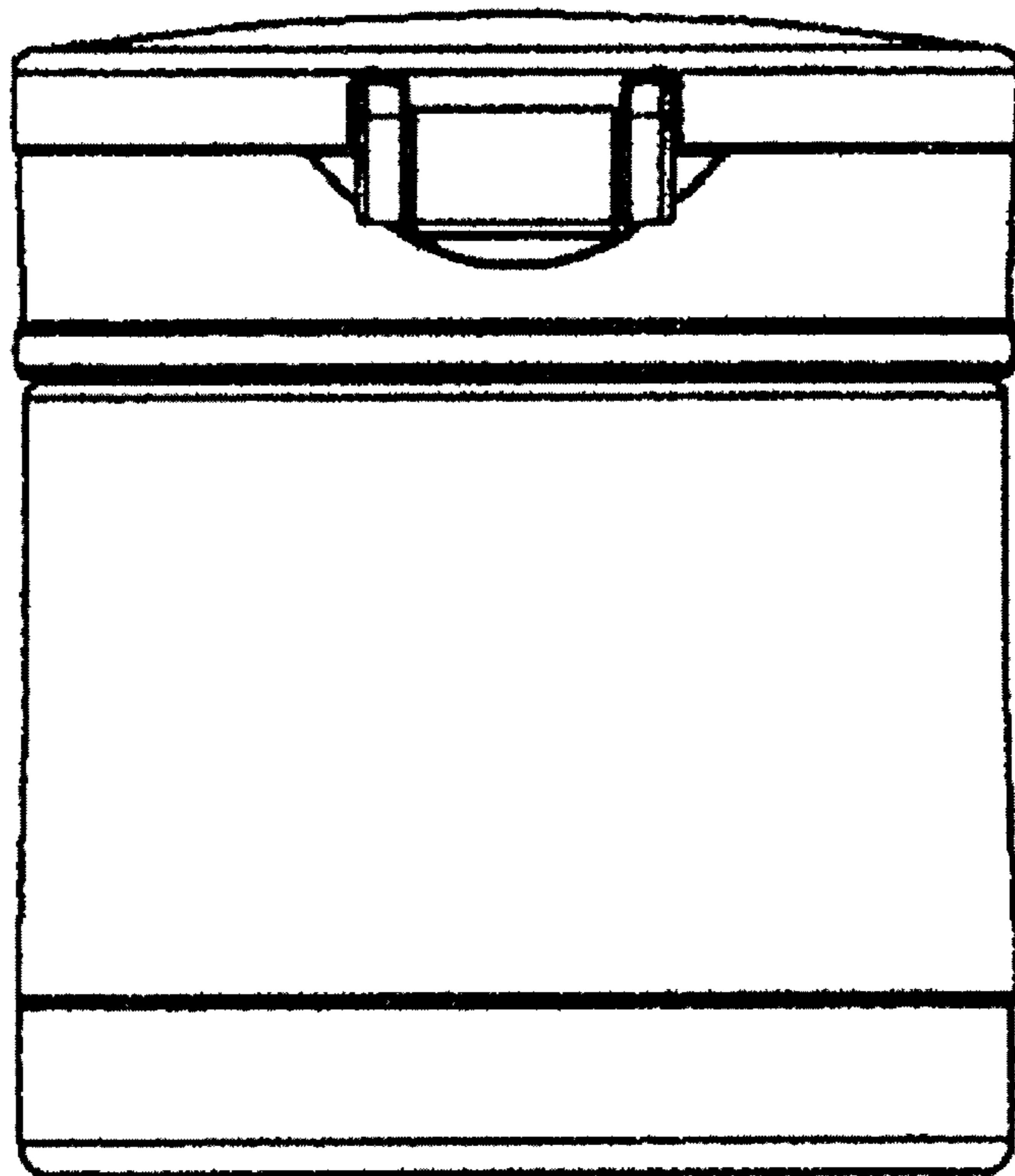

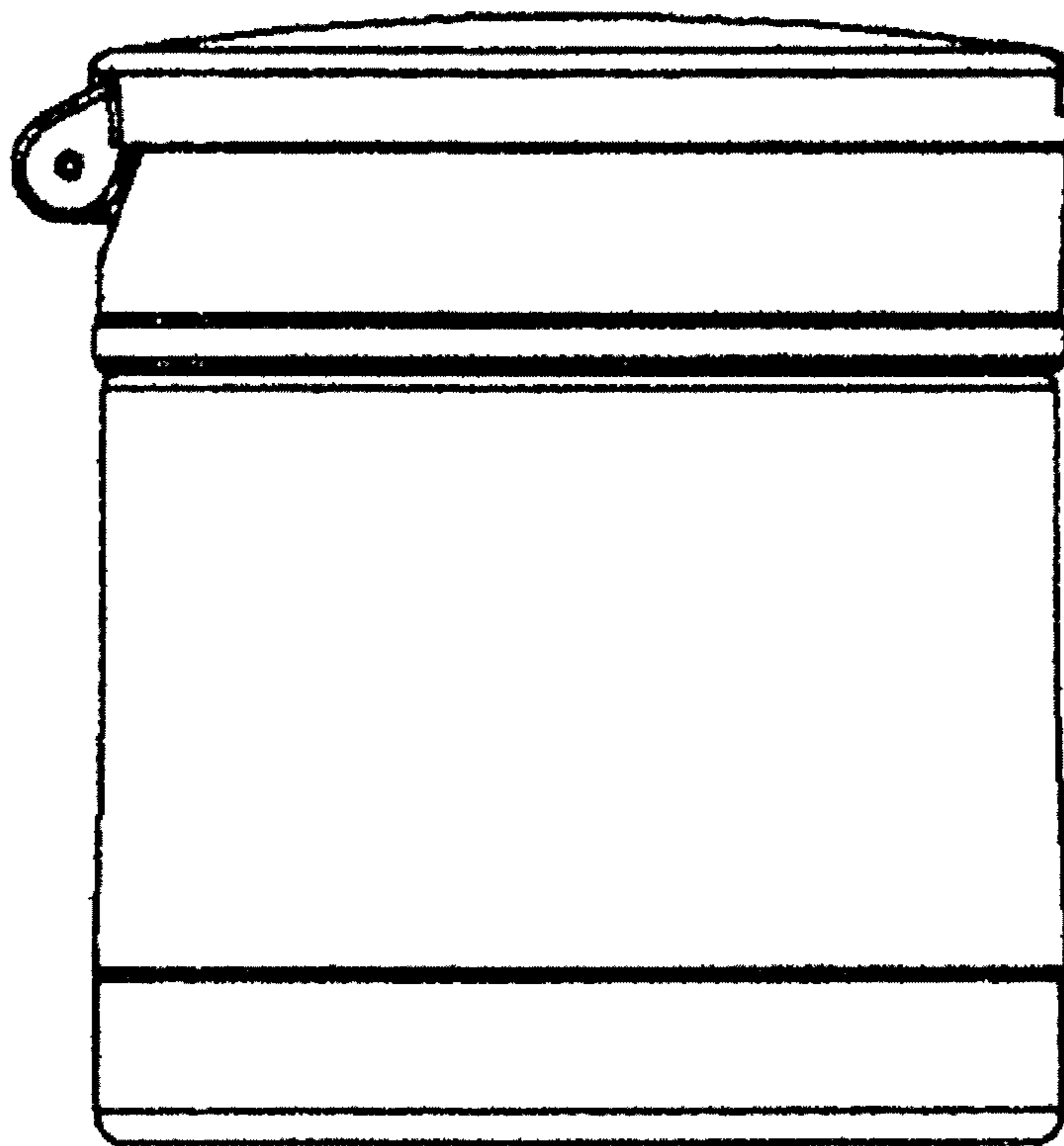

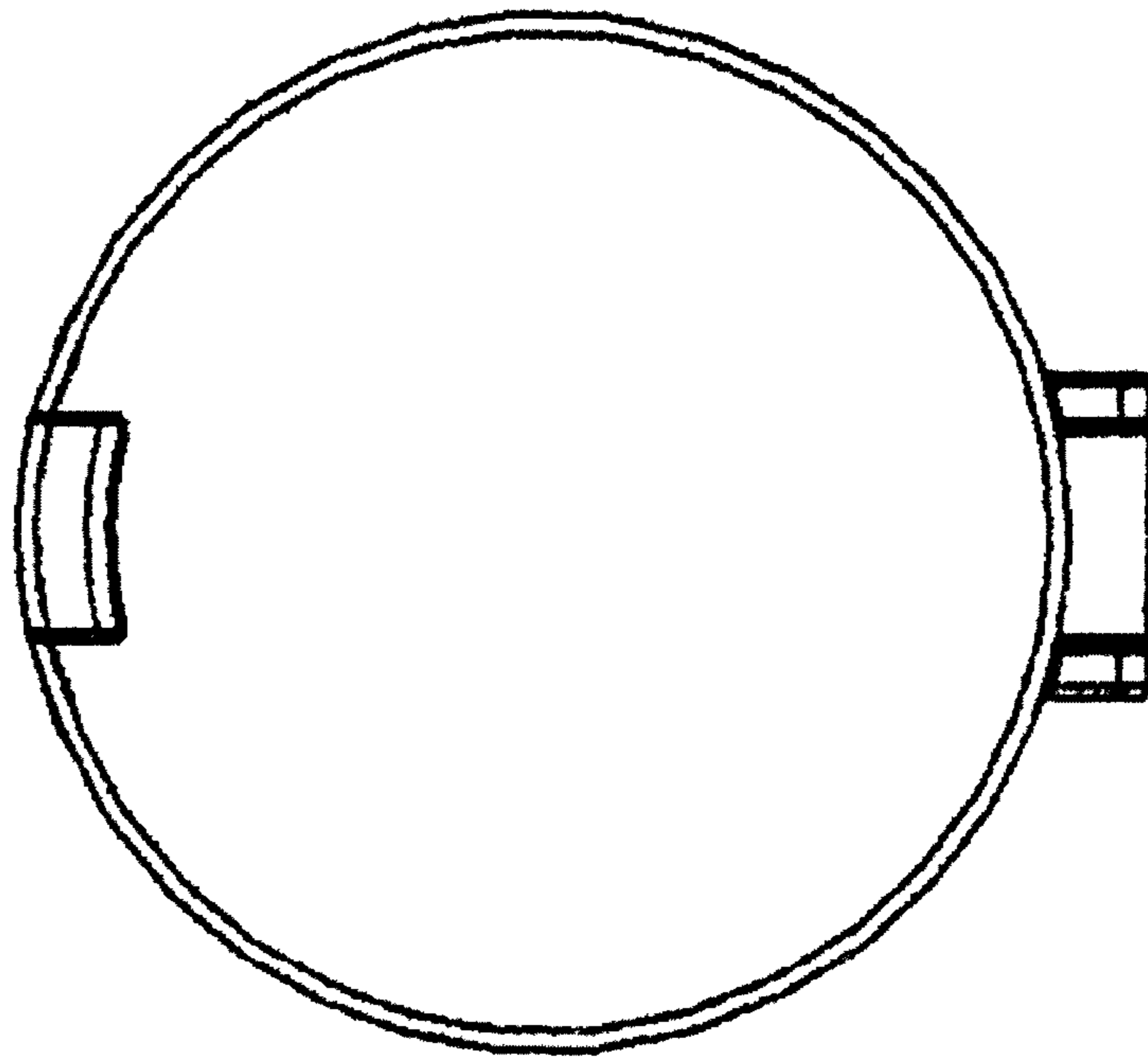

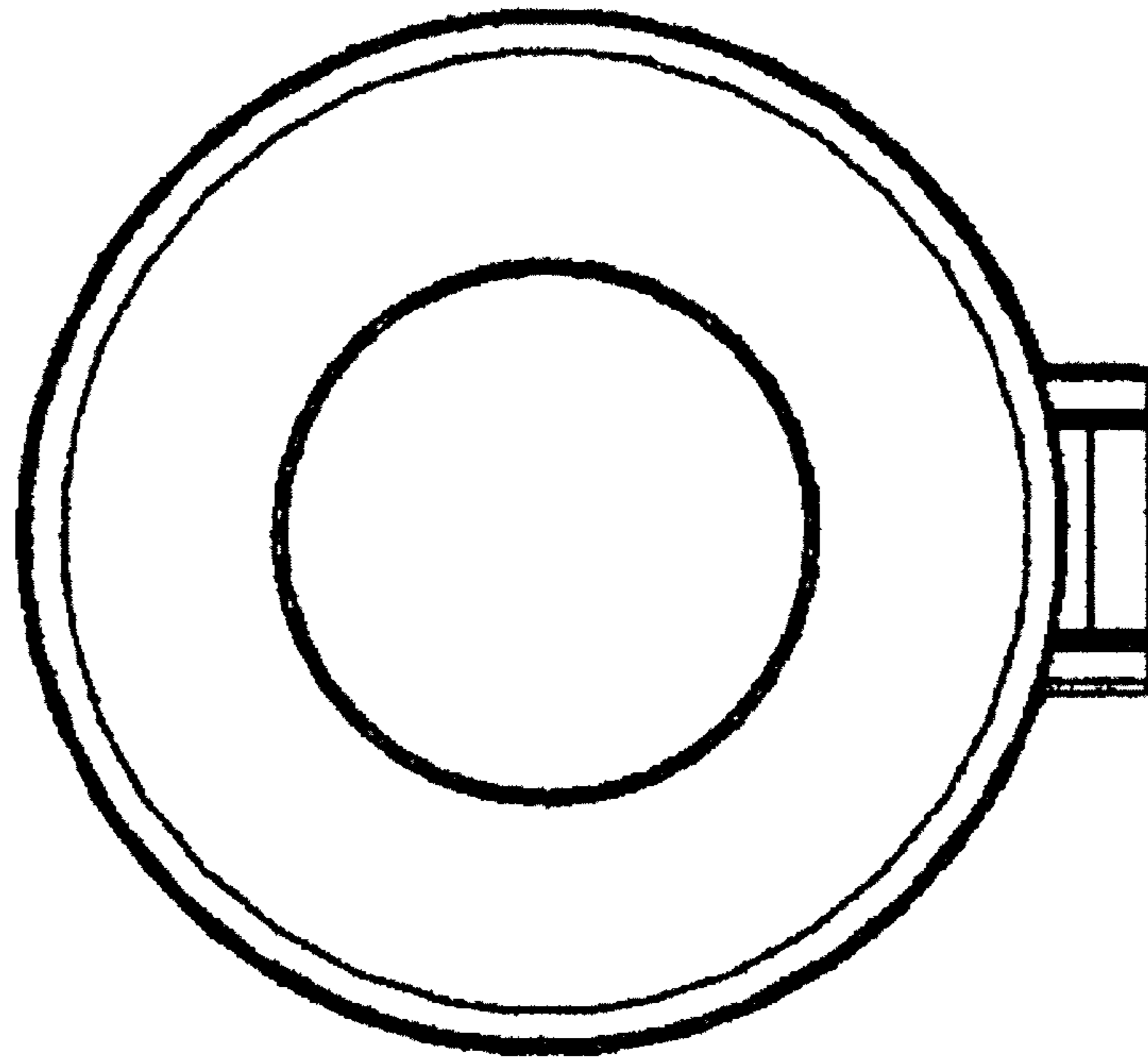
