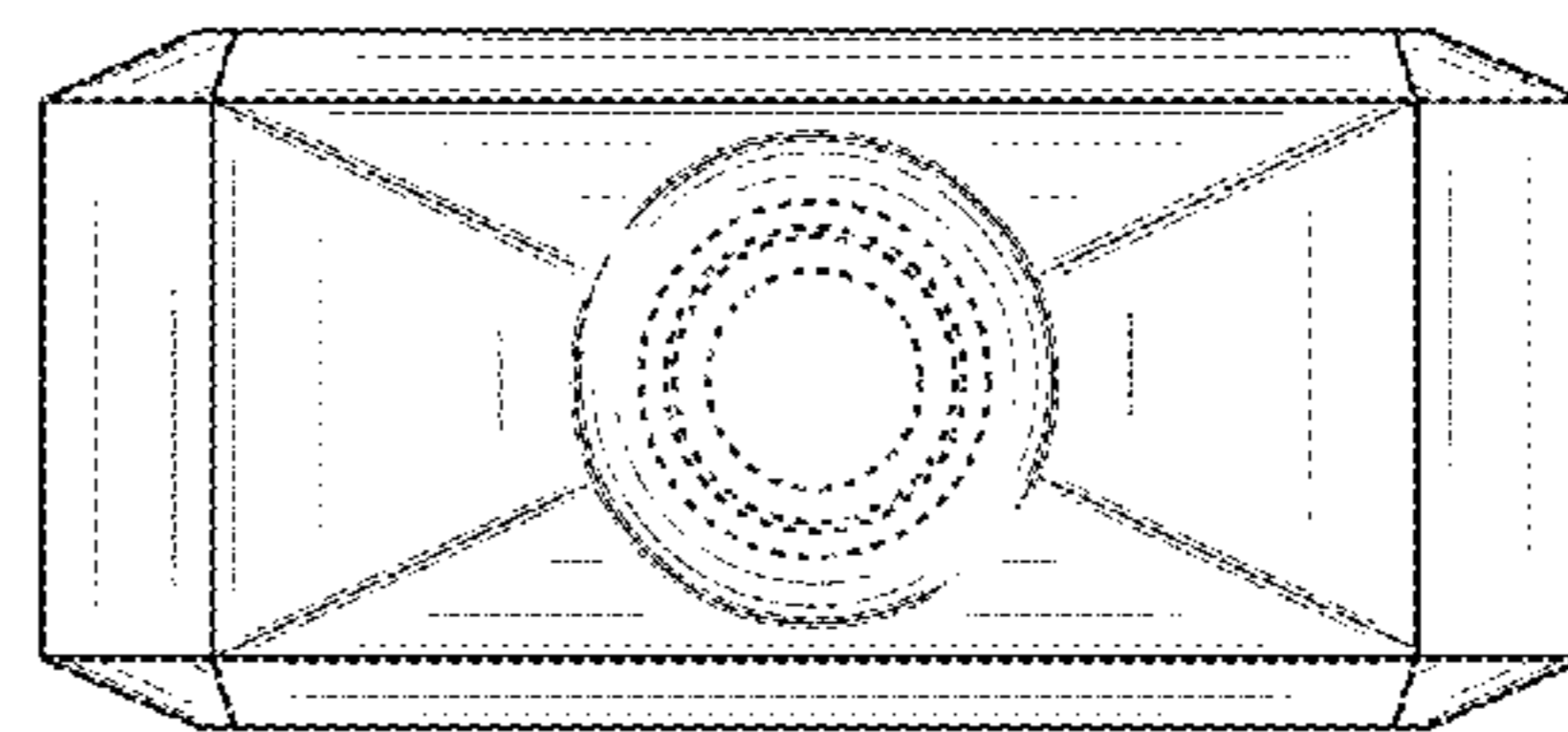
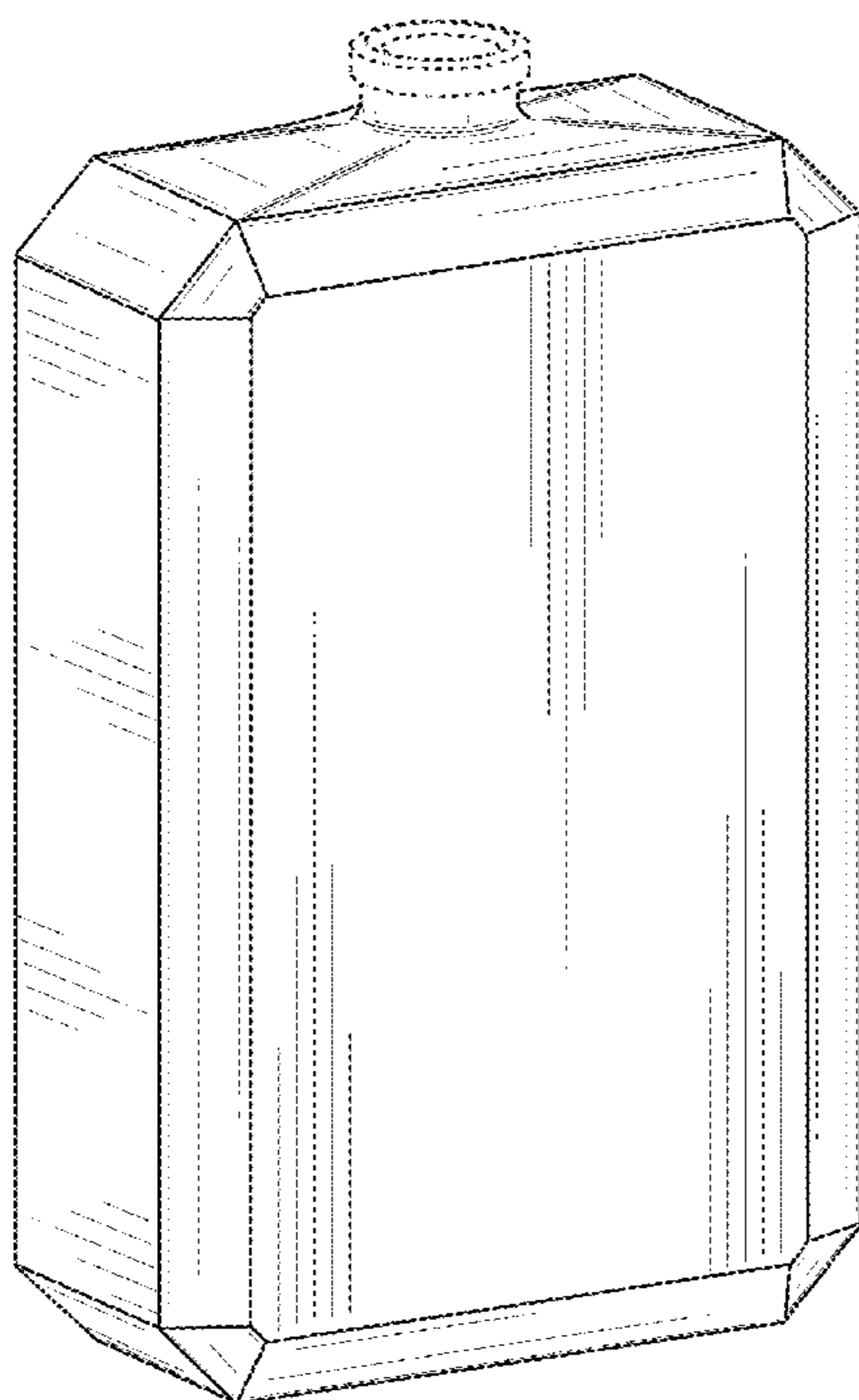

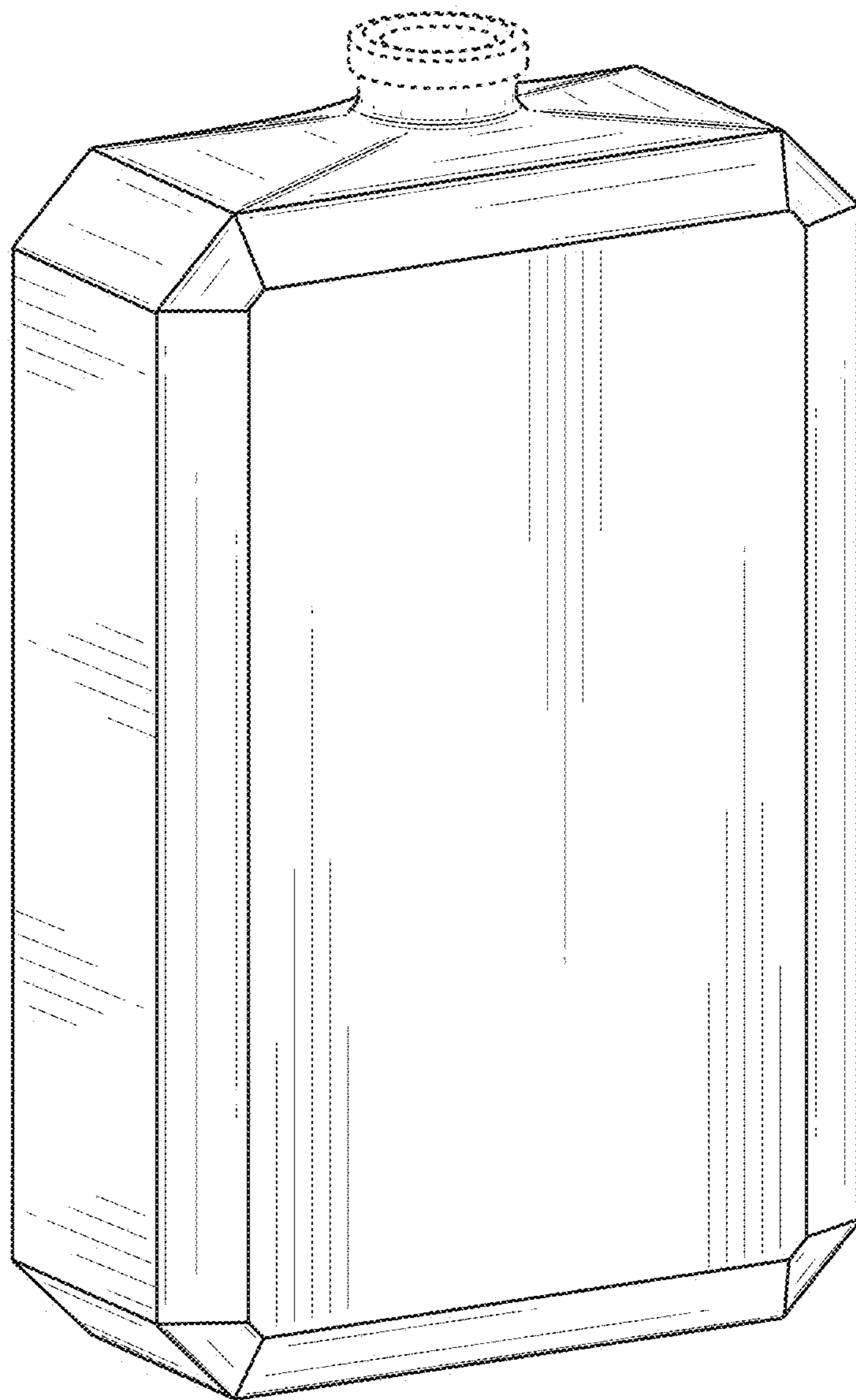
The ornamental design for a flask, as shown and described.

**DESCRIPTION**

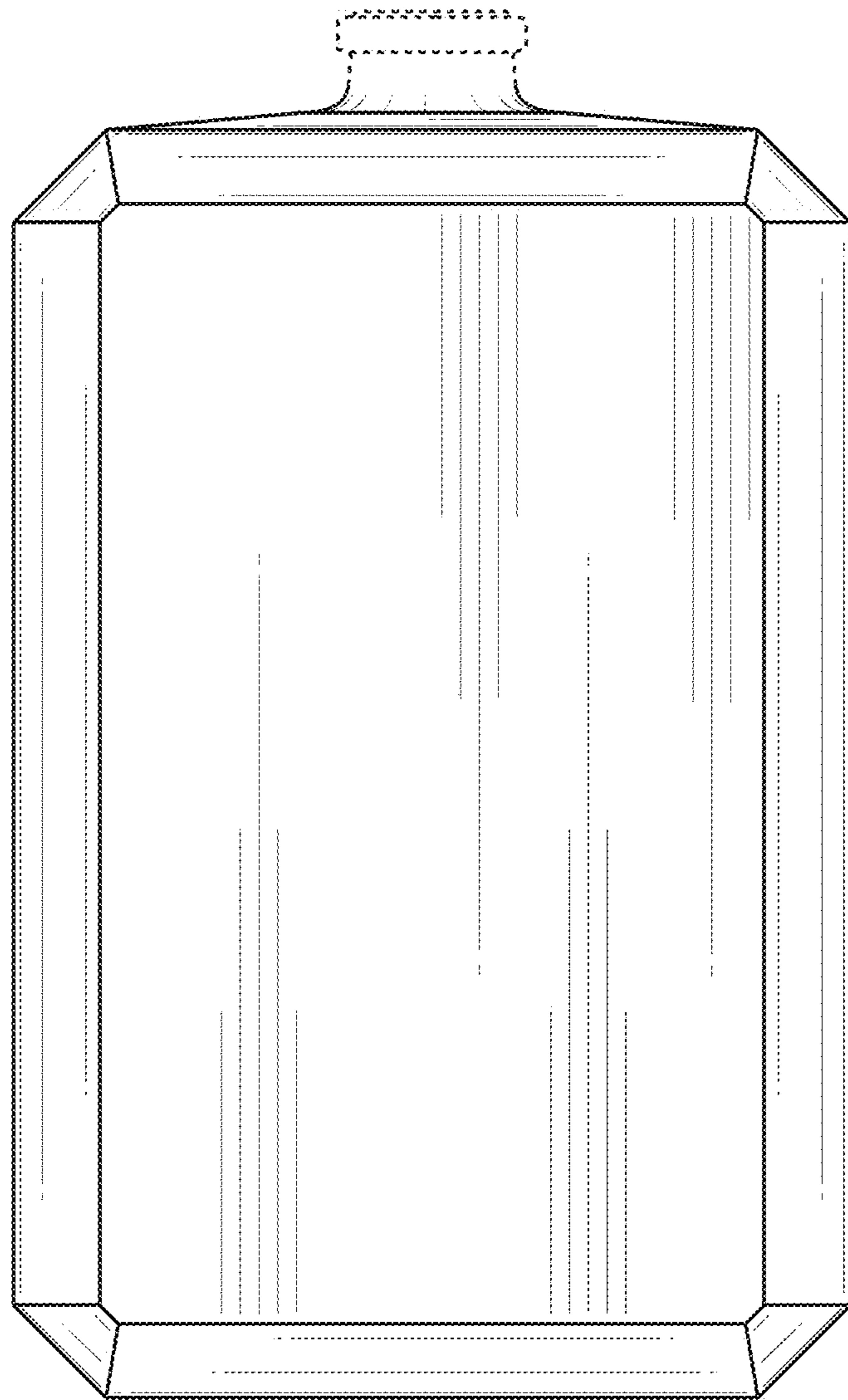
FIG. 1 is a front, left perspective view of the flask showing my new design;

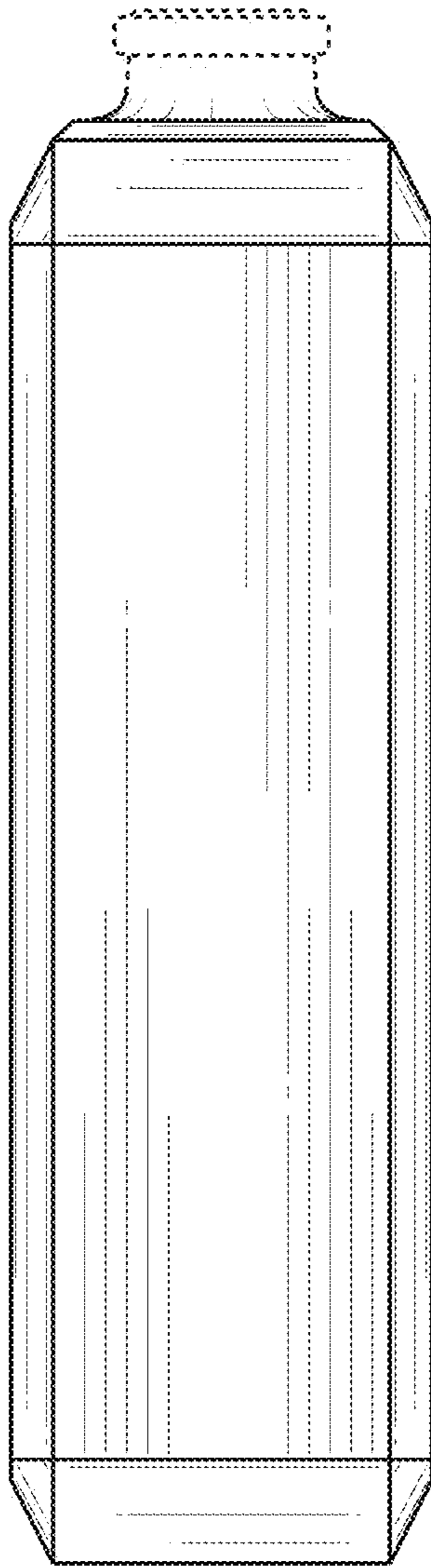




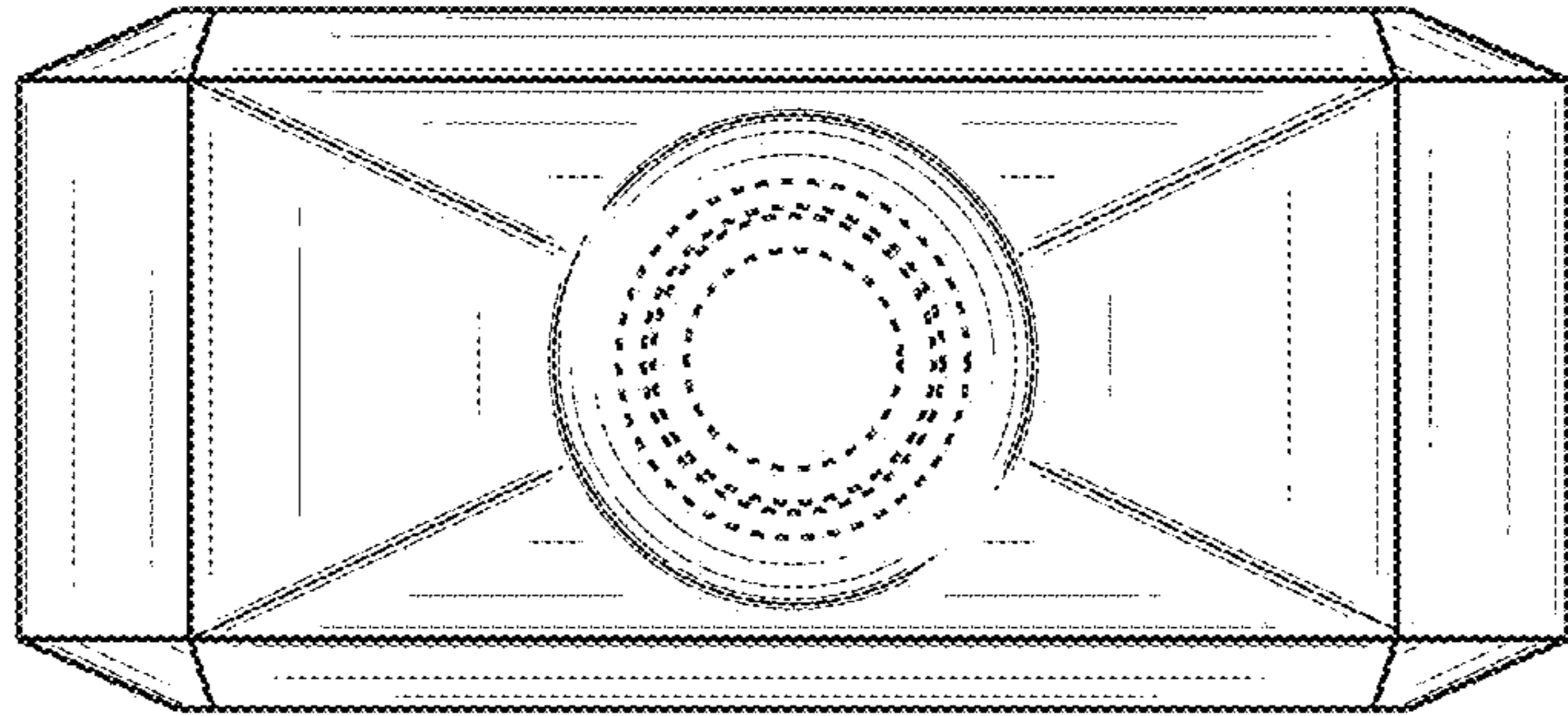

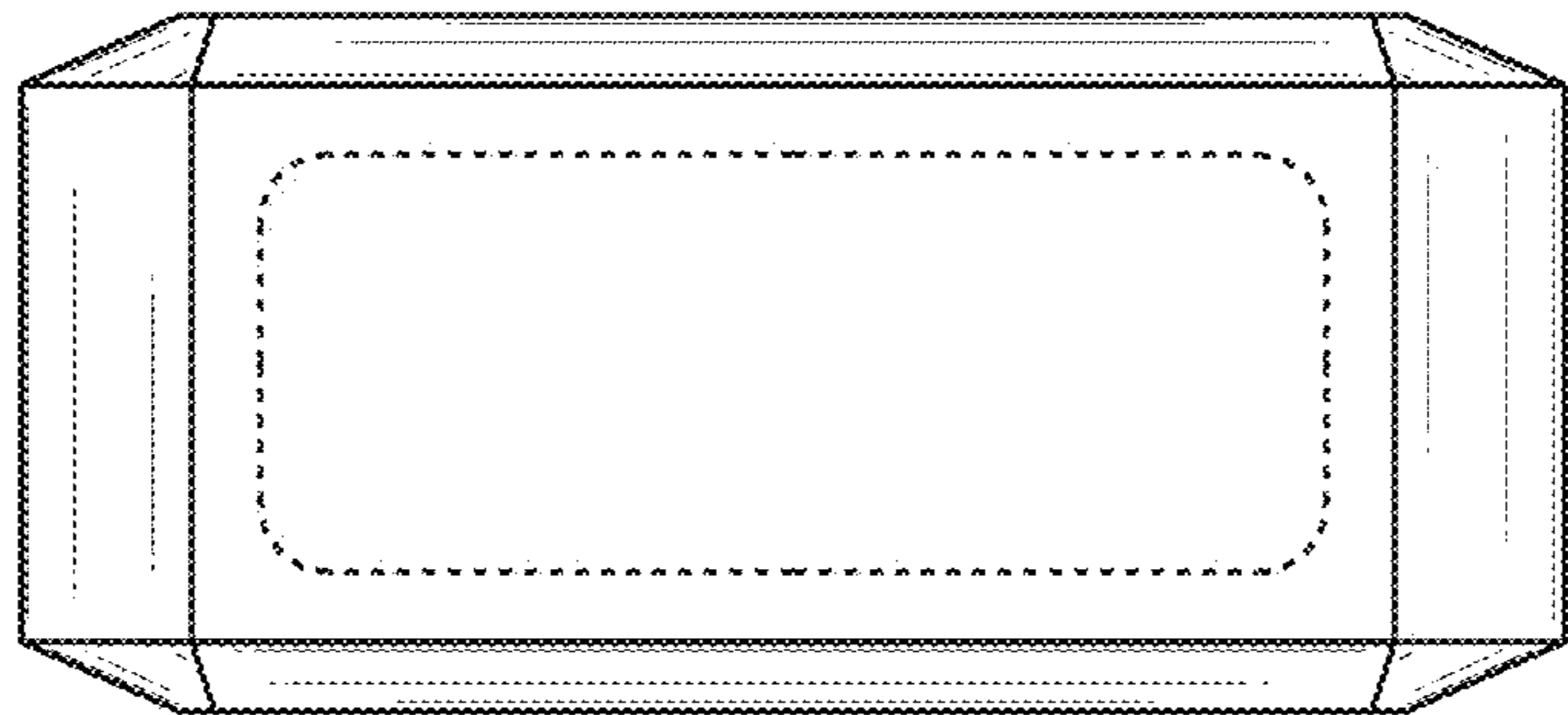
