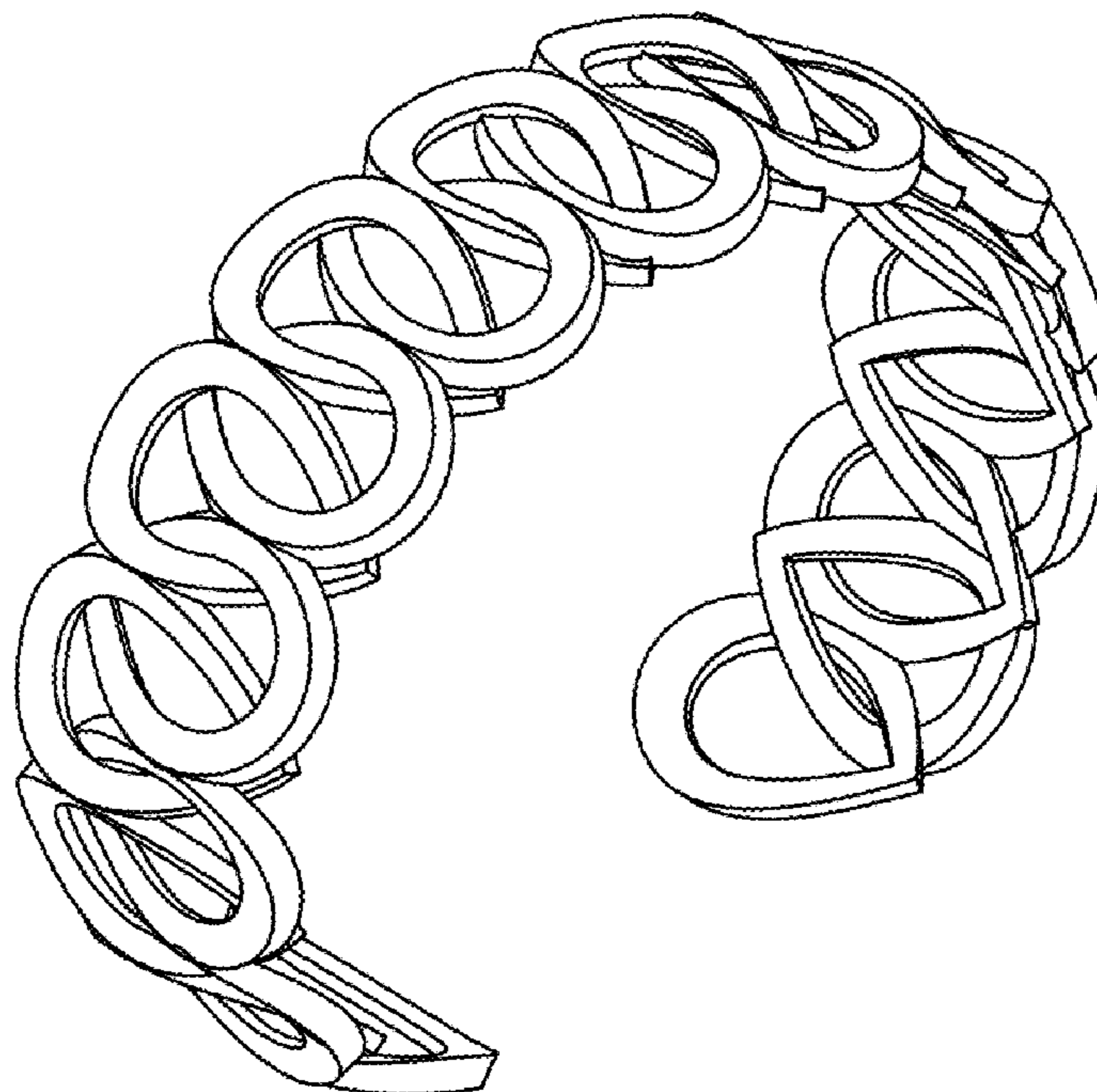
(57) **CLAIM**

The ornamental design for a bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the bracelet of the present invention. FIG. 2 is a bottom view of the bracelet of FIG. 1. FIG. 3 is a right side view of the bracelet of FIG. 1. FIG. 4 is a left side view of the bracelet of FIG. 1. FIG. 5 is a front view of the bracelet of FIG. 1. 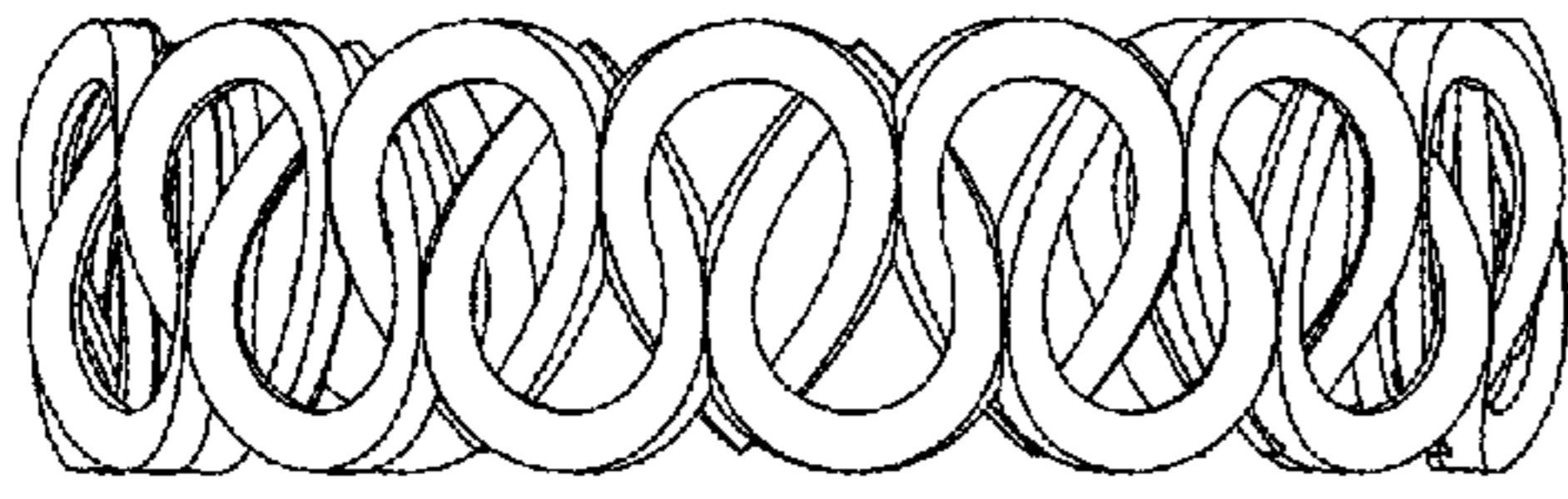

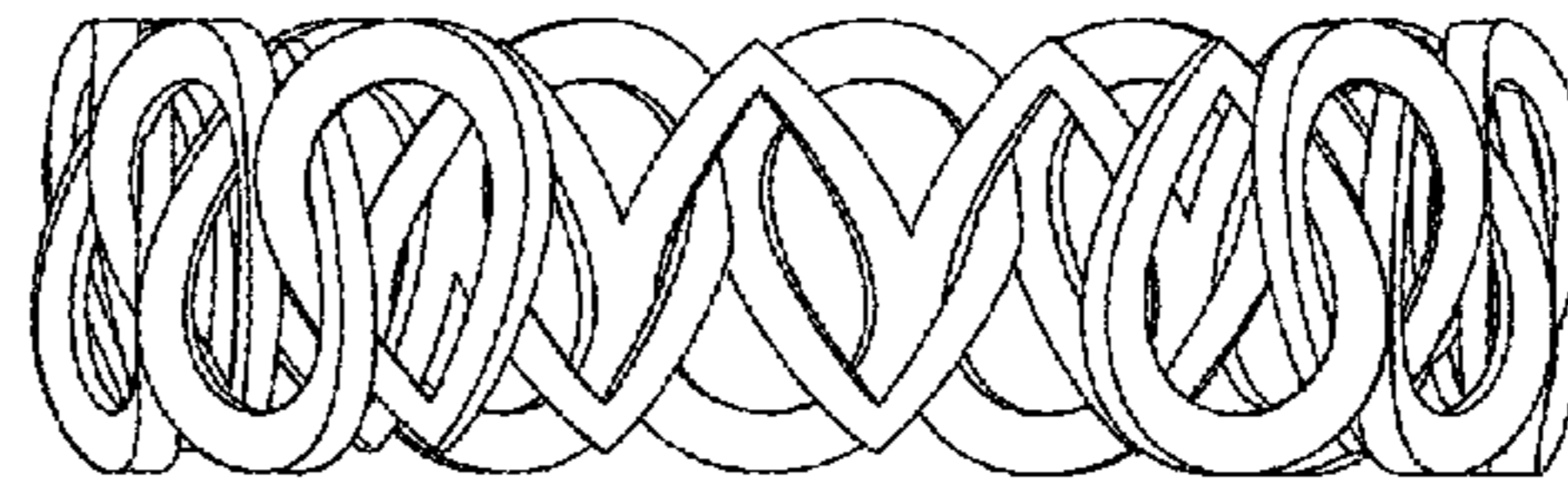

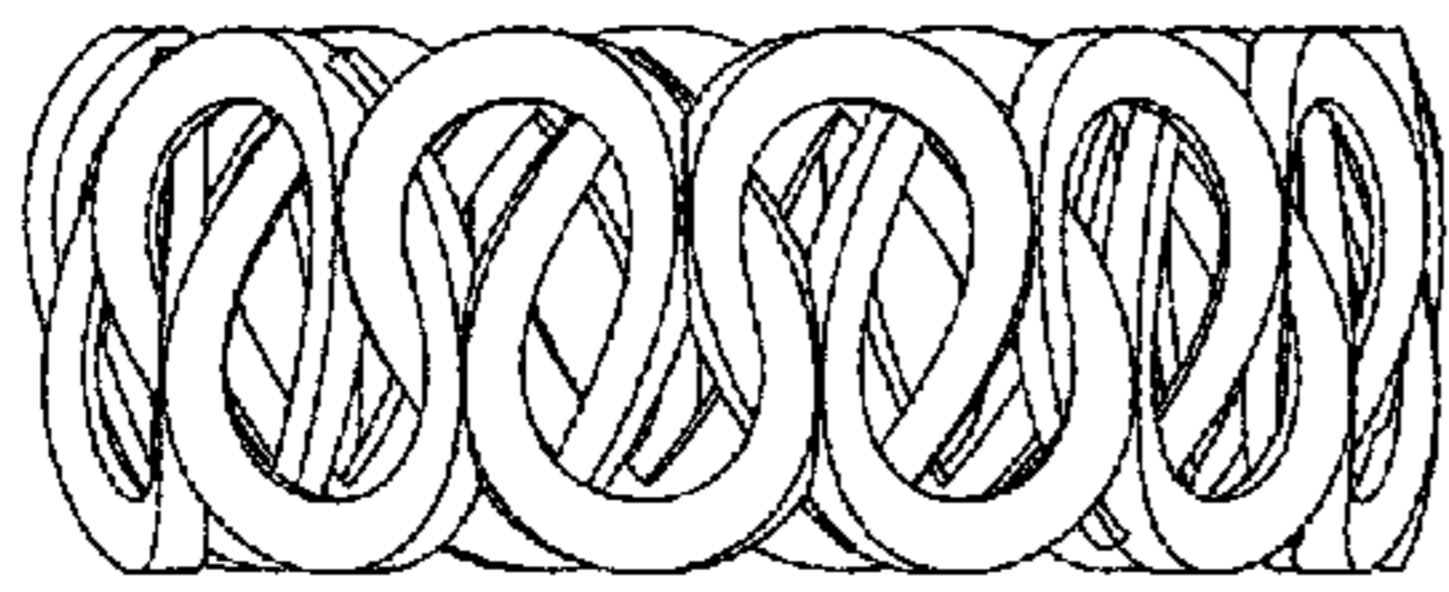

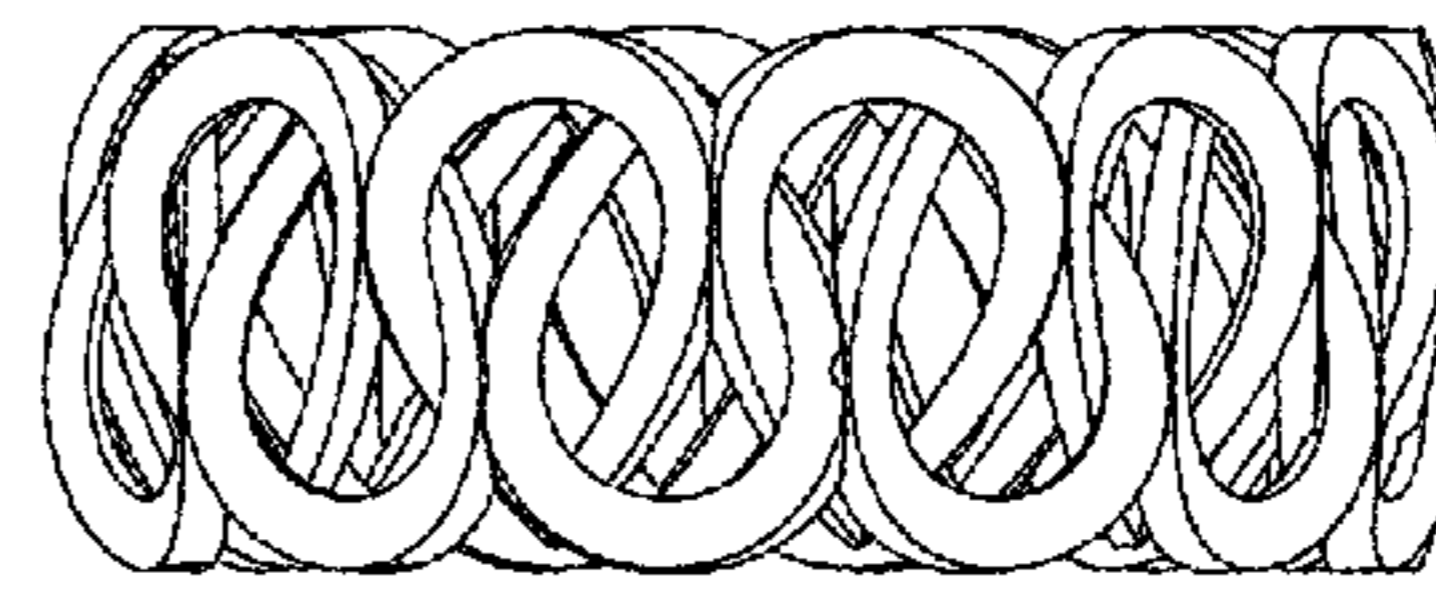

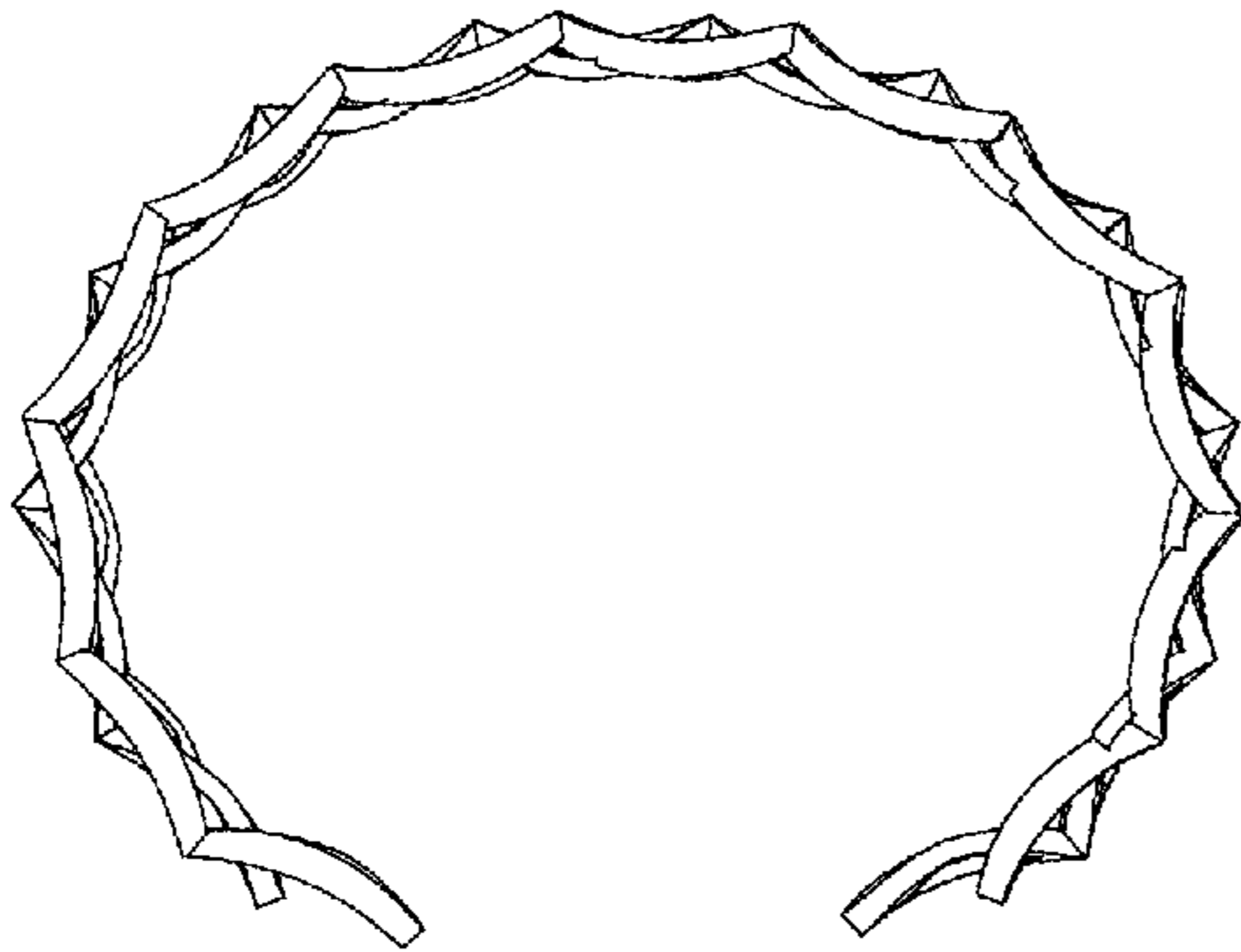

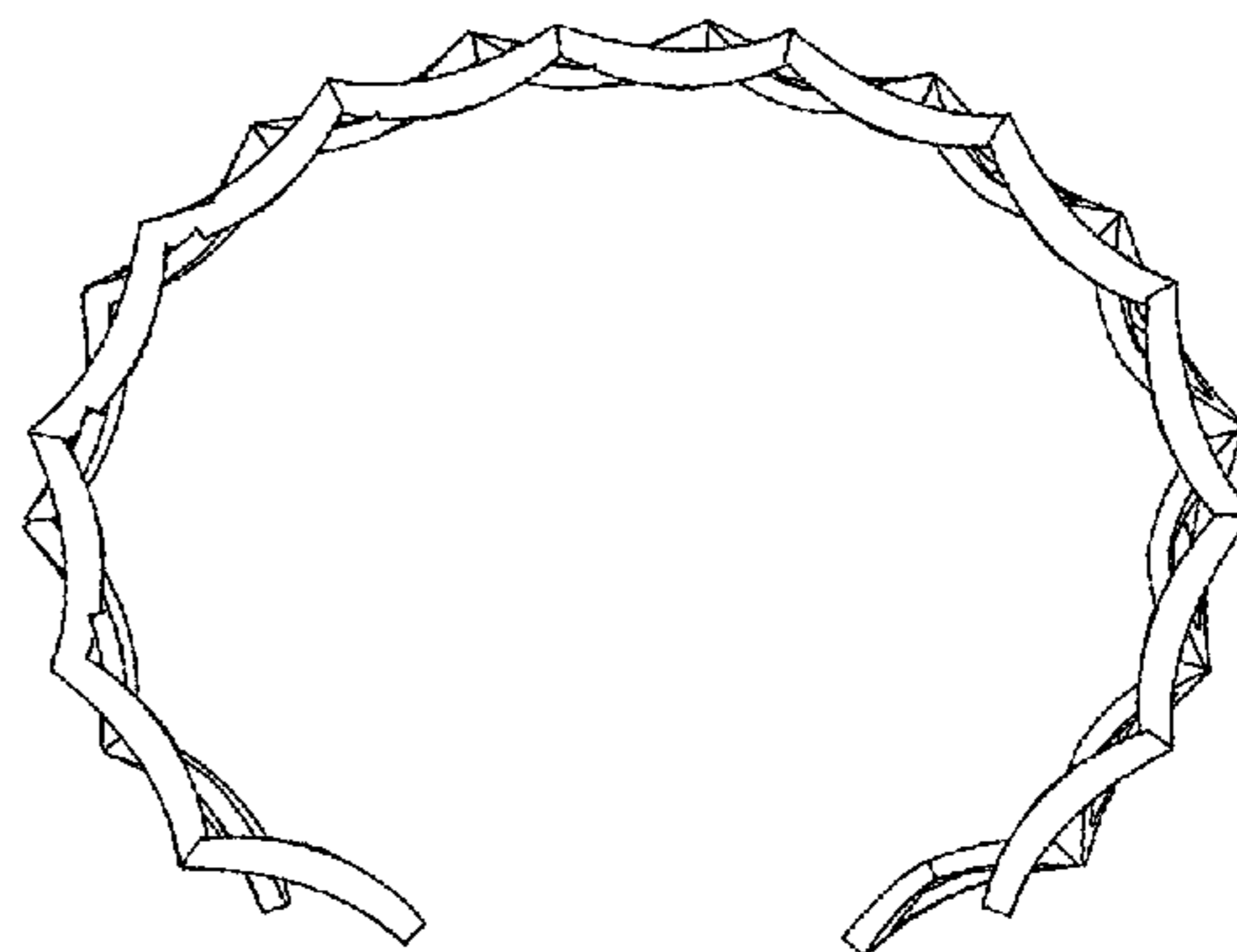

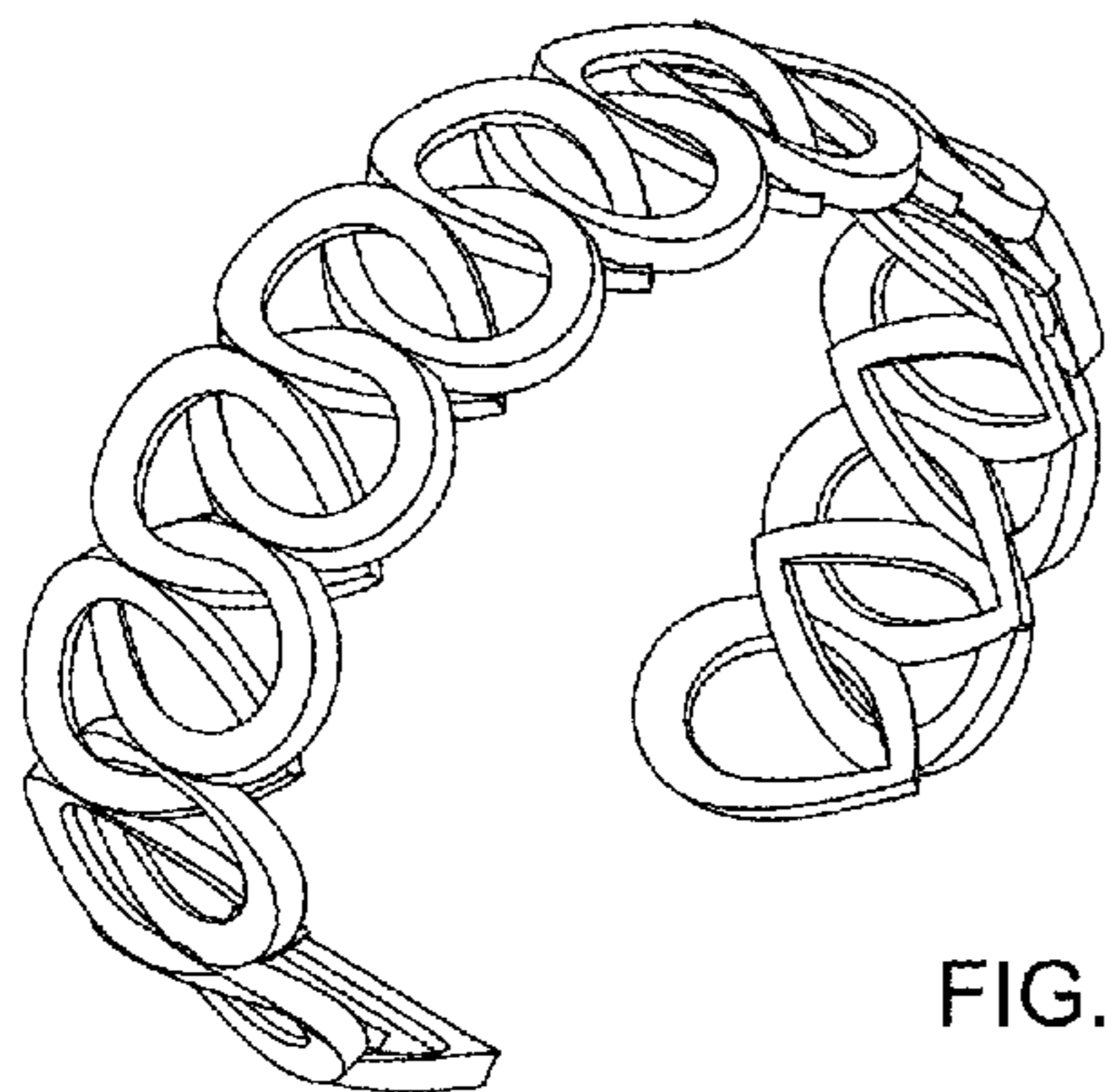
