The broken lines are for illustrative purposes only and form no part of the claimed design.

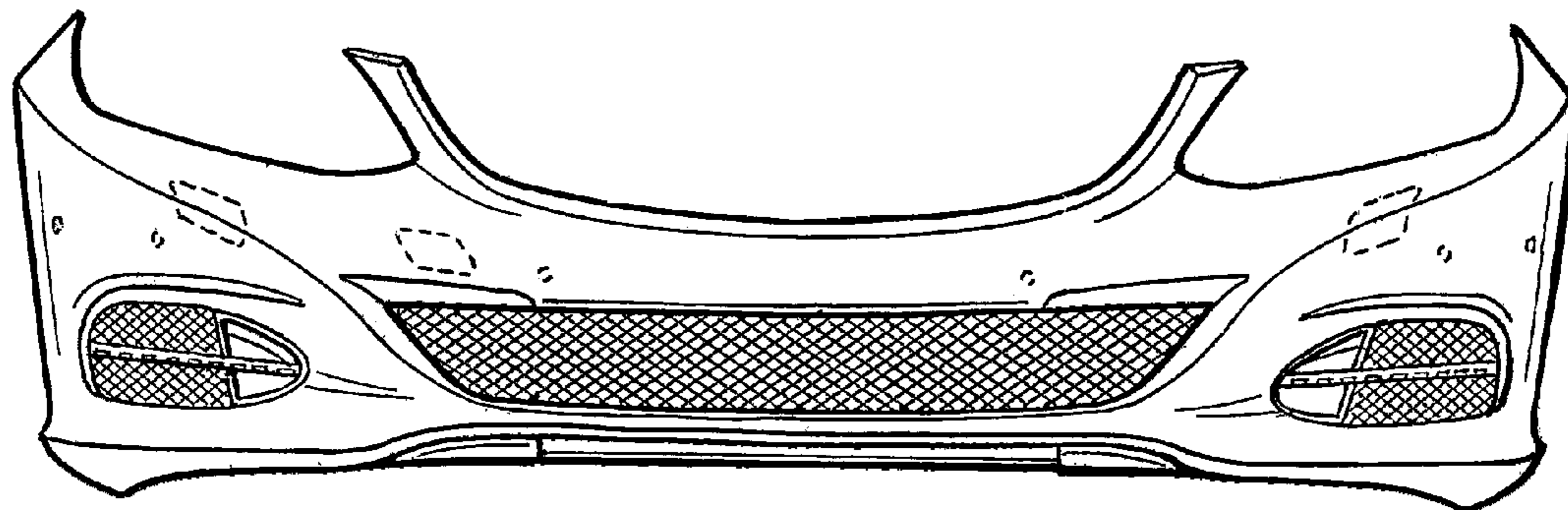

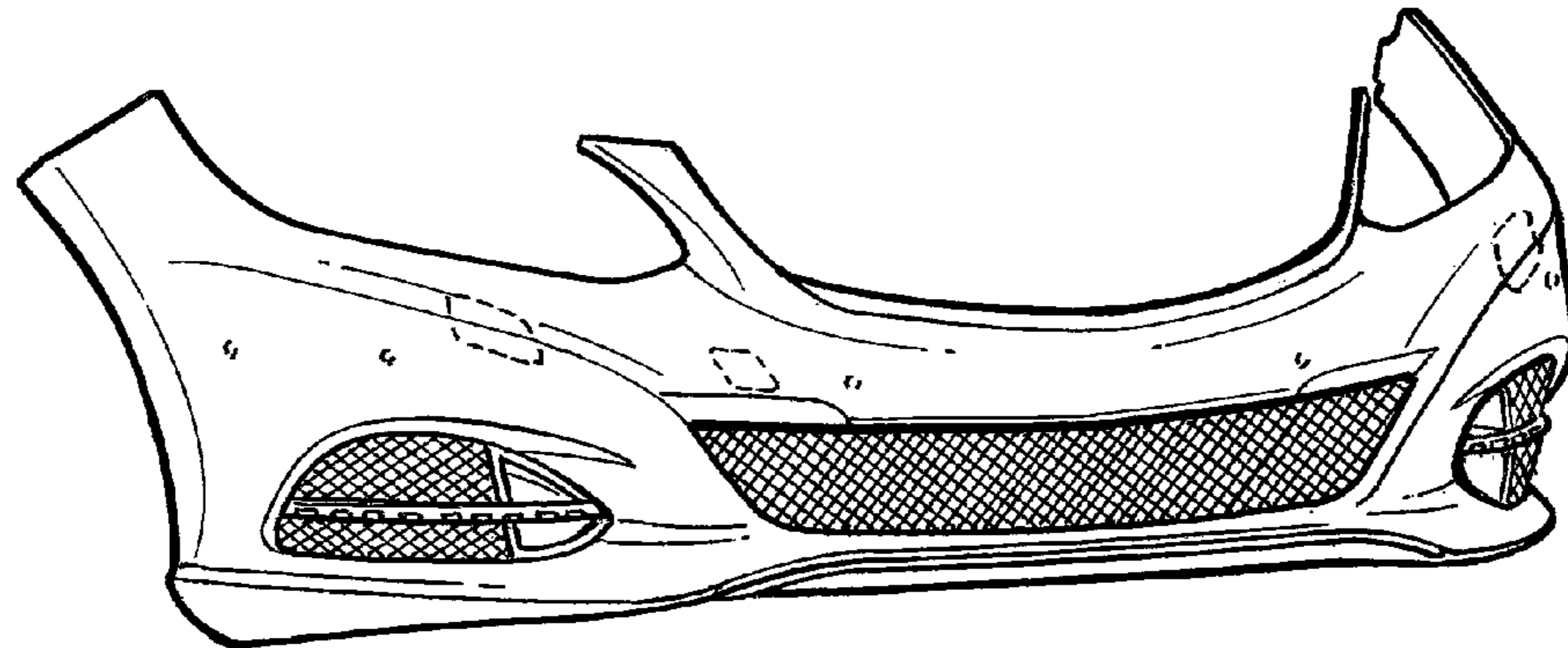

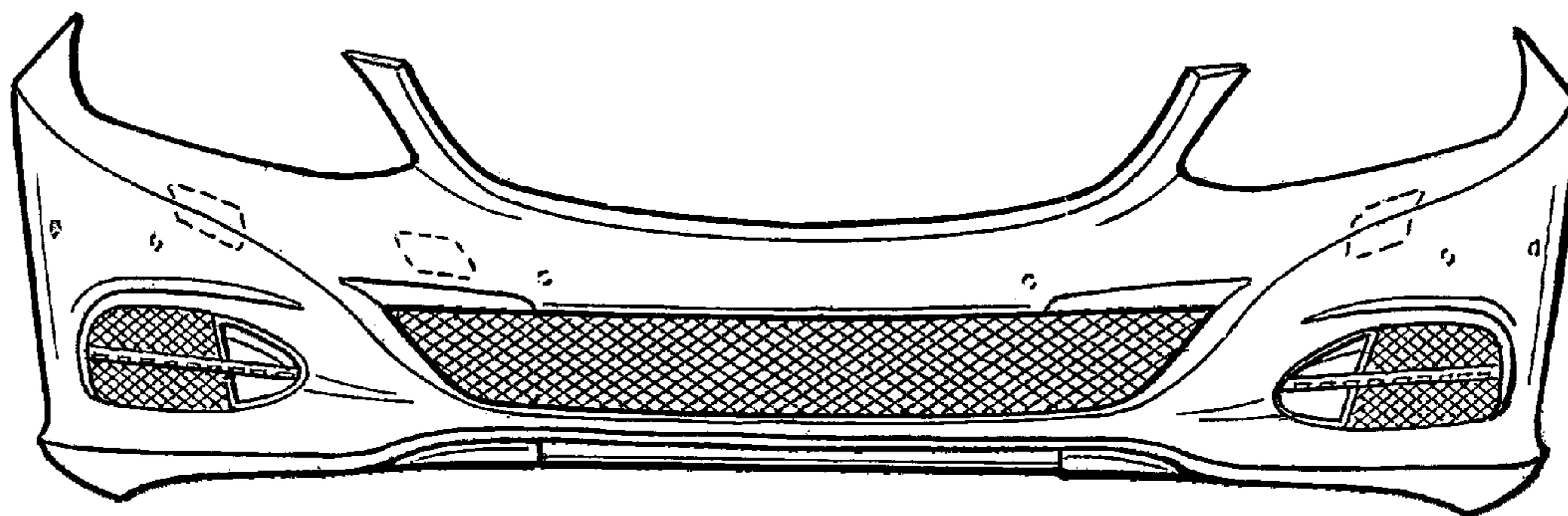

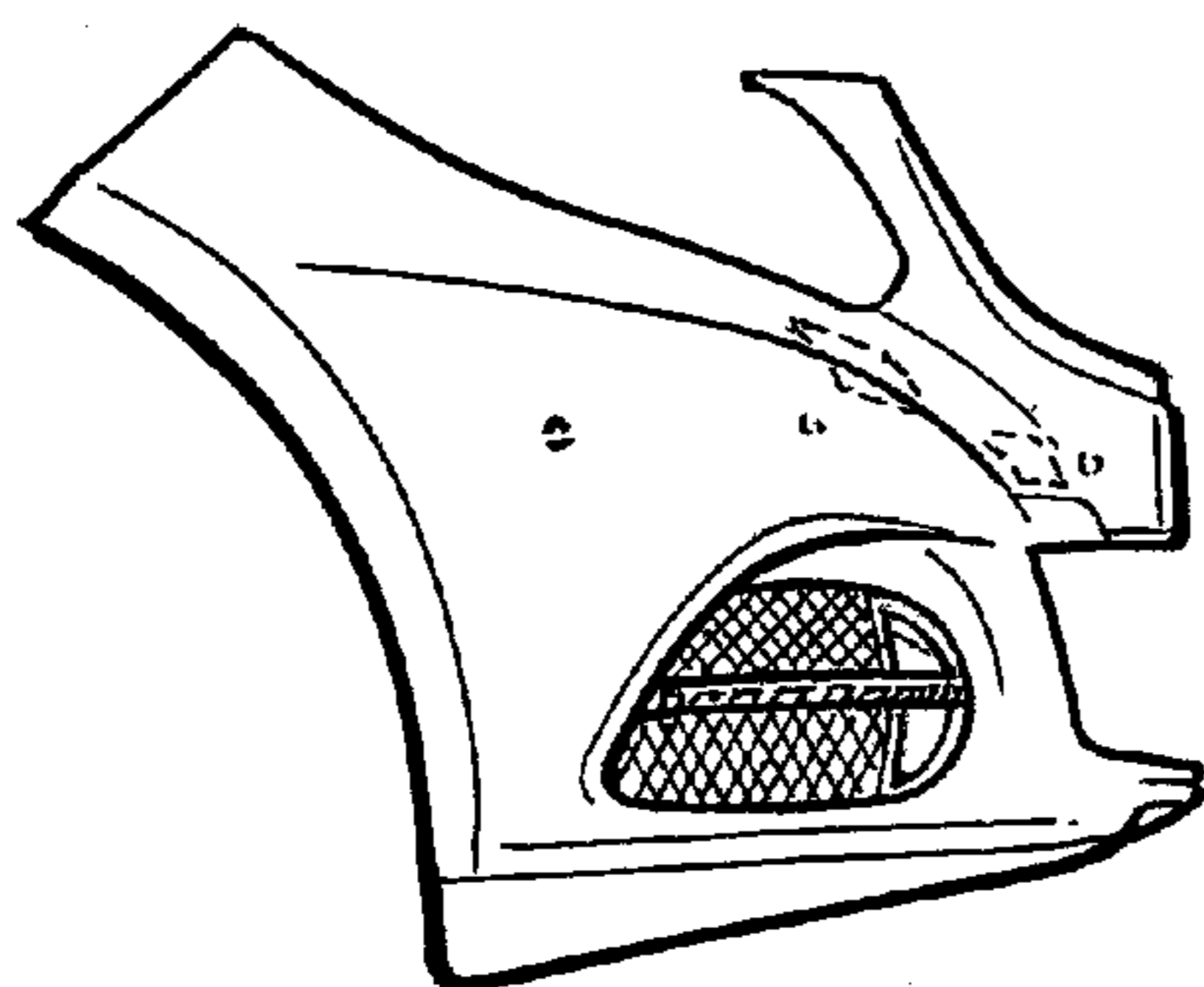

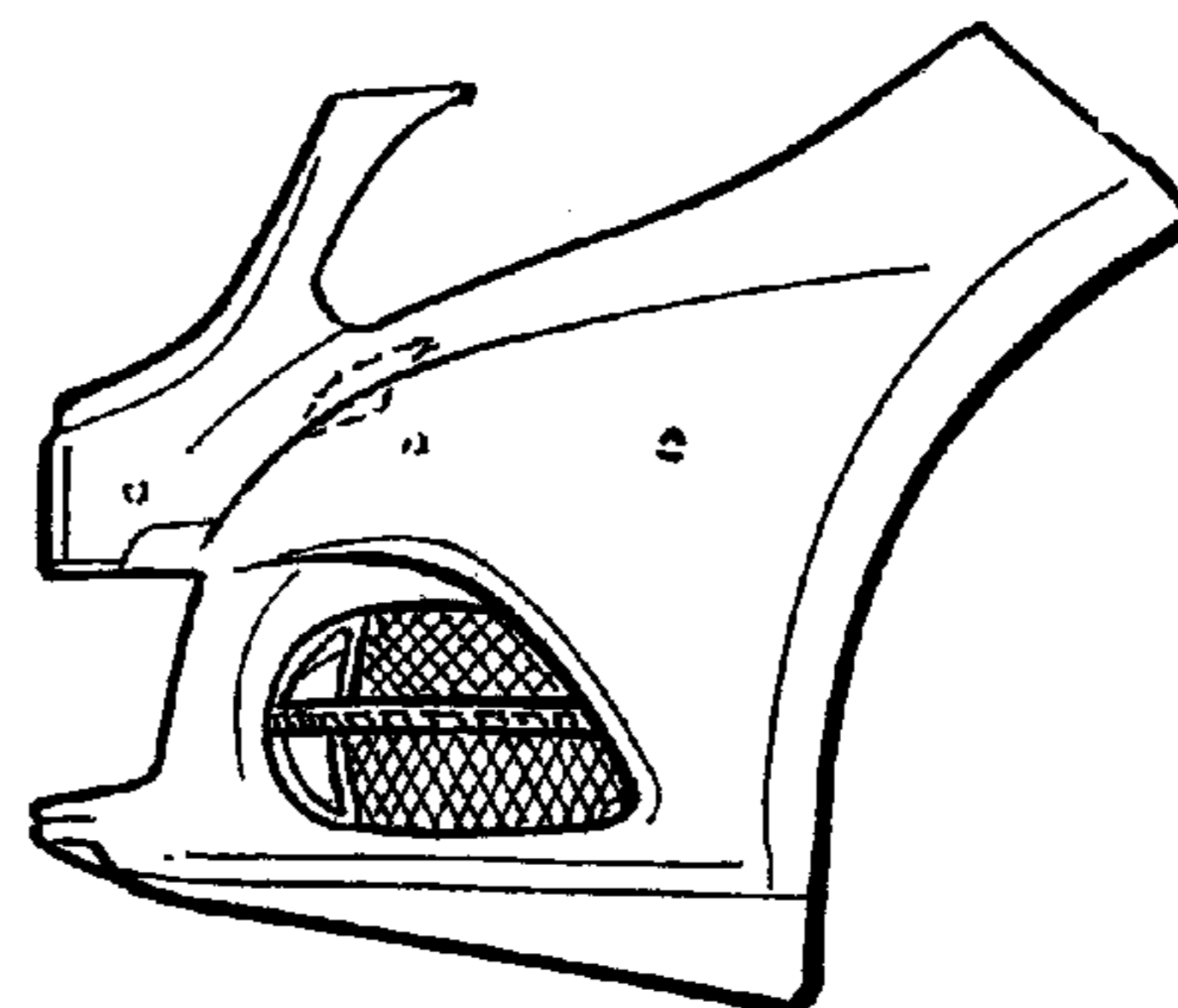

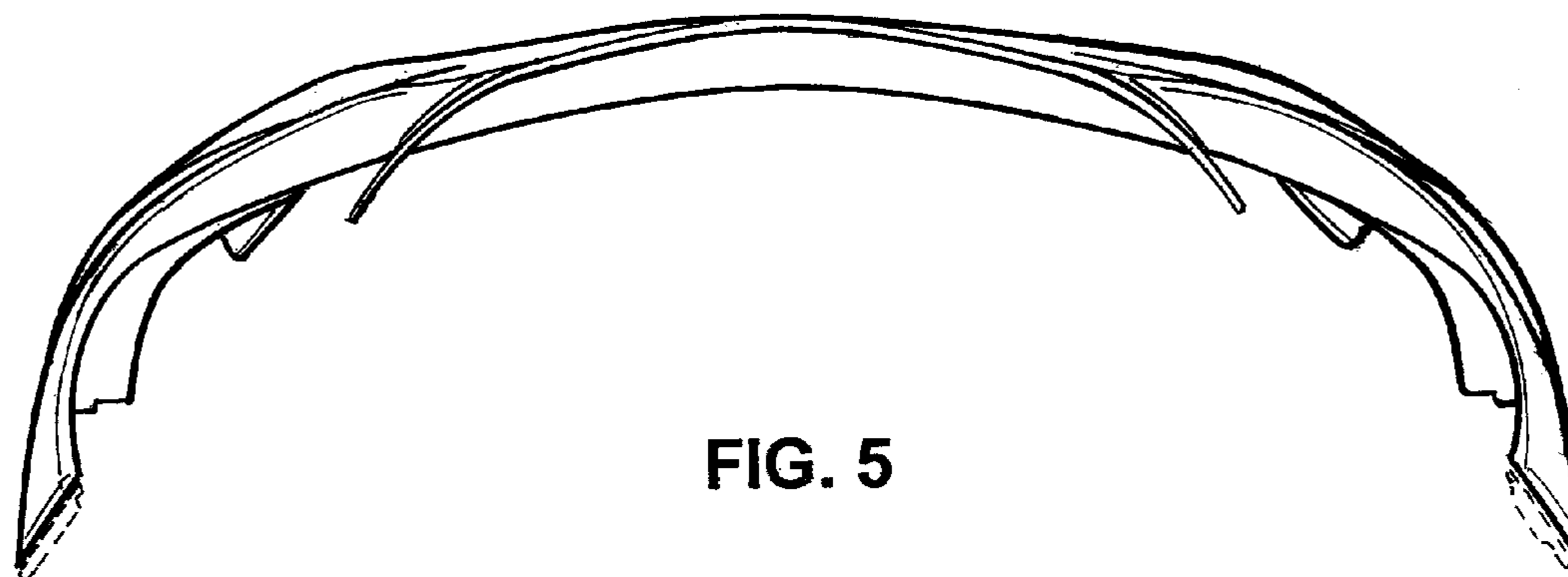
