The ornamental design for an F-brake, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper left perspective view of the F-brake including an illustration of a representative environment of the design shown in broken lines, the environmental detail in broken lines being disclaimed as forming no part of this design;

FIG. 2 is a right side perspective view of the design;

FIG. 4 a left side elevation view of the design;

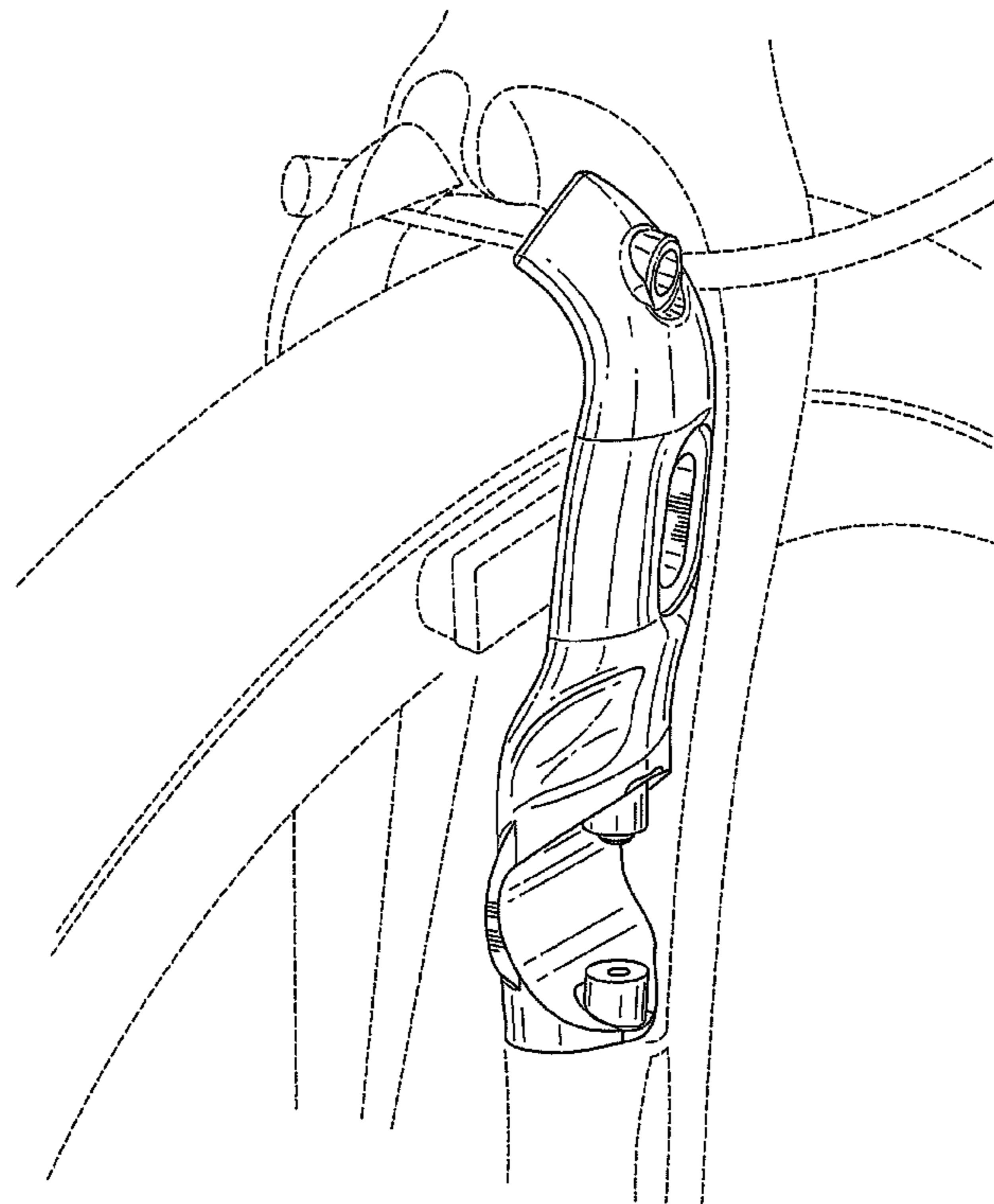
FIG. 5 is a front elevation view of the design;

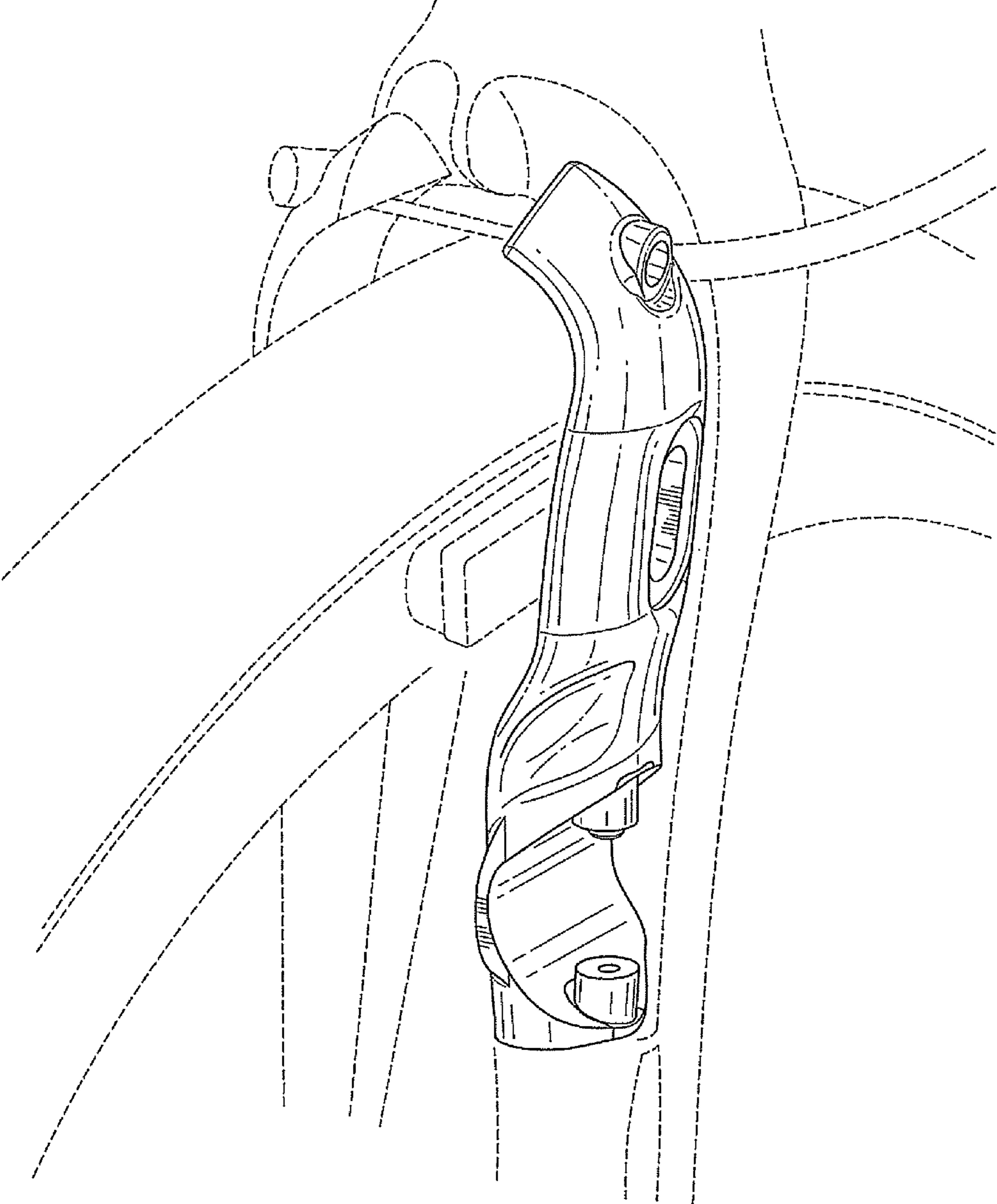

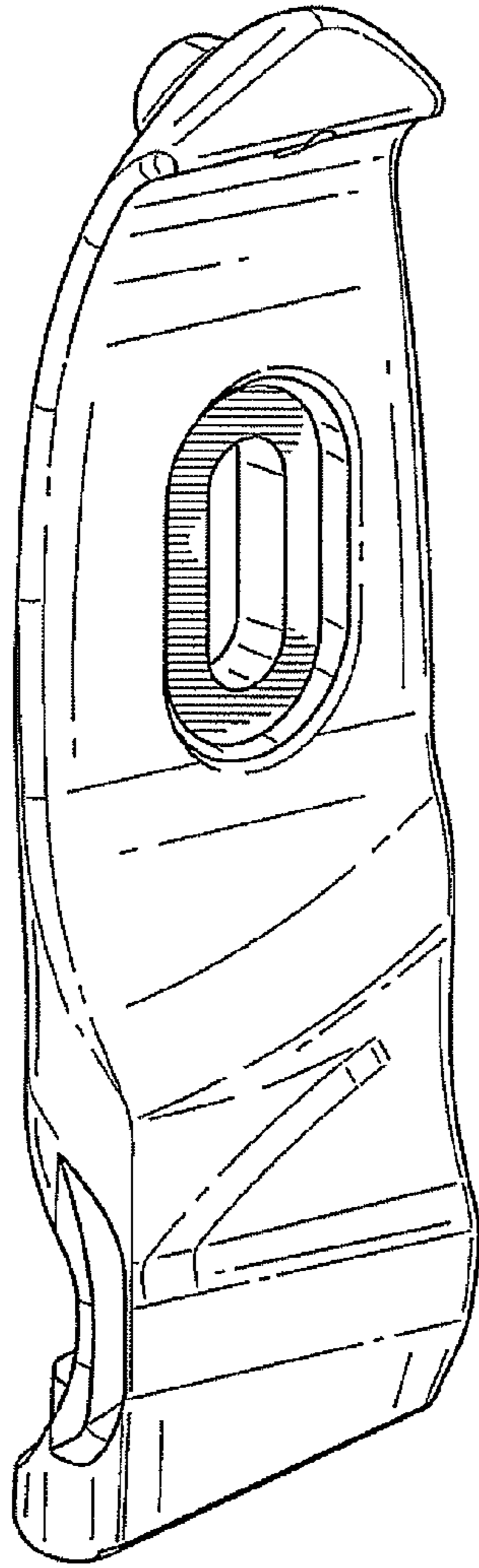

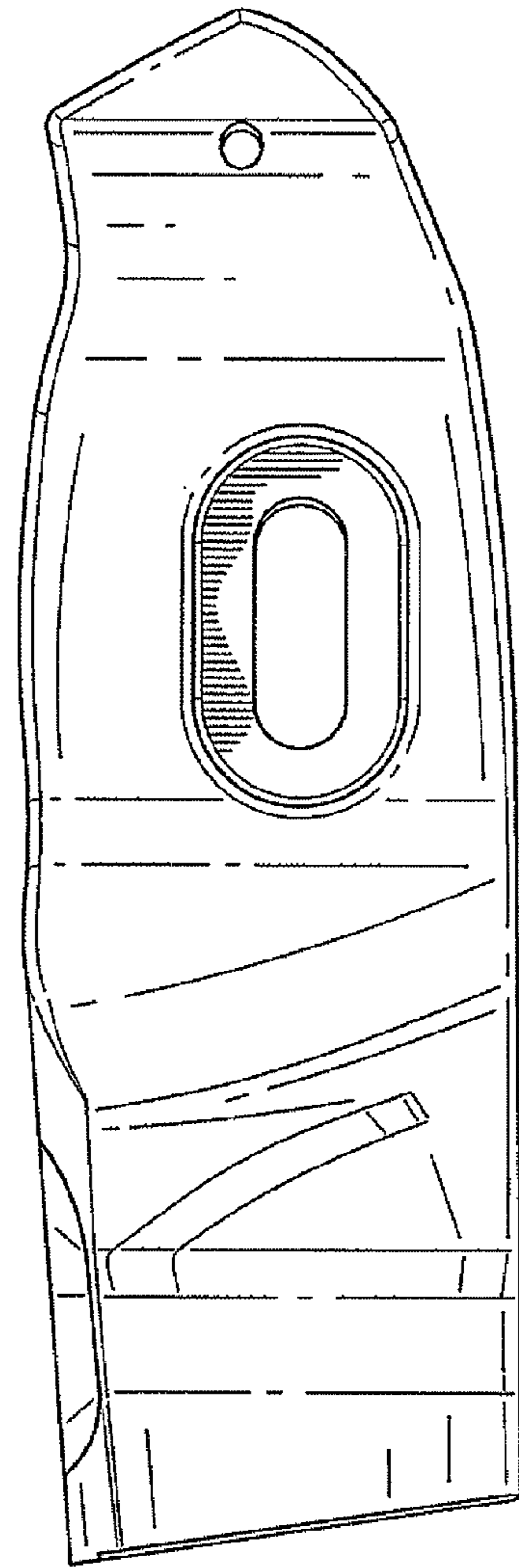

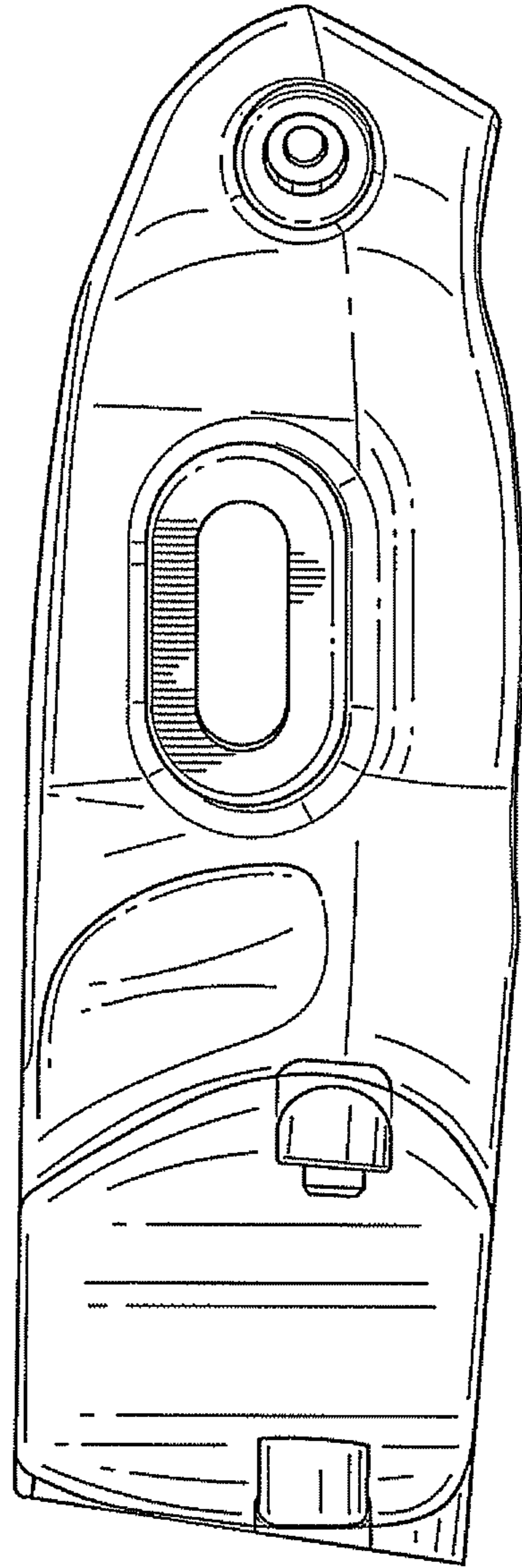

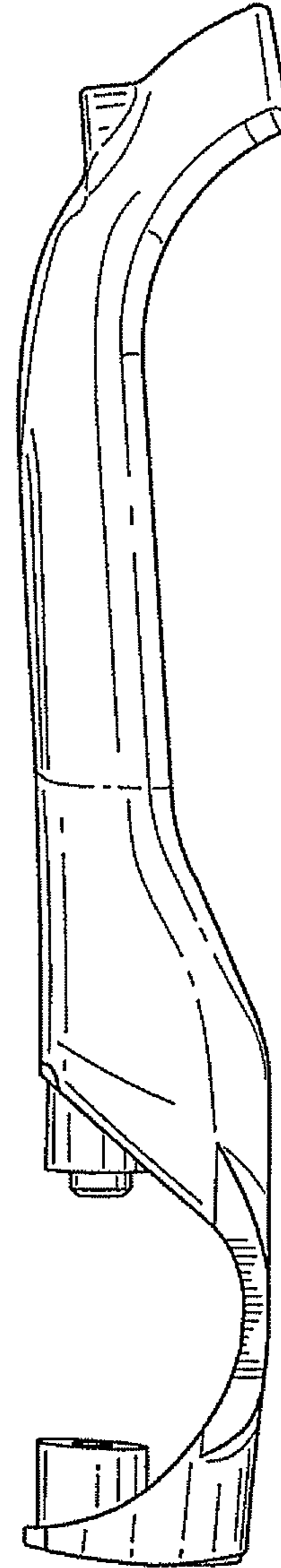

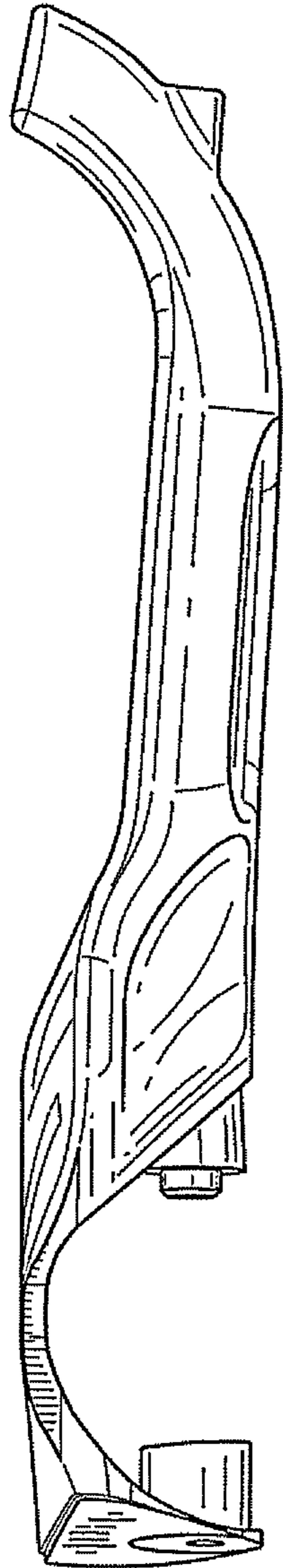

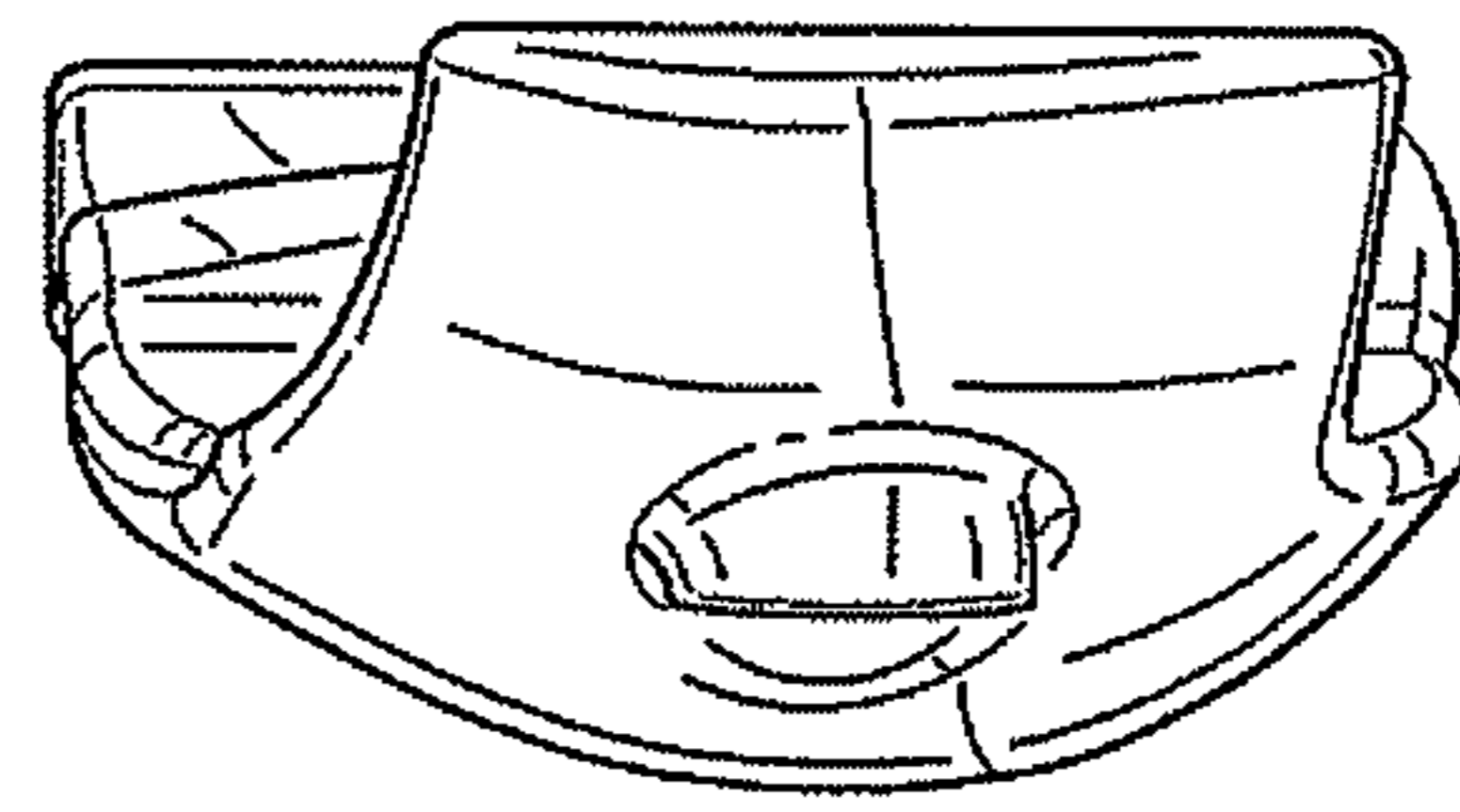

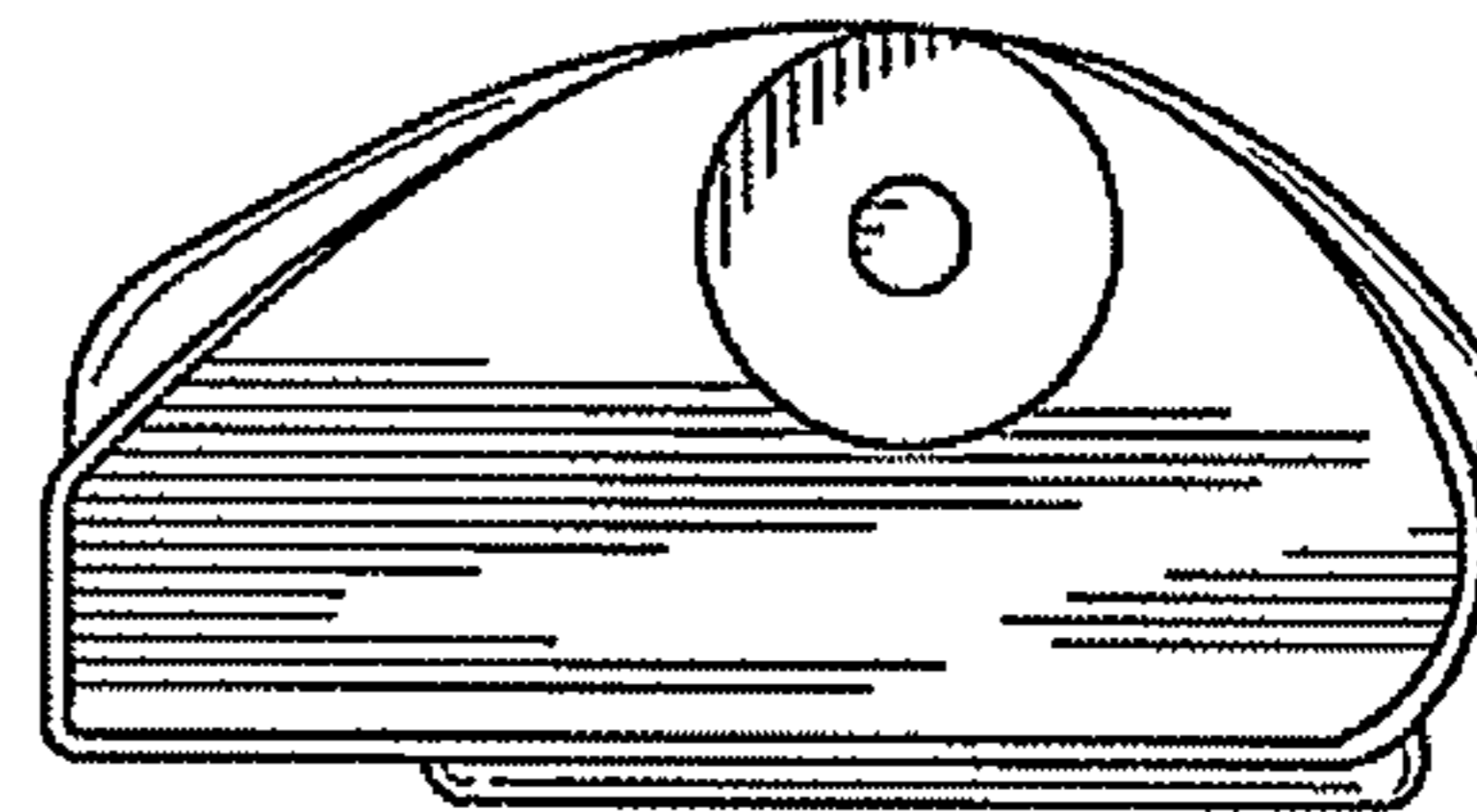
