FIG. 4 is a side elevation view thereof;

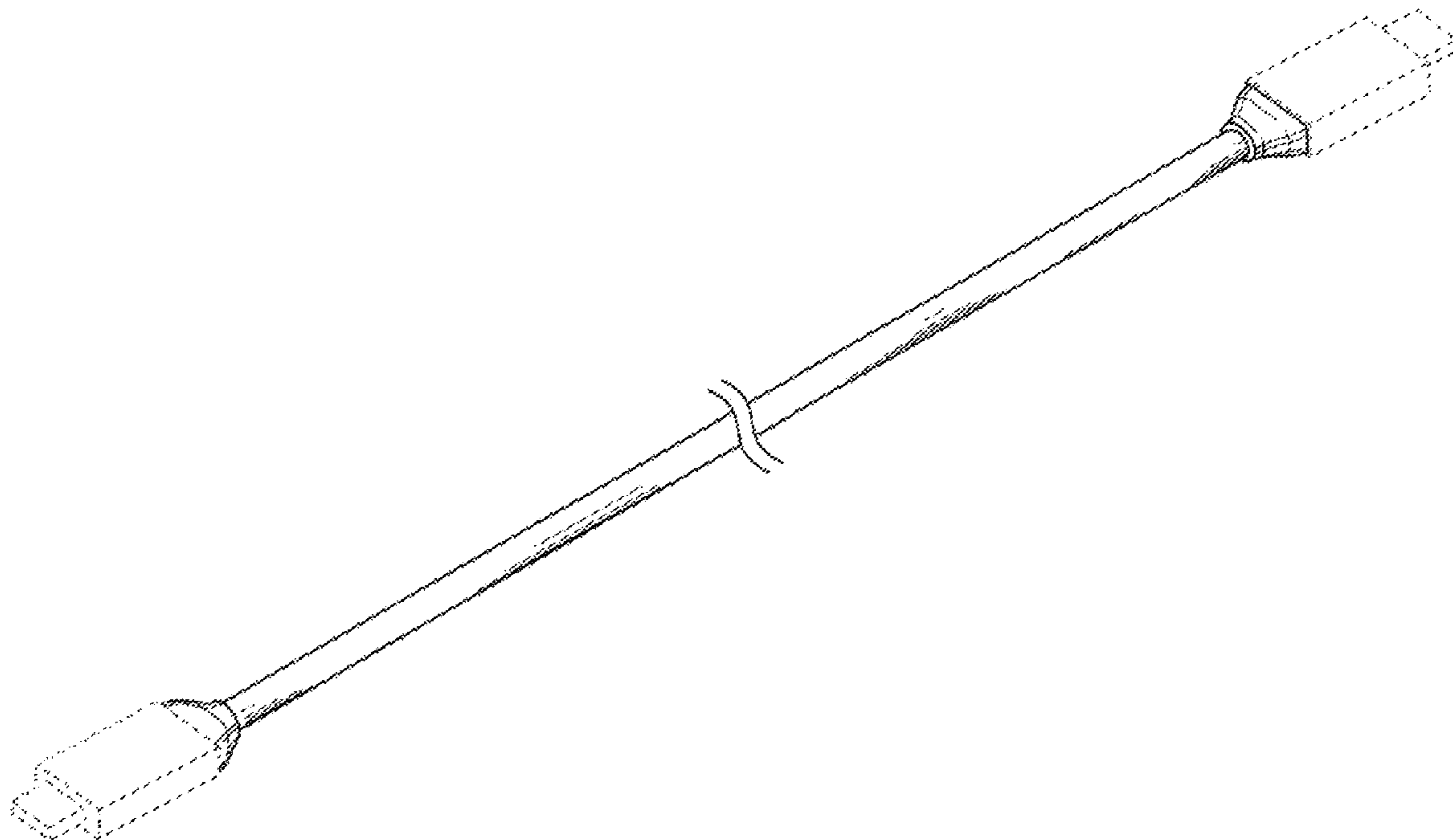
FIG. 5 is another side elevation view thereof;

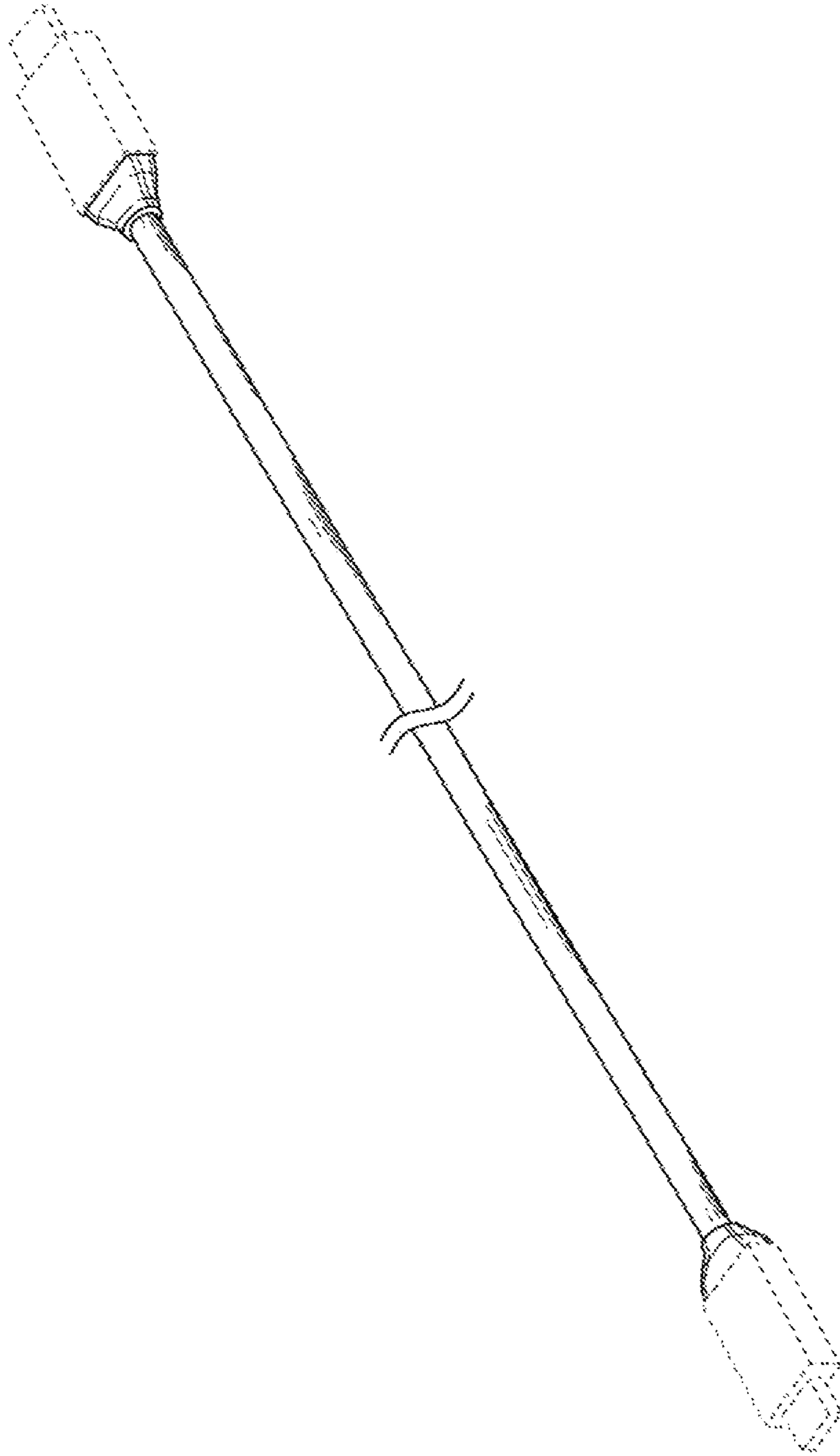

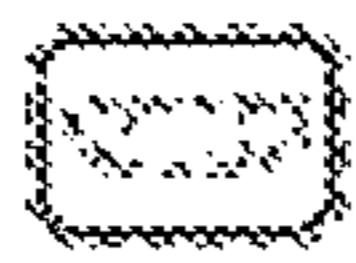

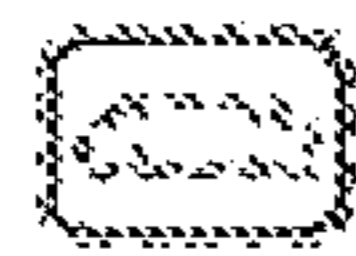

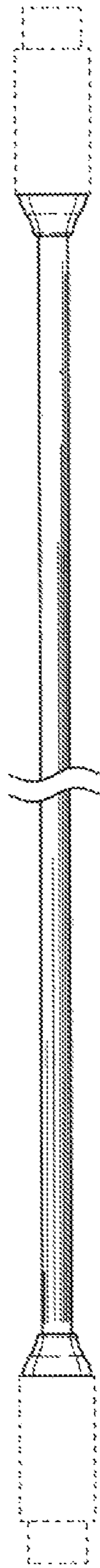

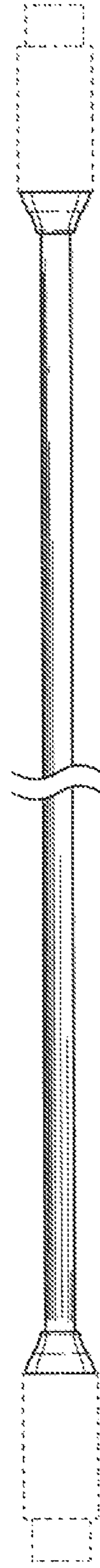
