DESCRIPTION

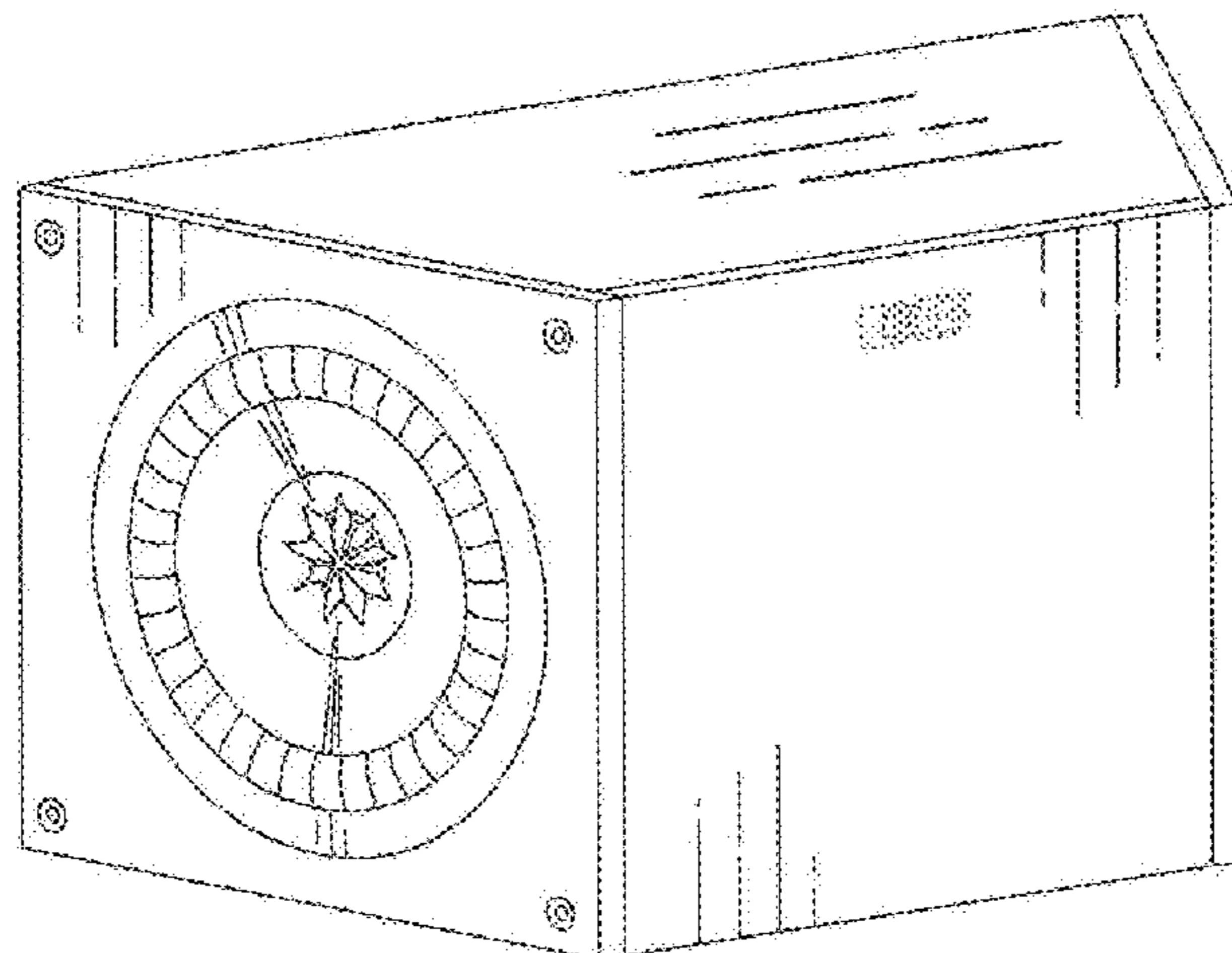
FIG. 1 is a front view of a loudspeaker showing our new design;

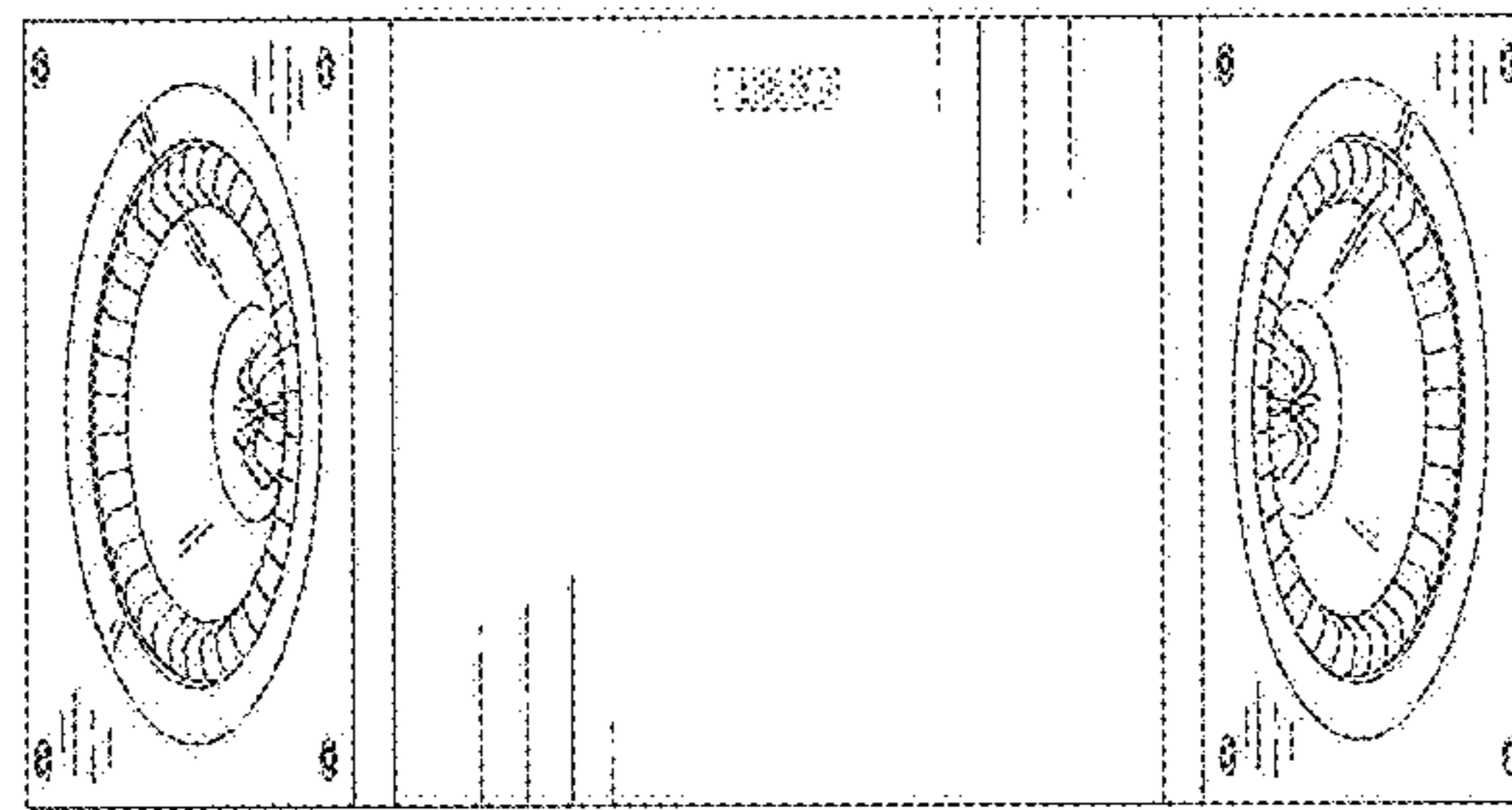

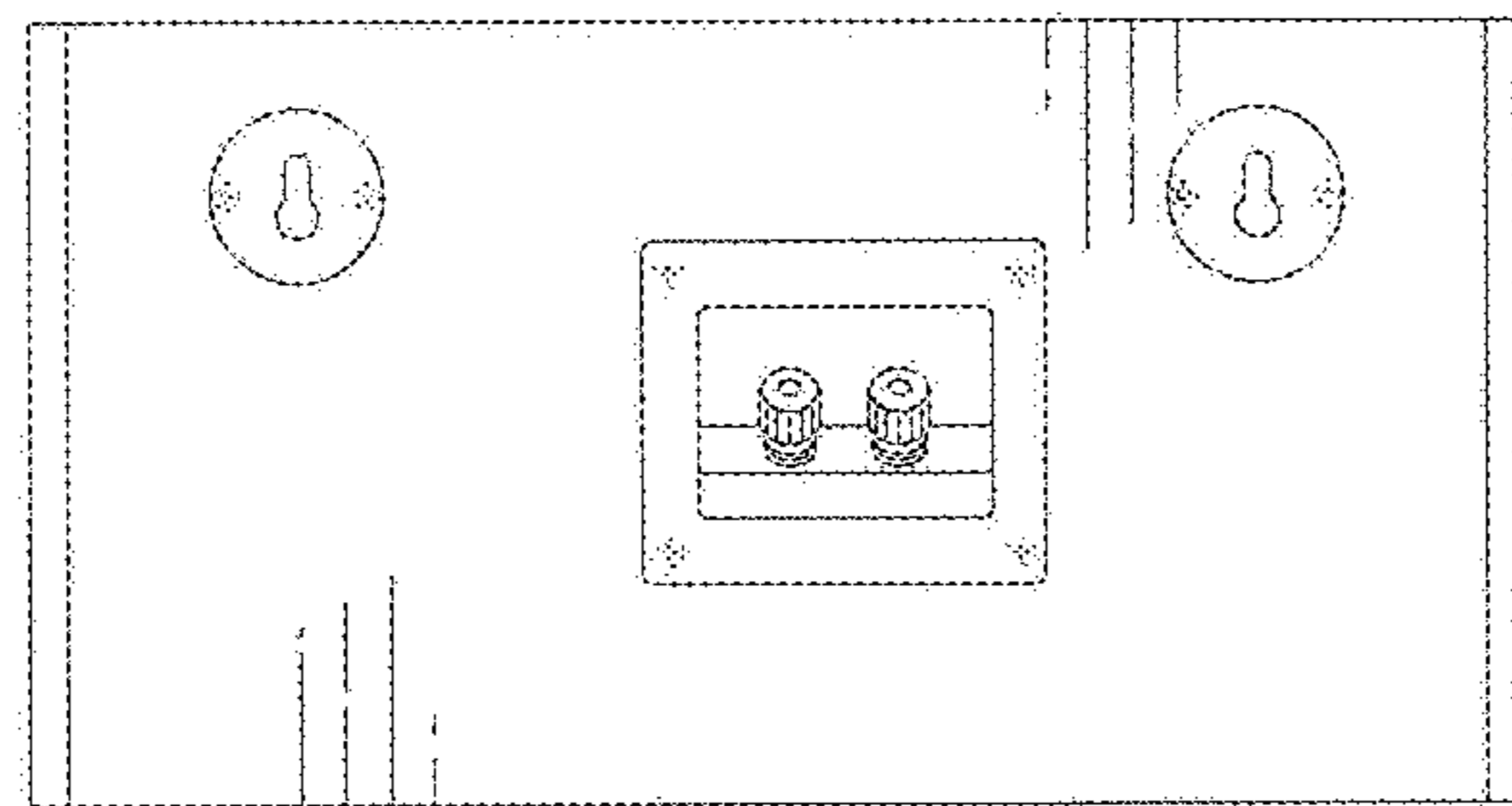

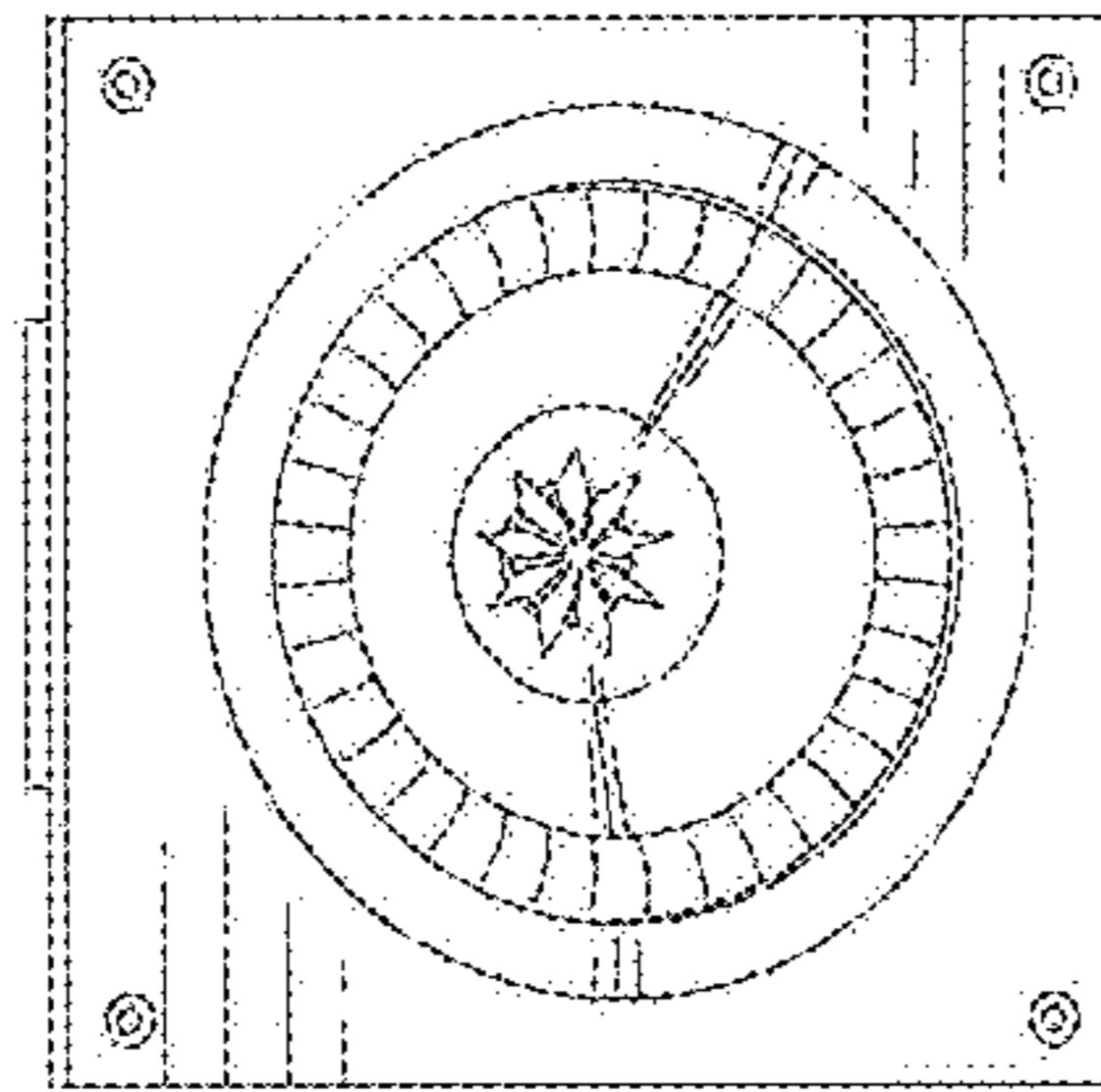

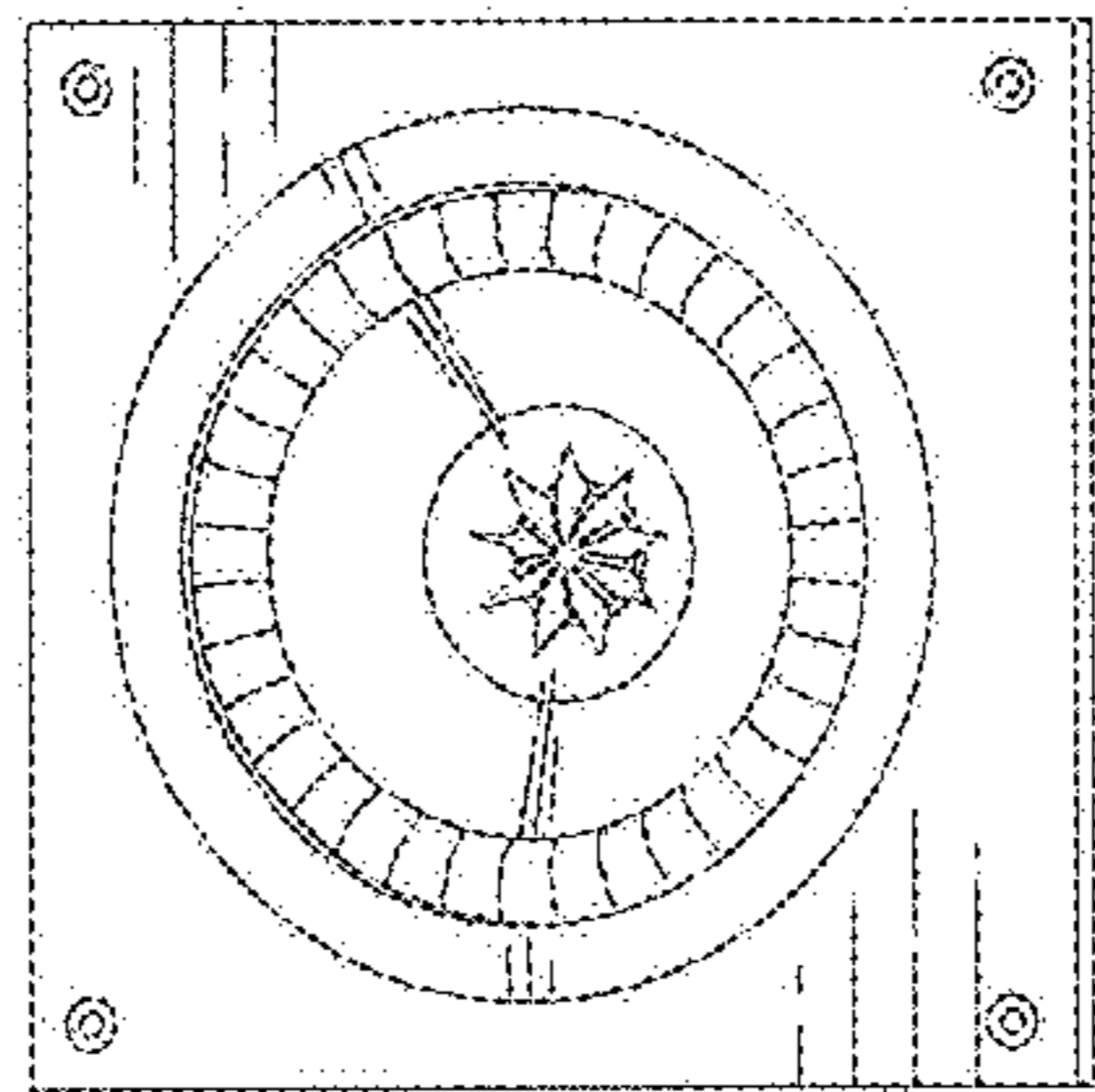

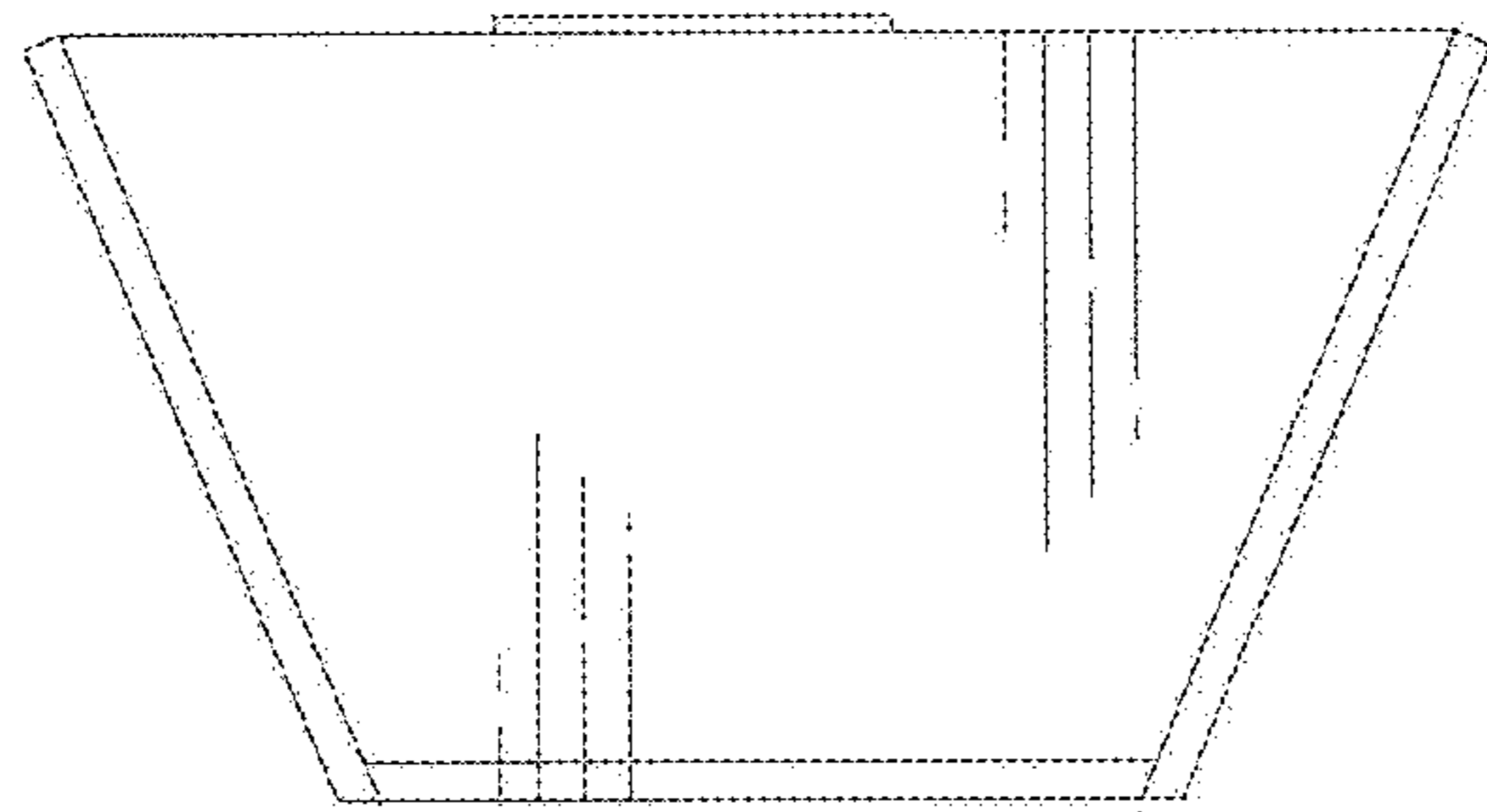

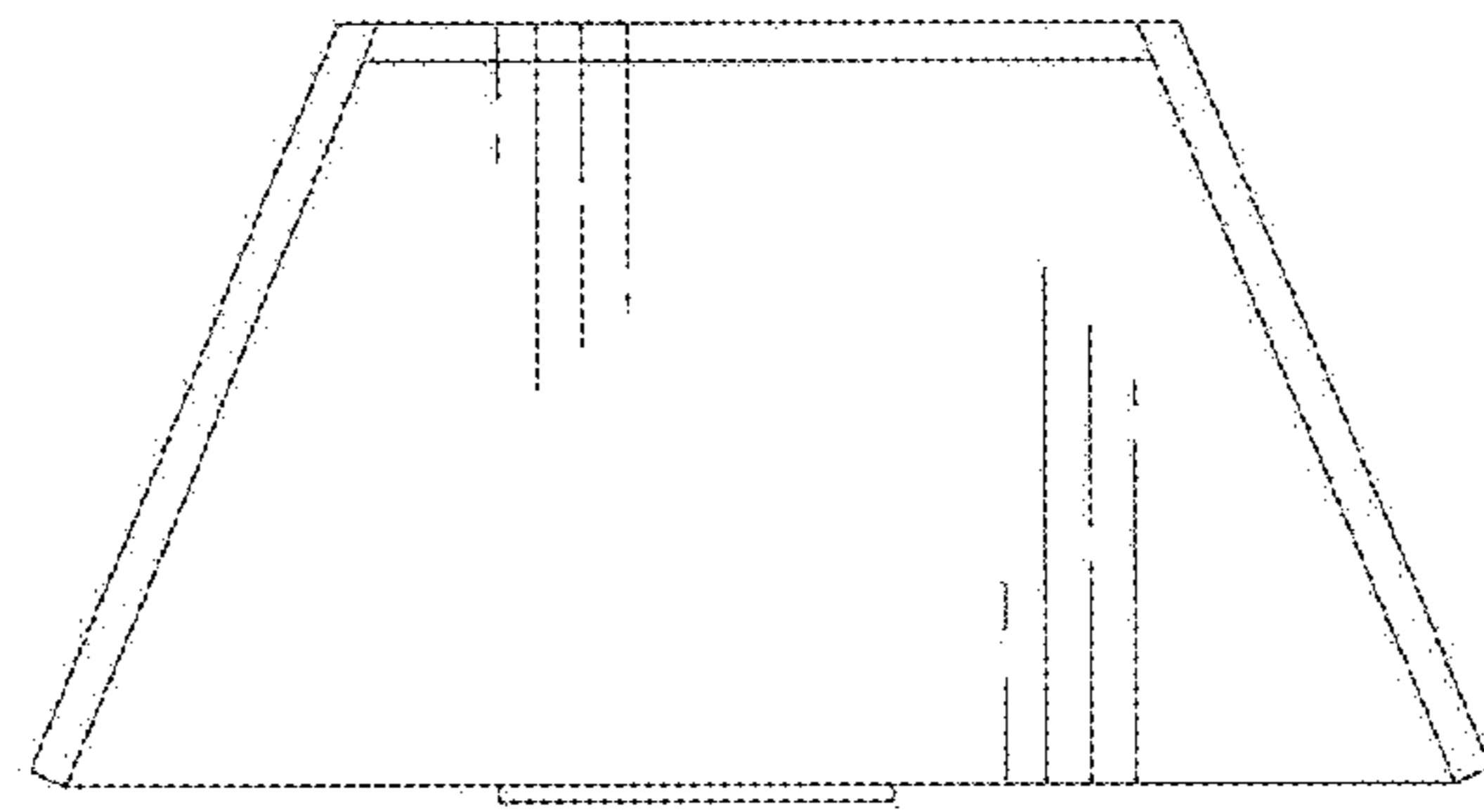

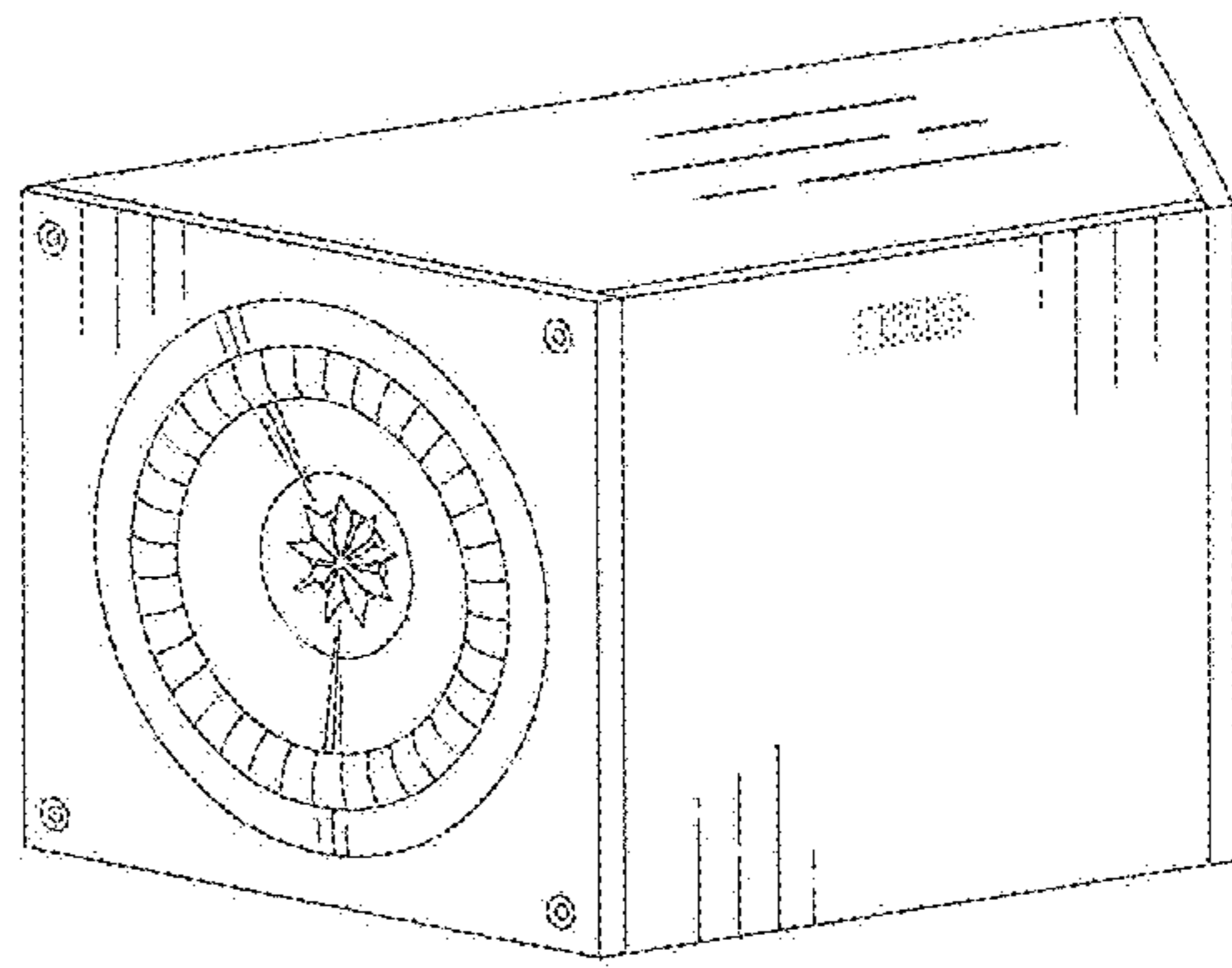

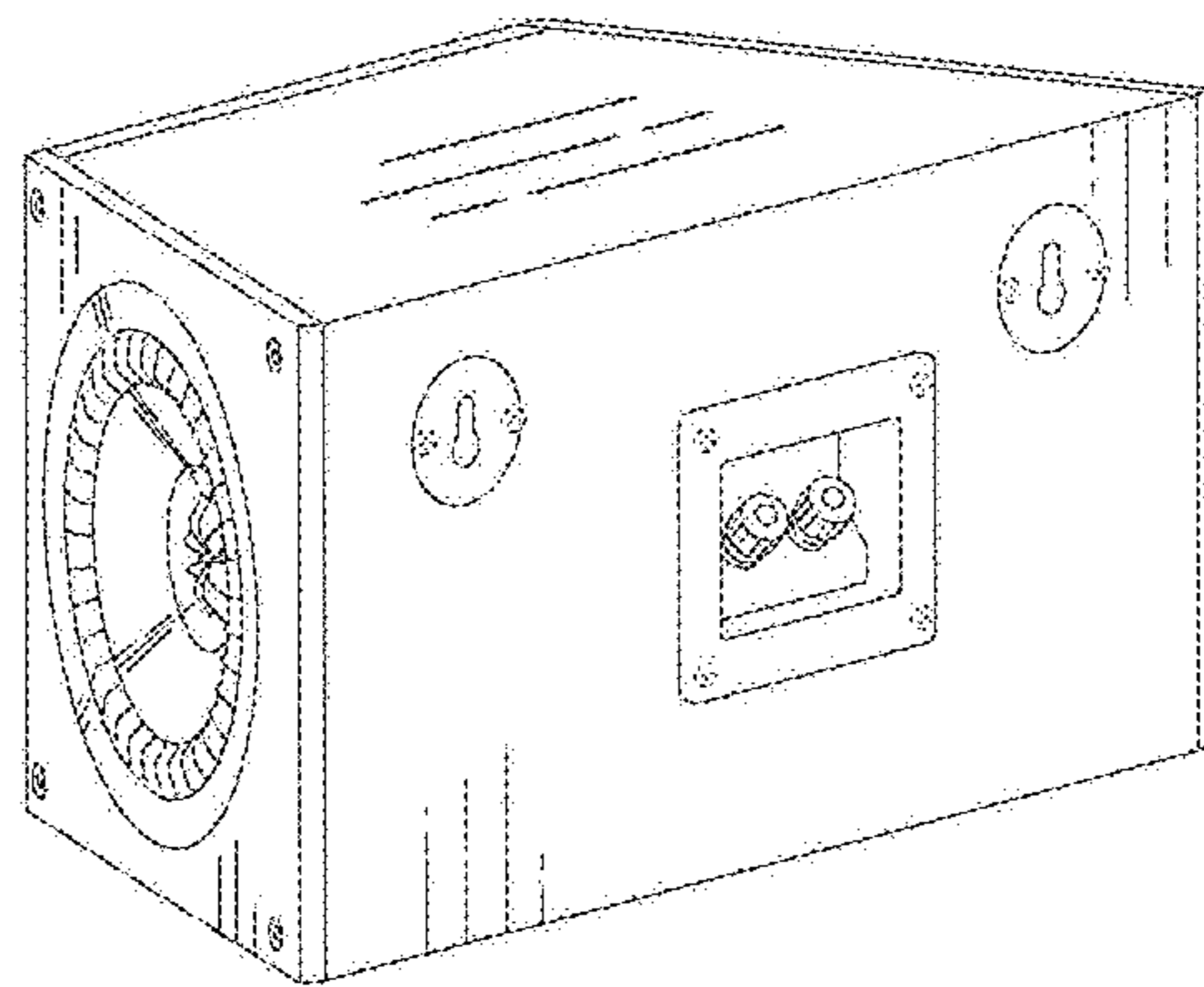
