(57) **CLAIM**
The ornamental design for a helmet insignia display, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the helmet insignia display showing my new design inserted into a helmet bracket environment;

FIG. 2 is a front perspective view of the detached helmet insignia display showing my new design;

FIG. 3 is top view of the helmet insignia display thereof;

FIG. 4 is a front view of the helmet insignia display thereof;

FIG. 5 is a left side view of the helmet insignia display thereof, the right side view of the detached helmet insignia display is identical;

FIG. 6 is a rear view of the helmet insignia display thereof; and,

FIG. 7 is a bottom view of the helmet insignia display thereof.

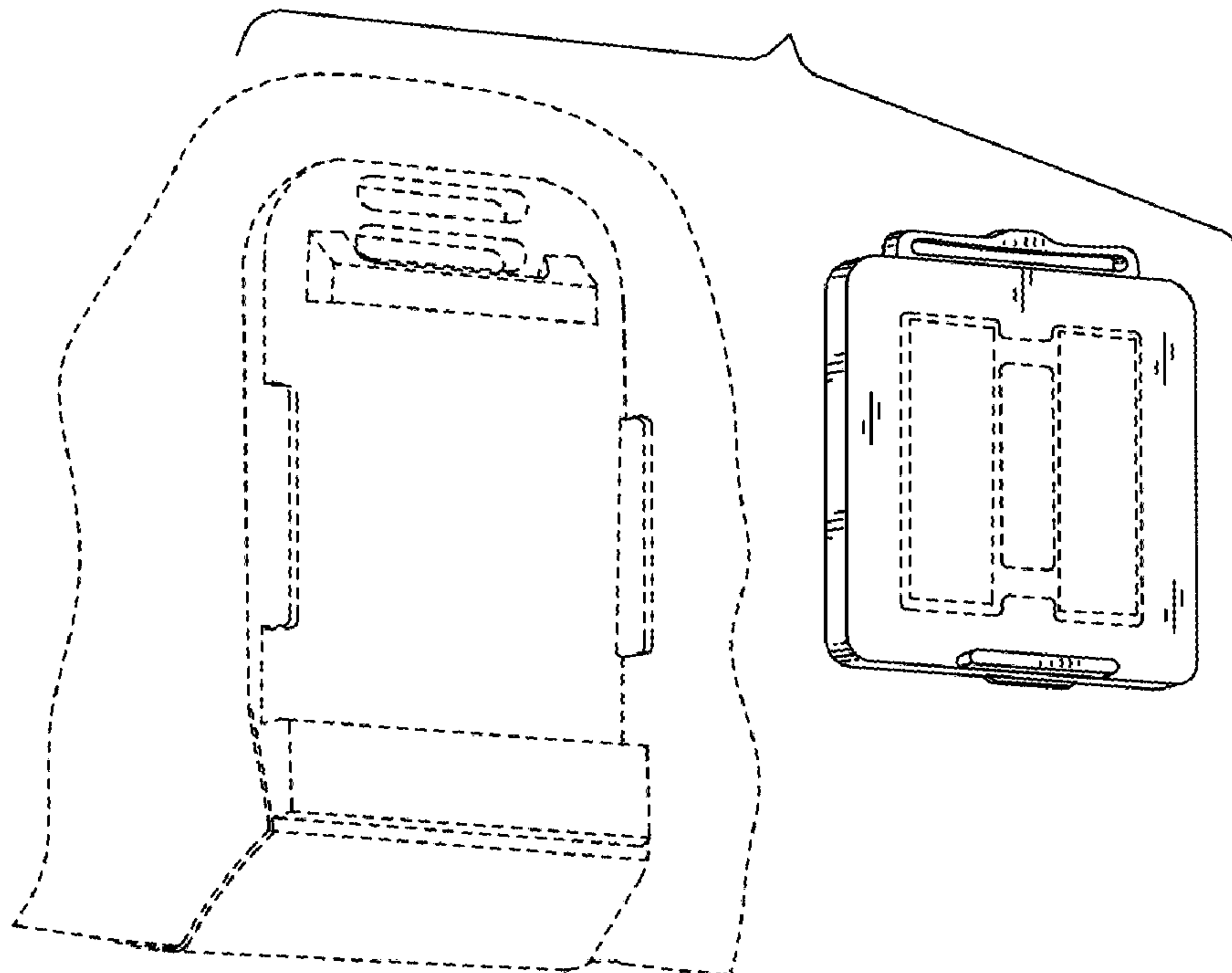
The broken lines in FIGS. 1, 2, 4 and 6 are for illustrative purposes only and form no part of the claimed design.

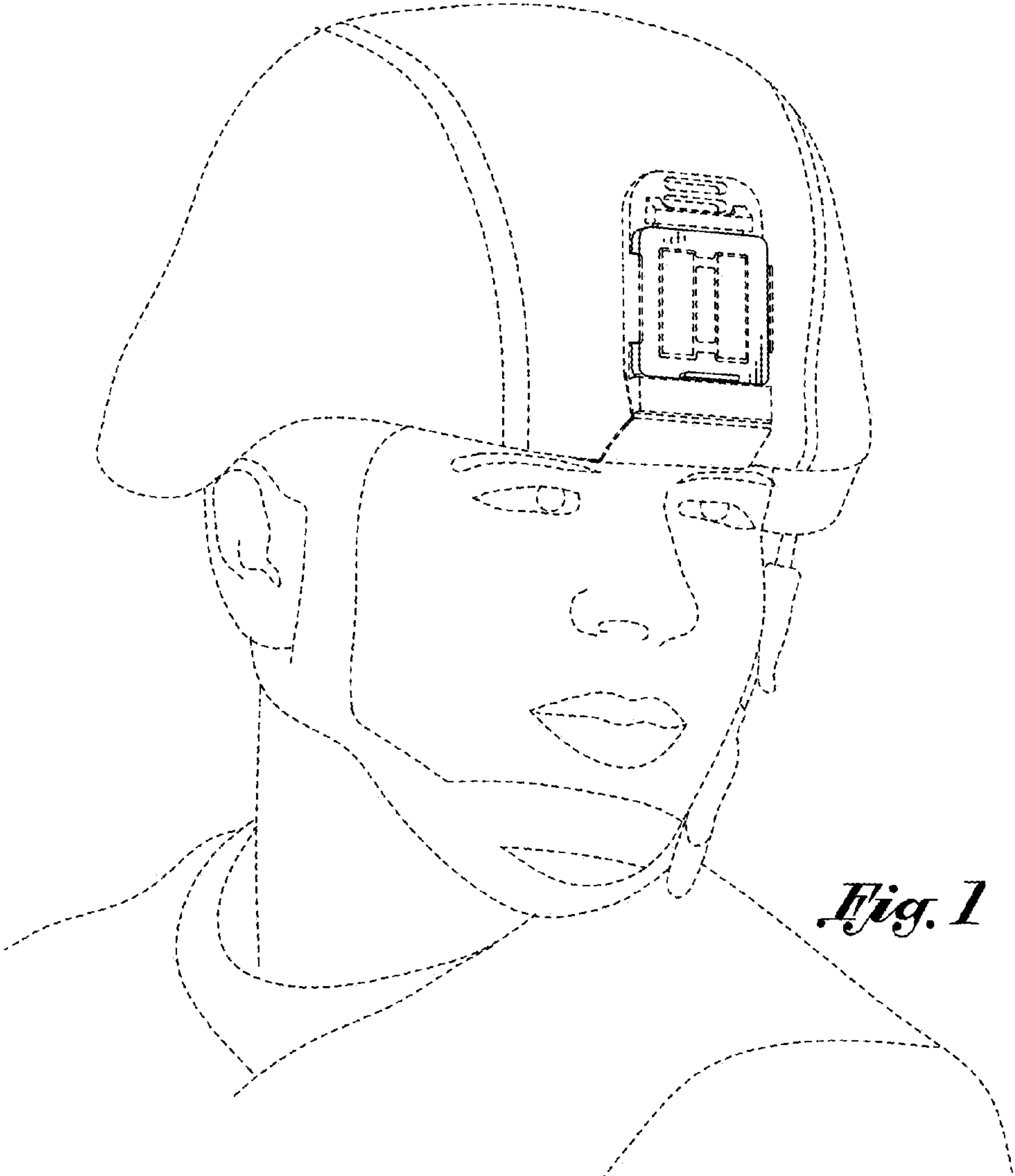

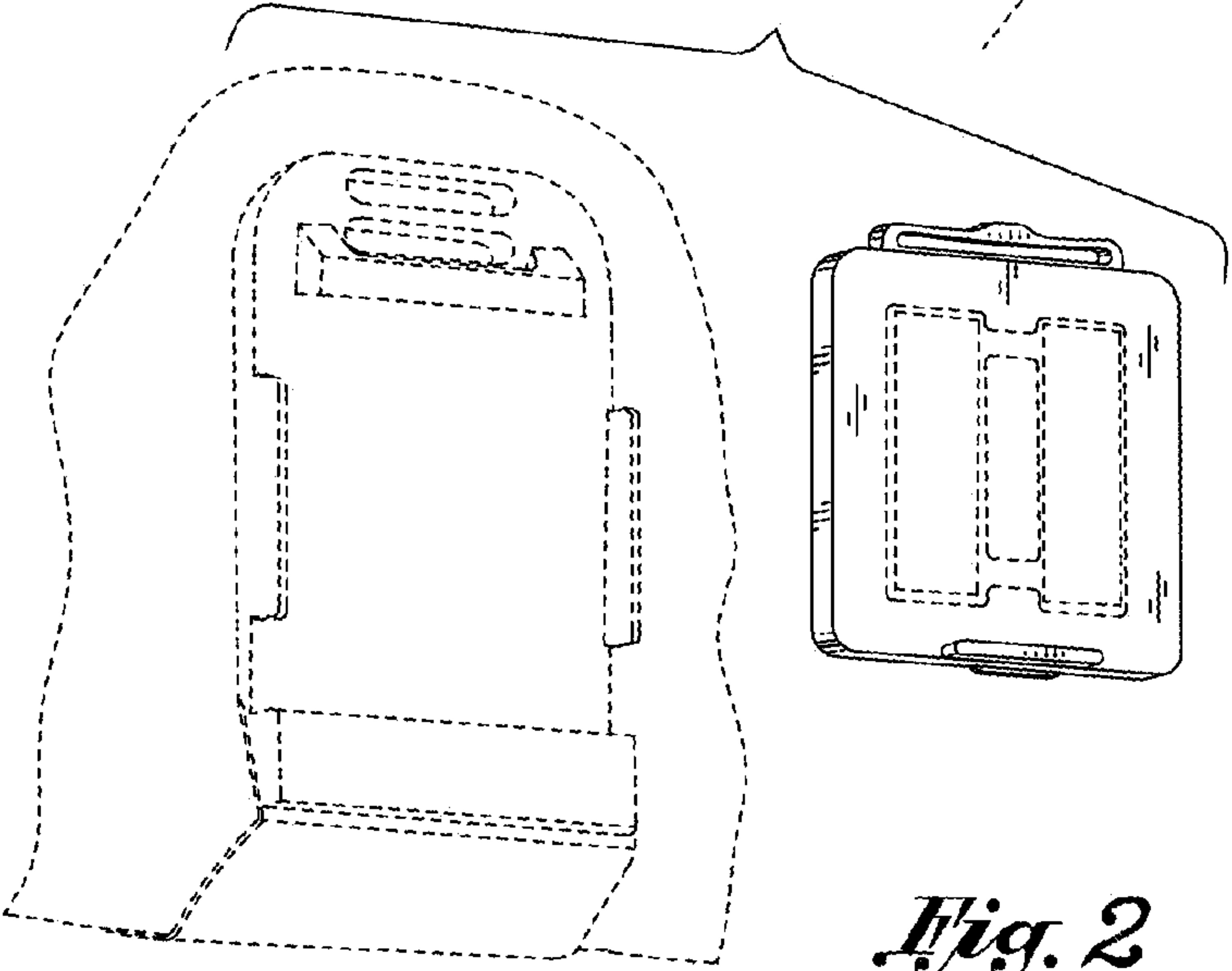

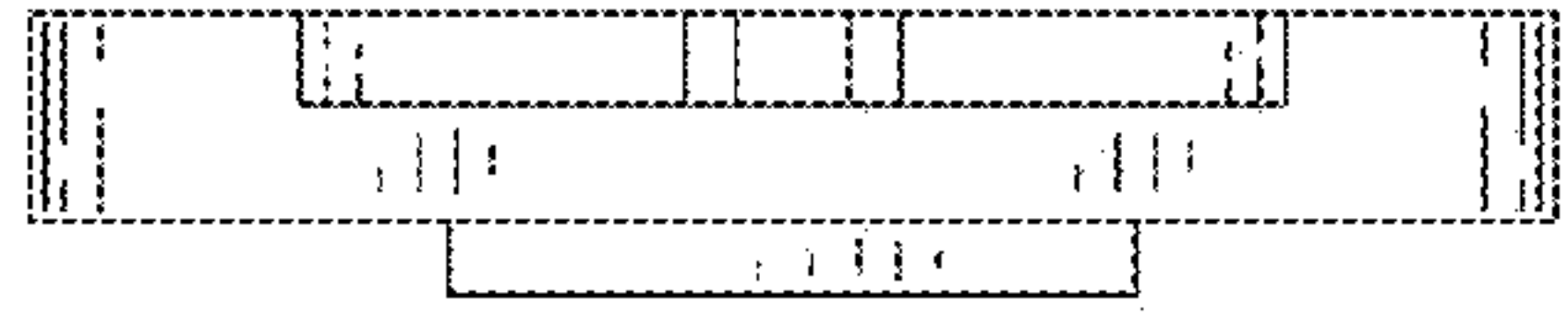

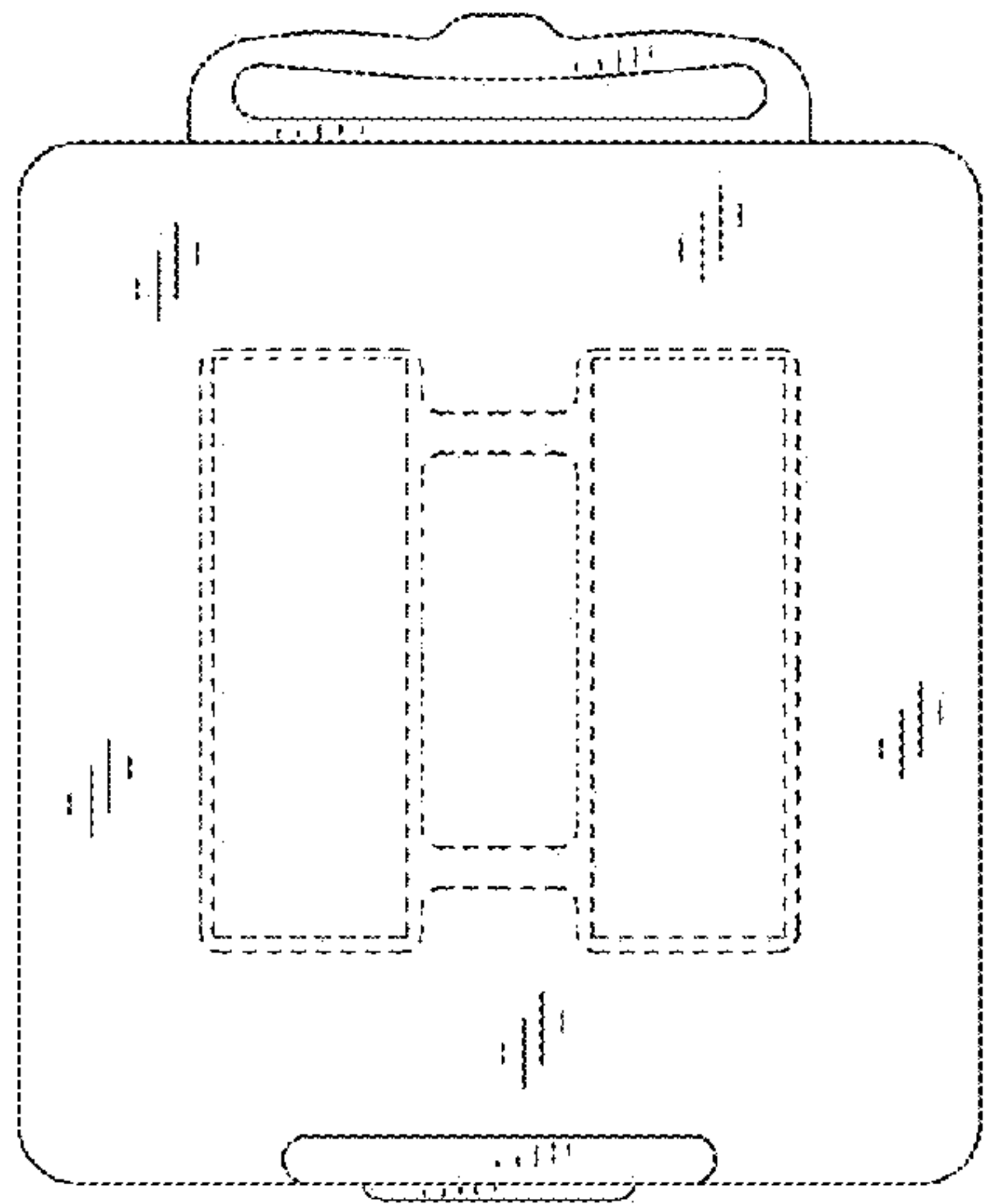

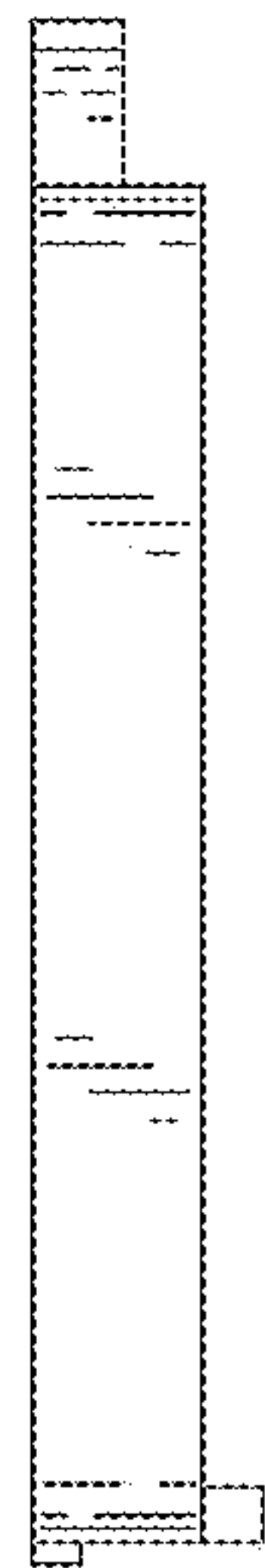

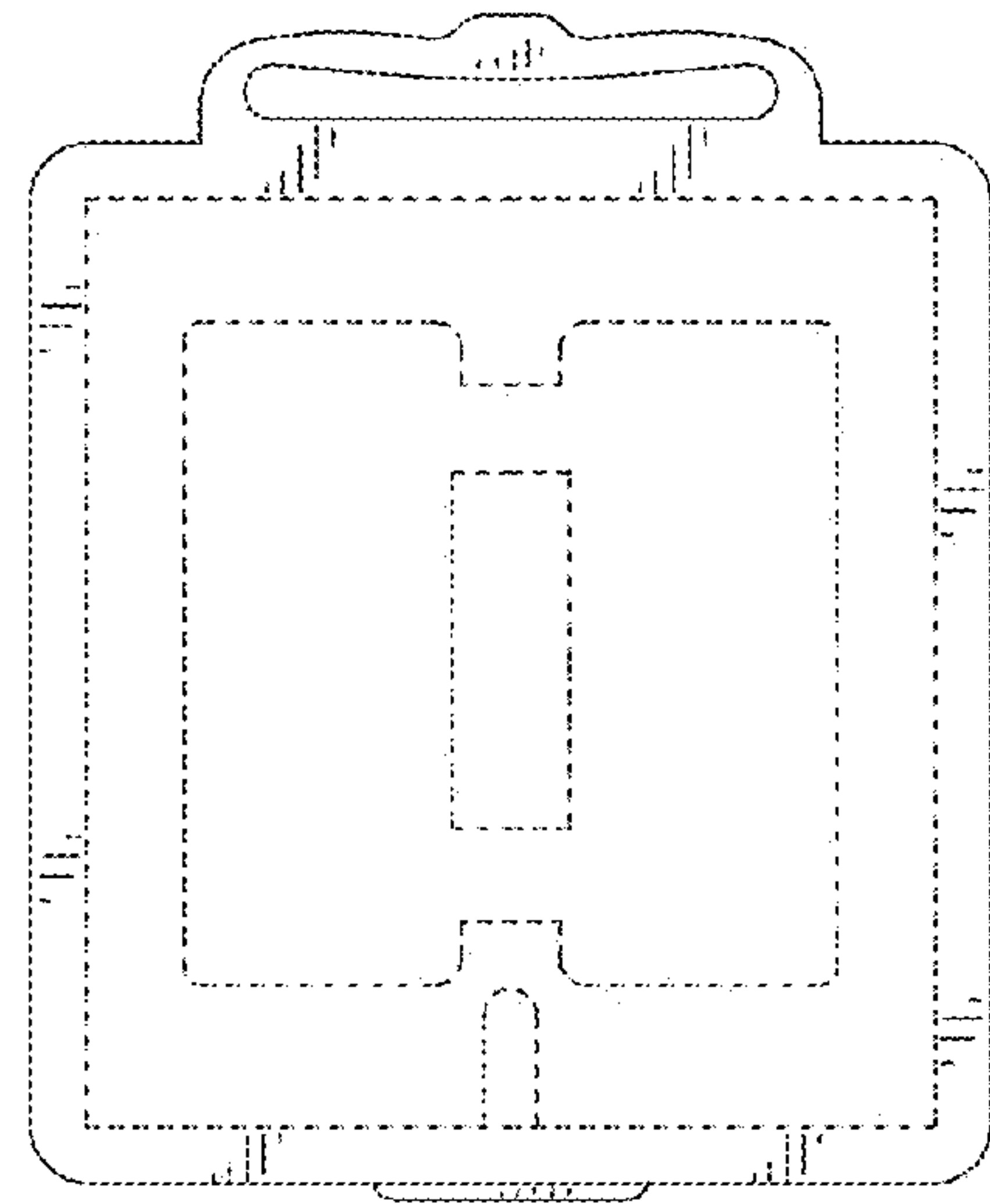
