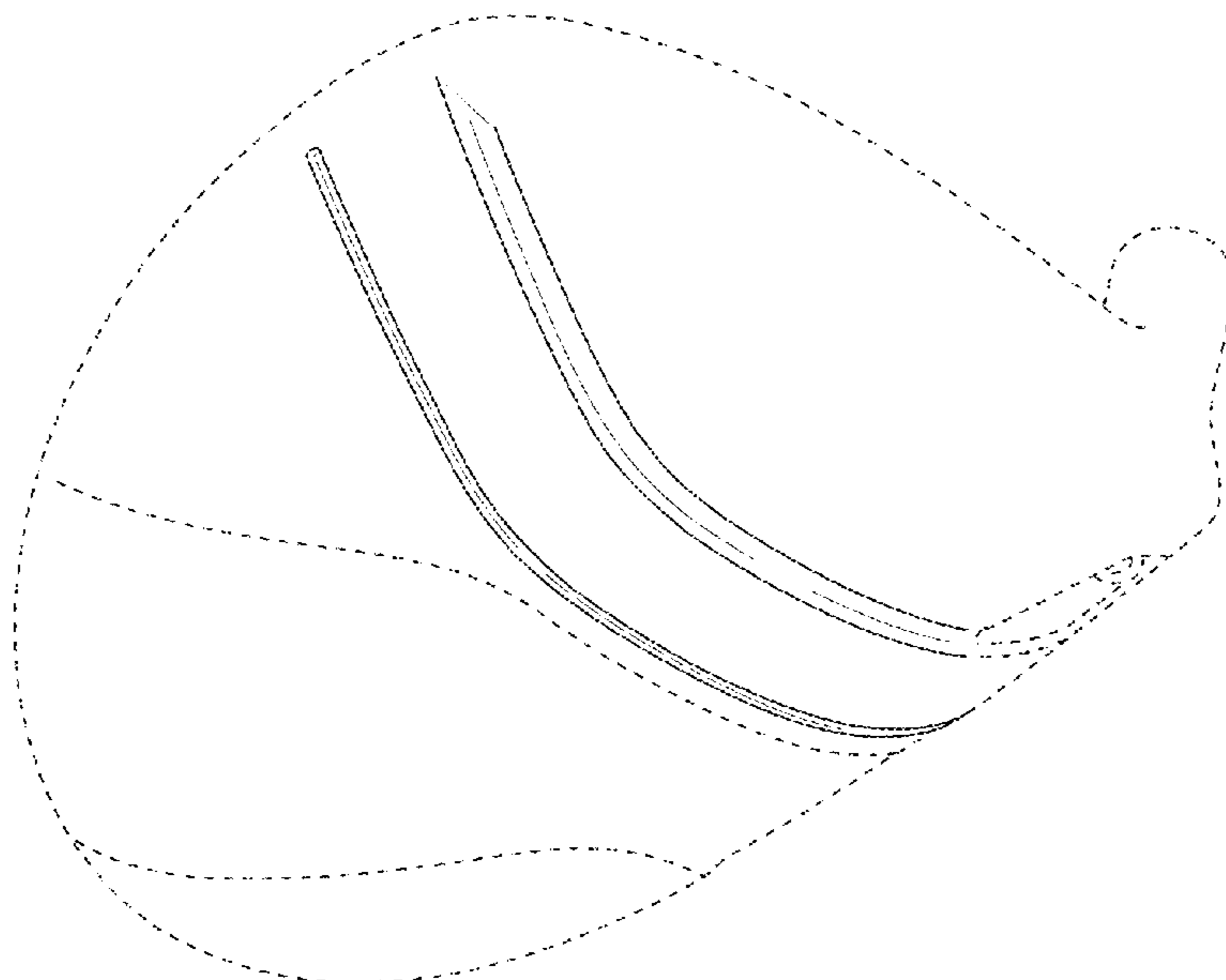

FIG. 1;

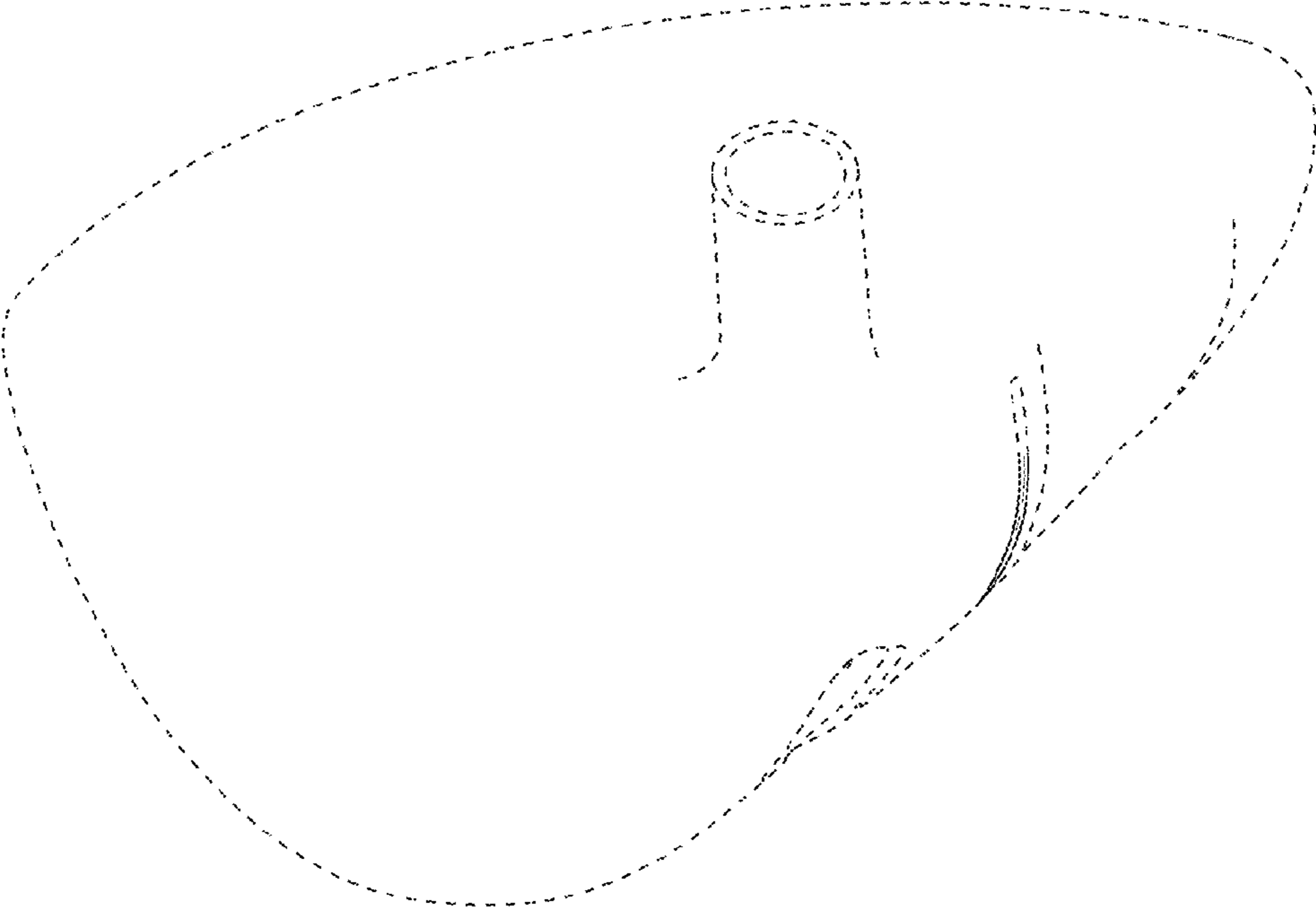
FIG. 7 illustrates a left side view of the golf club head of FIG.

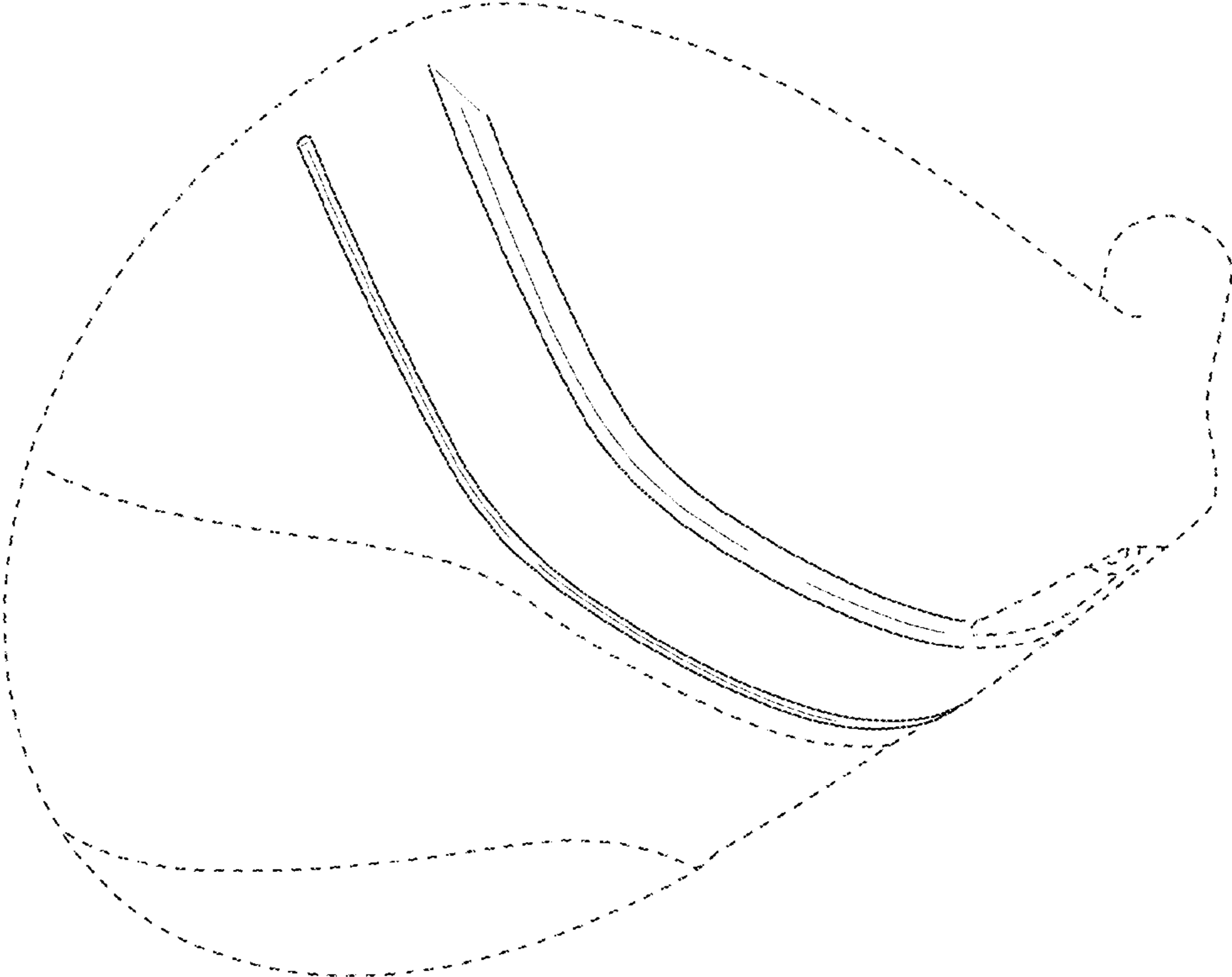
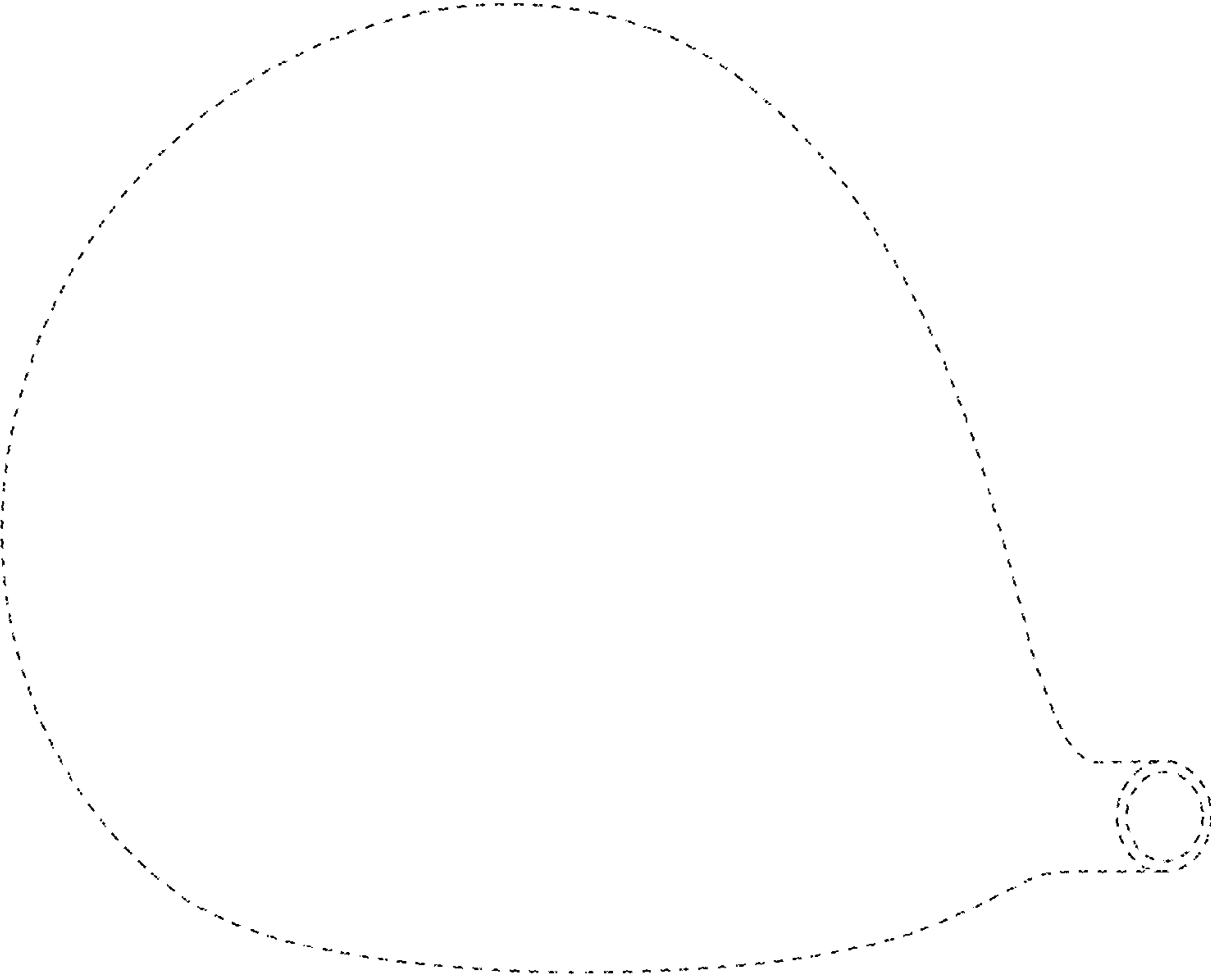
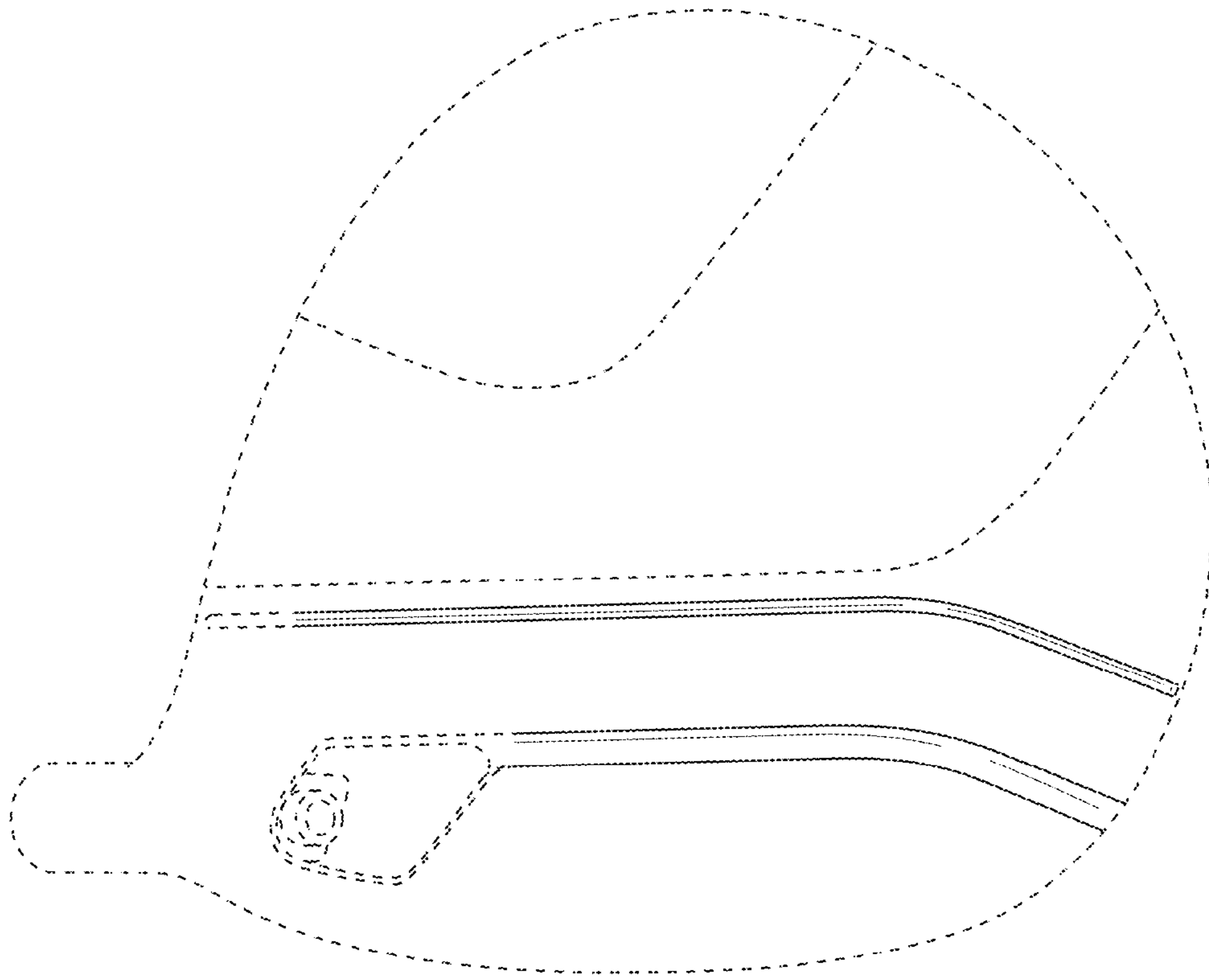


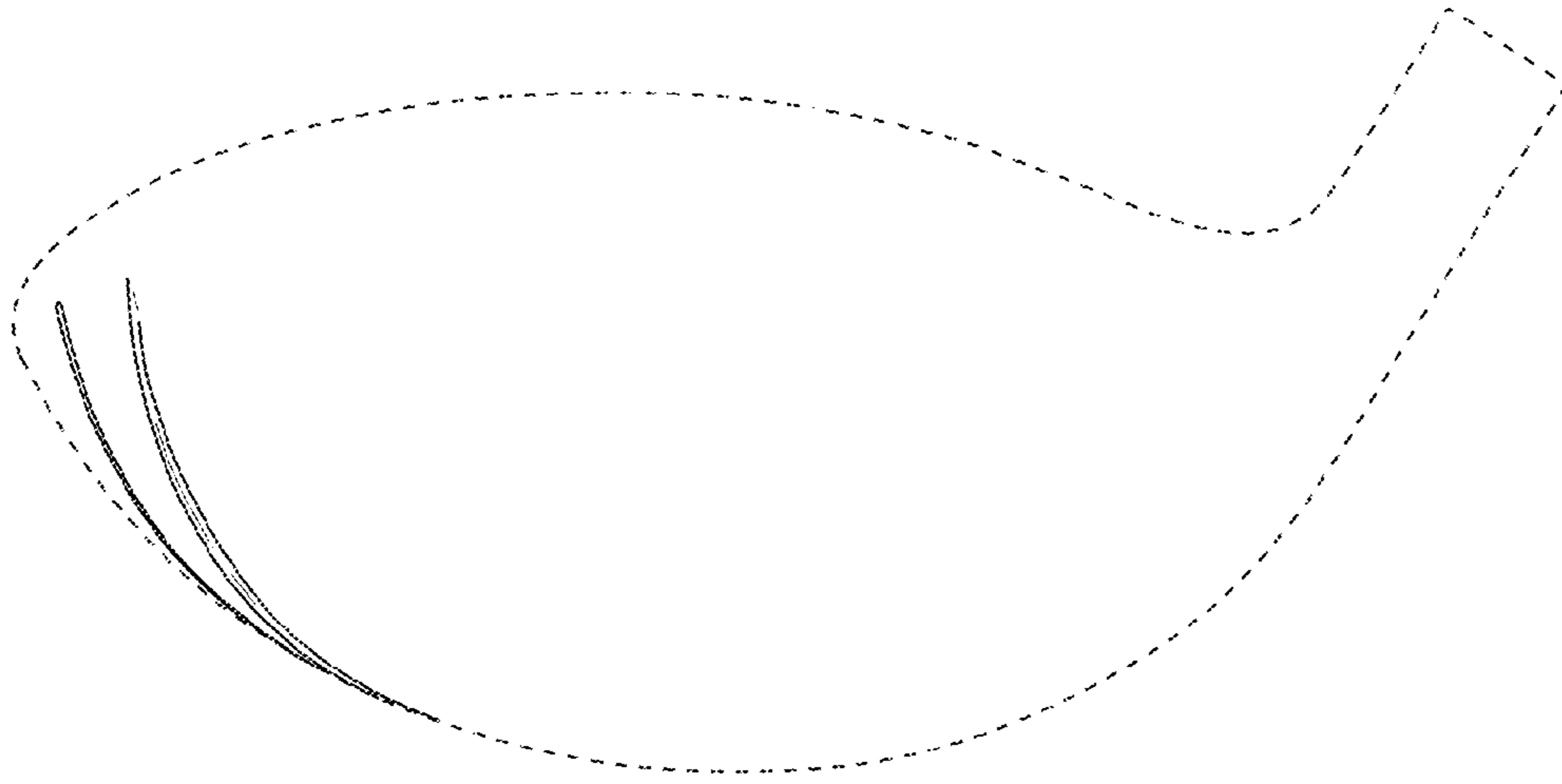

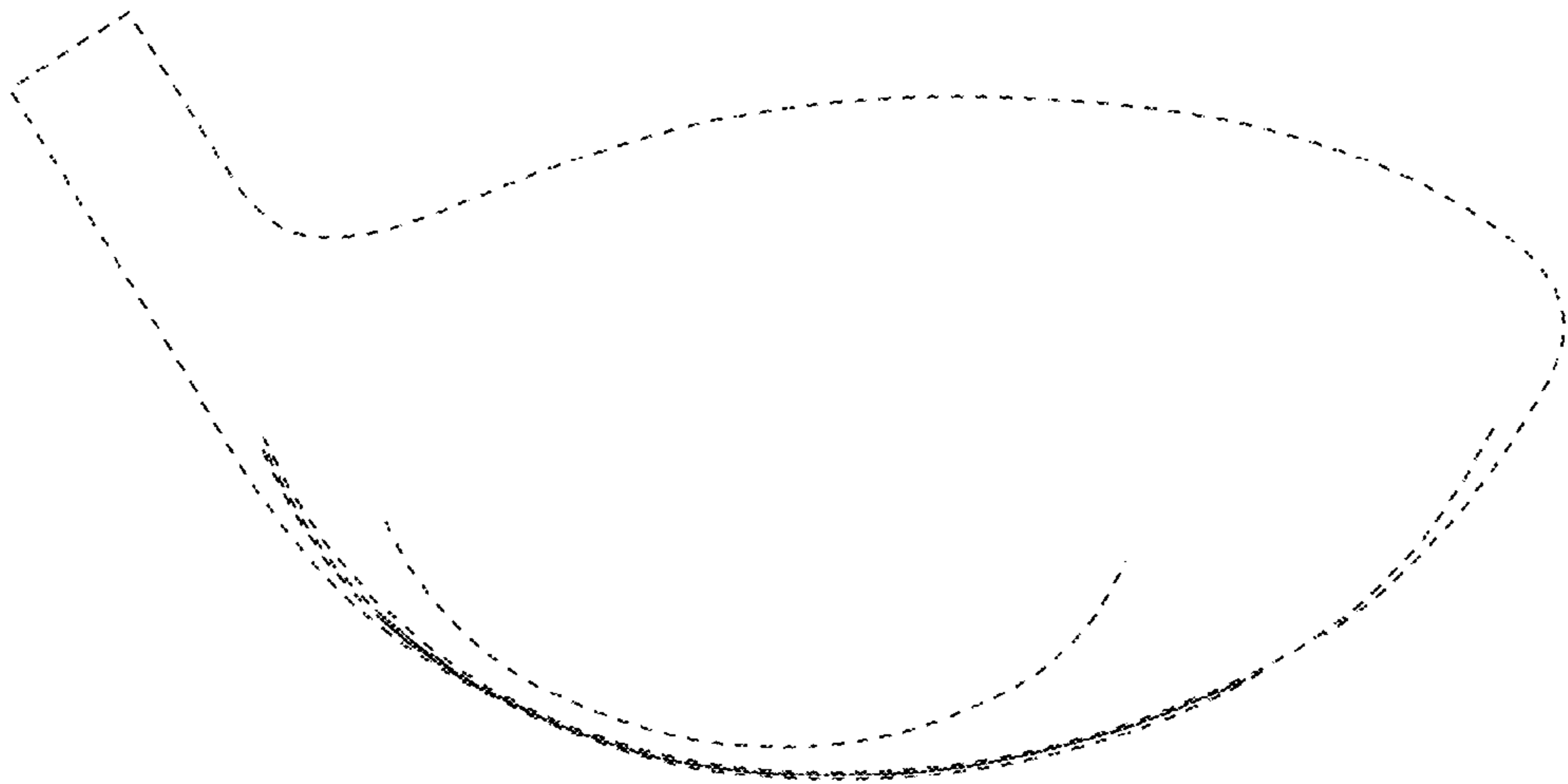

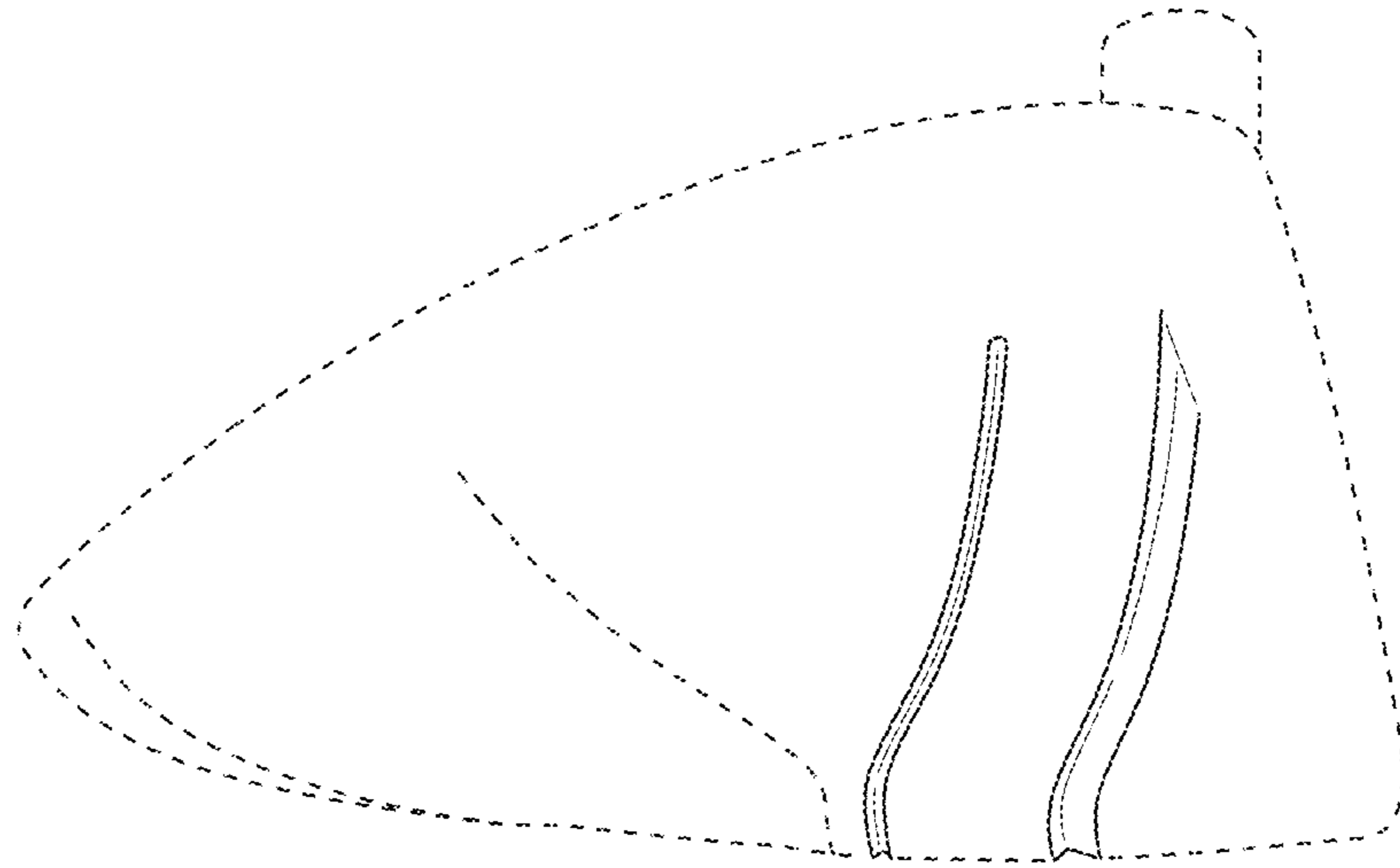

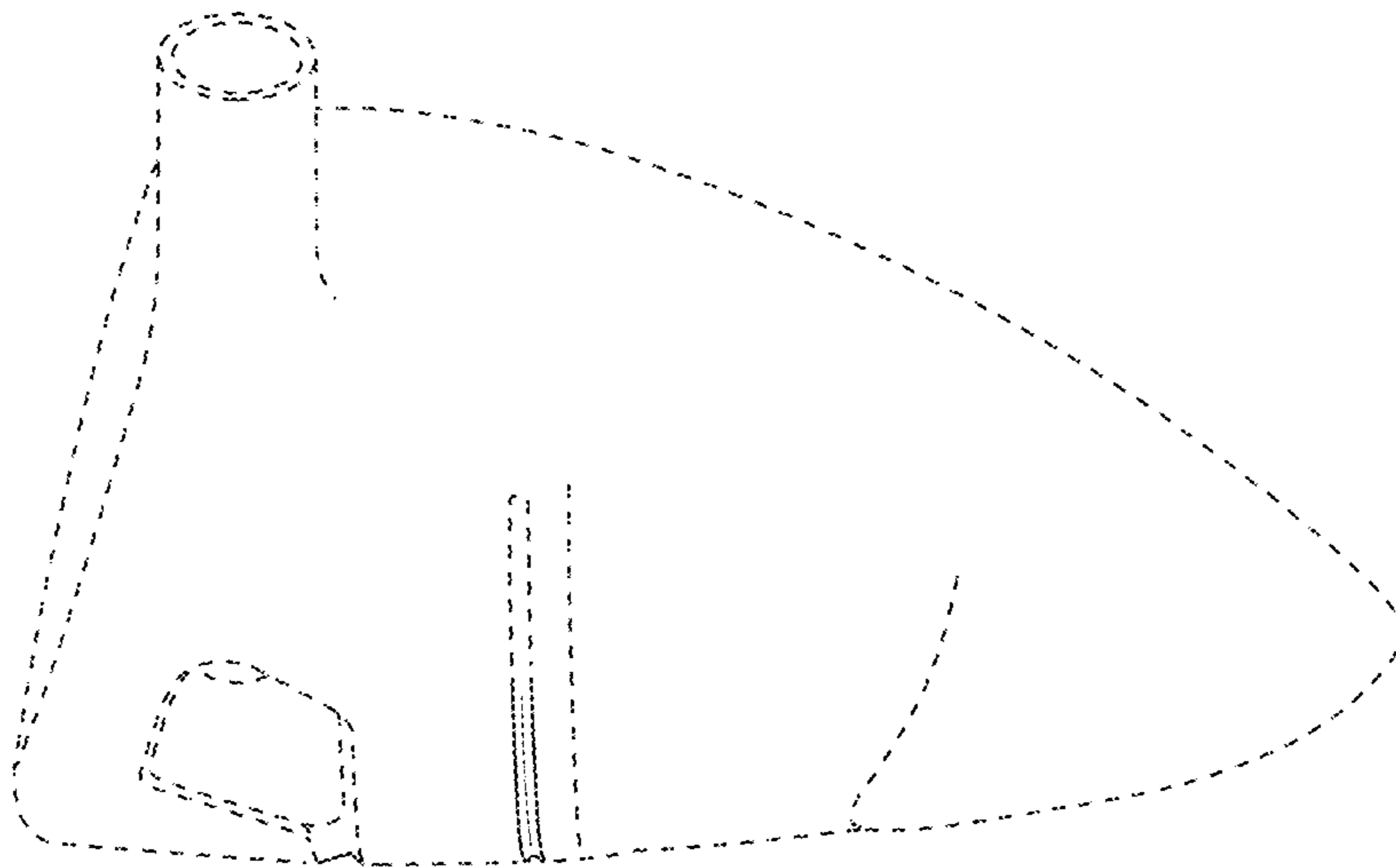
