The ornamental design for a surgical nail, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a surgical nail showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a top, front, left side perspective view of a second embodiment thereof;

FIG. 9 is a front elevational view of the design shown in FIG. 8;

FIG. 10 is a rear elevational view thereof;

FIG. 11 is a left side elevational view thereof;

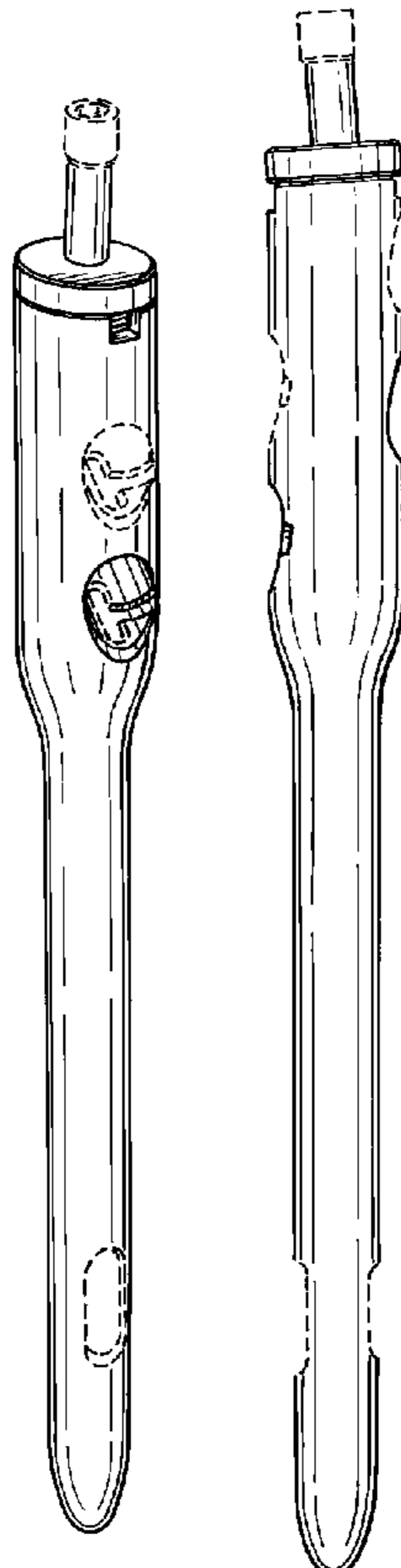
FIG. 12 is a right side elevational view thereof;

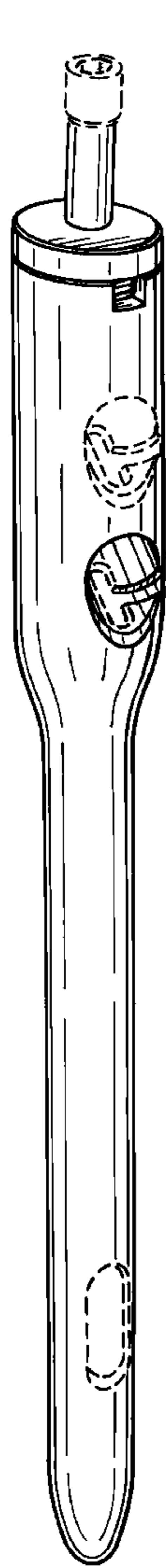

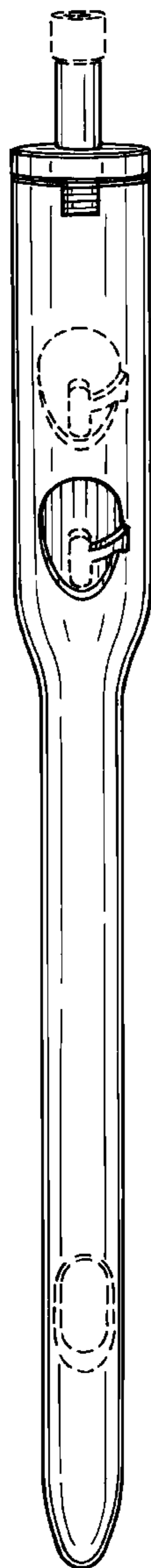

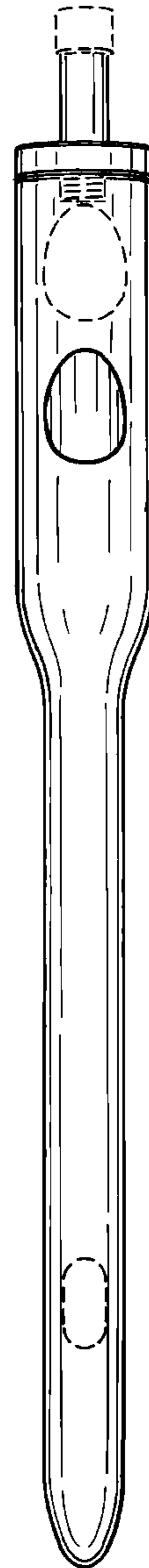

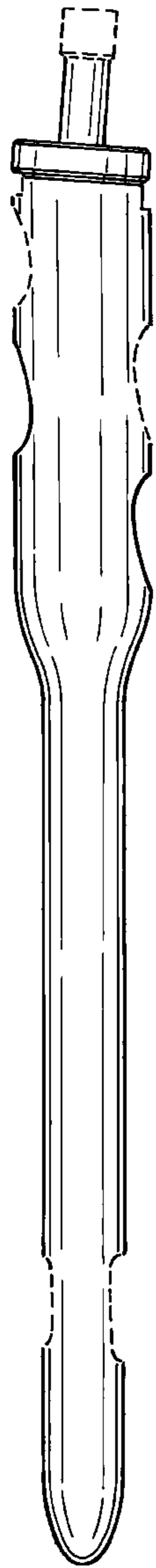

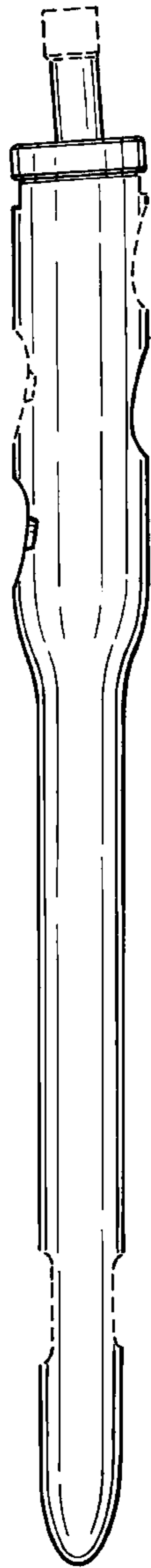

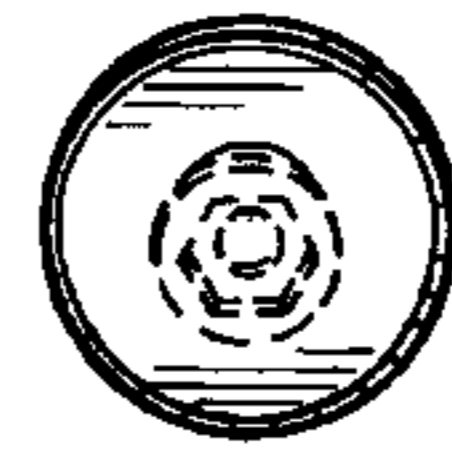

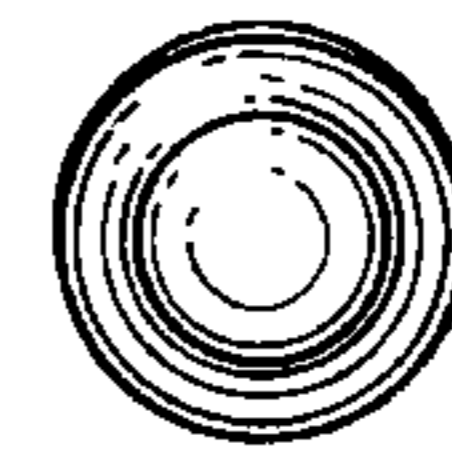

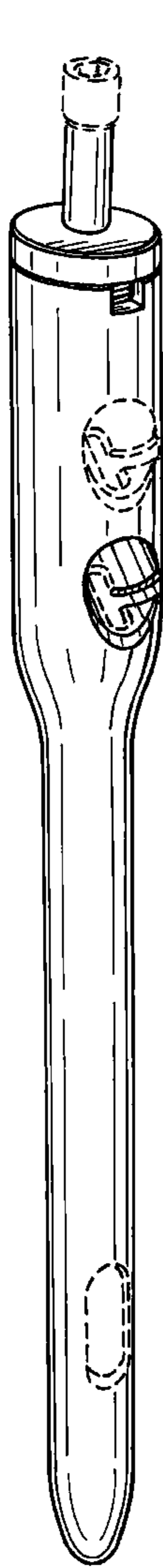

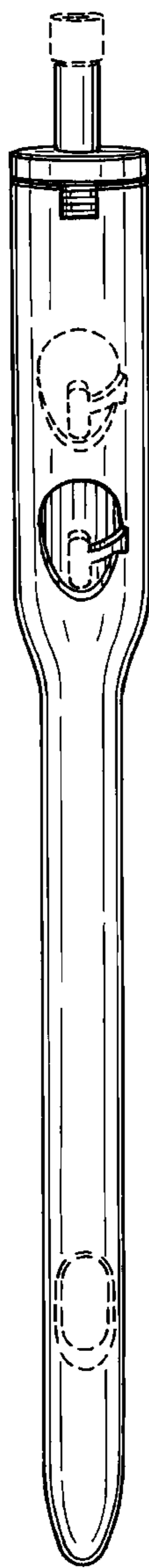

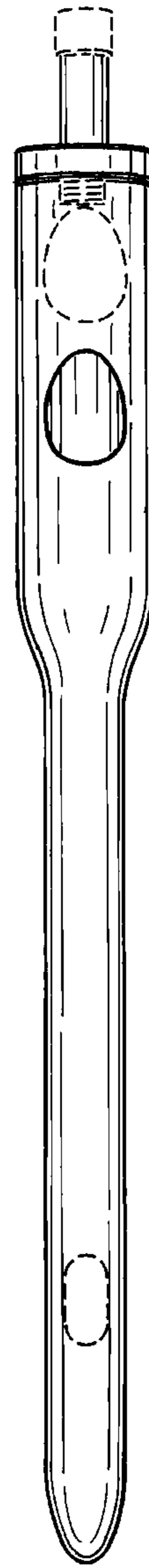

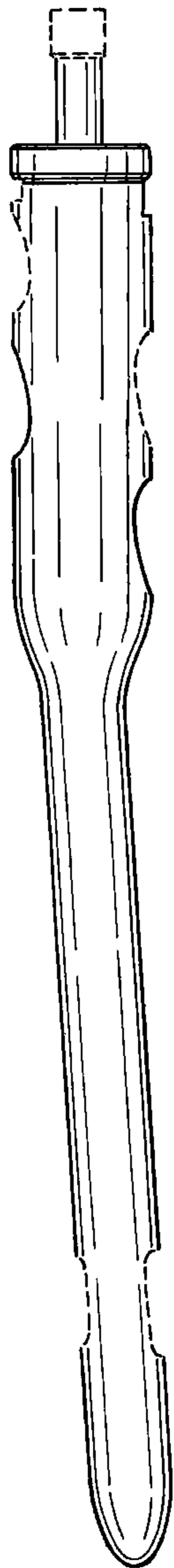

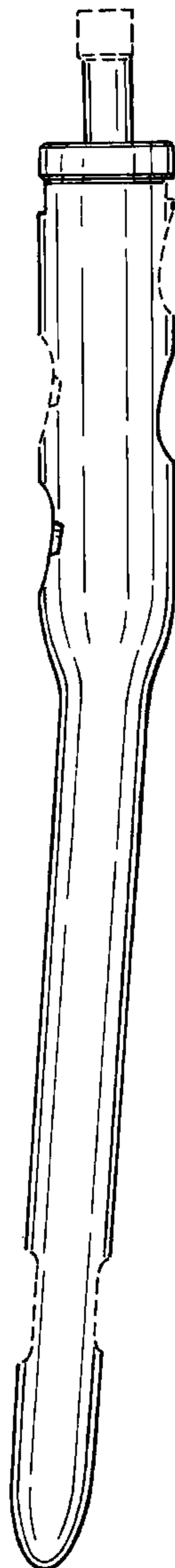

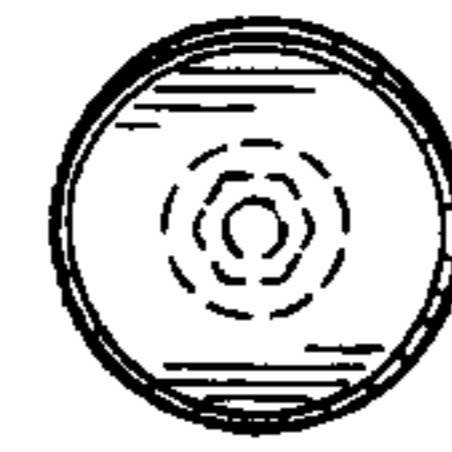

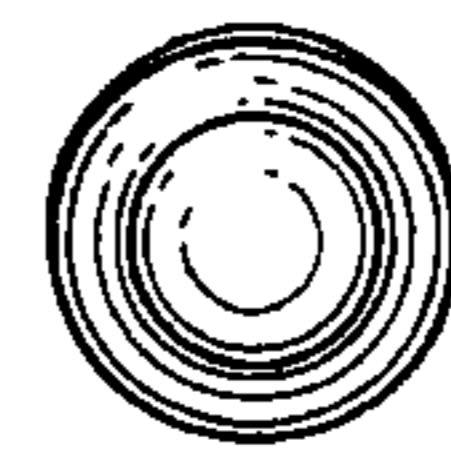
